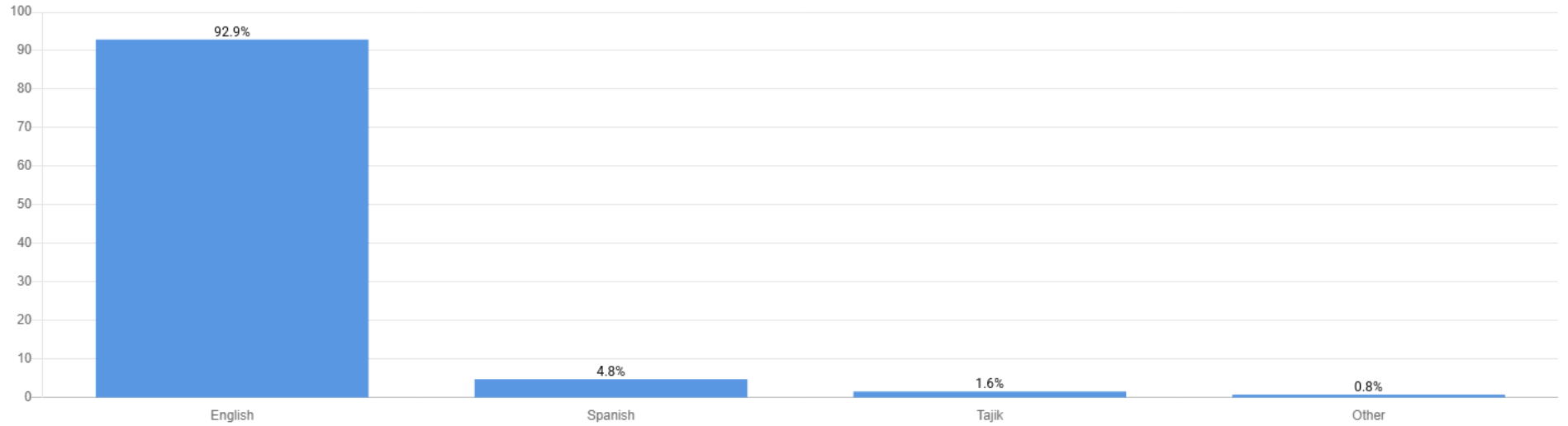

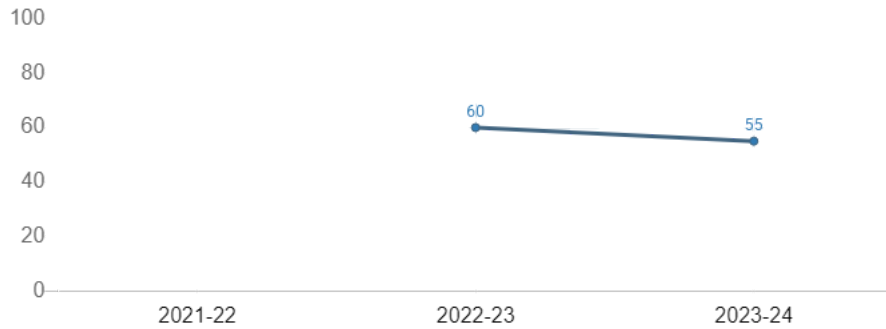

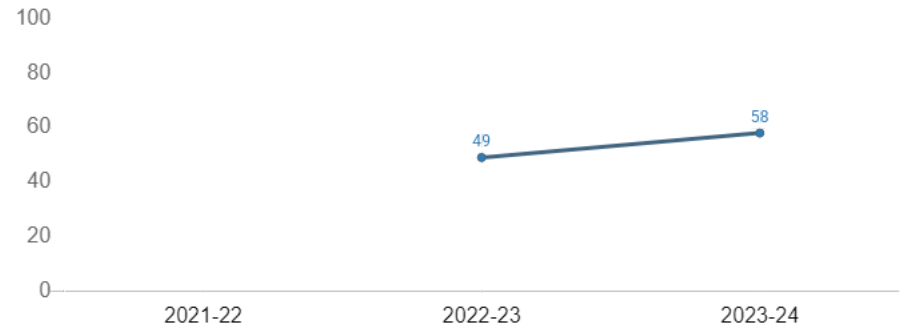

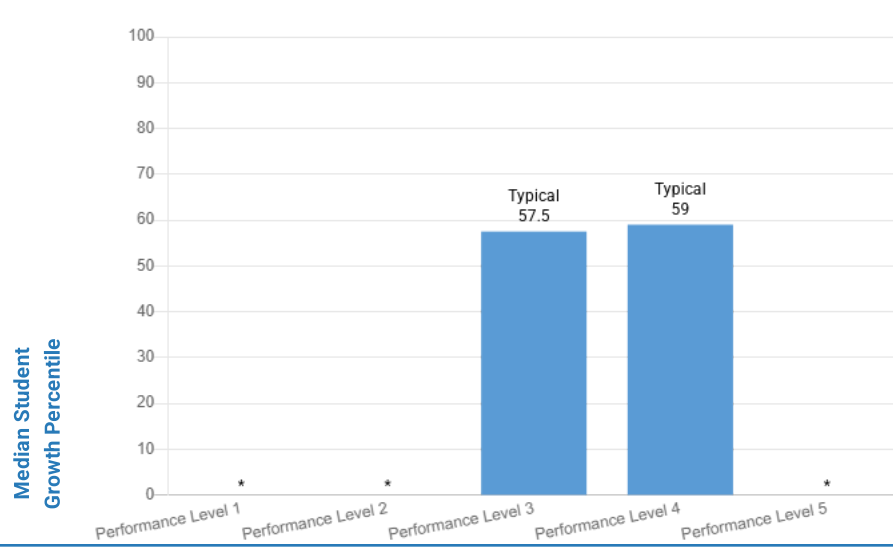

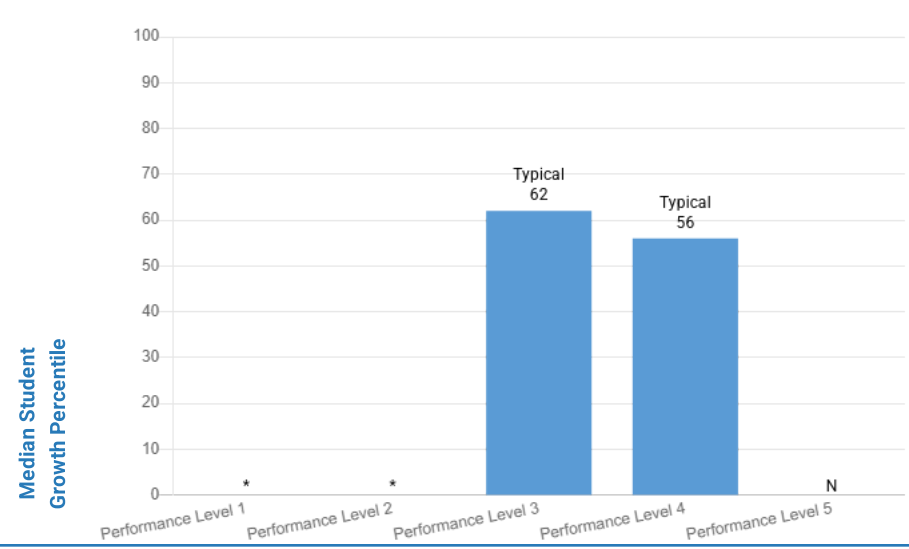

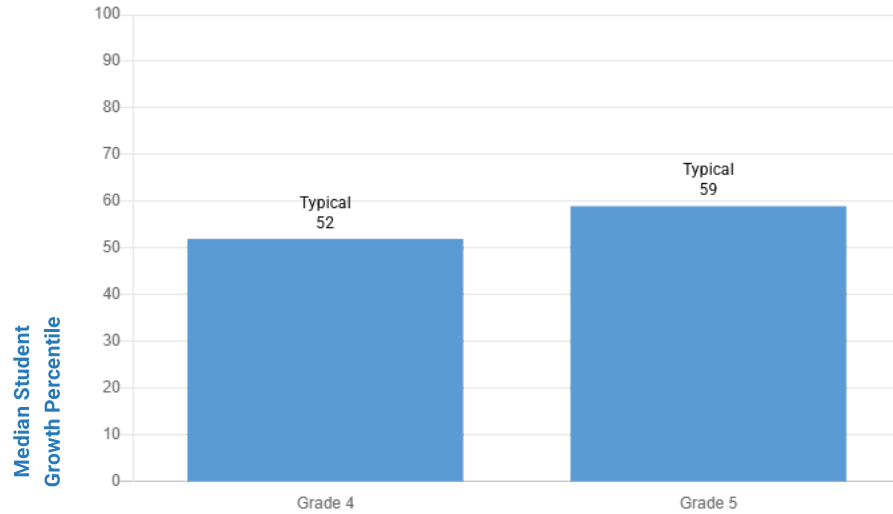

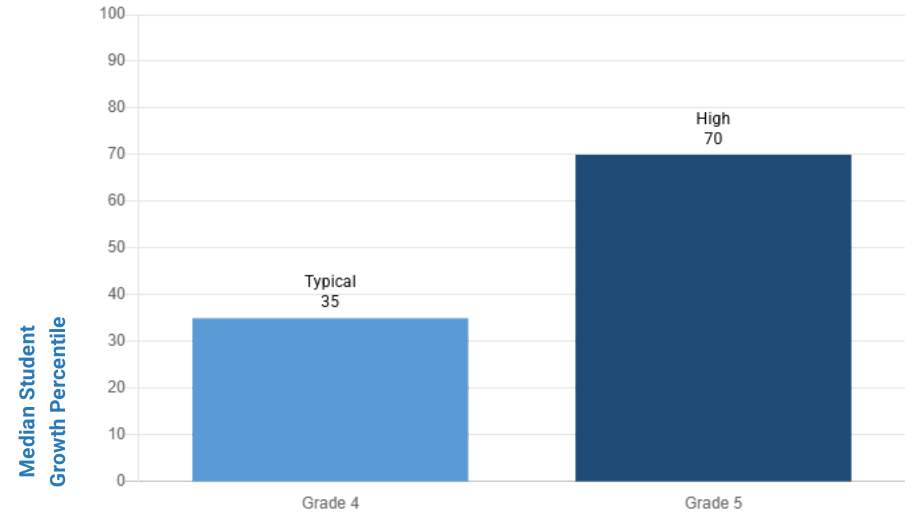

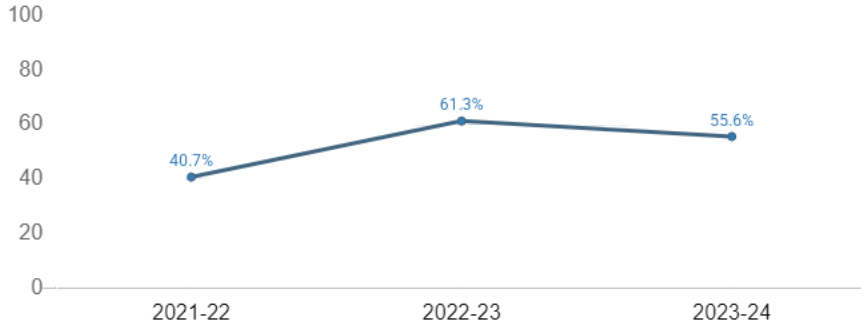

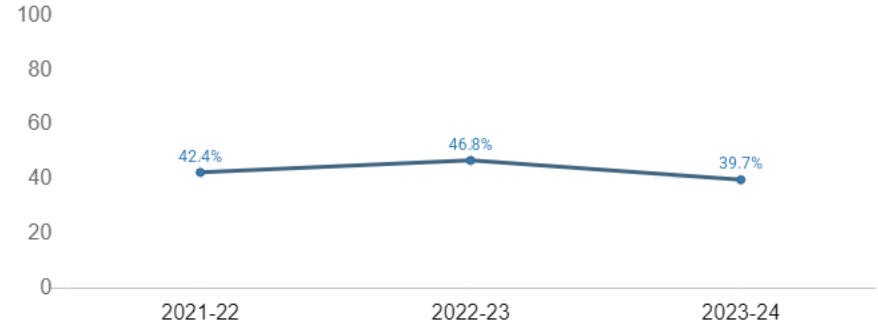
English Language Arts and Mathematics Performance Trends

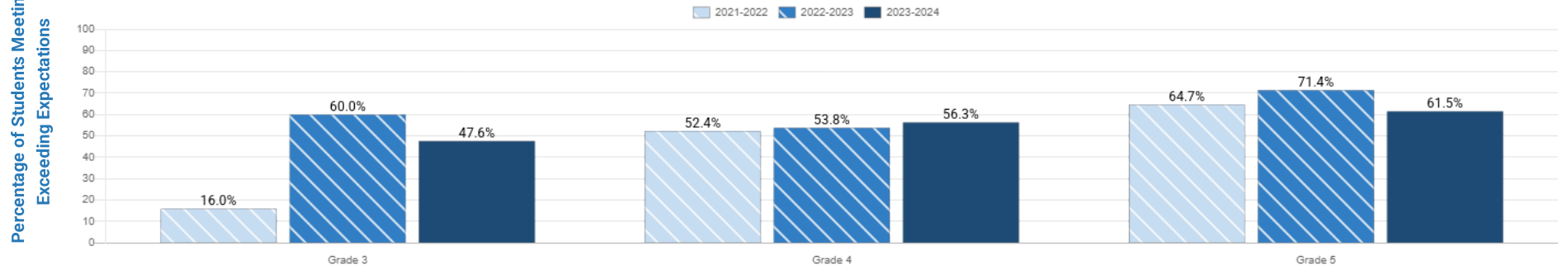

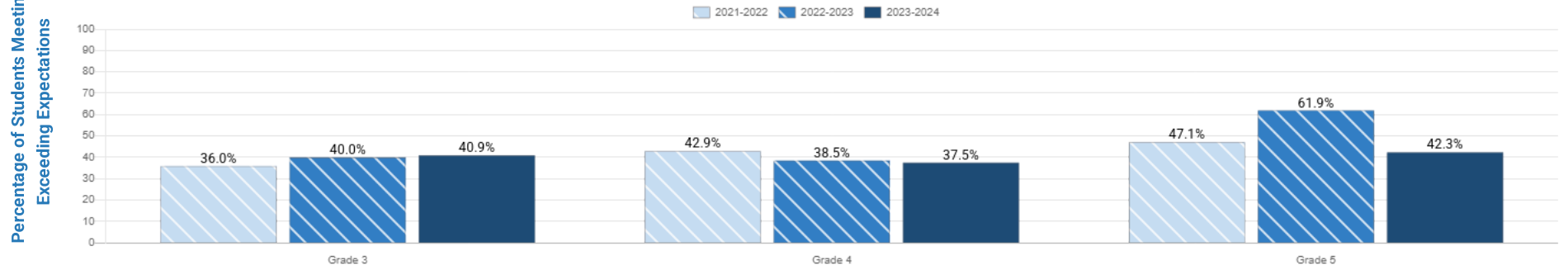

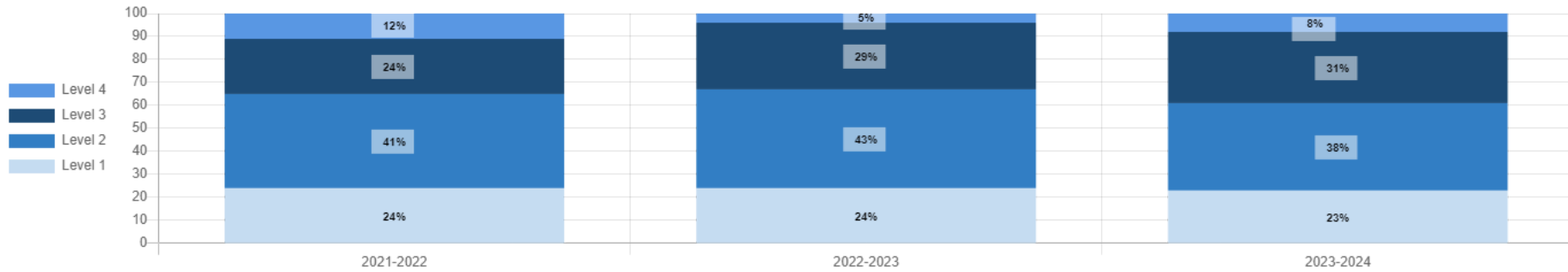

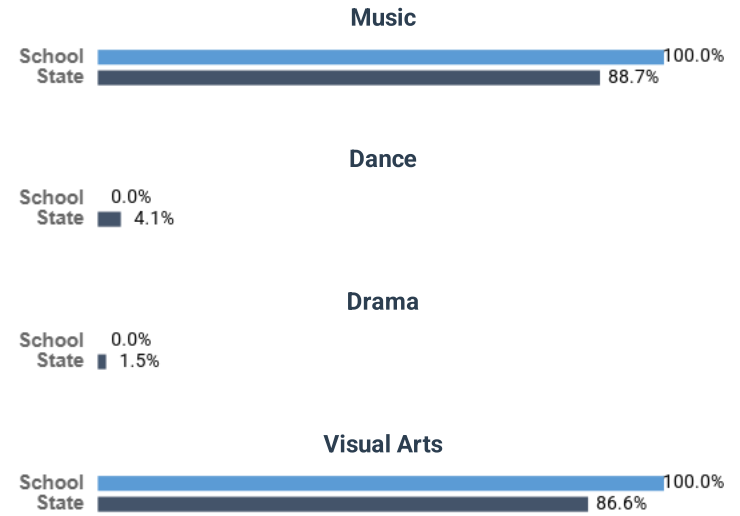

Students enrolled in one or more classes by discipline:



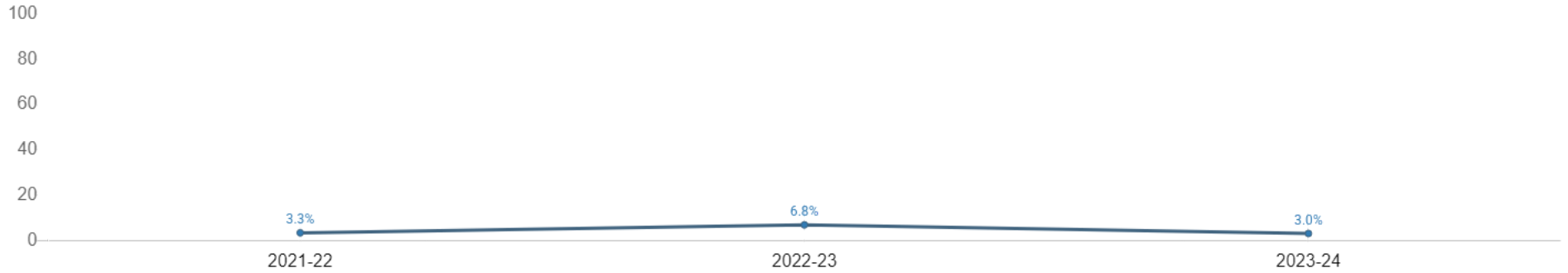

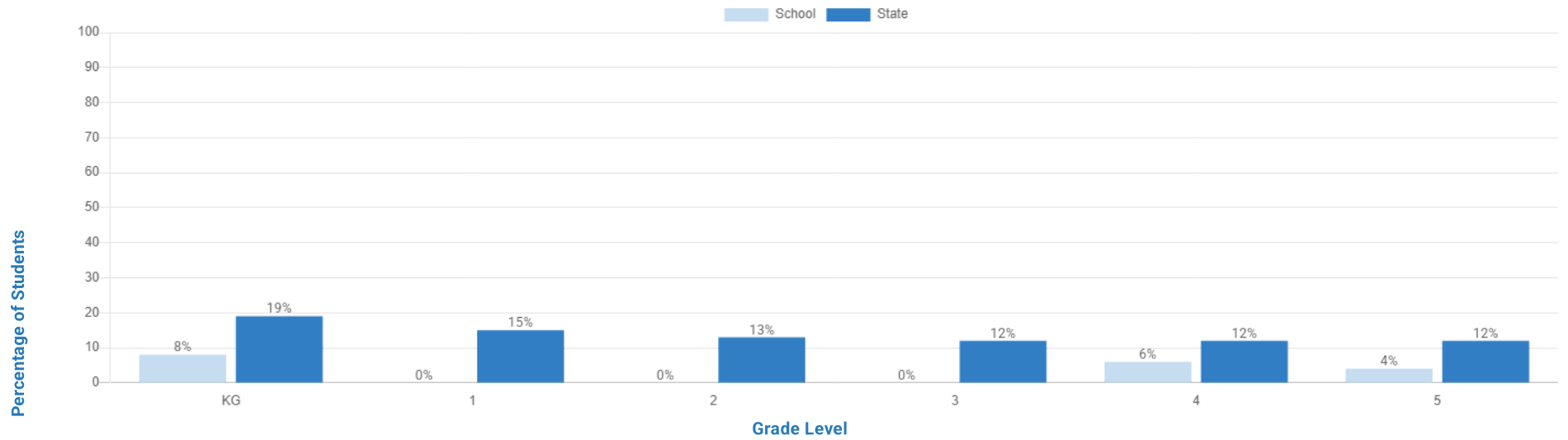

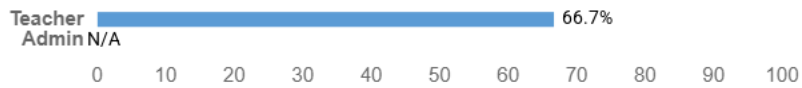

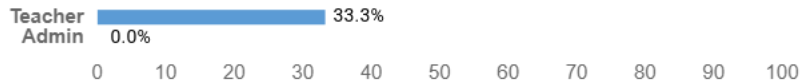

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Non-English speaking students work daily with a specially certified teacher. A continuum of services in the least restrictive environment is also provided to our students with special needs including occupational therapy, speech therapy, physical therapy, counseling and behavior support.



Student Health and Wellness:

Student health and wellness services are provided, and the school nurse completes annual screenings for each student. Students in grades K-5 participate in weekly physical education and health lessons. In addition, a daily recess period is provided in grades K-5 as part of the lunch program. Finally, the school offers a daily breakfast program.
