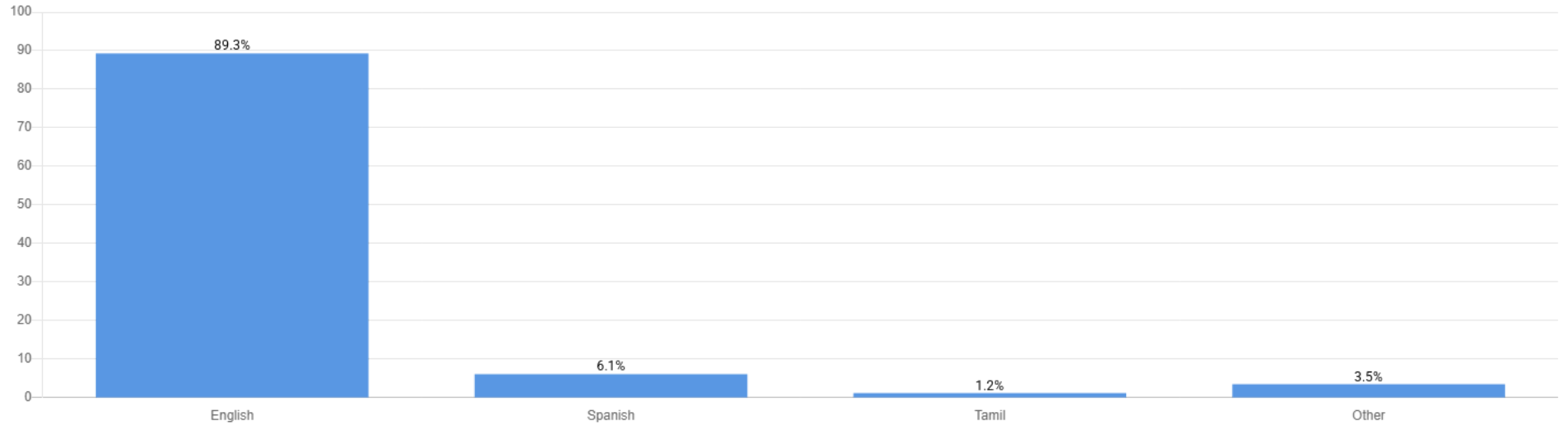

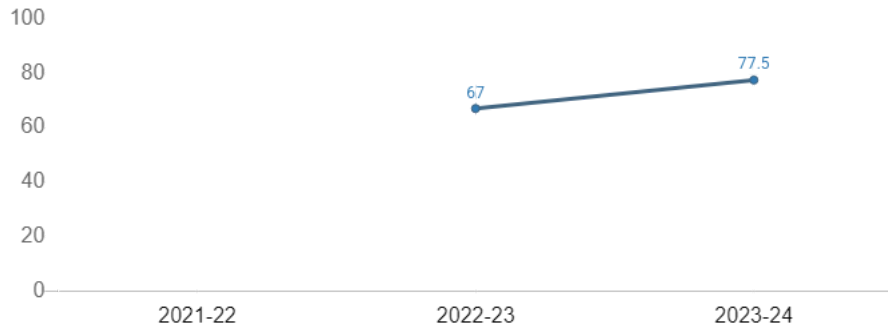

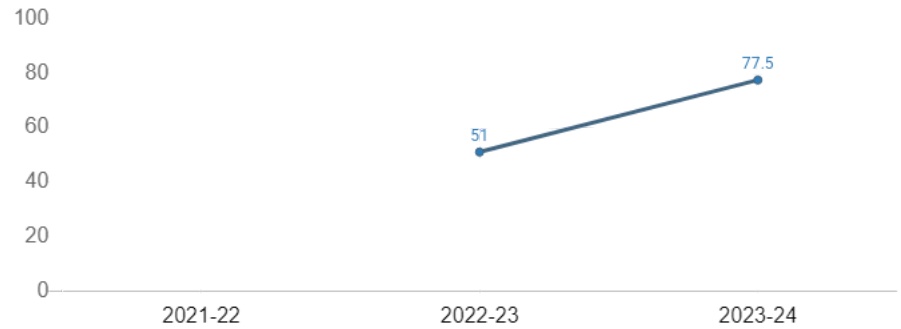

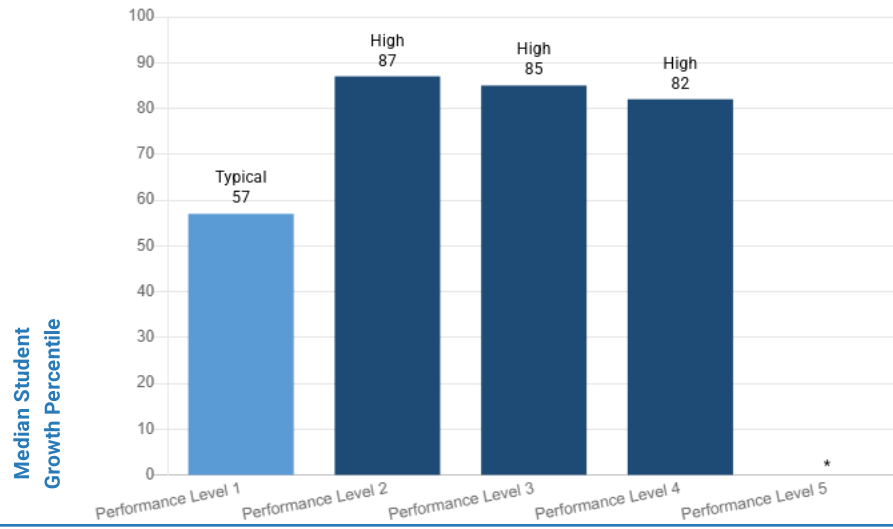

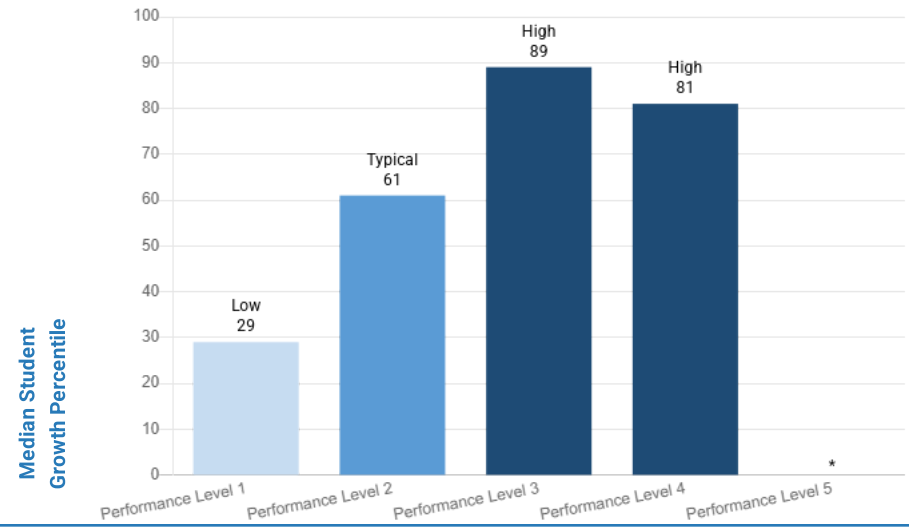

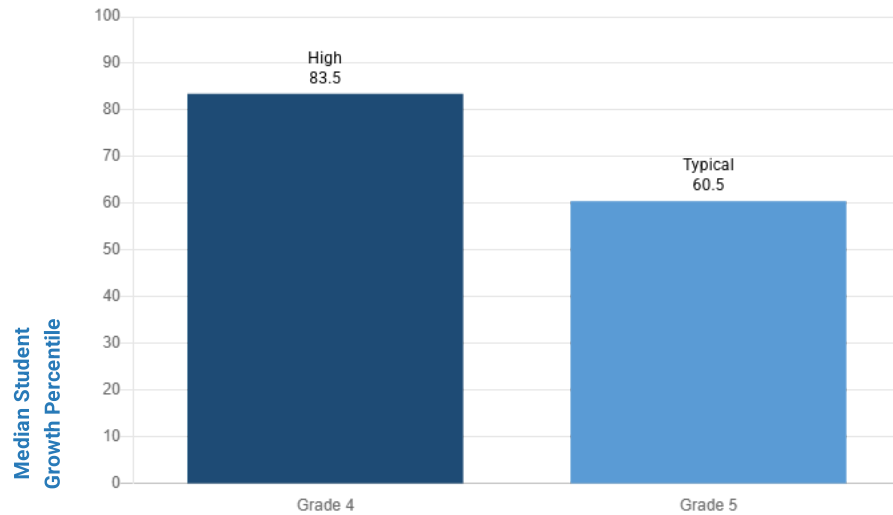

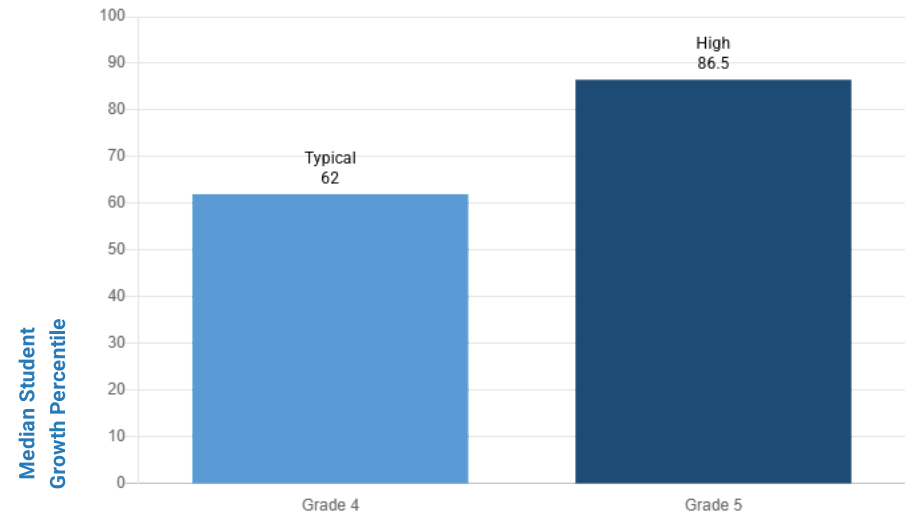

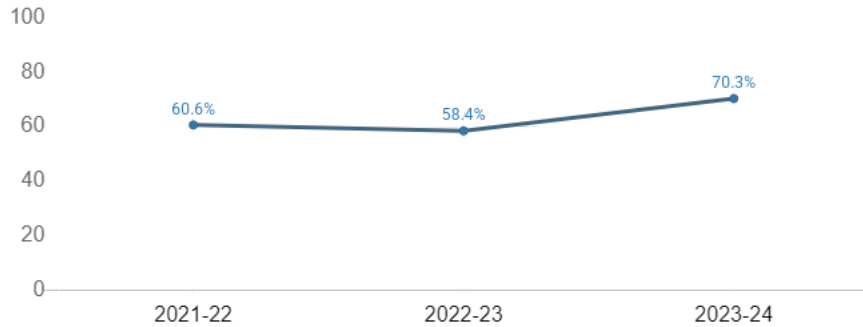

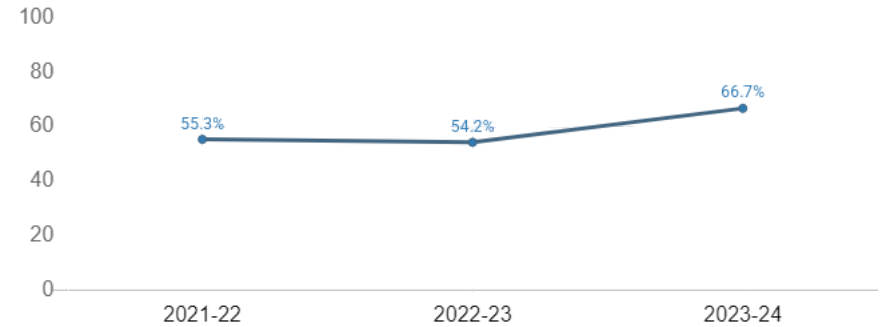
English Language Arts and Mathematics Performance Trends

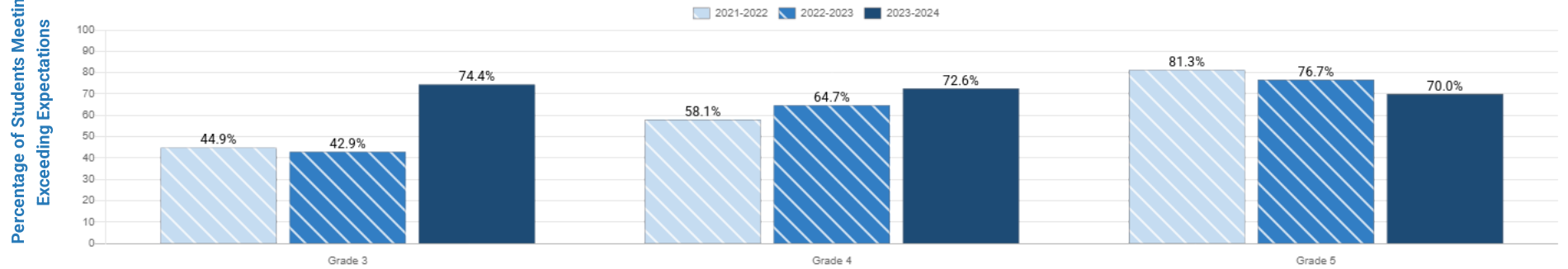

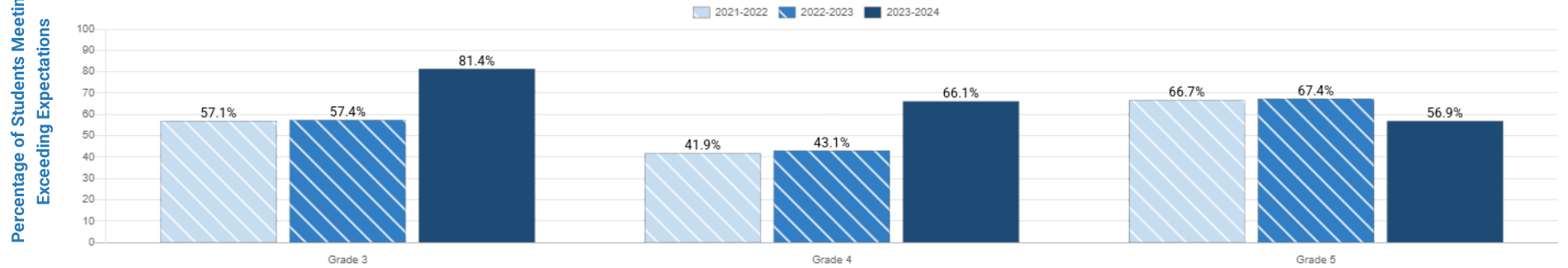

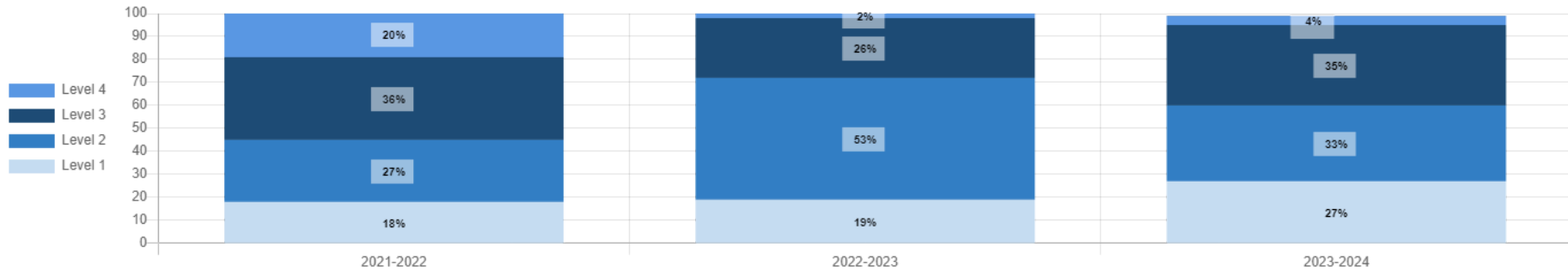

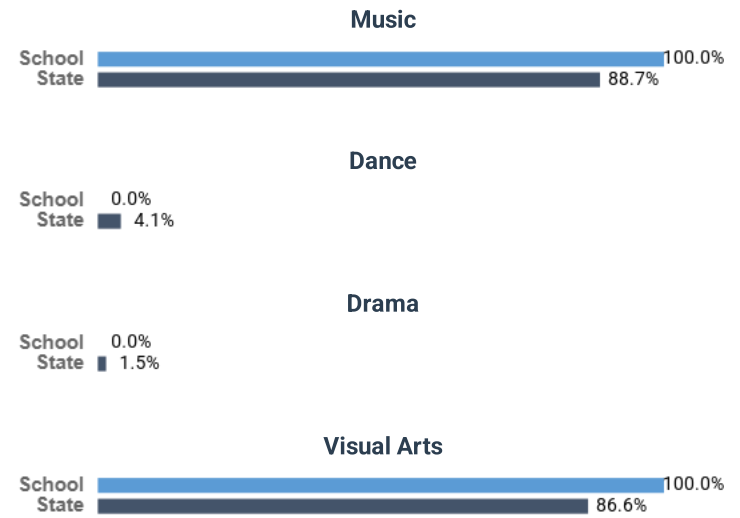

Students enrolled in one or more classes by discipline:



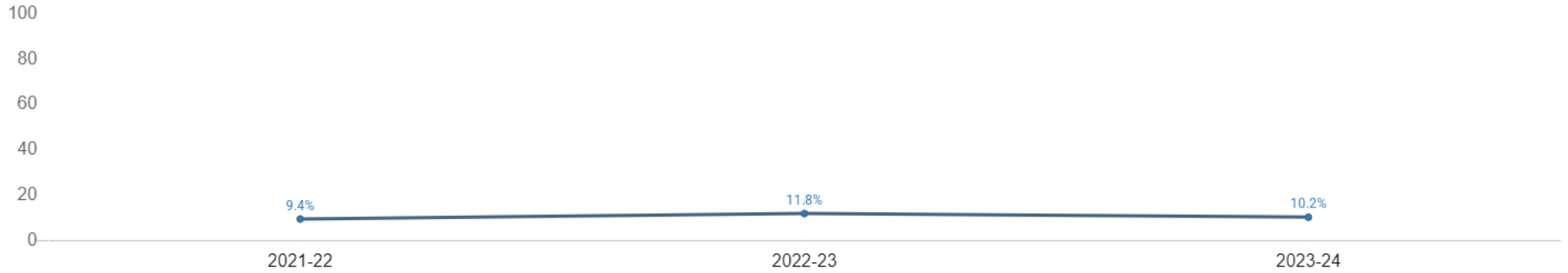

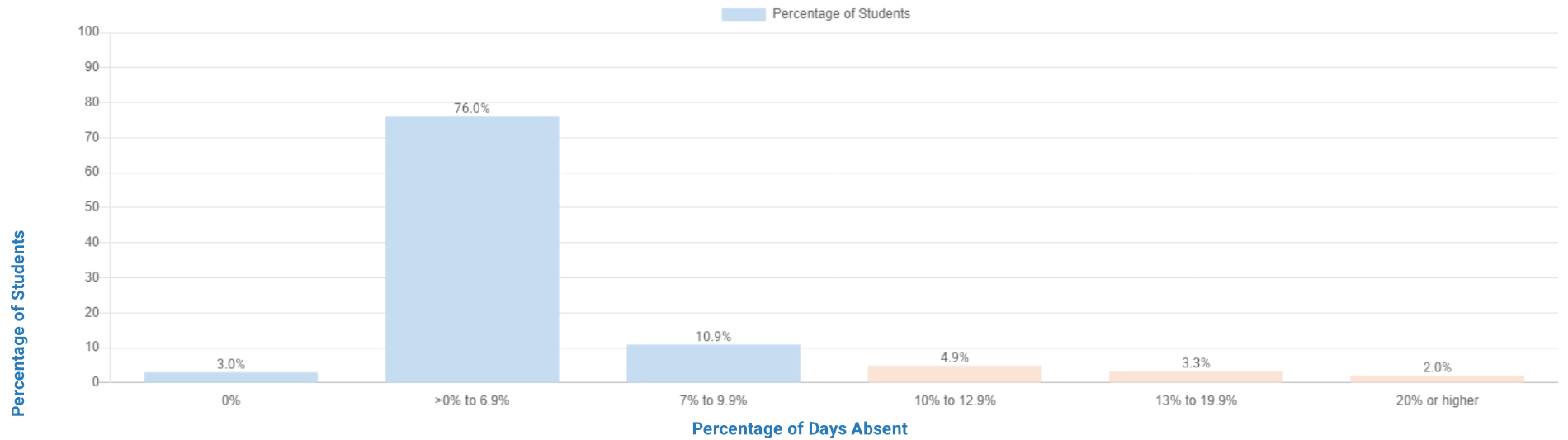

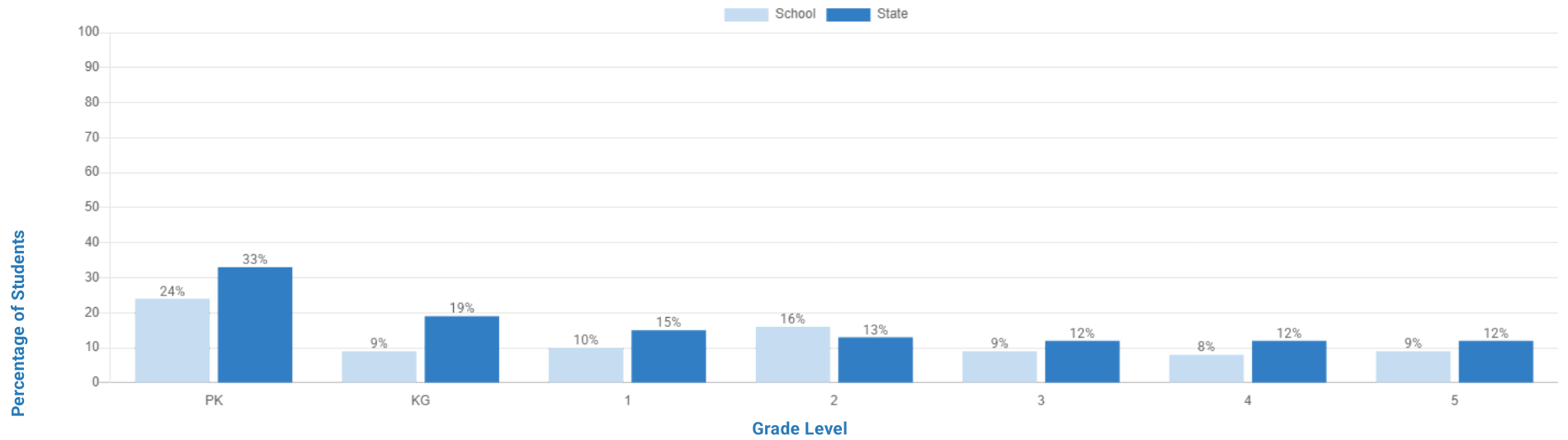

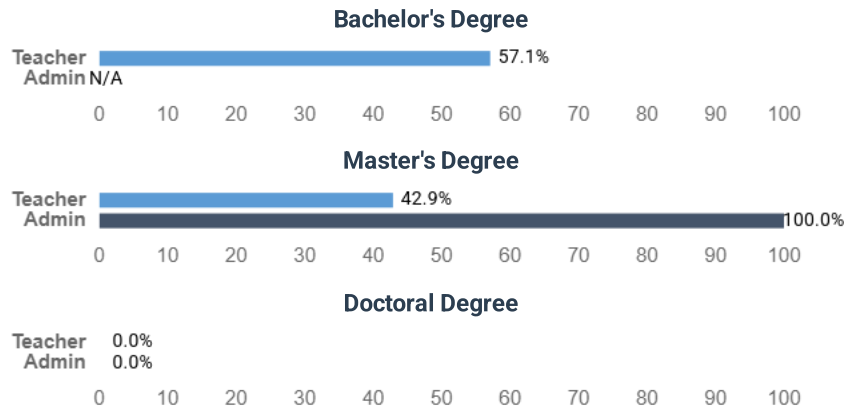

Non-English speaking students work daily with a specially certified teacher. A continuum of services in the least restrictive environment is also provided to our students with special needs including in-class resource, pull out resource, and self-contained programs, with speech therapy, occupational therapy, physical therapy, counseling and behavior support.



Student Health and Wellness:

Student health and wellness services are provided, and the school nurse completes annual screenings for each student. Students in grades K-5 participate in weekly physical education and health lessons. In addition, a daily recess period is provided in grades K-5 as part of the lunch program.
