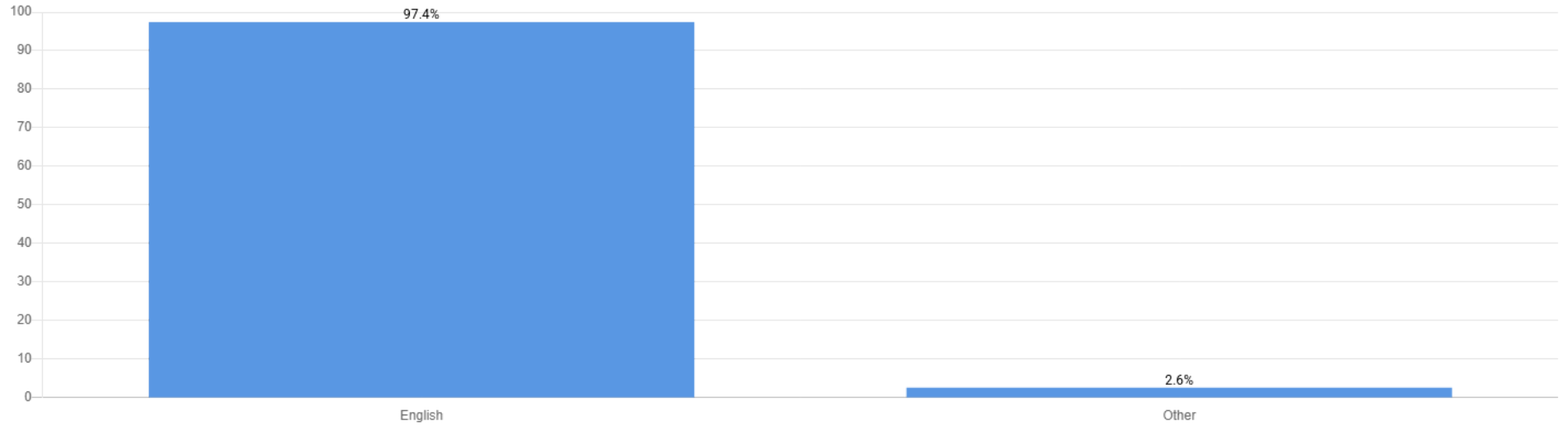

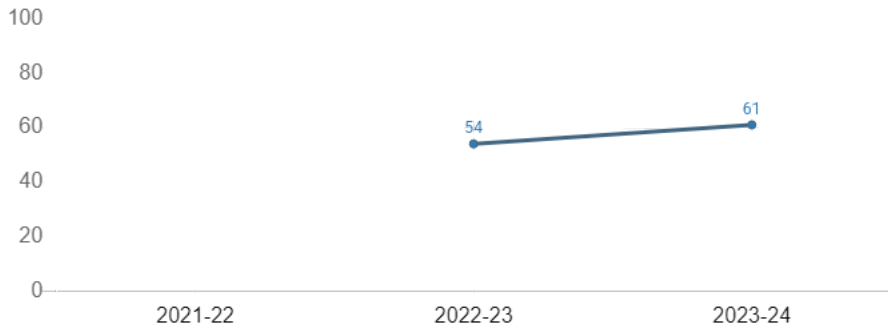

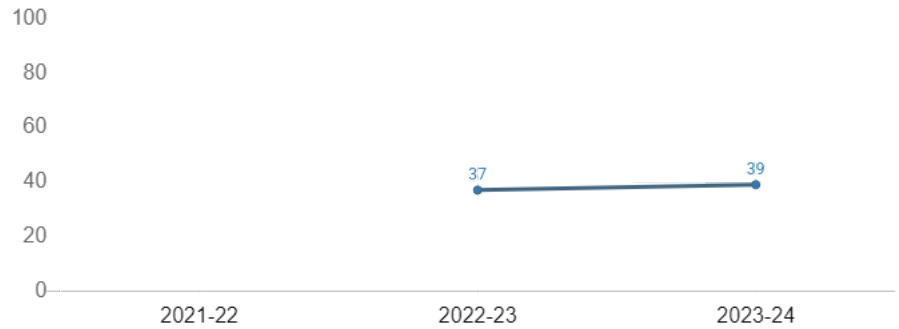

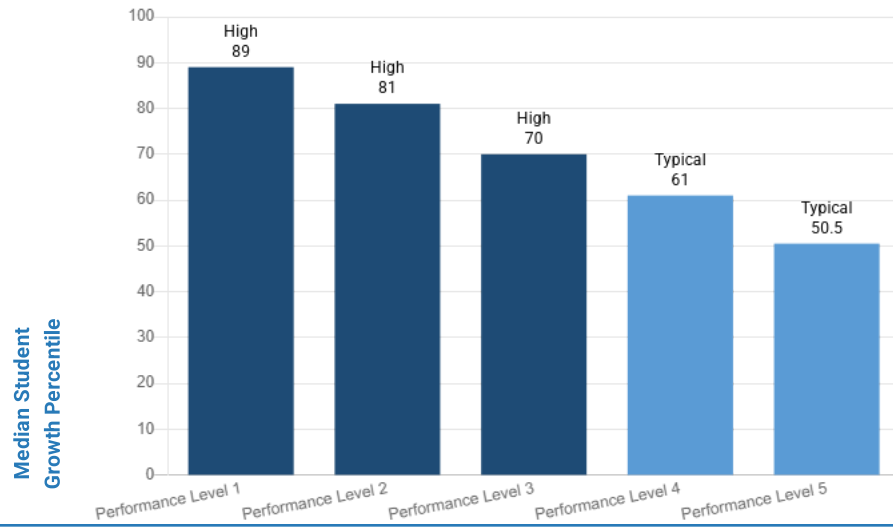

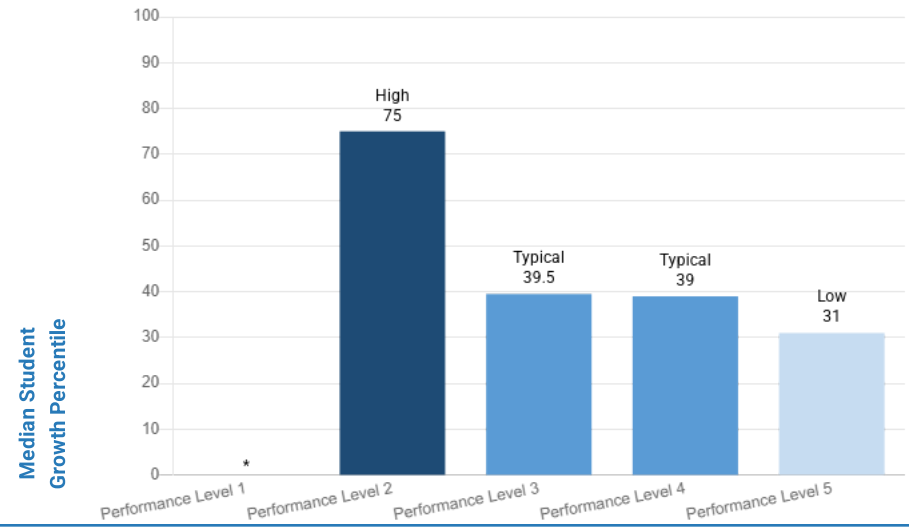

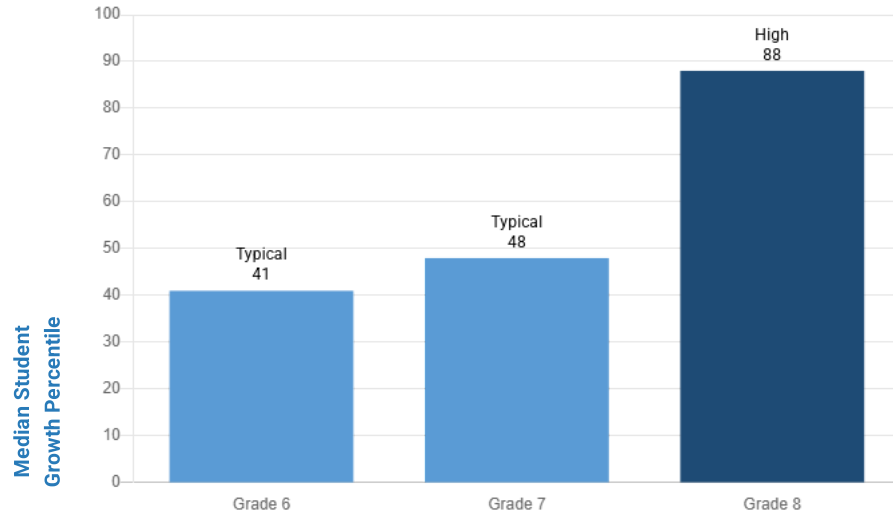

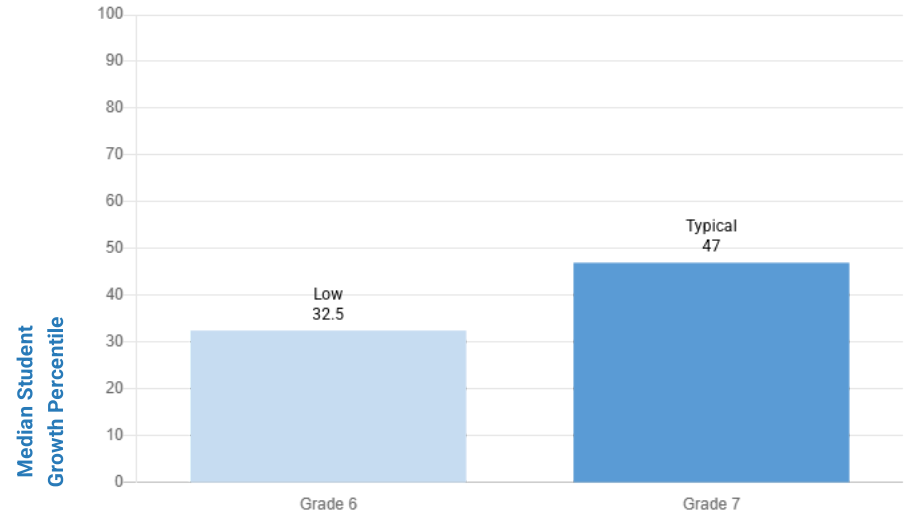

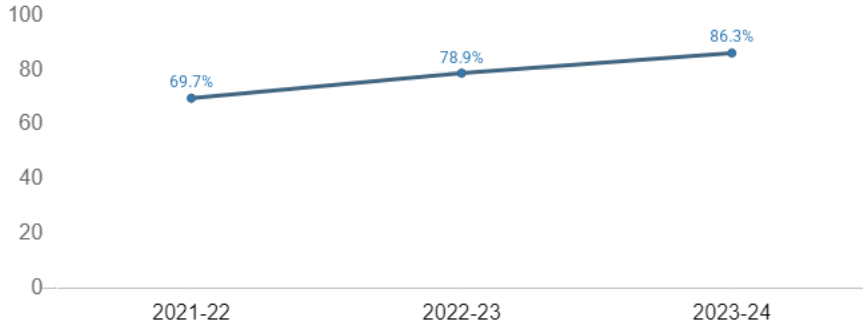

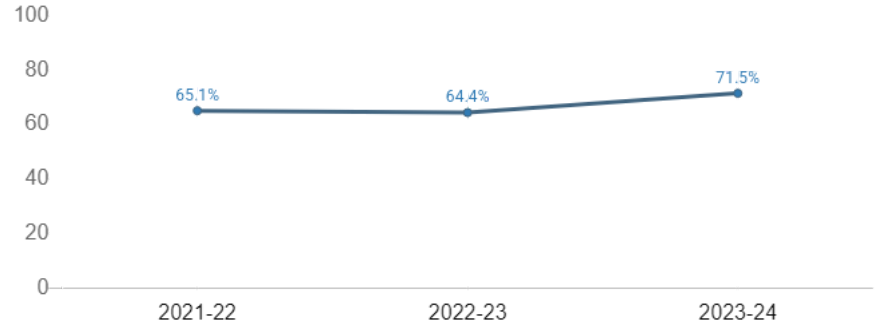
English Language Arts and Mathematics Performance Trends

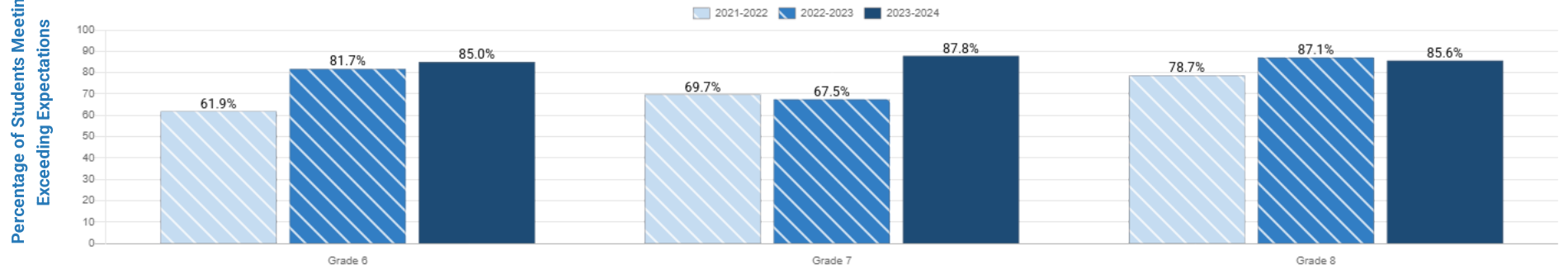

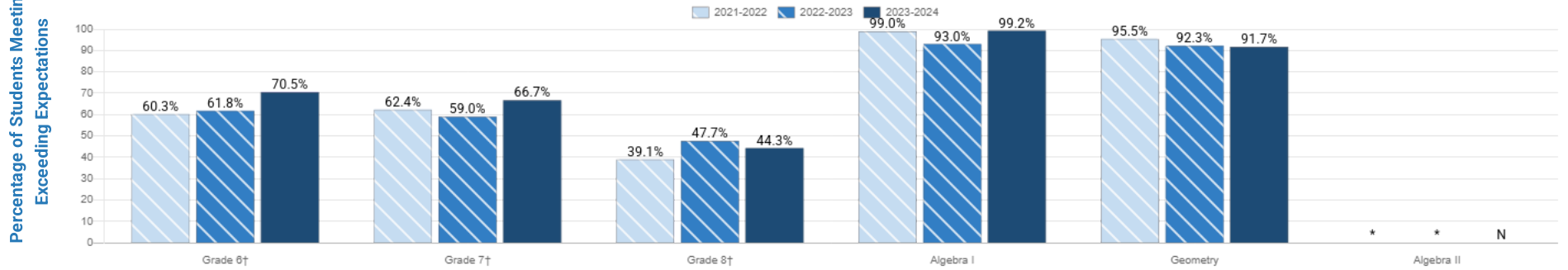

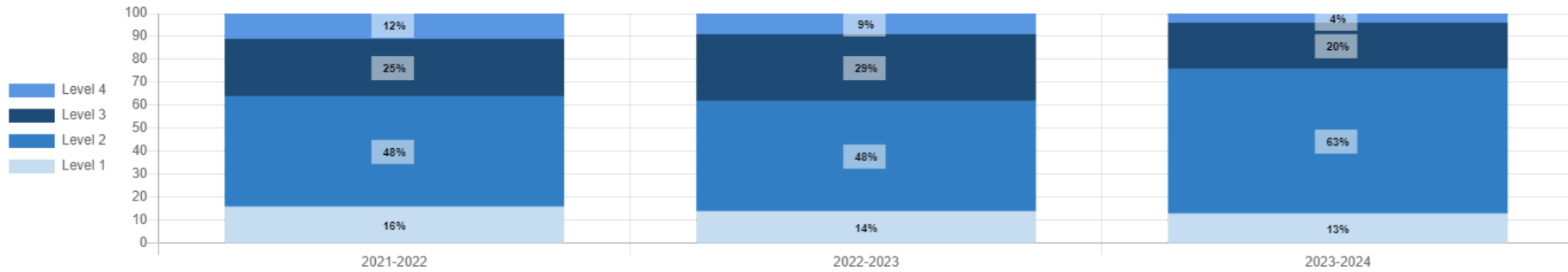

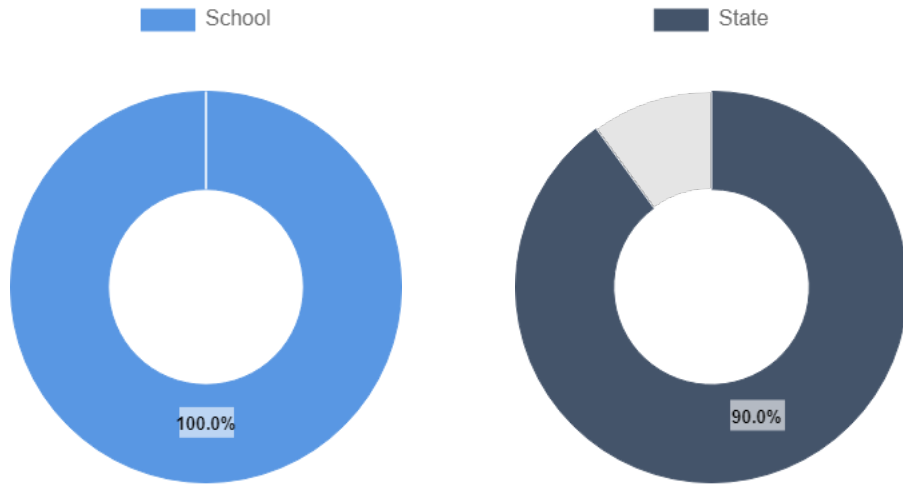

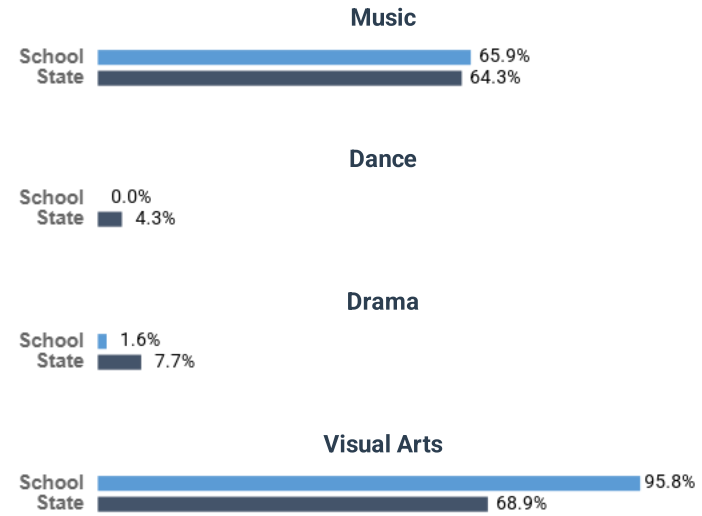

Students enrolled in one or more classes by discipline:



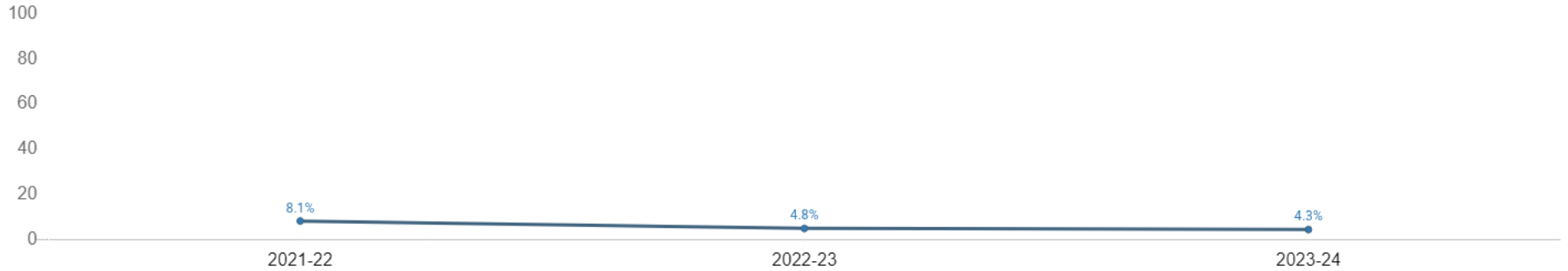

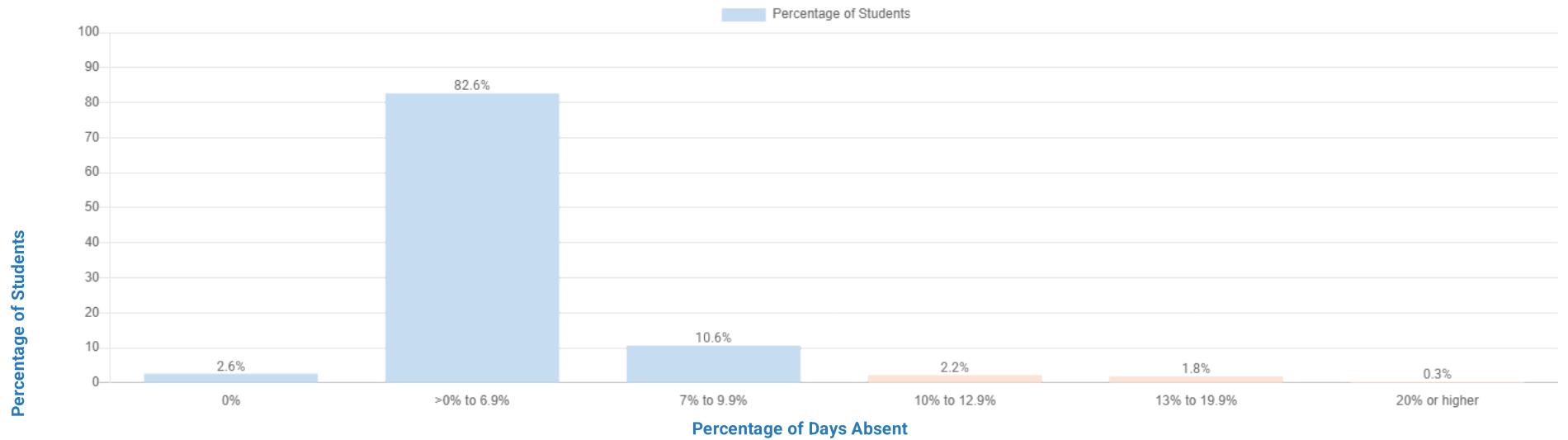

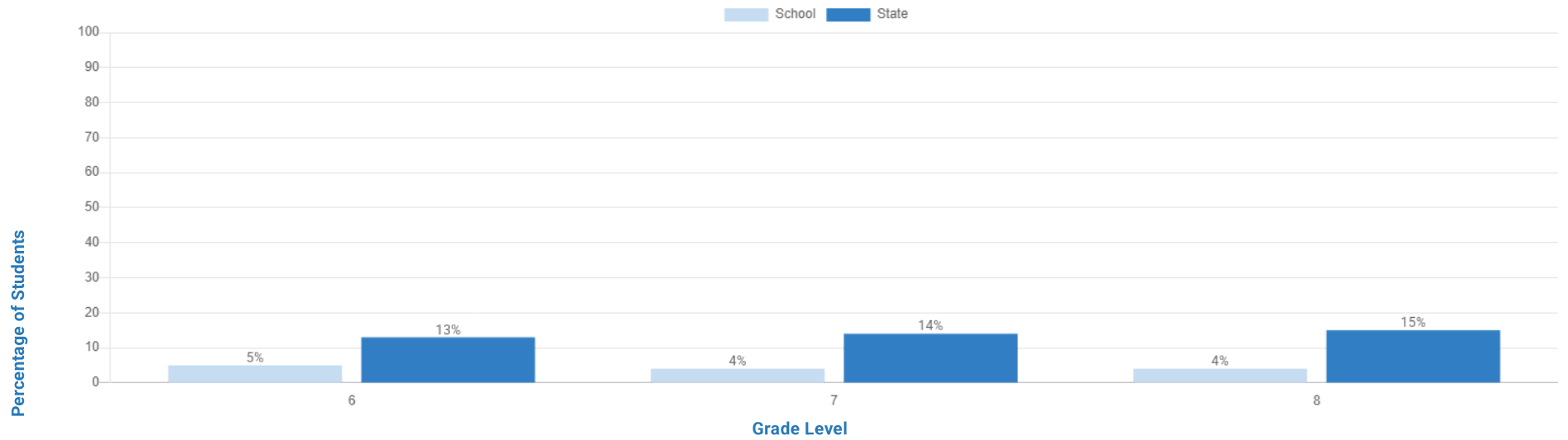

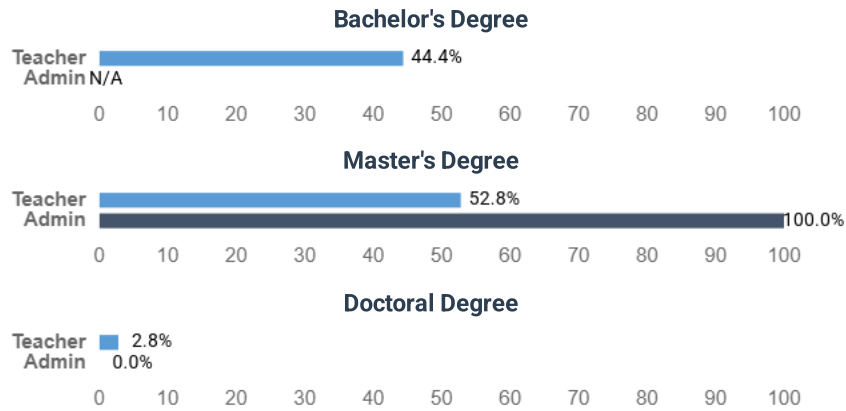

Accountability

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. School Safety:

The district has secured vestibules in 4 of its 5 school buildings, except for the High School, where we employ a School Resource Officer. We currently use the Raptor Visitor Management System at each of our buildings. The district has a School Climate/School Safety Team in each of the 5 schools. Each ABS has been trained in The Role of the School Climate Team and has received NJPSA/FEA Anti-Bullying Certification. The district established a community-wide District Safety Committee to assess the safety needs of the school district. HSD was awarded a \$500,00 grant to provide an emergency notification system complete with wall mounted lockdown buttons, personal lockdown pendants, integrated lockdown announcement through our PA system, remote access controls, and visual strobes in all indoor and outdoor areas of the buildings; video cameras to provide first responders with live feed; 3M ballistic resistant film on all first floor windows; and gun detection software.



Technology and STEM:

HMS elective STEM courses were revamped with engaging, high-interest STEM activities dealing with coding, drones, AI machine learning, and the engineering design process. We are in our third year of offering a fully developed STEAM program that infuses coding, engineering, art, and mathematics for all students. Our Coding Club also provides students additional opportunities to explore STEAM beyond the classroom. We are proud to continue working with BSD - BSD Education was founded to help schools bring technology education into their classrooms, including coding in all subjects, which is made possible by your teachers. The Library's Digital Literacy courses assist students in better understanding their digital footprints, social media, and the positive and negative effects of their online activities.
