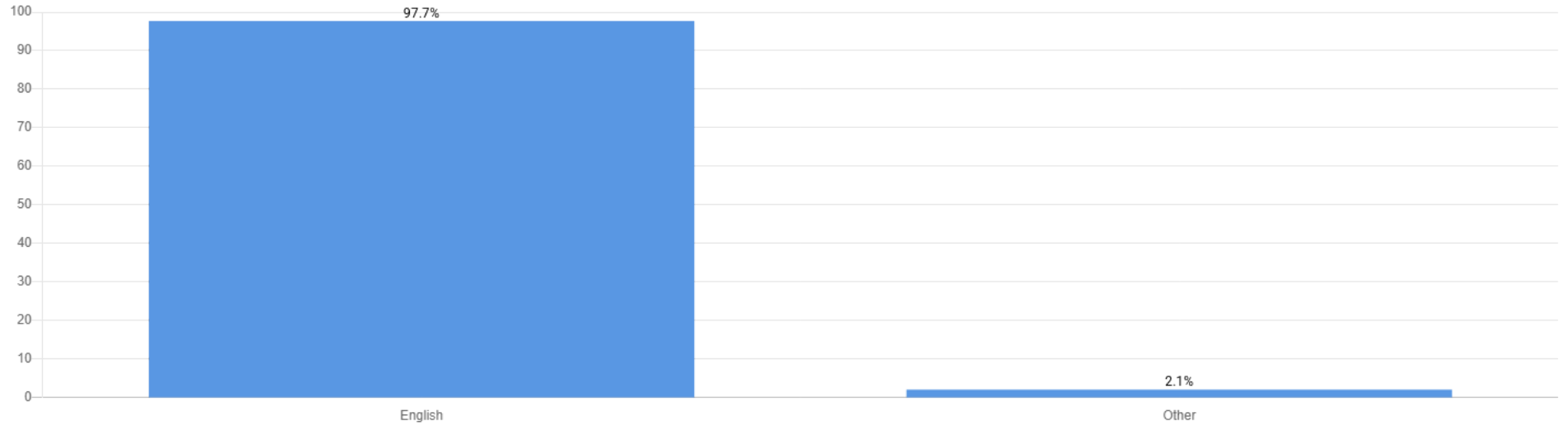

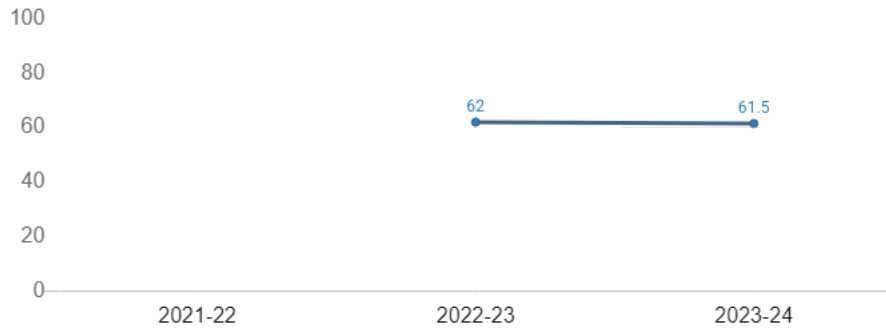

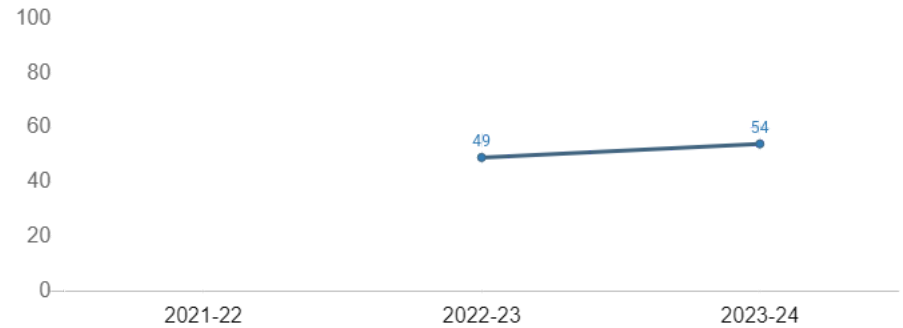

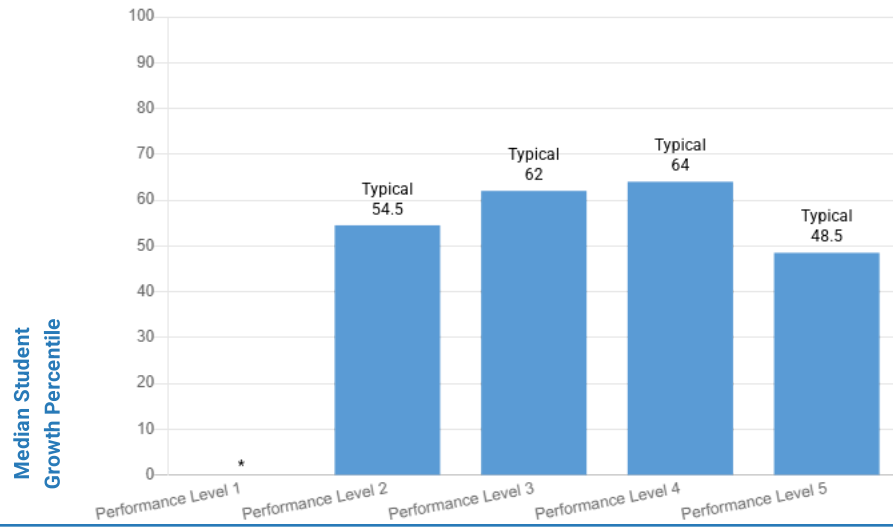

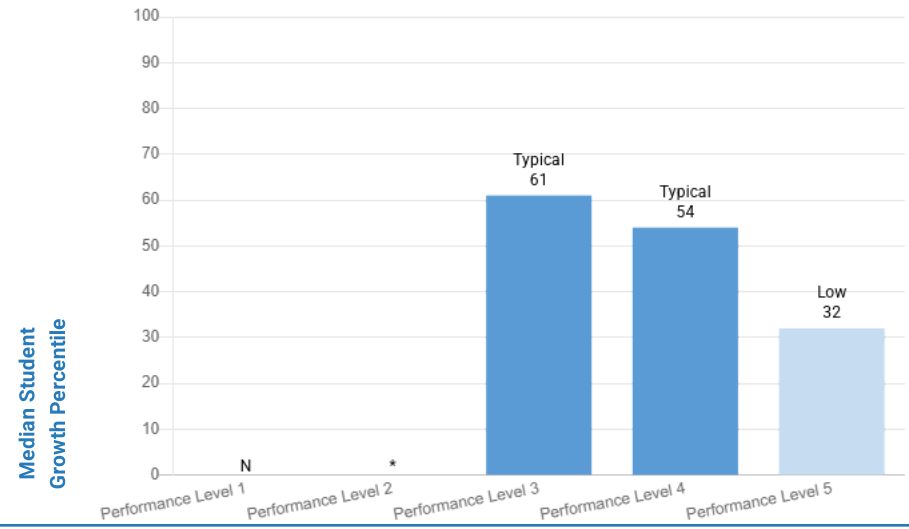

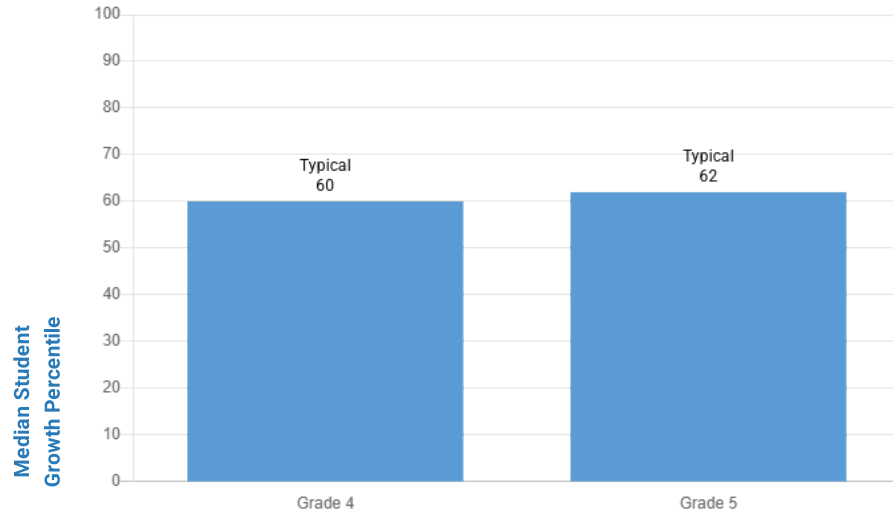

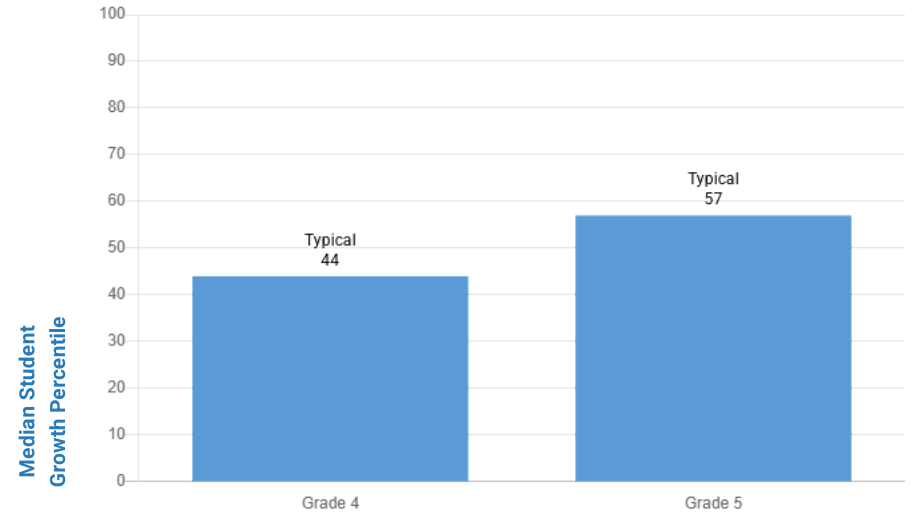

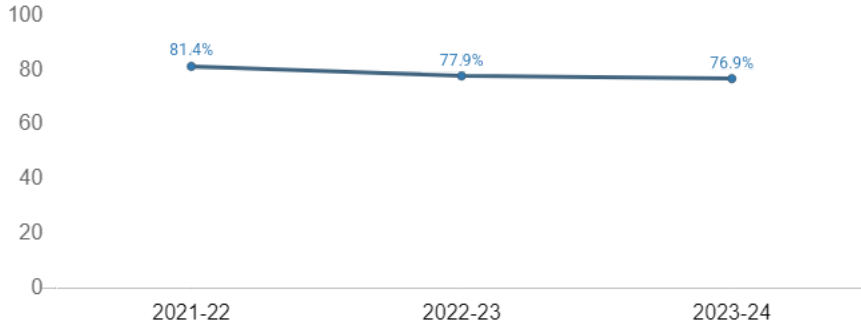

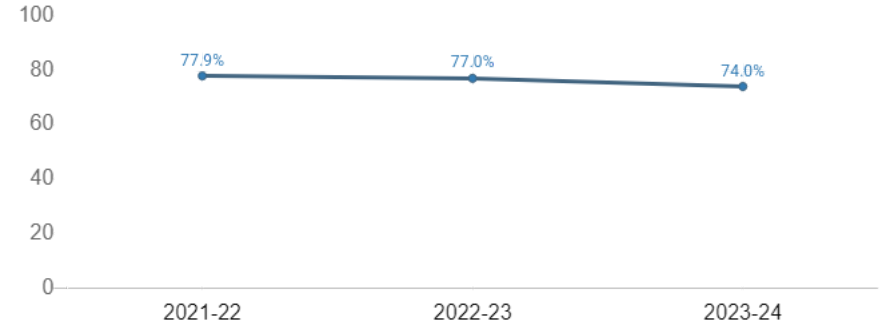
English Language Arts and Mathematics Performance Trends

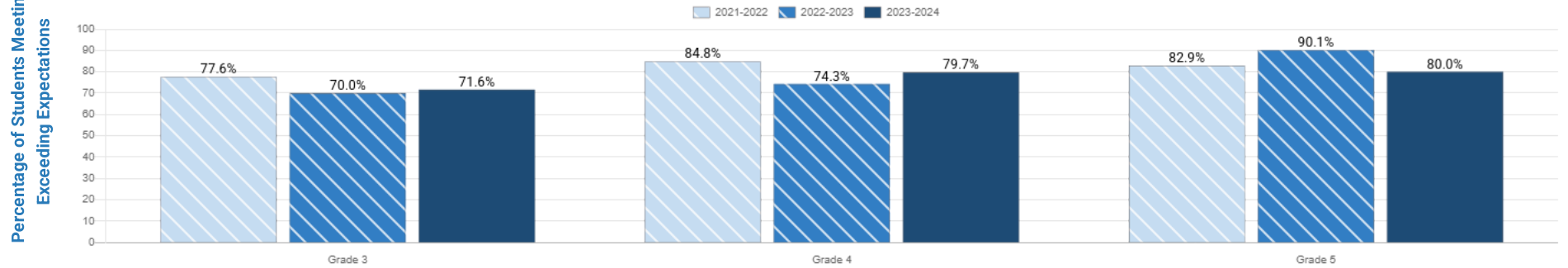

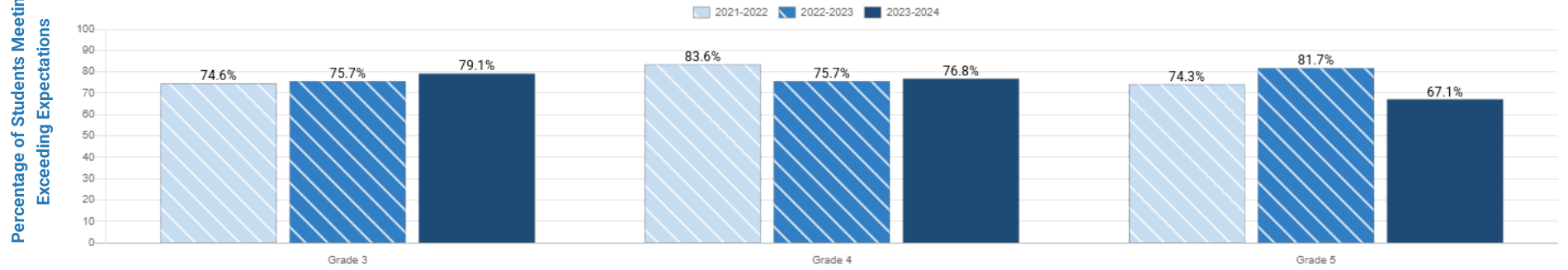

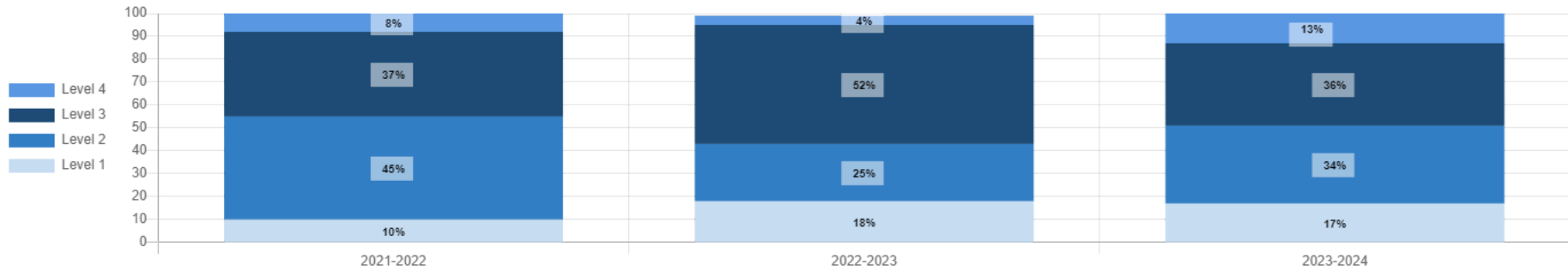

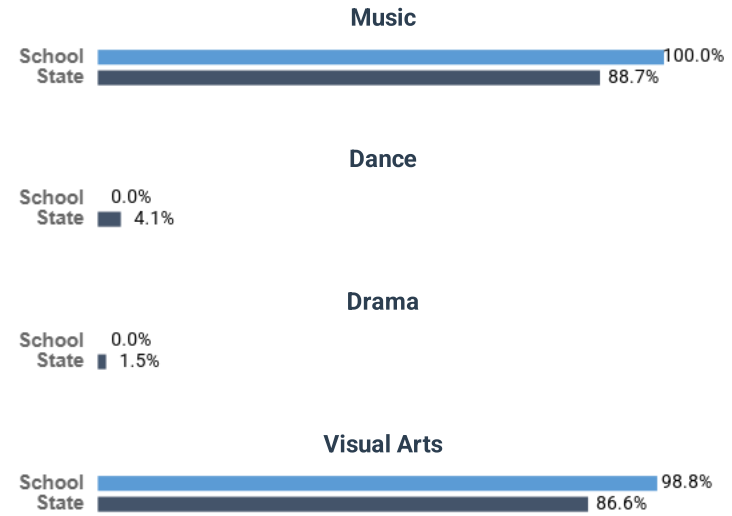

Students enrolled in one or more classes by discipline:



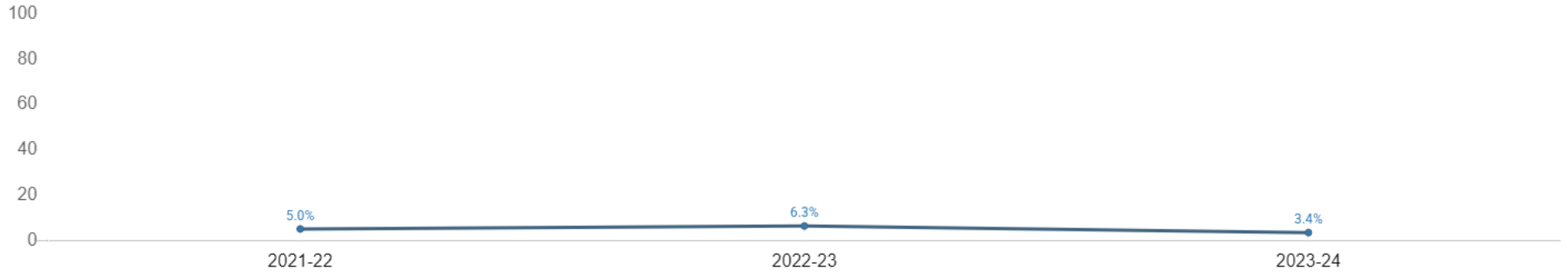

The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. 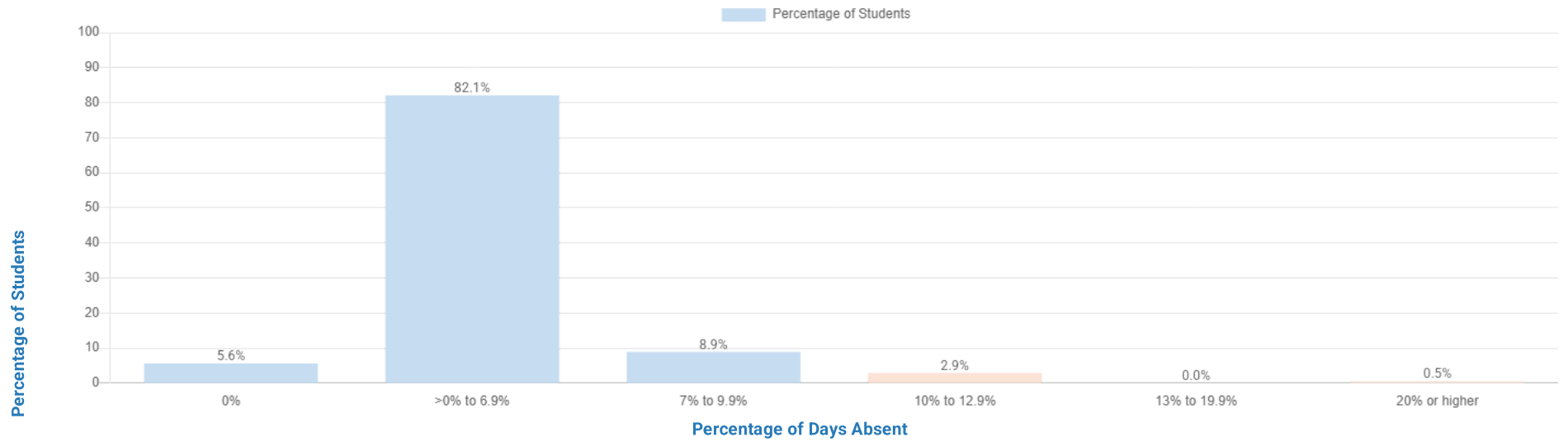

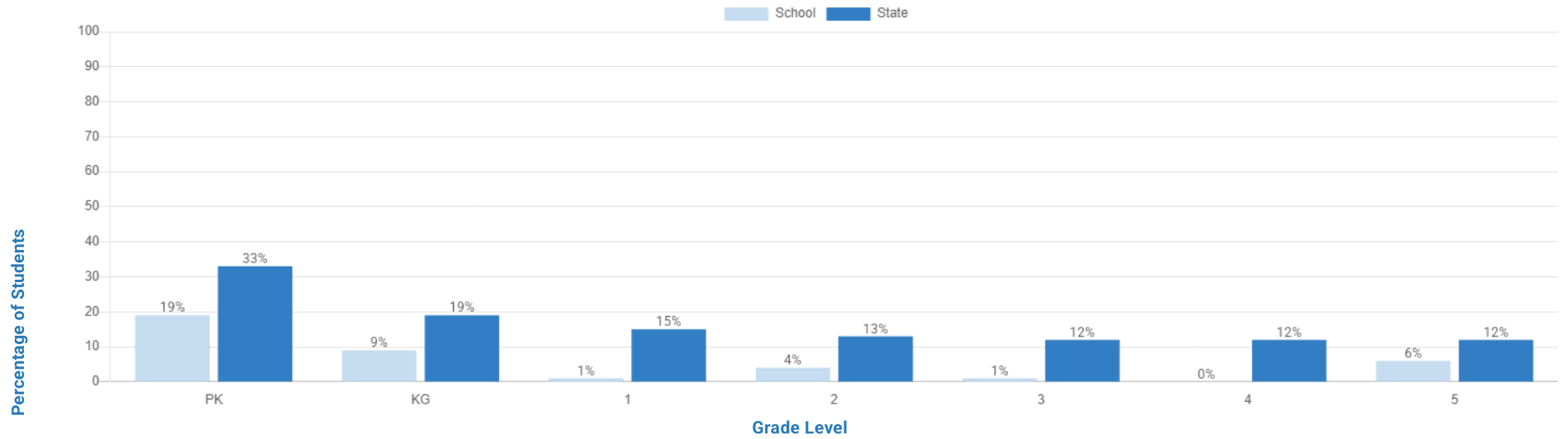

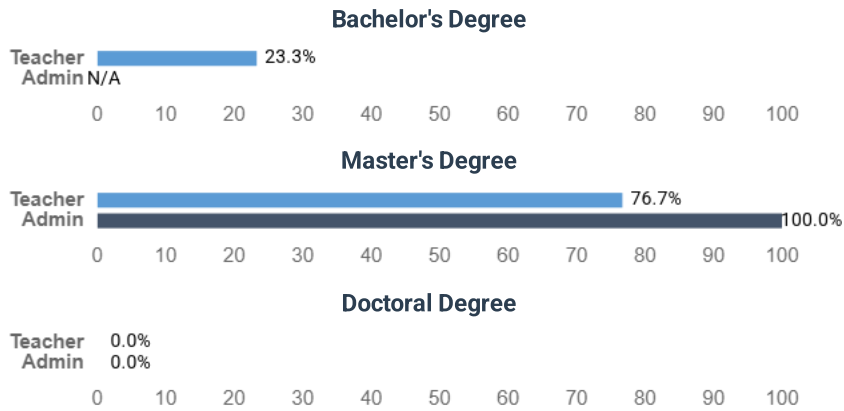

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Tatem's 433 students, ranging from preschool through fifth grade, can walk to school because the town encompasses just 2.6 square miles. Our school's mission is to develop each individual's unique potential, preparing our students to meet the New Jersey Learning Standards. Our caring and child-centered faculty is committed to creating a strong school culture. We strive to create a challenging and diverse learning climate that promotes the development of the whole student, preparing them with the knowledge, skills, and integrity to meet life's challenges and enrich their community.

Teachers create engaging learning experiences tailored to diverse learners, incorporating a variety of instructional strategies and technologies. The district offers a comprehensive range of courses, including core subjects, arts, music, world languages, and specialized programs like gifted and talented education. Regular assessments and progress monitoring ensure students are on track to achieve their full potential. Through a collaborative partnership between teachers, parents, and students, the Haddonfield School District strives to provide an exceptional educational experience that prepares students for success in college and beyond.

Staff and Professional Learning:

The school staff works collaboratively to promote learning and ensure that every child succeeds in ways that reflect his or her own aptitudes and interests. Our staff continuously engages in professional development through graduate work, professional growth groups, grade-level meetings, district professional development, and outside seminars. Each summer teachers work together to evaluate and revise the curriculum. This year, staff professional development will focus on the goals of our strategic plan. These include social-emotional learning (RULER program by YALE), cultural responsiveness, and project-based learning. Each grade level has a grade level leader across the elementary schools.



Student Supports and Services:

A wide range of supportive services are provided for students who require support and intervention. Students qualifying for ELL services receive tutoring. Students who have an IEP or 504 plan are provided with a range of services to meet their unique needs. Most students are provided in-class support services and small group instruction in the general education classroom. Those students requiring more support are provided with pull-out supplemental or replacement services such as Just Words, Sonday, Wilson Reading or Envisions Math. Students in general education benefit from, RTI, Math and Language Arts Specialists, and Early Intervention. We have an active and engaged Intervention and Referral Services Team to assist students who are experiencing learning, behavior, and health difficulties. Action plans and interventions are managed by the team and classroom teacher(s). Our school has a full-time counselor.



Student Health and Wellness:

Students are engaged in both health and PE in Grades 1-5. Health and PE curriculums are aligned to the NJ standards occurring once per cycle. Our mission is to help students become health literate, self-directed learners who can obtain, interpret and understand basic health information and develop competencies to use such knowledge to enhance physical, social, and emotional health. Students in grades 1-5 have physical education twice every cycle. PE promotes coordination, balance, and strength, allowing participation in individual and team activities. Students learn a variety of sports-related skills that are regularly integrated with community service opportunities. Special events include the Tatem Fun Run (PTA Boosterthon), the Tatem Fair, thematic holiday-related activities, and Field Day; a strong tradition of sportsmanship, community building, and outdoor fun. Our school nurse supports the health and wellness of our students. Students engage in recess at least once daily.

Parent and Community Involvement:

Parents and staff members are mutually respected and valued as key components to student success. Our school boasts an active and engaged National Award Winning PTA 2 years in a row. Our PTA supports assemblies, enrichment opportunities, field trips, and events such as Spaghetti Bingo, Movie Nights, Book Fairs, and Socials. They raise money to support the curriculum, wish lists, technology integration, and playgrounds. Parents are invited in as volunteers and to celebrate classroom learning. They hold key roles on decision-making committees such as the School Safety Team and Parent Partners. The school provides consistent and effective parent communication through newsletters, emails, conferences, phone calls, and online platforms such as Twitter and Seesaw. In addition, the schools are involved in the community with organizations such as the Tri-State K-9 Response Team, Rotary, local businesses, and emergency personnel.



Climate Surveys:

The Haddonfield School District administers an annual climate survey to all parents, staff, and students (grades 3-12). Climate surveys are completed yearly by all faculty, and students in grades 3-5. These surveys are used to assess these stakeholder' satisfaction with our program. We use these results to determine areas of strength as well as areas where we can improve. The student survey is reviewed by the School Climate Team as it asks students about their thoughts about school and issues related to bullying. The administration closely examines the faculty and parent surveys to determine areas we can grow. School goals may be developed based on survey results.



School Safety:

The district has secured vestibules in 4 of its 5 school buildings, except for the High School, where we employ a School Resource Officer. We currently use the Raptor Visitor Management System at each of our buildings. The district has a School Climate/School Safety Team in each of the 5 schools. Each ABS has been trained in The Role of the School Climate Team and has received NJPSA/FEA Anti-Bullying Certification. The district established a community-wide District Safety Committee to assess the safety needs of the school district. HSD was awarded a \$500,00 grant to provide an emergency notification system complete with wall mounted lockdown buttons, personal lockdown pendants, integrated lockdown announcement through our PA system, remote access controls, and visual strobes in all indoor and outdoor areas of the buildings; video cameras to provide first responders with live feed; 3M ballistic resistant film on all first floor windows; and gun detection software.

Technology and STEM:

Digital learning is facilitated by teacher leaders who utilize Promethean panels and smartboards, technology maps, learning benchmarks, a 3-D printer, laptops, and student iPads. A technology facilitator stipend position provides PD and supports teachers in integrating technology. Coding and STEM concepts are taught in our library curriculum. We also offer students the opportunity to participate in STEAM clubs after school. All students have 1:1 Chromebooks utilizing these devices for increased communication, collaboration, and personalized learning. Google Classroom is our learning management system and is used to provide students with assignments and instant feedback. Software programs utilized include IXL, Discovery Education, Raz-Kids, Typing Agent, XtraMath, Seesaw, Google Classroom, EPIC, Screencastify, iReady Online, Flipgrid, and Lexia Core Reading, and numerous Ipad Apps.



Early Childhood Education:

Haddonfield provides an inclusive preschool program that is tuition-based. The cost is 2970 per year. The preschool is half-day, 5 days per week utilizing The Creative Curriculum. For young children, meaningful and long-lasting learning requires active thinking and experimenting. This is best accomplished through purposeful play facilitated by highly intentional teaching practices. The Creative Curriculum addresses all areas of development: social/emotional, physical, cognitive, and language. It also addresses literacy, math, science, social studies, the arts, technology and process skills. Every preschool class is staffed with an experienced preschool teacher who is special education certified, two experienced Educational Assistants, and therapists who spend considerable time in the classroom providing integrated OT, PT, and Speech services. There is typically a waiting list for this program. We also house the district's ITT program - Preschool program for students with IEPs.



Attendance:

Haddonfield School District boasts an exceptional student attendance rate, fostered by a strong sense of community and a commitment to student engagement. Our schools prioritize building strong connections between teachers and students, creating a welcoming and supportive learning environment where everyone feels valued and belongs. By offering a diverse range of extracurricular activities, including clubs, sports, and arts programs, we encourage students to pursue their passions and find their place within the school community. This holistic approach to education motivates students to attend school regularly, ensuring they have the opportunity to thrive academically, socially, and emotionally.
