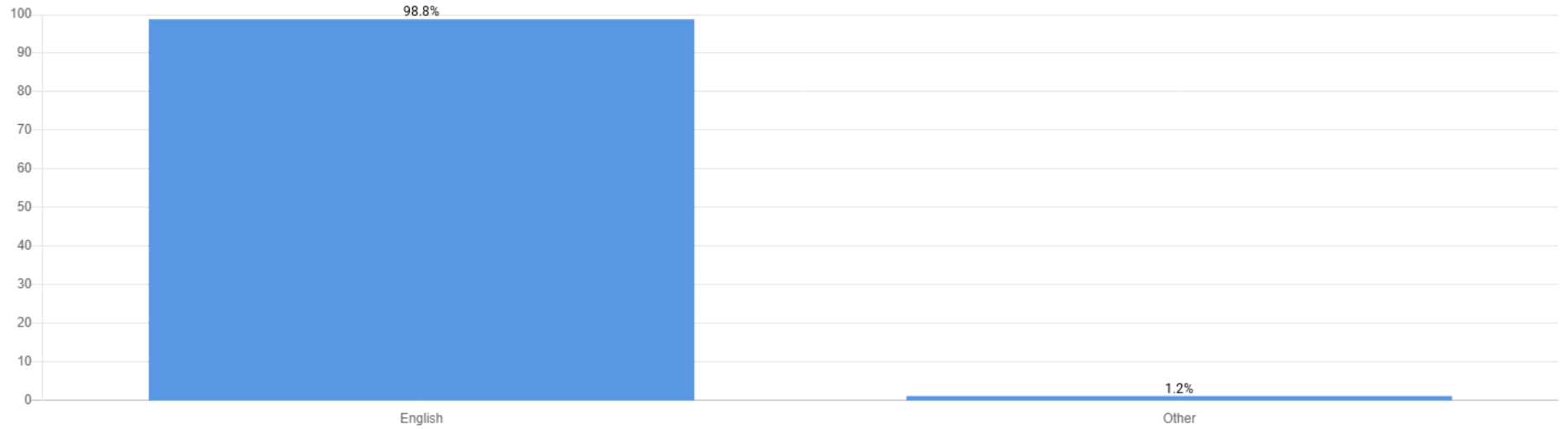

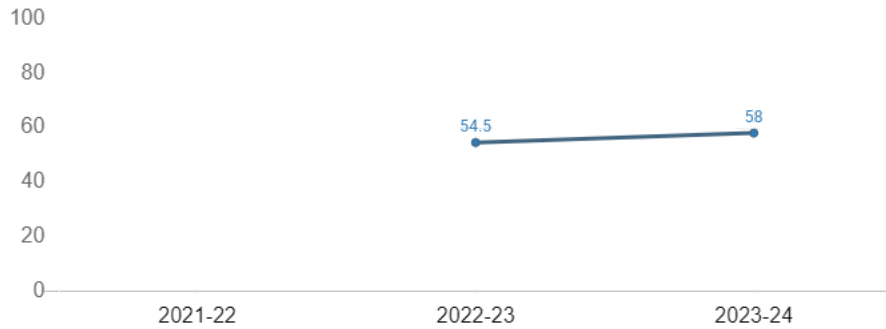

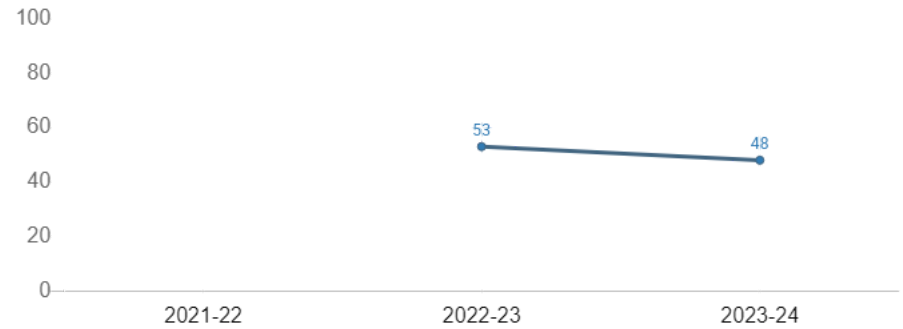

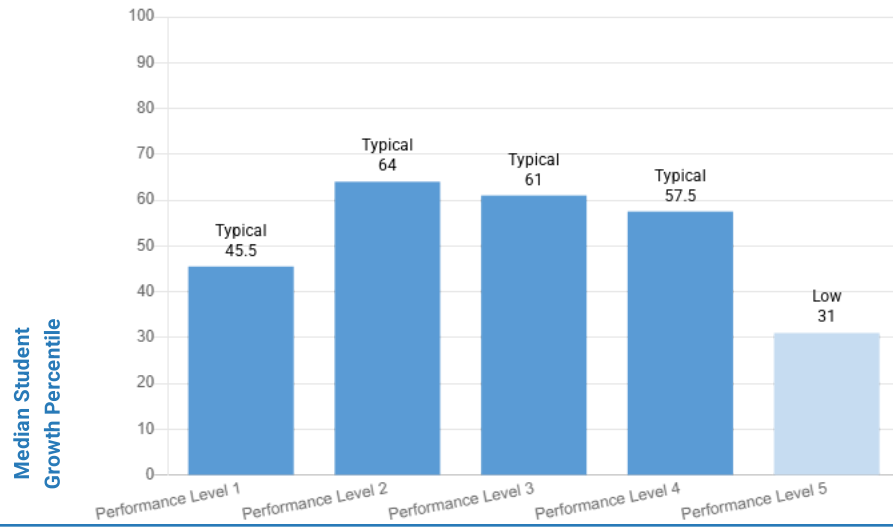

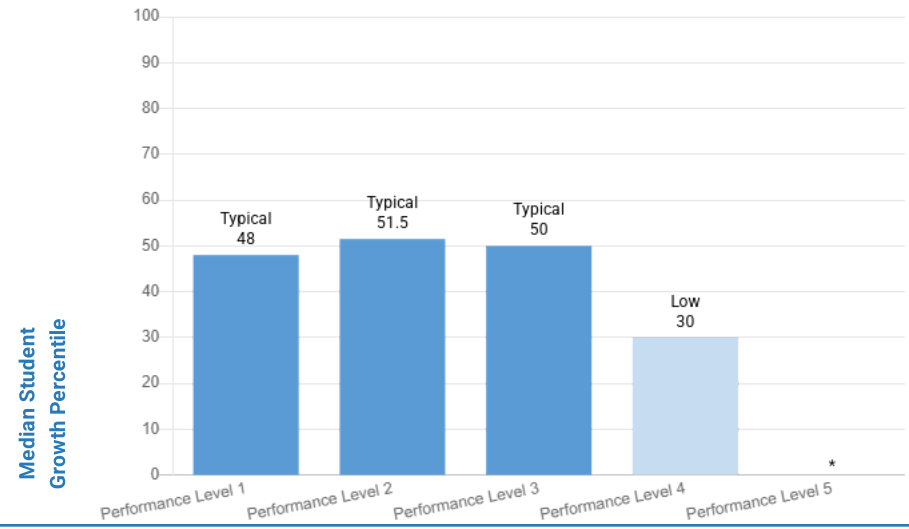

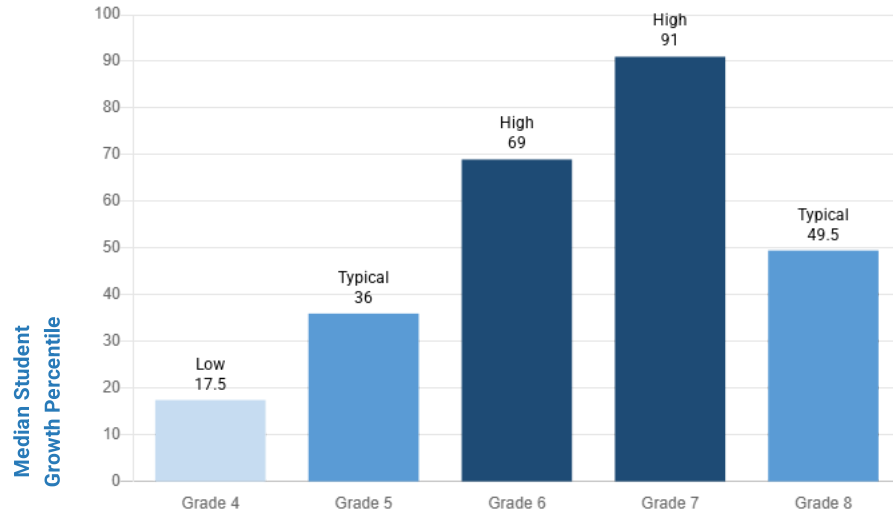

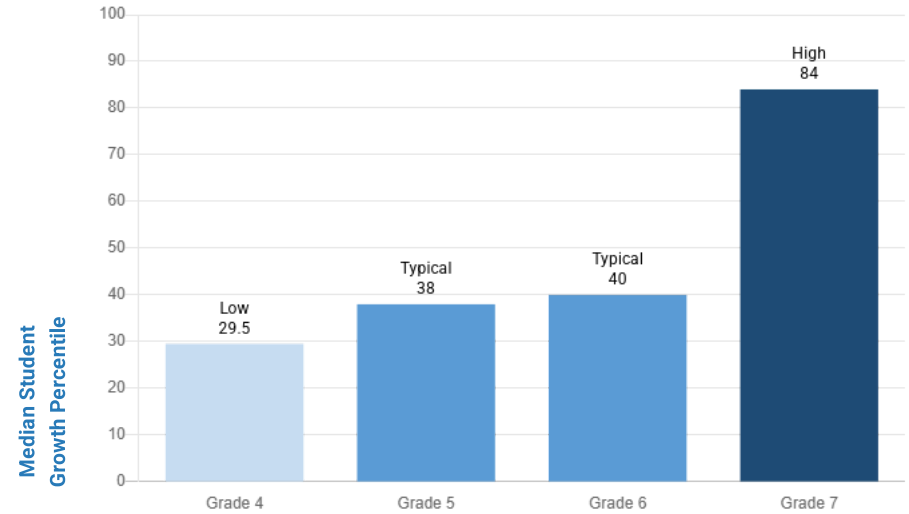

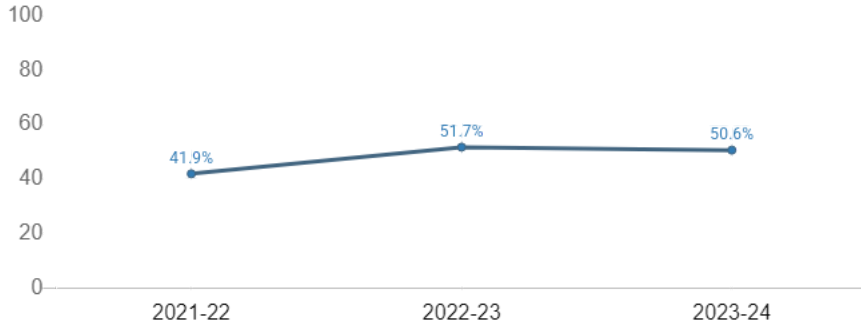

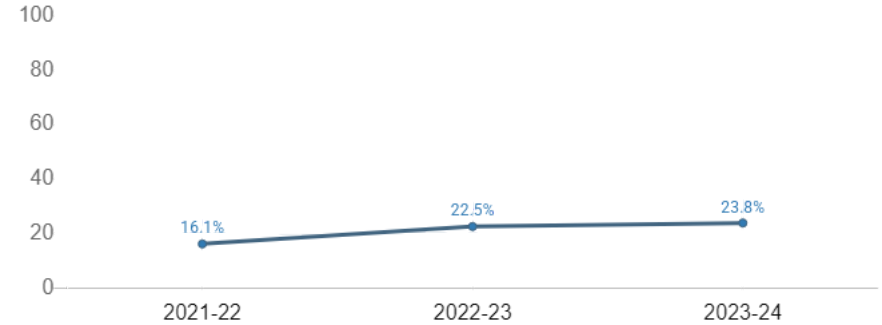
English Language Arts and Mathematics Performance Trends

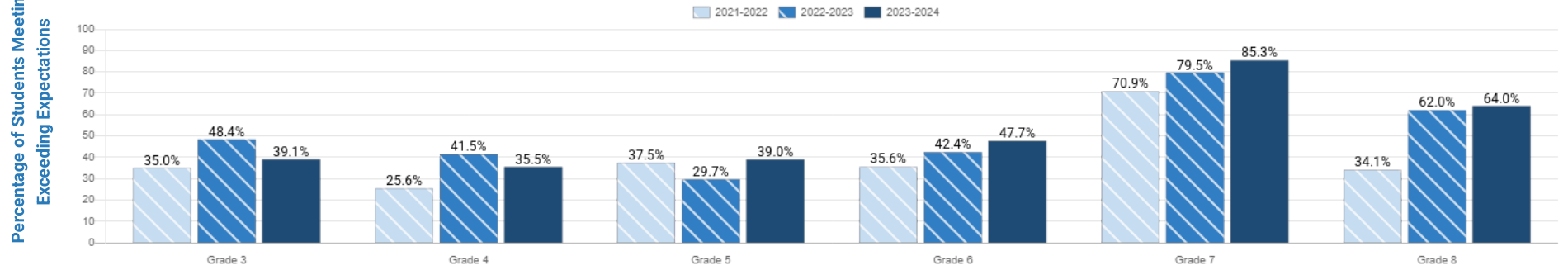

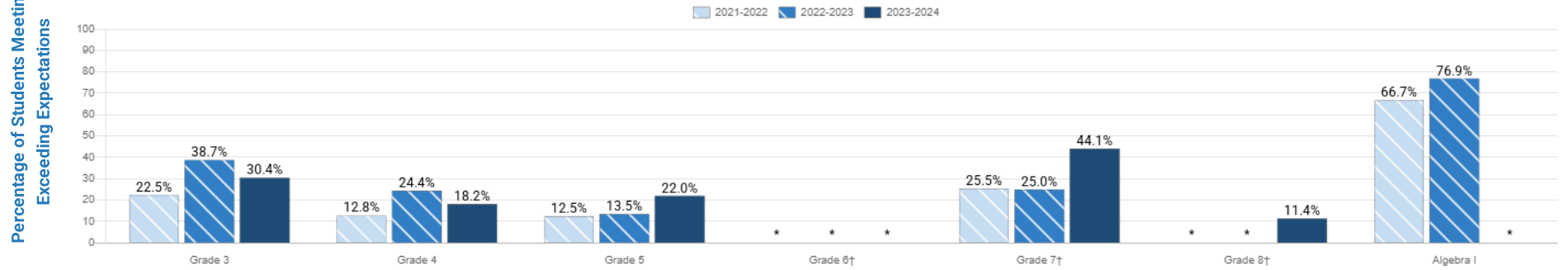

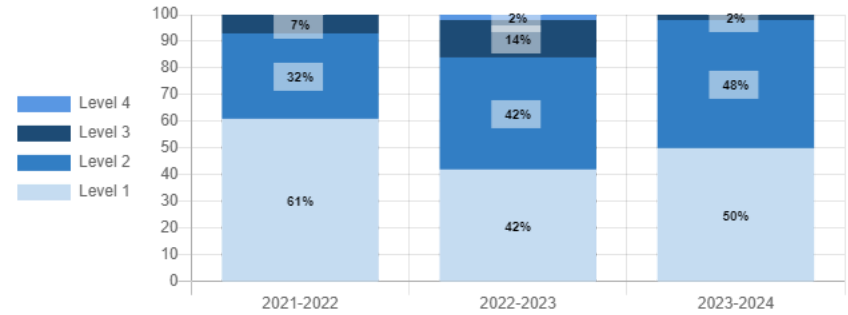

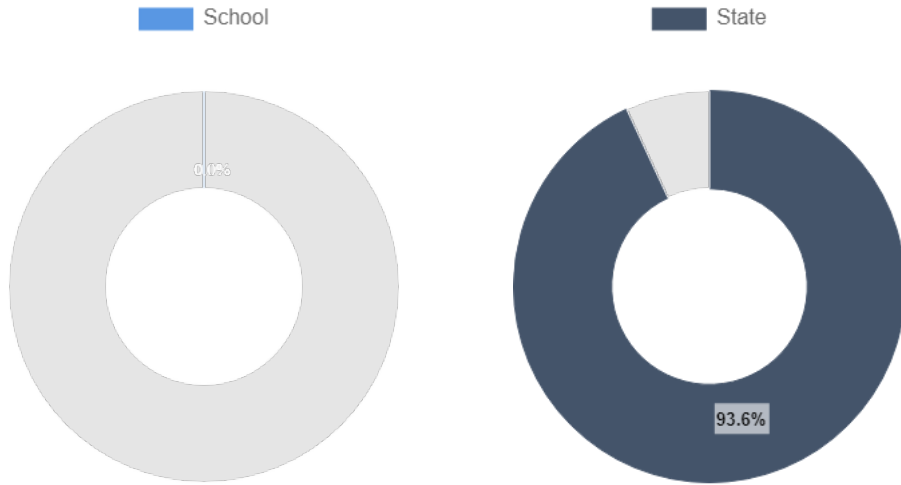

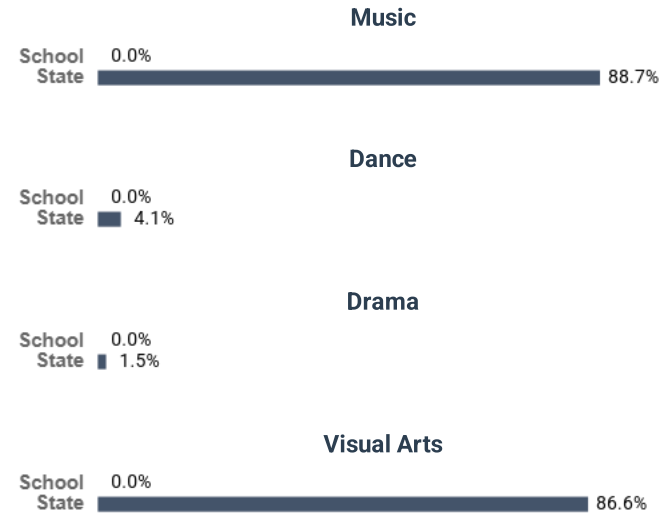

Students enrolled in one or more classes by discipline:



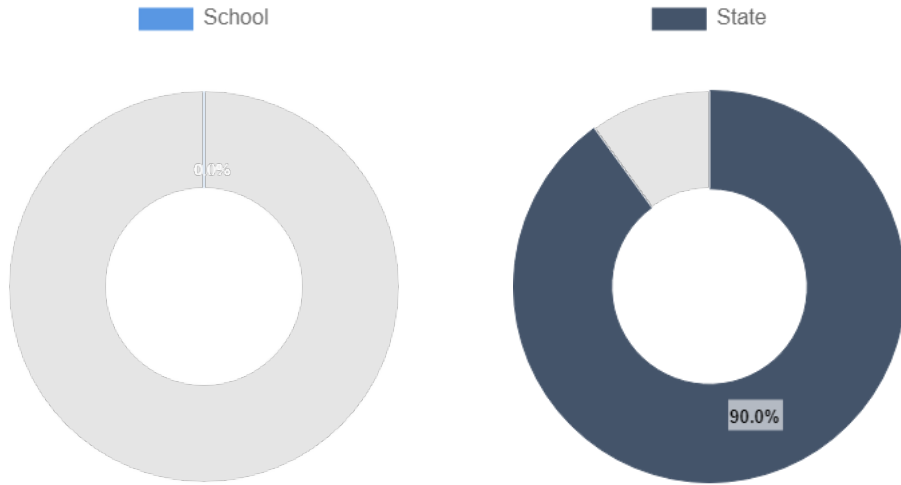

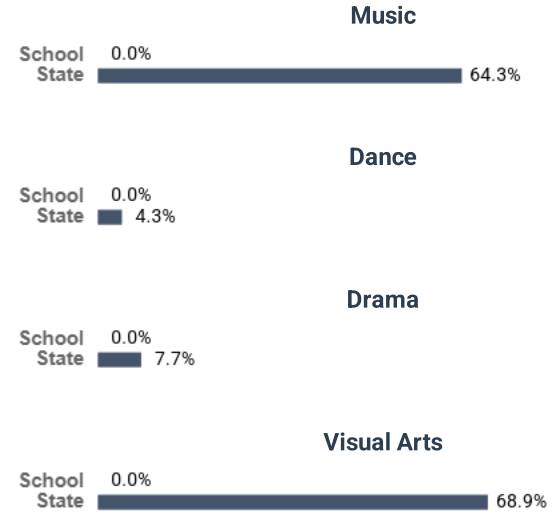

Students enrolled in one or more classes by discipline:



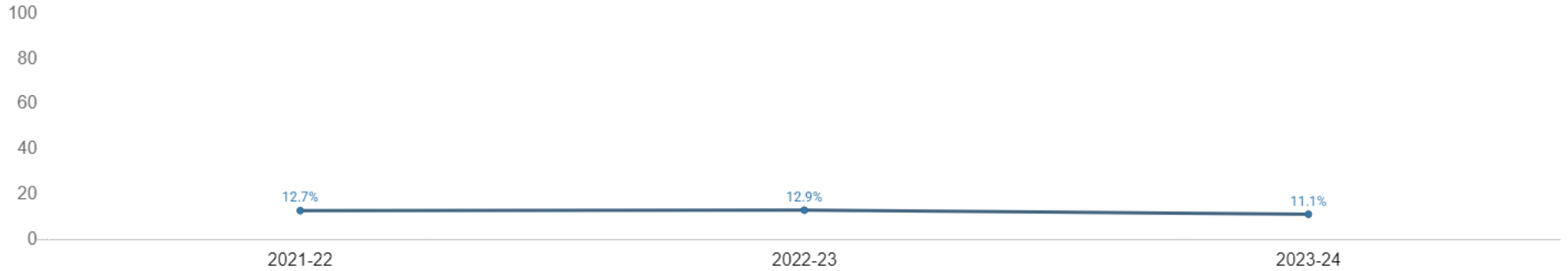

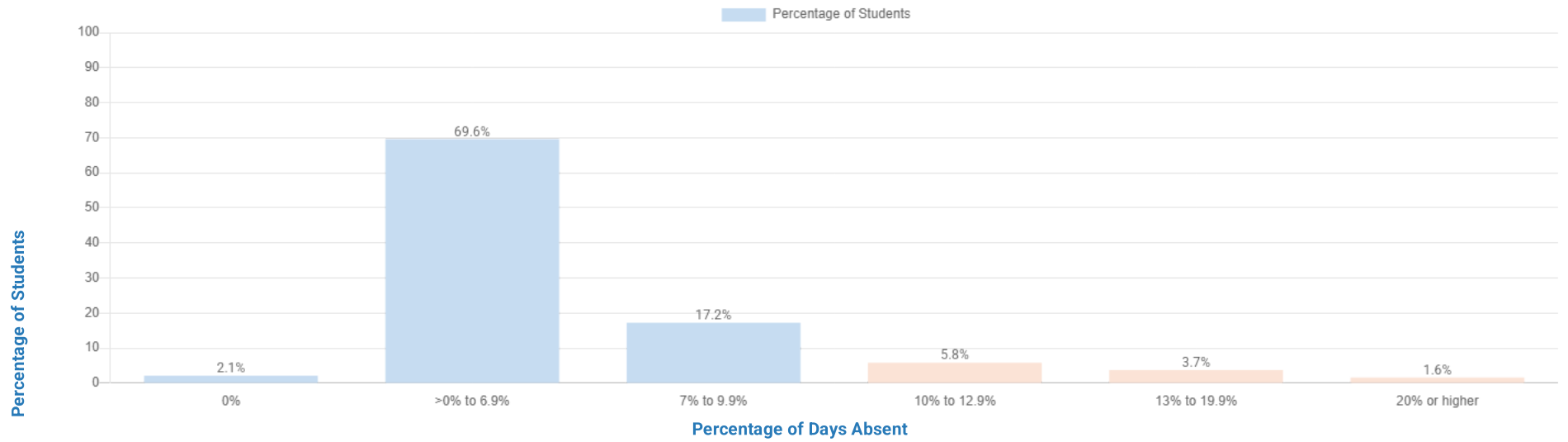

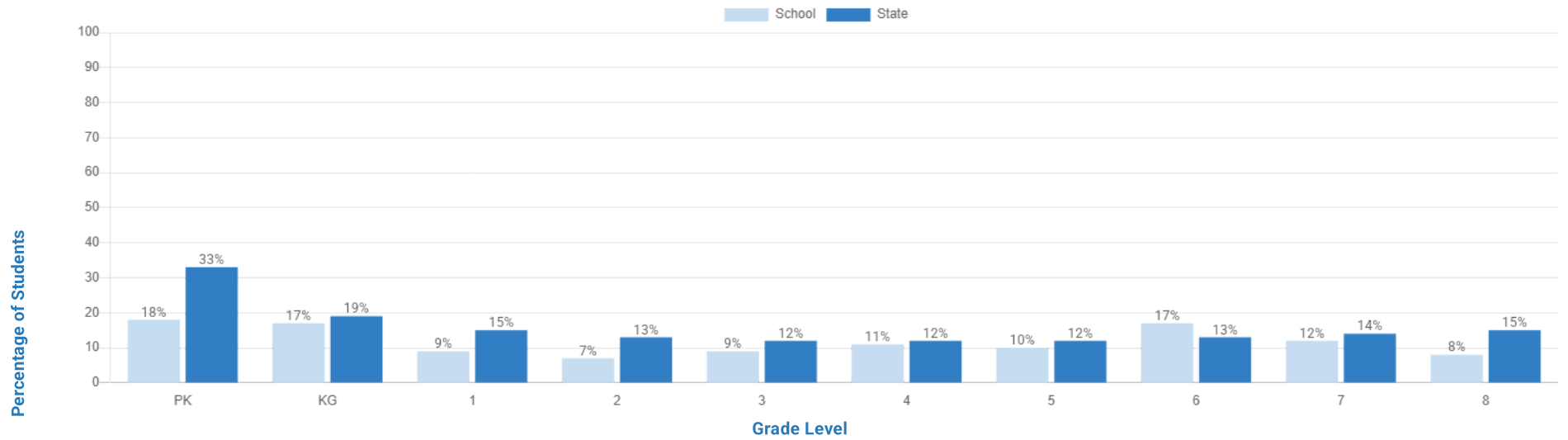

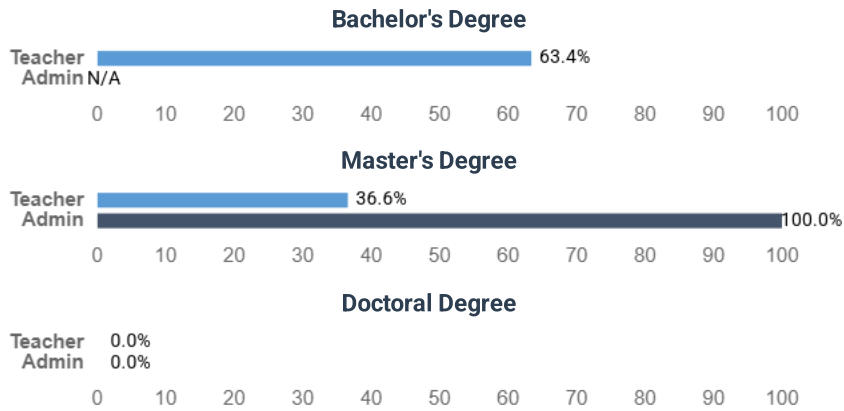

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Student Supports and Services:

The district has a PSD class, a self-contained MD class for grades K-3, resource rooms and inclusion classrooms. At -risk students are seen by our RTI interventionist 2-4 days a week. An I&RS team is available for teachers who have concerns with students who exhibit learning, behavior, or health concerns.



Student Health and Wellness:

Magnolia offers a breakfast program before the start of school. All students in Kindergarten through 8th grade have physical education twice a week plus a recess period daily. Our guidance counselors and members of the CST provide SEL (Social Emotional Learning) groups throughout the week to focus on student's well being. Assemblies on anti-bullying are held each year.



Parent and Community Involvement:

Parent involvement at Magnolia is of utmost importance in our one small square mile of friendliness. PTO is very active and involved and provides activities and events throughout the school year. Various events include: Book Fair, Movie Night, Science and Math Night and Dances. Parents can access students attendance and academic progress through the Oncourse Parent Portal. The local student youth athletic organization utilizes the gym for sport clinics.

Technology and STEM:

All students in grades 3-8 have their own device operating from Google. Our STEAM teacher and our science program lends itself to project based learning and STEAM activities. In addition, a Robotics club is offered after school.



Early Childhood Education:

Magnolia offers PreK full days for children who are three and four years of age. Children are chosen through a lottery system for open spots. The mission of this class is to afford the opportunity to expose children who are typically developing with those students who are eligible for special education. The recommended curriculum used is Tools of the Mind. In addition to our currently three full time classrooms, Magnolia also has a full time PSD classroom for the three and four year old students with special needs.



Attendance:

The Leader In Me research based program is used to support social emotional learning and address student's mental health . Leader In Me is based on Stephen Covey's 7 Habits of Highly Effective People. This framework uses the habits to transform our school culture. Our district's belief is educating the whole child to help them become proactive, well-rounded students who are compassionate, critical thinkers, leaders and life-long learners.
