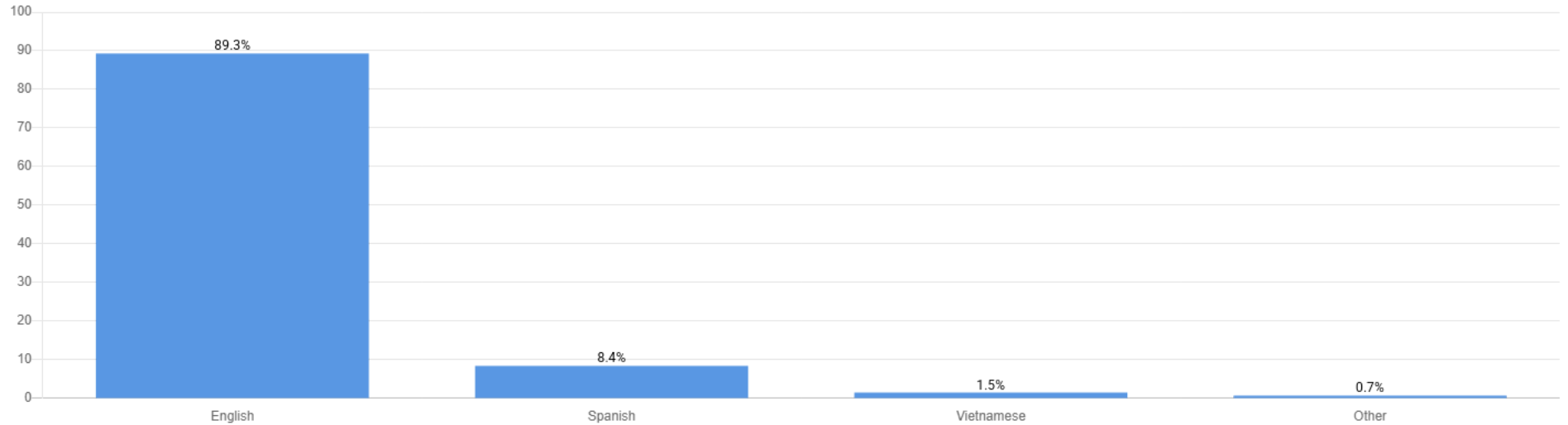

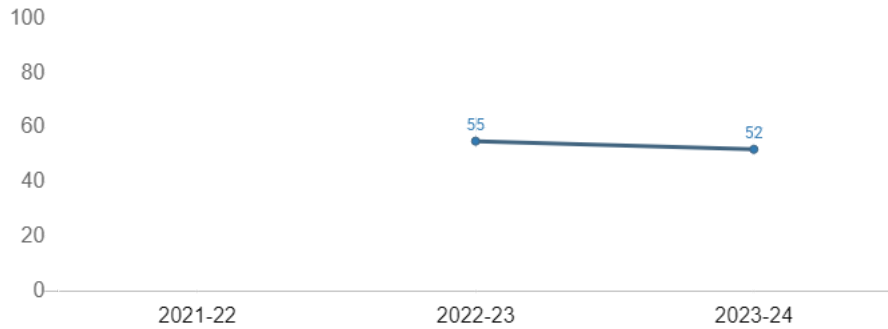

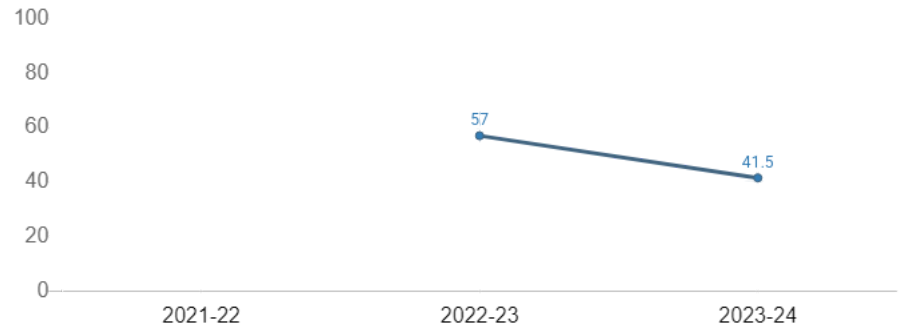

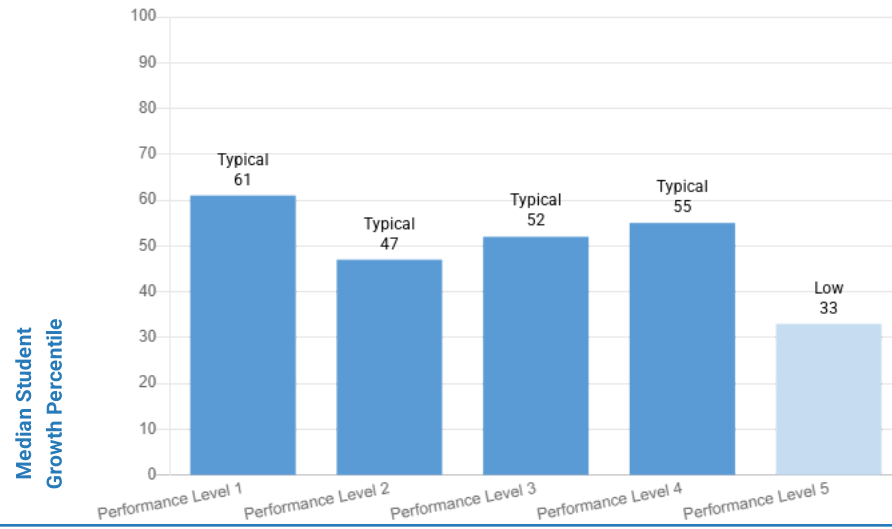

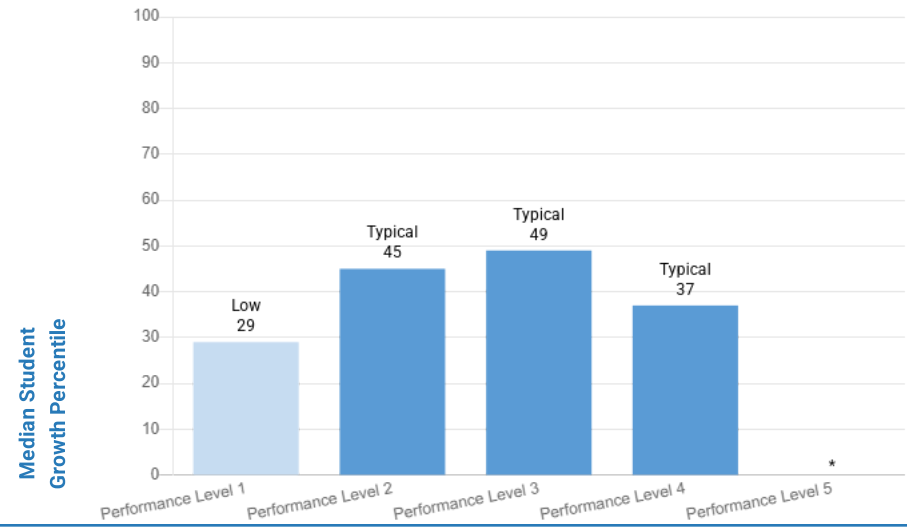

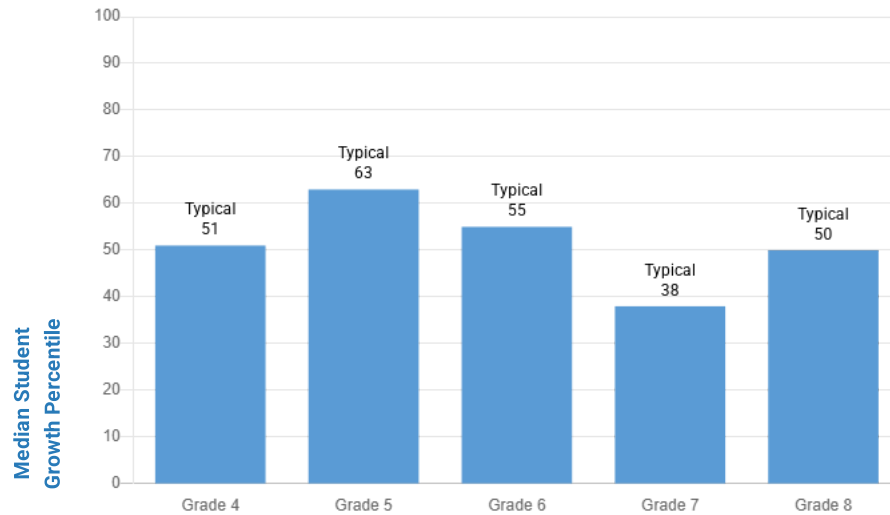

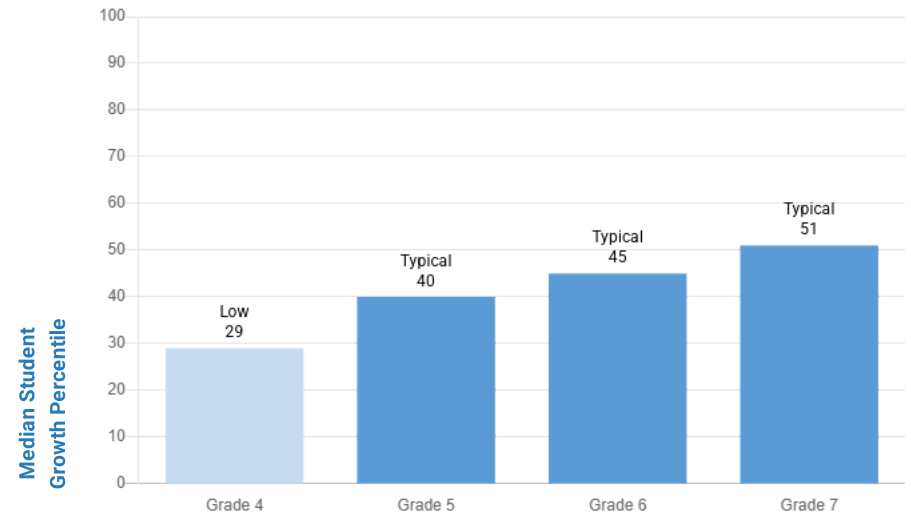

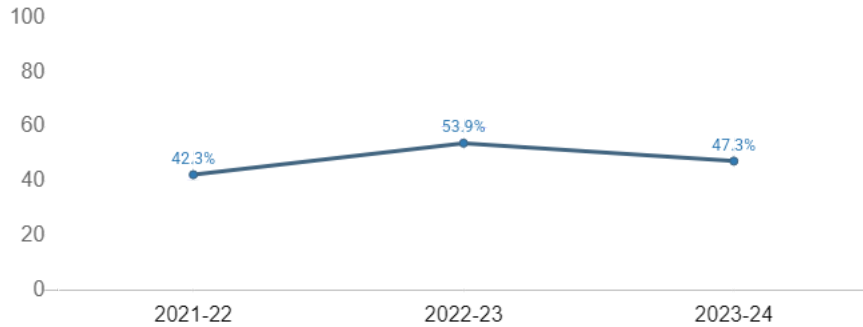

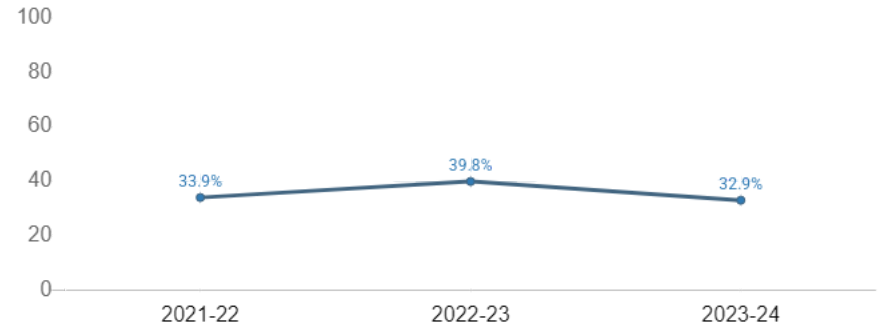
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 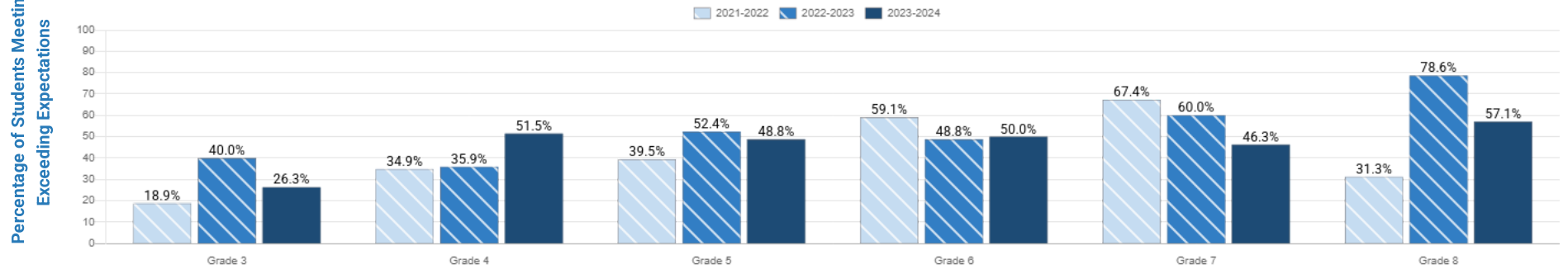

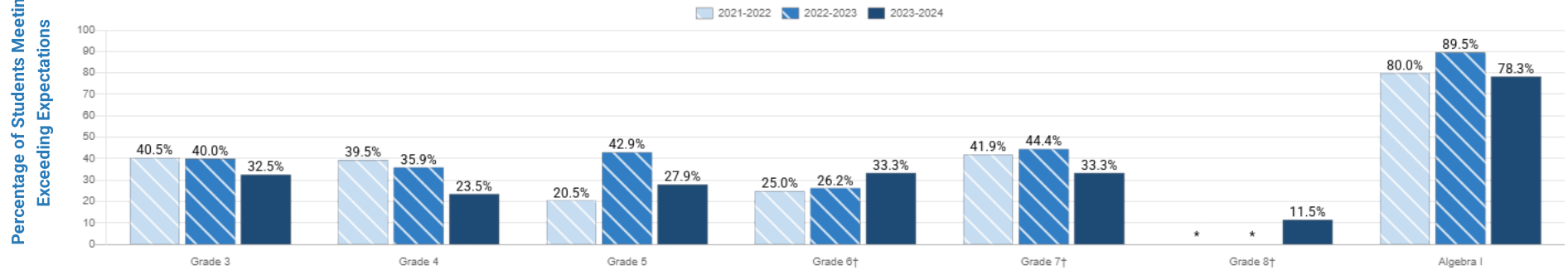

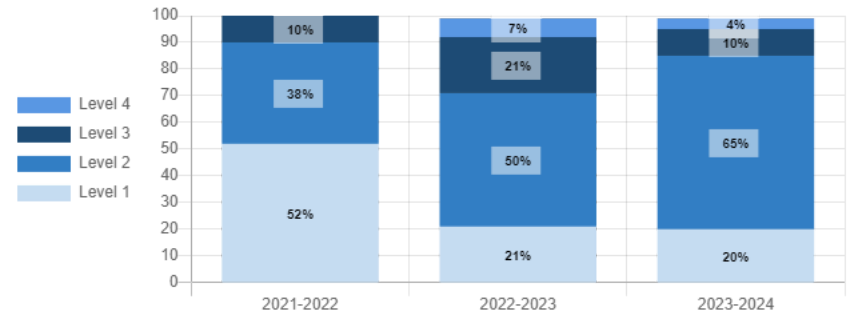

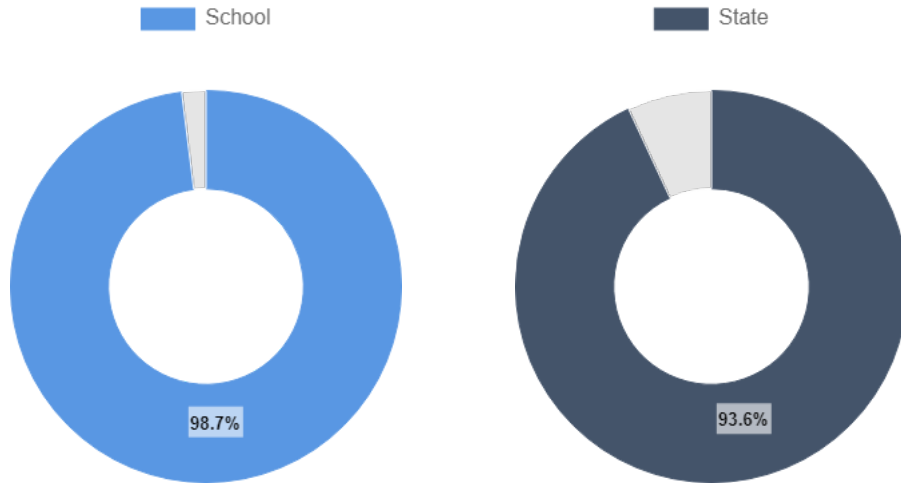

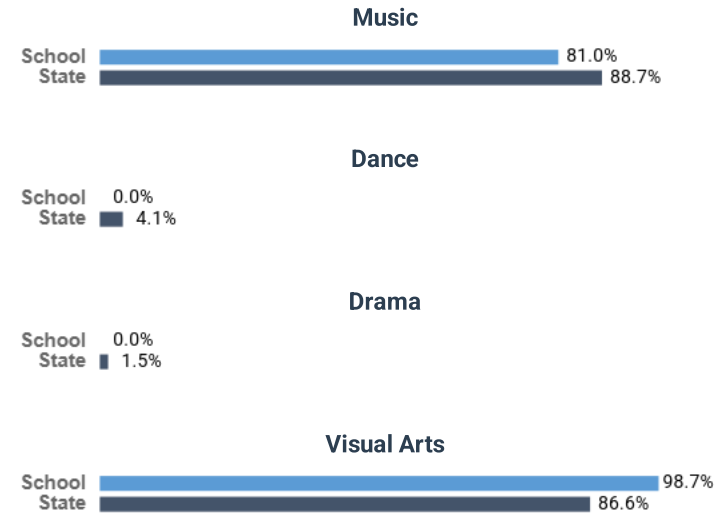

Students enrolled in one or more classes by discipline:



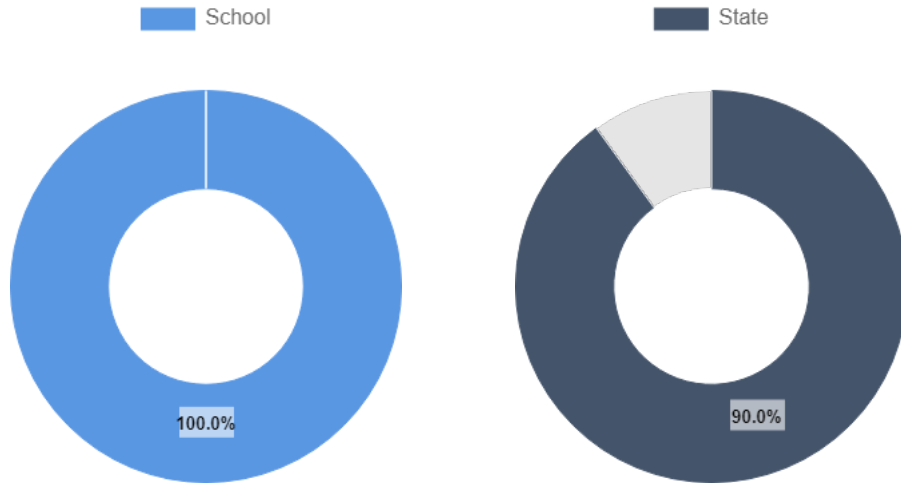

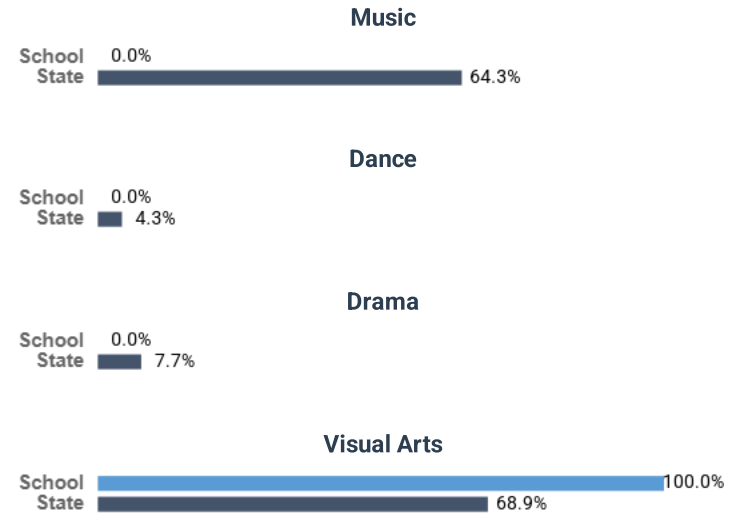

Students enrolled in one or more classes by discipline:



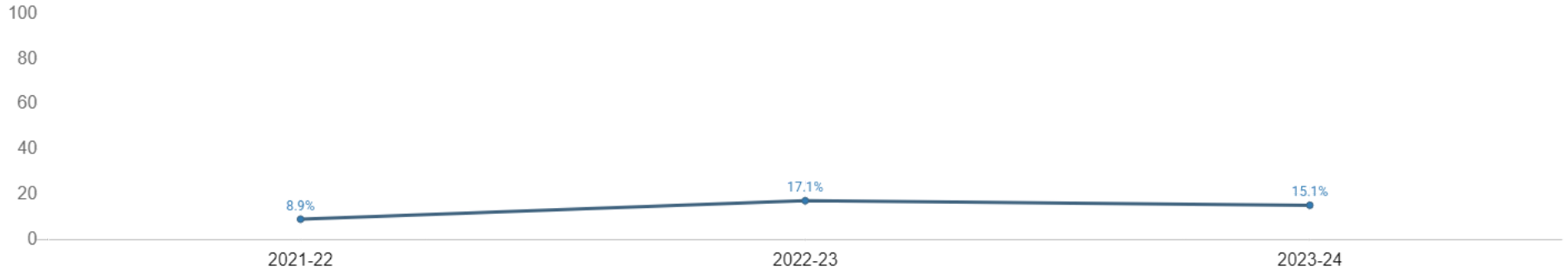

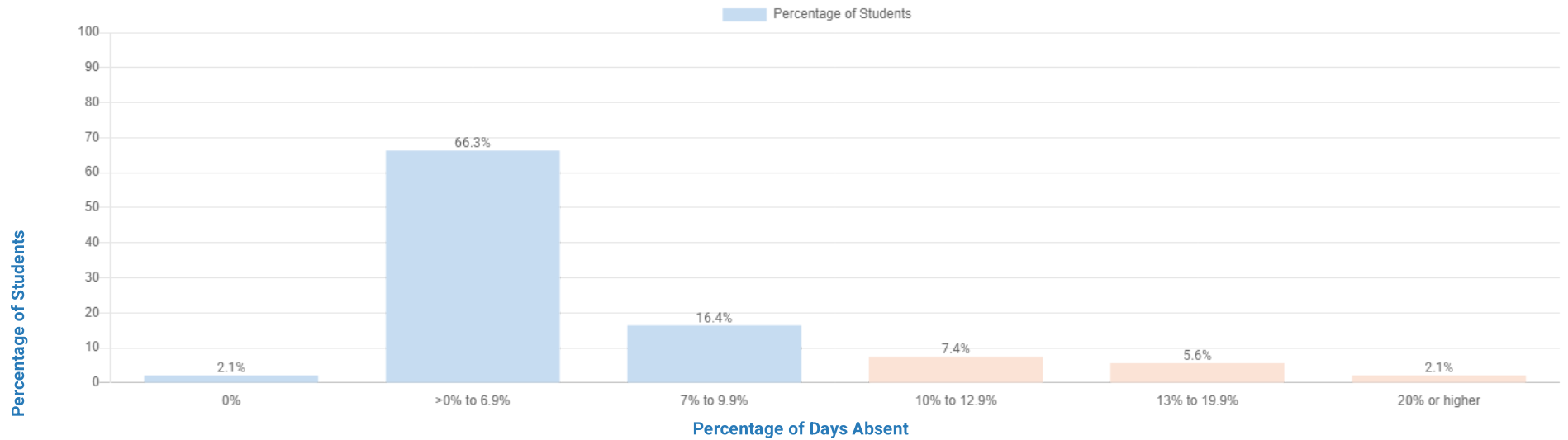

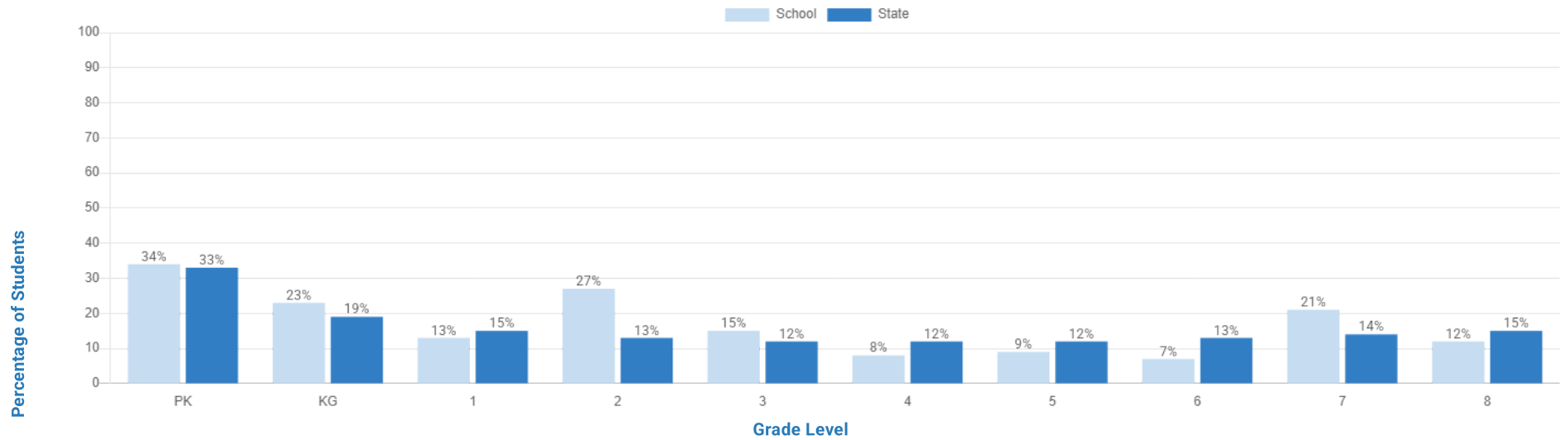

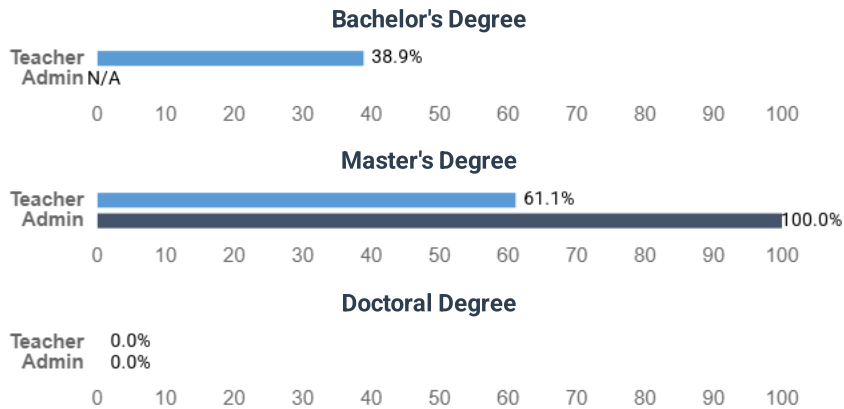

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Technology and STEM:

Technology is a part of the everyday curriculum at Merchantville School. Students in grades 6 - 8 are given a Chromebook to utilize in and out of the Classroom. Students in grades 1 - 5 have access to class sets of Chromebooks in every classroom as well. Our students use Google Classroom regularly to access lessons and assignments. iPads are in the Pre-K & Kindergarten classrooms where students will use various apps to support the learning. Teachers incorporate technology skills and standards into the general education curriculum.



Early Childhood Education:

Merchantville School offered a half day pre-school program to students that are 4 - 5 years old. The program is 3 hours per day and there are two sessions, an AM and PM session. Our Kindergarten program is a full day program for students that are 5 - 6 years old. The hours are 8:20 to 3:00. We are looking for ways to expand our Pre-School program to full day. This is District Goal set by the Board of Education.



Attendance:

Merchantville School is committed to using funds wisely to support the growth of our students. Our BSI program includes a robust Tier 2 intervention of WIN (What I Need) where students receive daily services based on their individual needs through assessment data. Students have targeted goals based on their individual needs. We host a Summer Knights program to ensure minimal learning loss over the summer for our needy students. We offer Algebra 1 to 8th grade students to allow them to start high-level classes in the first year of high school. We also use our funds to provide SEL opportunities to ensure a safe environment for our students.
