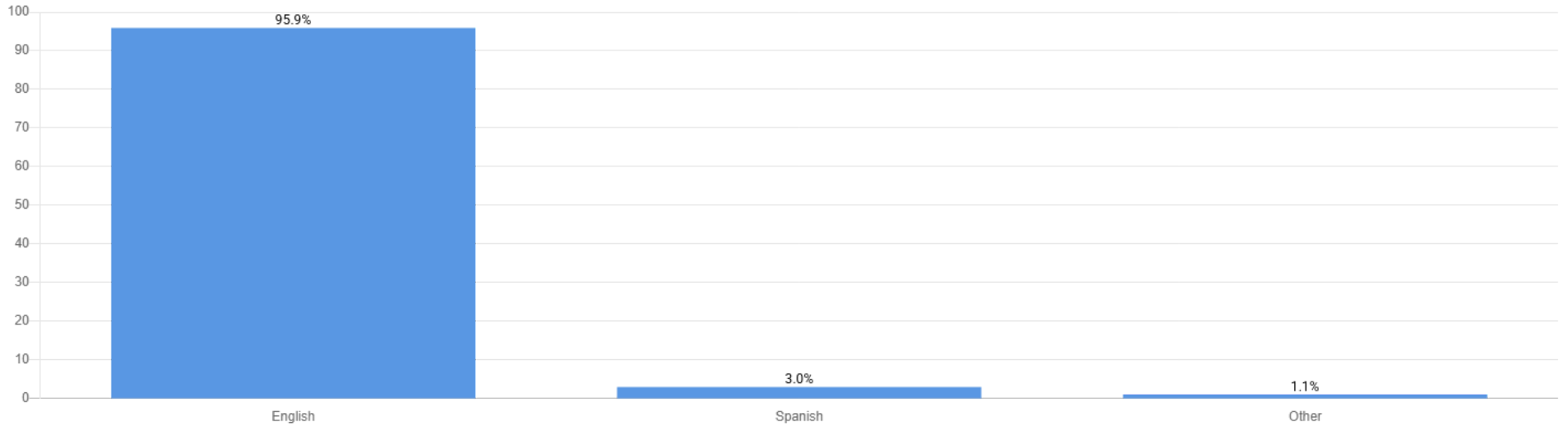

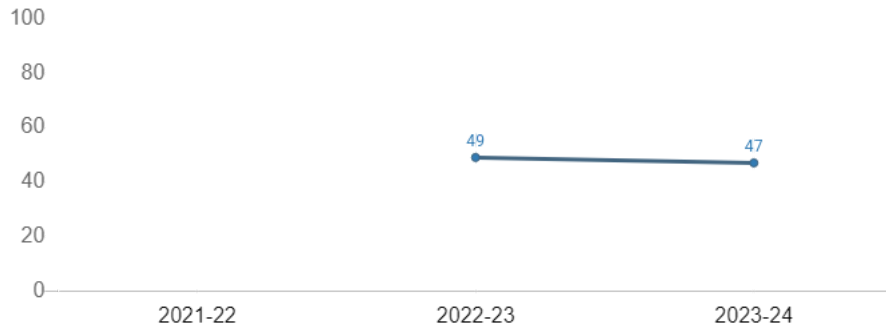

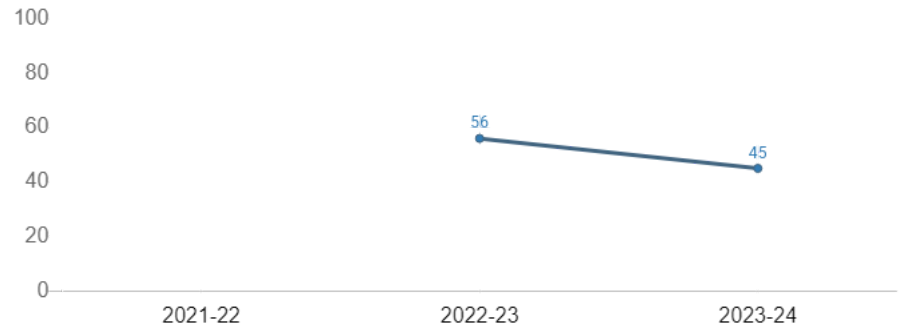

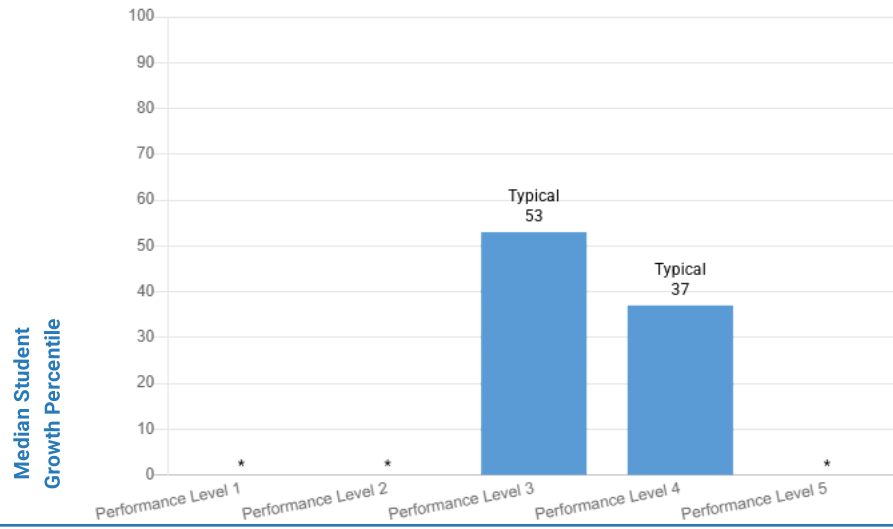

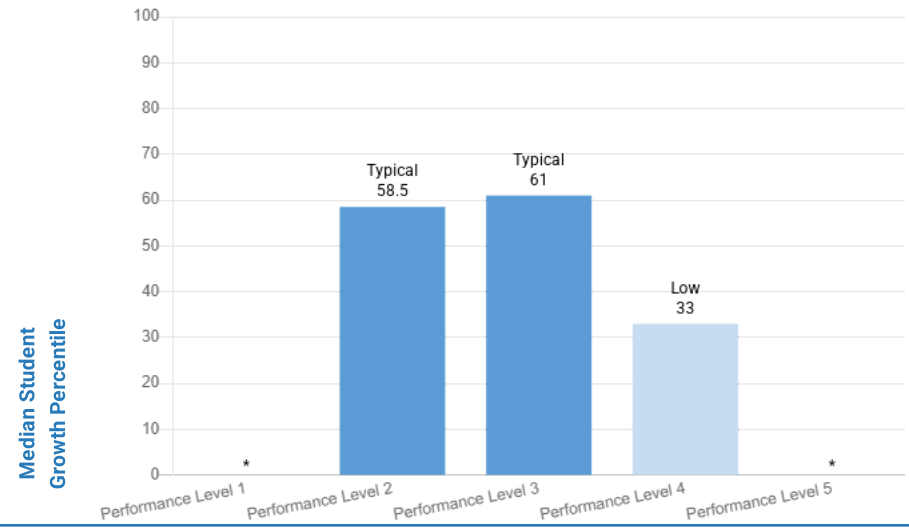

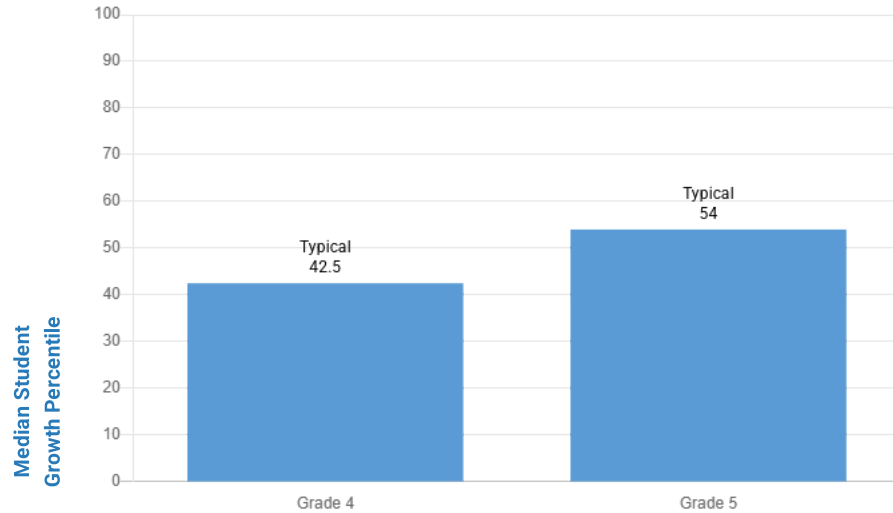

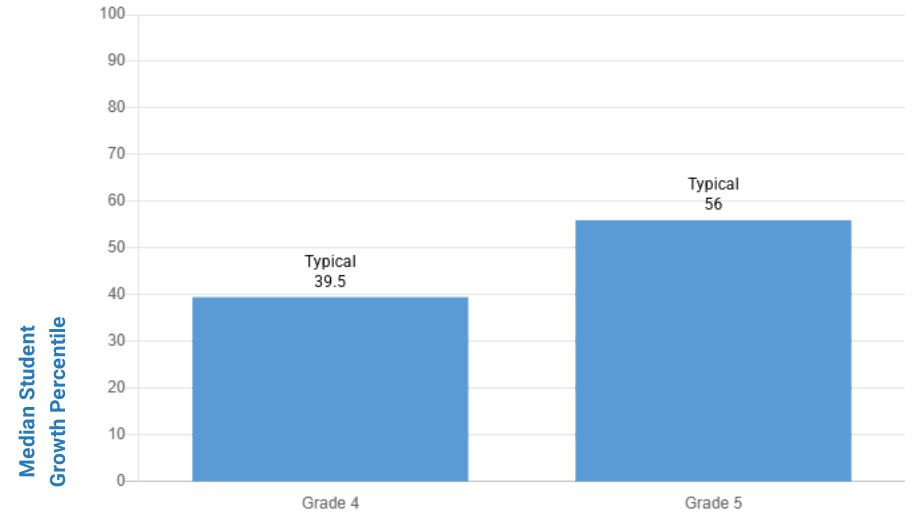

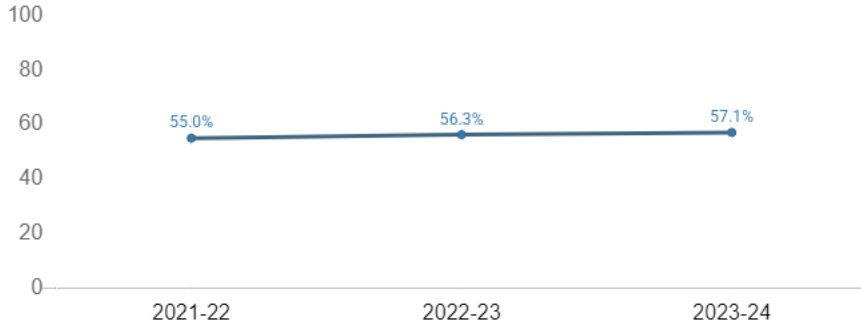

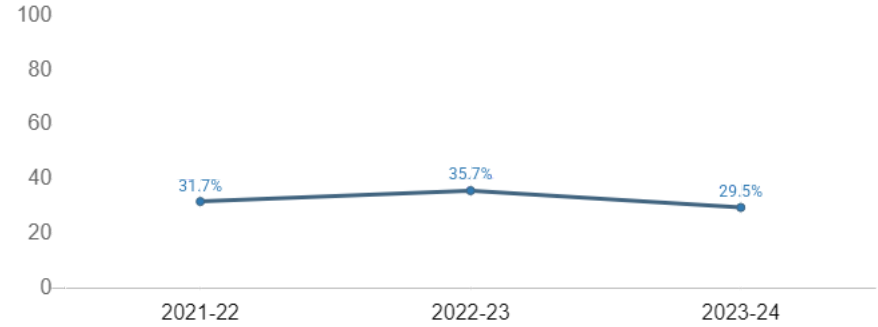
English Language Arts and Mathematics Performance Trends

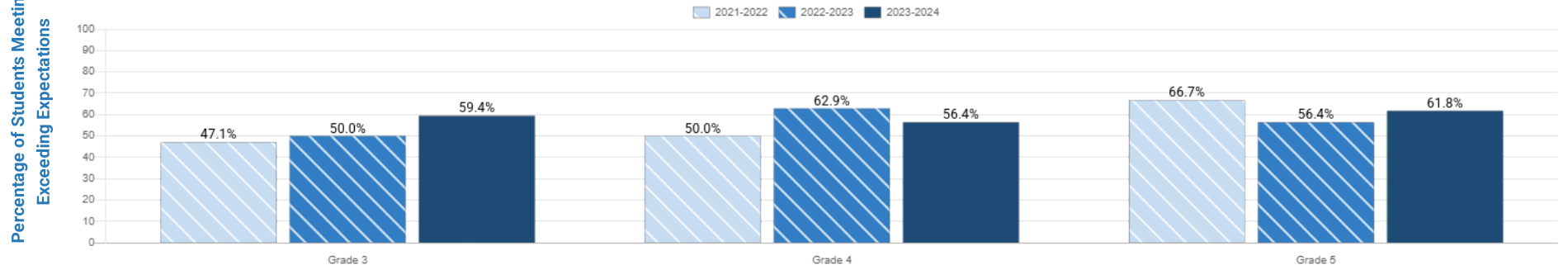

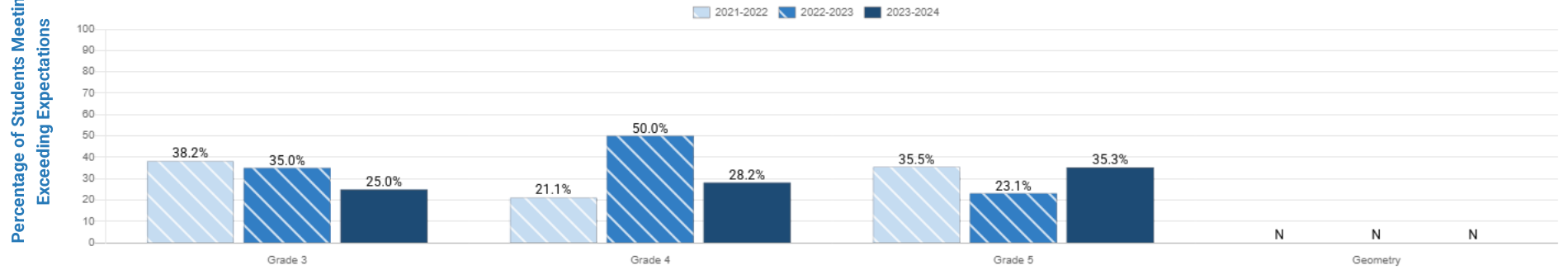

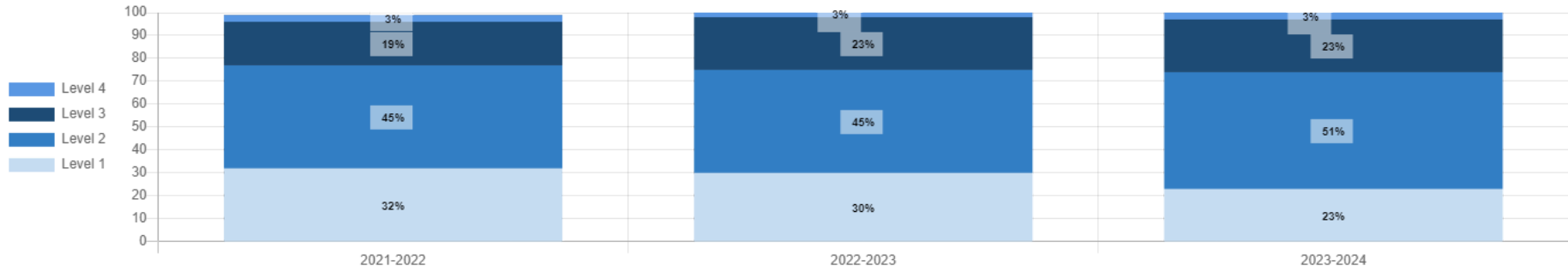

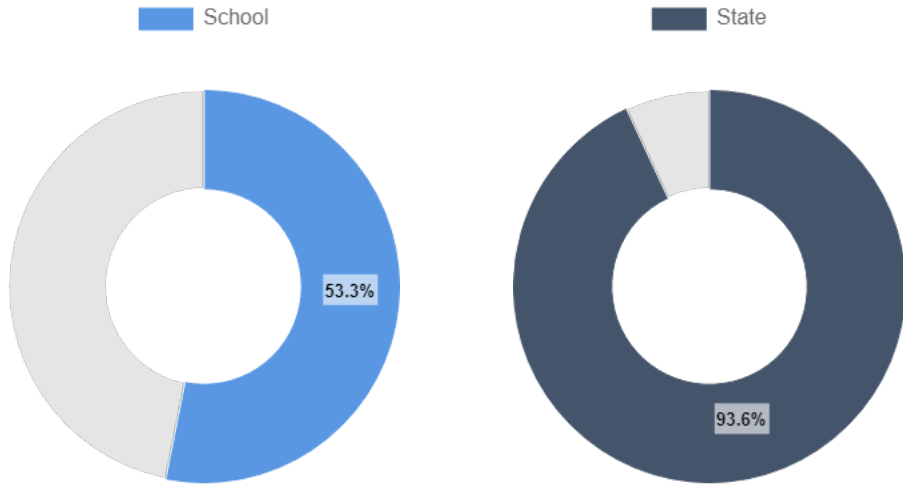

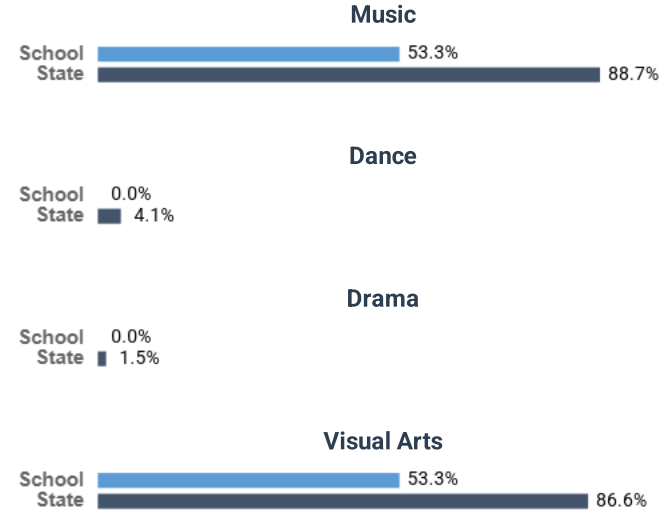

Students enrolled in one or more classes by discipline:



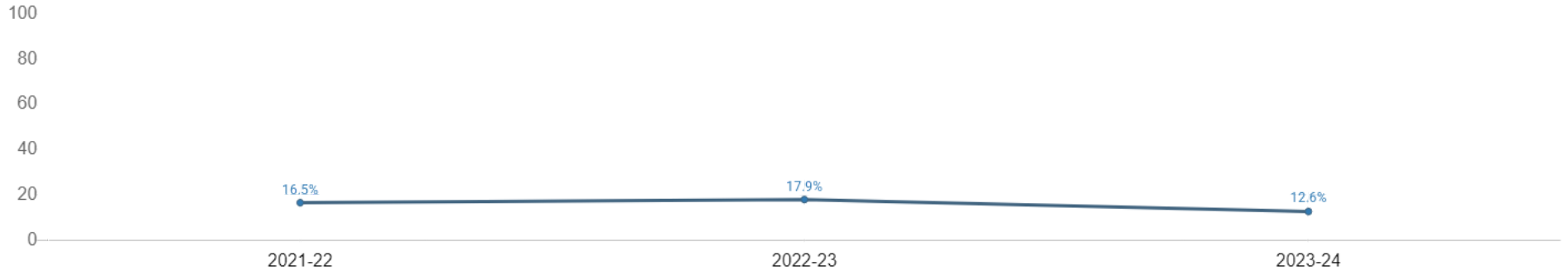

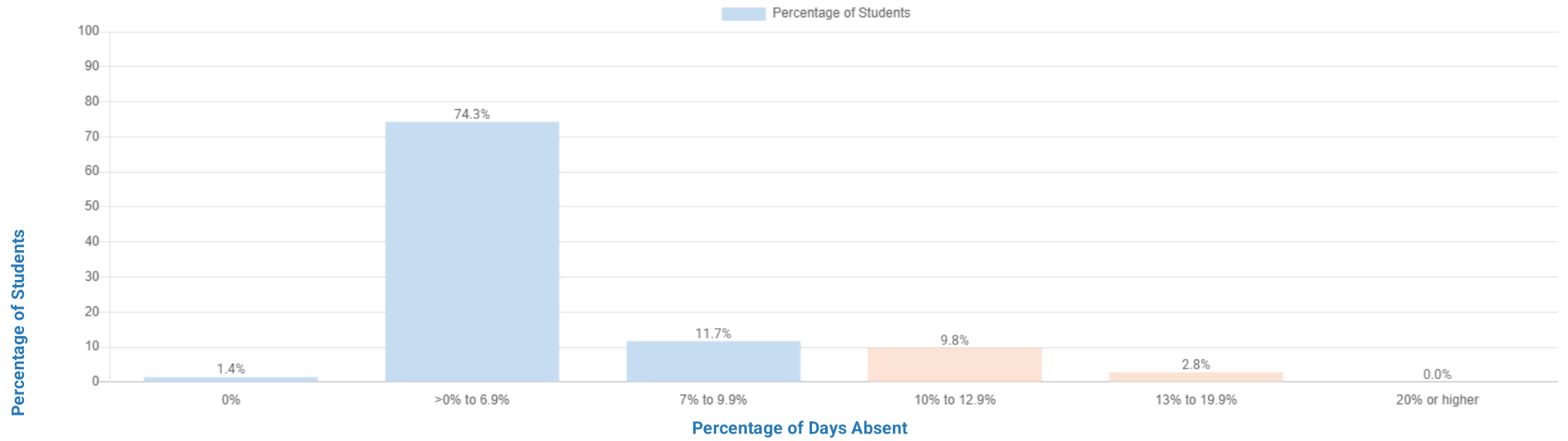

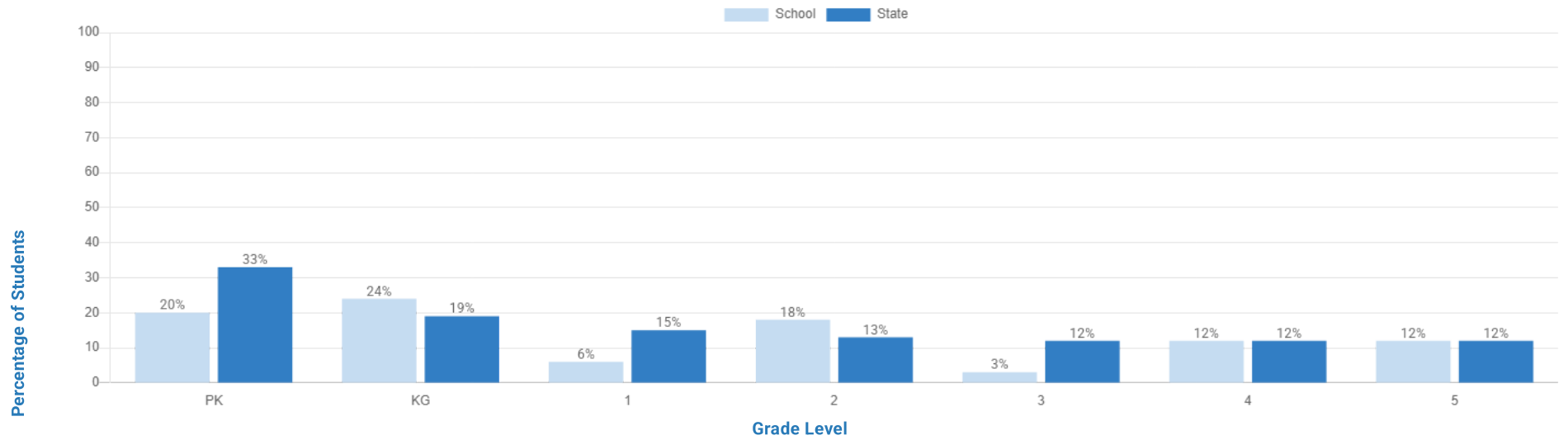

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. 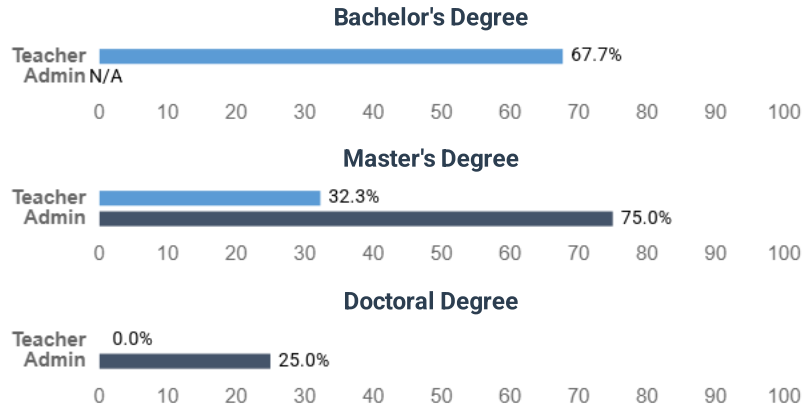

We also have a multi-tiered system of support (MTSS) program in place. Teachers refer students who are struggling academically and/or socially and emotionally in the general education setting. The MTSS team meets regularly to determine what interventions will be most beneficial for the students who are referred, and to track student progress throughout the year. Oaklyn also offered some mental health support to our students and their families.

Student Health and Wellness:

We have a full-time social worker on staff who provides some student counseling and provides families with additional resources. We have also teamed up with Jefferson Health in order to provide some individual student counseling services right in our own building. Students who are in need of specific health services receive some of these services in school under an Individualized Health Plan (IHP). These plans are written by our school nurses in collaboration with the families who request them. We have one full-time nurse and one part-time nurse on staff daily. Our school nurses organize programs and assemblies to teach students about various health related topics. All students participate in health classes weekly. Students are offered breakfast daily. Our physical education classes are offered two days per week to all students in grades preschool K - 5. All students also have thirty minutes of scheduled recess time daily.



Parent and Community Involvement:

A few key organizations that help raise money to benefit our students include our very active and supportive Parent Teacher Association (PTA), the Oaklyn Municipal Alliance Youth Services Commission (OMAYSC) and the Oaklyn Education Foundation (OEA). The Oaklyn Police Department and Fire Department are also very active within the school. They organize programs for our students such as Fire Prevention and Emergency Responders Day and they assist us with our school fire and security drills.



Facilities:

The Oaklyn Public School was built in 1926. This historic building contains classrooms for all students grades preschool through five, a full kitchen, cafeteria, stage, gym, library, and a sensory room for our physical and occupational therapists. In addition, three of the Collingswood preschool classrooms are located in our building. Within the last five years we replaced our roof, installed new windows, upgraded our HVAC system and enhanced school security by building a main entrance security vestibule.

School Safety:

The Oaklyn Police Department is very active in our security drills. They attend all monthly drills and provide feedback based on their observations. Our school has security cameras on the inside and outside of the building and our police department also has the ability to view these cameras from their station. All visitors must first ring the main office in order to gain entry. Once they are inside, they are limited to a security vestibule and must show ID, sign in and receive a security badge before accessing the school. All staff have been assigned security buttons. We have an automated security system that can be activated by pushing the staff buttons or other buttons located around the building. This system automatically notifies the police department.



Technology and STEM:

All students in grades K-5 participate in a STEAM enrichment course. STEAM activities are also incorporated into our math, science and recess time. All students grades K-5 have access to chromebooks, Mimio boards and document cameras daily. We also just purchased a new 3D printer for our STEAM classroom. All students and staff members K-5 have chromebooks or laptops (1:1), and every classroom is equipped with a document camera and interactive whiteboard.



Early Childhood Education:

The Oaklyn Public School offers universal preschool to families of three and four year old children who reside in the borough. Our preschool students attend school for a full day with breakfast, lunch, nap and outside play built into their daily schedules. We share a preschool supervisor, master teacher, PIRT leader and community liaison with Collingswood Public School District. We installed a big, beautiful playground that our preschool students use daily. Our preschool teachers are all certified early childhood educators and every classroom has an instructional assistant. Our preschool team receives training monthly on topics such as curriculum (Creative Curriculum), assessment (Teaching Strategies GOLD) and social emotional learning. We are very proud of how successful this program has become in such a short period of time!

To date, our district has used our ESSER funds to address learning loss due to the pandemic by hiring some additional learning acceleration teachers, providing staff with ongoing professional development focusing on Visible Learning, purchasing new classroom library books and other supplemental curriculum materials, offering before and/or after school clubs, and hosting a four week summer STEAM program for identified students in grades K-5. This year, we revised our academic schedule. Our schedule now includes daily universal intervention time for all students in the area of ELA and Math. We have a multi-tiered system of support program in place. All students are universally screened in the area of ELA using mClass/Dibels 8, and Math using Into Math/Waggle. With the new schedule in place, teachers also have more uninterrupted PLC time in the morning in order to meet with their PLC teams to analyze assessment data, appropriately group students, and plan specific interventions.

Other Information:

Learning acceleration teachers ensure that every K-5 classroom receives push in support during ELA and math time daily. Before or after school clubs are hosted by our teachers throughout the year. Students who are identified as needing additional academic and/or social and emotional support in grades K-5 are invited to attend our four week long summer STEAM program. In addition, we have a full-time social worker on staff. She offers tier two mental health support to our students and provides our families with other mental health resources. In addition, we offer some individualized student counseling services on site through a partnership with Jefferson Health.
