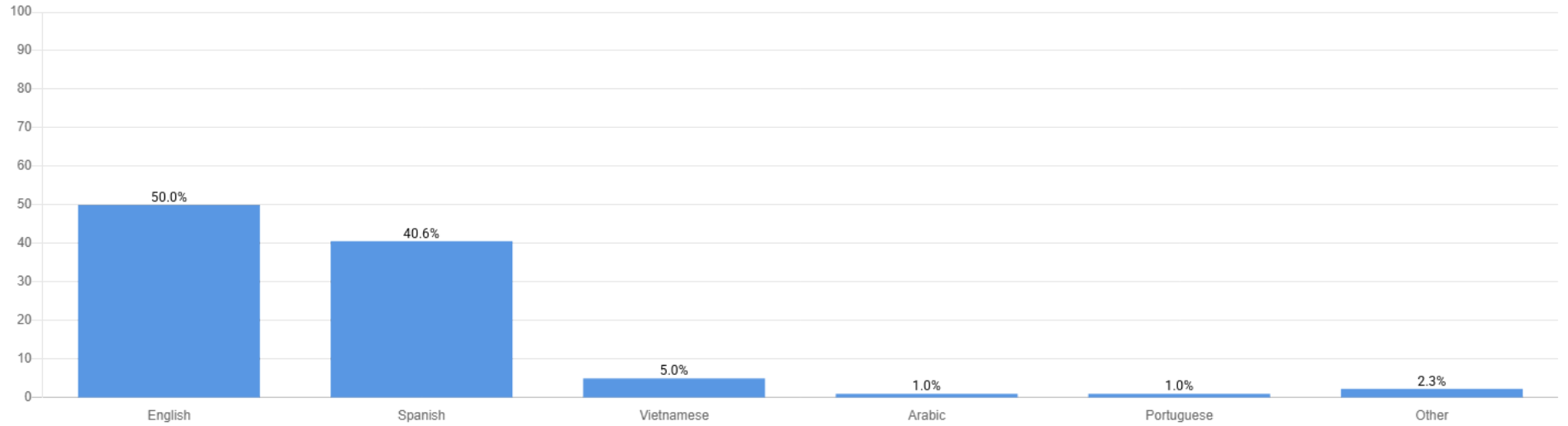

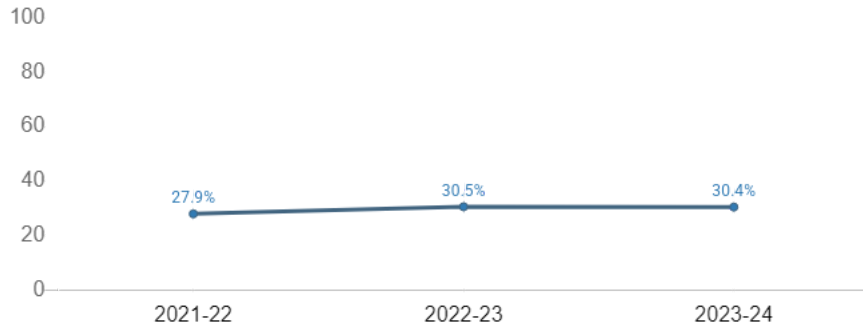

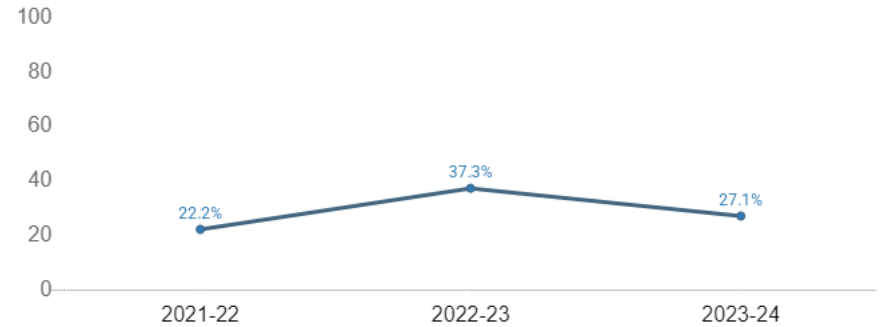
### English Language Arts and Mathematics Performance Trends

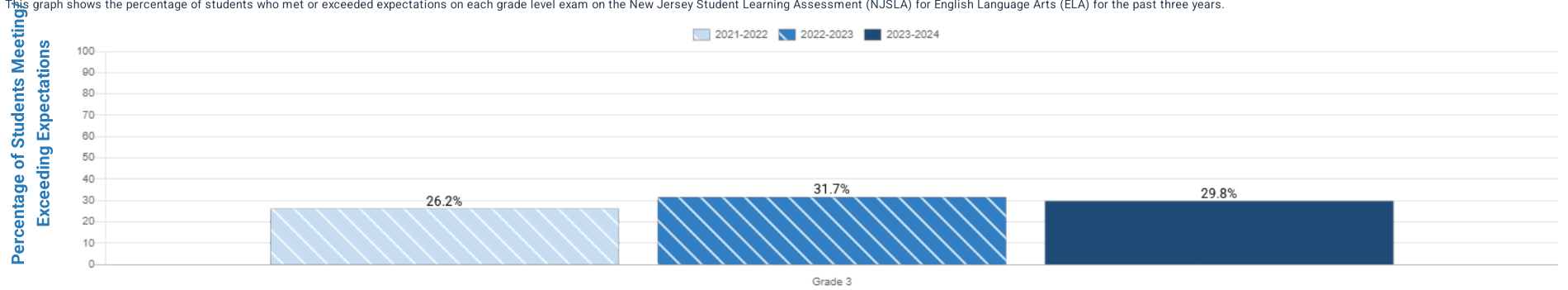

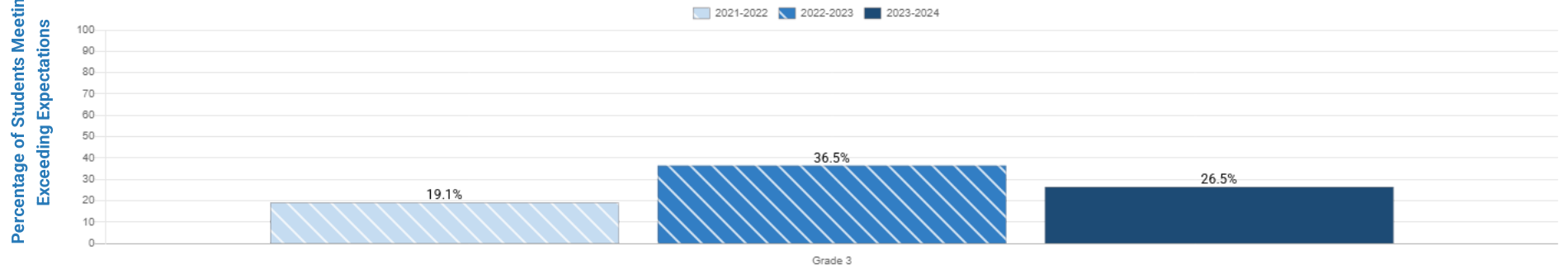

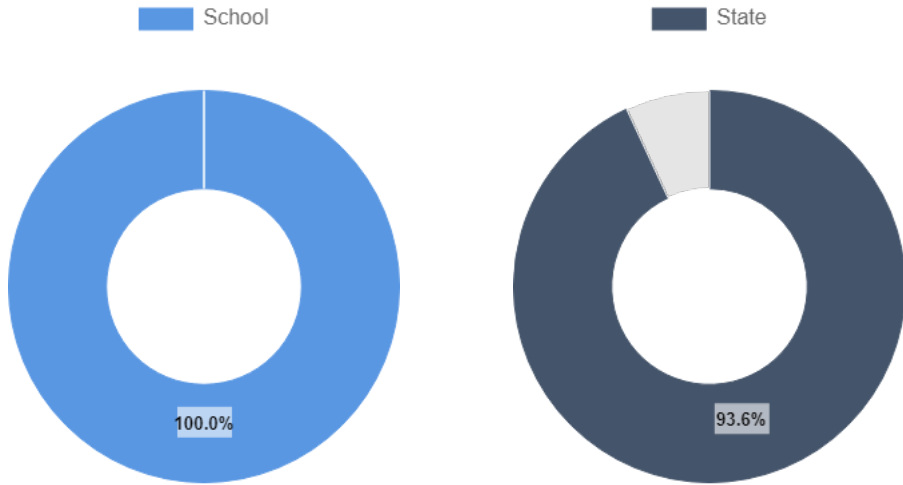

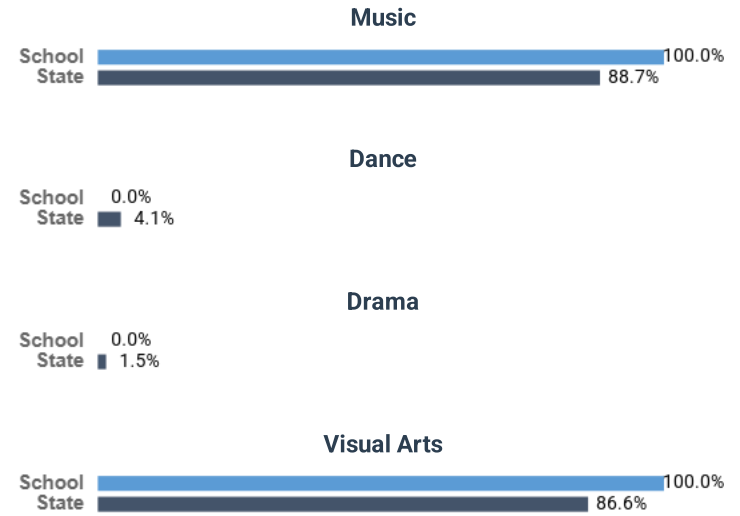

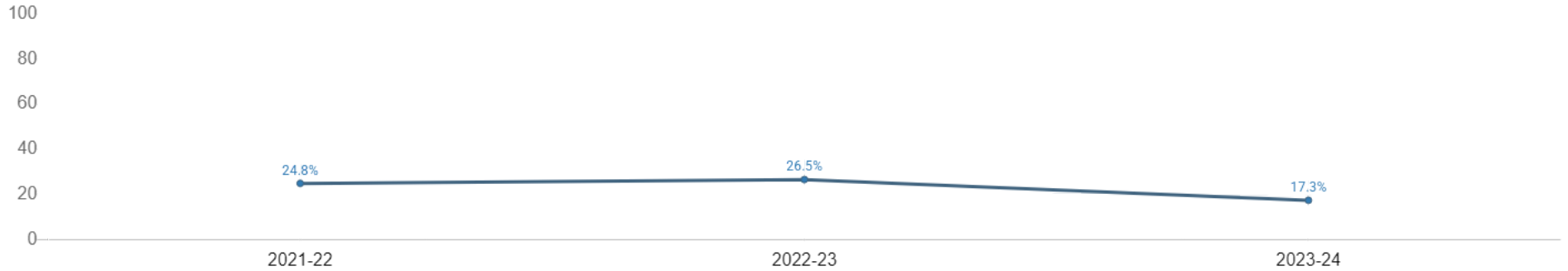

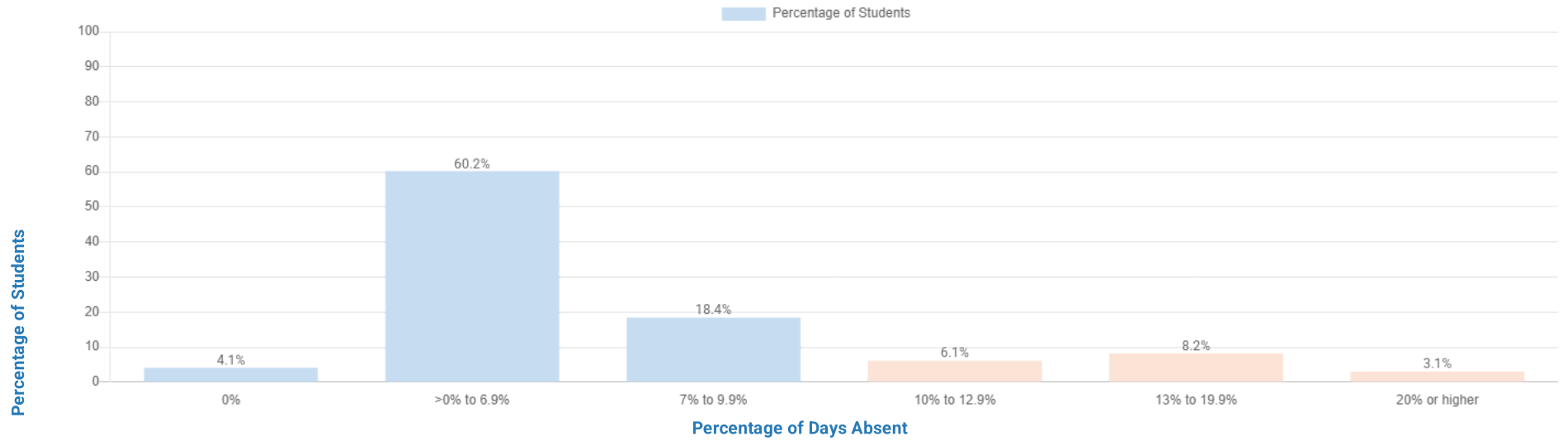

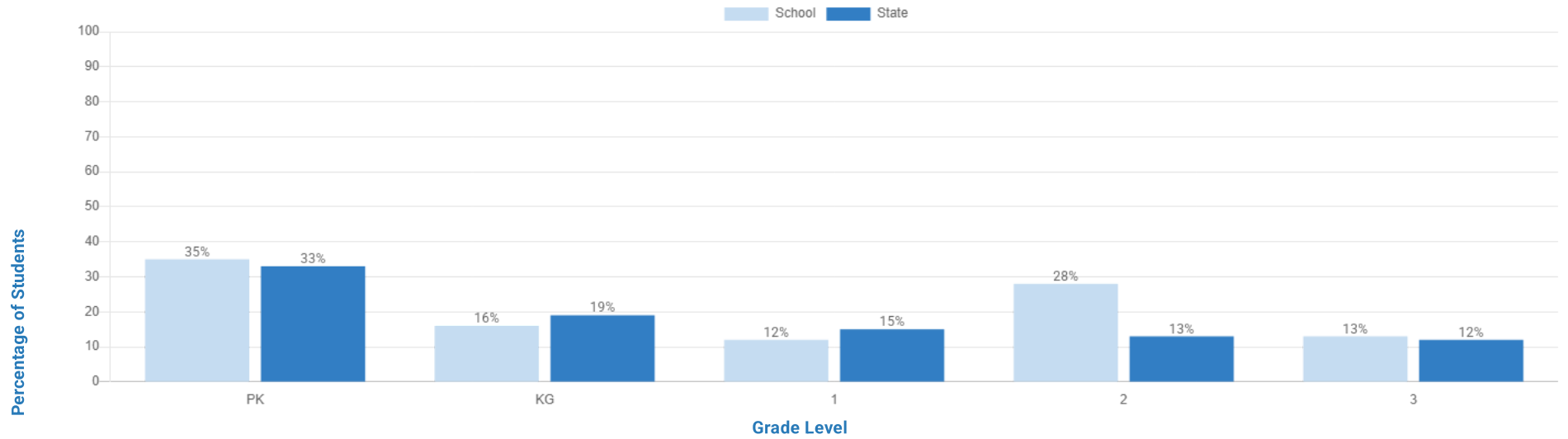

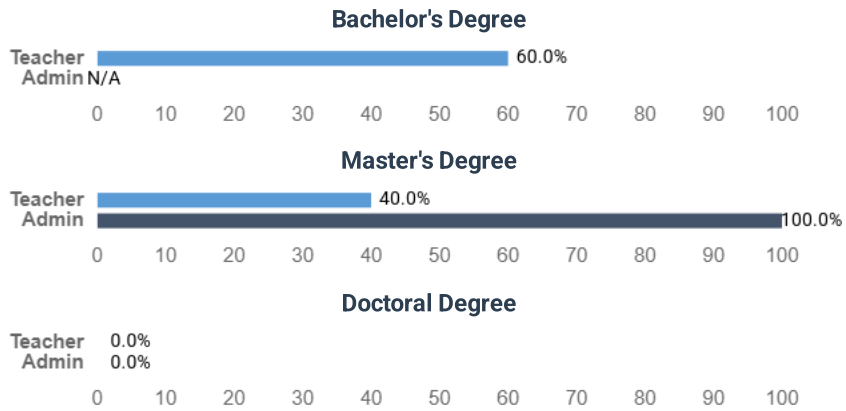

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. All students receive LAL, Math, Social Studies, Science, Art, Music, Physical Education, Computer, and Spanish instruction. We start our day with Morning Meeting which focuses on social-emotional learning (SEL) and daily student check-ins. We have an onsite CST member who provides assistance and services to support students' IEP and placements We have monthly I&RS meetings - parents, staff invited. We have a mental health counselor who is onsite 1-2 times per week. We have two school psychologists in the building. Basic Skills Instruction (math and language arts) English Language Learners Instruction K-3rd grade Special Needs autism classrooms (5 total)



### Student Health and Wellness:

Daily Homeroom Circle Meetings (Morning Meeting) "Zones of Regulation" Program (curriculum designed to foster self-regulation) We have a full time nurse on staff. She provides information to students, families and staff regarding best practices for health and safety. She administers yearly screenings (vision, hearing, etc.). She provides information to classes regarding healthy living habits via a monthly newsletter online. Two full time school psychologists in the building.

### Technology and STEM:

All students have a Google Chromebook at school and 2nd and 3rd grade students have them at home. Gifted and Enrichment (G & E) focus on STEM projects. G & E program has implemented coding and robot use into the elementary program.



### Early Childhood Education:

Pennsauken Babies Initiative --once a month gathering of families with babies and toddlers. Families form a cohort, exchange ideas, learn strategies for their young children and get a head start in lifelong learning. Teachers use the Creative Curriculum approach. One kindergarten teacher piloted the Creative Curriculum last spring and is instituting it for a full year this year. The kindergarten Creative Curriculum has recently branched out to another kindergarten teacher.
