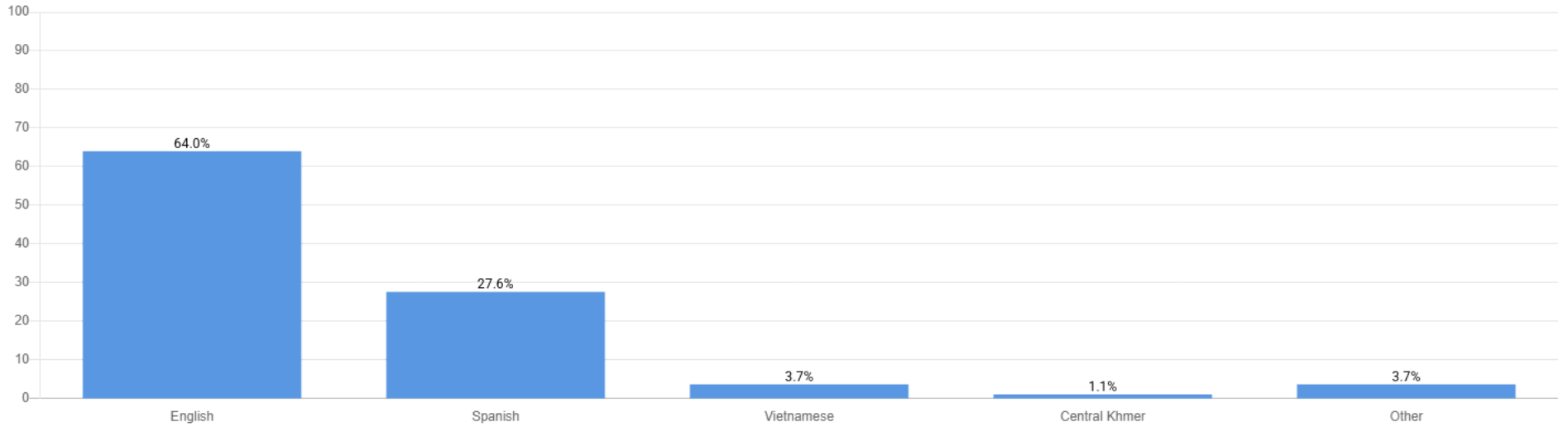

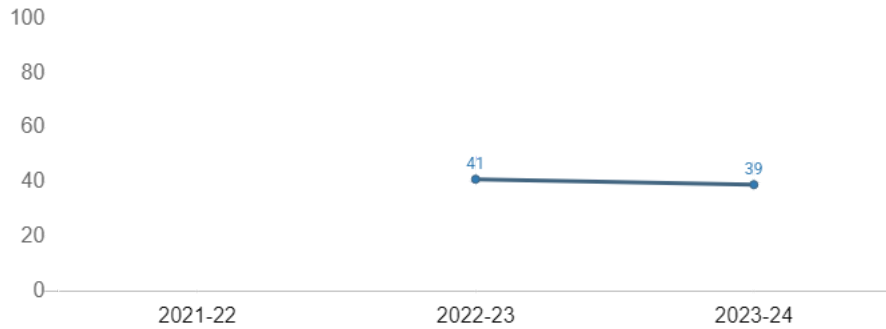

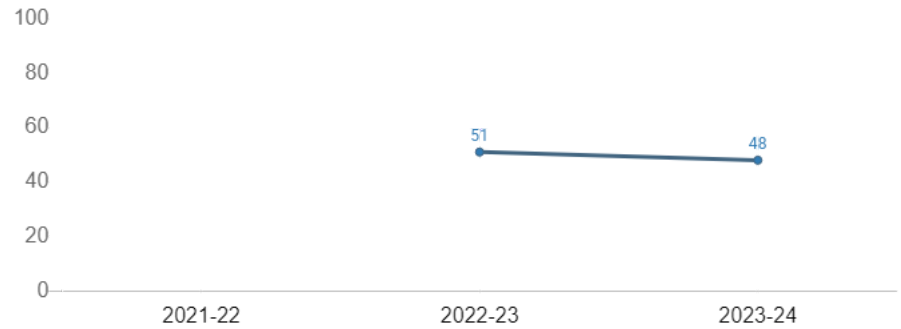

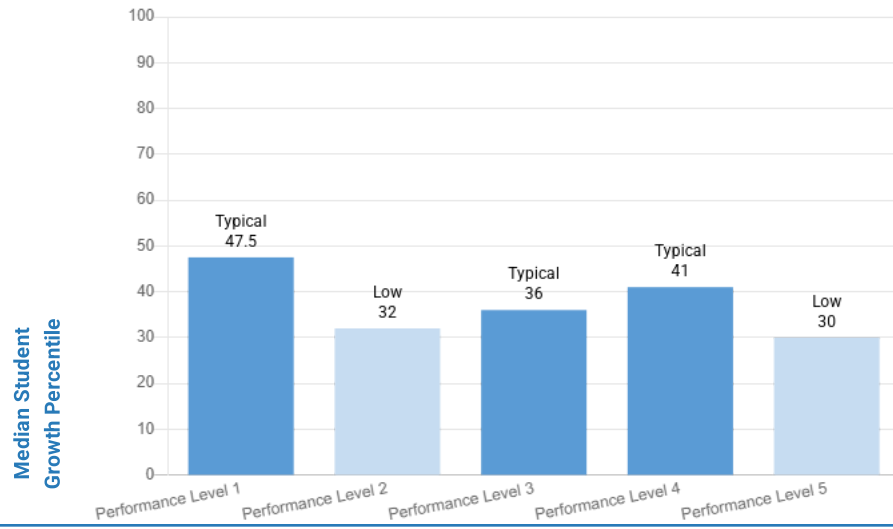

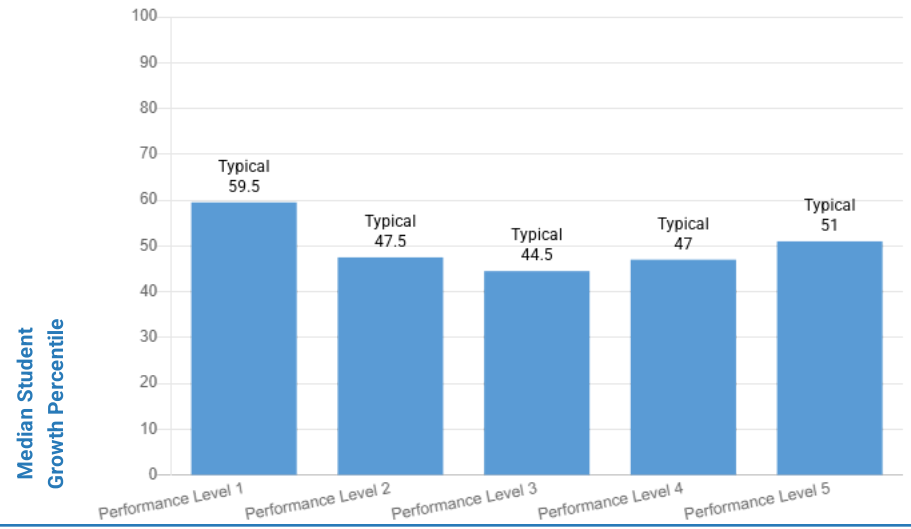

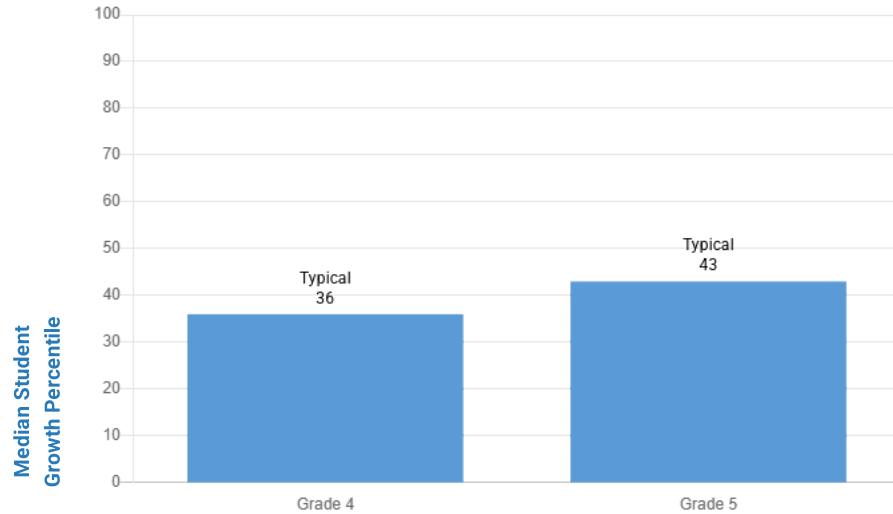

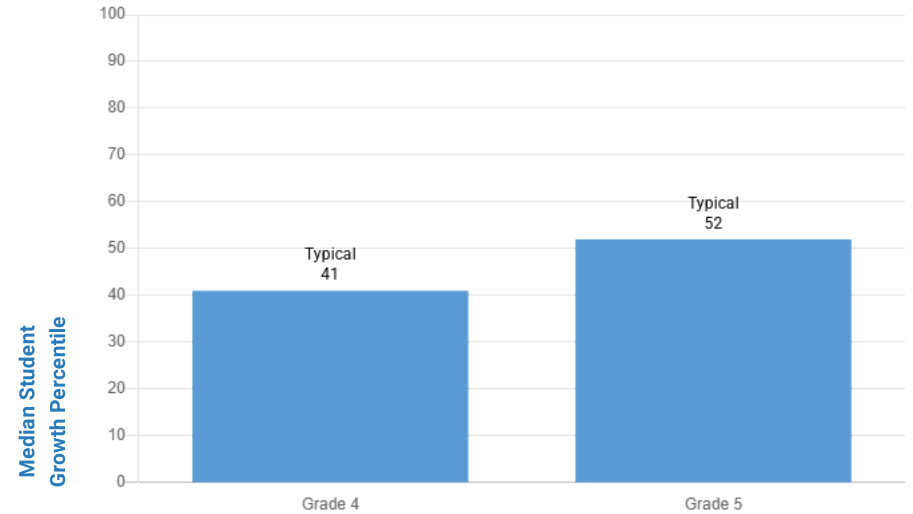

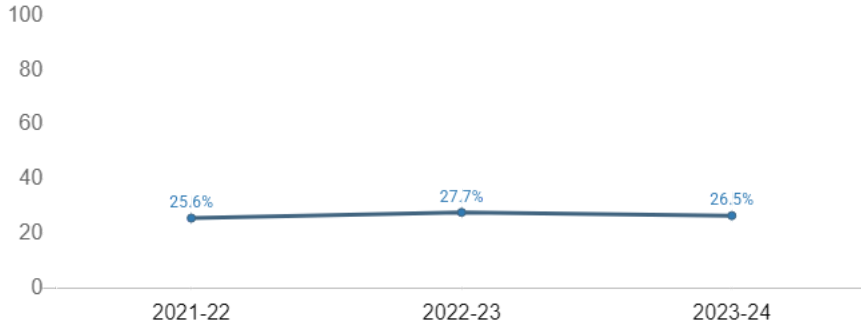

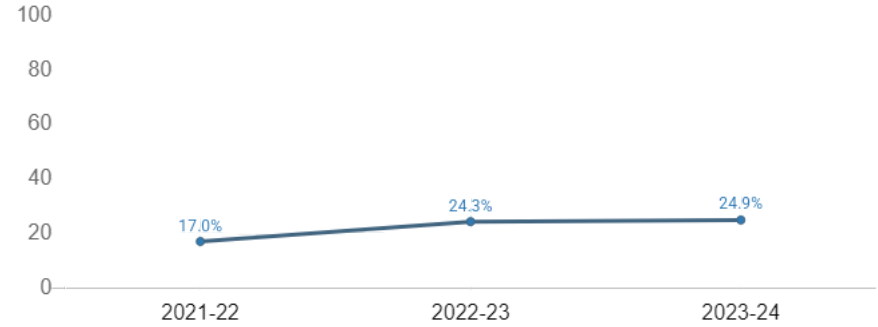
English Language Arts and Mathematics Performance Trends

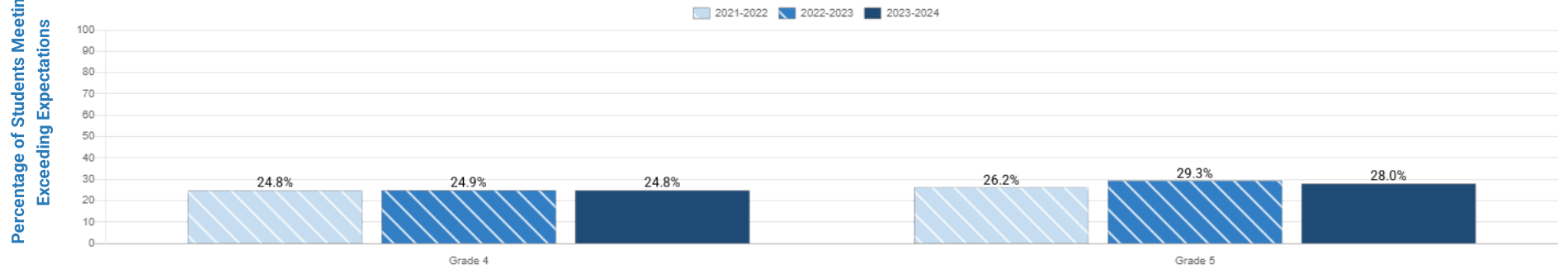

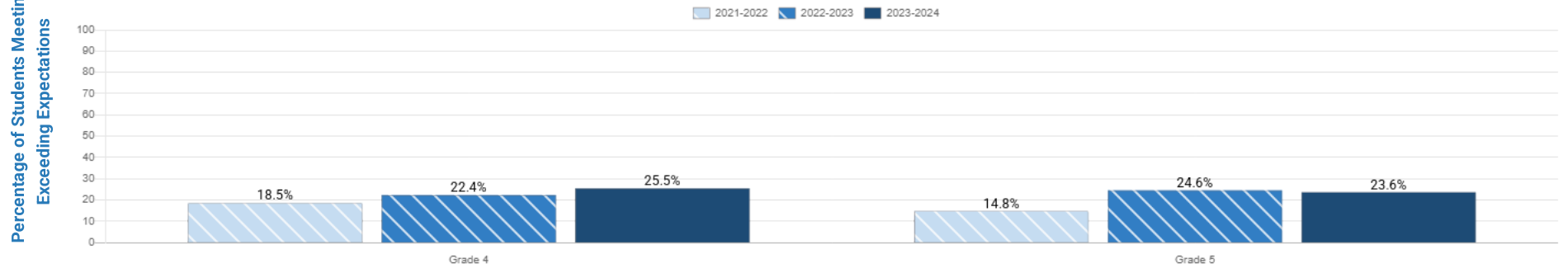

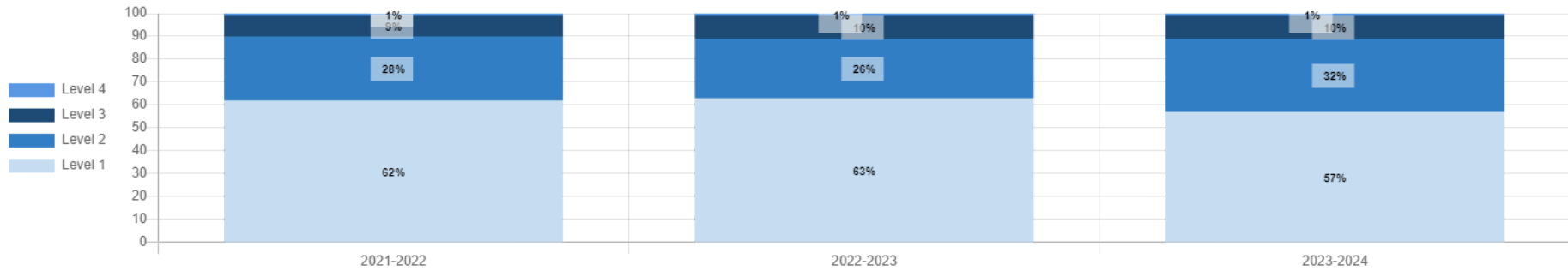

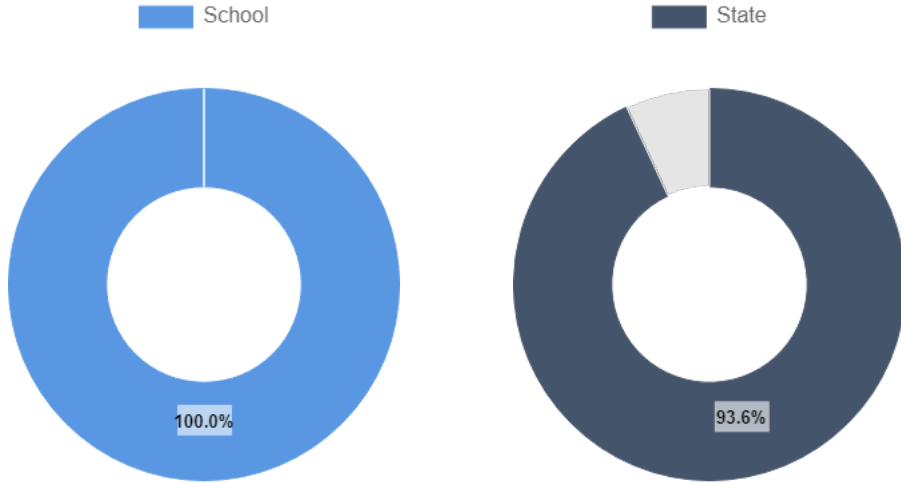

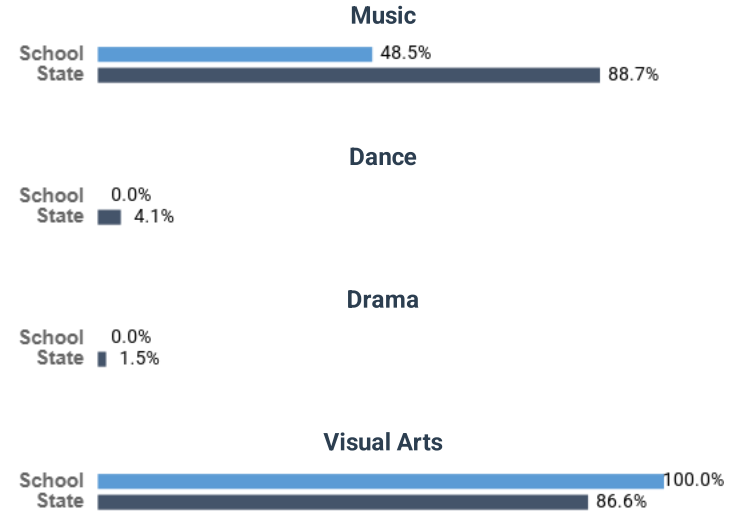

Students enrolled in one or more classes by discipline:



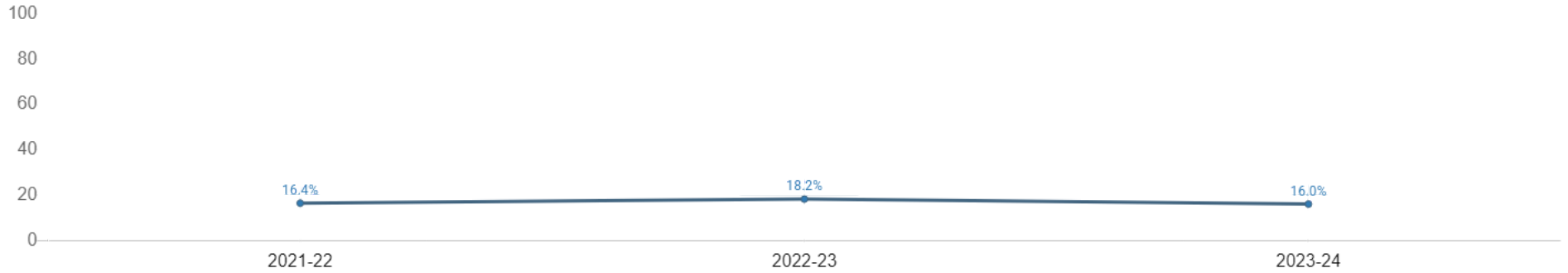

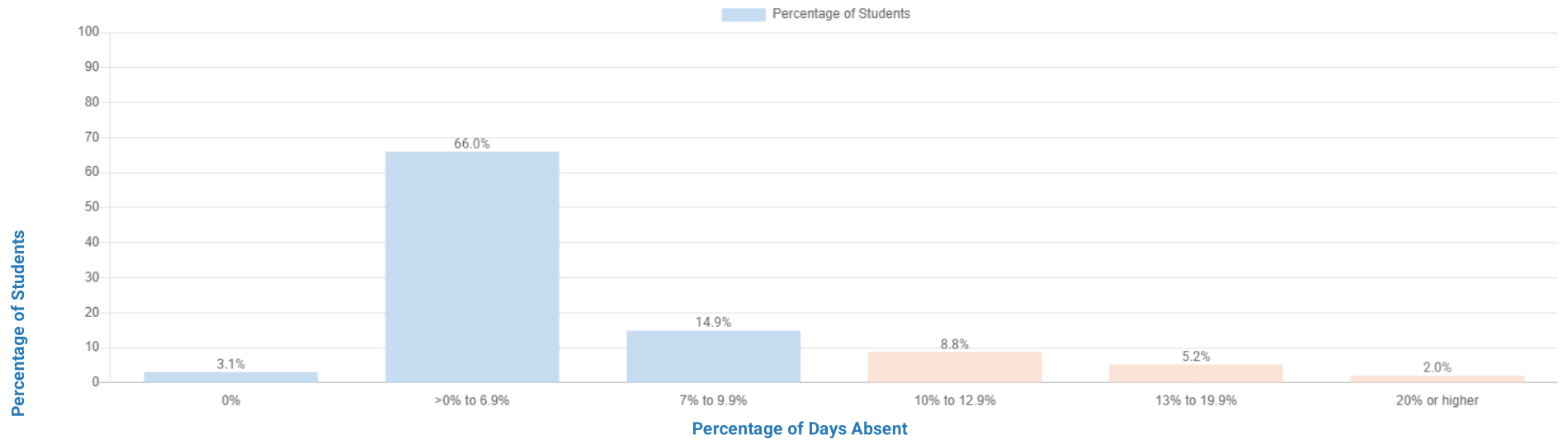

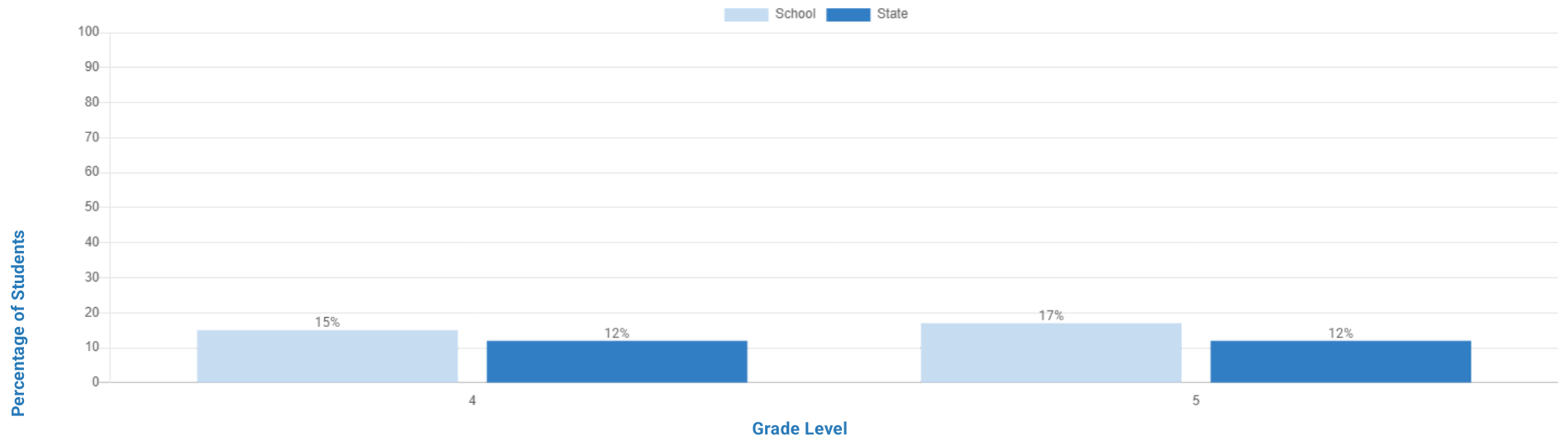

Courses, Curriculum, Instruction:

We offer Pre-accelerated and Accelerated programs in all four content areas (language arts, math, social studies, and science) for selected 4th and 5th Grade students. Gifted and Talented students receive one period daily of enrichment and exploratory learning



Clubs and Activities:

We offer Student Council, Band and Chorus, School Plays, News Media- Pennsauken Intermediate News (PIN News). Through our Positive Behavior Incentives/Supports (PBIS), students will continue to earn PennBucks that they can use to participate in different activities such as games, art activities, dance party, movie time, etc. Students are also recognized for demonstrating Random Acts of Kindness (RAK) and are rewarded with a monthly celebration. Each month, we recognize students for maintaining great characteristics or for achieving academic excellence. Of these students, one student is selected monthly to represent the Intermediate School at the recognition ceremony during the board meetings. Additionally, at the end of each marking period, we host an awards assembly program to highlight students in the building for demonstrating great attributes, for earning outstanding grades, and for having perfect school attendance.



Before and After School Programs:

The LAM program provides before and after care service to students at the Intermediate School. Our guidance department has developed an after-school SEL program for students who they feel need additional support in coping with emotional and/or behavioral challenges. This year, we have organized an afterschool Homework Club program to support students in all content area.

Staff and Professional Learning:

Common Planning meetings are held bi-monthly to discuss and collaborate on topics involving curriculum pacing, instructional practices, and program development. Professional Learning Communities (PLC) meetings are held bi-monthly to introduce new programs or for staff members to turn-key ideas and/or technology to their colleagues. Mandatory monthly district Professional Development Learning (PLD) sessions are offered to staff. These sessions are facilitated by school PLD coordinators who plan, organize, and present topics determined by the district. After-school PD opportunities are also provided to staff on topics including the selection of new curriculum and school improvement initiatives.



Student Supports and Services:

At the Intermediate School, support services such as English Language Learners, Basic Skills for both math and reading, and specific programs for students with disabilities are available to students who qualify. Pennsauken Public Schools is committed to implementing social-emotional learning (SEL) practices throughout the academic school year. The goal is to obtain a positive school climate, while improving positive social and emotional interactions, by increasing conflict resolution, valuing multicultural differences, demonstrating emotional self-awareness, and maximizing student engagement. The district continues to integrate SEL resources and training throughout the school community.



Student Health and Wellness:

Wellness programs are offered to promote the health and welfare of students. Our certified school nurses conduct wellness screenings (eyes, height, weight, and blood pressure) and offer information for dental and vision support. The counseling department delivers in-class lessons to provide emotional support for all students. The Mental Health grant has allowed the district to offer new services to students throughout the district. In addition to lunches, students also receive breakfast daily in the classrooms. Physical education and health classes are held on alternating days for 78 minutes. Students are provided with activities and instruction that enables them to value and participate in a healthy and active lifestyle and expose them to a wide variety of Individual and Team Sports. Students engage in a variety of activities to develop their from yoga to cross-training. Recess is a part of our daily routine.

Facilities:

The Intermediate School is a fully air conditioned, handicapped accessible two-story building with a sufficient number of classrooms to accommodate our diverse student population. There is a large library that also serves as a media center. The building boasts a recently renovated gymnasium. Students enjoy their special area classes in a very spacious art room, a band room accompanied by a stage to accommodate assemblies or musical performances, and a computer lab. Our cafeteria is strategically located towards the front of the building and is structured to seat students in a 3 tiered model. Adjacent the cafeteria is our recess area with both a blacktop activities and a large grassy field to accommodate outdoor activities.
