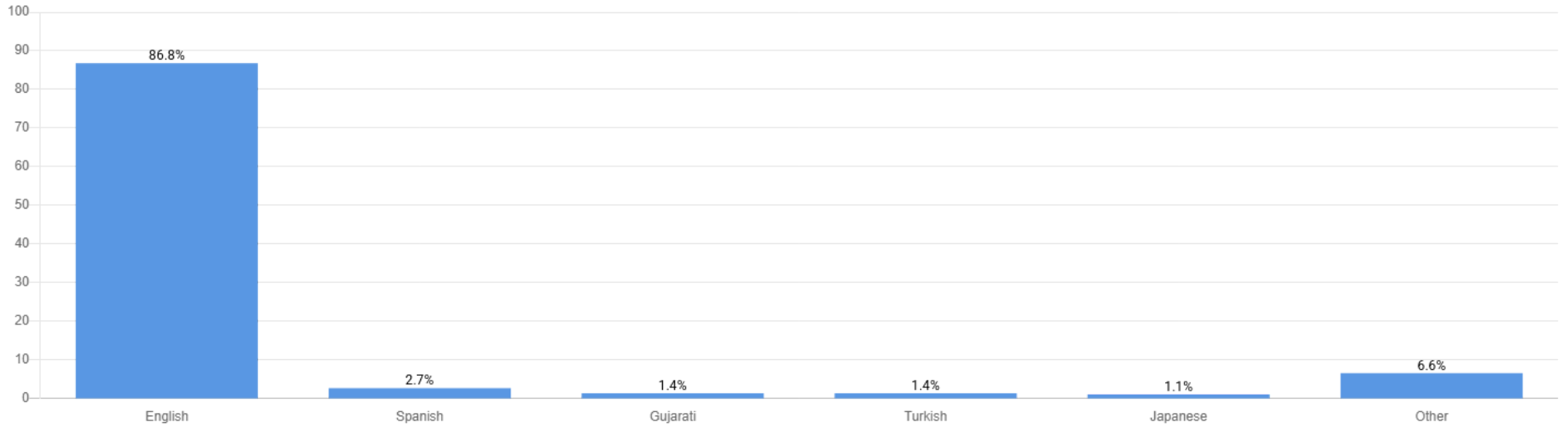

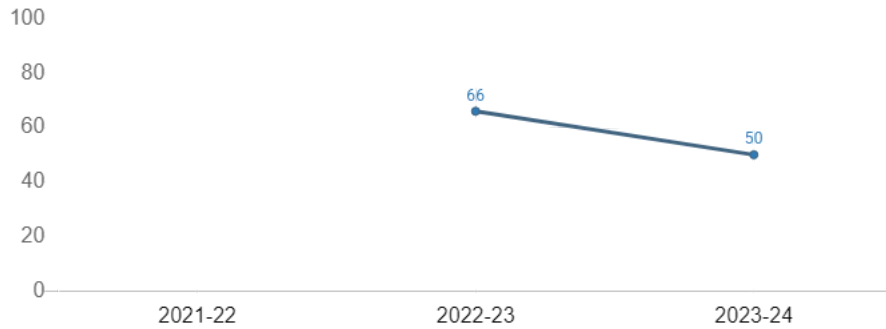

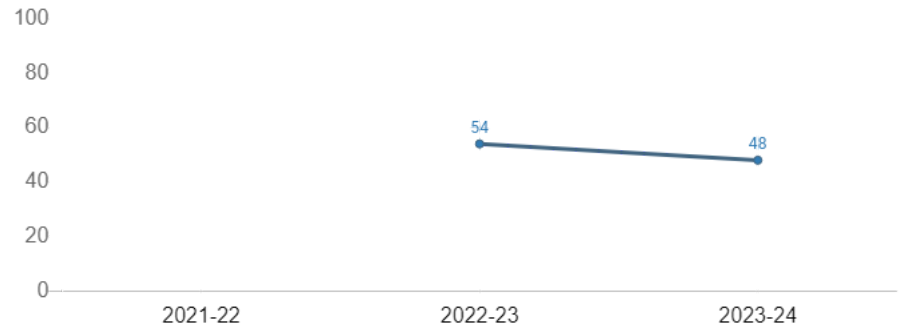

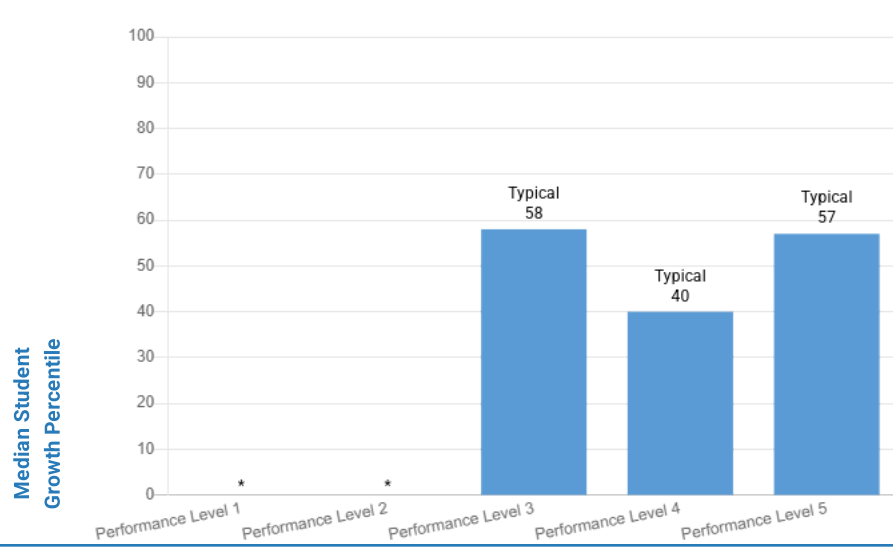

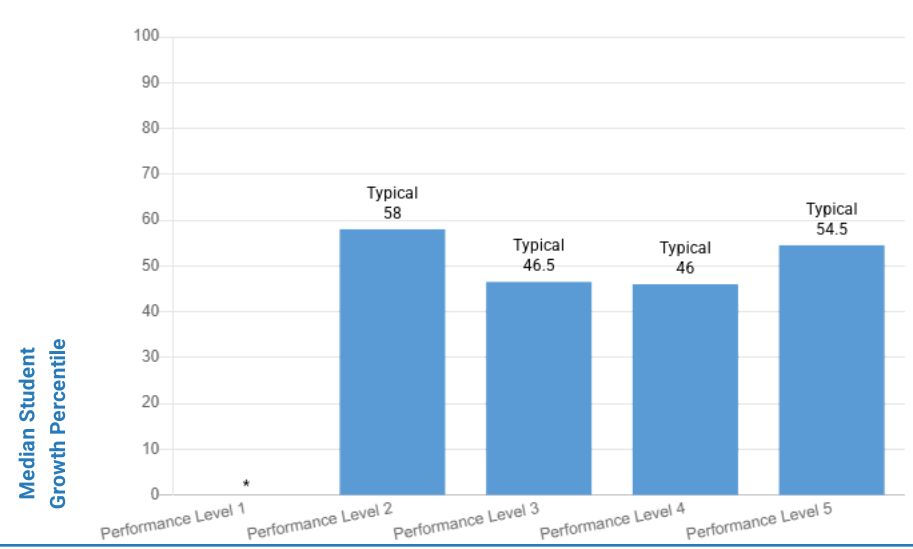

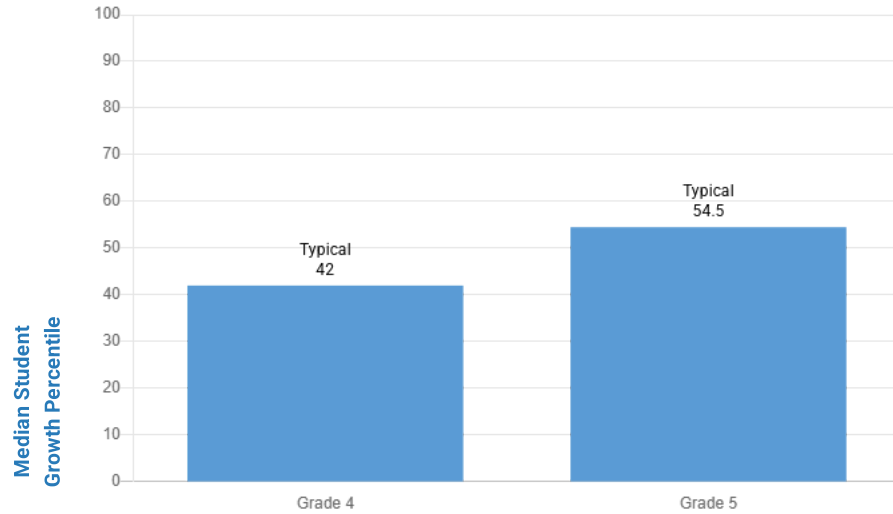

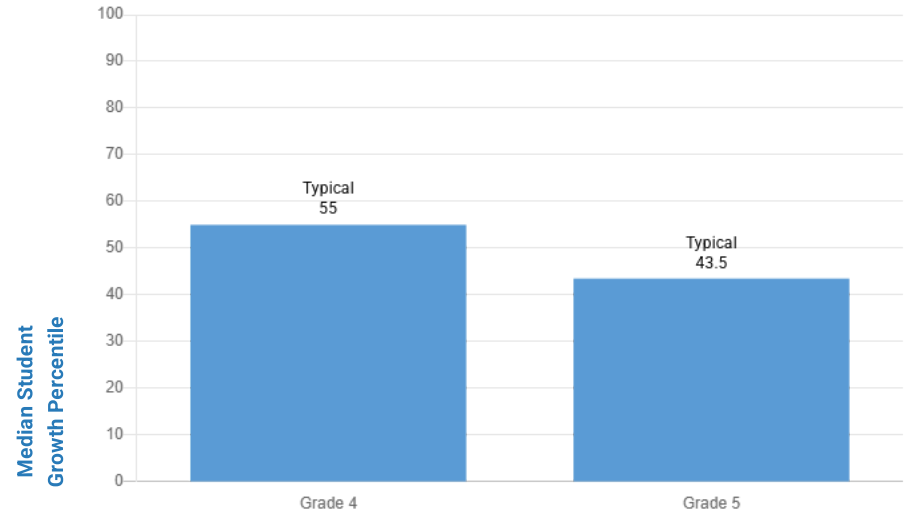

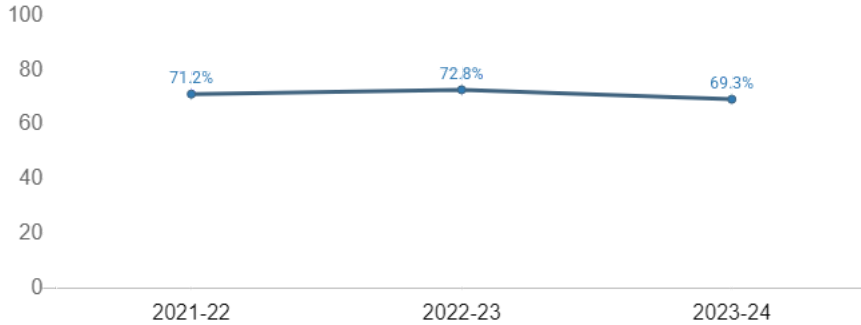

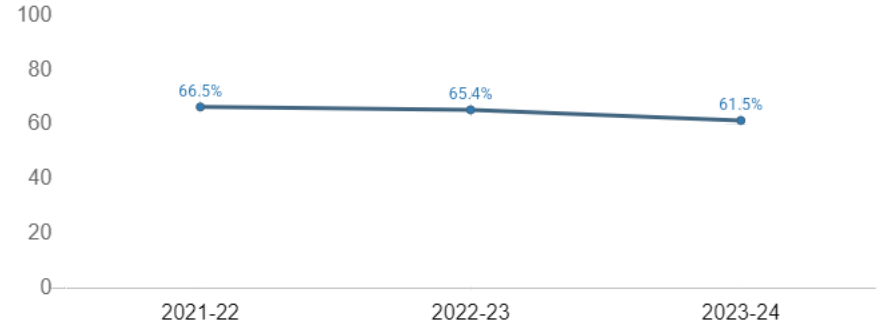
English Language Arts and Mathematics Performance Trends

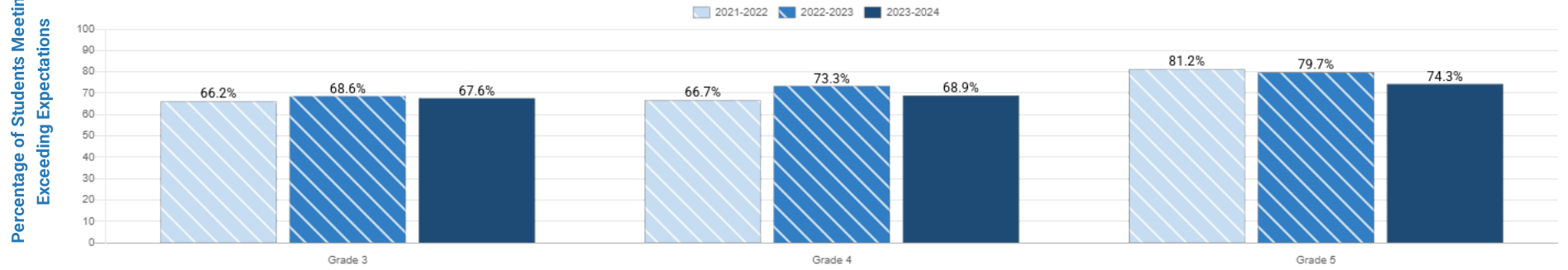

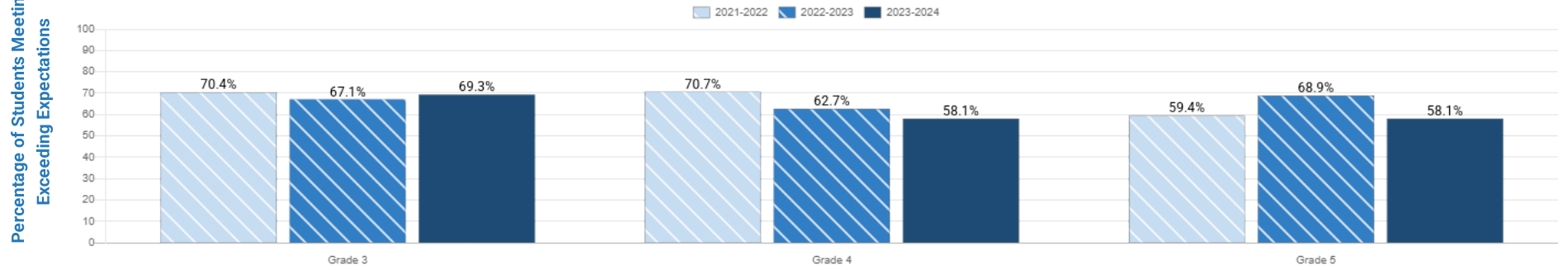

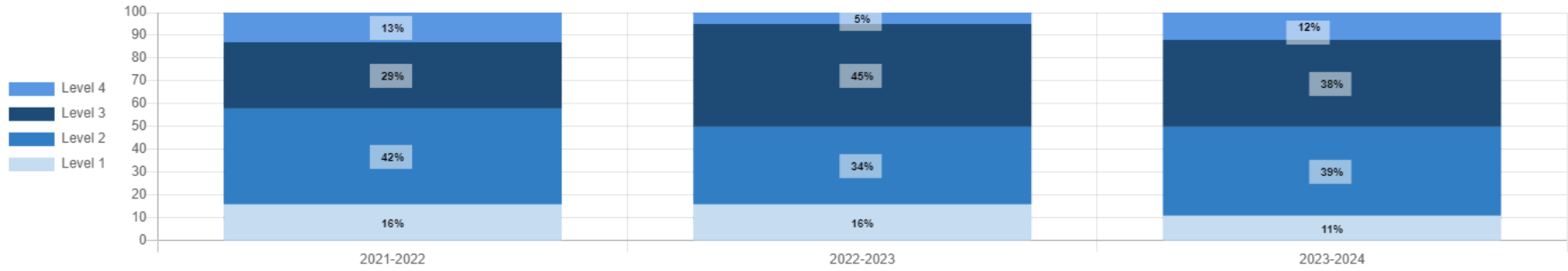

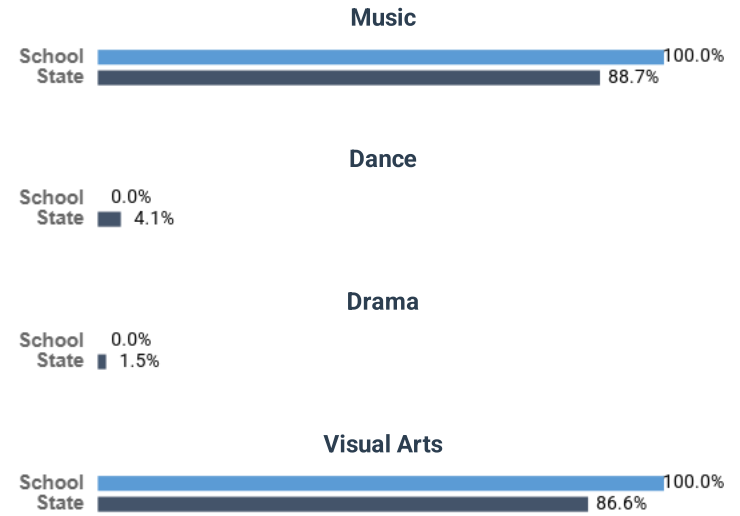

Students enrolled in one or more classes by discipline:



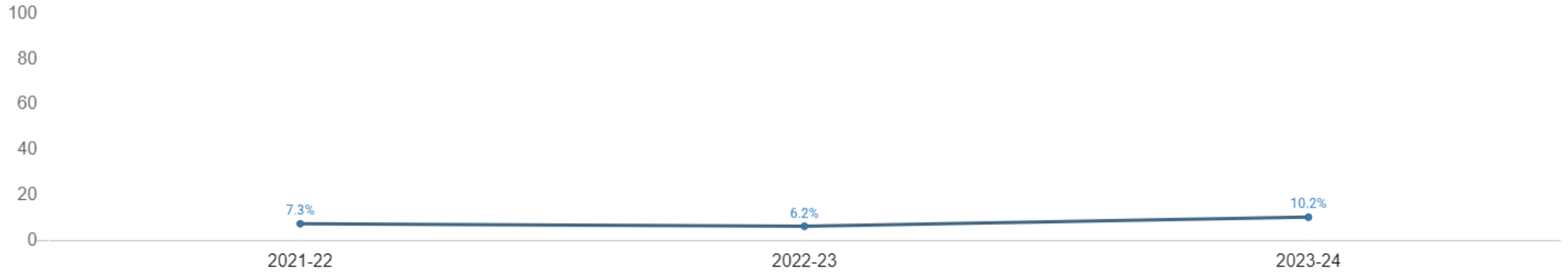

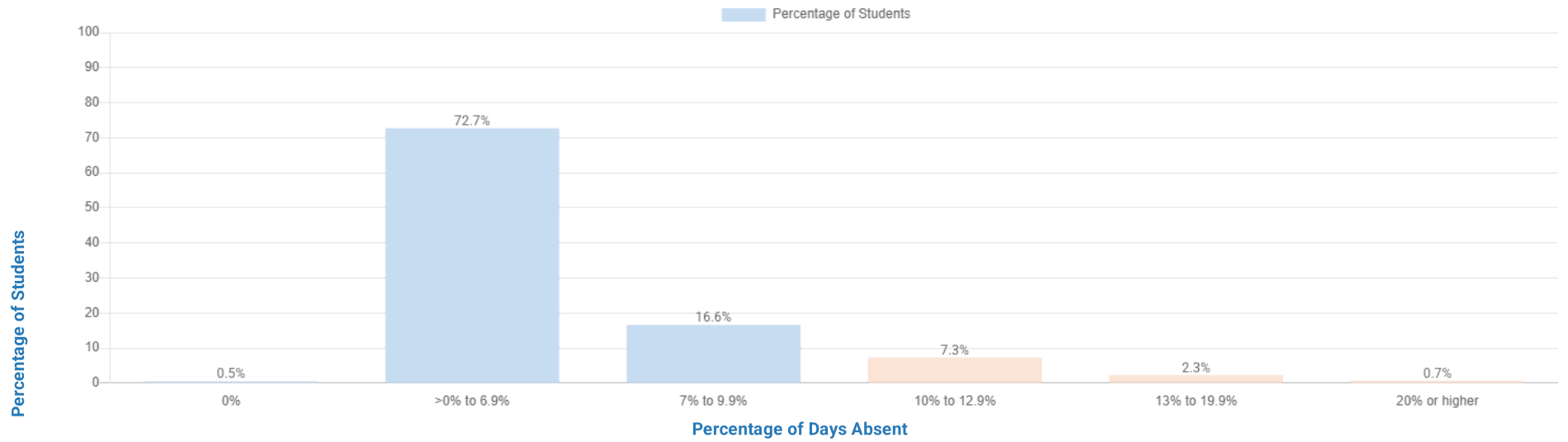

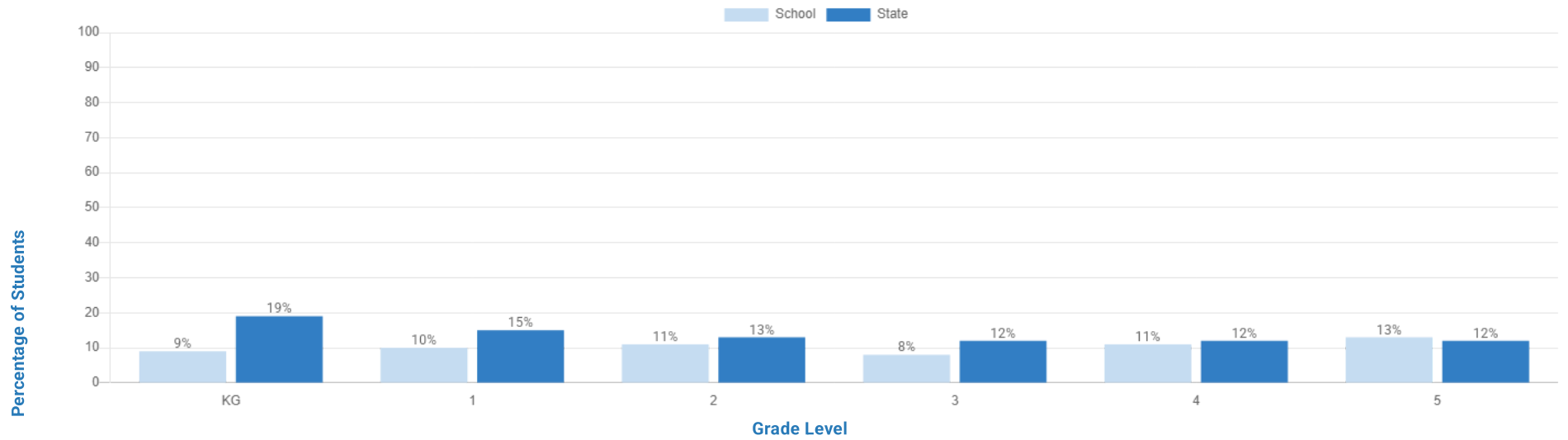

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

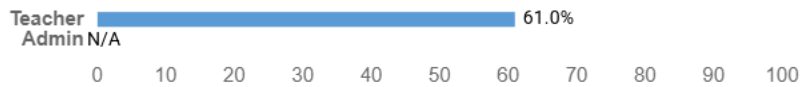

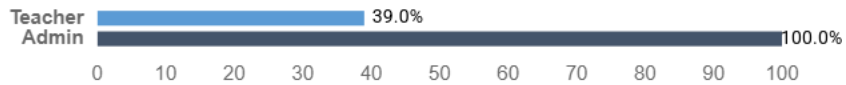

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. School Safety:

Clear and specific rules and procedures are in place for the safety and security of the school. Emergency management procedures are in place and coordinated with the Voorhees Township Police Department. Surveillance system allows for the administration, school office, and Voorhees Township Police Department to monitor school activity. All Voorhees Schools have a full-time Voorhees Township Police Department School Resource Officer stationed at the school when students are present during regular school hours. Officers are present at after school events, when requested. Crossing Guards assist with safe student arrival and dismissal to and from school each day. Monthly fire drills (12) and emergency drills (12) held annually.



Technology and STEM:

Signal Hill School uses 21st Century tools to engage in STEM learning. In addition to these district tools, our Parent Faculty Association hosts and/or plans for a STEAM Day for all students using community volunteers to teach students about STEAM related jobs they hold. Students also participate in the "Hour of Code."
