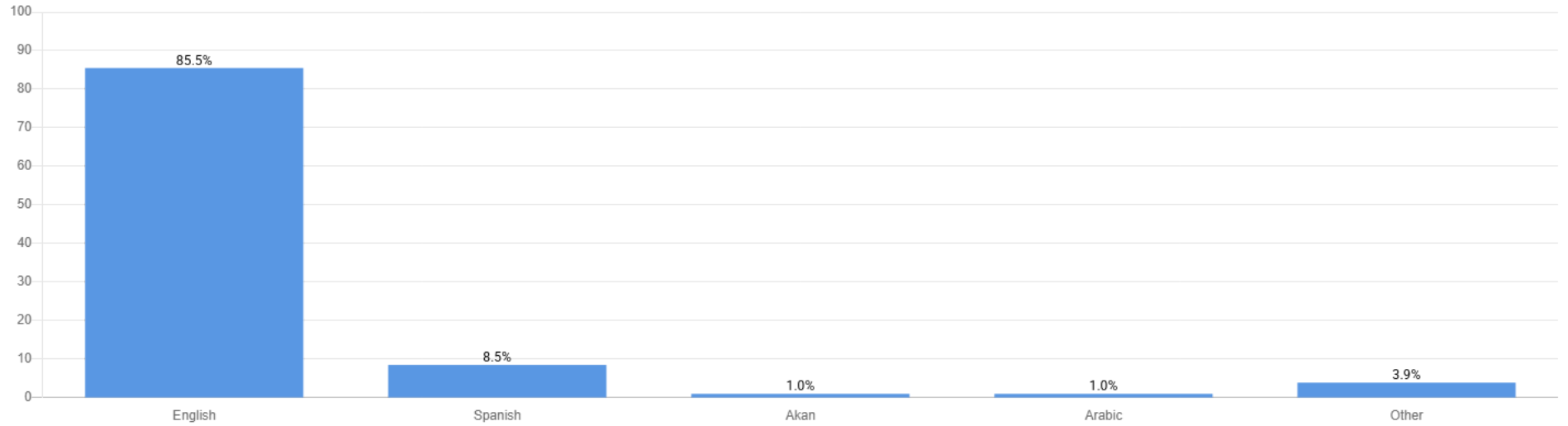

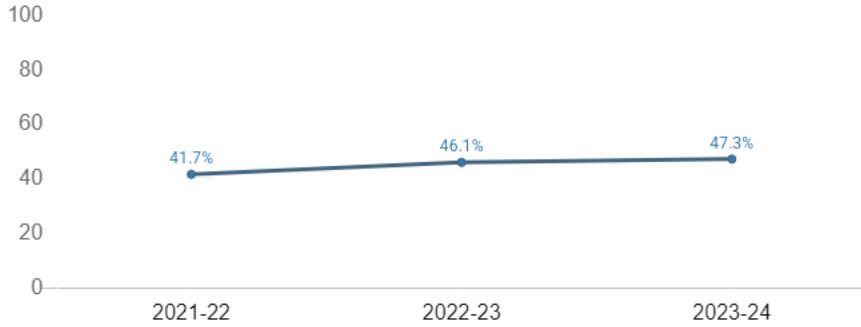

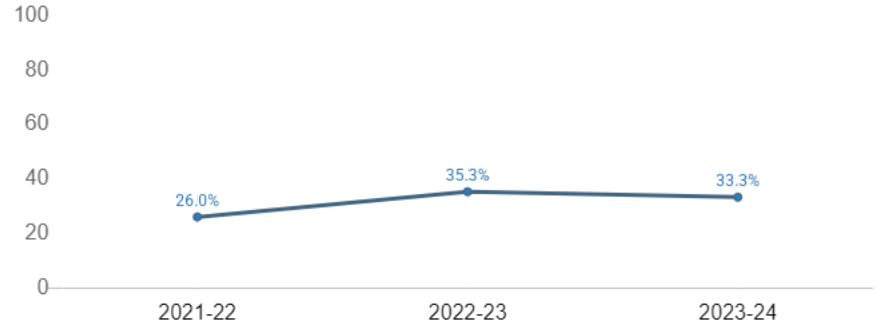
English Language Arts and Mathematics Performance Trends

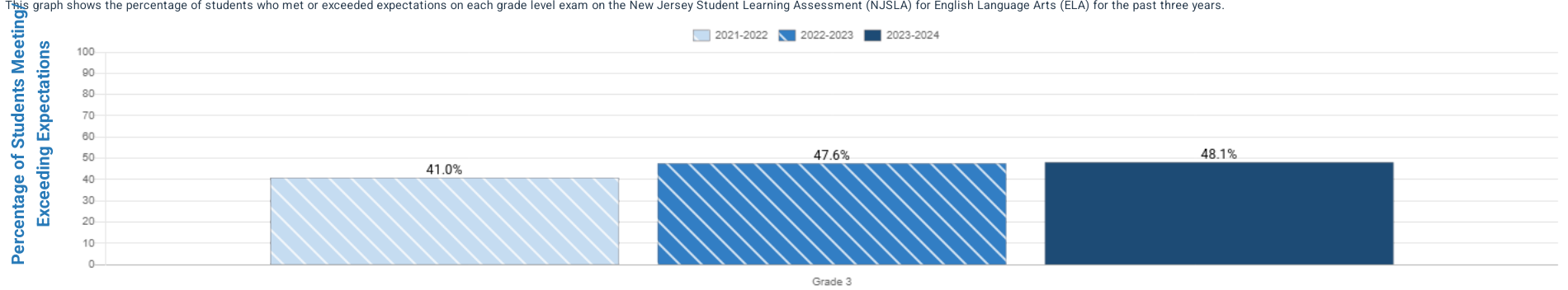

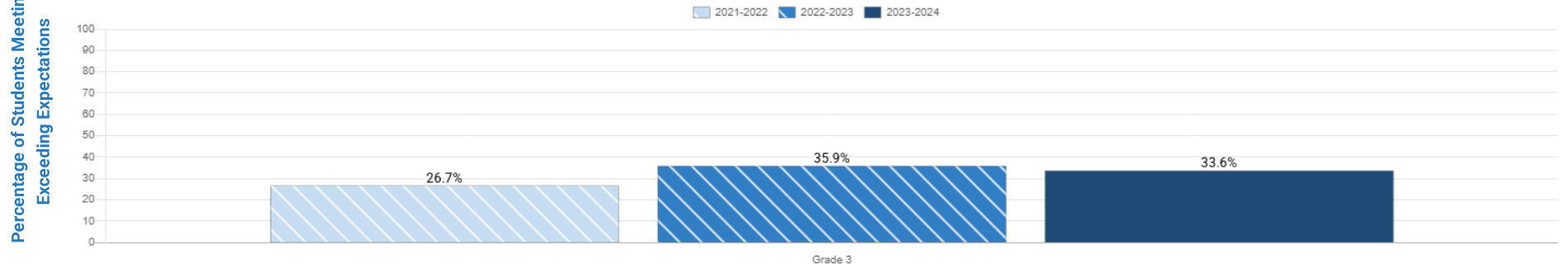

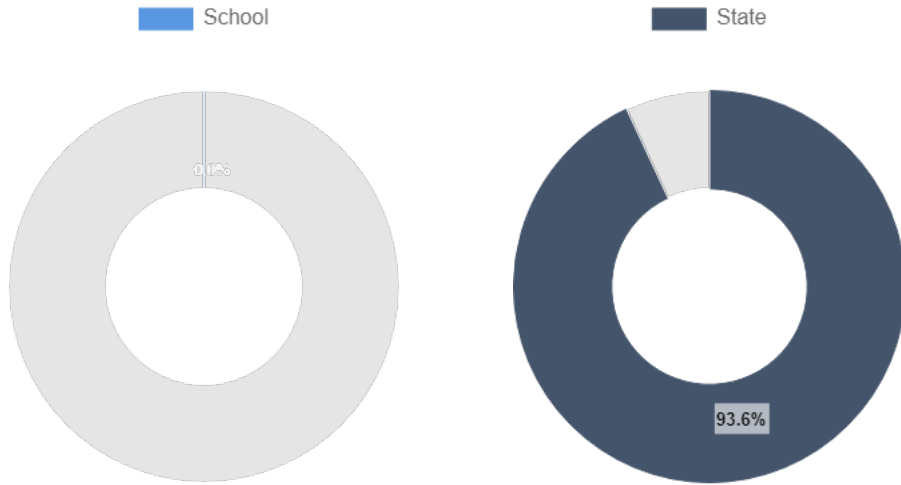

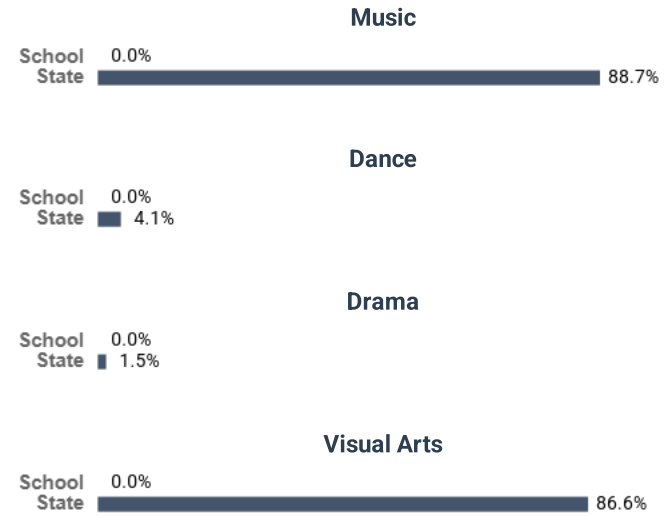

Students enrolled in one or more classes by discipline:



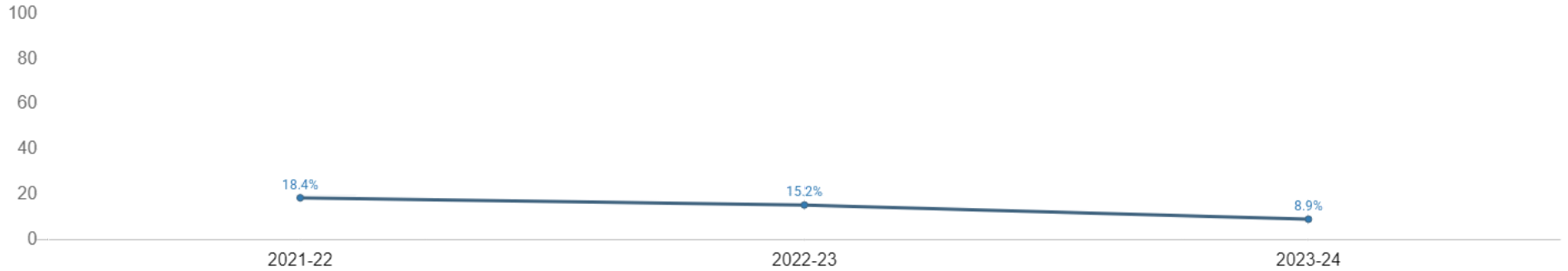
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. 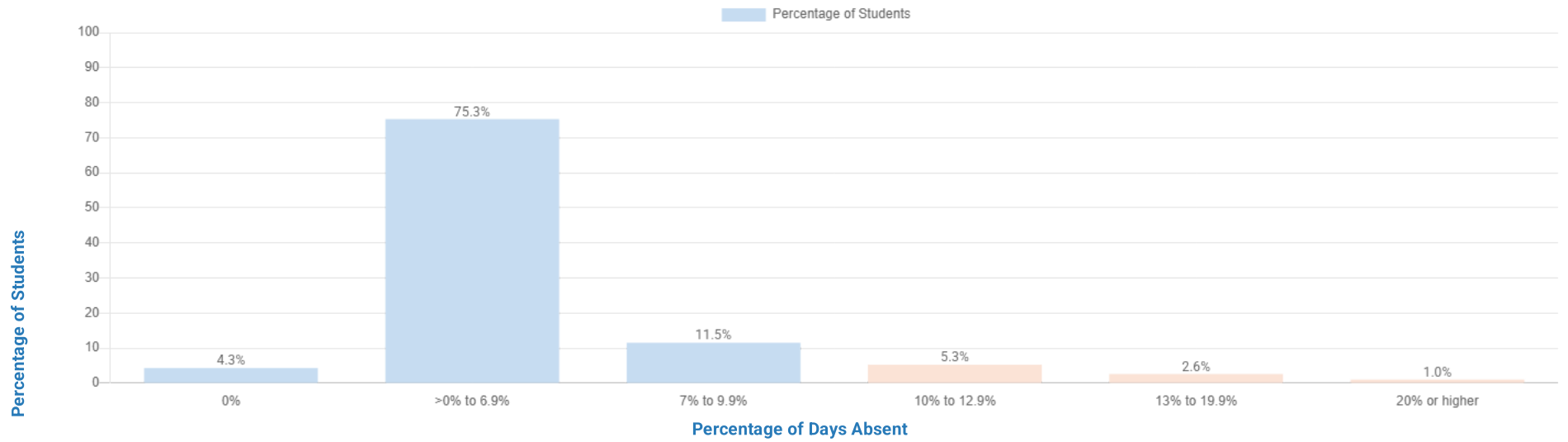

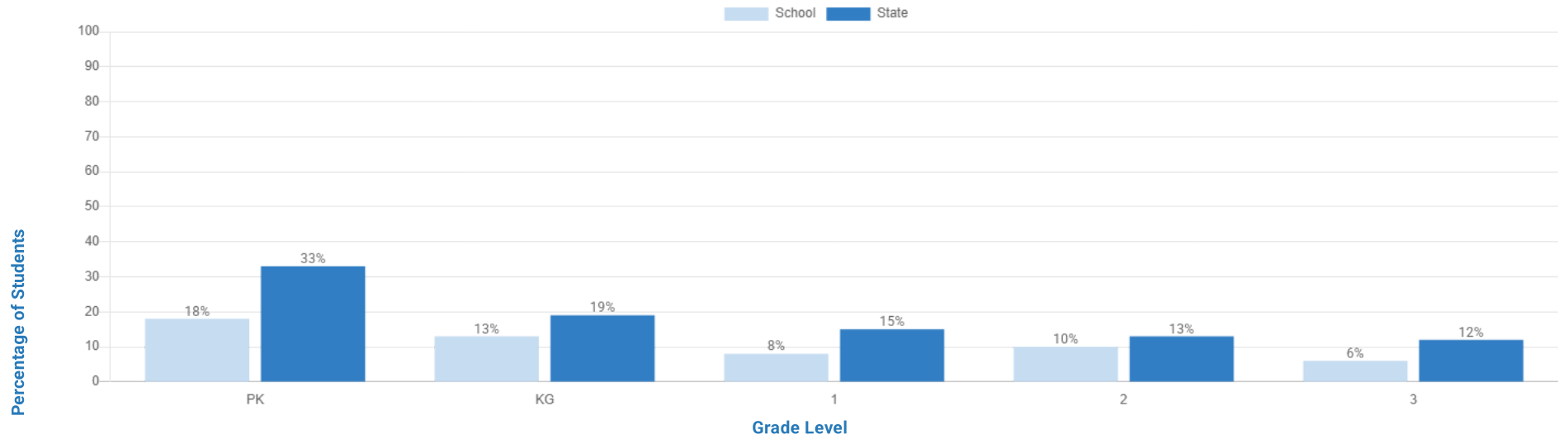

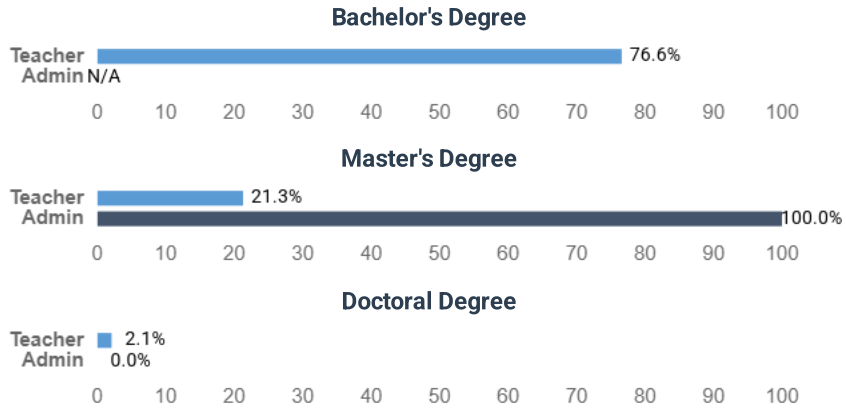

Courses, Curriculum, Instruction:

Winslow Township Elementary School #4 develops a strong literacy foundation for our youngest learners by providing a balanced literacy approach with a comprehensive literacy program. Critical and creative thinking along with problem solving skills are developed in our math and science programs. We have worked diligently to infuse technology. Pre-K through third grade students also receive Zaner Bloser handwriting instruction. To further drive data driven instruction, iReady is implemented in grades K-3 for English Language Arts and Math. Gifted and Talented and English as a Second Language (ESL) programs are provided. Students receive social emotional learning lessons by the school counselor and Mental Health Professionals are provided to further support the needs of students. Students also attend classes in Music, Physical Education, Art, and Computers. At the pre-kindergarten level classrooms remain student centered with the implementation of Creative Curriculum.
