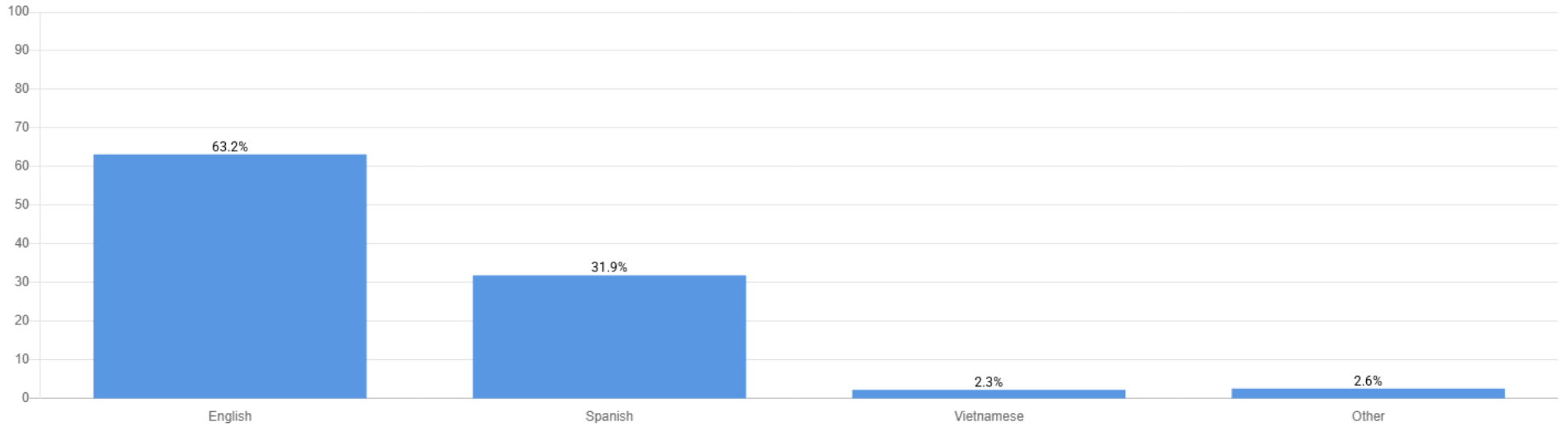

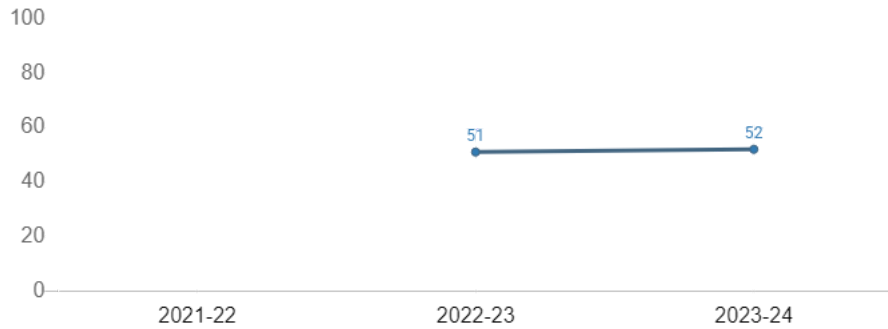

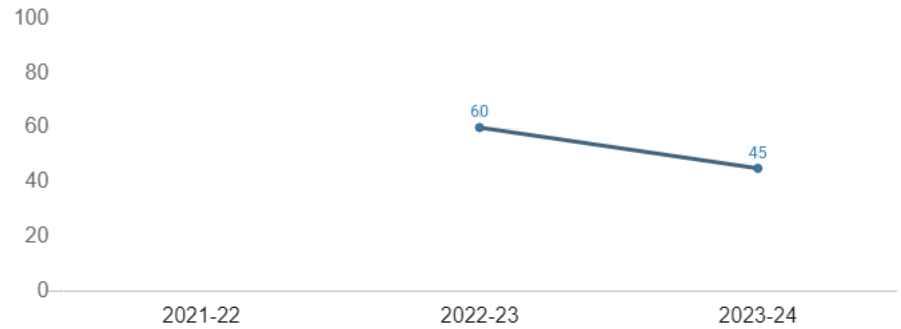

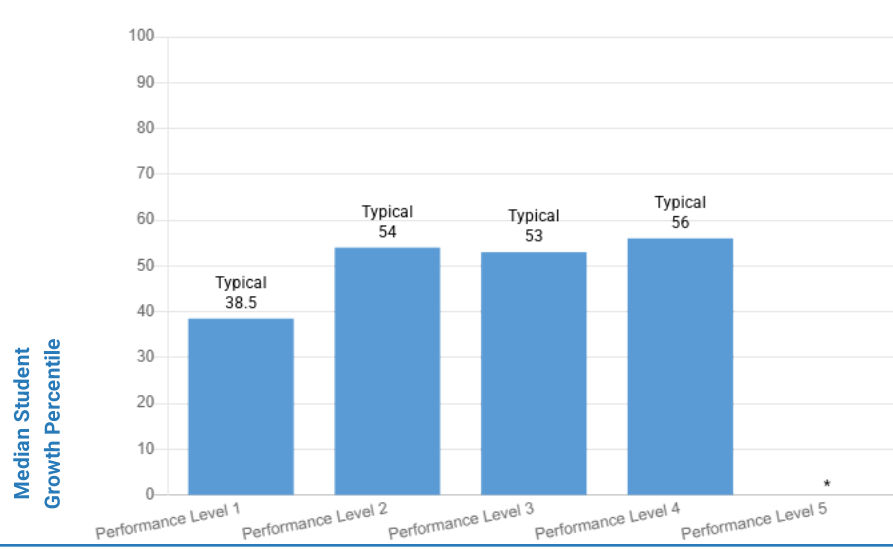

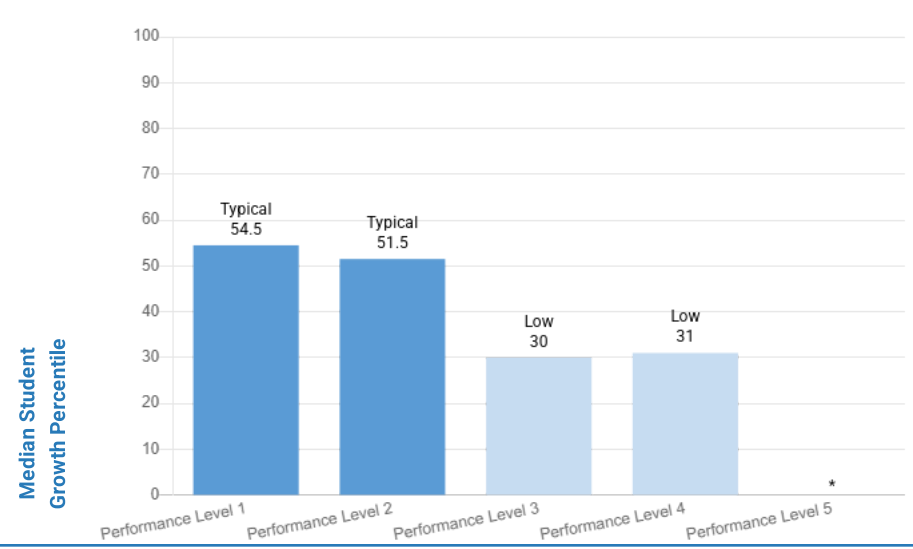

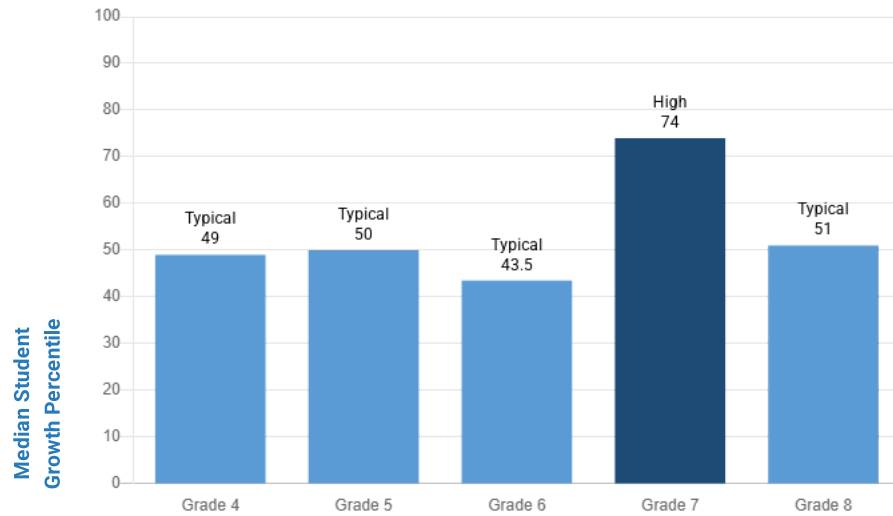

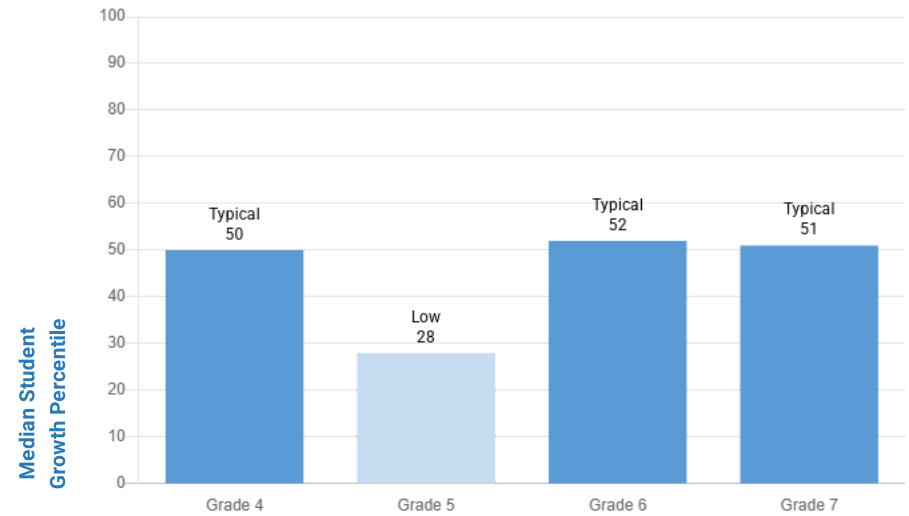

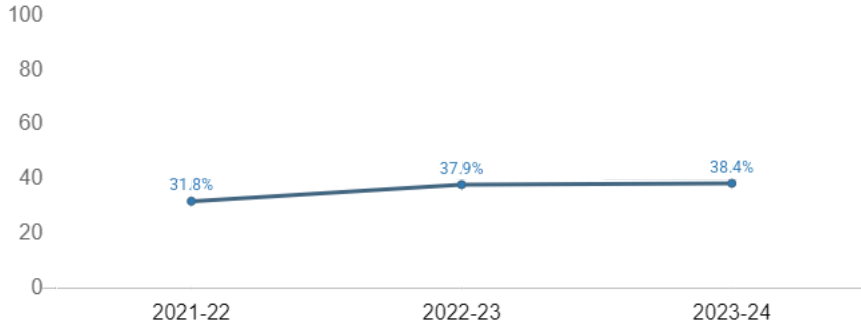

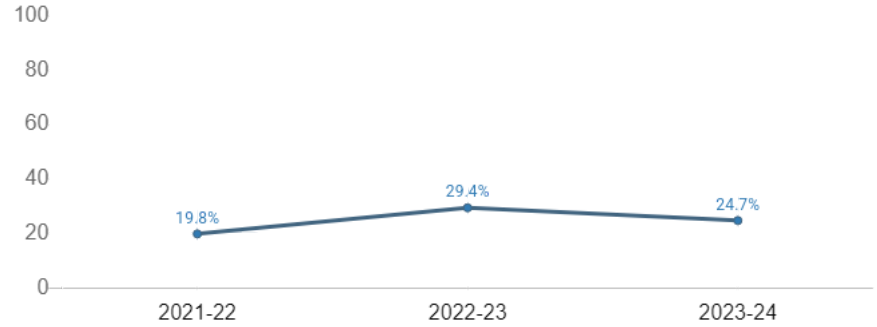
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 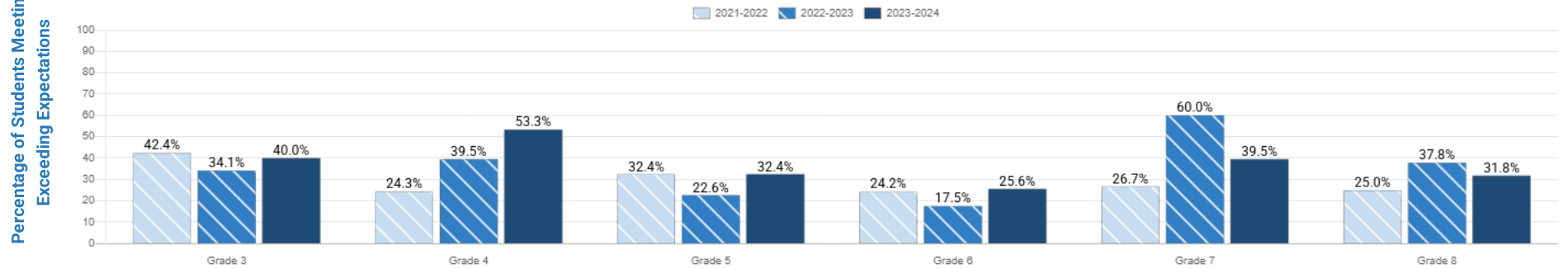

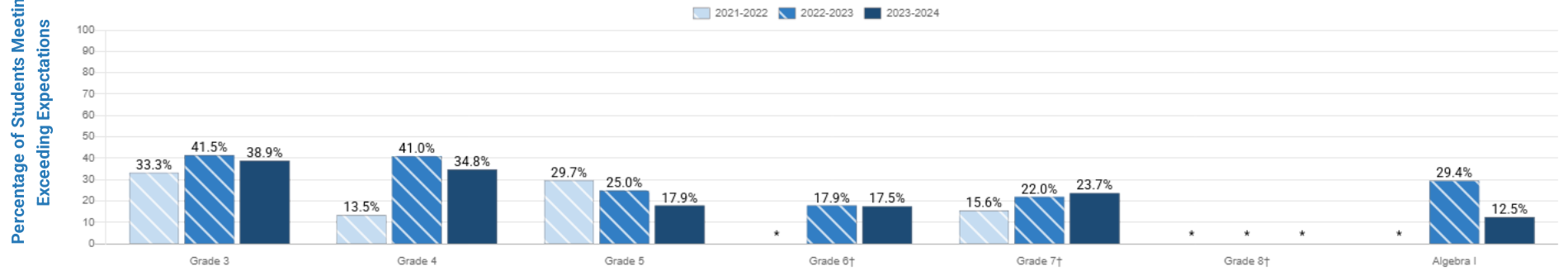

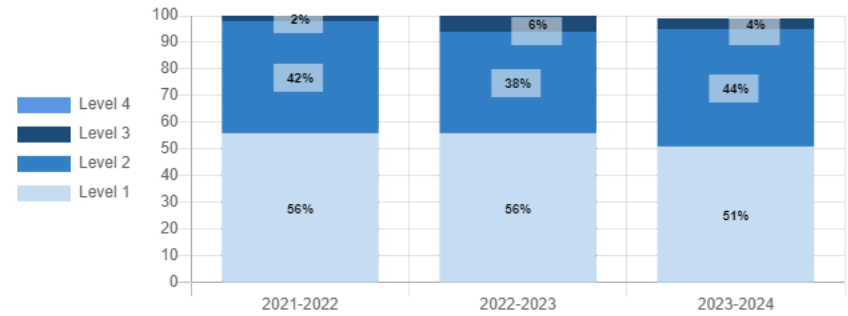

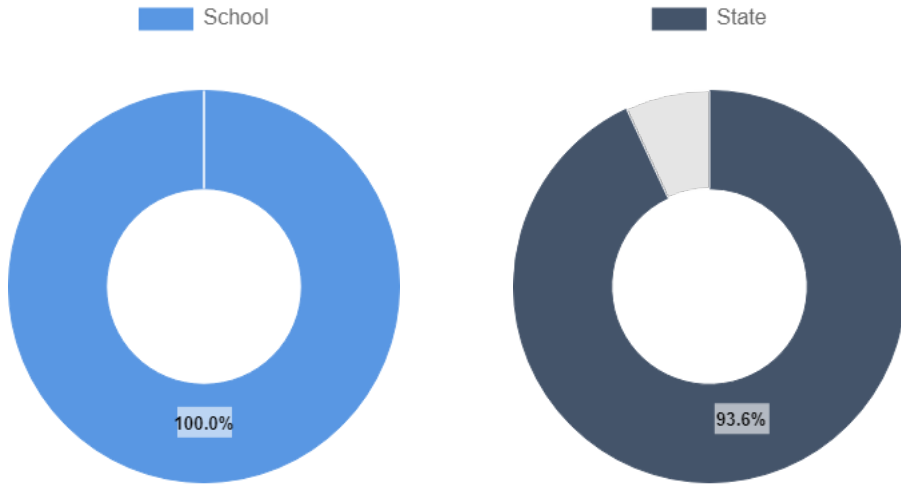

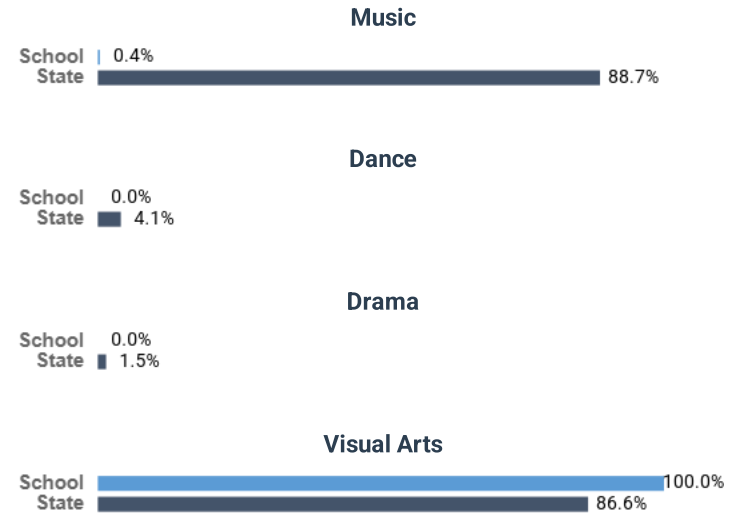

Students enrolled in one or more classes by discipline:



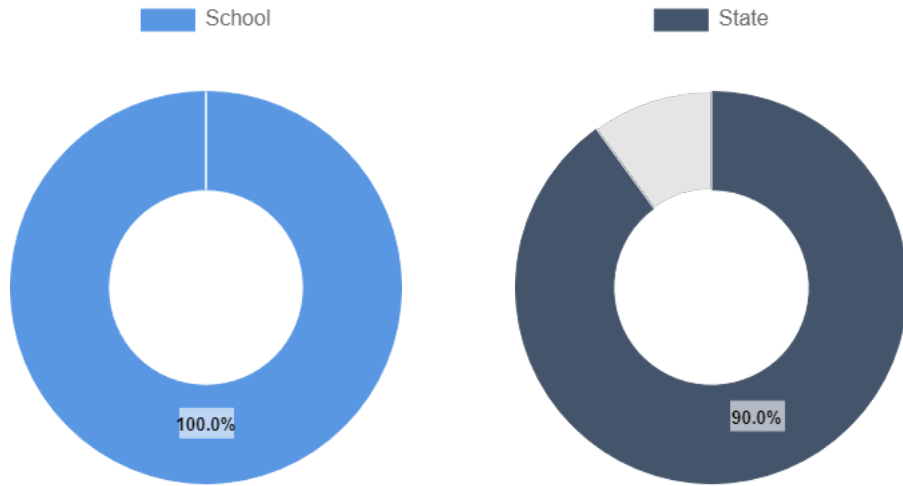

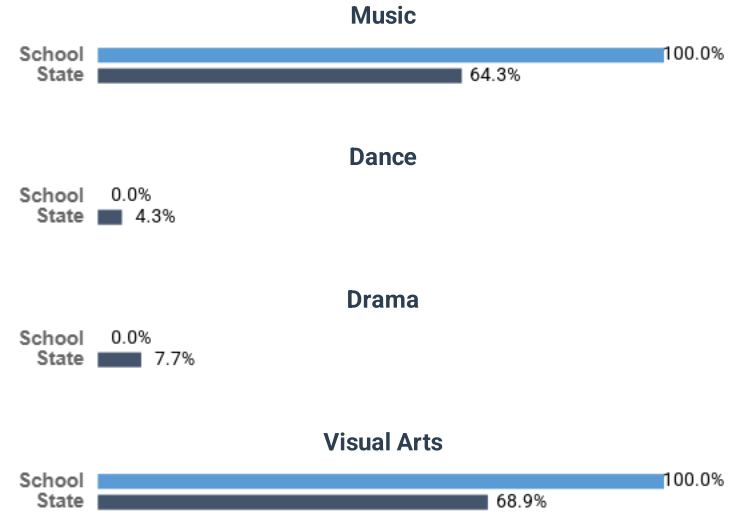

Students enrolled in one or more classes by discipline:



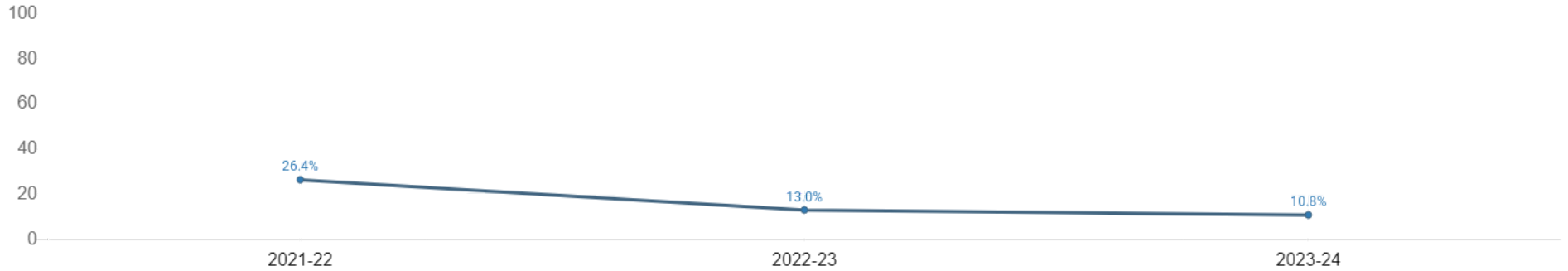

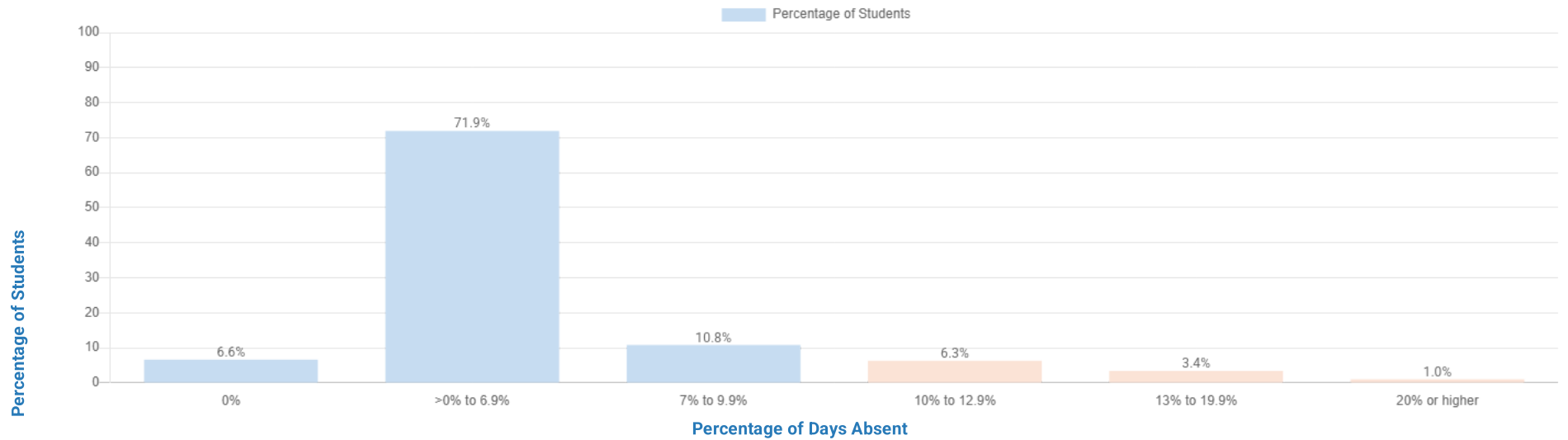

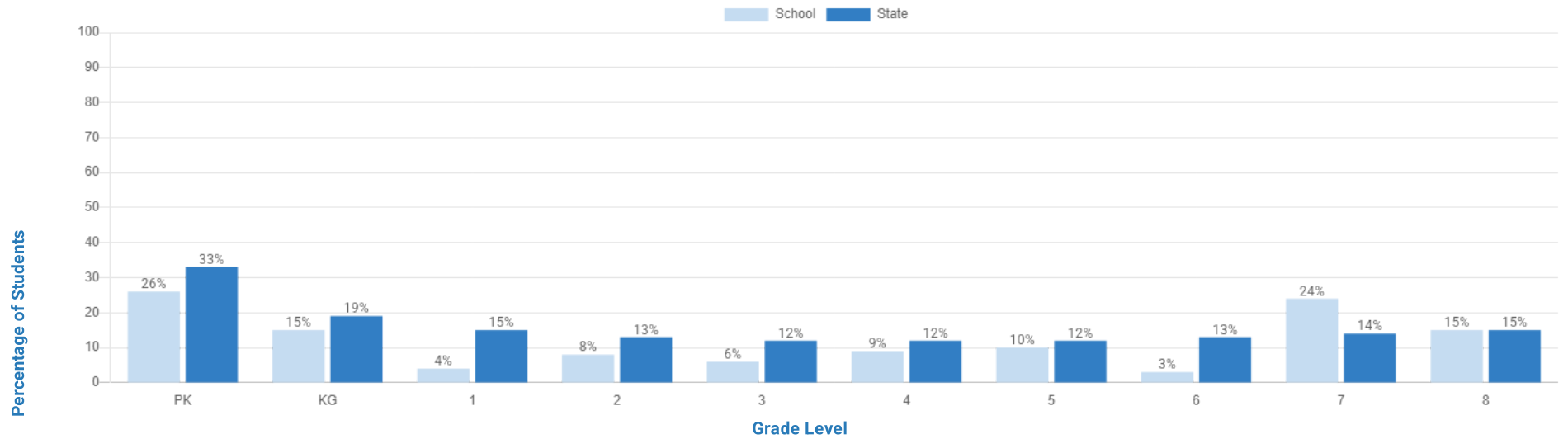

Staff

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

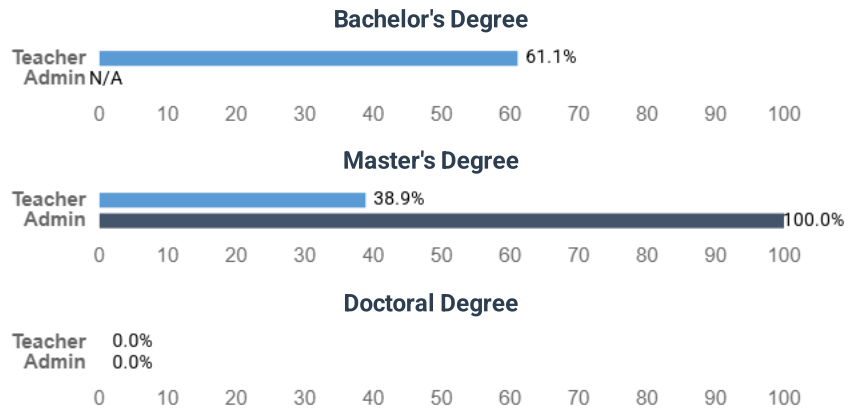

School Safety:

The Woodlynne School District takes many measures to keep our students and staff safe. We have installed a full indoor/outdoor camera system. To enter our building we now have a double door security measure, two sets of locked doors that must be unlocked by staff before entering. And we keep all indoor and outdoor doors locked throughout the day. We have appointed Mr. Guy Hamilton as our School Safety Specialist. Mr. Hamilton makes sure every student and staff member feel safe in school, when students do not feel safe, their mental health suffers, negatively impacting their academic performance. To thrive academically, emotionally, and socially, students require a safe and supportive school environment as the foundation for their success. There are 4 safe school elements that Woodlynne School District follows, Infrastructure, crisis communication, geography and procedures are four key security factors for establishing a safe school.



Technology and STEM:

The Woodlynne School District has an afterschool STEM Program for Fourth and Fifth Grade students. The Program runs for twelve sessions throughout the year.
