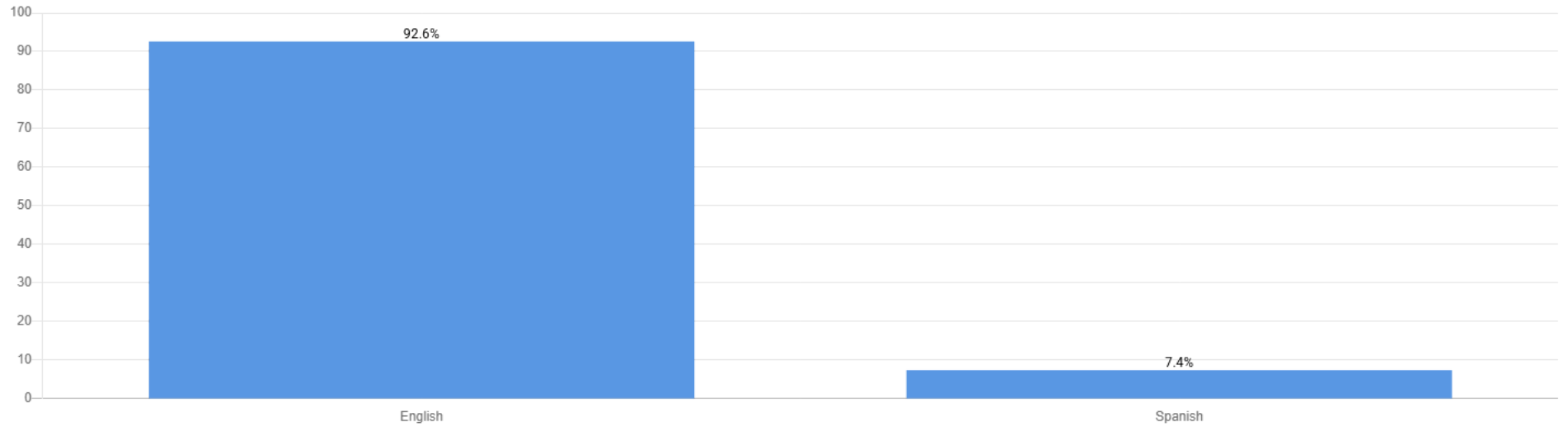

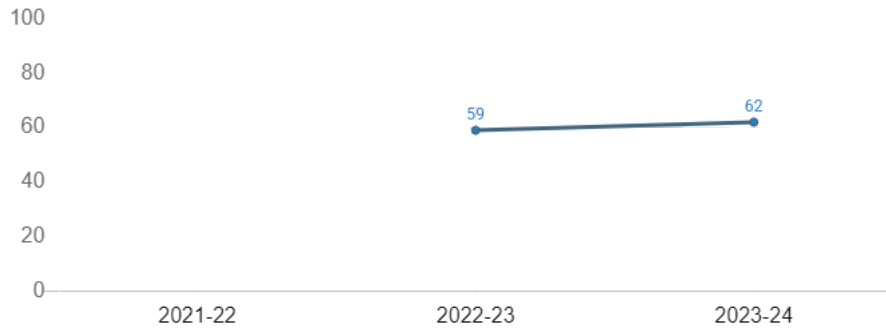

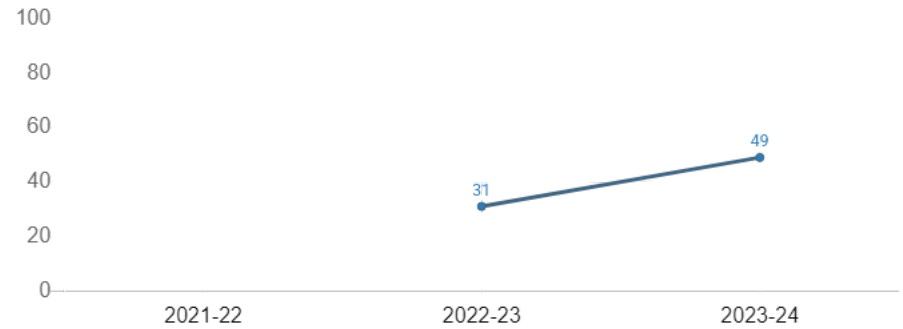

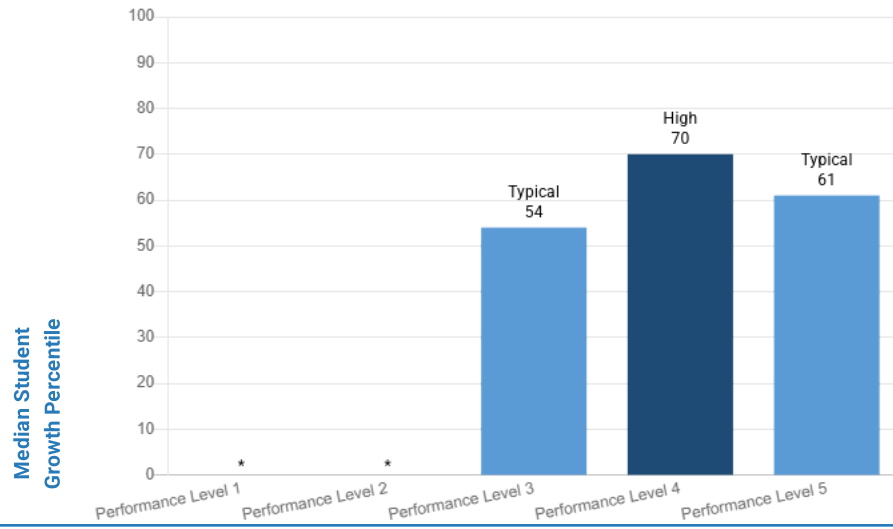

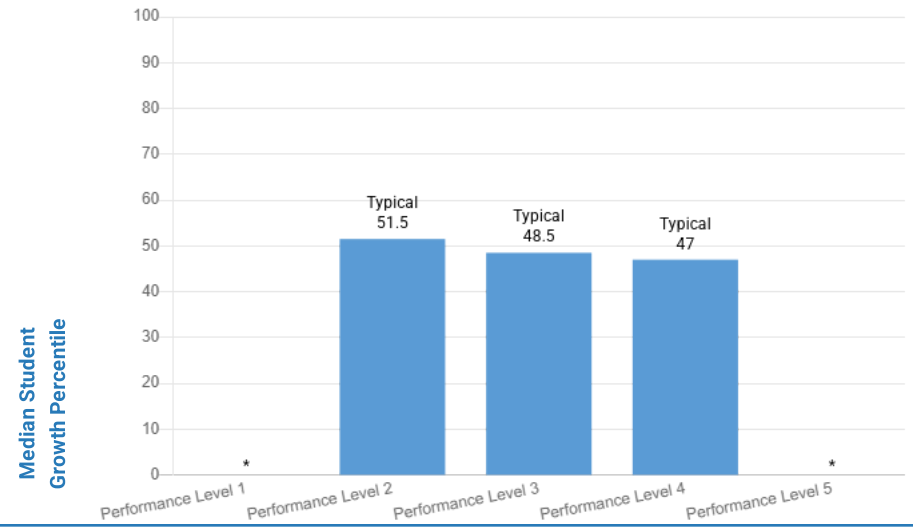

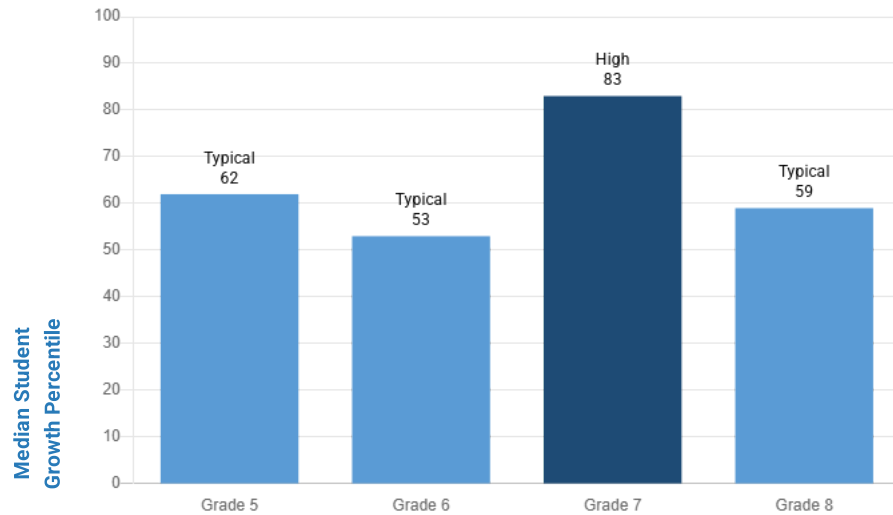

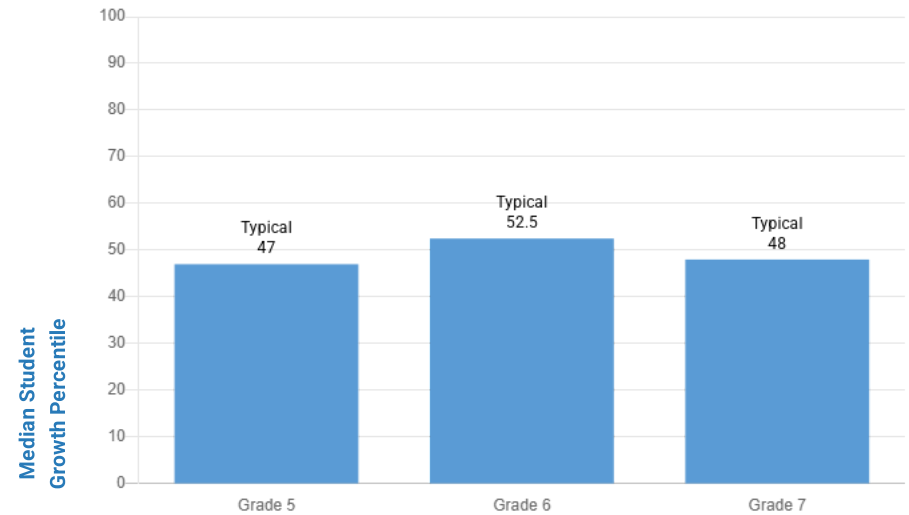

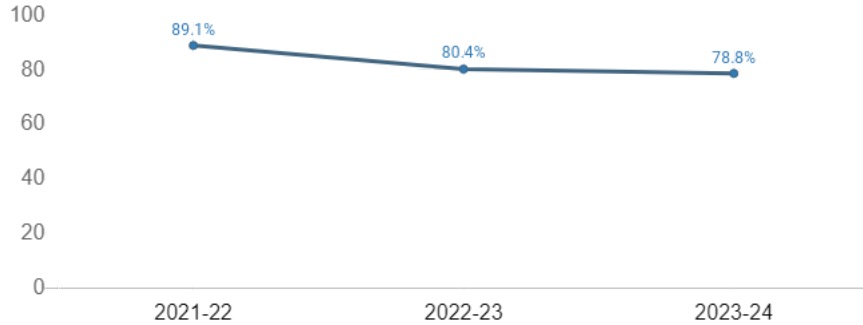

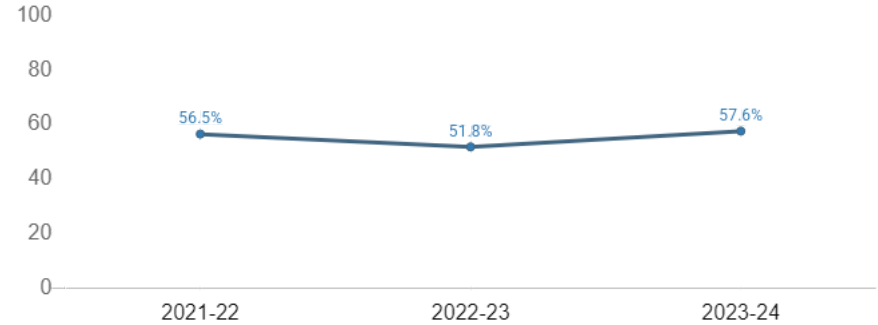
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 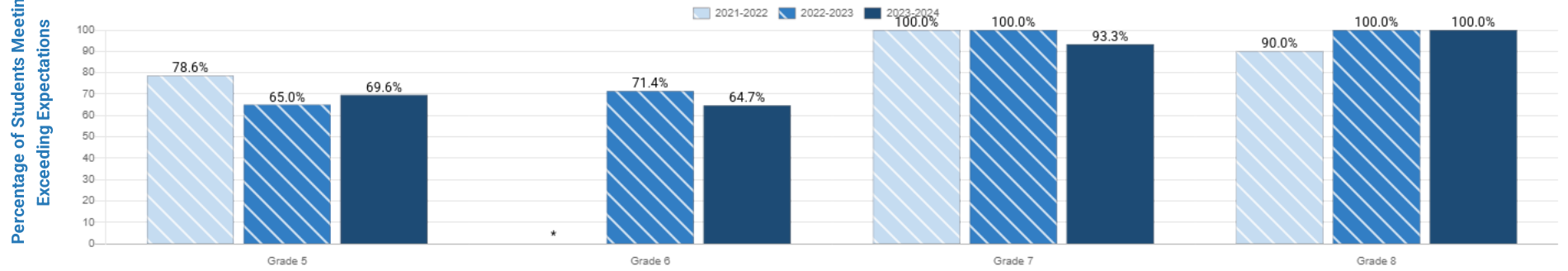

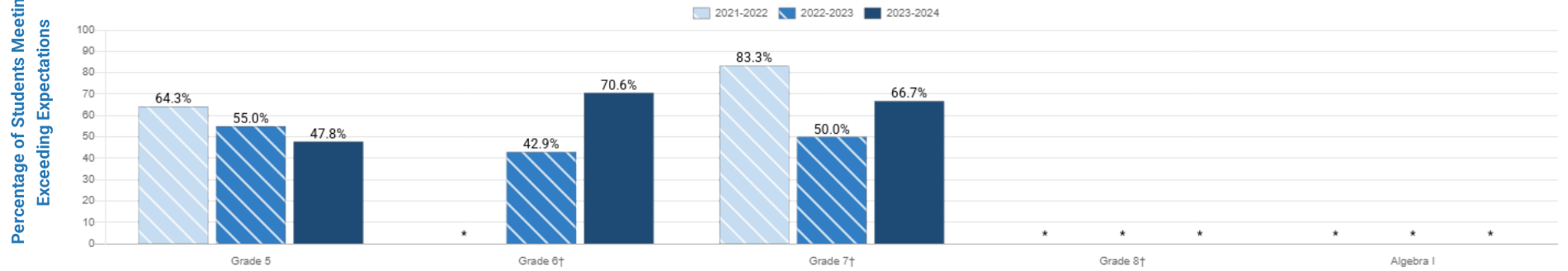

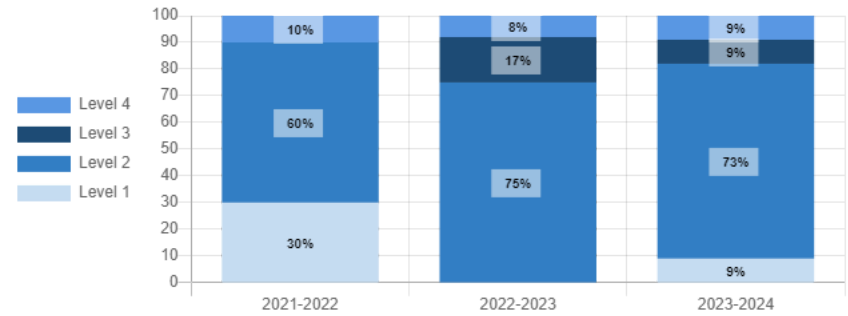

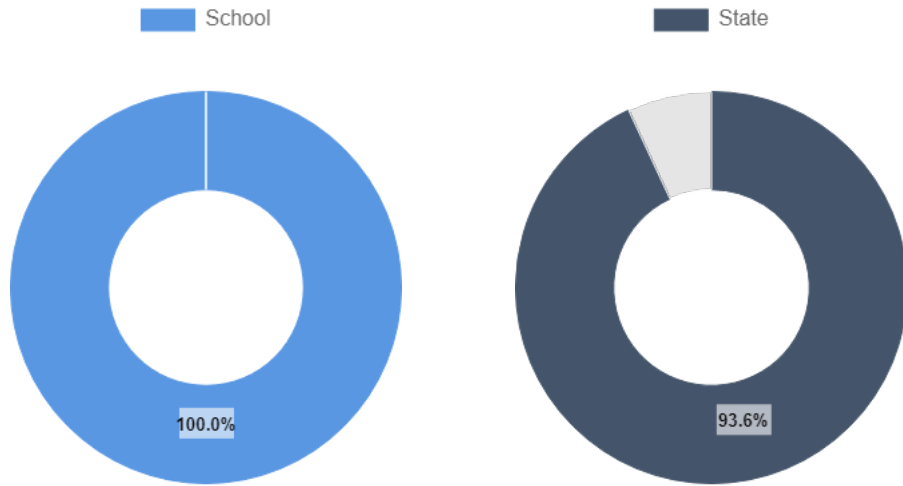

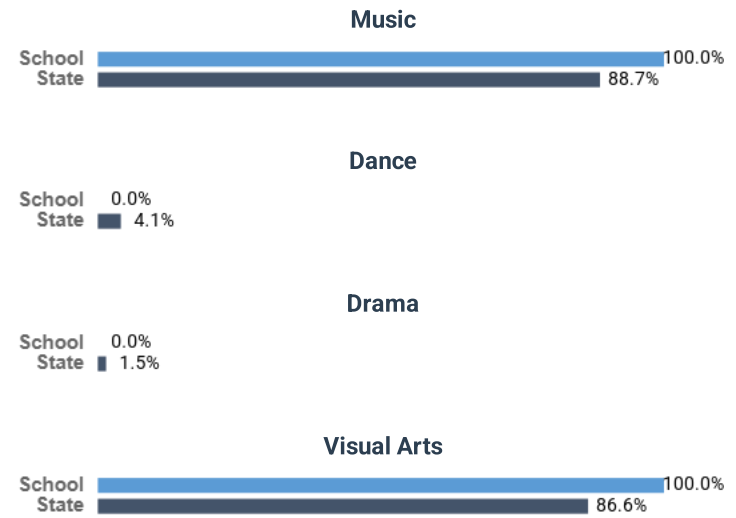

Students enrolled in one or more classes by discipline:



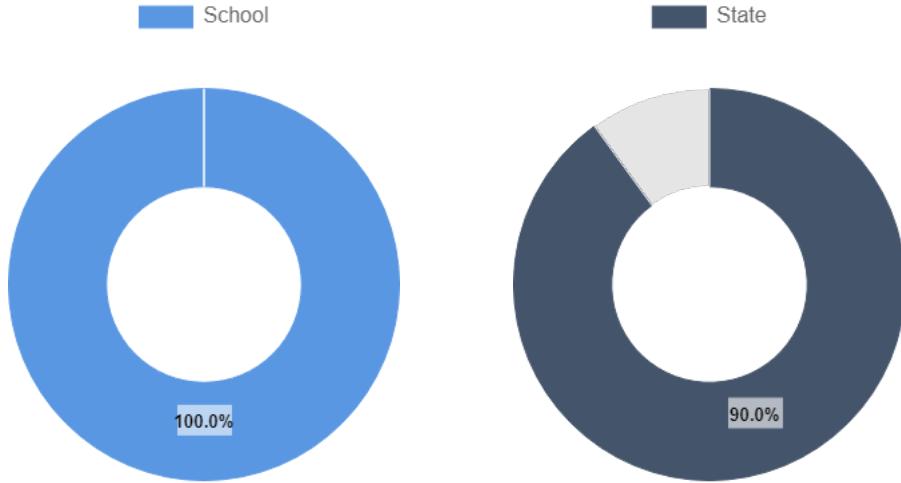

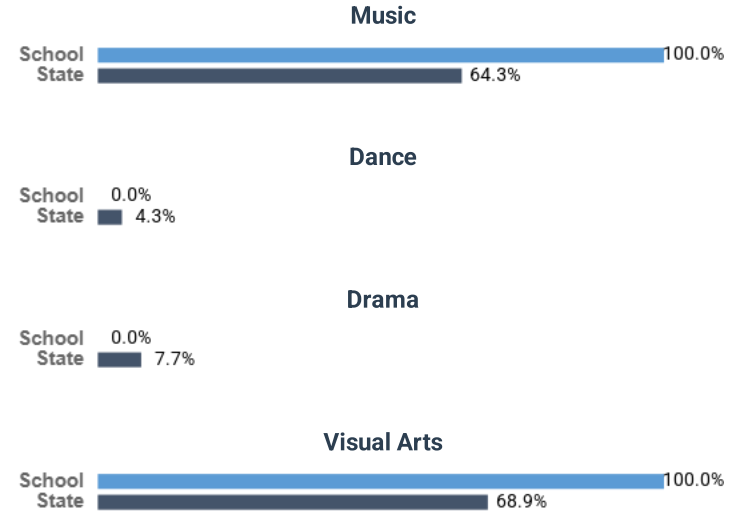

Students enrolled in one or more classes by discipline:



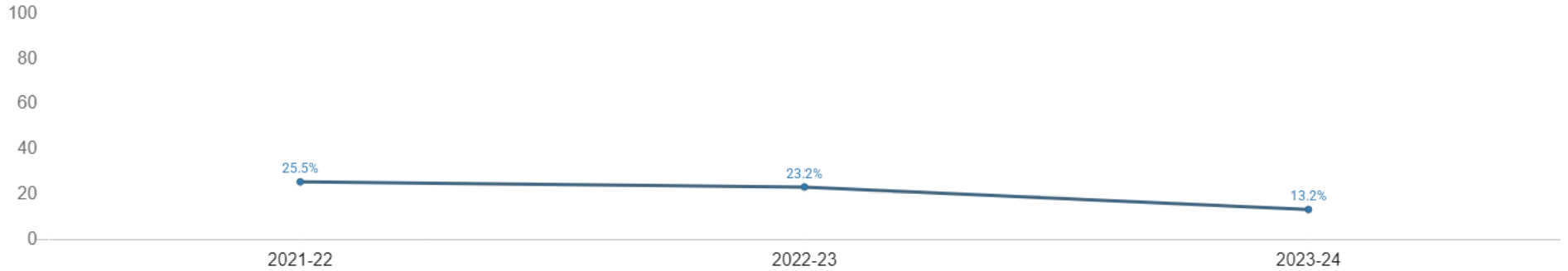

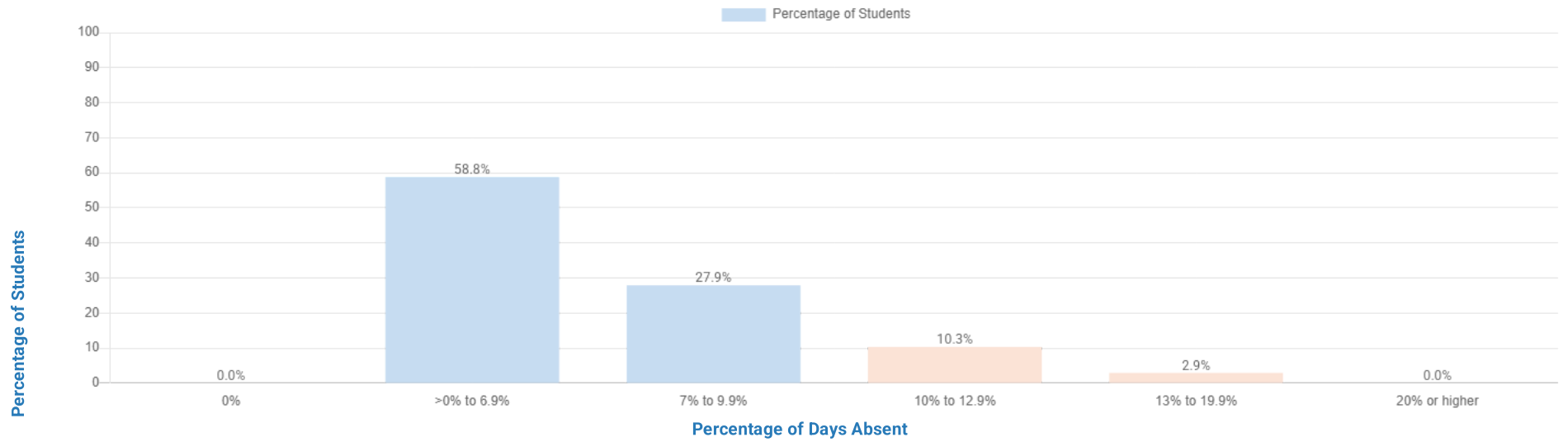

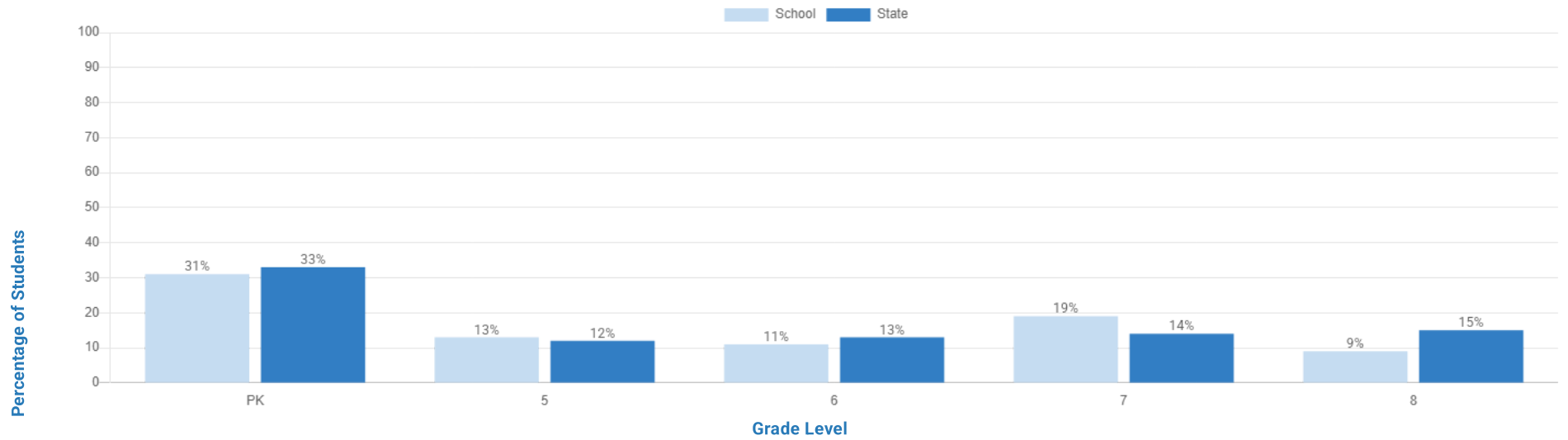

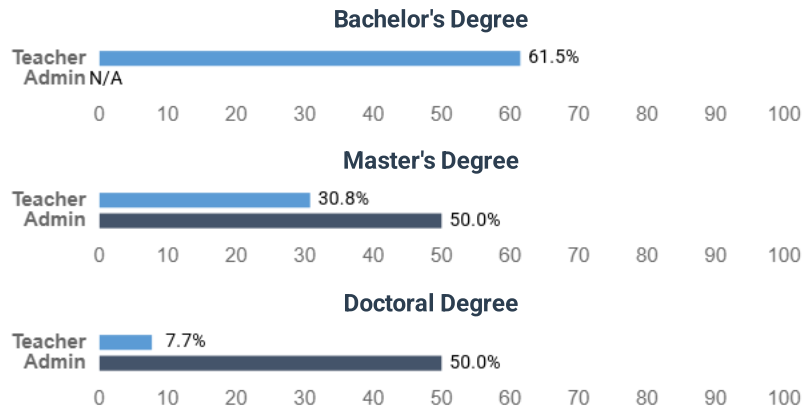

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Choice Based Learning is offered in grades 5-8 to promote student exploration of subjects that are not part of the basic curriculum.

The district continues to seek new ways to involve students in athletics while balancing their current commitments to other extracurricular activities. This year, Cheerleading was added as a new sport which grew exponentially during the season. Our Boys and Girls Cross Country teams also went undefeated, winning the league championship for the first time. Our JV girls basketball also had an undefeated season. We look forward to the continued growth of our athletic programs in years to come.

Staff and Professional Learning:

Staff members are offered multiple opportunities to advance their professional knowledge as individuals as well as a group. The Professional Development Committee, composed of teachers and administrators, annually develops a plan that encompasses the goals of the state, district, and individual teachers. Three professional development days are offered in-house to meet district level goals. After school faculty meetings cover topics such as school safety, student data and performance, and best practices for creating a positive school climate.



Student Supports and Services:

A full time Guidance Counselor and a full time School Psychologist provide counseling services as well as lessons in social and emotional learning for all students. Our full time school nurses communicate regularly with staff to ensure student medical needs are met. An I&RS team meets regularly to develop academic and behavioral supports for struggling students. Professional development this year focused on providing support for students who are dealing with anxiety. A Gifted and Talented Committee was formed to ensure the needs of diverse learners are addressed.



Student Health and Wellness:

Students in all grades receive gym and/or health class every week to ensure they are learning the appropriate way to care for their physical and emotional health. In addition, intramural and extra-curricular sports are offered to help students develop their fitness and encourage lifelong participation in athletic activities. Our nurses regularly screen students for hearing, vision, and medical issues that might interfere with student learning. Our school employs its own cafeteria manager who works with a Nutrition Committee to provide healthy, kid friendly meals.

Parent and Community Involvement:

Parent communication is frequent, student centered, and proactive. Students receive four report cards a year in addition to four Interim Progress Reports half way through each marking period. Teachers communicate with parents via email, phone, Google Classroom, social media, and a school based app. An active PTC fundraises for and plans activities for students. All committees engaged in school planning include parents and community representation.

Facilities:

The Avalon Elementary School is a fully equipped facility with dedicated spaces for a gymnasium, cafeteria, and athletic fields including a soccer field and a four-lane track. A MakerSpace lab and dedicated science lab encourage the infusion of technology in our classroom lessons. Unique to Avalon Elementary is the city's full time public Library is housed on site. This allows students to visit the Library regularly during and after school, attend Library programs, and become familiar with the Avalon Public Library staff and programs.

School Safety:

Many facility upgrades were made in recent years to ensure the safety of staff and students. This includes adding a vestibule for no access drop off of student items as well as shatter resistant glass to entrances and doorways. In Avalon, the Police and Fire Headquarters share a parking lot with the school, allowing for immediate response to emergencies. District staff are trained in the use of Epi-Pens, CPR, Defibrillators, and Basic First Aid. The building administrator is a certified School Safety Specialist and works in conjunction with local first responders to plan and execute safety and security plans and drills.



Technology and STEM:

A dedicated MakerSpace classroom complete with 3-D printing, digital display, and project based equipment, provides a hub for technology and STEM learning. The District hosts MakerSpace challenges for both Middle and Elementary students. A STEM club provides opportunities for additional learning outside of the school day.



Early Childhood Education:

The Avalon Elementary School is home to a full day preschool program for 3 and 4 year old students. Our Pre-K classes utilize the Creative Curriculum for instruction and are staffed with a full time, Early Childhood Education certified teacher and a full time paraprofessional in each room. The curriculum focuses on hands-on discovery and play based learning. Class sizes range from 10-15 students. This program is offered at no cost to resident students and tuition students are accepted based on availability of seats. Pre-K students also receive weekly instruction in the Arts, Music, Spanish, Health and PE from certified teachers. The district has its own school bus with an aide to provide transportation for all resident students. The focus of our program is to meet each child where they are and help them grow confidence, social skills, strong foundations in literacy and math, and critical thinking aptitudes.

The districts also share a bus which transports resident students to school as well as allows the students to travel between Stone Harbor and Avalon for activities, assemblies, and school functions. The Avalon and Stone Harbor Schools support students in their transition to high school and beyond.
