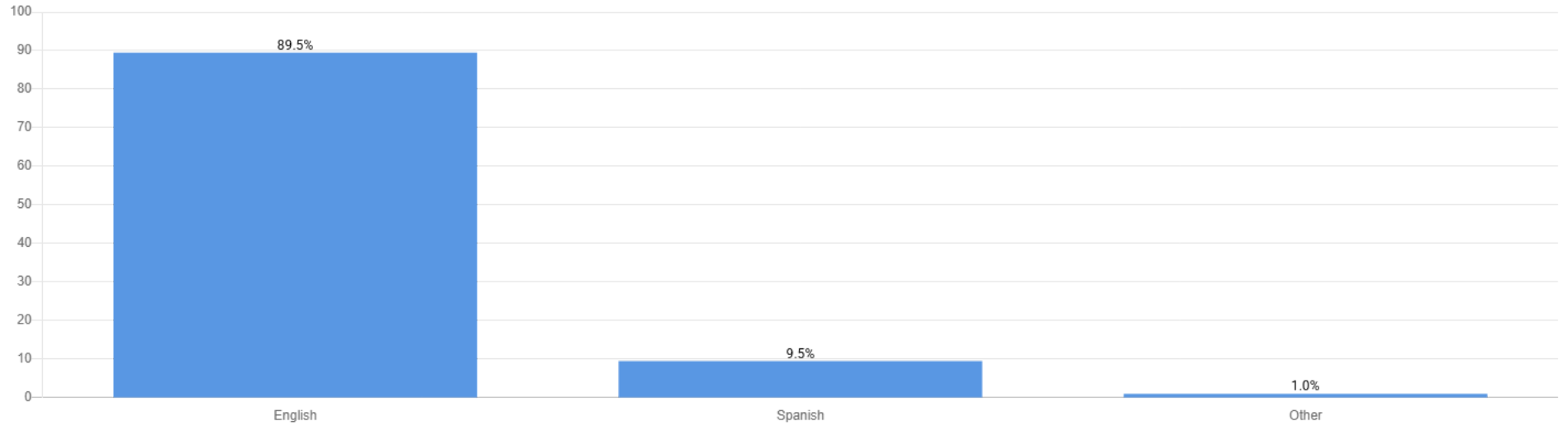

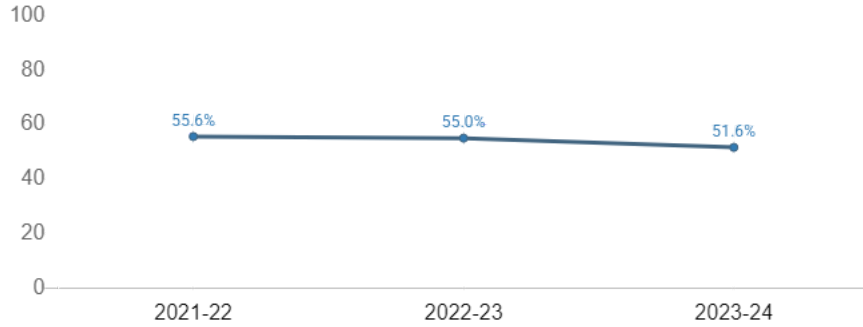

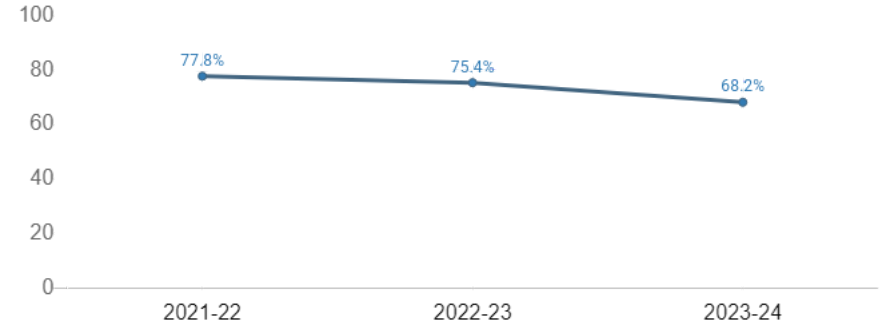
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 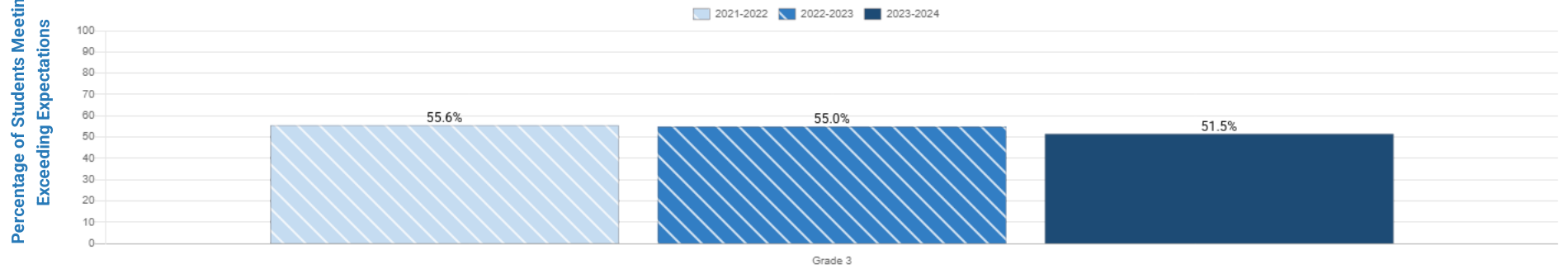

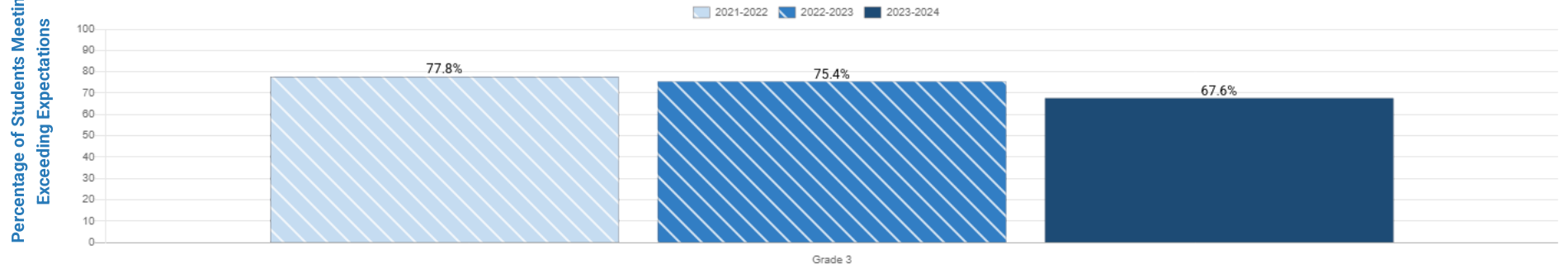

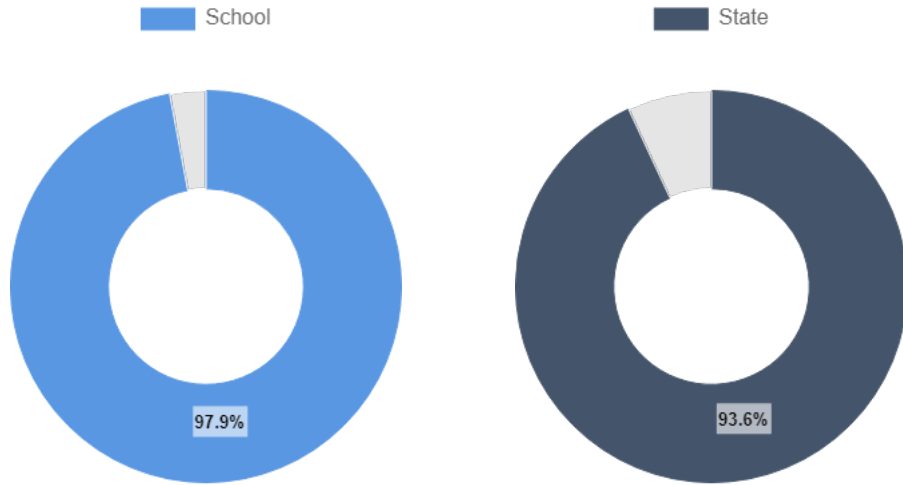

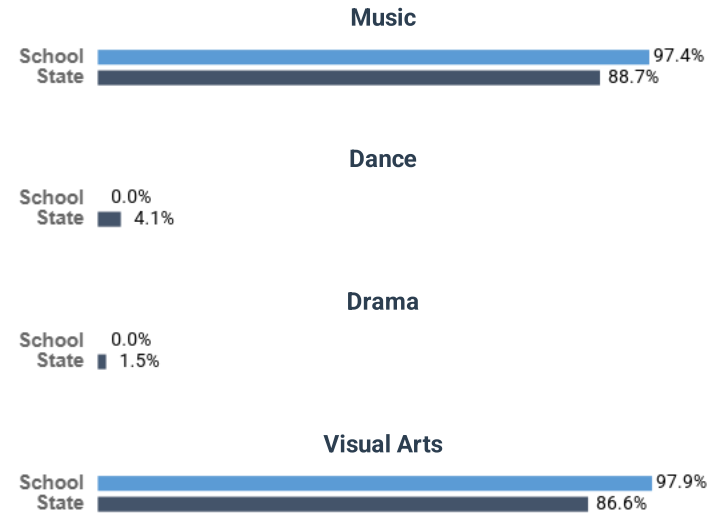

Students enrolled in one or more classes by discipline:



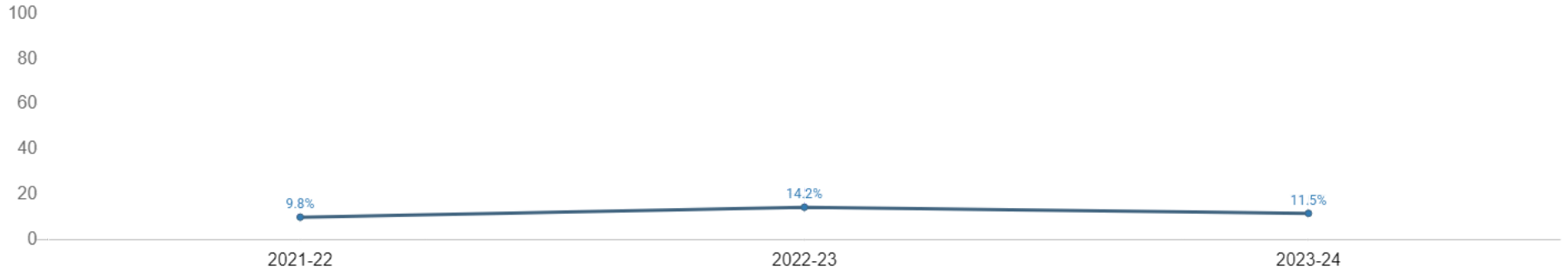
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. 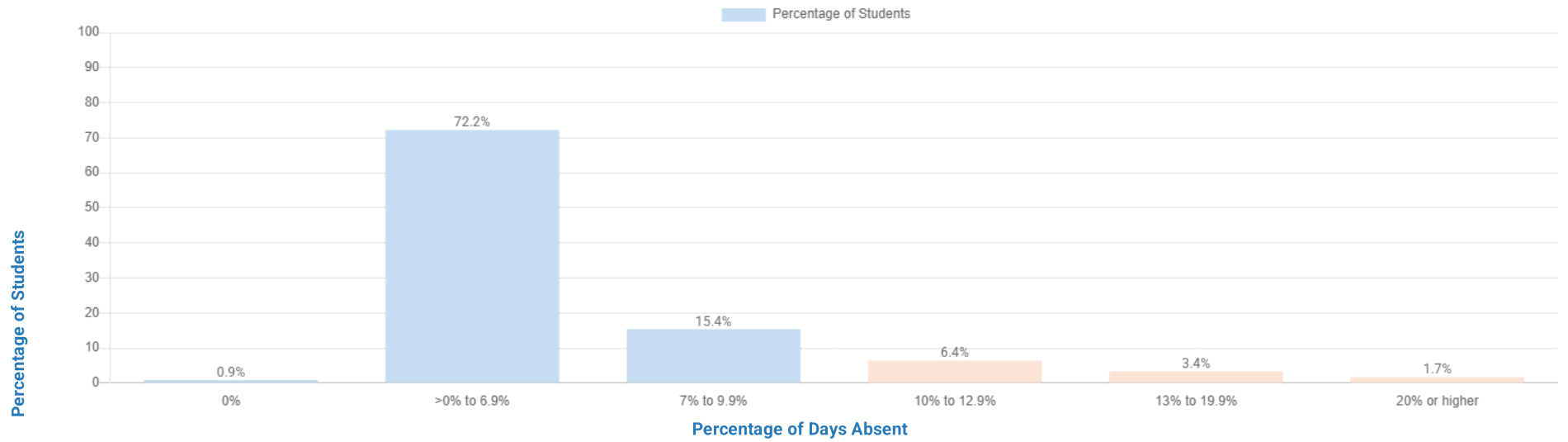

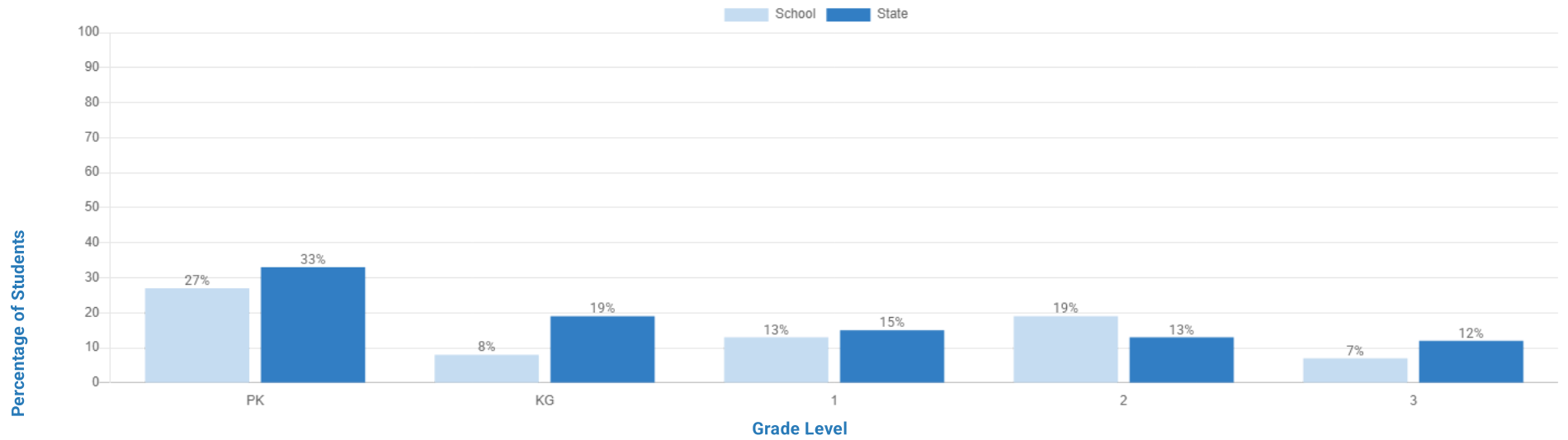

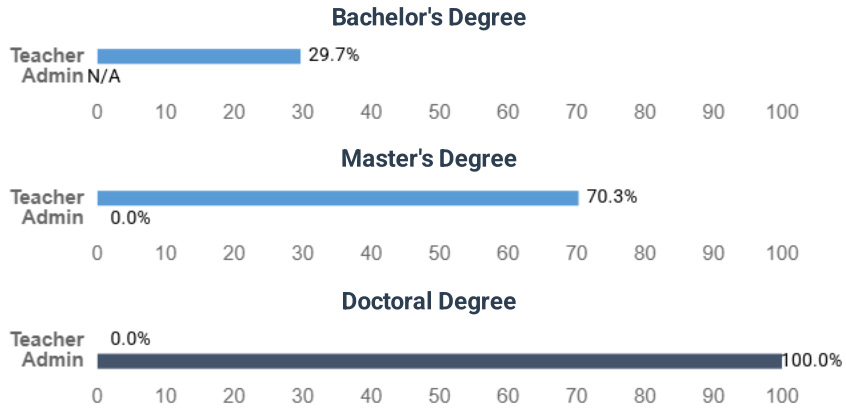

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Courses, Curriculum, Instruction:

Our K-3 programs offer a comprehensive curriculum in language arts, mathematics, social studies, and science, all aligned with NJ Student Learning Standards. In addition, students participate in physical education, media/technology, art, music, wellness, and world language classes. Our teachers utilize differentiated instruction, integrating research-based practices to deliver a standards-driven curriculum. They foster a growth mindset by using data to inform instructional decisions. Our full-day inclusive preschool implements the Creative Curriculum, supporting the development of the whole child. An intense focus on social-emotional learning promotes each child's value and importance. Every student is equipped with a personal device to support their learning needs and enhance achievement across any learning environment. To bring 21st-century learning to the forefront, each classroom is equipped with an Interactive White Board to promote engagement and make learning come alive.



Clubs and Activities:

A high percentage of students throughout the district are actively involved in extracurricular activities, which we believe are essential for developing well-rounded individuals ready for success in the 21st century. One example is our evolving "Primary Express Newspaper," where students serve as reporters, publishing 2-4 editions each year. Our Multicultural Club promotes cultural awareness, sensitivity to individual differences, and respect for diversity among students. Additionally, our Family Literacy Club brings parents and students together after school to read and discuss books. The OC Life 21 Club allows students to develop innovative projects from start to finish-one recent project involved constructing a LEGO room for students to showcase their creativity. We are continually exploring new opportunities to expand extracurricular activities and further enrich the student experience.

Staff and Professional Learning:

Professional learning at Ocean City Primary School is guided by a comprehensive needs assessment and covers a wide array of topics and learning opportunities. Our focus on student achievement data informs instructional decisions, with ongoing professional development centered on data tracking, identifying relevant data factors, and empowering students to examine their own progress. This data-driven inquiry process is strengthened by teacher collaboration, ensuring a deeper understanding of student needs and the implementation of effective strategies to address them. A core component of our approach is teacher collaboration, where educators work together to gain a deeper understanding of student needs and implement evidence-based strategies to address those needs effectively. Additionally, our teachers prioritize Social and Emotional Learning (SEL) to ensure we support the whole child, recognizing the importance of addressing both academic and personal development in our students.



Student Supports and Services:

Ocean City Primary School is committed to providing a comprehensive continuum of educational supports for students with diverse needs, ensuring services are delivered in the least restrictive environment. Our inclusive pre-K program integrates special education teachers and related services to support all learners. For students in Kindergarten through 3rd grade, we offer a range of services from general education to self-contained classrooms, meeting varying levels of need. The school provides extensive related services, including occupational therapy, physical therapy, speech and language therapy, counseling, and behavioral supports. Title I services support struggling readers, and English Language Learners receive specialized assistance to foster language acquisition. Gifted students participate in our GATE program, ensuring enrichment and engagement for all students across the educational spectrum.



Student Health and Wellness:

Health and wellness are central to the programs at Ocean City Primary School. We have implemented a standards based approach that encourages a safe and inclusive school environment. This approach is integrated into our weekly class meetings and supported through monthly lessons that reinforce anti-bullying practices with fellow classmates and special area teachers. Our students participate in monthly assemblies focused on character education, where a unique character trait is highlighted each month. During these assemblies, students learn how to embody positive character traits, and individual students who exemplify the monthly trait are celebrated. Through our Wellness Program, we equip students with resources and skills to make healthy behavioral choices. The program promotes physical and mental wellness, teaching coping skills and fostering confidence to support students' physical, emotional, and social growth.

Facilities:

Ocean City Primary School, a 59-year-old building, has recently been modernized to enhance its facilities and learning environment. The school includes essential spaces such as classrooms, offices, bathrooms, and a cafeteria, along with specialized areas to enrich student learning. These include a library/media center, a Lego STEAM lab, a computer lab, an art room, a music room, a foreign language classroom, and a multipurpose room that serves as both a gym and performance stage. Recent upgrades include centralized air conditioning throughout the building, ensuring comfort across all spaces. Structural improvements, including new concrete and curbs, have been completed, and a school garden was added. The playground is refreshed annually with upgraded mulch and play equipment, with additional structures and a shade covering specifically for preschool-aged children to create a safe and engaging outdoor area for our youngest students.

School Safety:

Technology and STEM:

Our technology program immerses students in a dynamic, hands-on learning experience with emerging technologies, encouraging creativity and exploration. Students have the opportunity to design/3D print an object of their choice using computer-assisted design software, gaining experience in digital creation/self-guided project management. Students continue to engage in projects like designing and engineering a Bluetooth-connected remote-controlled car, which they can showcase in a robotics competition. Students are also introduced to media editing software, while creating promotional videos for their projects, blending technical skills with creative expression. The curriculum covers diverse topics including video game creation, robotics coding, civil and electrical engineering, Google tools, and virtual environments, all aimed at fostering problem-solving and critical thinking. Students acquire a broad set of technology skills and the confidence to apply them to real-world challenges.



Early Childhood Education:

The Ocean City Primary School preschool program, funded through the Preschool Education Aid (PEA), features five full-day classrooms dedicated to serving 3- and 4-year-old students. The mission of the Ocean City School District Board of Education is to provide a high-quality learning environment for Early Childhood students, fostering critical thinking, embracing diversity, and cultivating enthusiasm and a love of learning. Our curriculum is carefully aligned with the district's comprehensive K-12 curriculum and encompasses interdisciplinary content. It is developed in accordance with the Preschool Teaching and Learning Standards, the standards set by the National Association for the Education of Young Children, and the objectives outlined by the Creative Curriculum. This alignment ensures that our preschool program offers a rich, engaging educational experience that prepares young learners for future academic success.
