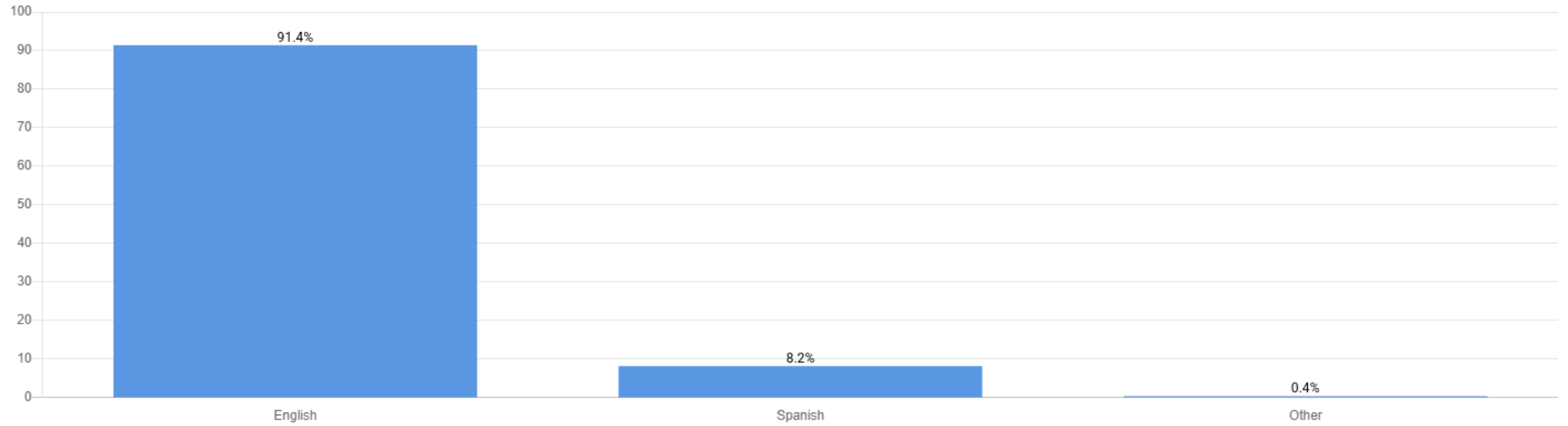

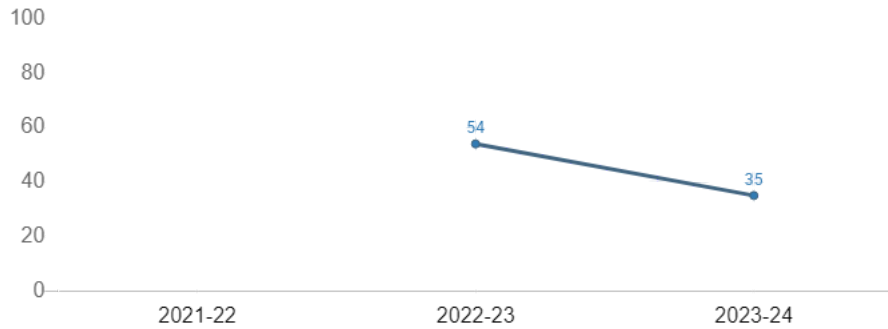

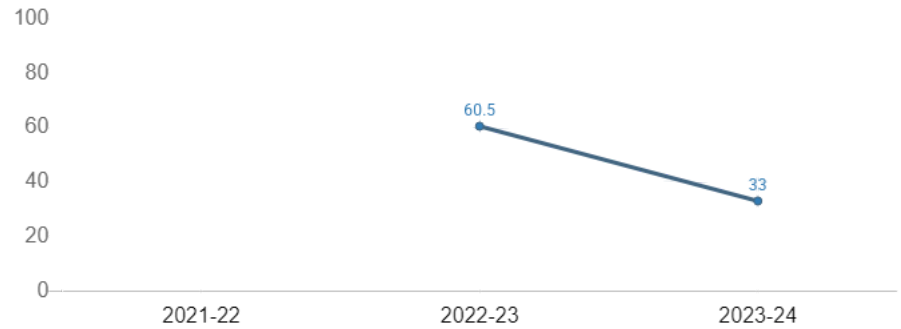

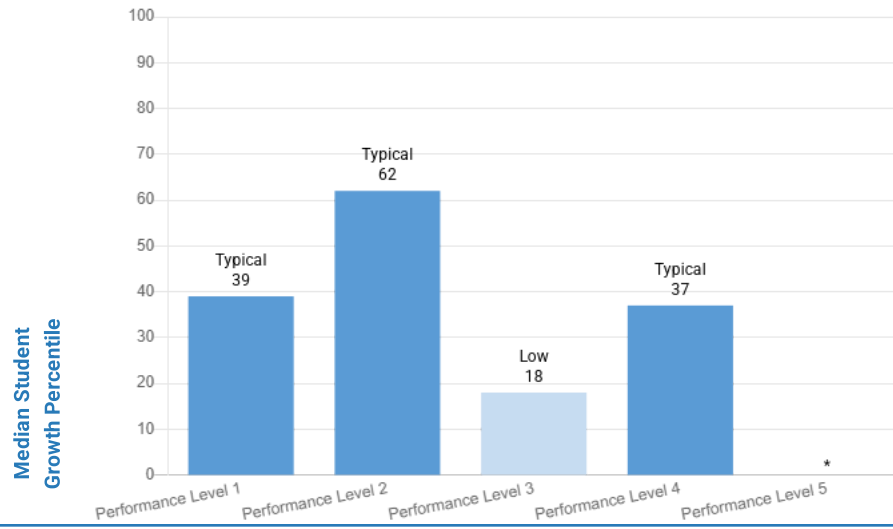

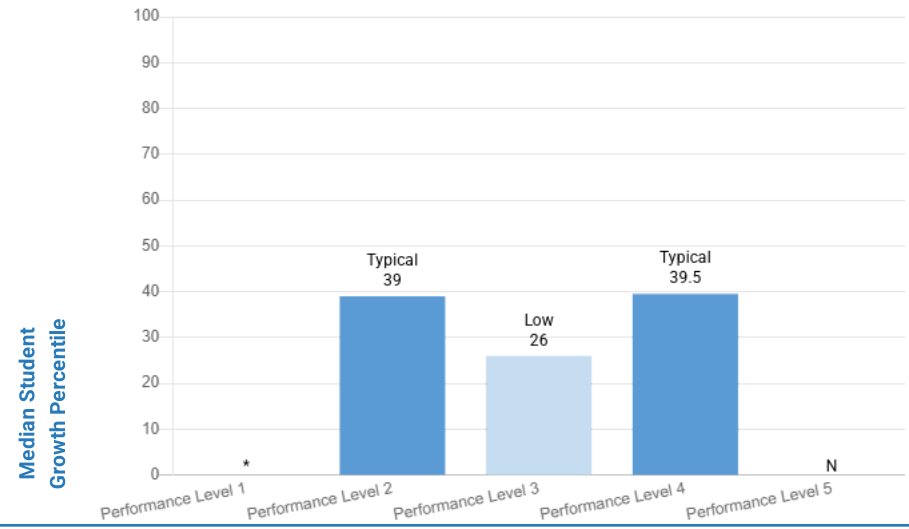

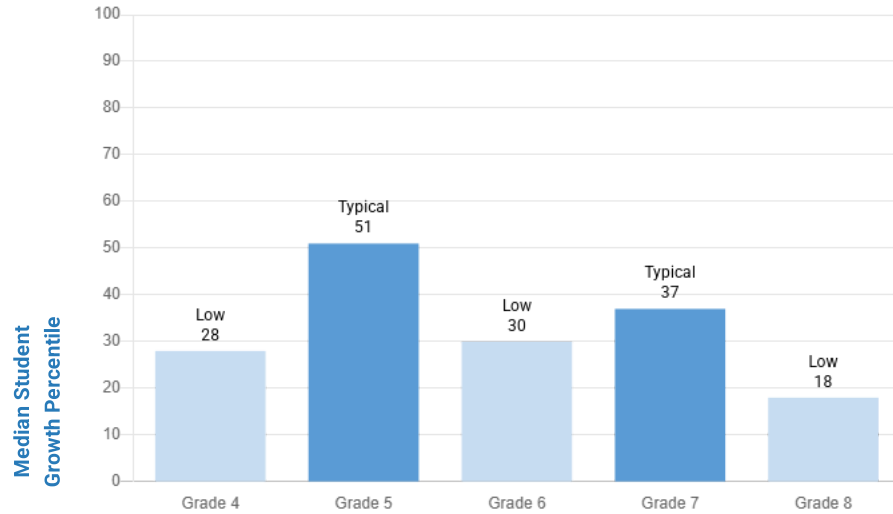

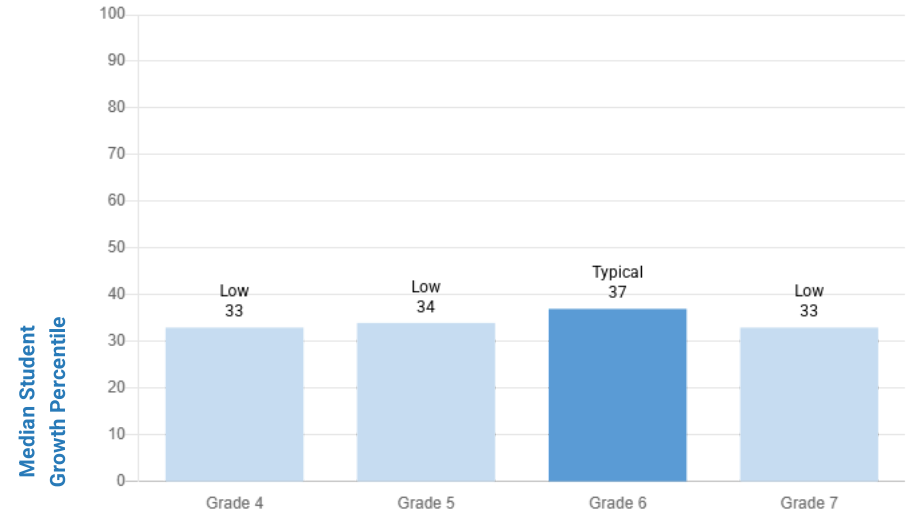

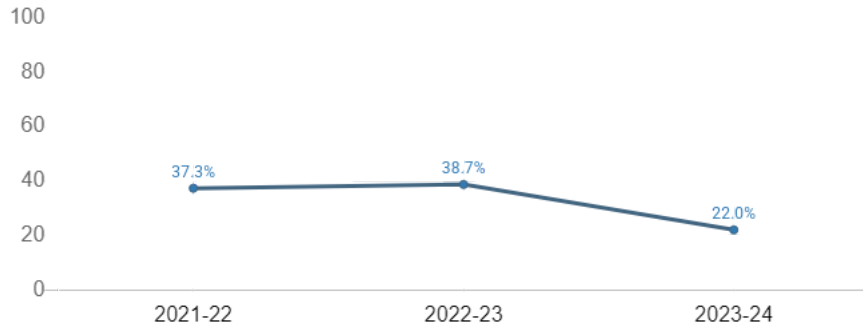

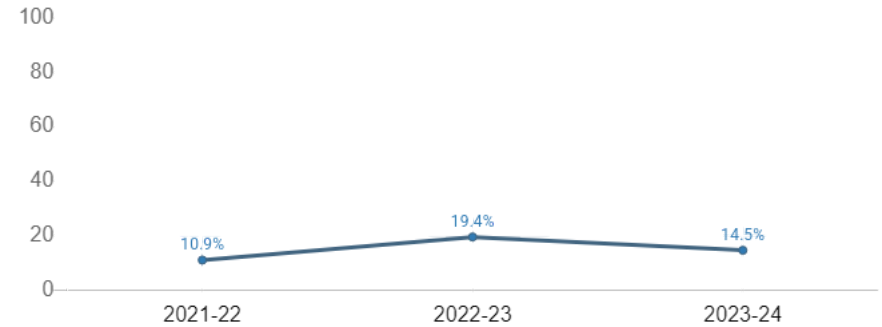
English Language Arts and Mathematics Performance Trends

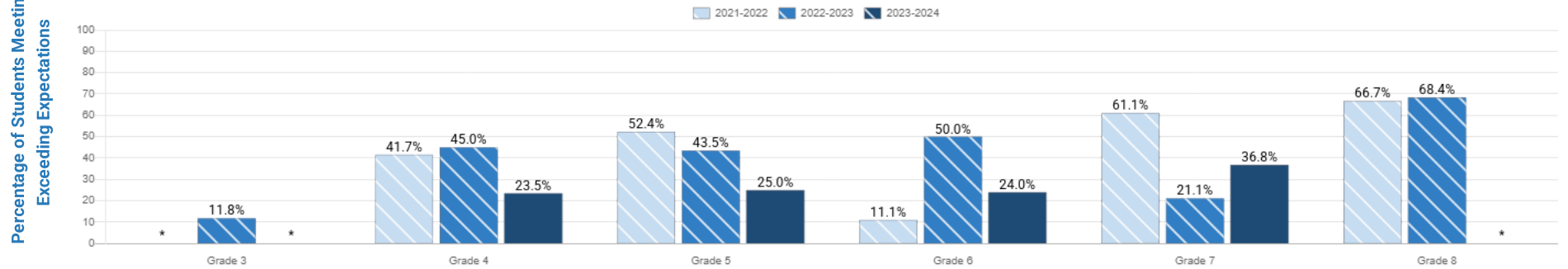

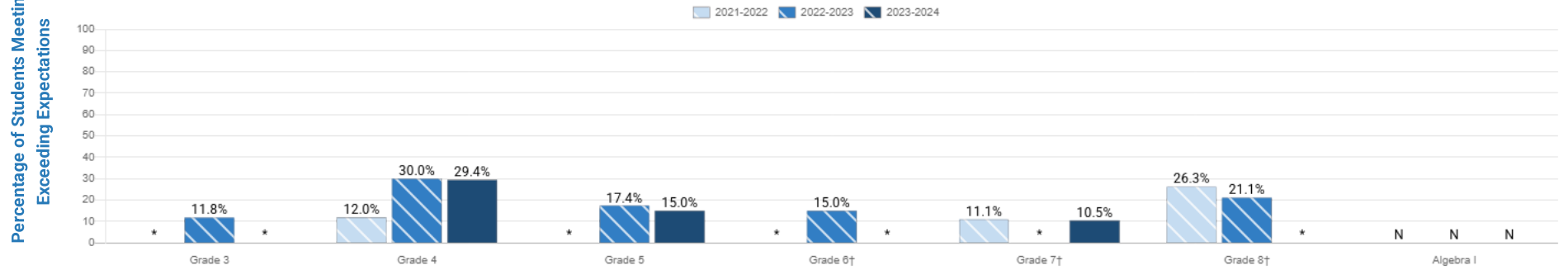

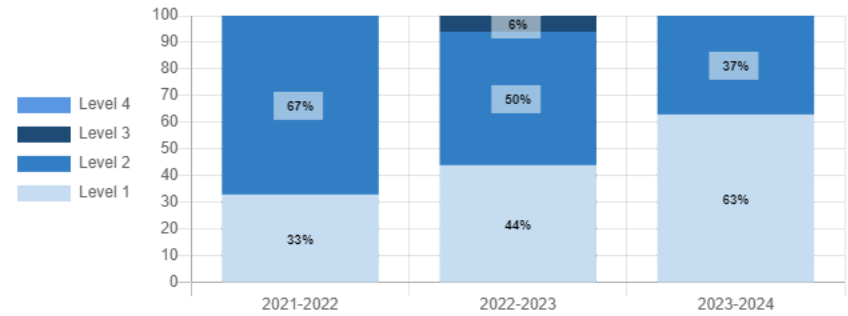

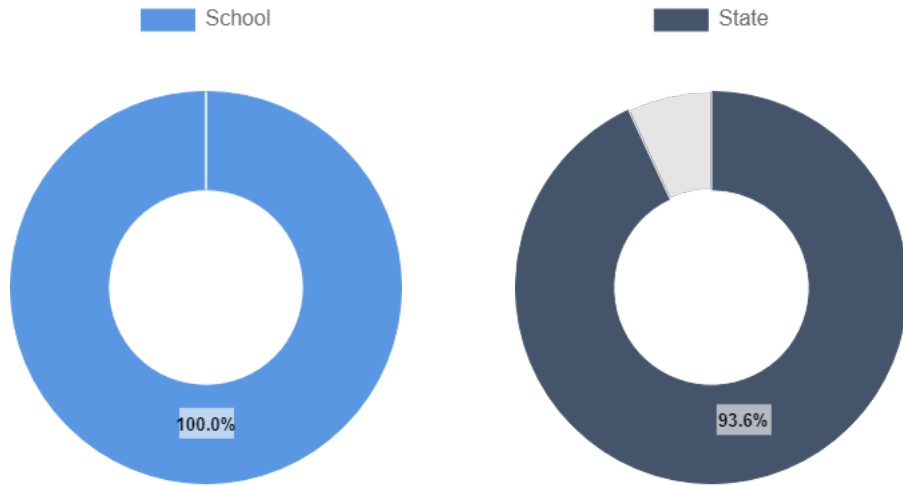

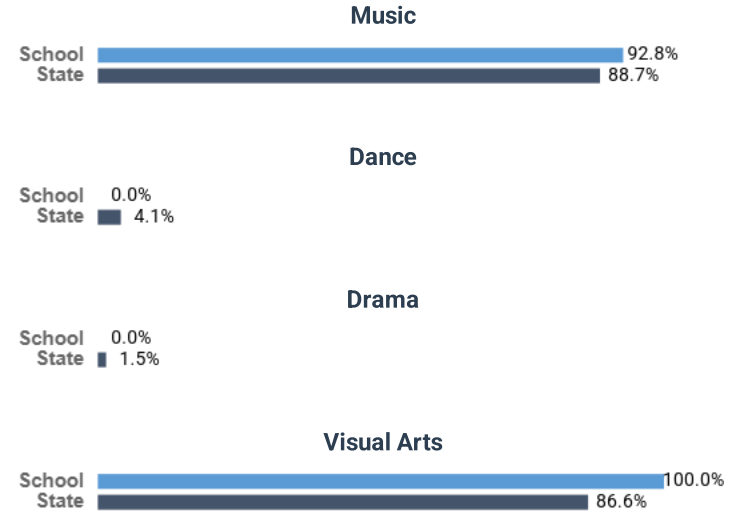

Students enrolled in one or more classes by discipline:



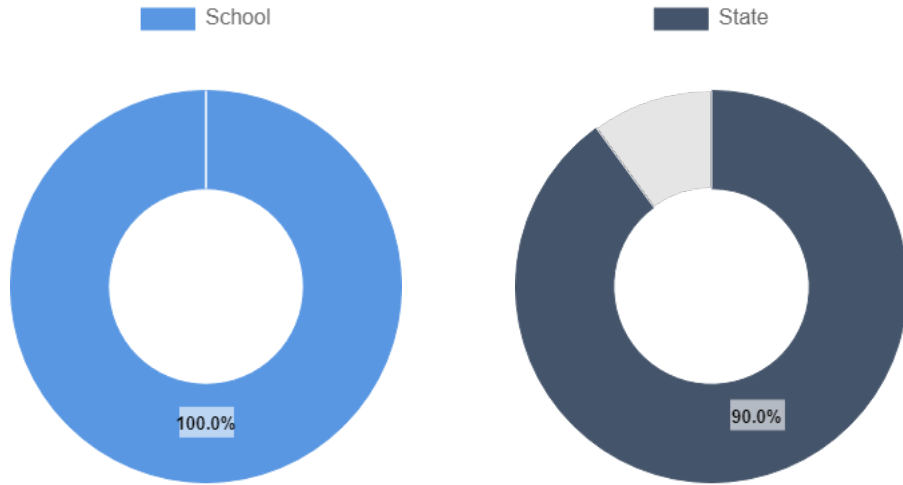

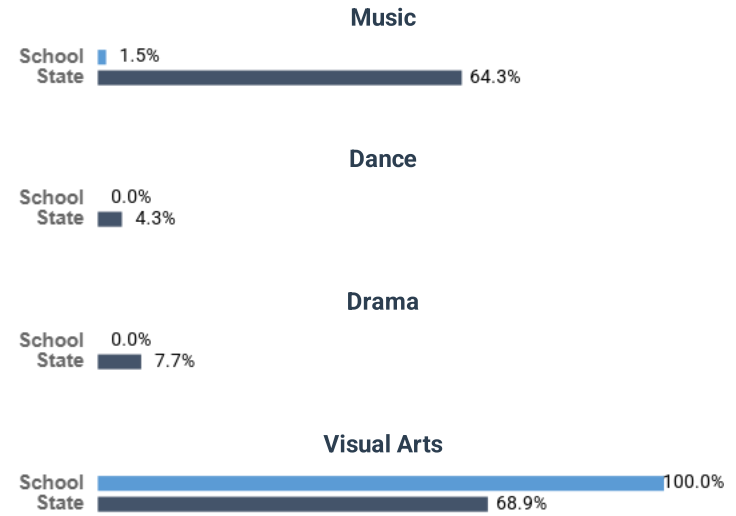

Students enrolled in one or more classes by discipline:



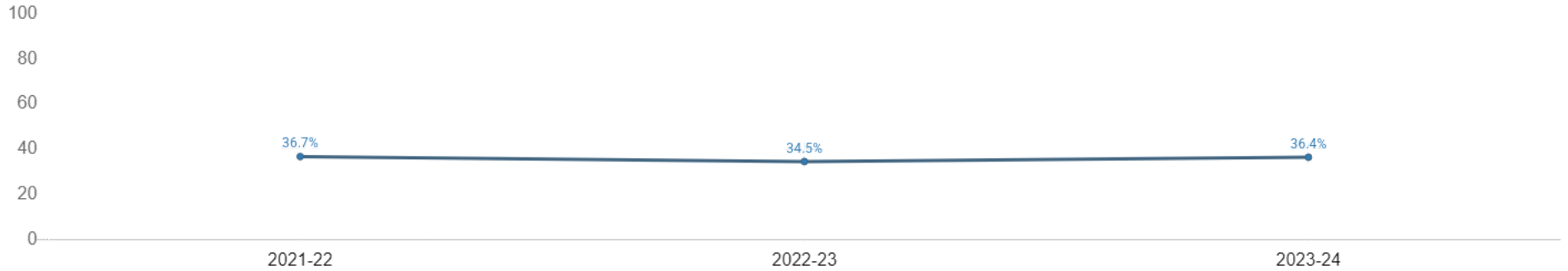

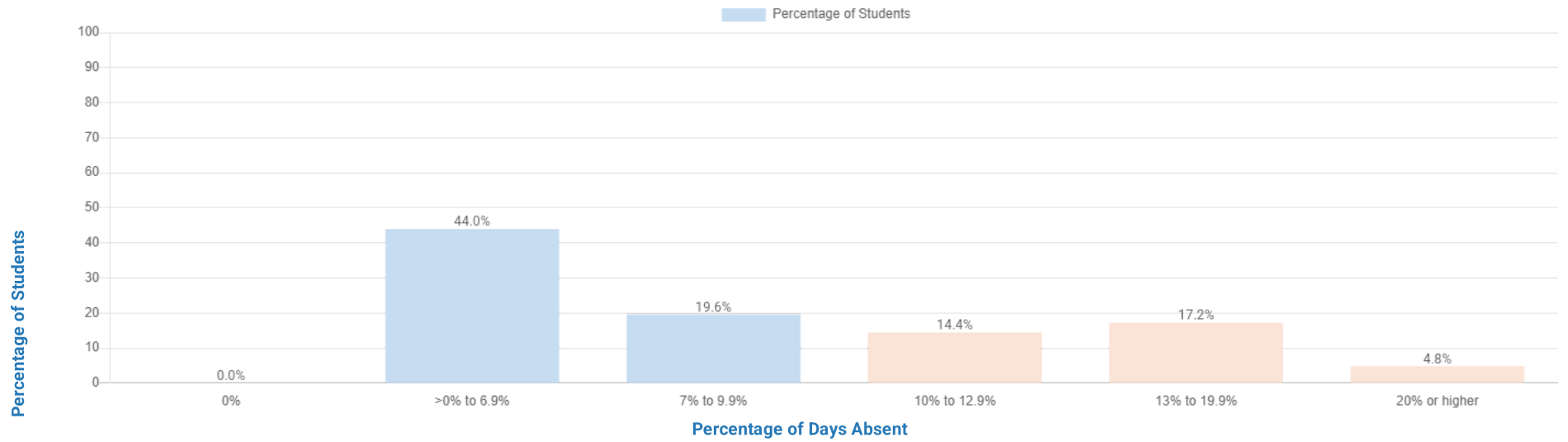

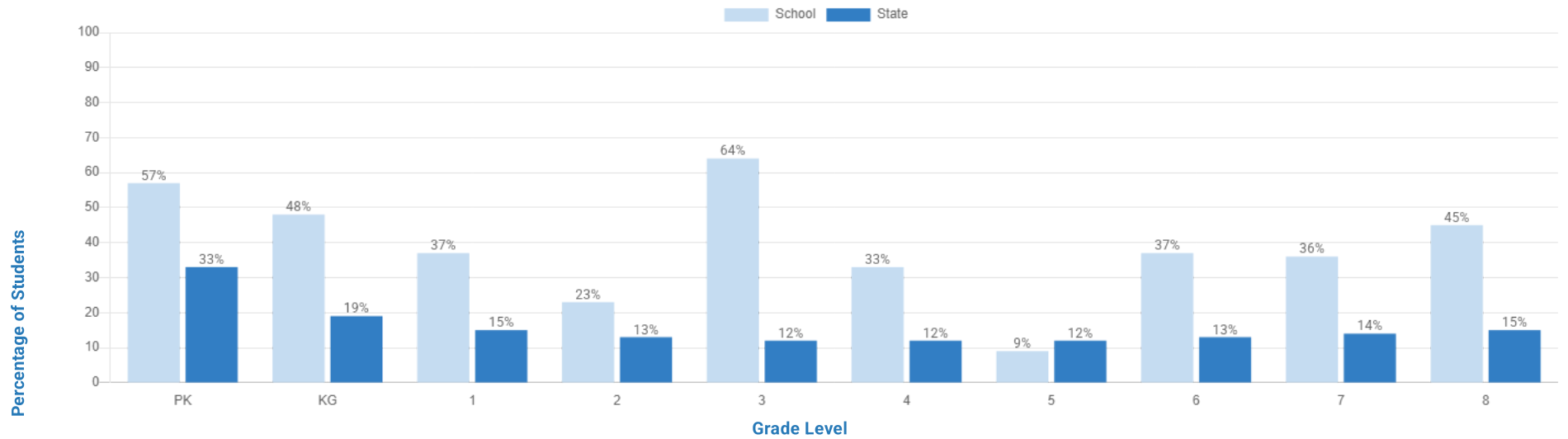

Staff

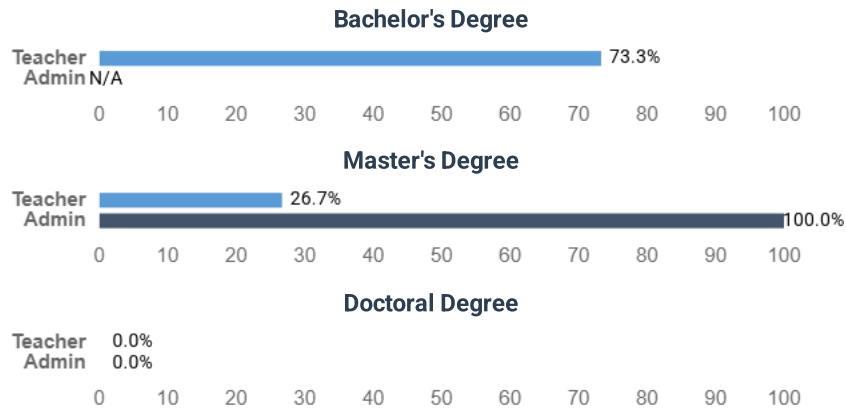

- The Woodbine Elementary School offers 1:1 devices in Pre-K through eighth grades. Pre-K students have access to tablets, while K-8 students use chromebooks.
- WES offers weekly SEL periods where students PK-8 engage in activities to enhance their social & emotional competencies and are supported & facilitated by the guidance counselors & teachers.

The Woodbine Elementary School recognizes that each child is a unique individual; possessing talents, abilities, goals and dreams. We further recognize that each child can only be successful when we acknowledge all aspects of that child's life; addressing their needs, enhancing their intellect, developing character and integrity and uplifting their spirit.



Awards, Recognition, Accomplishments:

The Woodbine Elementary School received a silver recognition as part of the Safe Routes to School program recognition by Cross County Connections for the 2023-2024 school year. We continue to promote this initiative as a walking district through monthly walking school buses within the community.

Courses, Curriculum, Instruction:

All curricula in the Woodbine School District are strategically aligned with the NJSLs. PreK and K use the Tools of the Mind program. For ELA, grades 1-2 use HMH Into Reading, while grades 3-8 use Open Up Resources EL Education. Wilson Reading programs are used for special education, intervention, and foundational skill needs: Foundations in grades K-3 and Just Words in grades 4-8. Grades K-8 use iReady Reading and Math for individualized instruction based on diagnostic assessment results. Daily intervention/enrichment periods are scheduled for grades 1-8 addressing individual student needs identified through monthly PLCs and data analysis of NJSLA, diagnostic, benchmark, formative/summative assessment data. SEL lessons are offered weekly to students through the Second Step program.



Clubs and Activities:

The Woodbine Elementary School participates in a district wide community clean up twice a year through Clean Communities. Woodbine Elementary School offers the following clubs and activities for student involvement: Student Council, Intramural Sports, Yearbook, Midfulness Club, Think Team, Band & Chorus.



Before and After School Programs:

The Woodbine Elementary School offers after school tutoring for grades K-8. This program is run by teachers. In addition, we offer a four week summer school program funded through Title I, which is run by a summer school coordinator and staffed by teachers. Latchkey services are provided before and after school as well.

The Woodbine Elementary School has an I & RS team, PIRT team, full-time guidance counselor, social worker and CPIS to provide social emotional supports to students. We also have a K-2 and 3-5 Basic Skills teacher for Math/ELA supports, as well as a full-time ESL teacher to provide assistance to students. We will continue to utilize PBSIS as an additional support to our students. All students have a daily scheduled intervention period to address academic deficits and a weekly SEL period for social-emotional lessons.



Student Health and Wellness:

The Woodbine Elementary School students receive free universal breakfast and lunch through the CEP, provided by NutriServe. All students K-8th have Physical Education twice a week as well as a designated daily 20 minute recess. Many teachers also utilize gonoodle and other strategies for brain breaks and to allow structured movements during transitions. In addition, the Woodbine Elementary School facilitates regular activities that earn point for the Altantcare health and wellness grant. Our wellness committee plans regular activities to promote the health and wellness of our students & community

The Woodbine Elementary School has an Early Childhood Advisory Council and School leadership Council to help inform the community about the school. We also encourage all parents to use OnCourse Connect which is the parent portal connected to our student information system. Parents are invited and encouraged to participate on district committees and the PTO. District committees include the Resiliency Committee, Title I, School Leadership Team, C-Sure Committee for Climate and Culture, Health & Wellness, and ECAC.



Climate Surveys:

The survey is conducted during the fall of each school year for parents, students and staff. Facilities:

The original part of the building was built in 1965, with additions in 1971 and 2006. The building features a cafeteria, art room, and music room, in addition to classrooms. Through a partnership with the Borough of Woodbine, a county library branch is located adjacent to the school as well as our gymnasium, nurse suite, and school library. We recently replaced and updated our Preschool and Elementary playgrounds and an upgrade to the HVAC system is currently underway.

School Safety:

The Woodbine Elementary School keeps all entrances and exits locked throughout the day. Staff utilize a fob system for entry into the building. Visitors must enter through the main office entrance and sign in. All Pre-K students must be signed in and out daily by an adult at arrival and dismissal. The pre-k area is secured with a gate during that time to separate from the rest of the school. Our safety and emergency response committee reviews our safety plan and procedures monthly to identify areas of focus for increased security based on the two monthly safety drills. Our School Resource Officer provided by the NJSP comes regularly to do walkthroughs and safety checks. Additional NJSP troopers are visible during arrival, dismissal and various points throughout the day.



Technology and STEM:

All classrooms utilize Mimio Boards, Ipads, Chromebooks, and document cameras. All students in grades PK-8 have 1:1 devices. Classroom teachers use these devices within content area curriculum.



Early Childhood Education:

The Woodbine Elementary School offers a full day Pre-K program for 3-4 year old children funded through the Early Childhood Expansion Grant. We have 4 multi-aged inclusion classrooms, each with a preschool teacher and instructional assistant. We currently have the capacity for 60 students, 15 students per classroom.

Woodbine Elementary School is a walking school district. We have a 6.5 hour school day that begins at 8:15am and ends at 2:20pm. On early dismissal days, students leave school at 12:55pm. We have a traditional 9 period day, each period lasting 40 minutes. Students in grades 1-8 are given 80 minute ELA and Math blocks each day. Woodbine Elementary is a choice school with two approved seats for the district. Our high school students attend Middle Township, Cape May County Vocational High School or private/parochial school.
