









Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Staff and Professional Learning:

Professional Development is built into the school year with two full days and eight half days. Staff members are offered outside PD through intense multi-day training and conferences, including Project Lead the Way Core Training and AP Intensive Workshops. Some of the half days staff are given time to work in their PLCs to discuss data and share best practices. Partnering with our constituent districts, teachers from Pre-K through 12 receive content and grade level appropriate pedagogical professional development on the two full days. Additionally, first year teachers and teachers new to CRHS are afforded the opportunity to engage in New Teacher Induction sessions held in the summer and monthly throughout the year.

Counselors offer parent evening programs to explain information on career and college planning, and financial aid. Counselors work with students individually and in small groups during high school to provide career exploration, college planning and guidance on the college application process. Parents and students utilize Naviance to assist with career and scholarship research, resume building, and the college application process. Dozens of university reps visit CRHS each Fall to meet with students. CRHS also hosts a career fair to allow students an opportunity to speak to professionals in a variety of occupations. Students are given the opportunity to take the ASVAB and students are given the PSAT for free and they are encouraged to take the SAT & ACT prior to senior year.



Student Supports and Services:

The Cumberland Regional High School Child Study Team is comprised of special education teachers, paraprofessionals, related services providers, counselors, a learning consultant, a school social worker and a school psychologist. The mission of the department is to meet the learning needs of students identified as having a disability that impacts their ability to learn. A variety of individual programs are designed for student success, and we work closely with students, staff and familiesto provide maximum support.

Parent and Community Involvement:

CRHS serves 7 towns as well as "choice students" from several local districts. CRHS strives to facilitate ongoing communication with all stakeholders. Meetings and events are held to encourage engagement and discussion from the community. Our Colt Community Advisory Team (C.C.A.T.) brings representation from the parents, teachers, administration, and the local community together with the superintendent to discuss local concerns, school highlights, timely issues, and upcoming events. Administrators visit constituent schools to interact with families and other stakeholders to share information about CRHS. Our website, social media and notification system are other resources utilized to communicate. The superintendent meets monthly with superintendents from our constituent districts to coordinate curriculum, calendars, and activities to strengthen the PreK-12 continuum.



Climate Surveys:

Is a Climate Survey Used: Yes; Who is surveyed: Students, Parents, Administrators, Teachers. Students, staff, and parents were each given their own climate and culture survey. CRHS uses the State recommended surveys. Once data is collected it is shared with the School Climate and Safety team, as well as administration and staff. Using this data CRHS looks to make changes in the areas of concern. This year CRHS incorporated a mental health survey to address the mental well-being of our students following the pandemic. Additionally, we repurposed one of our classrooms as a Zen Den staff with counselors and a support team to provide a space for students to refocus and connect with the Mental Health supports offered at CRHS.



CRHS has renovated four science classrooms over the summer with new cabinetry and flooring. In addition, we have removed outdated carpet from our Performing Arts Center (PAC) foyer and replaced it with new flooring. We also updated our Dramatic Arts program with new flooring and new lighting to enhance our students' experiences. CRHS has expanded its Adventure Education program by adding indoor ropes course elements. Construction has ended and our new State of the art Student Wellness & Instructional Center is operational which includes eSports lab, broadcast studio and student lounge. The district has also upgraded its internal radio infrastructure for more secure and effective communications.

CRHS offers a safe and secure environment for staff and students. All visitors entering the school must have official government identification. Visitors must state the reason for their visit before being granted access to the vestibule. A visitor then may leave an item they are just dropping off or show their ID to be buzzed into the school. CRHS has three-armed security personnel who are all former law enforcement contracted through a third party. There are roughly 80 cameras throughout the school and school grounds which can be accessed in and out of the building. Radios are used to communicate with administration, offices, and security. EMS has a radio if needed for an emergency. Canine units are utilized for campus sweeps and crowd control during major extracurricular events.



Student technology is utilized in every classroom at CRHS as an integrated set of tools to support the learning process. We are a 1:1 district, providing a Chromebook for every student. Desktop computers are used in selected lab classes and all devices connect to high-speed Internet via wireless access points throughout the school. There are also Promethean boards in every class being utilized by students and staff. STEM classes for both Engineering and Electronics include a variety of software programs, and our state-of-the-art STEM Lab is set up for 3D scanning and printing, and laser engraving/cutting. Internet-based programs and resources integrating technology are part of the curriculum for many core and elective courses.
