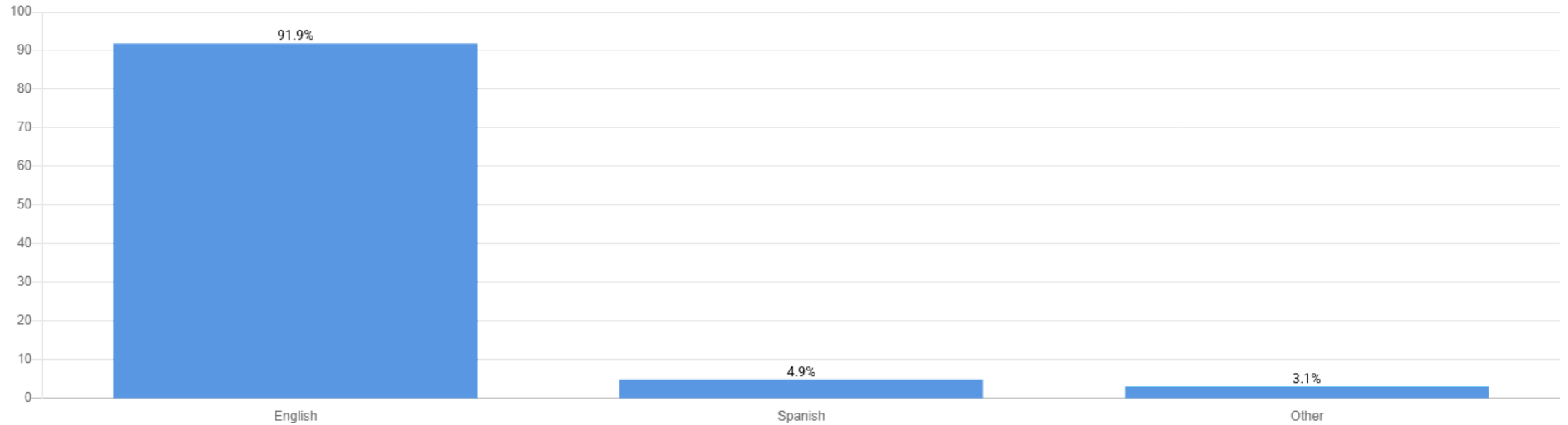

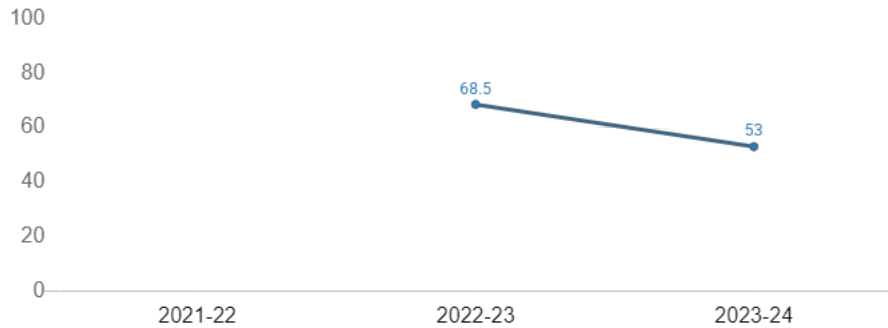

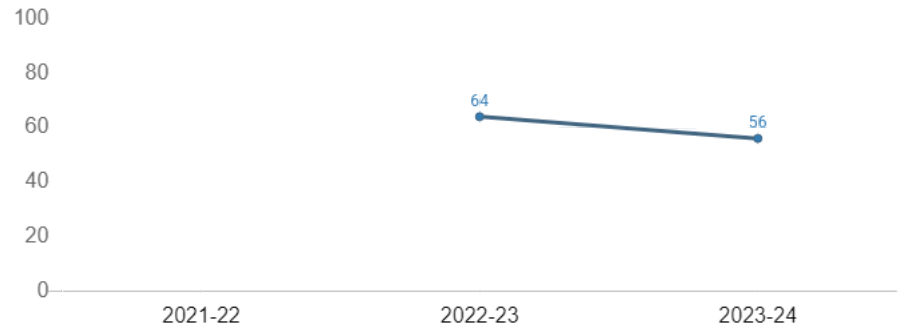

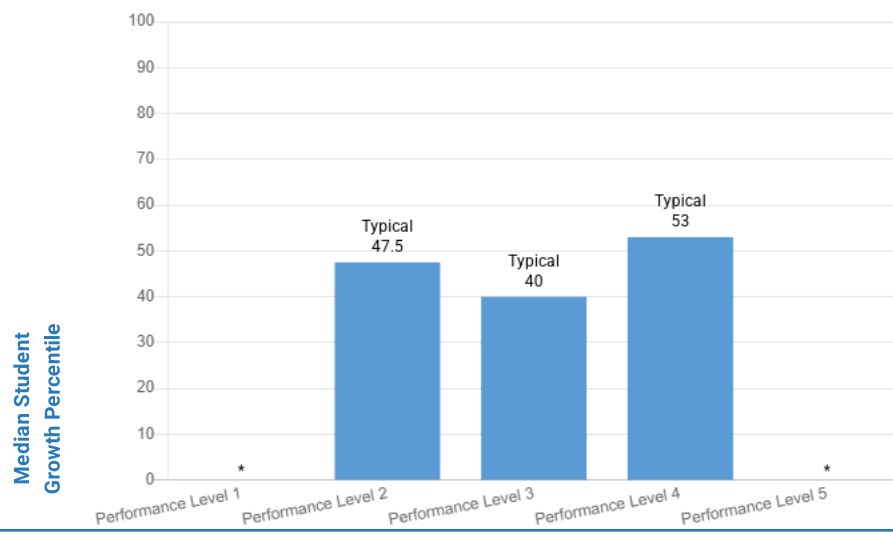

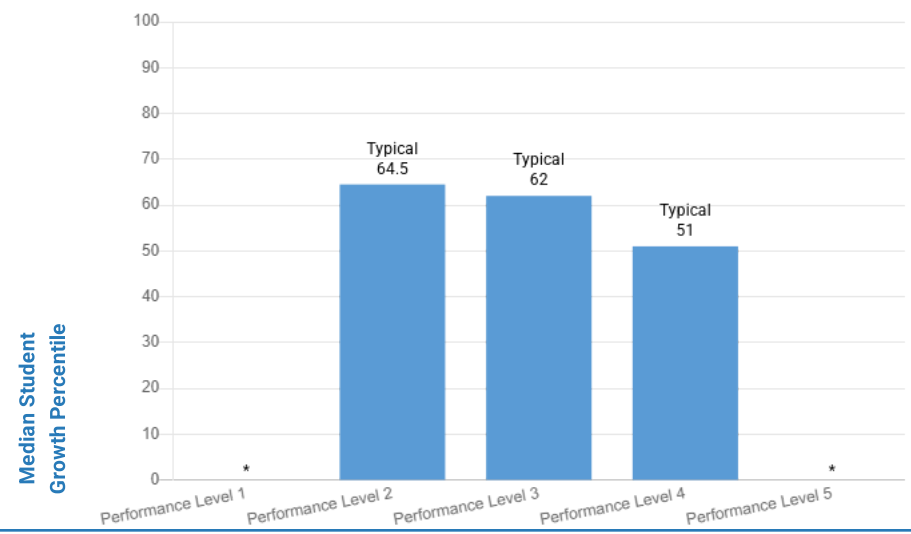

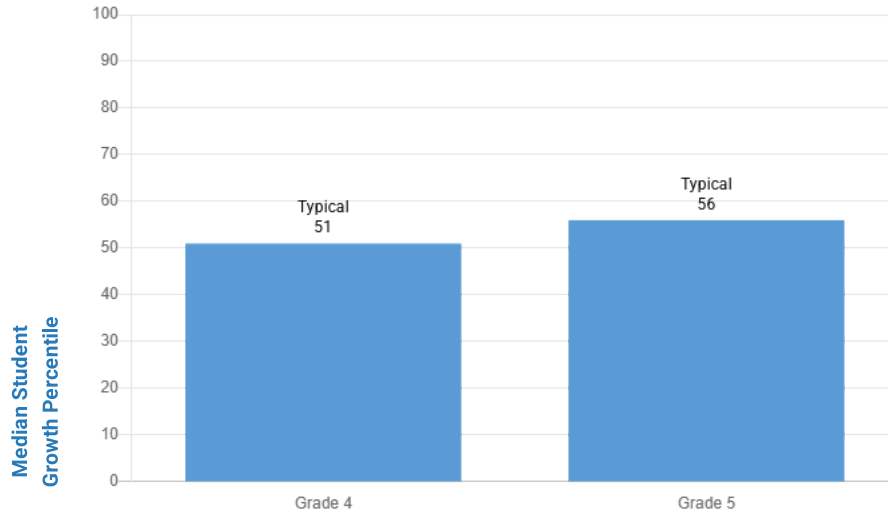

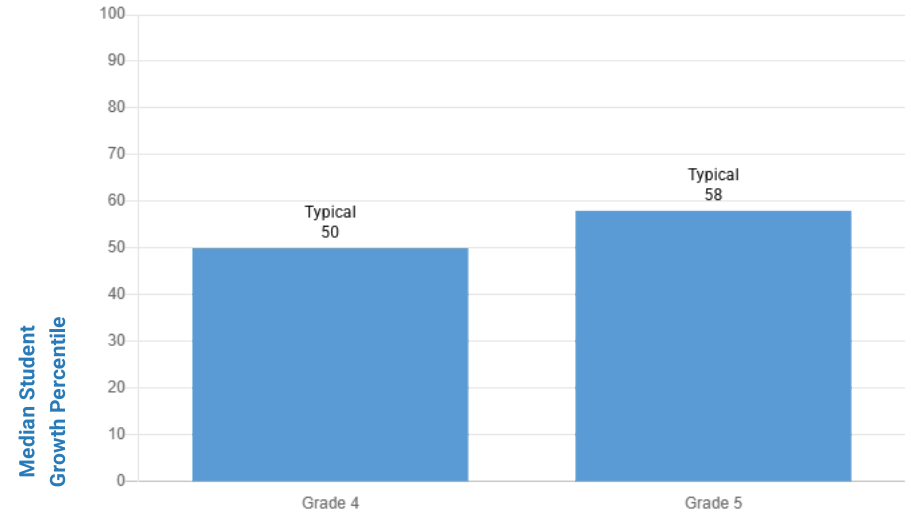

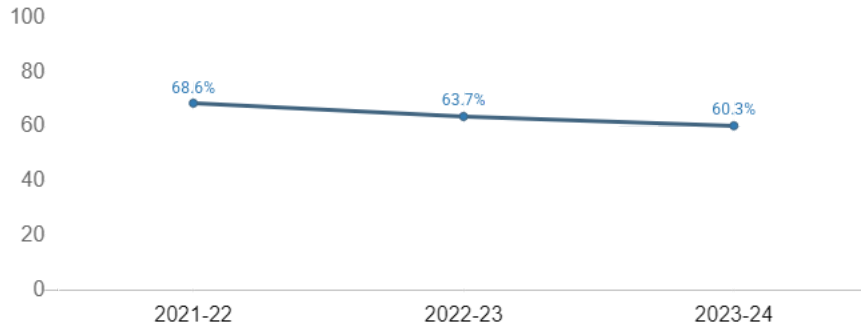

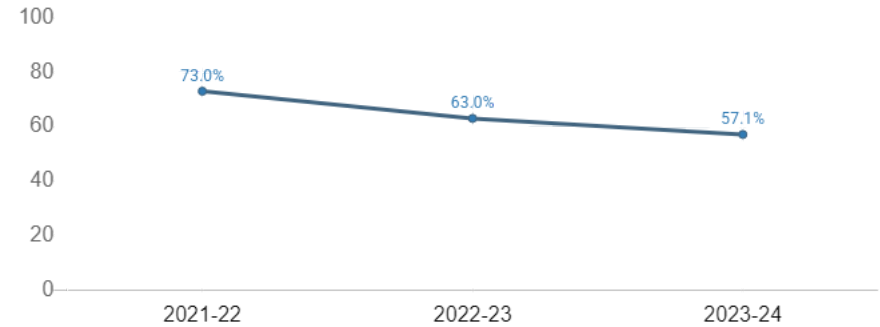
English Language Arts and Mathematics Performance Trends

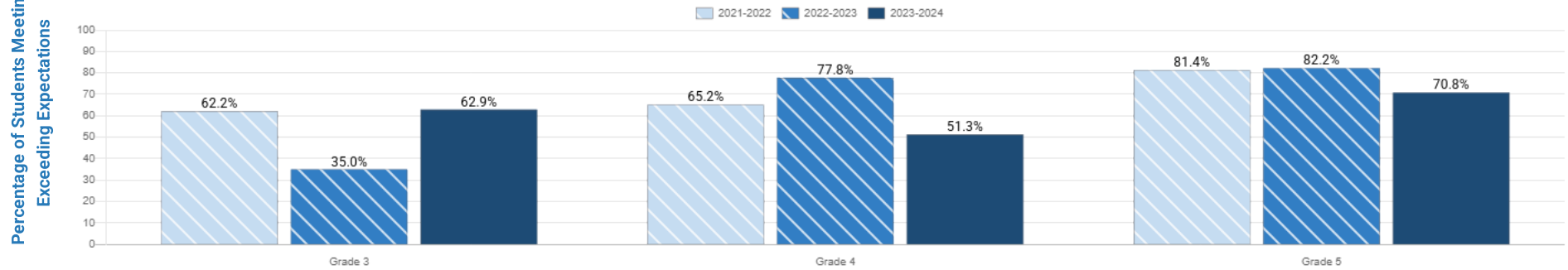

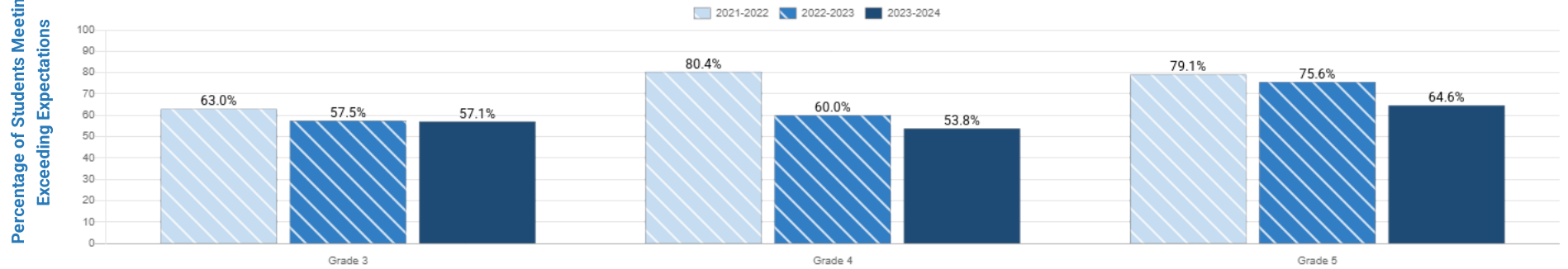

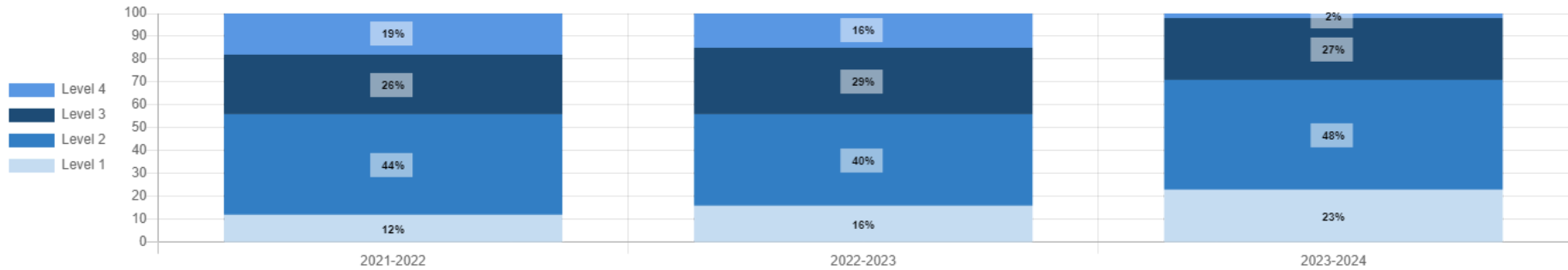

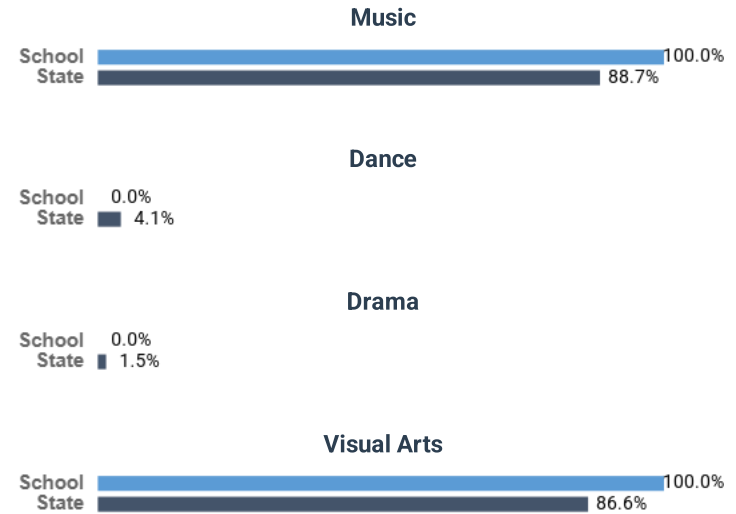

Students enrolled in one or more classes by discipline:



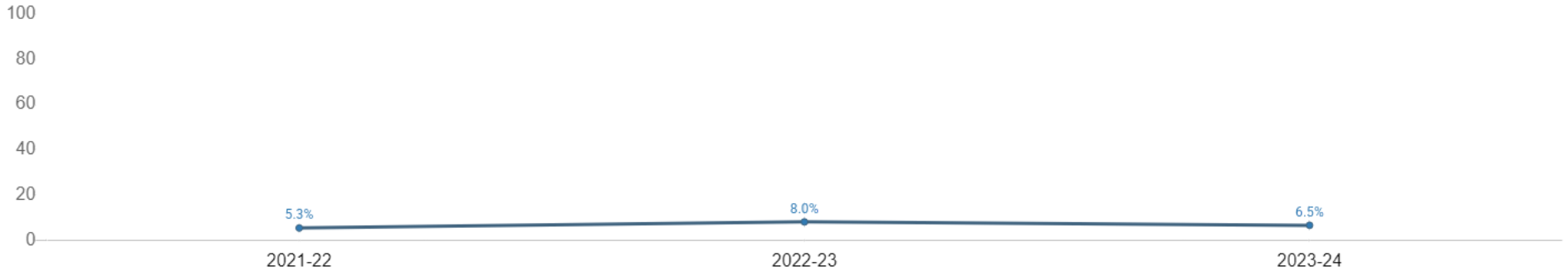

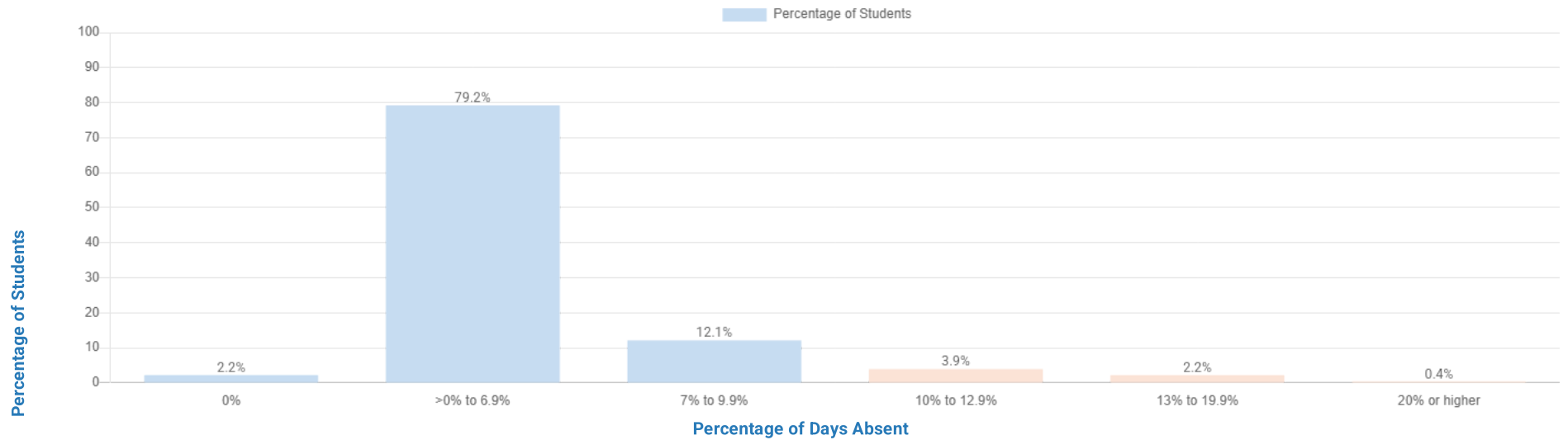

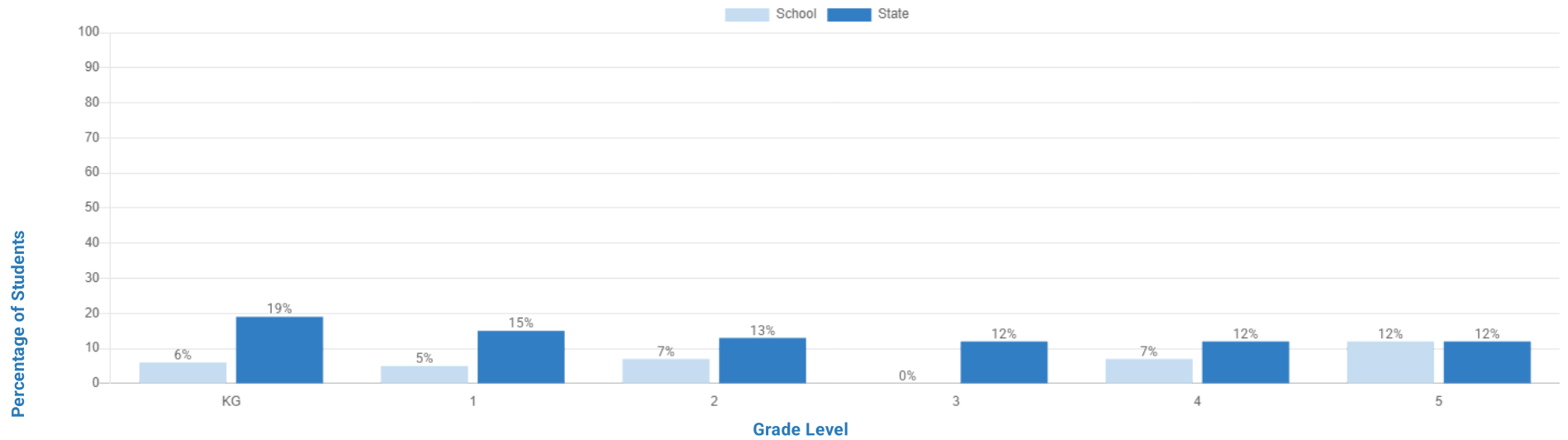

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

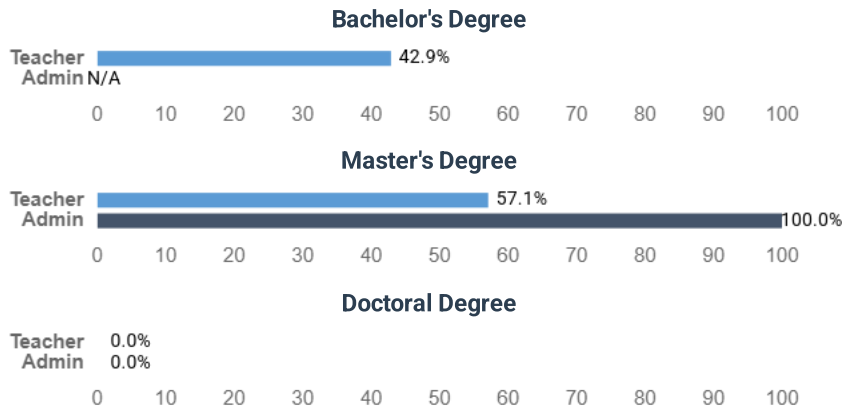

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. - Students in grades 3-5 all have their own device that they bring to and from school daily. Each classroom at Wilson School also has a Promethean Board that teachers use daily.
- All teachers at Wilson School are engaging and applying professional development around creating an inclusive classroom environment.



Mission, Vision, Theme:

At Wilson School, the staff ascribes to the philosophy of implementing developmentally -appropriate practices, while challenging each child to reach his or her potential. Our mission is a simple one: to provide a learning environment, during the formative educational levels, which is filled with rich experiences that enhance the social, emotional, intellectual and physical development of the whole child.



Courses, Curriculum, Instruction:

Teachers push students to engage in hands -on activities and cooperative projects that address the learning objectives. The Language Arts program emphasizes a balanced literacy approach. The use of manipulatives is leveraged in Math to provide students with a tangible and tactile approach, through which our students learn strategies to address complex problems.

Wilson also strives to leverage in-house expertise; we have a full-time academic interventionist in addition to ELA & STEM coaches who consult with all of our teachers on a regular basis. On a monthly basis, teachers meet with their colleagues in "Teacher Learning Teams" (TLT's) and engage in homegrown professional development based on topics that relate directly to their practice.



Student Supports and Services:

Wilson School has a full-time counselor in the building to provide individual and group counseling to students. Our counselor also conducts social-emotional learning (SEL) based lessons across all grade levels on a monthly basis. Finally, our counselor serves as the head of our School Climate Committee.

Special subject teachers present Art, Music, Physical Education, Library skills and Spanish language instruction. Professionals trained in the fields of special education and gifted and talented instruction address the diverse needs of our student body. Computer technology is a powerful tool that allows our students to learn technological skills through project-based activities that are integrated across the curriculum. The Orchestra, Band and Chorus perform concerts throughout the year that are well attended by the community at large. Field trips, guest speakers, community service-based projects, and cultural arts assemblies further enrich learning experiences for the children at Wilson School.
