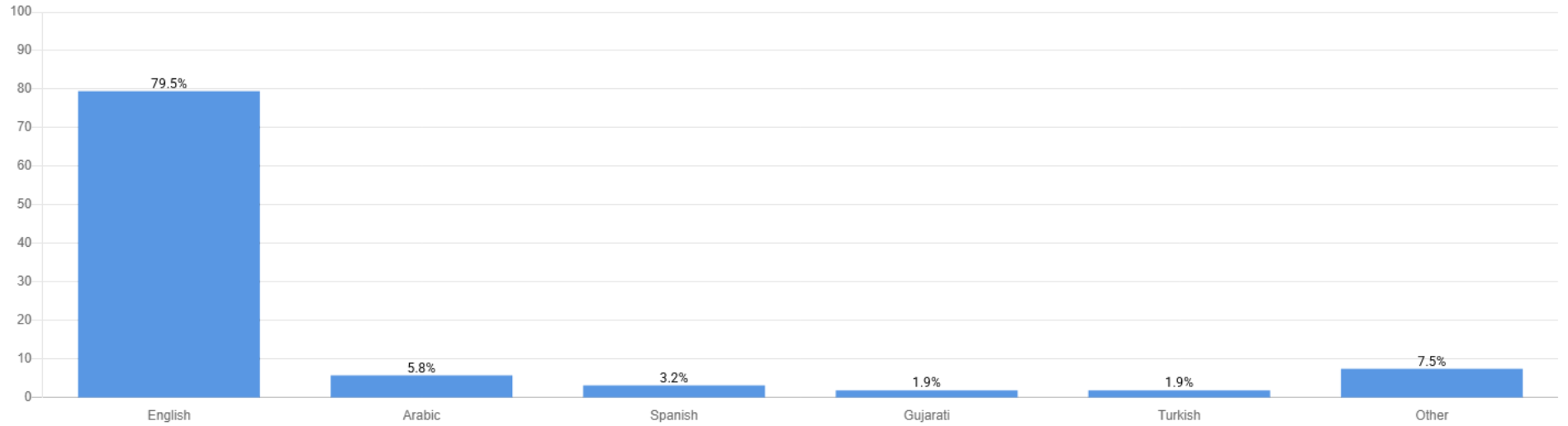

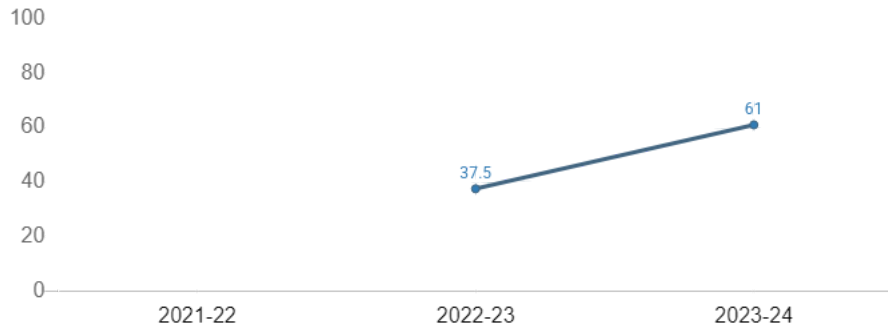

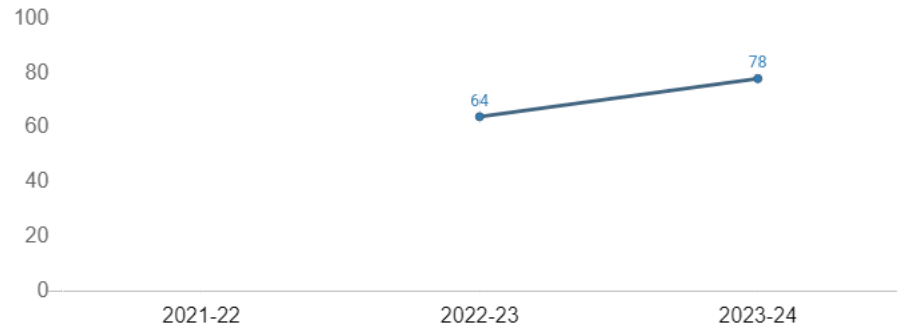

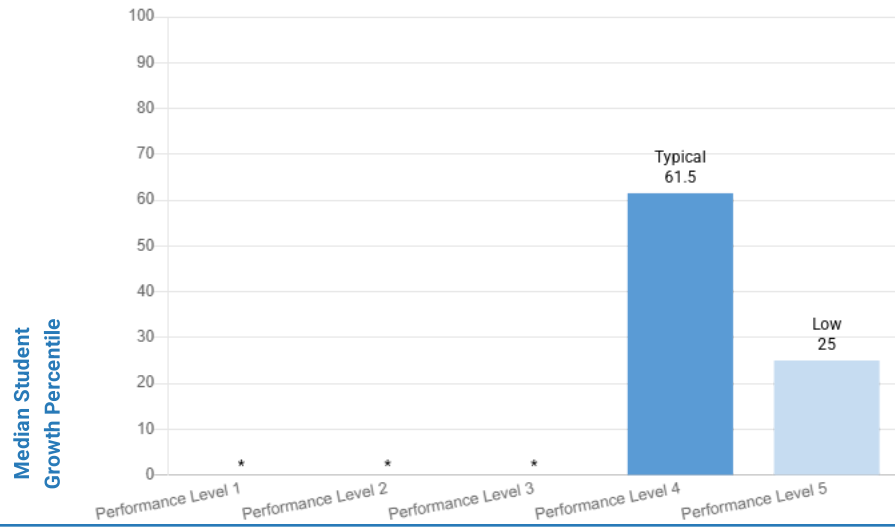

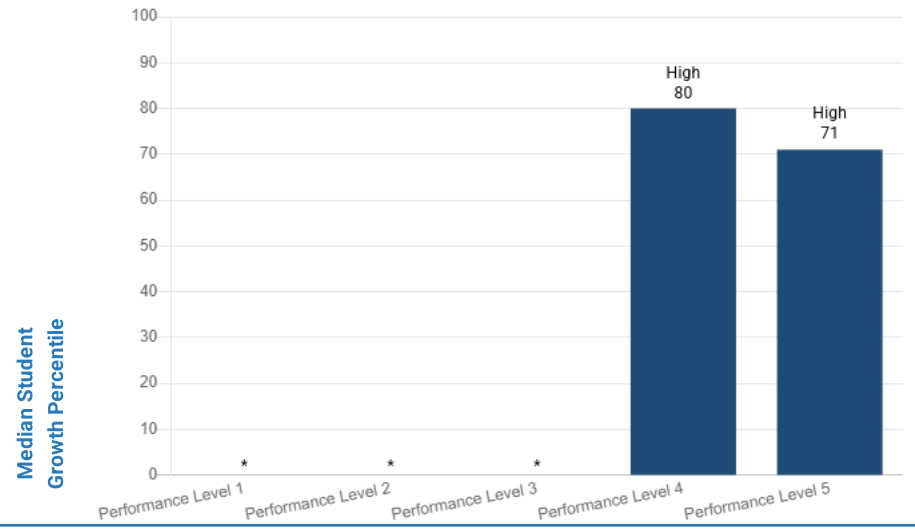

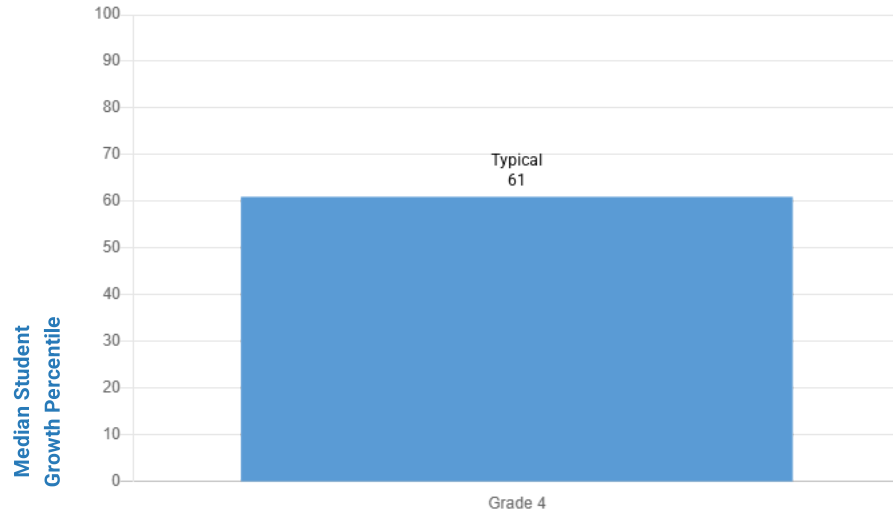

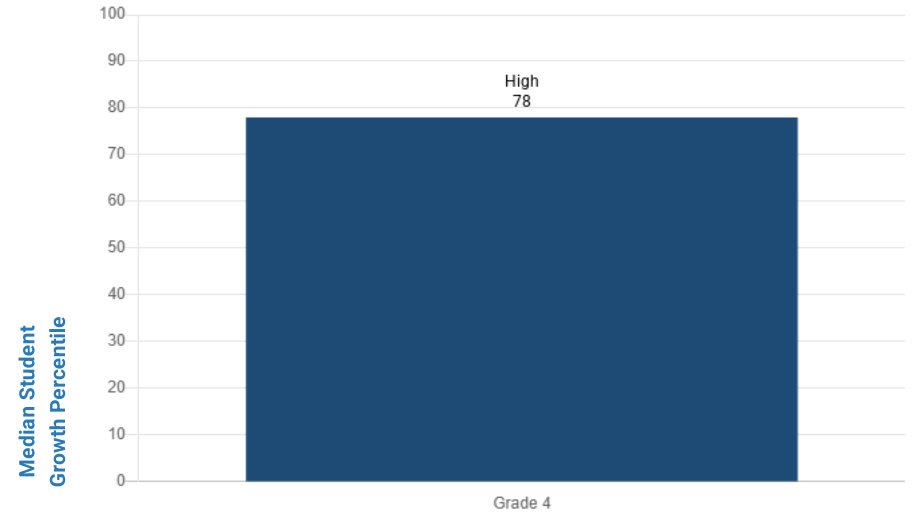

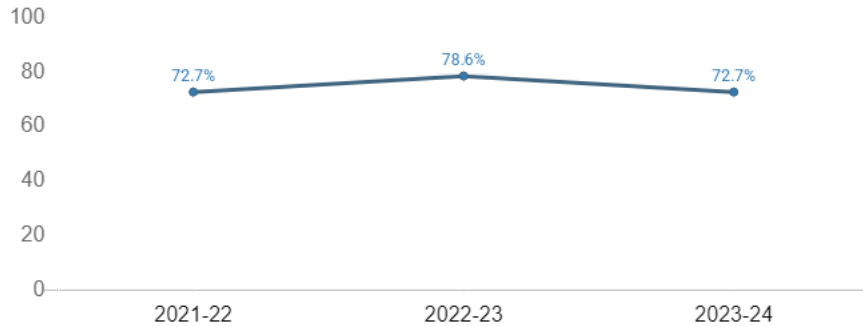

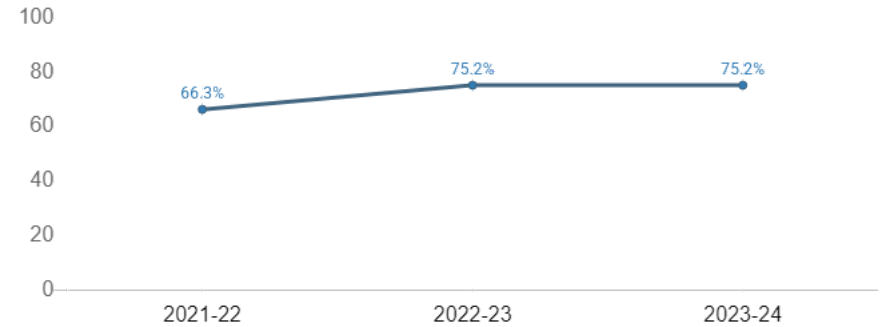
English Language Arts and Mathematics Performance Trends

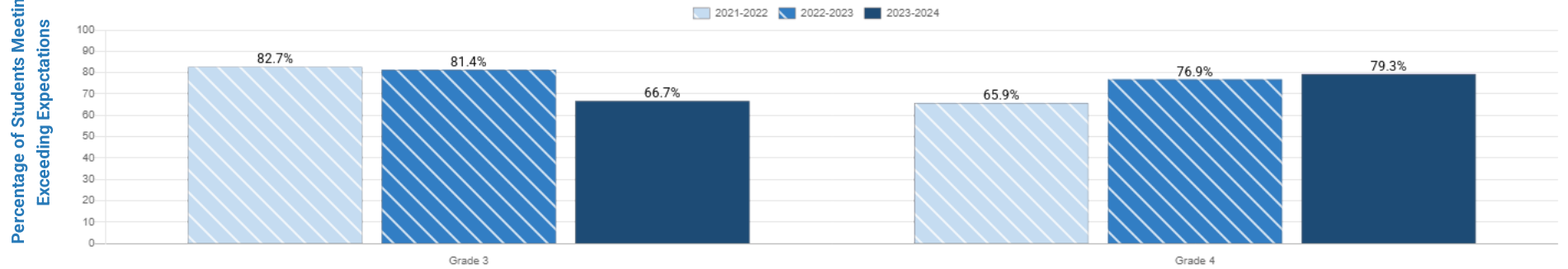

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

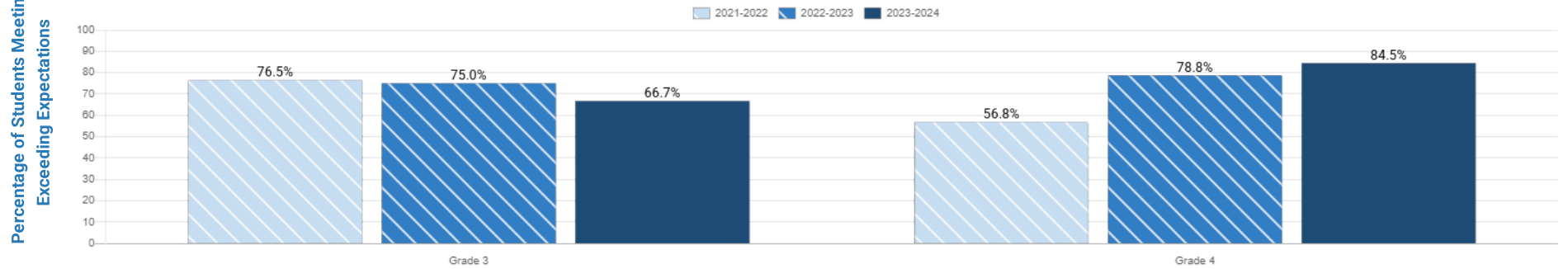

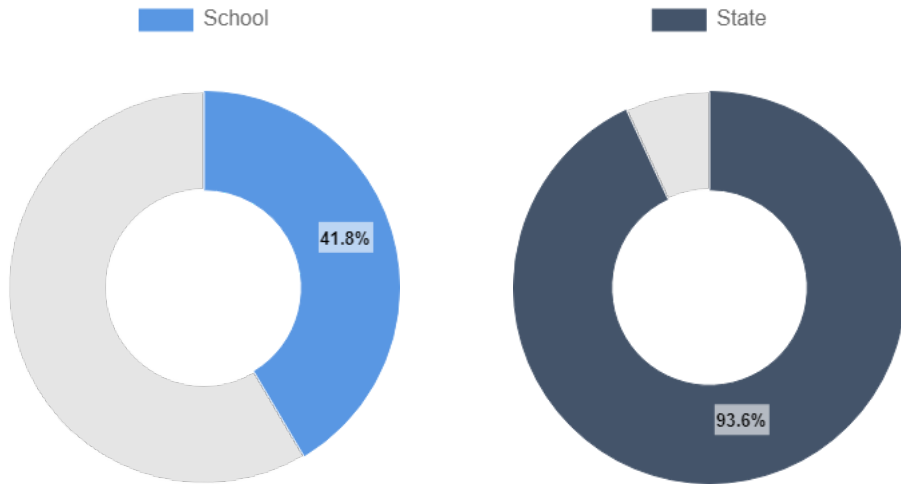

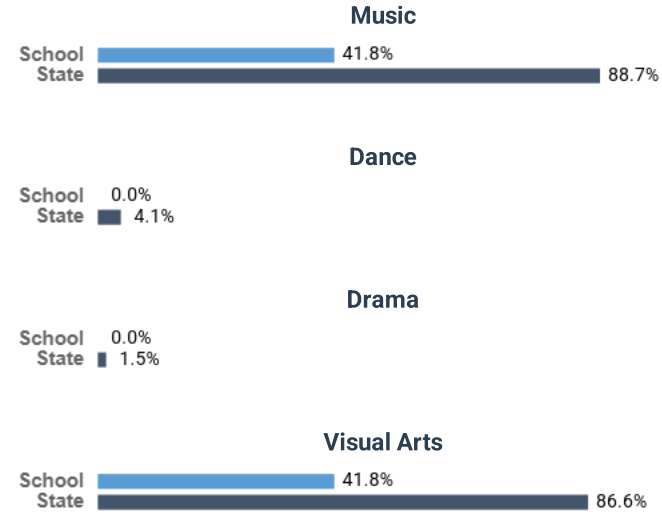

Students enrolled in one or more classes by discipline:



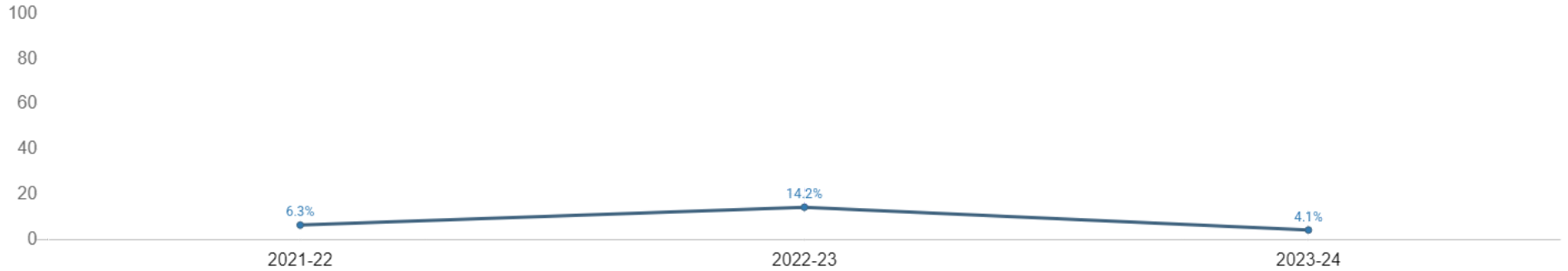

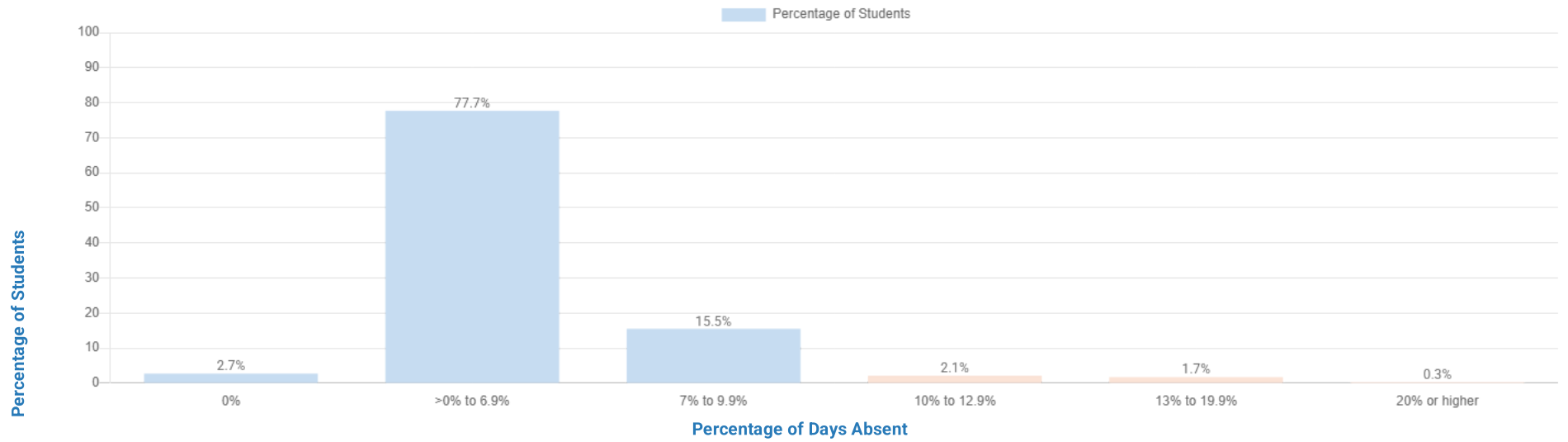

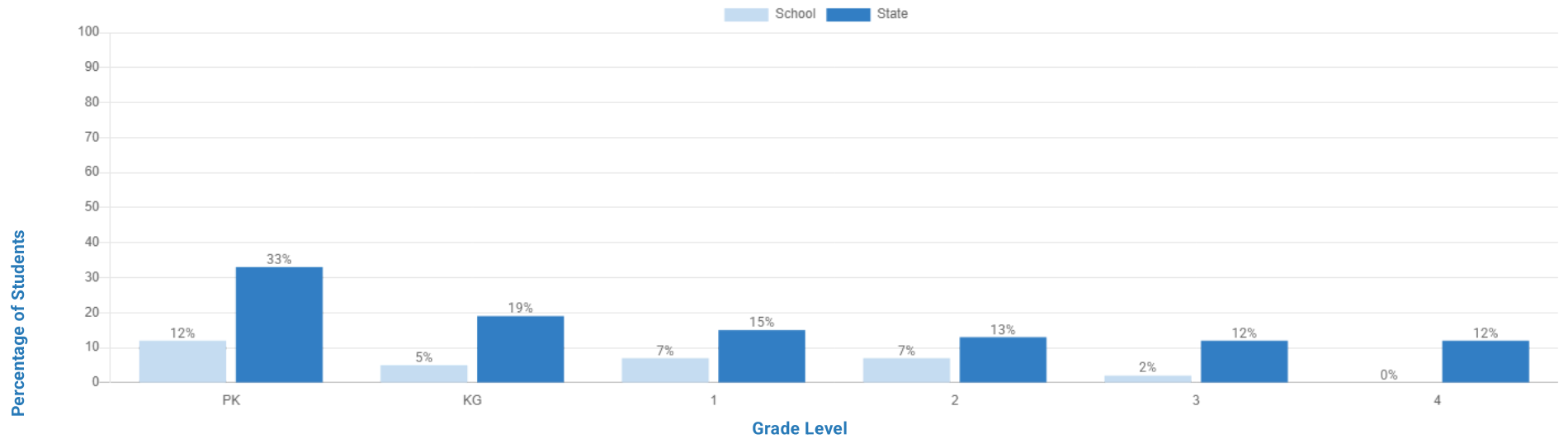

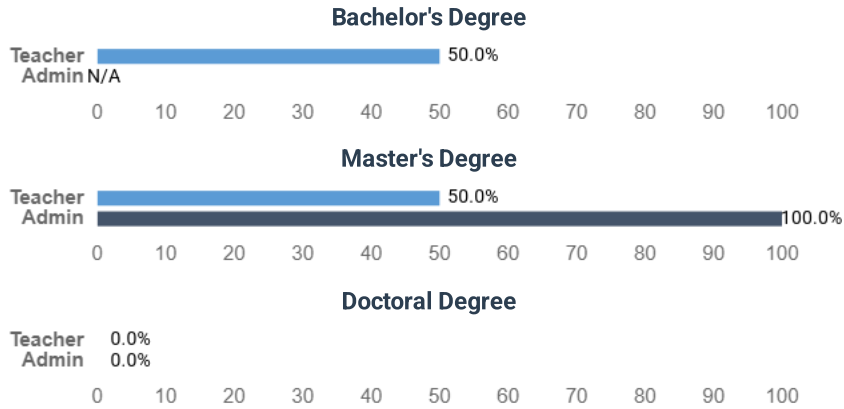

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

We accomplish the goal of educating the entire child through the Daily5/CAFE literacy structure. Our teachers have worked with literacy consultants to enhance their skills in the teaching of writing. We use Heggerty and Foundations for phonological awareness and phonics instruction. Leveled instructional materials and differentiated instruction provide the backdrop for activities that reinforce key skills and concepts related to NJSLs. During Math instruction, teachers encourage the use of manipulatives and students experience a lesson in all three developmental stages (manipulatives, drawings, computation).



Before and After School Programs:

A morning care program is offered for our children (PK - Grade 4) prior to school opening until 8:15. Morning care and aftercare is offered through Alphabest from dismissal through 6:00 PM.



Staff and Professional Learning:

The North End staff has high expectations for their students and themselves. To meet these expectations, staff members actively participate in graduate classes and workshops in and out of district. Teachers have been using a professional learning community model to develop an understanding of collaborative learning and to analyze data to drive instruction. Additionally, our teachers have worked with a consulting firm, The Living Literacy Network, to enhance their teaching skills in the area of literacy instruction. Teachers have also been trained in the use of Heggerty and Foundations.

Student Supports and Services:

North End fosters a collaborative, co-teaching model where a general education and special education teacher work together to teach students with and without disabilities in a shared classroom. Replacement classrooms provide additional academic support in reading in math for classified students. In addition to an integrated PK program, we have an ABA, self-contained program for students with special needs. Reading and Math Intervention is offered for K-4 students, along with an after school Pathways program to assist students in need of additional support in ELA and Math. Intervention and Referral Services addresses students who are experiencing learning and/or behavioral difficulties. Our ELL program supports second language students as they acquire a new language.



Student Health and Wellness:

Students partake in physical education classes designed to teach skills, strategies, cooperation, and team building. All students have recess each day. Our school nurse addresses a number of programs in classrooms to promote a healthy lifestyle and the wellness of students, such as hygiene, the benefits of exercise, dental care, nutrition, and germ prevention.



Parent and Community Involvement:

The parent portal in Genesis, our student data management system, provides parents with important information including report cards and attendance. School Messenger is used to communicate important events and to keep parents informed. The Family School Association (FSA) is an integral part of the North End community. They provide materials, technology equipment, programs, and cultural experiences that enhance the instructional program. Parents serve as key communicators, disseminating information through the FSAs Facebook page. Additionally, NES is an active partner with multiple local organizations in an effort to teach our children to give back to others. Students collect for several charitable organizations.

Technology and STEM:

At North End we believe that technology enhances our curriculum and is used to improve upon teaching and learning. In addition to one-to-one Chrome Book use in grades K-4, each classroom has a Smartboard and document camera. We use a variety of online assessments and district benchmark assessments to aid our teachers in differentiating instruction providing a more individualized learning. These include DRA (Developmental Reading Assessment), LinkIT!, STAR, DIBELS, and Lexia. Students use Raz Kids Plus and Moby Max to target ELA and Math skills. Our teachers are proficient in the use of Google Apps for Educators (Google Classroom, Sites, Documents, Forms, Slides) along with a number of apps allowing students to provide live feedback.



Early Childhood Education:

We are proud of our Integrated Preschool Program based on The Creative Curriculum for children 3-4 years old. Additionally, our youngest students take part in music therapy, social skills, group speech, OT/PT, and art class.
