







Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

The district is committed to providing students with an excellent educational experience while being mindful of their overall health. Curriculum ensures the safety and well-being of all students by building their skills in managing decision making, thinking and acting responsibly, and considering choices for their lives. Topics include but are not limited to wellness, substance abuse, social emotional learning, becoming an upstander, and managing life stressors. Efforts are made to embed health and wellness across the curriculum including the importance of mindfulness practices. Healthy choices are taught as an important life skill within the School Counseling Health and PE curriculum. Starting in the 2022-2023 and continuing through 2023-2024 school year, the teen Mental Health First Aid (tMHFA) was implemented for 10th grade students providing them with strategies and resources to support overall mental health and wellness.



Parent and Community Involvement:

The district values the involvement of all stakeholders and works to partner with parents and the community to provide students with an excellent education. College/career forums and parent workshops are regularly offered. Schools work with groups on leadership programs and social/emotional and equity topics. Community outreach and support for families with ESL needs is part of our full system of support. Our district enjoys collaborative relationships with community partners such as our Parent-Teacher Council, SEPAC, and Equity Teams at the disrict level and building levels. In addition, we host monthly school equity meetings, and provide educational opportuities for parents through evening presentations, moderated by our Student Assistance Counselors.



Is a Climate Survey Used: No; LPS has developed district and BOE goals in the area of equity and inclusion since the 2019-2020 school year. To assist the district in better understanding the areas in which to focus this work, we conducted equity climate surveys with our community in the spring of 2021 and 2022. This survey was shared with our parents via an online system for gathering feedback on questions specific to their child(ren)'s experience in our schools. Students were invited to participate in focus groups on multiple topics that are relevant to them. During the 2021-2022 school year, the LPS engaged in a full year strategic planning process during which all members of our community were provided with a climate survey. All results were gathered by the district, analyzed by relevant stakeholders, and utilized in planning for future areas of focus in our schools. Survey data has proven useful in designing district goals, budget priorities, staff development of our staff, and curricular initiatives.

Built in 1955, Livingston High School underwent major reconstruction in 1966 and 2008. The most recent project included a modern science wing, equipped with instructional and laboratory settings in each classroom, and a state-of-the-art Fitness and Wellness Center with a gymnasium, conditioning room, and flexible space for education, yoga, and team practices. In 2017, the media center was renovated to allow for greater integration of technology, collaborative spaces, and student performance.

LHS is comprised of over 2100 students. The building utilizes a Rotating Drop Schedule in which classes run 56 minutes. Students experience more than 200 additional minutes of classroom interaction per section per year compared to a traditional schedule. Benefits of this schedule include a daily unit lunch for all students, more common time for teachers and students to meet informally, rotating class slots and a decrease in the number of student pull-outs for science labs, counseling and nurse visits. LHS Lancers of the Month is a program designed to celebrate the students and staff within the building who exhibit exemplary behaviors. Each month is dedicated to a different character trait as it relates to the LPS Portrait of a Graduate. Staff and students nominate each other for demonstrating that trait. Students and parents are notified of their nominations and at the end of the month, winners are announced. Lancer Time allows time within the schedule for open office hours for students to access teachers during a flex period. Community is the advisory program that meets one a month to address issues of equity, as identitied by staff and students at LHS.
