





## Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Our curriculum is updated on a regular cycle, typically every 5 years in most subjects. Certainly new state mandates (ex: DEI or NJGSS) prompts earlier revisions. We offer a wide selection of AP courses but our focus tends to be the elective courses available for all students. Many of our courses are not textbook centered whether electronic or hard copies. Students expect to have 20 minutes of homework per night in each of the core academic disciplines; however, the amount of time actually spent varies greatly. Teachers are available a minimum of 2 days per week, usually during our 1 hour lunch period.

Facilities:

Our main building opened in Sept. 1956. A few of the restrooms have recently been gutted and redone. Some Science labs from that era have been revitalized as well – more scheduled for this summer. In recent years we opened up our state of the art MILL (Millburn Innovative Learning Lab) and a new library. Our video production room was given a modern face lift last summer. The auditorium is due for major renovations this summer although will require more in years to come dealing with audio/video capabilities. Since 2003 we have opened up two new wings with modern science lab space and envious art rooms.



We conduct the mandatory 2 drills per month as prescribed by the State. We employ two security guards. Everybody must enter and leave from our Main Lobby that utilizes a 'man trap'. The entire district utilizes See Something Say Something to encourage anonymous reporting although we try to foster a culture of direct communication: 3 D's: Do right; Discourage others; Distance yourself (if necessary). We do have certain student groups speak to our faculty annually including our Black Student Union and our Gender Sexuality Alliance. Our One Millburn Day last year (and schedule for April/May again) helped increase everyone's awareness for support. Our Freshman each year have an assembly on resources for support. This past month we provided a further assembly on safety by our police department to Freshman. Other grades have assemblies scattered throughout the year.

All our students are issued Chromebooks in Grade 9 to use for their 4 years of high school. Many of our courses require their use and student use is monitored. Certainly, students do much writing with their chromebooks, utilize various software and utilize the internet for research. Most classrooms use SmartBoards for uses ranging from notes to editing.



Students are required to be in class although they may not be disenrolled before they attain 12 absences in any one class for a semester (modified recently for our A/B schedule). Even then, students who have excessive absenteeism may appeal and be granted more days of permissible absence.

Millburn High School conducts school on an A/B schedule where 4 classes meet each day. Students typically take 8 classes so 4 of the classes meet on A days and the other 4 meet on B days. Seniors usually take one last class to concentrate on college applications in the first half of the year. Classes are 81 minutes long. Seniors typically are free to go out for lunch and may leave school if they have nothing scheduled for that period. Millburn does not accept tuition students so 99.9% of students are residents of the community. Only seniors may park on campus; however, each senior is only guaranteed one semester of parking with a carpool partner.
