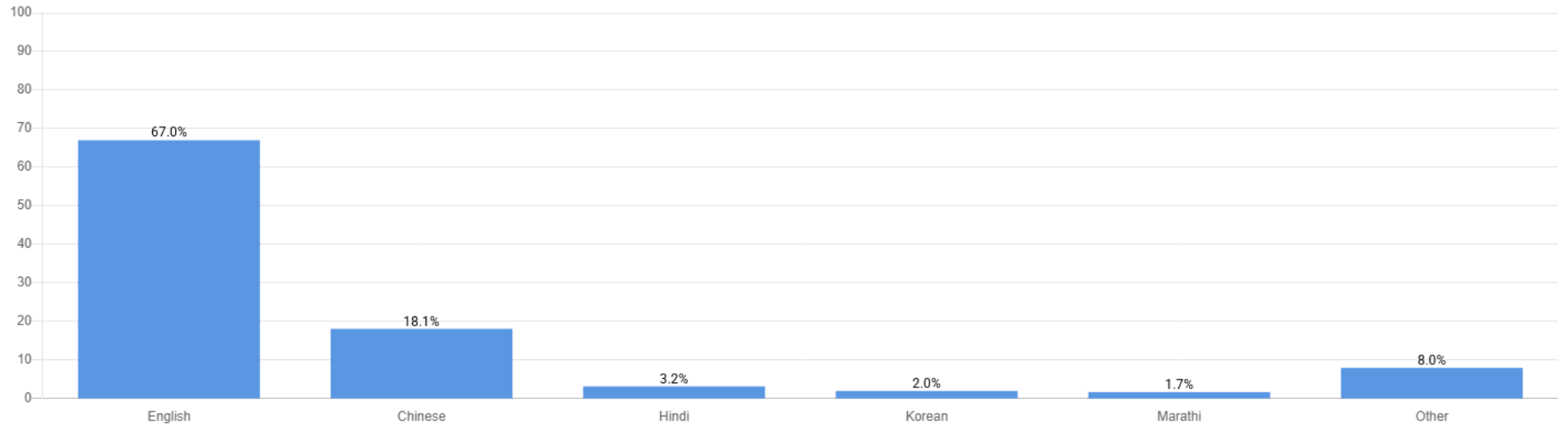

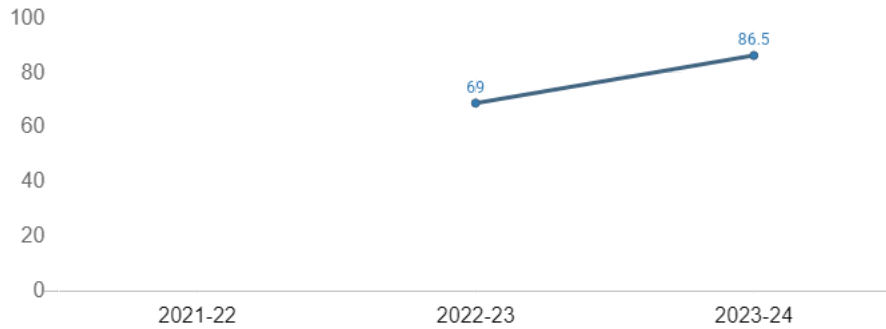

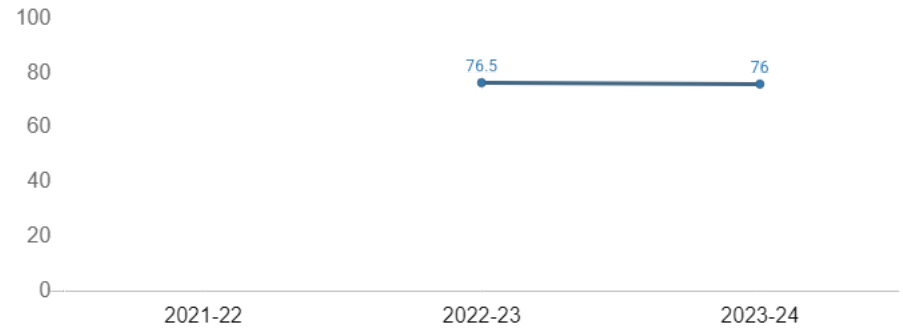

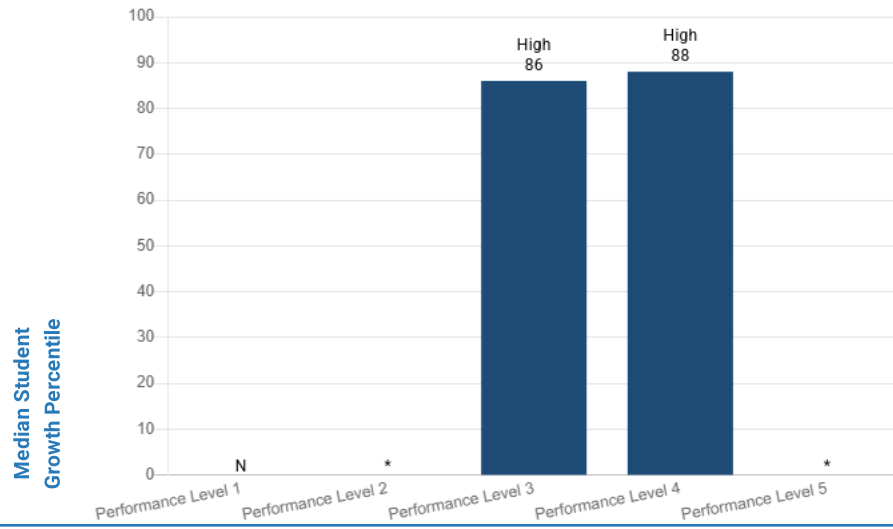

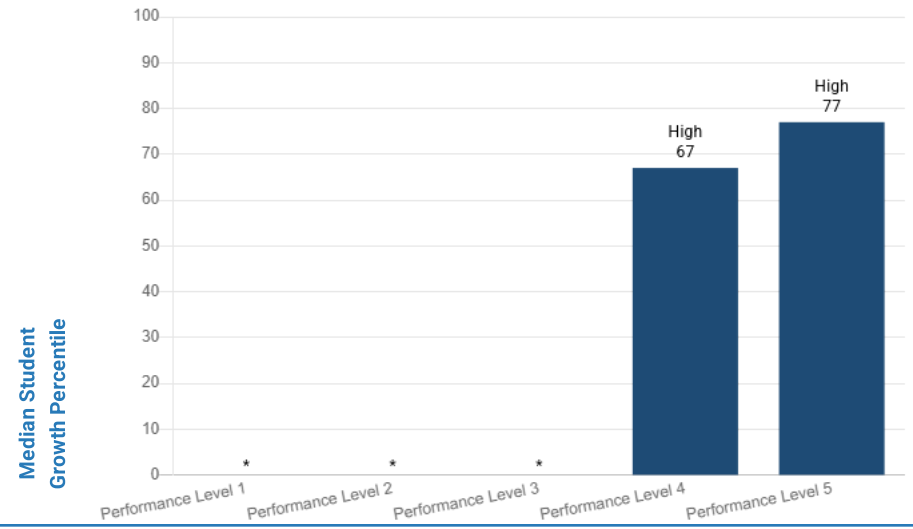

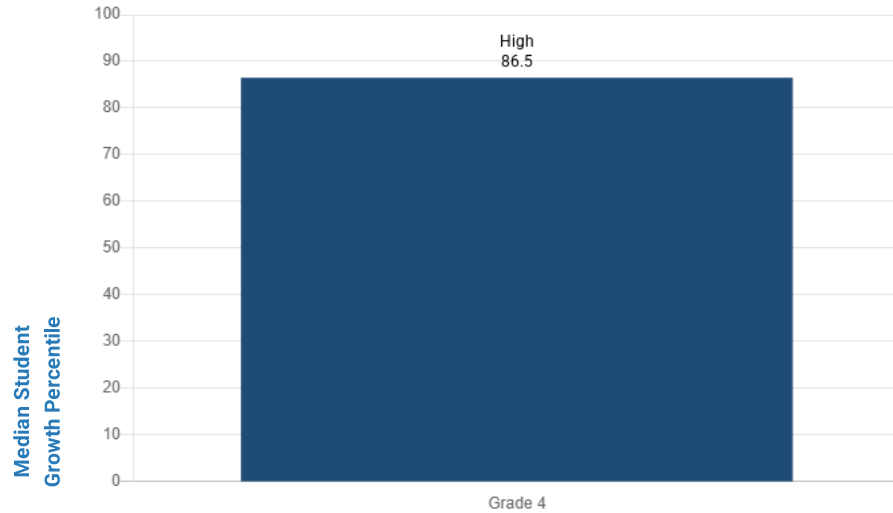

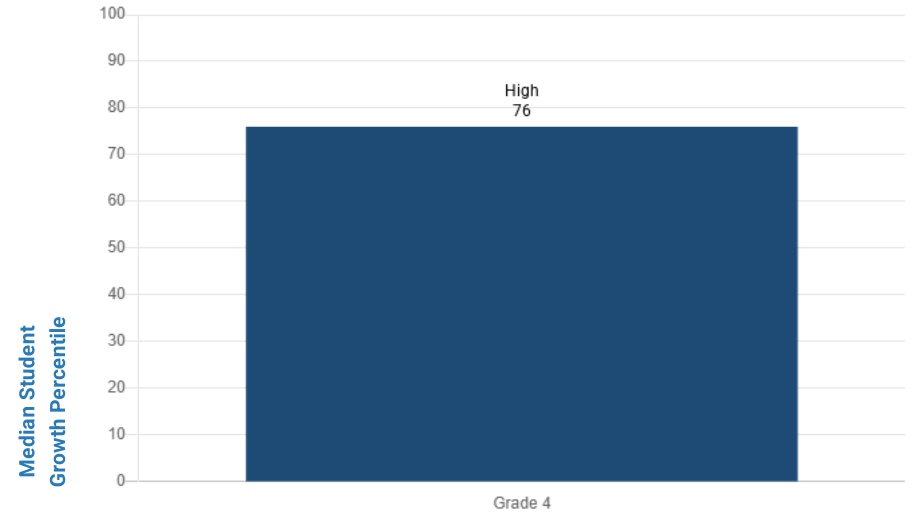

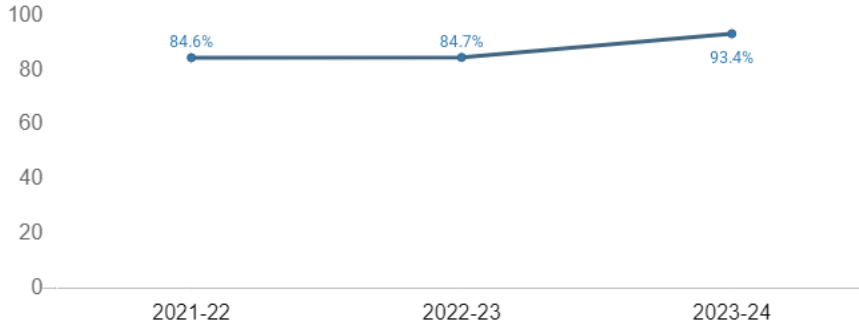

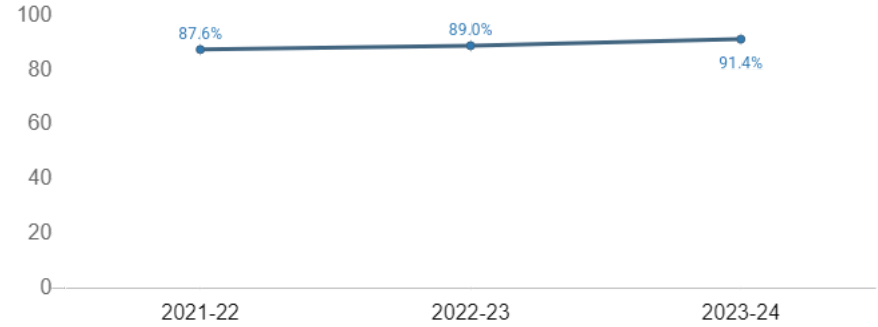
### English Language Arts and Mathematics Performance Trends

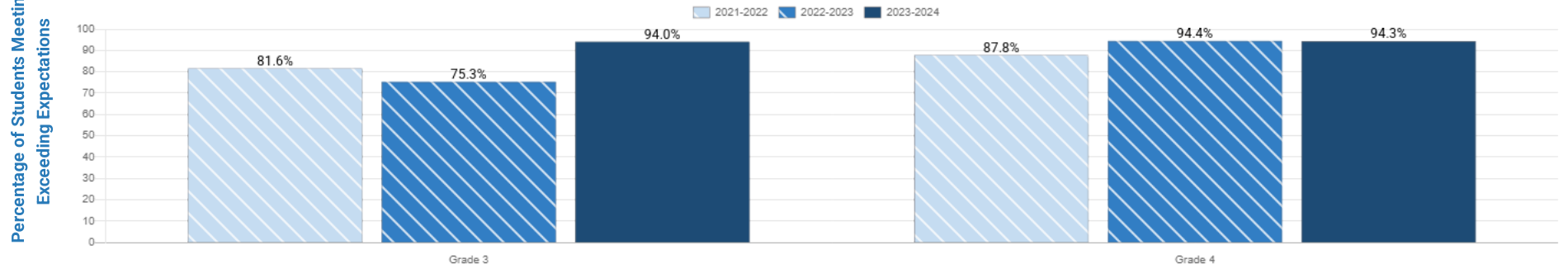

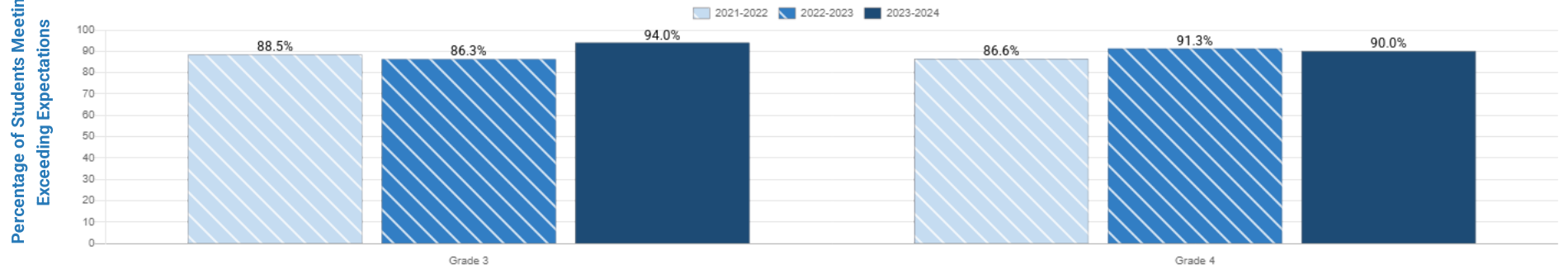

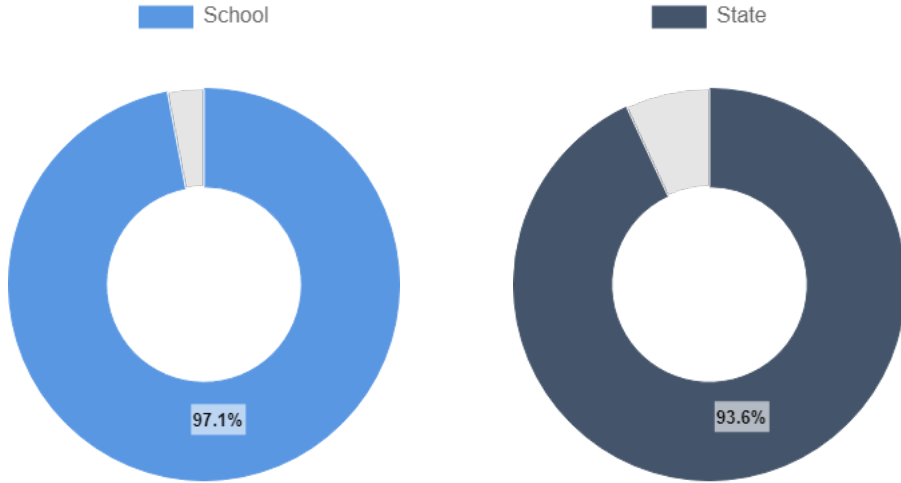

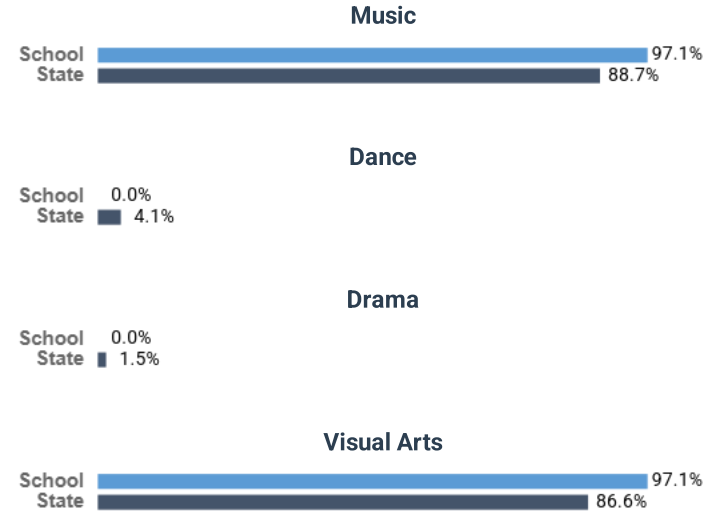

**Students enrolled in one or more classes by discipline:**



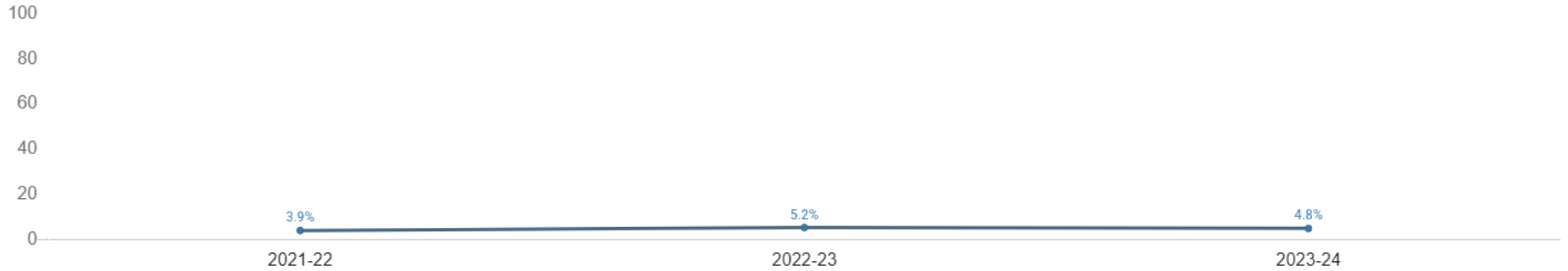

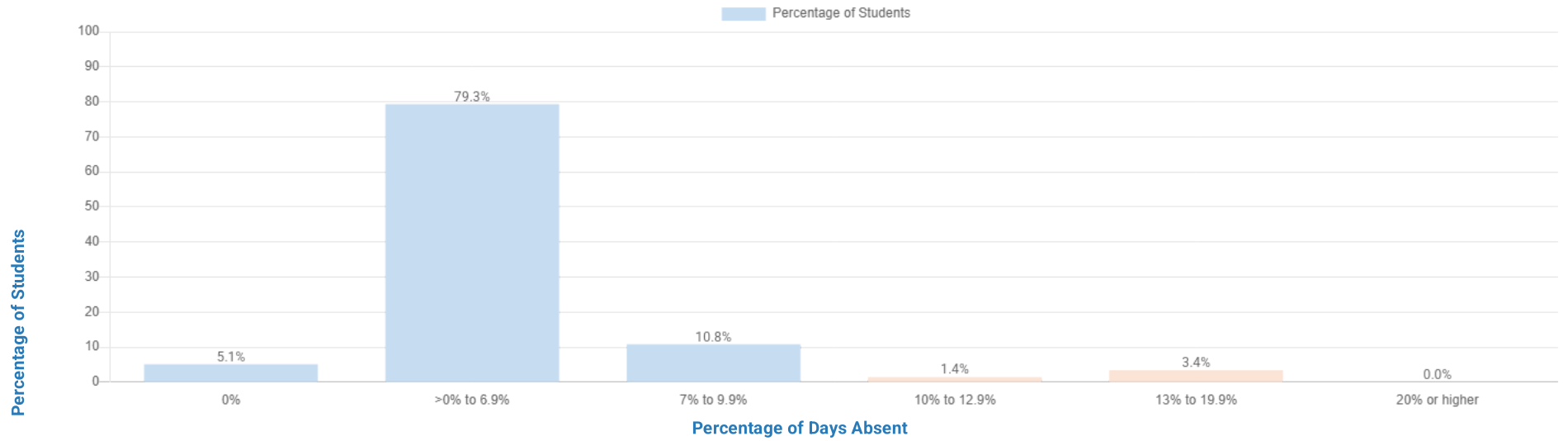

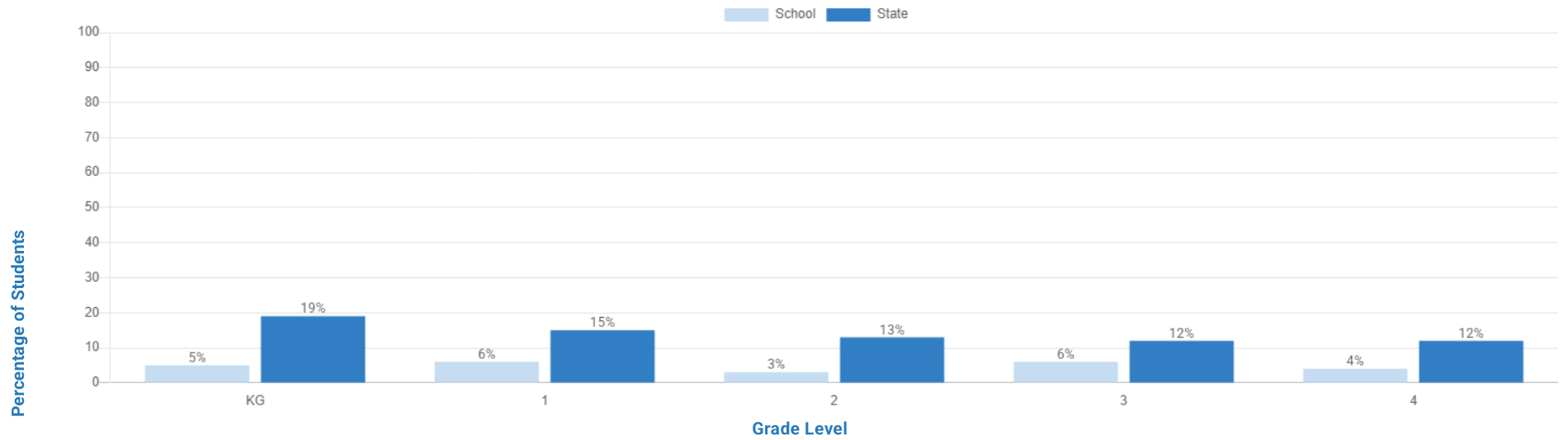

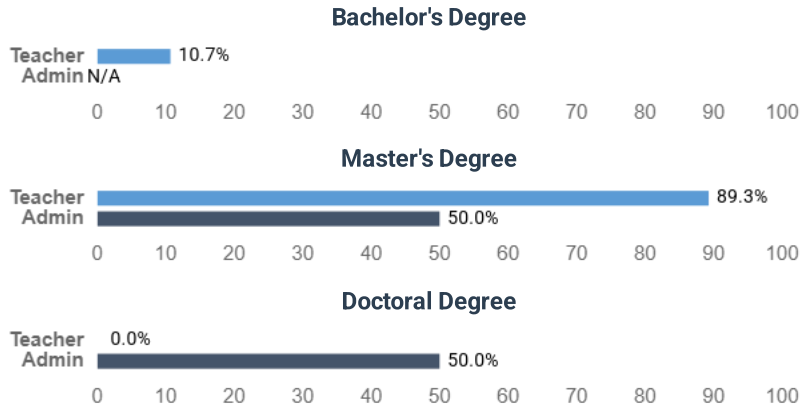

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Glenwood School follows a comprehensive and rigorous curriculum aligned with state standards and benchmarks. Student progress is monitored and evaluated using various formative and summative assessments throughout the school year. Parents receive a standards based progress report at the end of each trimester and attend a parent-teacher conference twice annually. A strong working partnership between teaching staff and parents regarding student growth and learning is a hallmark of Glenwood School.



### Sports and Athletics:

All students at Glenwood participate in physical education program twice each week and a school-wide field day program every spring.



### Clubs and Activities:

Glenwood School in partnership with the Glenwood PTO has an active outreach program raising funds and collecting items for donation to several different charities. ### Before and After School Programs:

For the past 20+ years Glenwood has partnered with the SAM program. The SAM program is a licensed nonprofit child care program providing comprehensive before school and after school care housed at Glenwood and serving all district elementary schools and the Millburn Middle School. The SAM program employs experienced certified teachers and specialists providing a broad range of fun enrichment activities in art, sports, games and homework assistance. The SAM program also provides fun and exciting trips to different destinations on days that school is closed during the week.



### Staff and Professional Learning:

All instructional staff works toward common goals in professional learning communities or PLC's. Grade level teachers have common planning time each week built into the building schedule to review student data and collaborate and plan for instruction. Each school year, the district provides several early dismissal and delayed opening days for staff to receive professional development on various topics regarding instruction and assessment.



### Student Supports and Services:

In addition to a full child study team and two Orton Gillingham certified special education teachers, we have support from a part time behaviorist and a part time school social worker. We also have a certified English language learner (ELL) teacher and two strategies intervention teachers for students identified as needing additional support in mathematics and language arts. Our school also has an intervention and referral services (I&RS) team that meets monthly to support teachers in their work with struggling students and to determine if there is a need for any additional supports or a referral to the child study team is needed.
