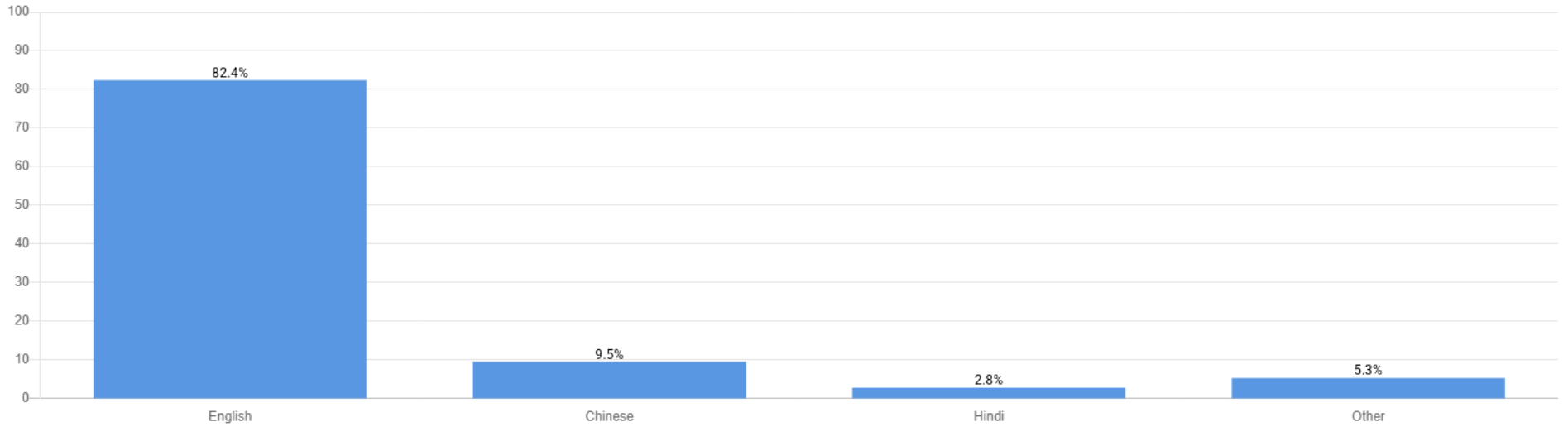

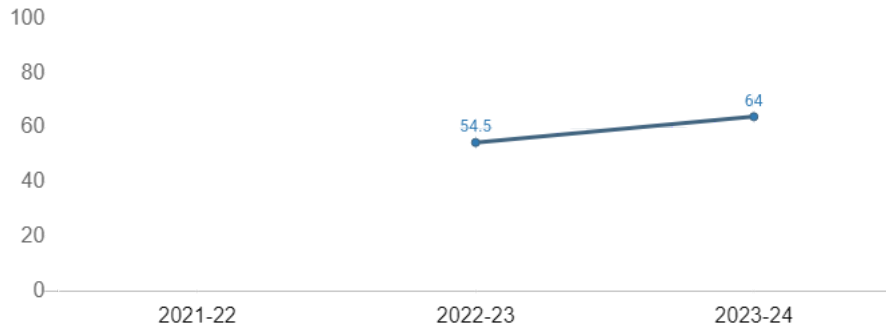

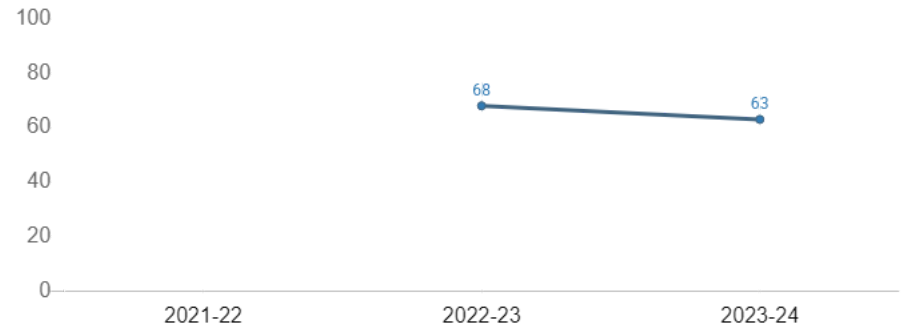

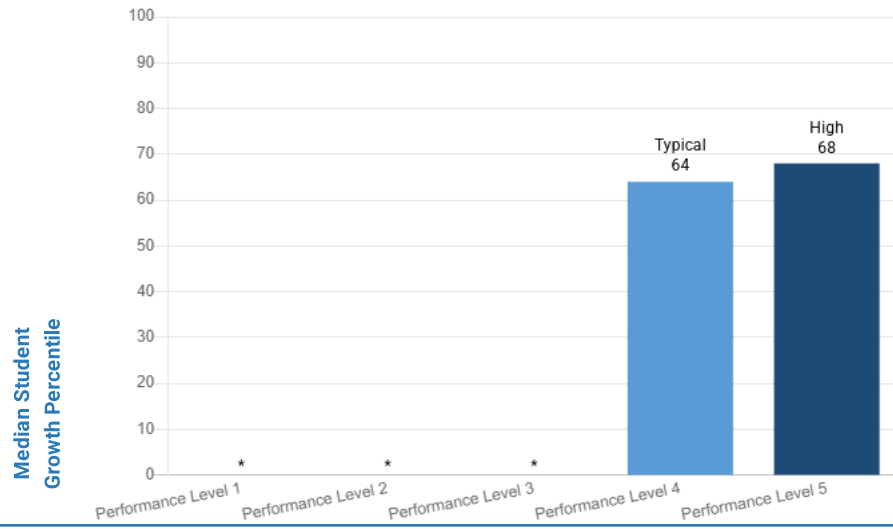

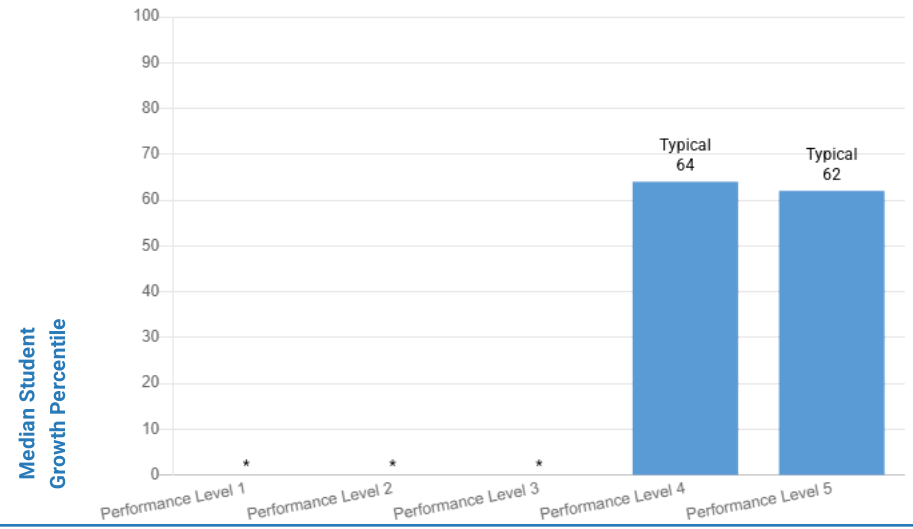

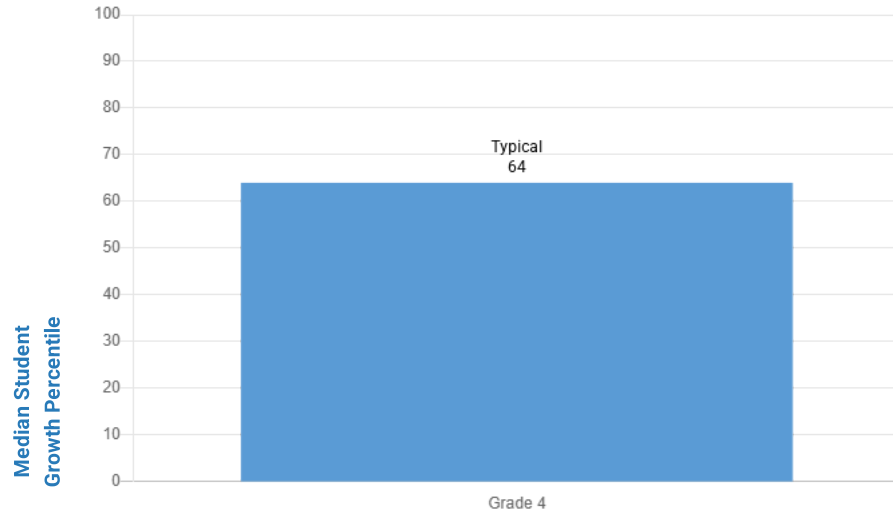

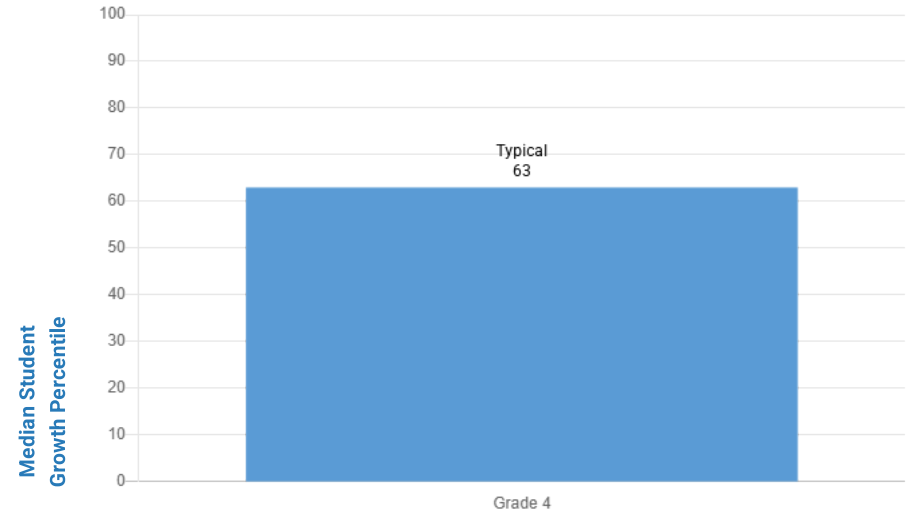

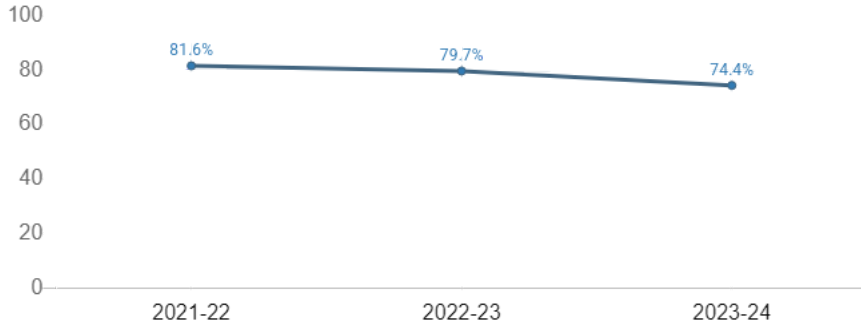

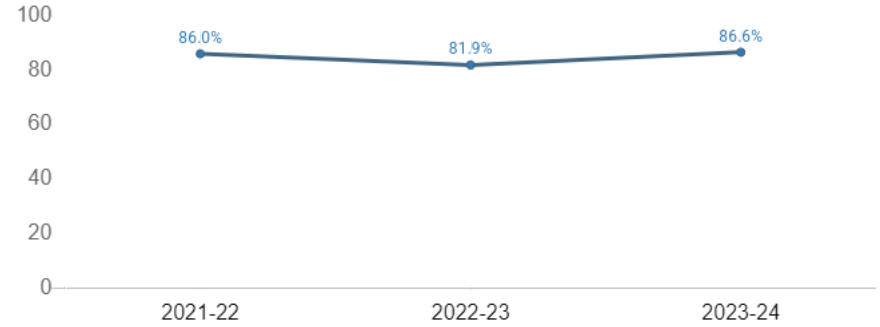
English Language Arts and Mathematics Performance Trends

English Language Arts Assessment - Participation and Performance

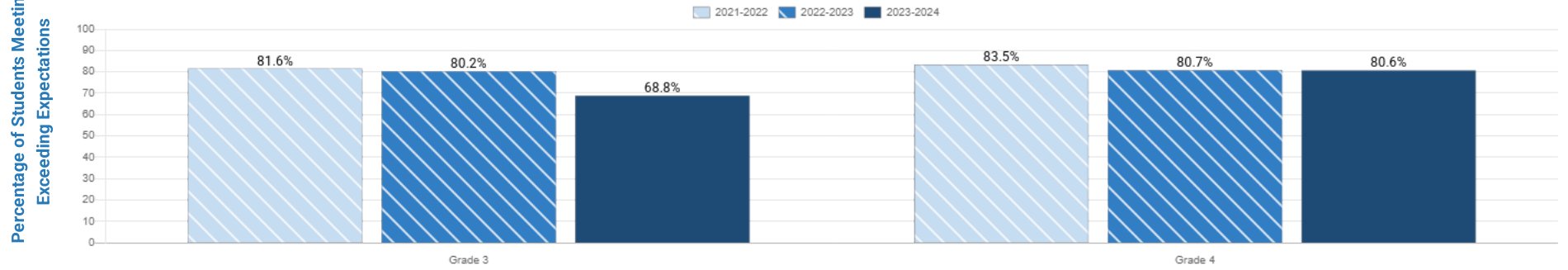

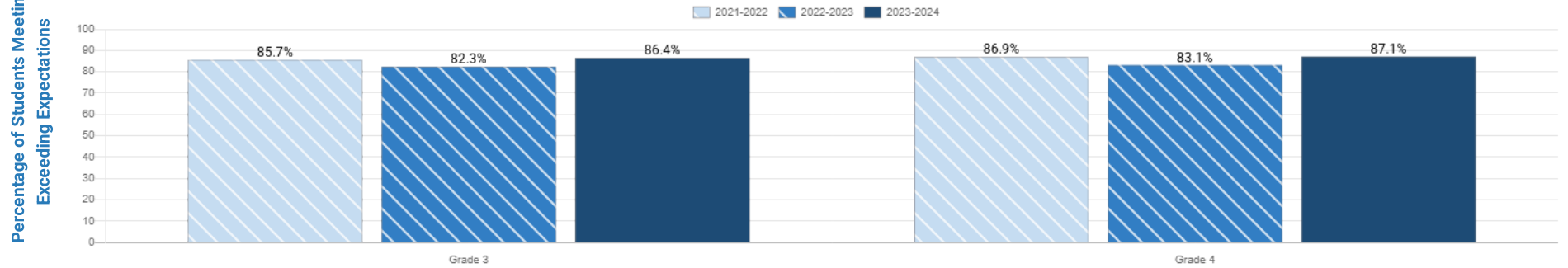

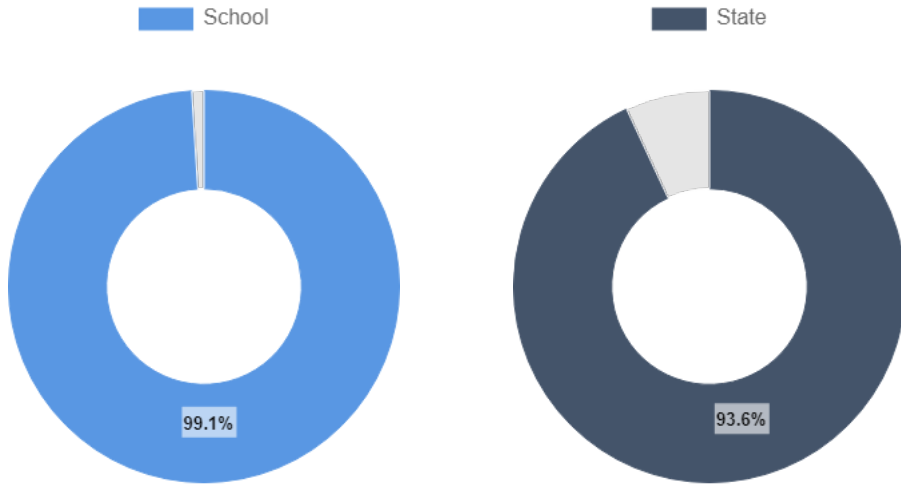

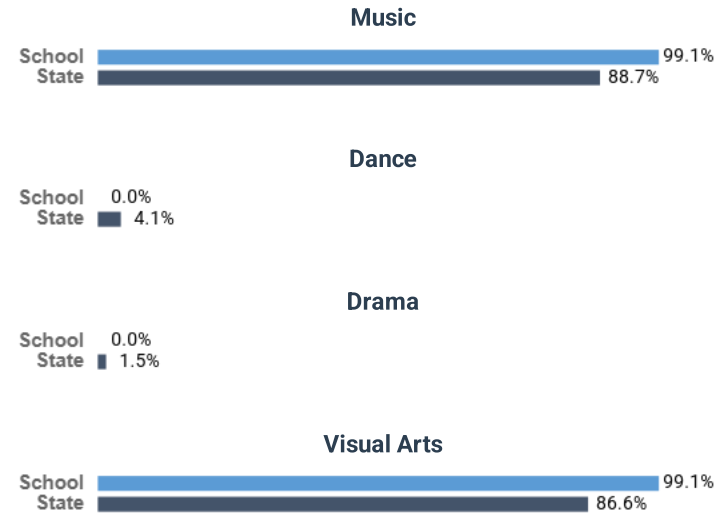

Students enrolled in one or more classes by discipline:



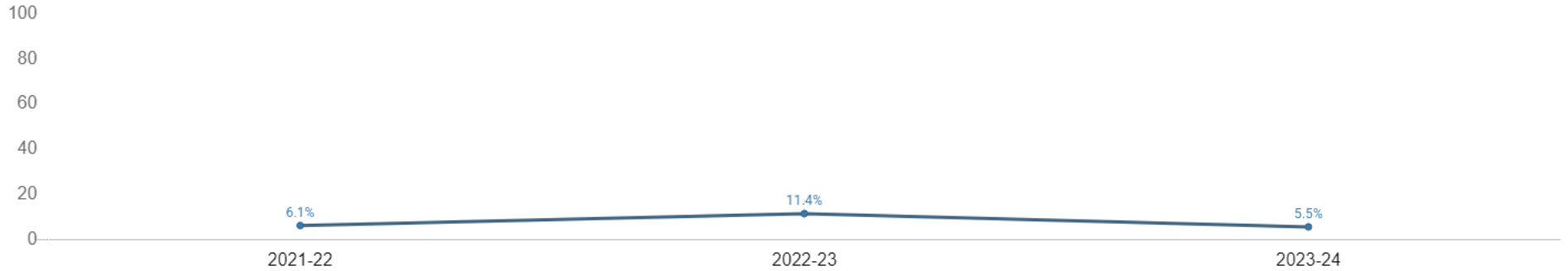

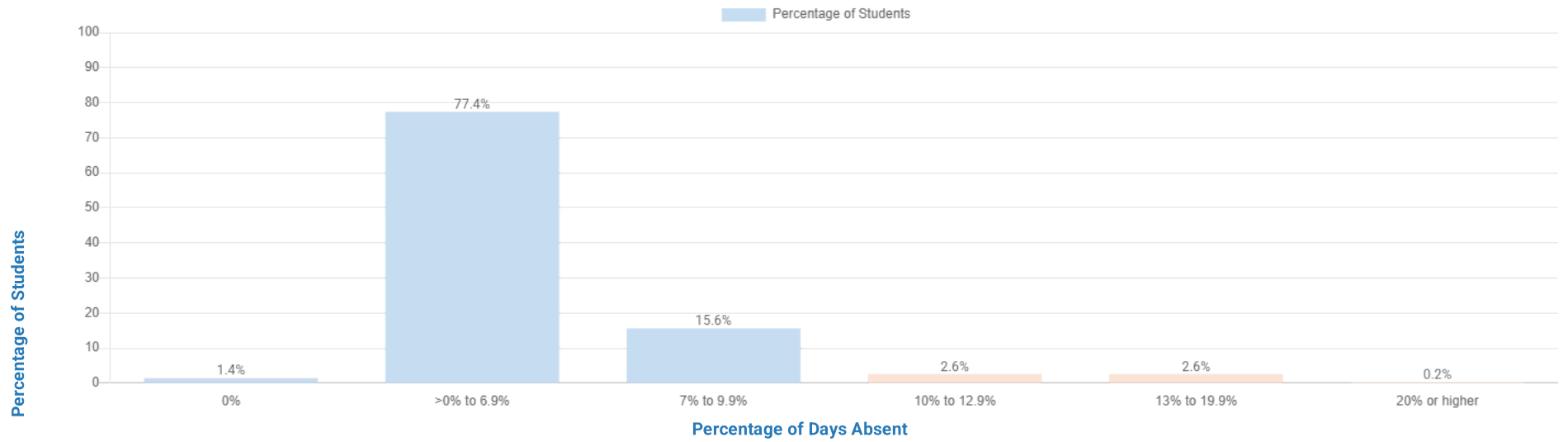

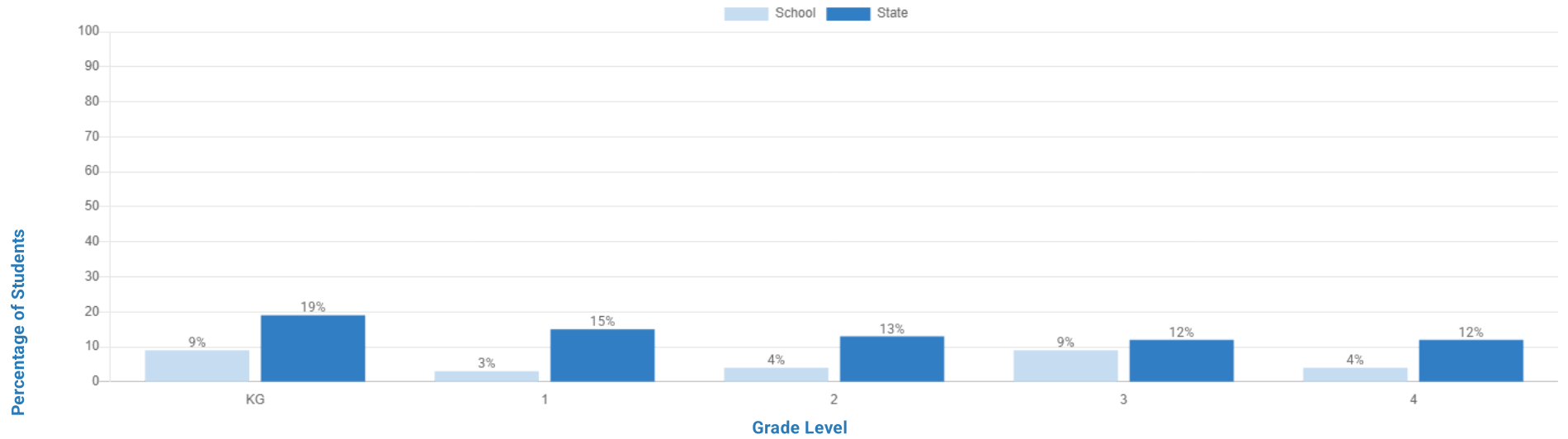

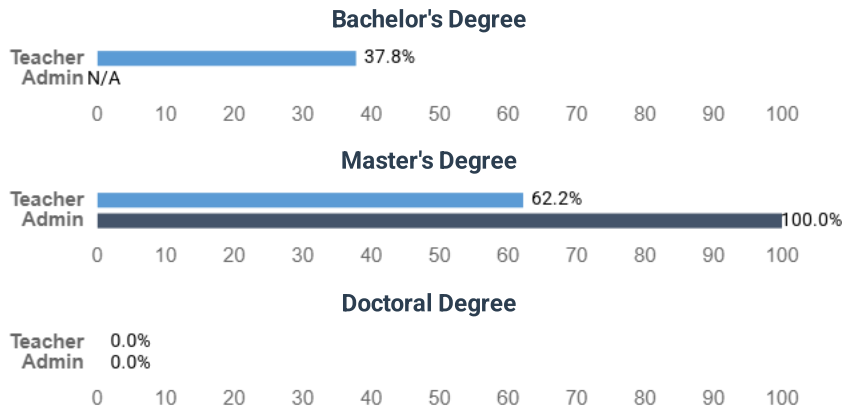

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Courses, Curriculum, Instruction:

Hartshorn Elementary uses the IMSE Program for interactive, multisensory reading and phonics instruction. Our reading comprehension program implements the Teacher's College Reader's/Writer's Workshop model. Our textbook for math instruction is Math in Focus which is based upon the philosophy of Singapore Math. Our Math in Focus program has an online site which allows students and parents to access materials and extra practice at home. Students are given the opportunity to develop critical thinking skills developing a conception of mathematics moving from the concrete, pictorial, and abstract approaches. Gifted and talented needs are met through differentiated instruction in the classroom. Homework is a planned part of the curriculum, extending and reinforcing the learning experience for all students. Homework provides practice in the mastery of skills and helps students develop a sense of responsibility and independence.



Sports and Athletics:

As an elementary school, Hartshorn does not offer any sports or athletics programs other than those that parents can register their students through our PTO run After School Enrichment (ASE).

Before and After School Programs:

Our PTO (Parent Teacher Organization) offers a wide-variety of after school activities for our students through the ASE program. In addition, Hartshorn has a student council, chess club, TREP\$ program, and STEAM (Science, Technology, Engineering, Art, and Mathematics) program.



Staff and Professional Learning:

There are two, full staff development days for faculty prior to the start of school. During these days, district and school goals are shared with a plan for how they will be implemented throughout the year. Five delayed opening days and one early dismissal day also encompass staff development. This year, the delayed opening and early dismissal days focused on new universal screeners for math, language arts, and social emotional learnings. These days were used to teach faculty how to implement the new assessments, analyze data, and develop instructional plans for the various needs of the students. Monthly faculty meetings also provide staff development in various areas aligned to our district and building goals. Finally, each staff member participated in a Professional Learning Community, PLC, of their choice. Staff members share their notes from their PLC with the administration on an ongoing basis.



Student Supports and Services:

Hartshorn Elementary has a program for English Language Learners. English Language Learners are provided daily instruction with an ELL teacher. In addition, we have a full Child Study Team for students with disabilities and offer a wide-range of services from self-contained classrooms, resource rooms, in-class support and an array of special services including speech, occupational and physical therapy, and counseling. Supports and services for students who are struggling include tutoring, extra help, and strategies intervention teachers. Strategies Intervention teachers work with tier 3 students to address identified skill gaps in a small group setting. A LCSW, licensed clinical social worker, is also available to support students in private counseling sessions and pushes in to classrooms for SEL lessons. Hartshorn also has a behavior analyst who works with teachers to develop and implement positive behavioral plans for students with identified behavioral needs.

Student Health and Wellness:

A LCSW, licensed clinical social worker, supports identified students in private counseling sessions. The LCSW also pushes into classrooms for SEL lessons. Hartshorn also has a health teacher who implements a comprehensive health program to instruct students on healthy eating habits, social and emotional health and personal safety. Physical education teachers instruct every class 2 times per week to engage in structured physical activities to promote exercise and lifelong fitness. Every student also engages in daily recess activities.



Parent and Community Involvement:

Hartshorn School has an active PTO that provides a plethora of programs and events to enrich the school experience. Programs include after school enrichment, family nights, fundraisers, cultural arts assemblies, and educational assemblies for our students. Our district has a special education parent advisory group (SEPAC) which supports and promotes appropriate education for all children with special needs in our community. They meet 5 times per school year with our Department of Special Services. SEPAC provides a parent workshop series to the parents of students with IEP's. Our Parent Portal is through the Powerschool platform. Each parent is provided with a login and password. Hartshorn has a partnership with MMAC (Millburn Municipal Alliance Committee), the Millburn Education Foundation, and the Bridges Outreach Program that provides resources for homeless people in Essex and Union County.

Facilities:

Hartshorn Elementary School was built in the 1950s. The 4th grade wing and Kindergarten wing were added on in the late 1990s. Our facilities include a Media Center, STEAM lab, computer lab, art room, gymnasium and multi-purpose room. All of our building, has air conditioning and we have large outdoor recess facilities including two playgrounds, exercise stations, soccer field, baseball field, and basketball court.



School Safety:

Hartshorn has an armed security officer present throughout the school day. We have two all-school drills every month, one fire drill and one emergency drill. These drills are monitored by our district security officer, as well as the police and fire department. At the beginning of the year, these drills are reviewed with the teachers and each teacher reviews drill procedures with her class. We have clear procedures for morning dropoff, afternoon pickup, absent students, late students, and students who need early dismissals. All of these procedures are explained and reviewed with parents on multiple occasions throughout the school year. Students follow three rules when making decisions. They are taught to ask themselves Is it safe? Is it kind? Is it respectful. School safety is reviewed at our bi-monthly all school assemblies as well. We have a DARE program through the Millburn Police Department.



Technology and STEM:

We have a full-time technology teacher who teaches a related class for every teacher once a week in the computer lab. In addition, he pushes into classrooms and assists teachers when implementing lessons related to technology. We have a STEAM lab in the media center where teachers can sign up their classes for STEAM challenges. Additional technology opportunities are available to our students through our After School Enrichment program. Over the summer, we offer a STEAM camp for interested students. Chromebook carts are located in each classroom.
