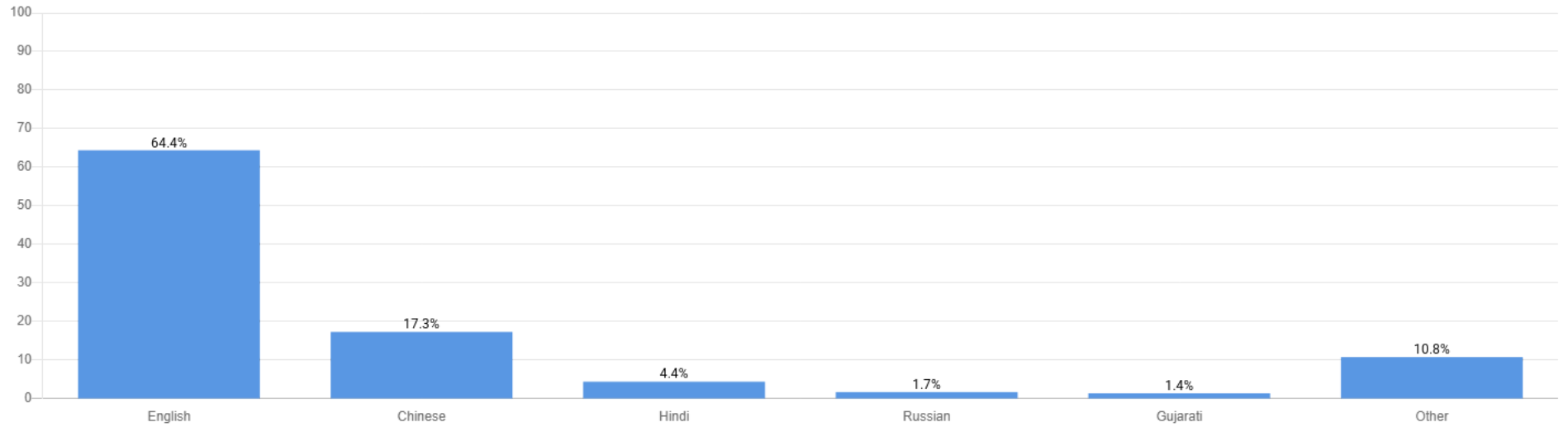

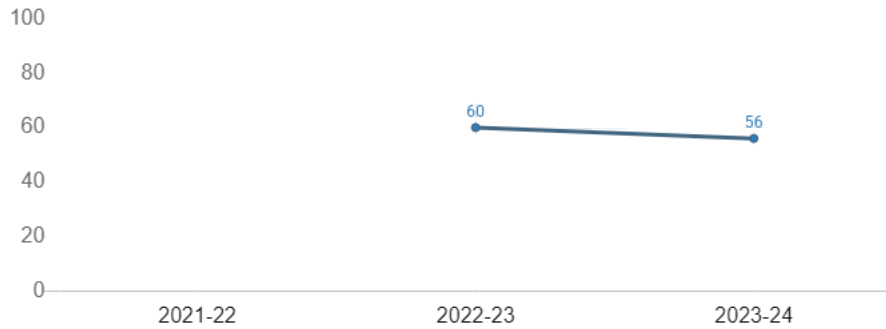

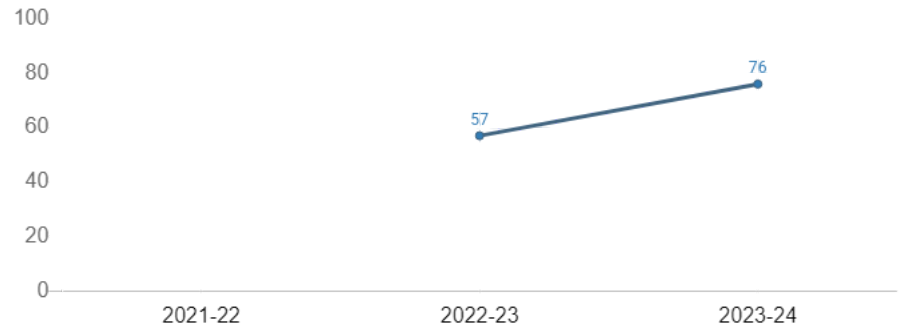

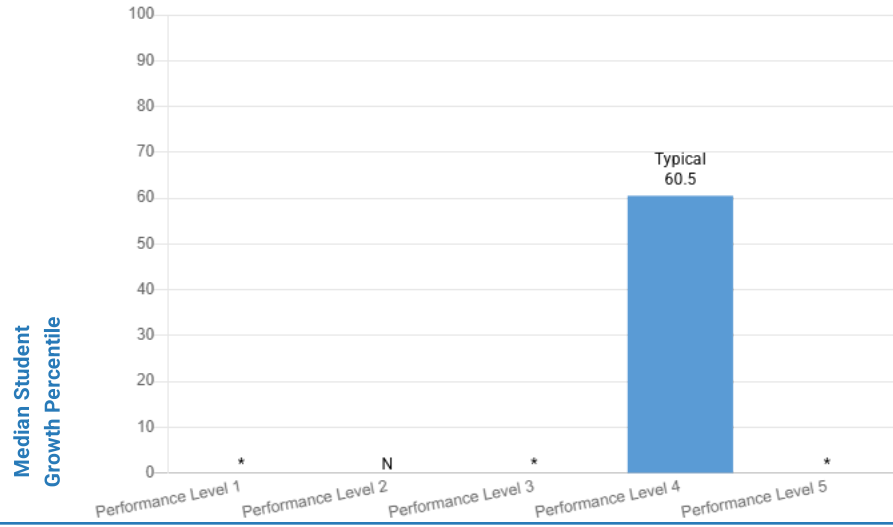

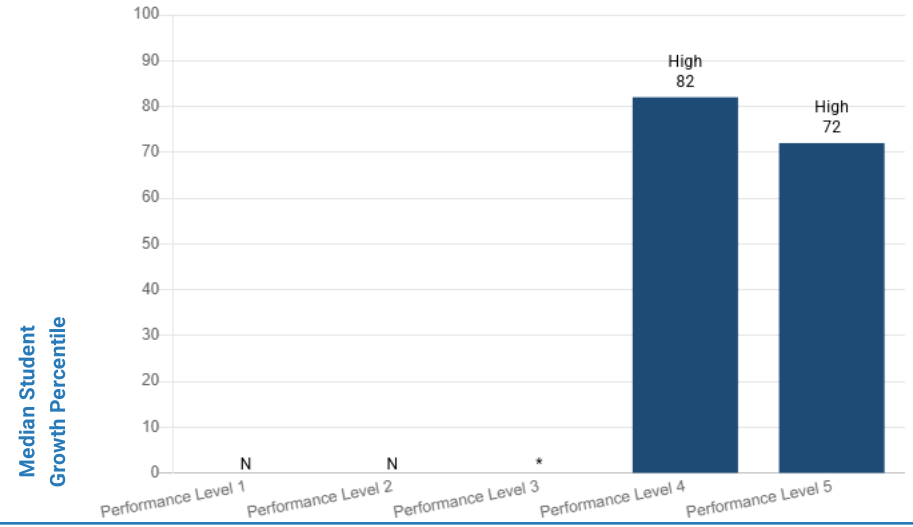

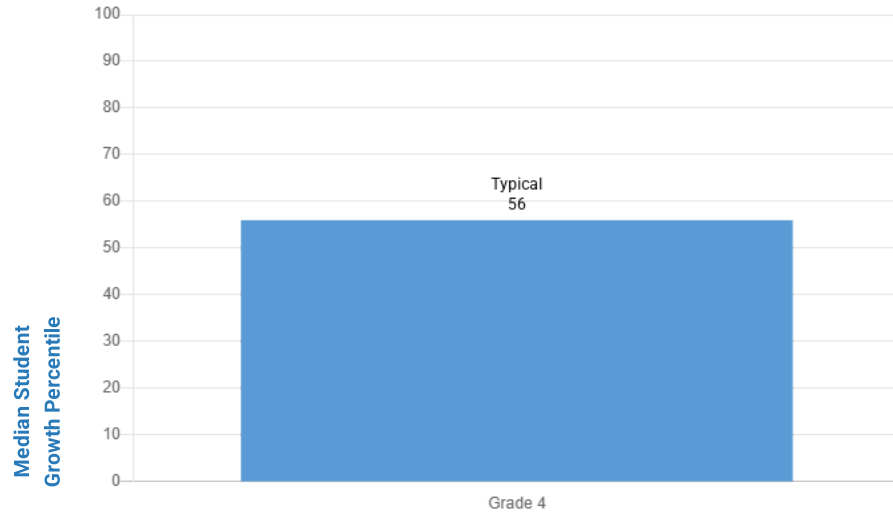

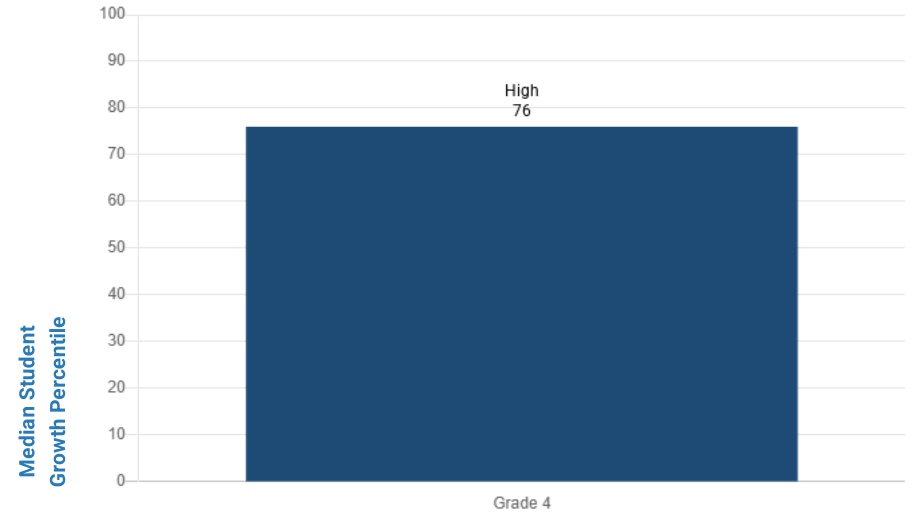

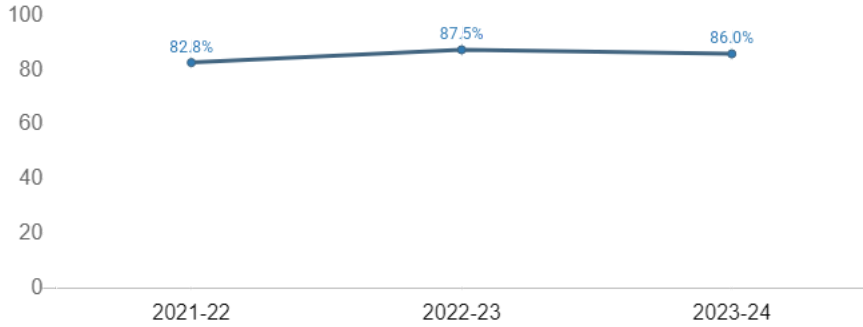

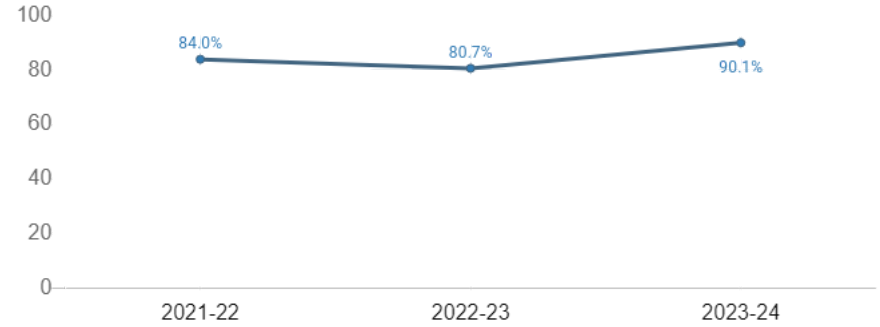
English Language Arts and Mathematics Performance Trends

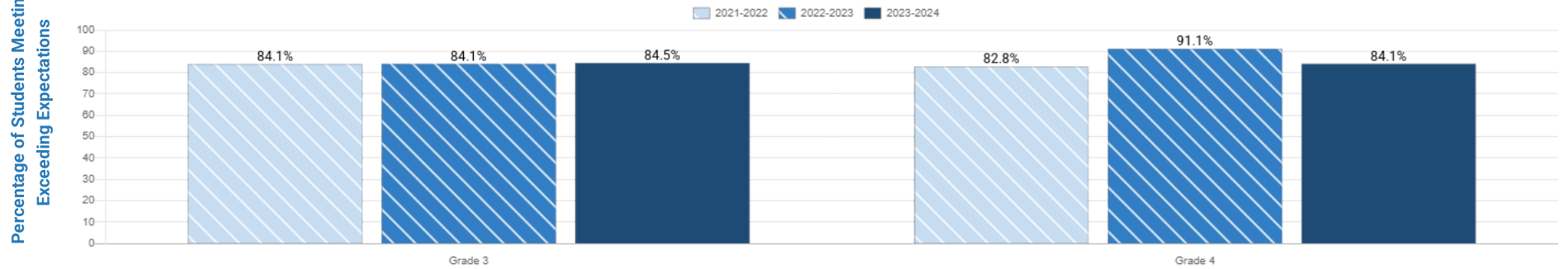

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

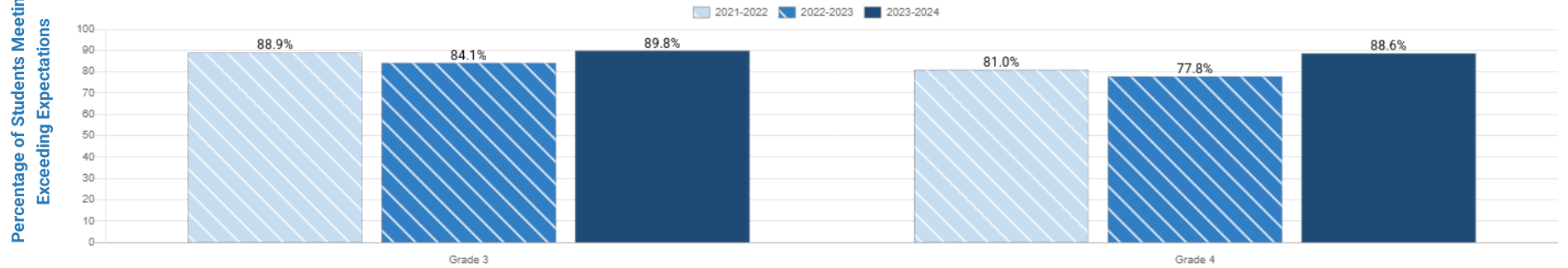

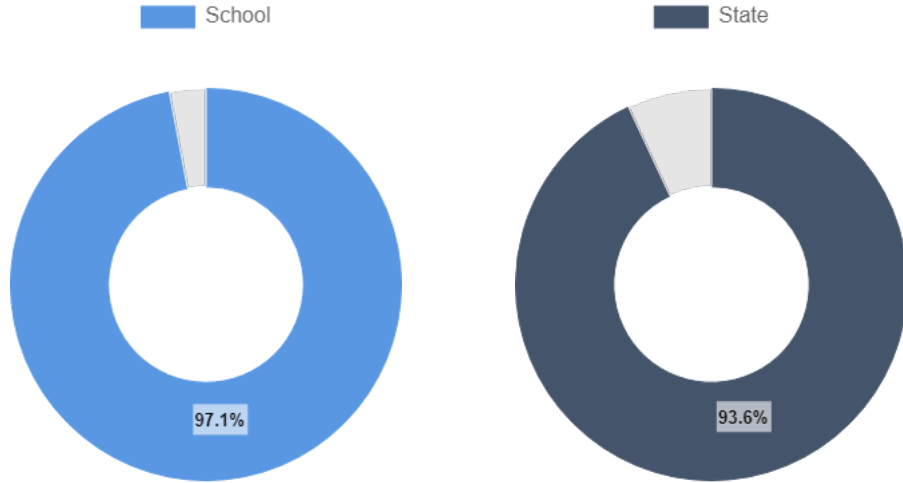

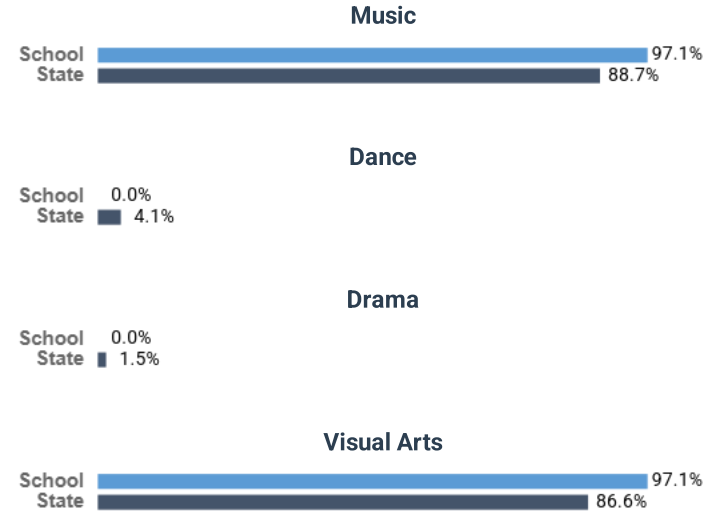

Students enrolled in one or more classes by discipline:



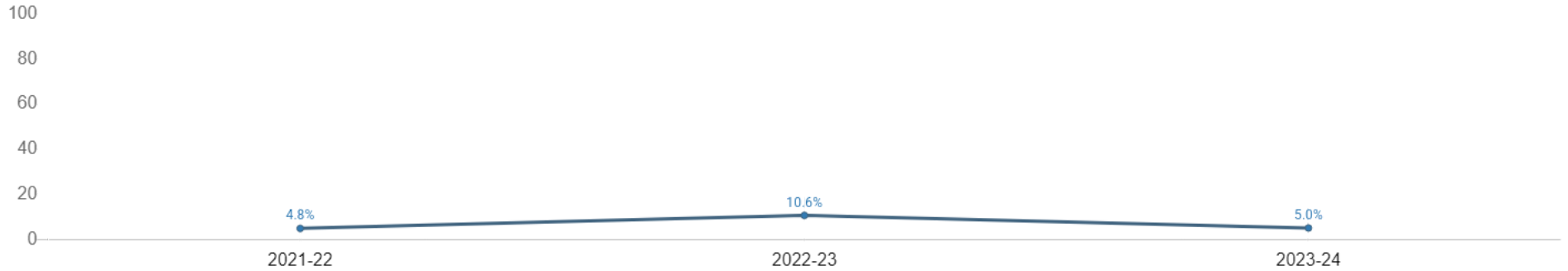

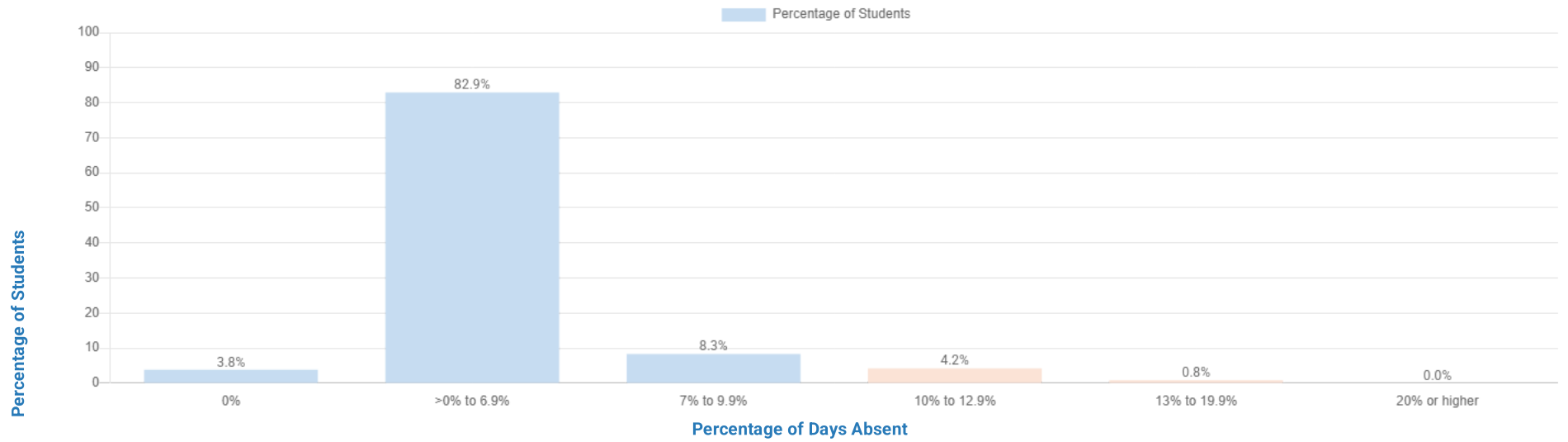

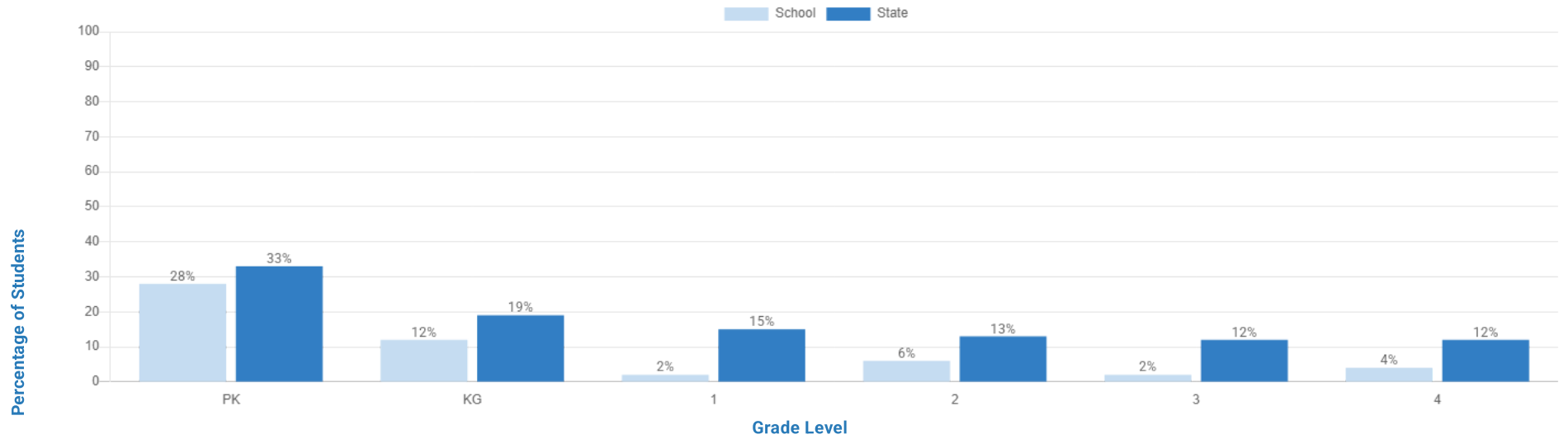

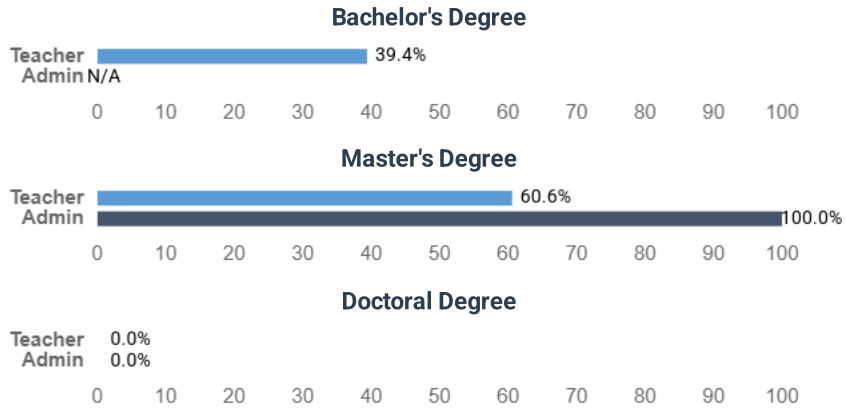

- The school uses Math in Focus, a balanced literacy approach to reading/writing, next generation science standards, and updated social studies work.

South Mountain School has been ranked consistently as one of the top elementary schools in New Jersey, and remains as one of the top elementary schools in the country. As the first elementary school in the district to create a true STEAM space, we have been viewed as pioneers in authentic learning.

Courses, Curriculum, Instruction:

The Millburn Township Public Schools utilize a systemic 5-year renewal plan for curriculum development and implementation. Most currently, science and social studies have been reviewed with new program adoptions. The technology facilitators continue working with classroom teachers to help organize and present new learning in an authentic manner.



Sports and Athletics:

Similar to the other elementary schools in the district, South Mountain School does not offer school-based sports' programs, but supports our local recreation department through the use of the school for basketball, soccer, baseball/softball, etc.



Clubs and Activities:

South Mountain School holds PTO run clubs following the normal school day. Activities/Topics include things such as chess, LEGO creations, sports learning, cartooning, baking, pottery, jewelry making, etc. The school itself has an announcement club, safety club, International Night, TREP\$, and other activities for students and the entire school community.

In addition to district-wide professional development opportunities, the staff at South Mountain School has formed PLCs to further enhance their data-driven learning and teaching.

South Mountain School has a Child Study team that works with our students in both the Pre-K program, as well as the grade K-4 program. Our use of the NJTSS has increased our ability to identify and offer additional services to our students. The ELL program and its teacher meets daily with students that qualify for ELL, and works with the students and parents to help each, individual child.

Student Health and Wellness:

Every student in the school has their height, weight, and blood pressure checked as required. Other screenings, such as hearing and sight, are done based on NJ Standards. Any abnormal findings are reported to the parents. Personal hygiene and how to control the spread of germs are reviewed with all members of the school community. This has become even more of a focus since the outbreak of Covid-19 in 2020. In addition to having physical education class twice a week, the school has an 8 week cycle of Health classes led by a certificated staff member. A breakfast program is not offered.



Parent and Community Involvement:

Parents are active, and plan in invaluable role in our school. Under the direction of the PTO, parents work as media center volunteers, class parents, field trip chaperones, art appreciation instructors, special lunch volunteers, and book fair workers. The PTO conducts fundraising activities which provide the budget for cultural arts assemblies, special programs, and many other contributions to our instructional programs. The PTO also supports a Strawberry Festival, International Night, Summer Reading, Talent Show, Book Fair, Holiday sale, and Science Fair. The school also works with the Millburn Education Foundation, Millburn Municipal Alliance, Caring Kids, and Down the Block. Information is retrieved and uploaded by parents through PowerSchool.

Facilities:

Built in 1935, the school is located on Southern Slope Drive in Millburn. Due to a decrease in enrollment throughout the district, it was closed in 1983, but reopened in September of 1998. There were major renovations that took place at this time, and included fibre optic wiring for internet access. Our school has a multi-purpose room, gymnasium, library, STEAM lab, and art room with a kiln. All learning spaces are air-conditioned.



School Safety:

South Mountain School takes school safety extremely seriously, and has a school safety committee made up of all stakeholders in the school. This committee meets various times throughout the year, with a focus on improving what we do to provide a safe environment for our students, staff, and parents. The school has a security vestibule, as well as a sign-in procedure that checks visitor identification through a national database through facial recognition. The school also has an armed safety officer that is full-time at South Mountain School. He monitors both interior and exterior cameras, is a visible presence during arrival, dismissal, lunch, and recess. He also goes into classrooms to talk with students about how to keep themselves safe, emergency drills, Halloween safety, etc.



Technology and STEM:

With the assistance of the media specialist, and technology facilitator, all students in grades K-4 take part in a variety of technology learning areas weekly. The use of our Collaboratory (Maker-space) happens on a daily basis and provides an opportunity for personalized learning, and problem-solving in groups/as individuals. All classrooms are outfitted with SMARTBoards, and every student has a Chromebook assigned to them.

Early Childhood Education:

The Preschool program is located at South Mountain School. The three-year-old students attend class in the morning and four-year-old students attend class in the afternoon. This inclusionary program follows a general education preschool curriculum. The special education students receive support including related services in accordance with their IEPs. There are also self-contained special education preschool classrooms. The preschool teachers are dually certified. All classes have additional support from paraprofessionals. Behaviorist support is provided on an as-needed basis. Special needs students enroll upon determination of eligibility for special education and related services. Regular education students are admitted through a lottery process and pay tuition. It is the philosophy of the Millburn Preschool Program to provide developmentally appropriate programs to encourage students to become independent and confident learners.

Other Information:

Millburn Township has six elementary schools, of which, South Mountain is one. Enrollment for the 2023-2024 school year was approximately 250 for kindergarten through 4th grade, with an average class size of around 18. Our Preschool enrollment was approximately 40 with an average class size of around 10. The kindergarten program is developmental and allows each child to become a part of the school community. Math and reading readiness join the other disciplines in a thematic presentation. Formal reading instruction begins in the primary grades with an emphasis on Language Arts (reading, listening, speaking, writing) as an integrated whole throughout the grades. In the area of mathematics, concepts and computation that are linked to problem solving are emphasized. The Science curriculum is delivered with a hands-on approach and is integrated throughout the curriculum. Social Studies is presented and also integrated throughout the curriculum. Special subjects are presented weekly, including art, music, computer, and library skills. Physical Education is offered twice weekly. The services of the Child Study Team, including the Learning Consultant, School Psychologist, Social Worker, and special education teachers are available to those students who need them. Instrumental music (strings) begins in fourth grade. There is no school uniform requirement.
