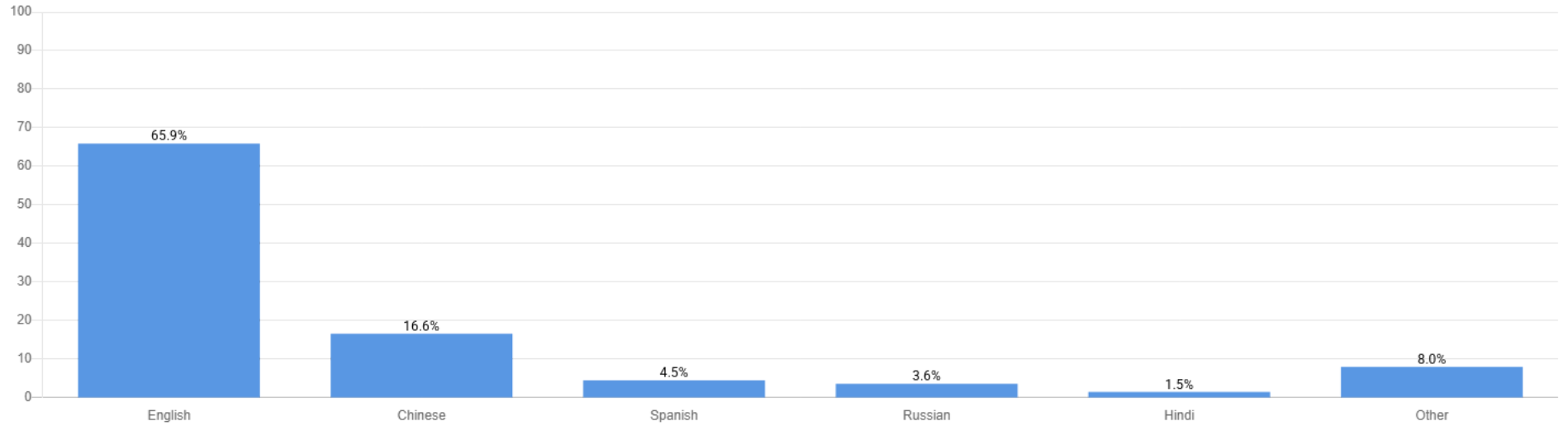

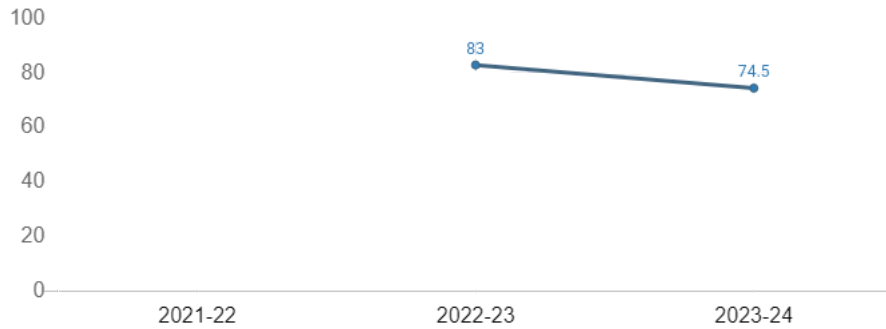

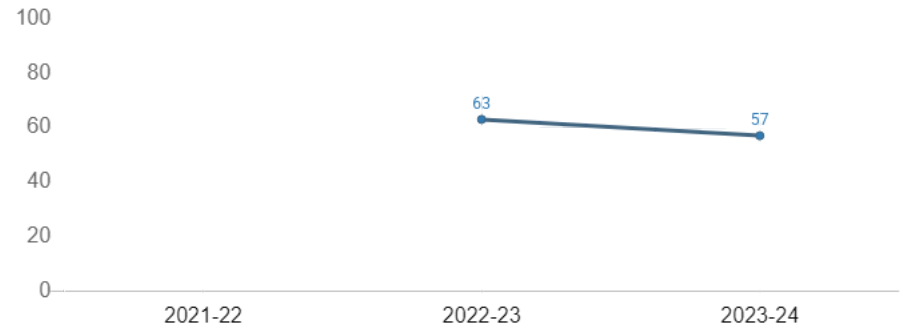

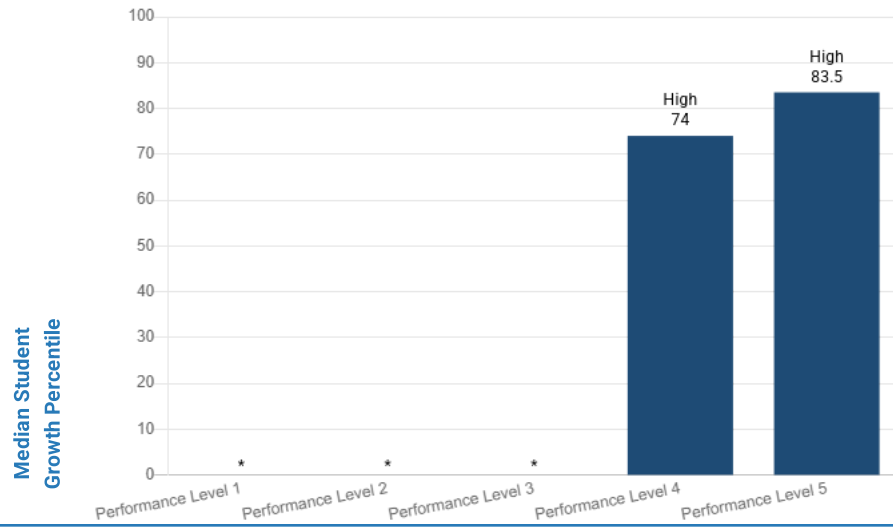

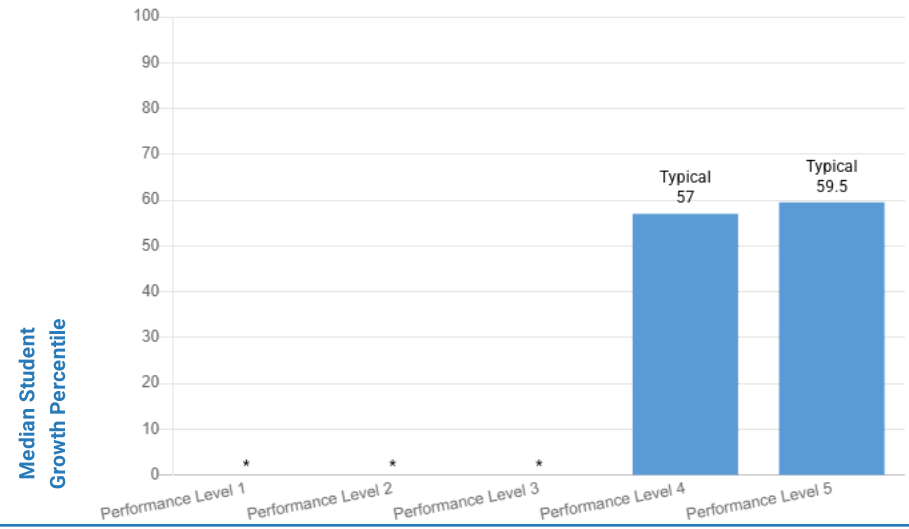

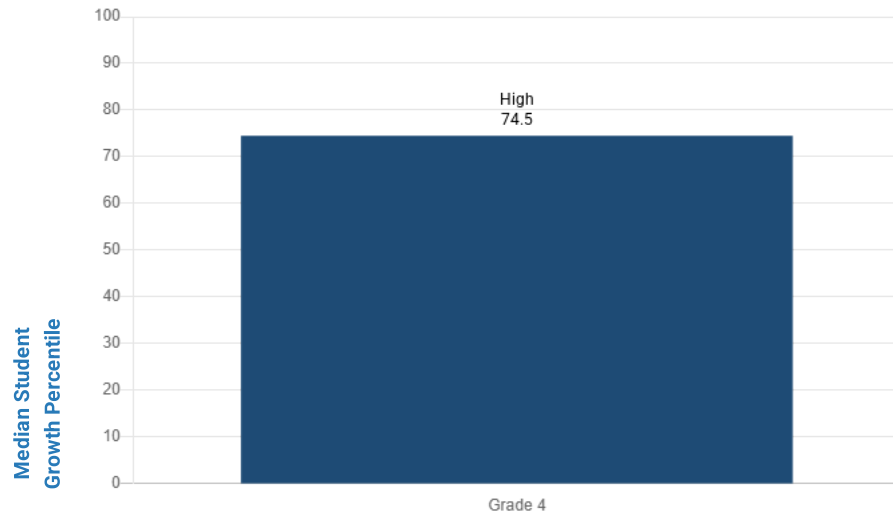

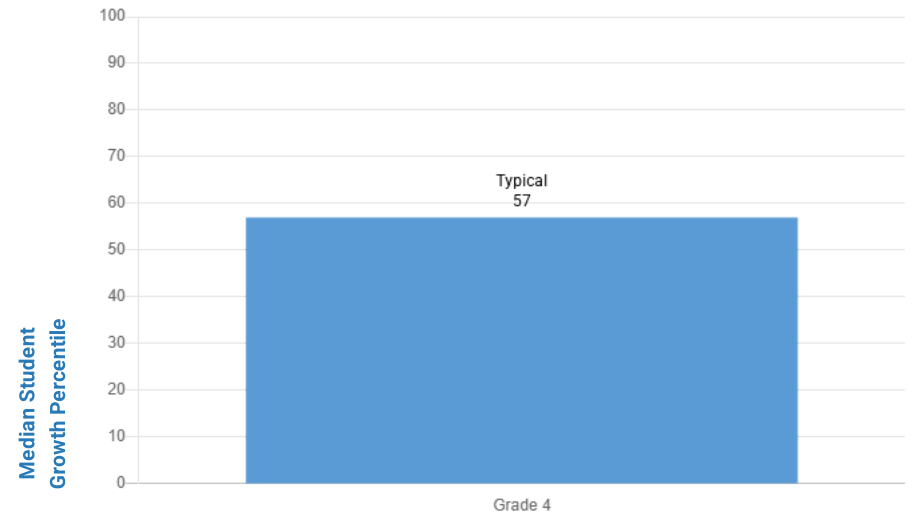

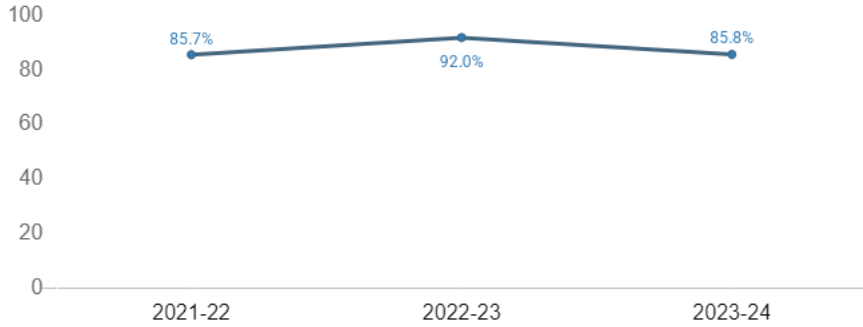

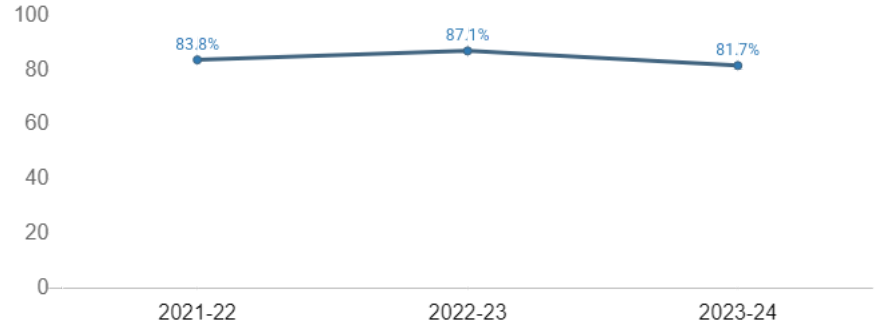
English Language Arts and Mathematics Performance Trends

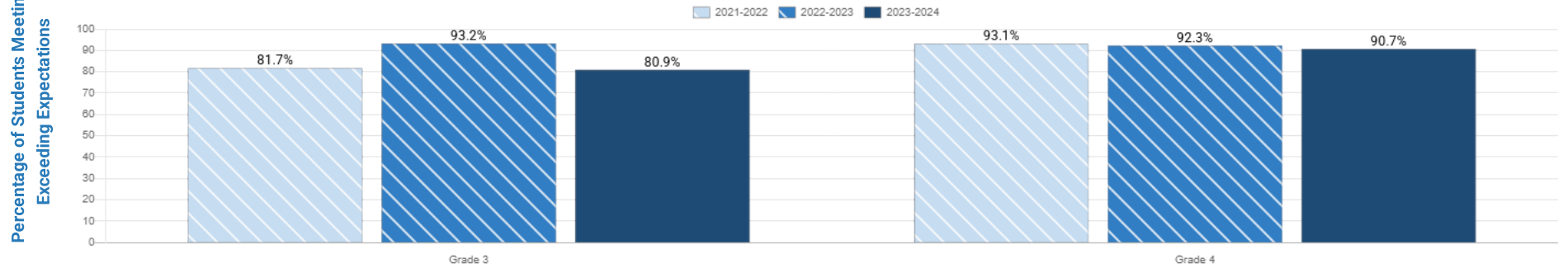

Mathematics Assessment - Participation and Performance

NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. 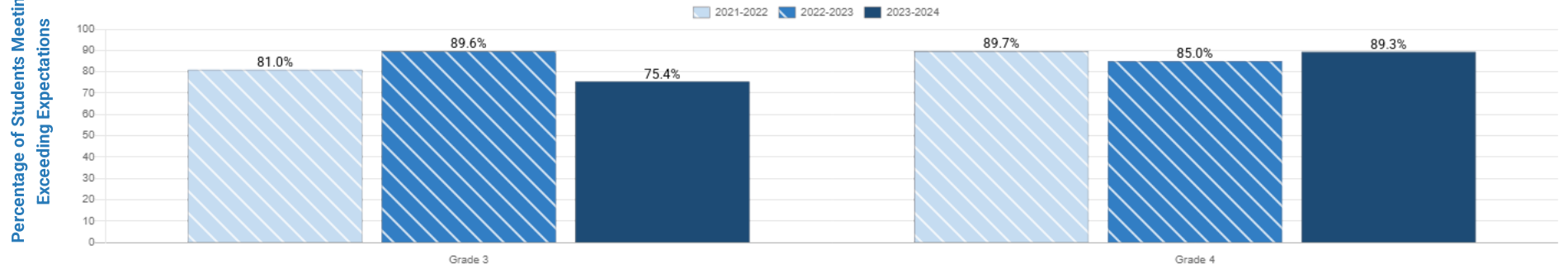

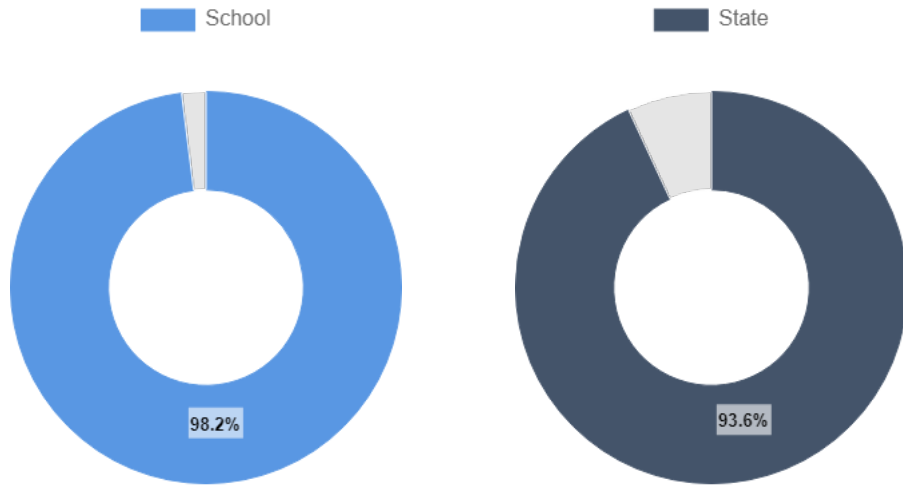

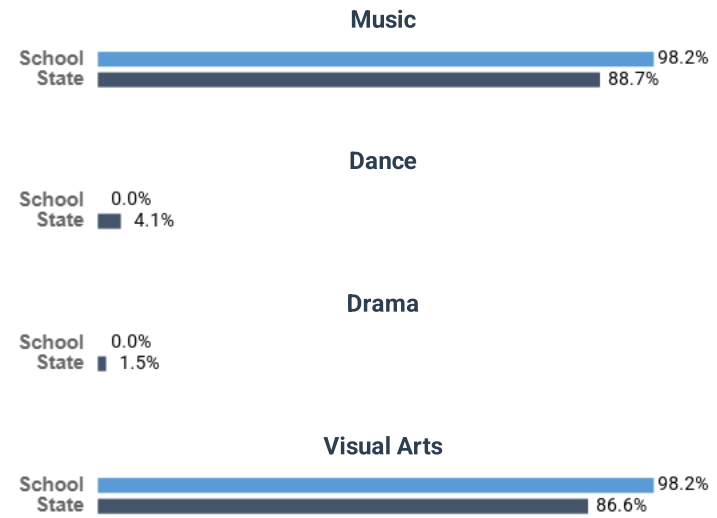

Students enrolled in one or more classes by discipline:



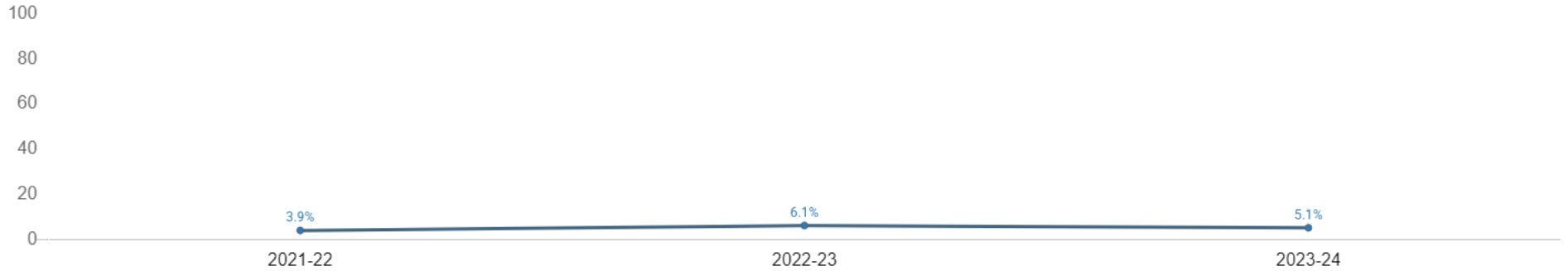

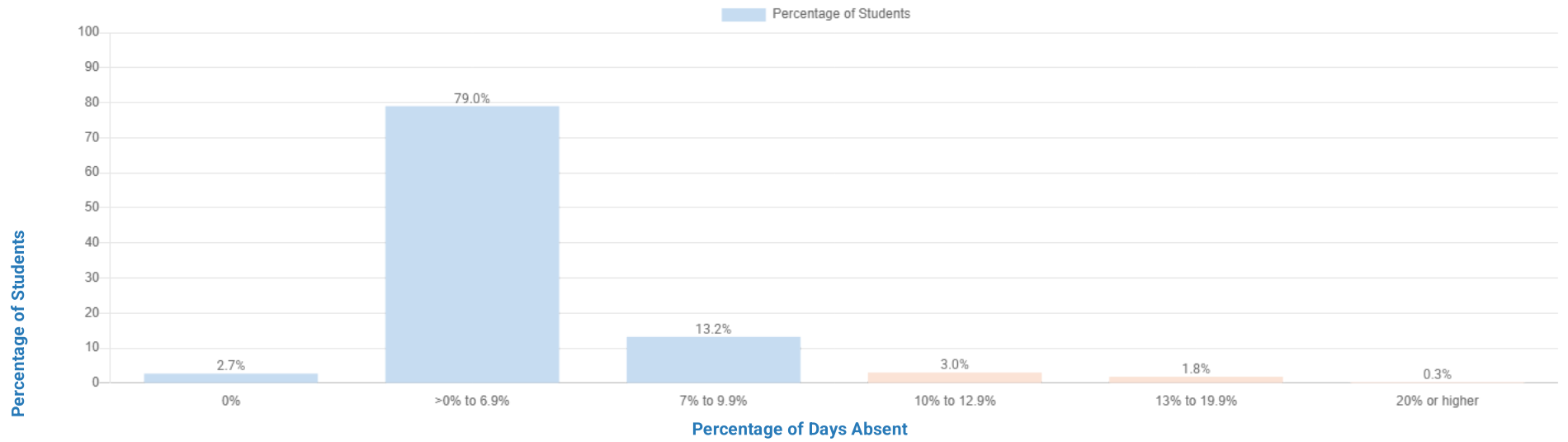

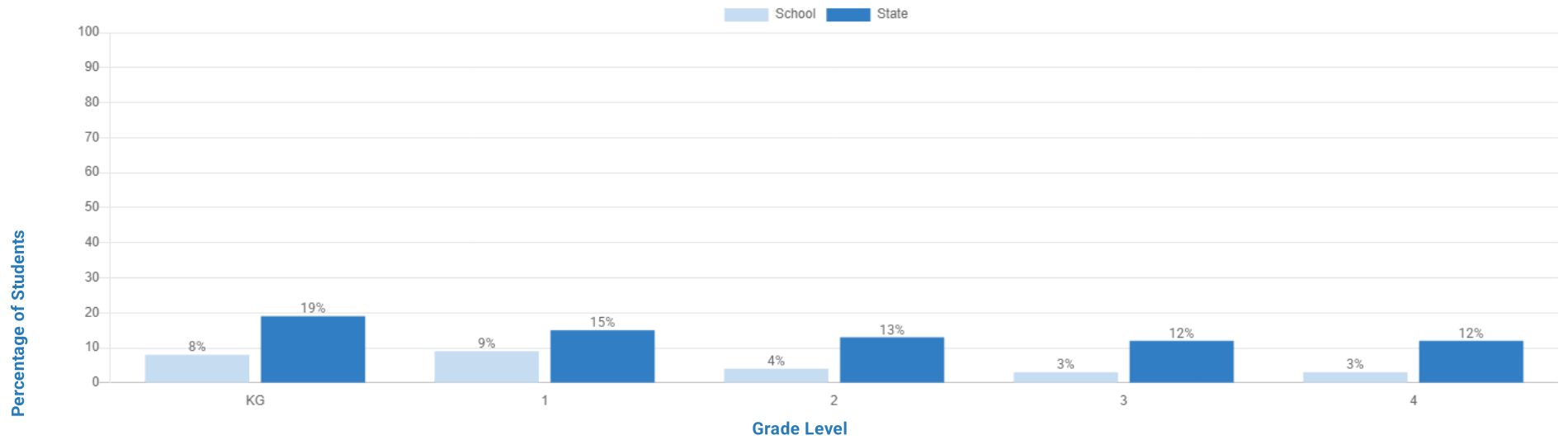

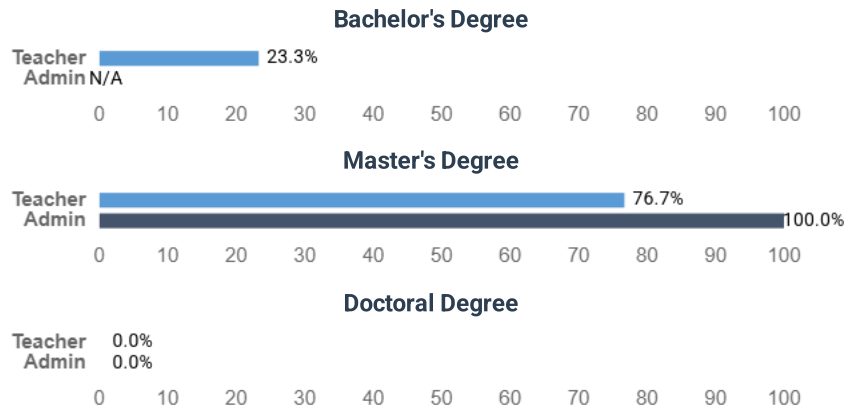

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Two organizations offer before and after-school programming in our district schools. AlphaBEST, an external organization, operates at Wyoming School to provide childcare outside of school hours. Additionally, the Wyoming staff runs various clubs after school, and the Wyoming PTO offers a wide range of After School Enrichment classes for a fee.



Staff and Professional Learning:

Wyoming faculty members participate in extensive professional development both within and outside the district. Resources are provided to promote diversity, global awareness, and cultural responsiveness, aligning with our district's equity goals. This professional learning enables us to evaluate our curriculum and teaching methods through a social justice and equity lens. Furthermore, we continue to participate in refresher training on literacy across grade levels, engage in discussions about the principles of high-quality assessments, and study best practices in math and technology instruction. We are also enhancing our capacity to utilize our innovative research and design space. Faculty members take part in professional learning communities (PLCs), peer observations, and regular reflection on their professional practice through self-developed professional development plans.



Student Supports and Services:

The Department of Special Services adheres to the New Jersey Administrative Code, delivering quality education in the least restrictive environment for students with educational disabilities who require special education services. We prioritize facilitating inclusion in general education settings to the greatest extent possible. Programs are continuously evaluated to ensure they meet the individual needs of students, with a variety of placement options available in accordance with Individual Education Plans. Our special services staff consists of professionals dedicated to developing educational plans and providing essential services tailored to each student's needs. Our Special Education Teachers are passionate experts committed to delivering the highest level of education possible.

Student Health and Wellness:

Wyoming School is dedicated to ensuring the health and safety of both students and staff. A school nurse and student support services are readily accessible on campus. The Wyoming staff implements a character education program centered on Sean Covey's "7 Habits of Happy Kids," which includes the 8th Habit, voice, to foster positive character development. Students engage in Whole School Meetings to teach each other the 8 Habits, during which they are recognized for demonstrating these behaviors. Additionally, every student has the opportunity to earn a token for the Book Vending Machine as an incentive for modeling leadership, while promoting literacy. Each year, the school nurse conducts height, weight, and blood pressure checks, along with other screenings as mandated by New Jersey standards. Any abnormal findings are communicated to parents, and discussions on personal hygiene and germ control are held with students.



Parent and Community Involvement:

We greatly appreciate the collaboration between parents and teachers. Guided by the PTO, parents volunteer in various capacities, including assisting in the library, chaperoning field trips, supporting the cafeteria lunch/snack program, organizing the school-wide book fair, and greeting students in the mornings. The PTO is a highly effective fundraising organization that helps finance cultural assemblies, and enhances instructional programs, including class libraries, various technology resources, and innovative teacher grants.

Established in 1927, Wyoming School is situated on Myrtle Avenue in Millburn, NJ. Recent enhancements include a new Innovative Design Space featuring a MakerSpace for STEM exploration, an upgraded art room, renovated student bathrooms, restored historical auditorium, and the installation of air conditioning in all learning areas.



School Safety:

At Wyoming School, ensuring safety is a top priority. The School Safety Committee, which includes various stakeholders from the school and community, meets each trimester to enhance the environment for students, staff, and parents. Regular drills are conducted to familiarize everyone with procedures. Additionally, a school safety officer is on-site to maintain the safety of the entire school community.



Technology and STEM:

Wyoming features a Media/WonderLab (Innovative Design Space) and a STEM Lab available for all students and staff. Our Technology Facilitator collaborates with teachers to integrate technology into the curriculum. Students have opportunities to develop their problem-solving and critical thinking skills during technology classes where they engage in activities related to robotics, coding, environmental sciences, and design challenges. Through our Genius Hour program, they use technology resources to support their research and exploration. Each student is provided with a Chromebook as part of our 1:1 initiative, and all classrooms are equipped with SmartBoards and document cameras.

Attendance is closely monitored at Wyoming School. If a child is absent, parents are asked to provide a reason for the absence. Should attendance become a concern, the Intervention Referral Services Team offers strategies to support the family. Attendance letters are sent home for excessive absences or tardiness, as maintaining school attendance is a top priority for supporting student learning.
