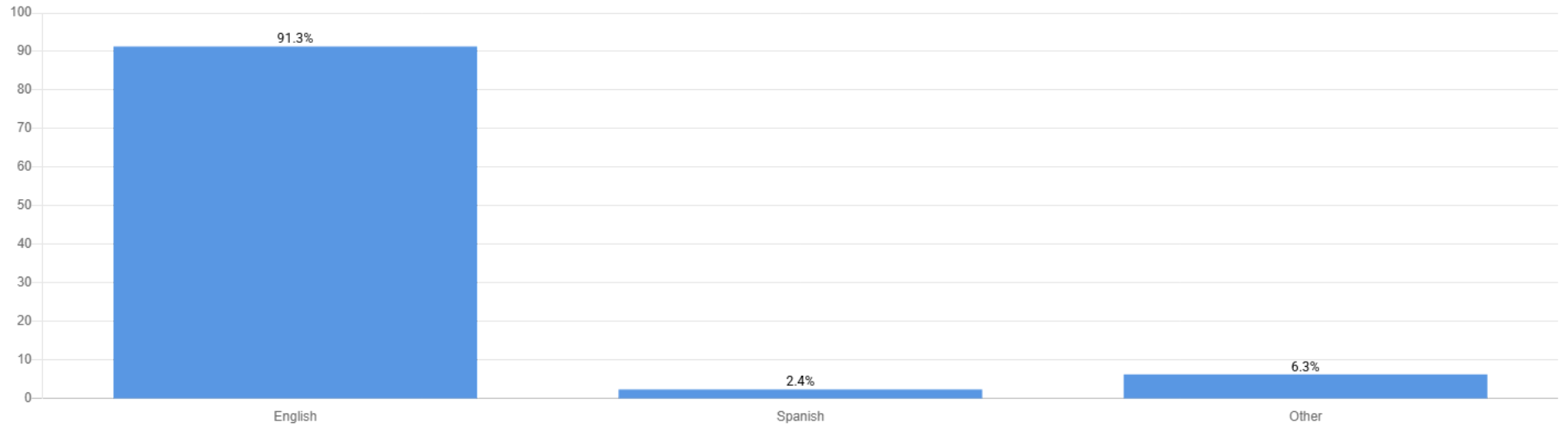

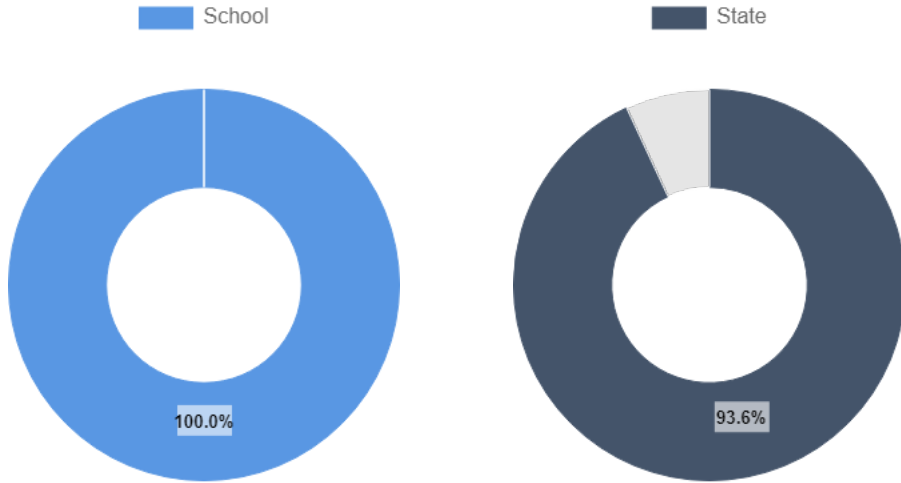

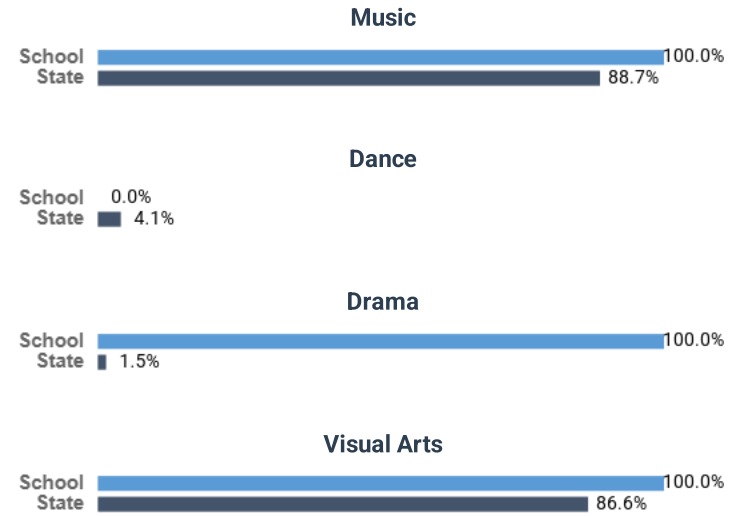

**Students enrolled in one or more classes by discipline:**





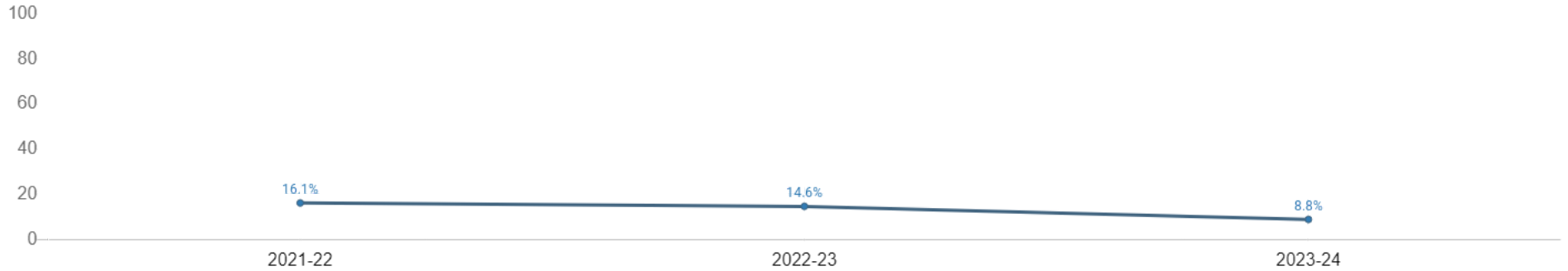

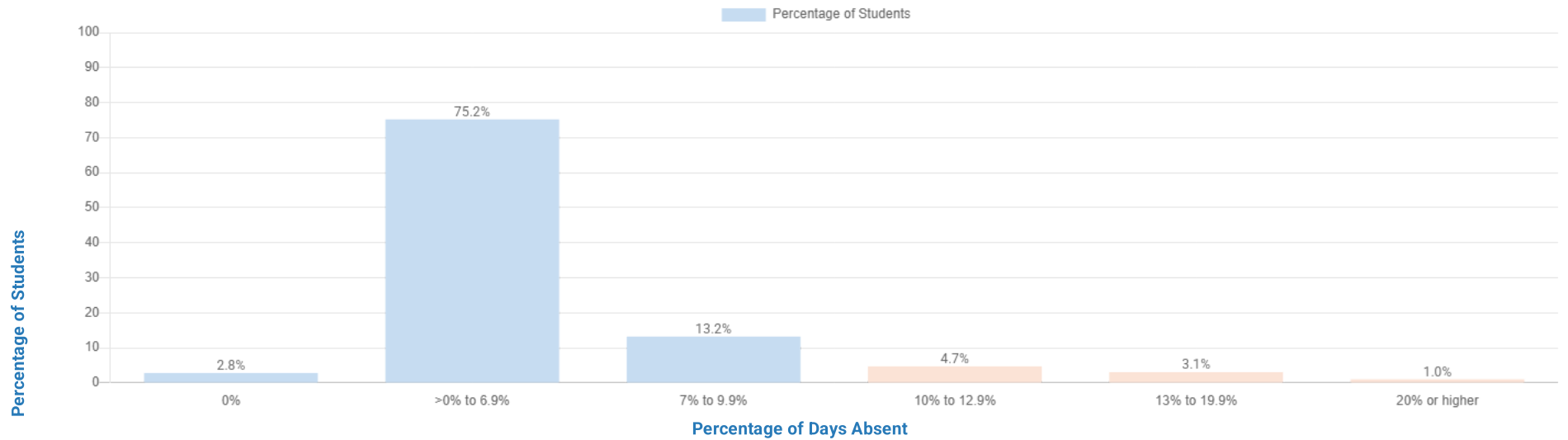

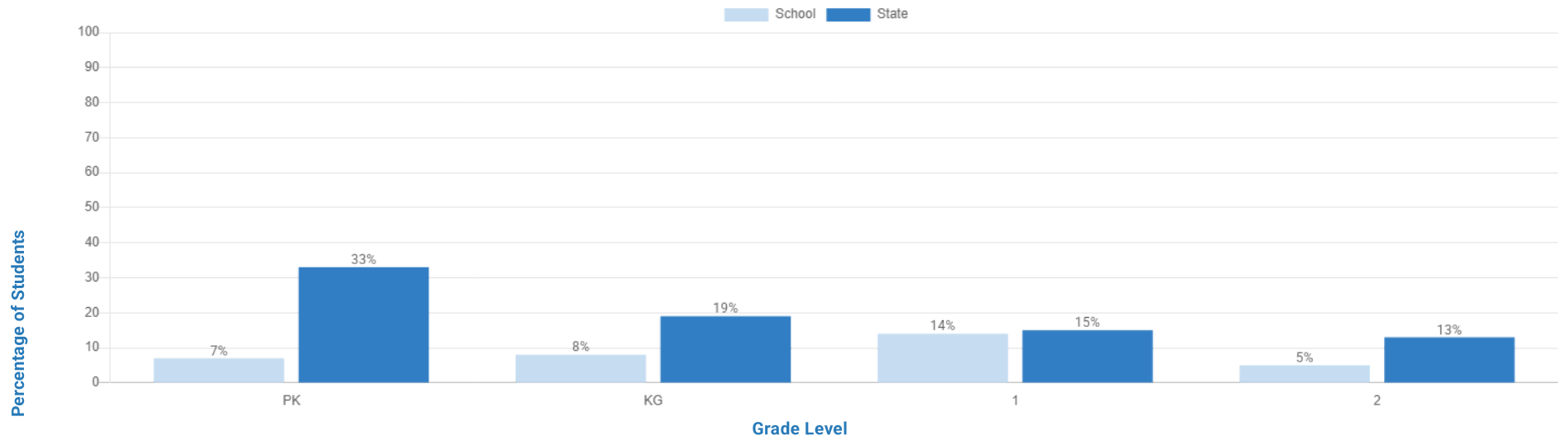

ELA: Best practices aligned to the Science of Reading utilizing the Core Knowledge Language Arts (CKLA) program. Mathematics: GO Math! develops conceptual understanding through daily problem-based interactive learning and the mathematics workshop model. IXL is implemented for both ELA and mathematics. Science: The Next Generation Science Standards guide our science instruction through the Full Option Science System (FOSS). FOSS is a research-based science curriculum, which provides tools and strategies to engage students. Social Studies: Implementation of the district curriculum and supplementary programming. Related Arts offerings include: Physical Education, Art, Music, Technology, Mandarin, and Drama. Our students use IXL throughout the year. In addition, students are assessed using Acadience. These assessments are administered three times per year, along with progress monitoring. Data informs instructional support and targeted skills for our learners.



### Clubs and Activities:

"Aesthetics: Our magnet theme catalog includes a variety of courses. Families can select from a wide menu of courses; some of which we refer to as "Aesthetics." These courses are designed to allow children to explore a range of areas. As interest and skills develop, students discover what they like and can work on developing their strengths. Creative I: Other courses that we refer to as "Creative I" provide more exploration opportunities and add to an enriching experience at Nishuane School. Participation in these courses requires that children qualify through a screening process. Screenings are conducted each year in late spring. Families will receive individual schedules, reflecting acceptance, by September of the new school year. All children in first and second grade have Aesthetics and/or Creative I classes for three cycles. "

### Staff and Professional Learning:

Our School Improvement Panel (SciP), comprised of staff and administration, informs and develops professional development opportunities for staff throughout the year aligned with district and school goals and also with the staff evaluation framework. All teachers participate as a part of horizontally aligned Professional Learning Communities (PLCs) and vertically aligned Small Learning Communities (SLCs) that meet regularly and are focused on essential questions pertaining to student learning, data inquiry, and a comprehensive Multi-Tiered System of Supports (MTSS). Nishuane also has an Instructional Leadership Team, School Leadership Team, School Safety & Emergency Response Team, Climate & Culture Team, a School Threat Assessment Team, as well as New Jersey Inclusion Project (NJIP) site-based team. All Nishuane Faculty & Staff participate in district and building based professional development opportunities offered throughout the school year.



### Student Supports and Services:

Nishuane School is committed to providing a high quality, developmentally appropriate education for all students. Supports include 504 Plans, continuous support from the Student Support Committee (SSC), and Individualized Educational Plans (IEPs). Students with special needs are educated in the Least Restrictive Environment (LRE) to the maximum extent appropriate. Additionally, students are supported prior to referral to the Child Study Team by a Multi-Tiered System of Support (MTSS) and Student Support Committee (SSC) that provide a continuum of services.



### Student Health and Wellness:

Health and Wellness is a part of our School Action Team for Partnership to promote the social, emotional, and physical wellbeing of children. Students have physical education and health each week. Nishuane offers a wide array of activities throughout the year for health and wellness including caregiver workshops, Bike/Walk/Roll to School Day, My Plate, and a Health and Wellness Fair. We offer school breakfast and lunch through the school district's food services department. Nishuane also has a fulltime School Nurse and Student Assistance Counselor on the staff.

Nishuane School provides students with the foundational skills to develop their talents and interests to ensure academic success in a diverse environment; actively engaging families and partnering with the community. Our magnet program offers our children many opportunities to participate in a wide range of exciting areas of study. At Nishuane, we believe that children learn best in a positive and supportive learning environment. As students develop their social skills through learning experiences and interactions with peers and adults, we emphasize aspects from Responsive Classroom (practices that emphasize social, emotional and academic growth) and Bucket Filling (a classroom program reinforcing kindness and respect among students) for our positive behavior model. The Special Nishuane Arts Program (SNAP) is an integral part of every child's academic experience. All students receive weekly instruction in music (vocal and instrumental), Physical Education/health, art, technology, and drama.
