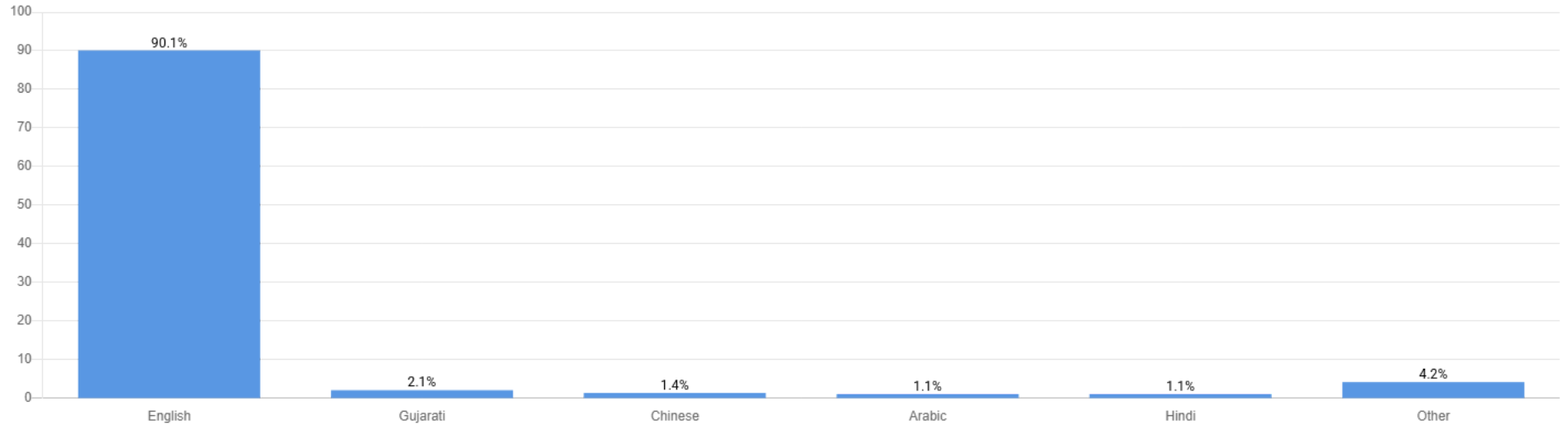

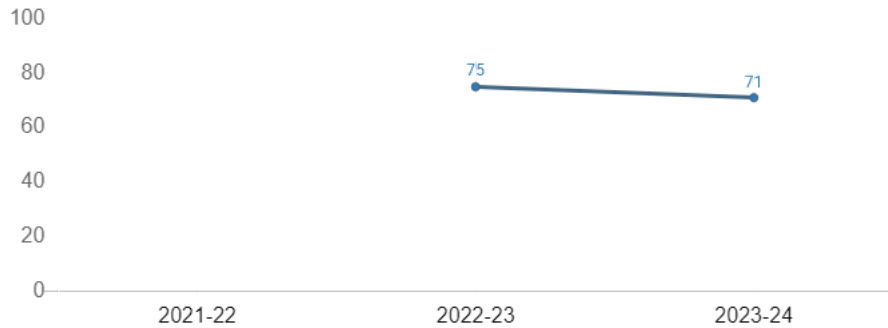

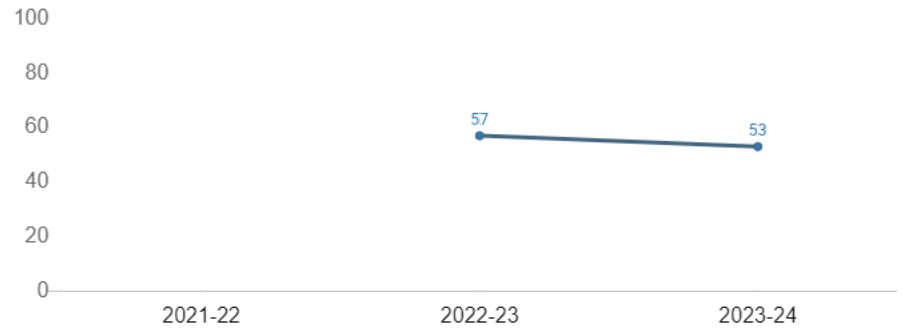

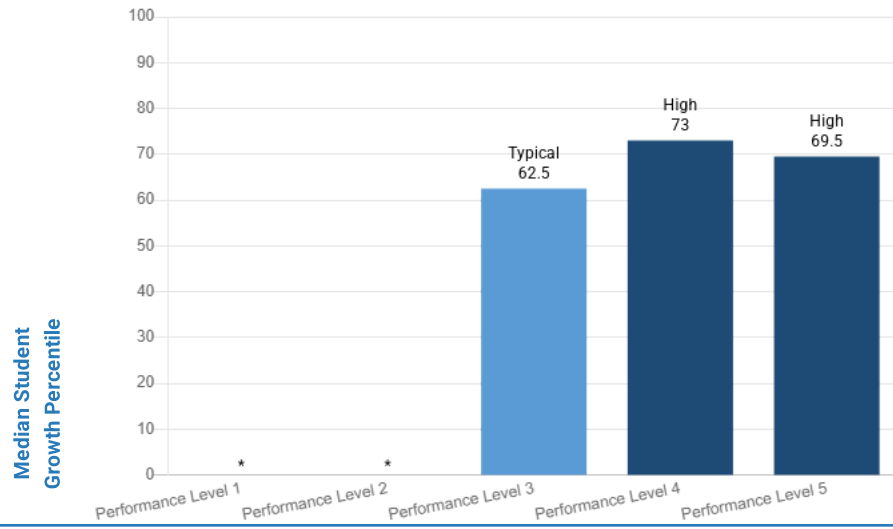

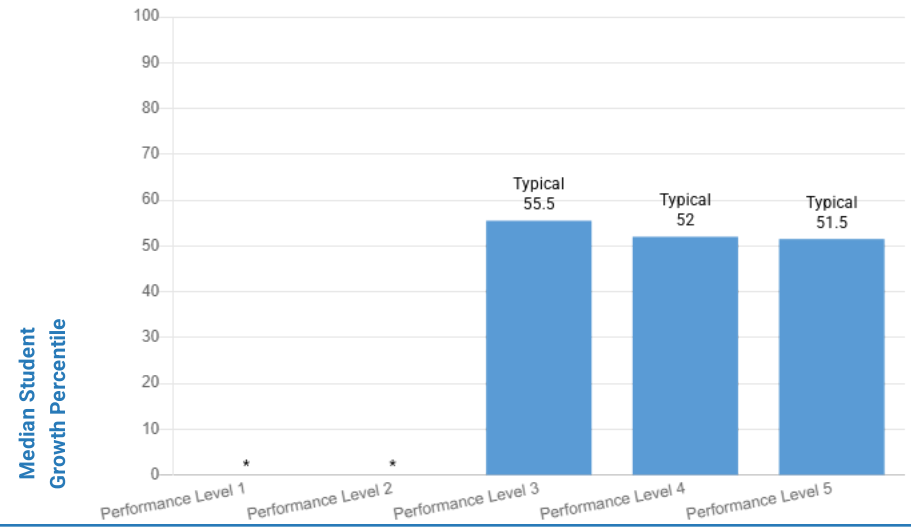

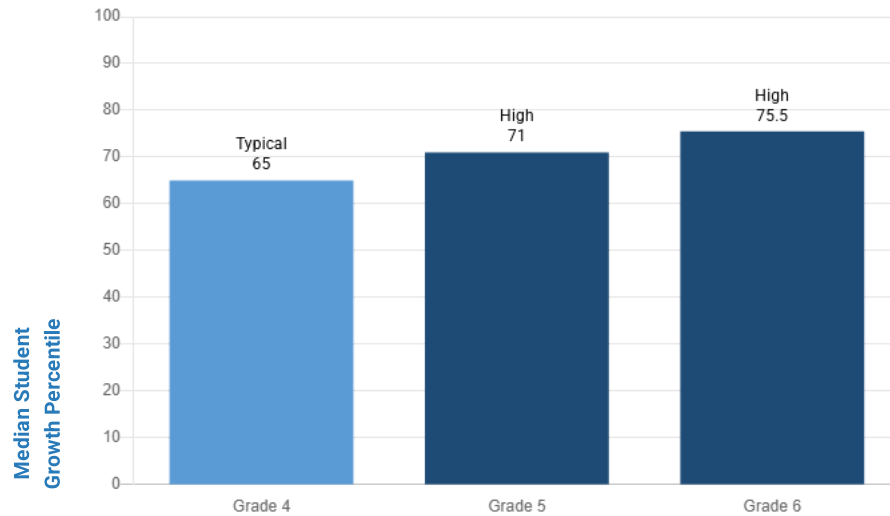

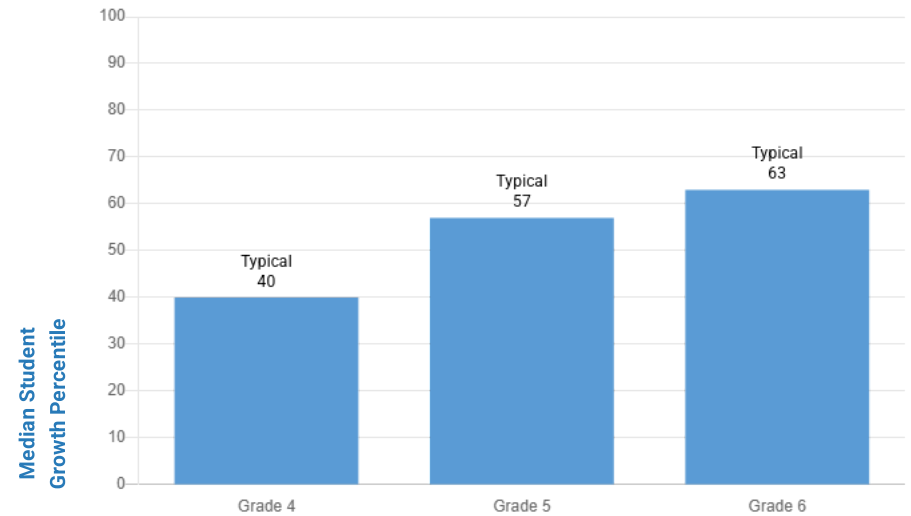

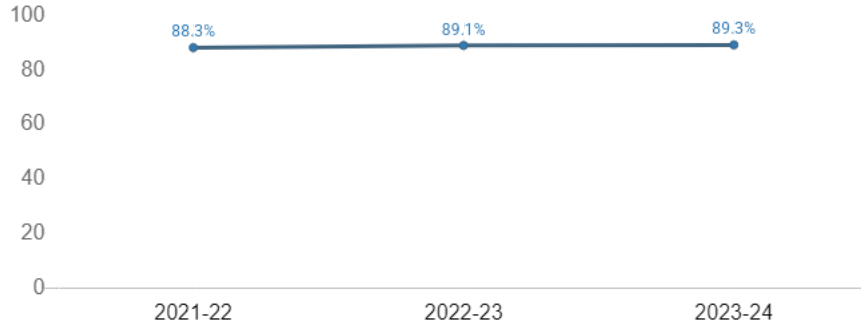

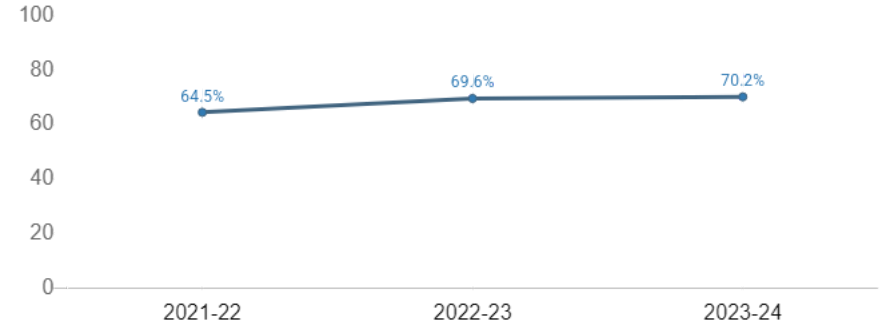
English Language Arts and Mathematics Performance Trends

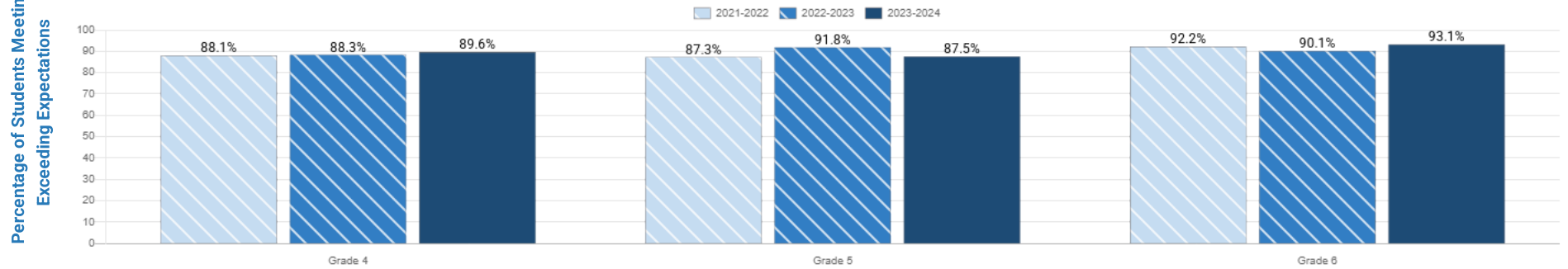

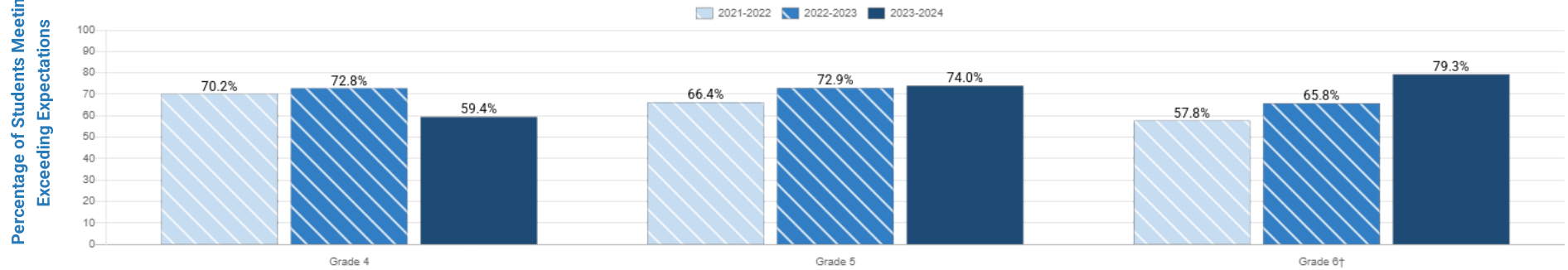

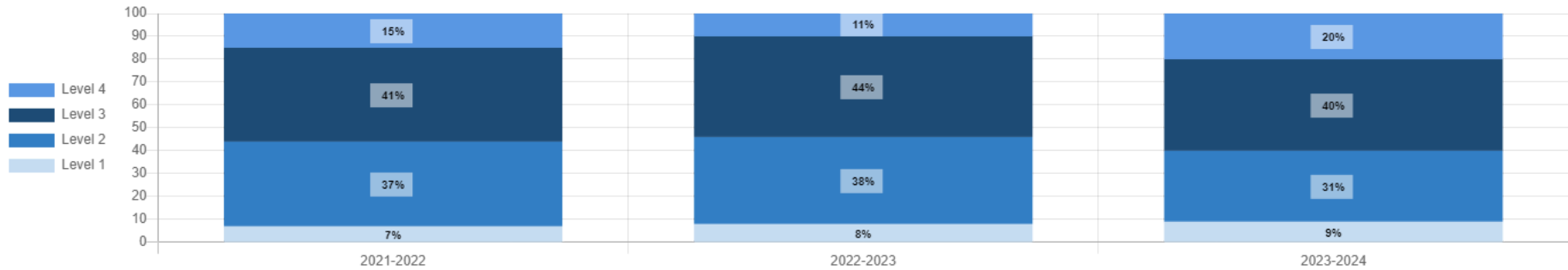

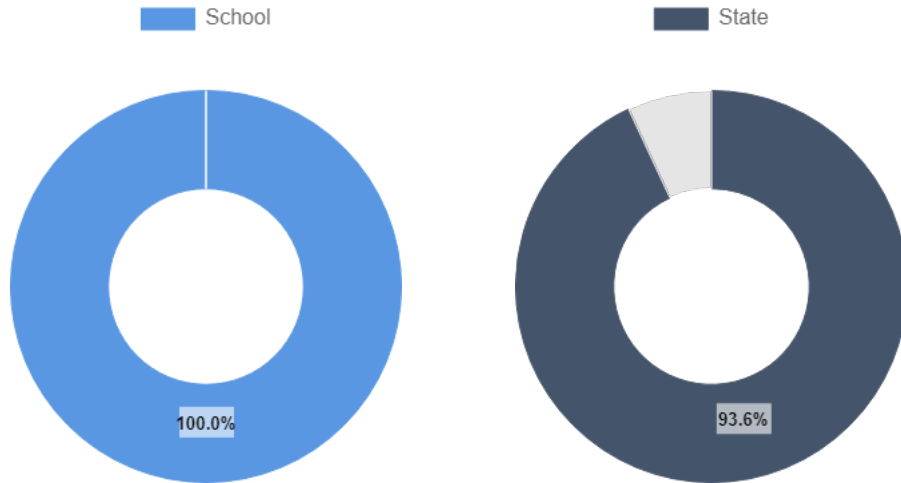

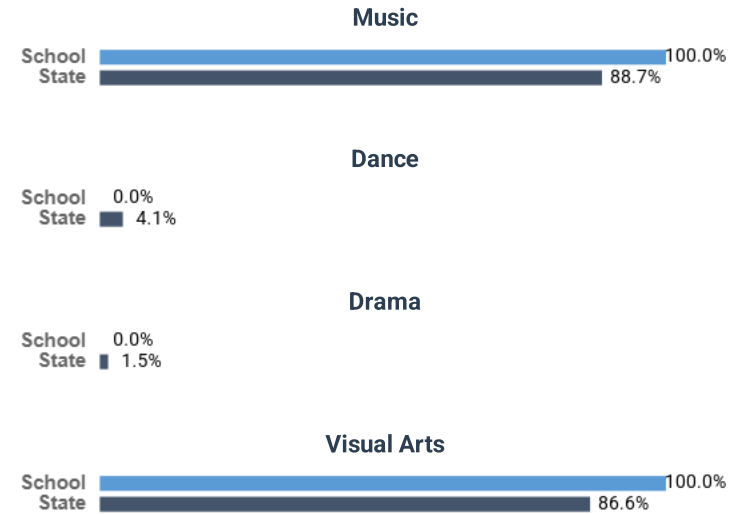

Students enrolled in one or more classes by discipline:



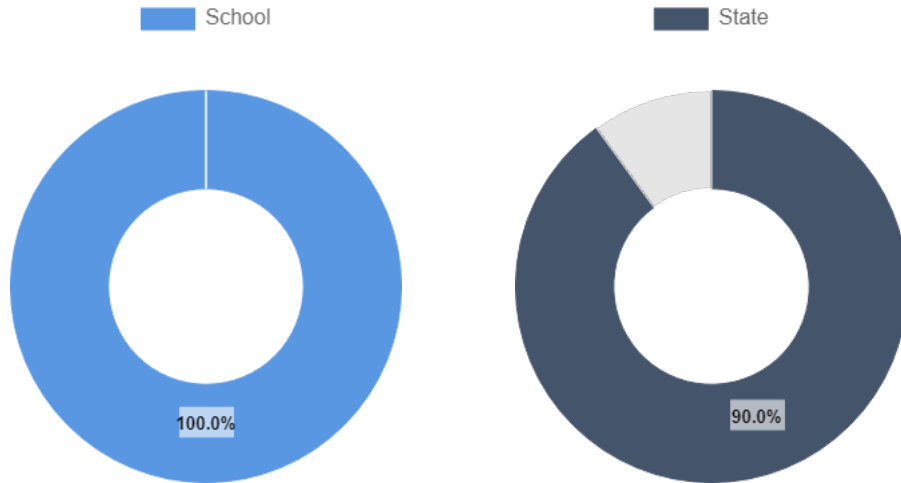

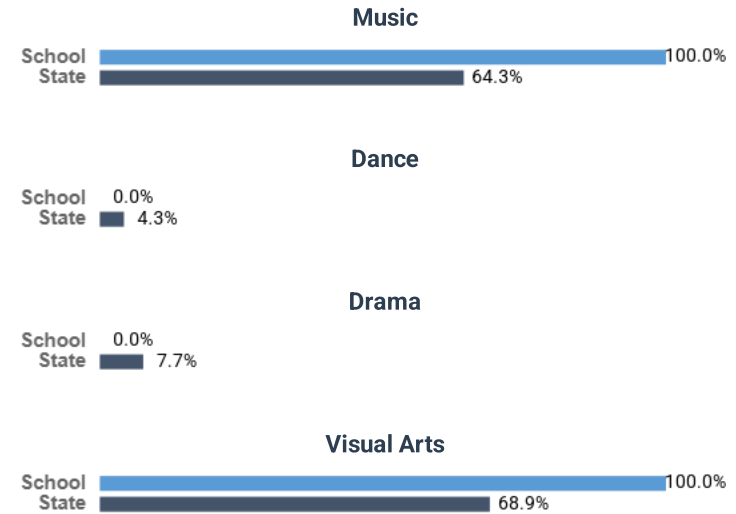

Students enrolled in one or more classes by discipline:



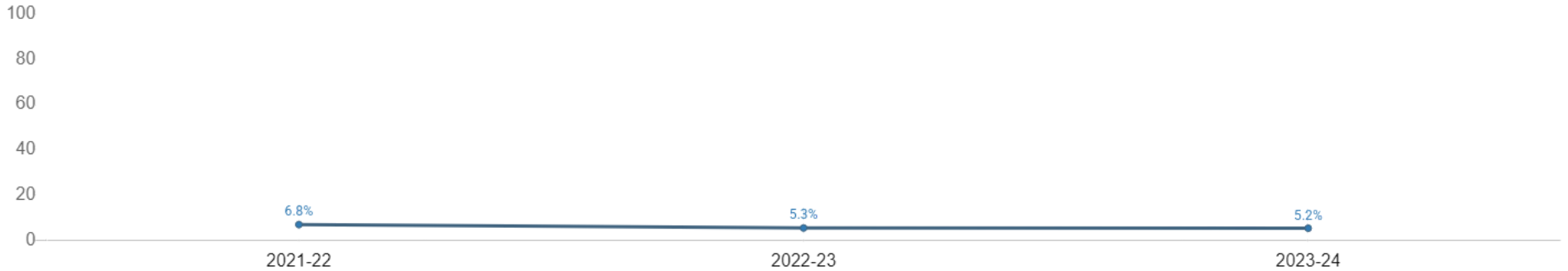

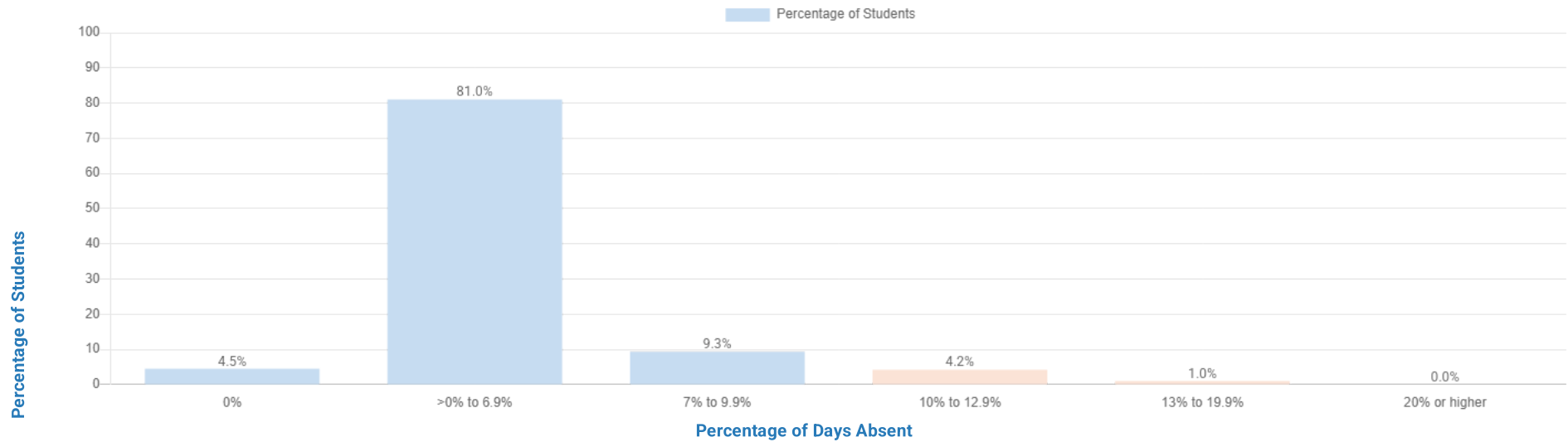

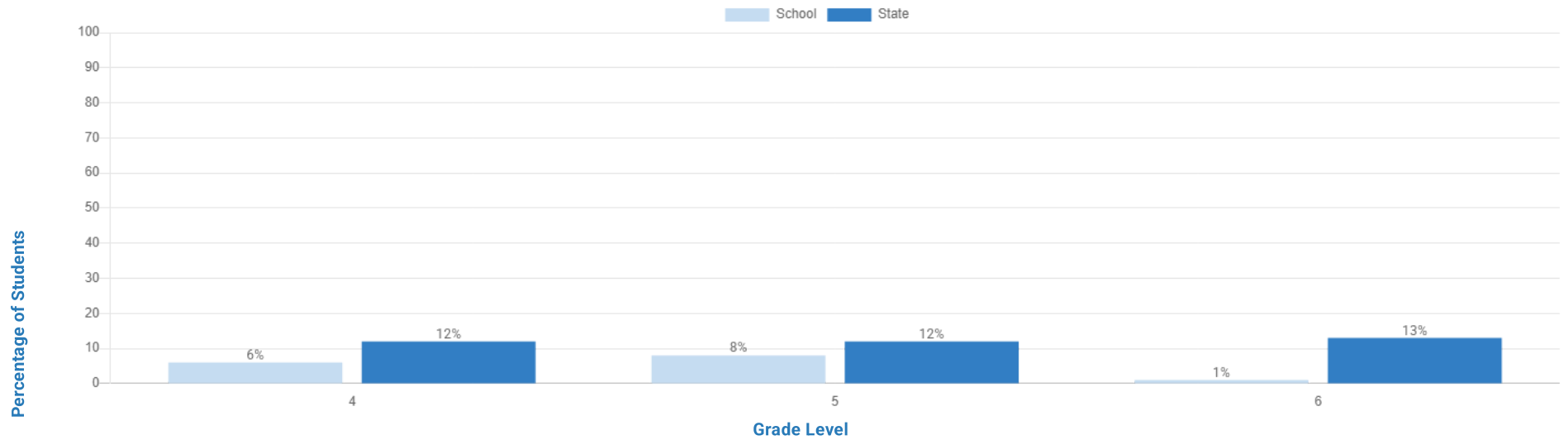

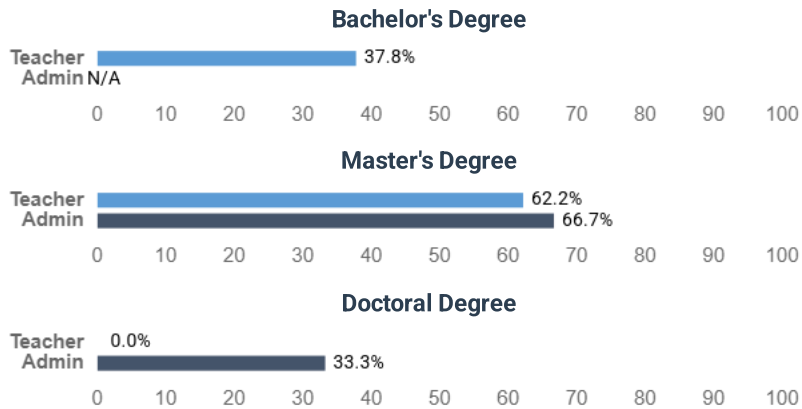

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Technology and STEM:

All classrooms are equipped with Smartboards Ladybugs, and Redcat audio systems. Additionally, all students are assigned a 1:1 chrome book. Students are provided with technology instruction one time per week in the Computer Lab. STEAM instruction is infused into all areas of the curriculum.
