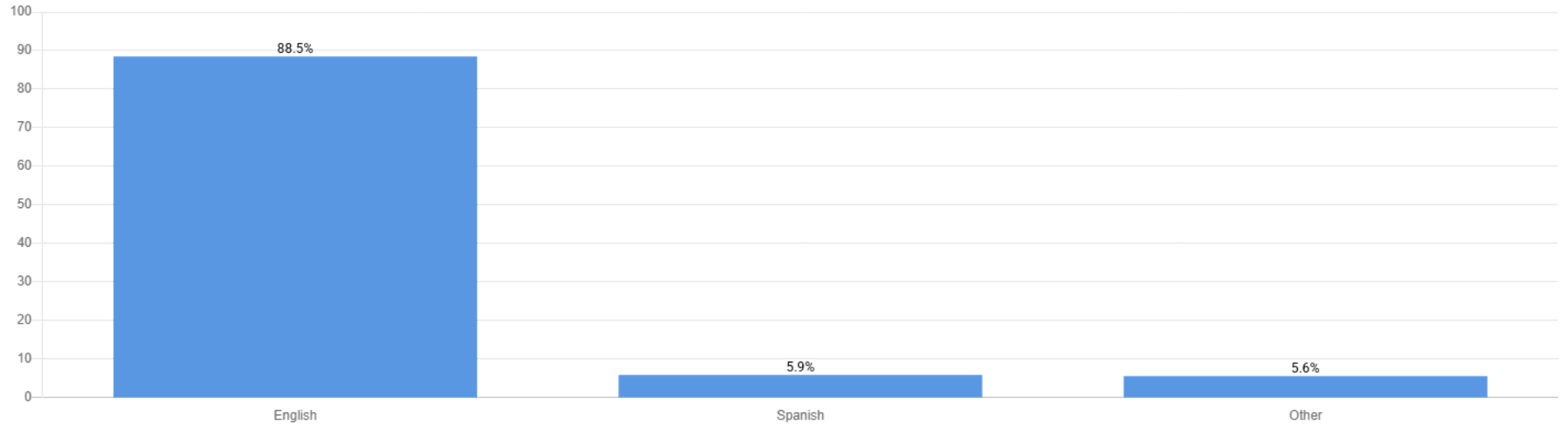

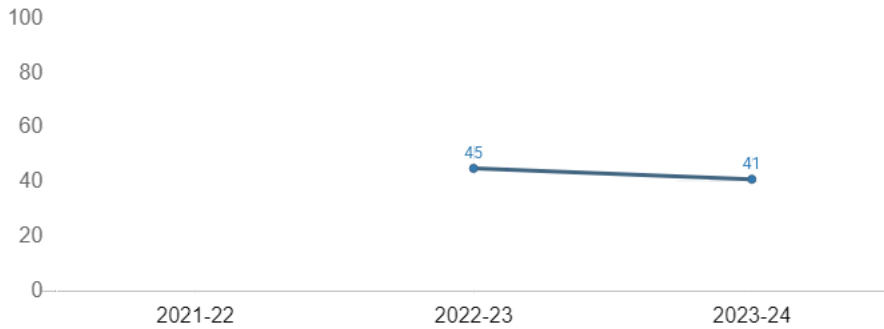

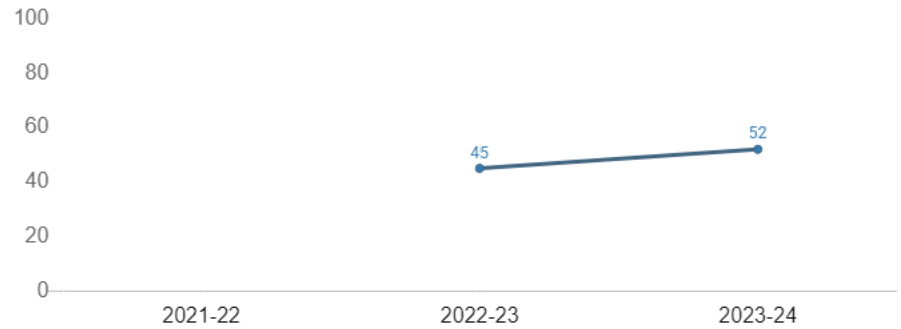

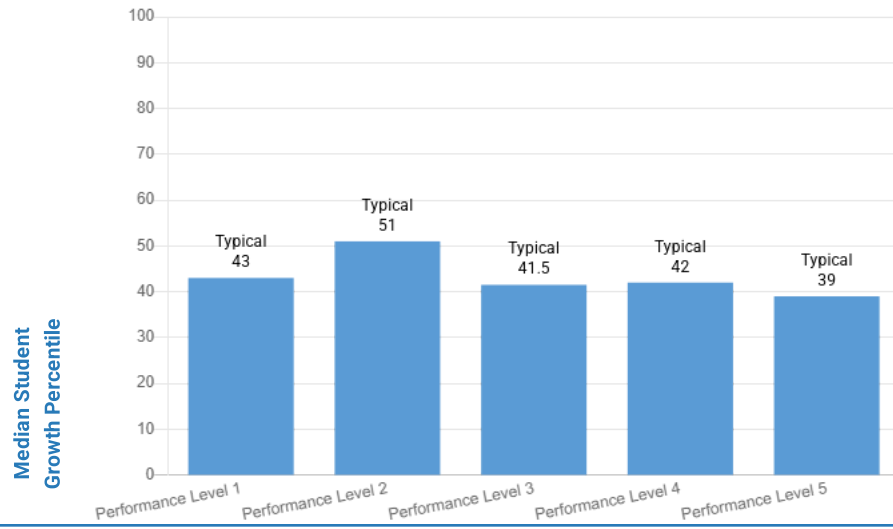

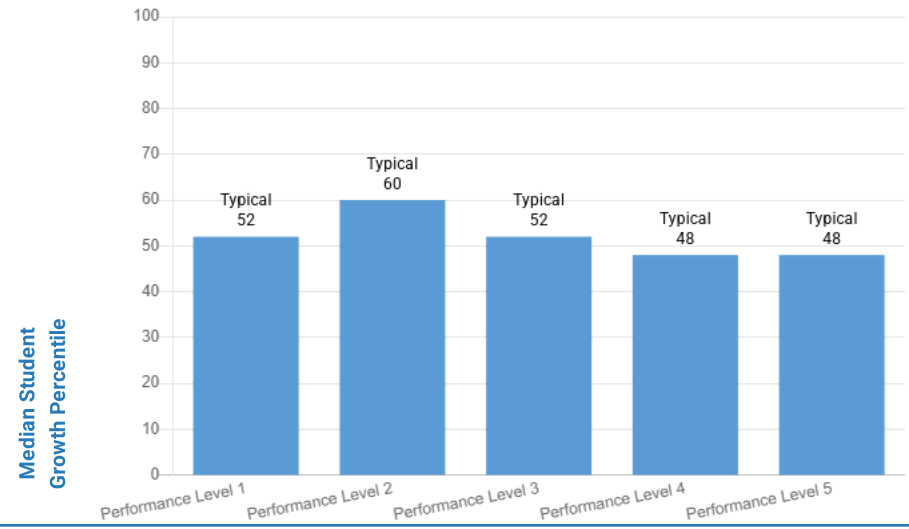

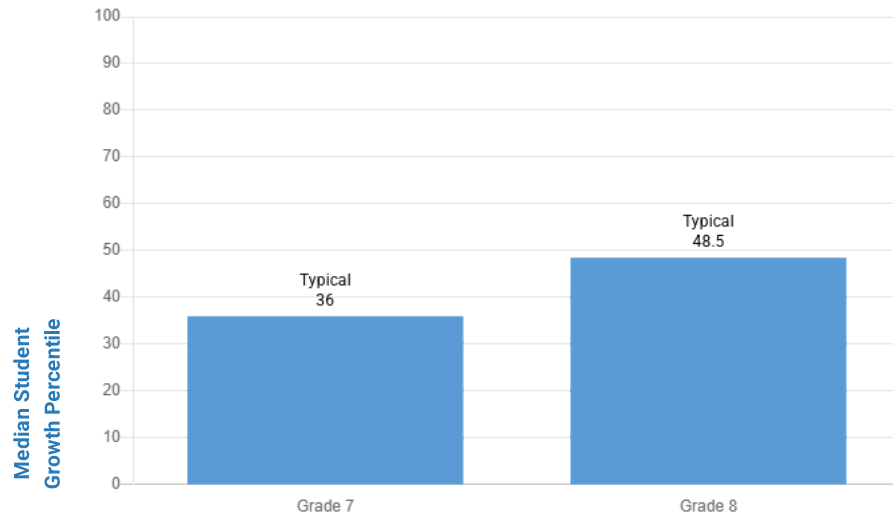

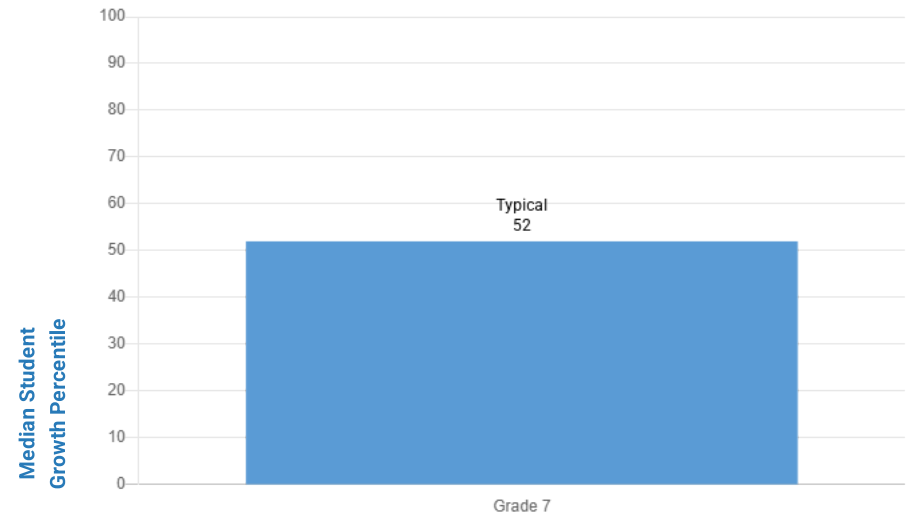

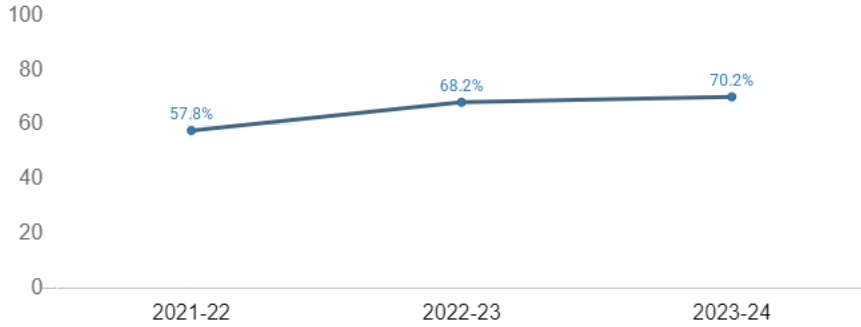

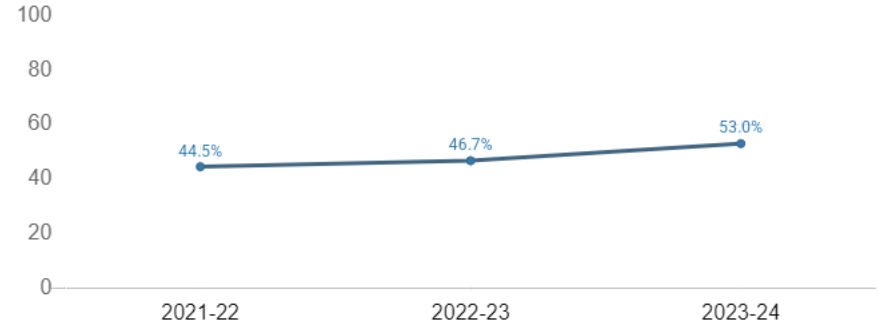
English Language Arts and Mathematics Performance Trends

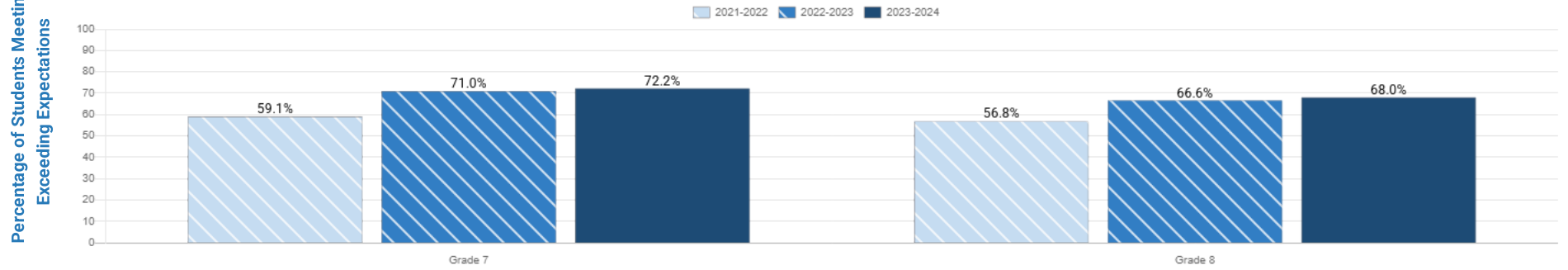

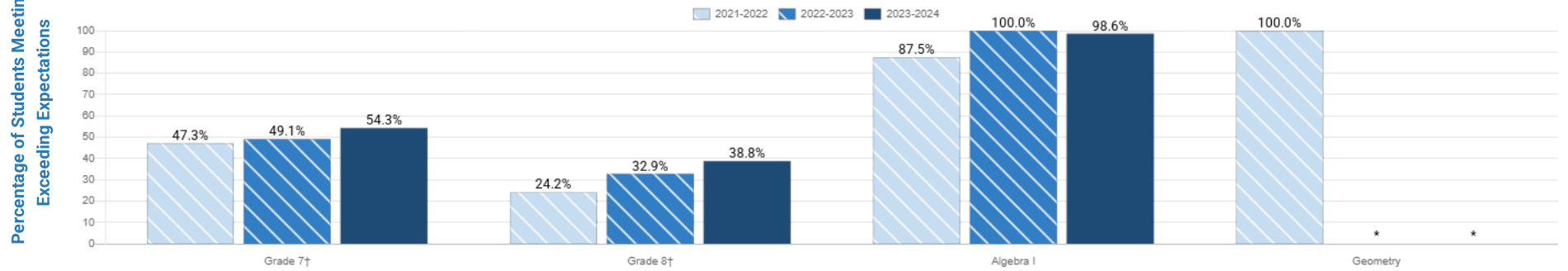

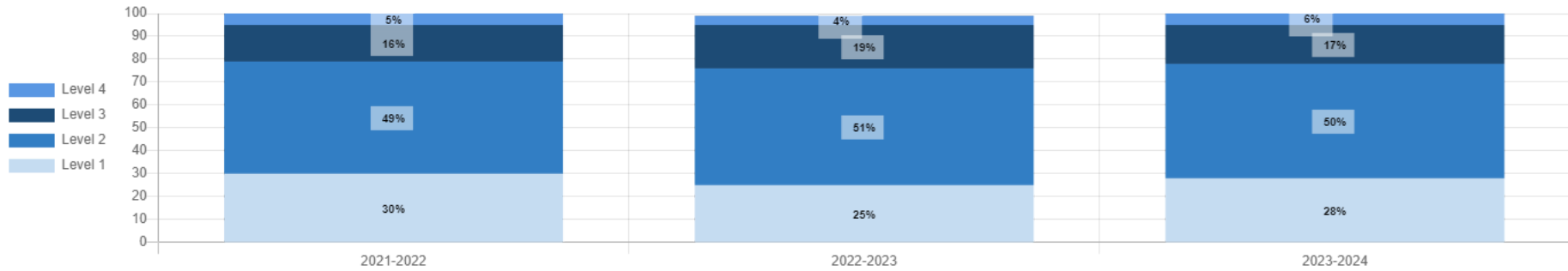

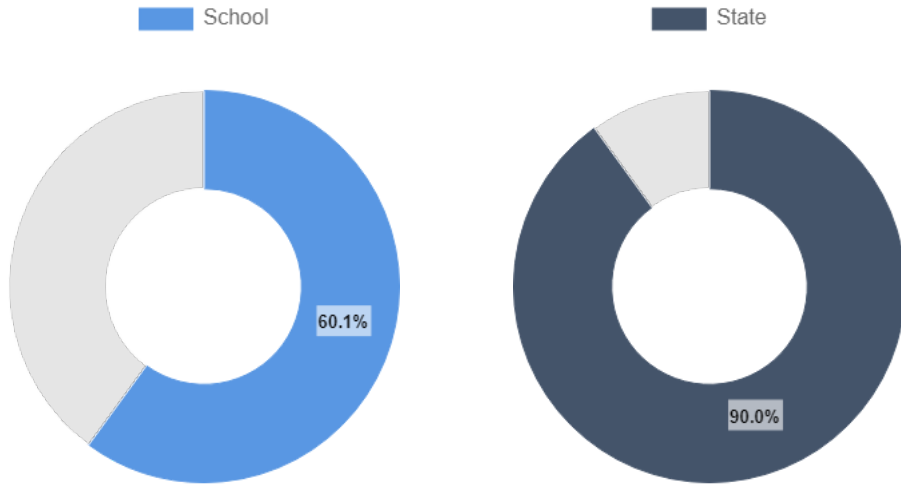

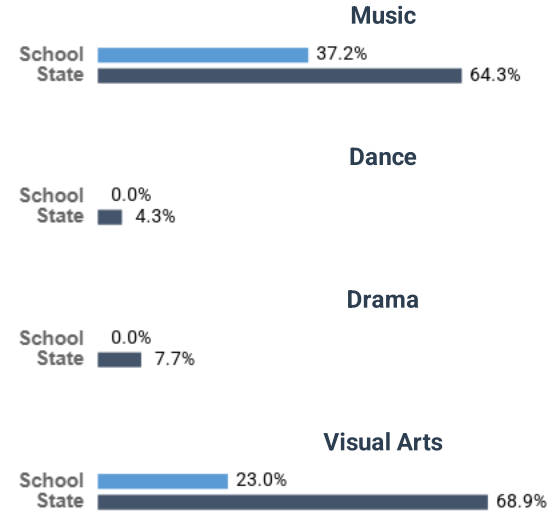

Students enrolled in one or more classes by discipline:



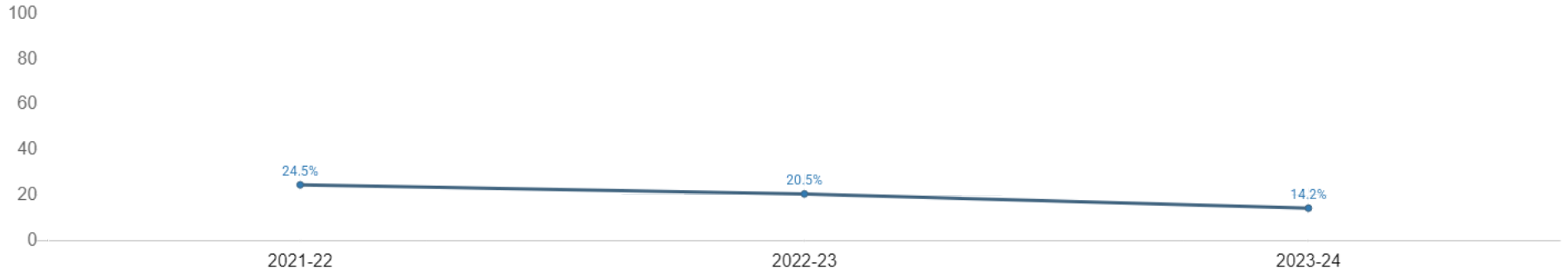
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

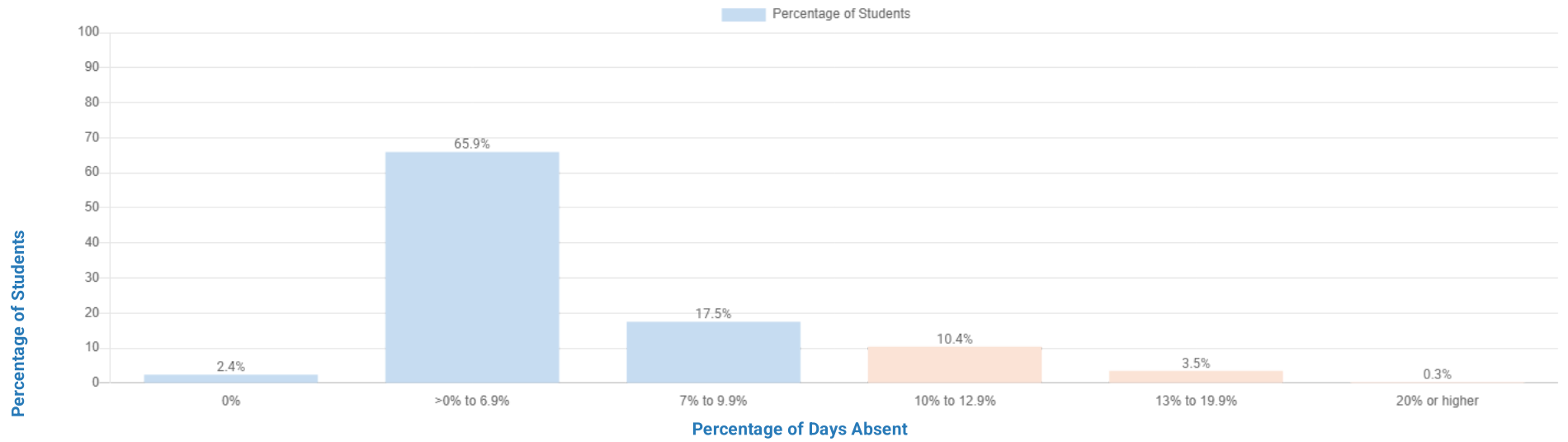

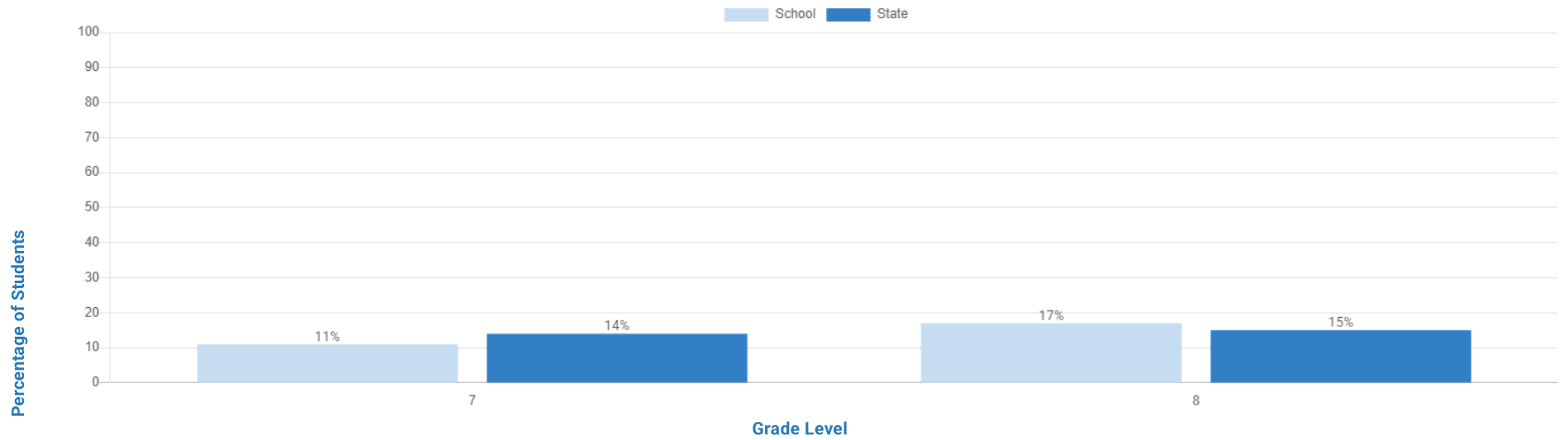

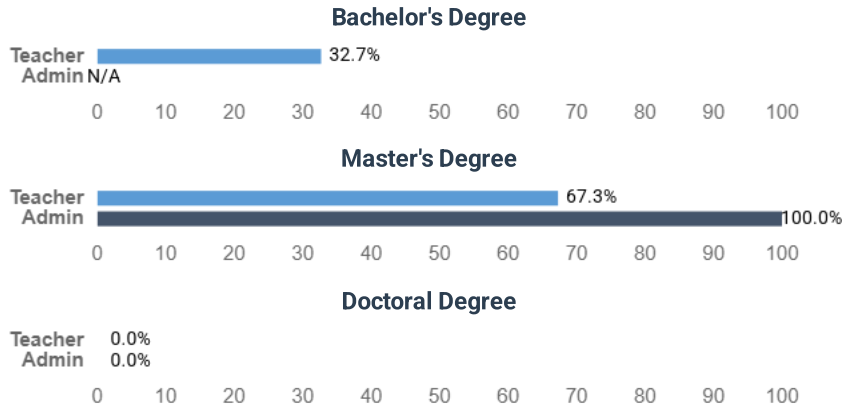

The curriculum includes a full academic program, as well as electives in fine and practical and performing arts. All students take a world language, physical education/health, and an elective in addition to math, science, language arts, and social studies.

Attendance:

JHWMS increased the frequency of excessive absences notifications in order to decrease chronic absenteeism. In addition, we also implemented the attendance action plan and attendance action plan meeting along with monitoring to involve the parents as well as teachers to support students. These meetings inform parents of frequency as well as specific areas of concern. For example, in most instances, the teachers and counseling department work with administration to identify how the attendance issues are affecting the student academically as well as social-emotionally. During the meetings, strategies are shared with students and parents as well as outside resources (if applicable) that can help address school avoidance. In most instances, an intervention plan is also created. Tracking of the students in question begins once the meeting is completed. At JHWMS, these students are discussed on a regular basis during admin team meetings as well as I&RS meetings and/or Team Meetings.
