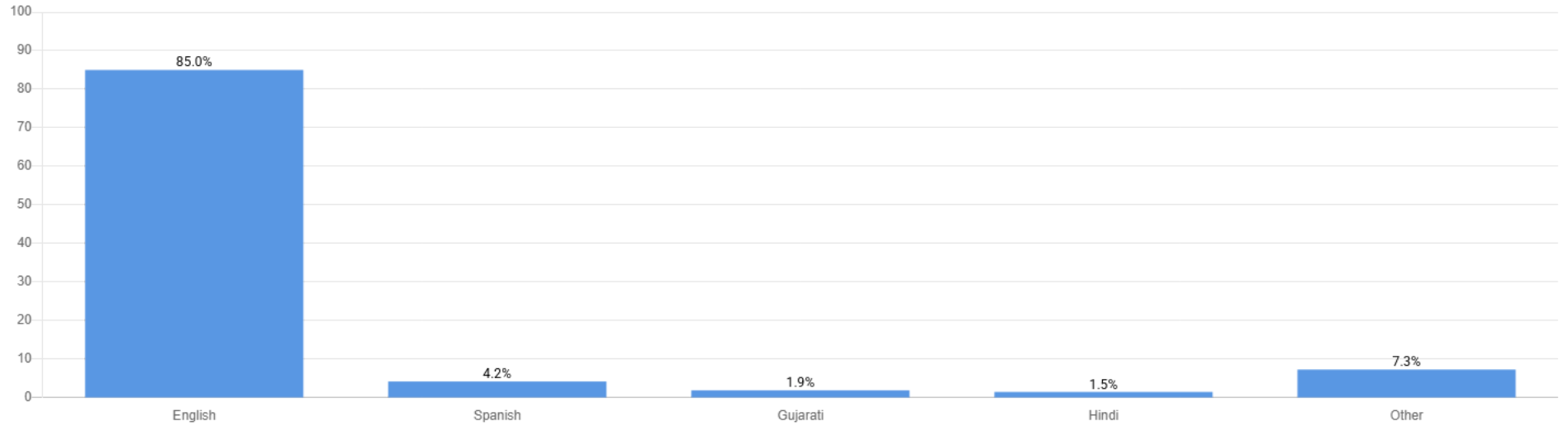

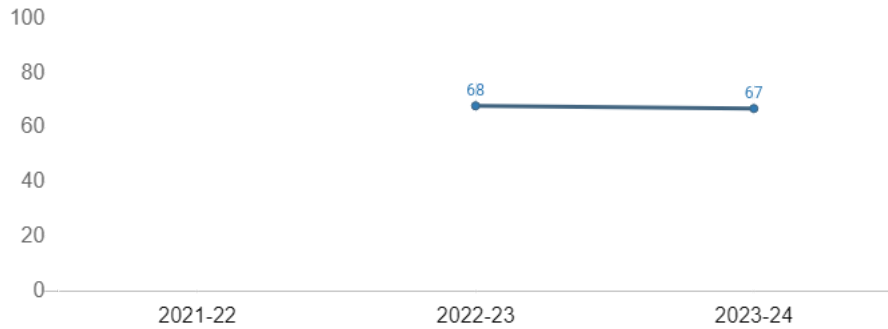

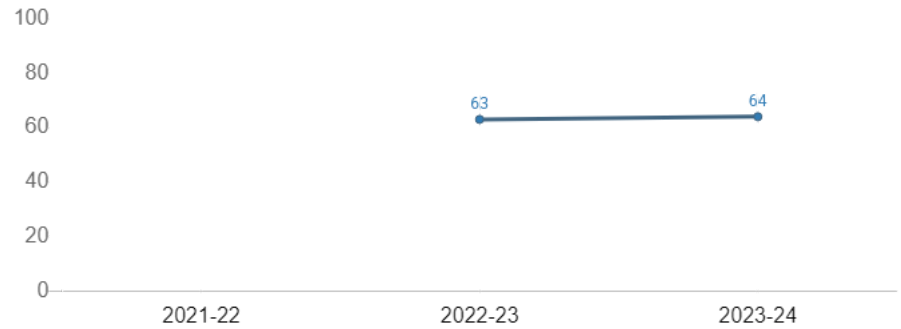

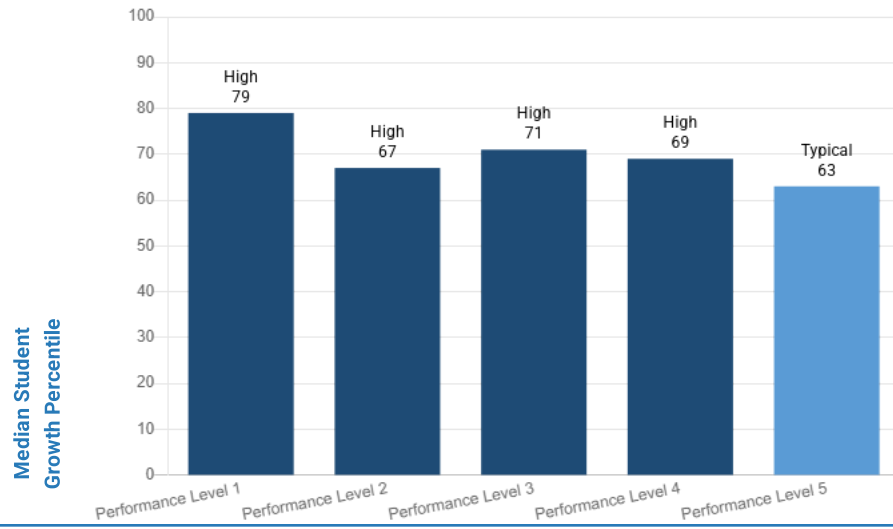

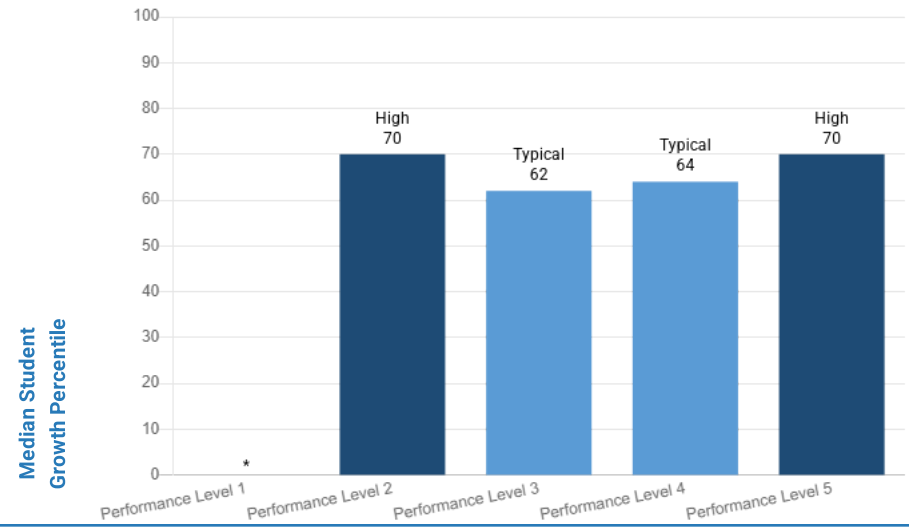

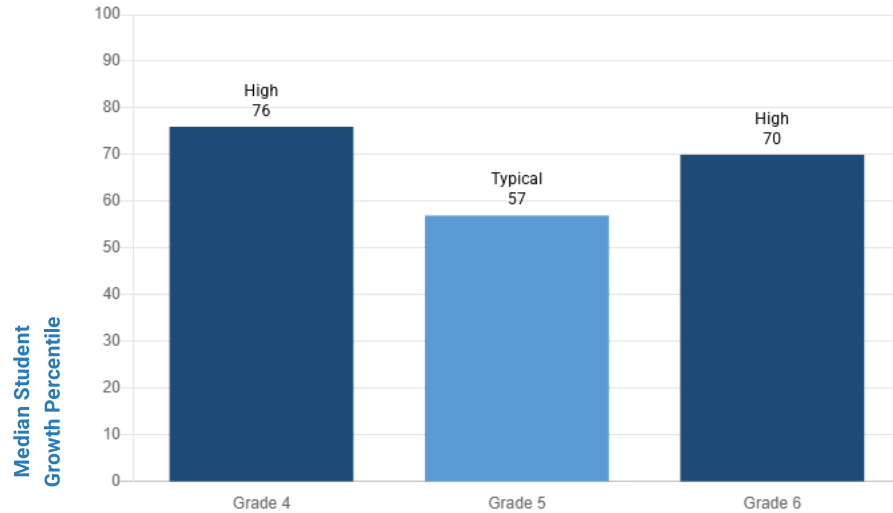

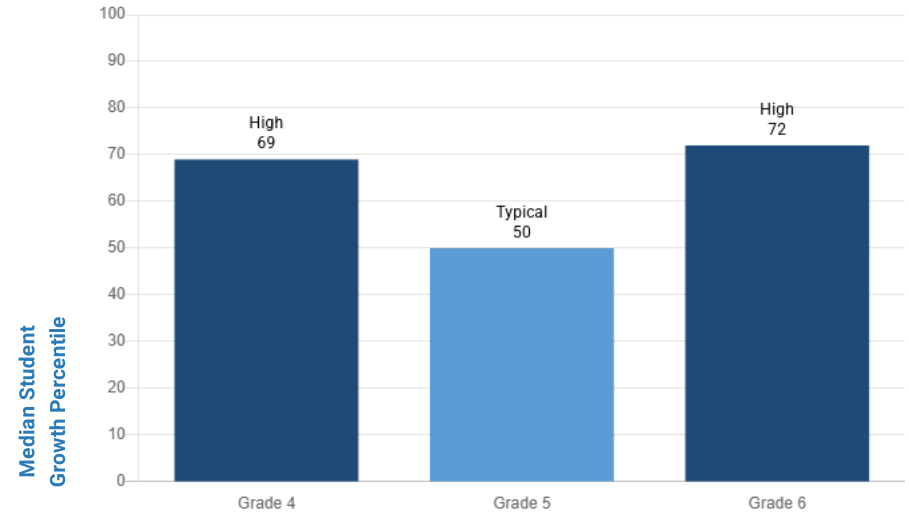

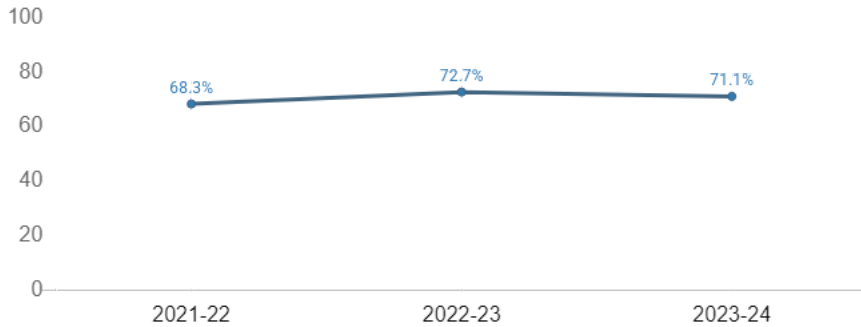

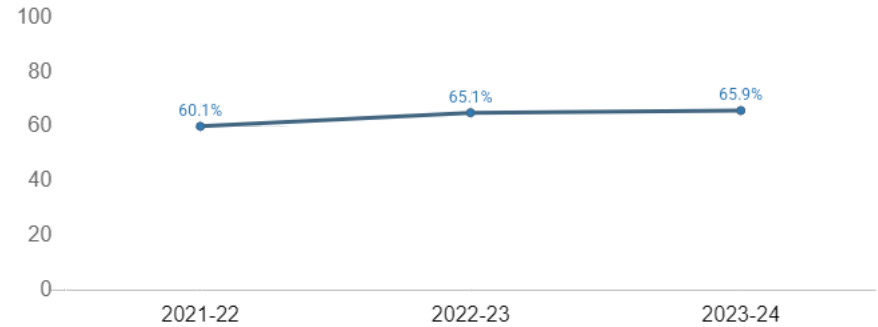
English Language Arts and Mathematics Performance Trends

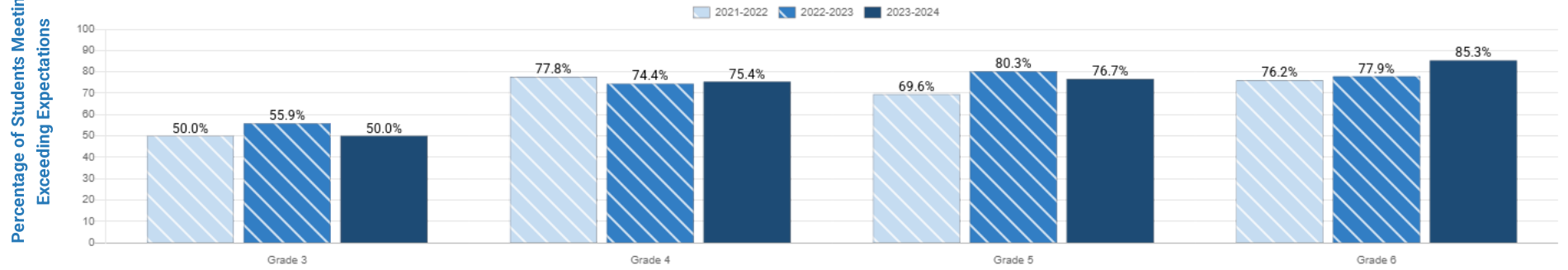

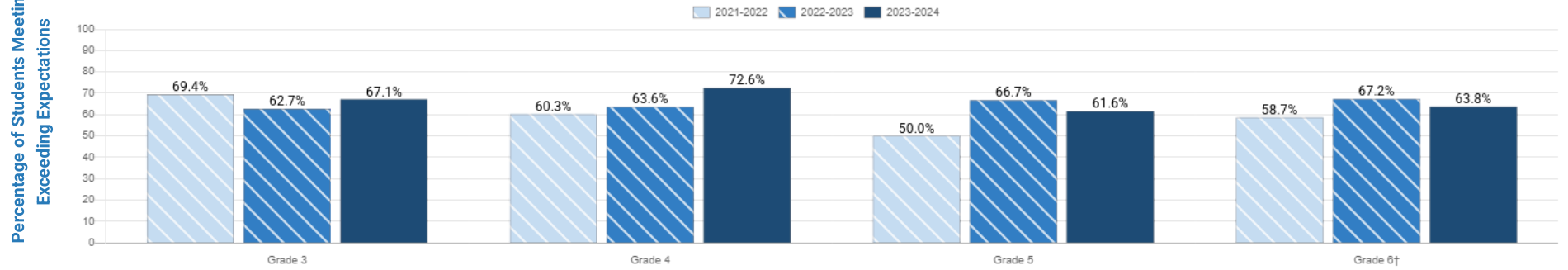

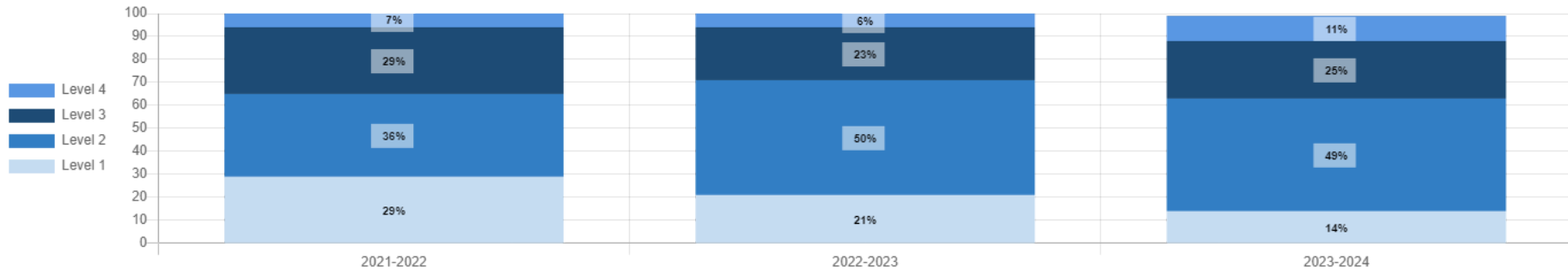

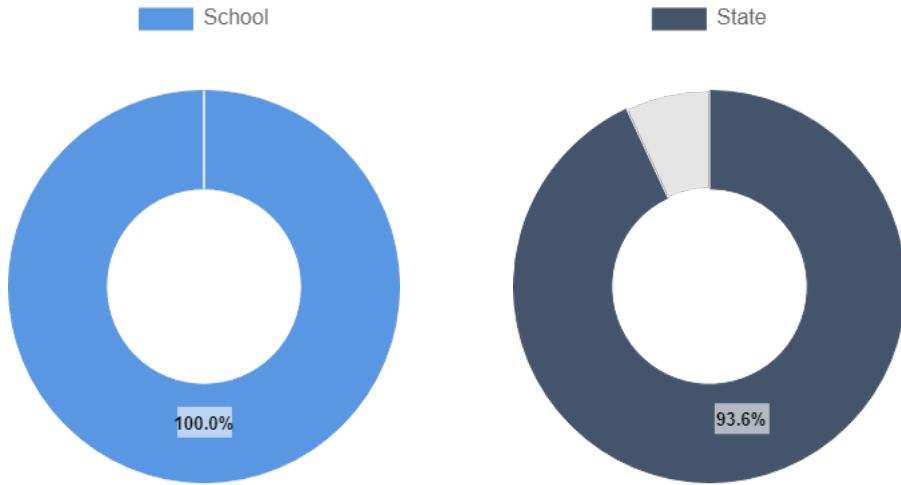

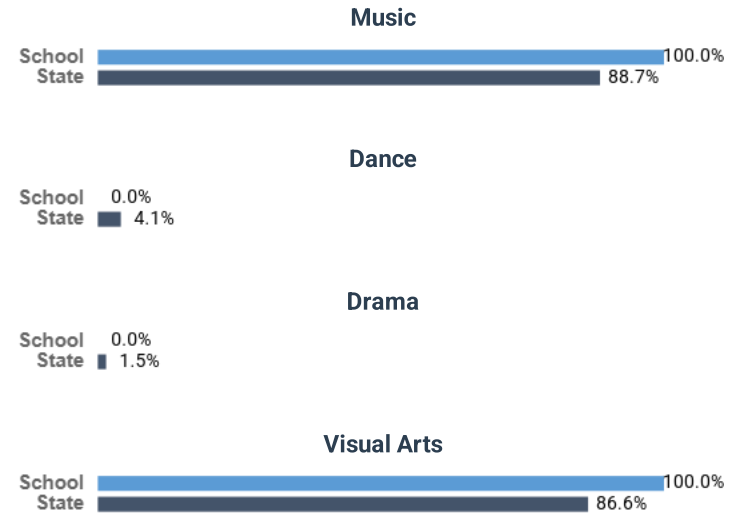

Students enrolled in one or more classes by discipline:



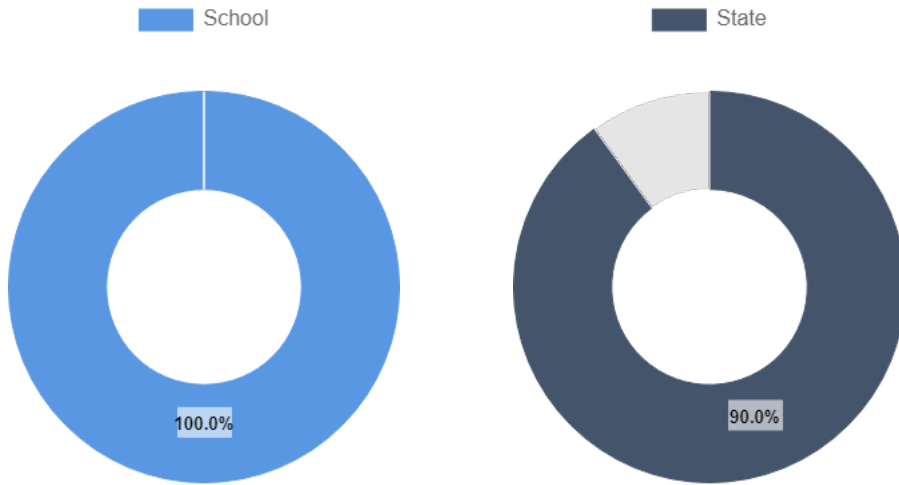

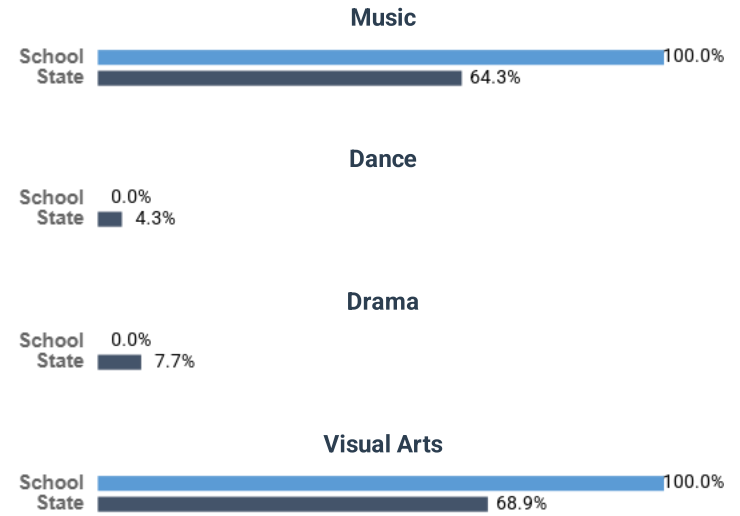

Students enrolled in one or more classes by discipline:



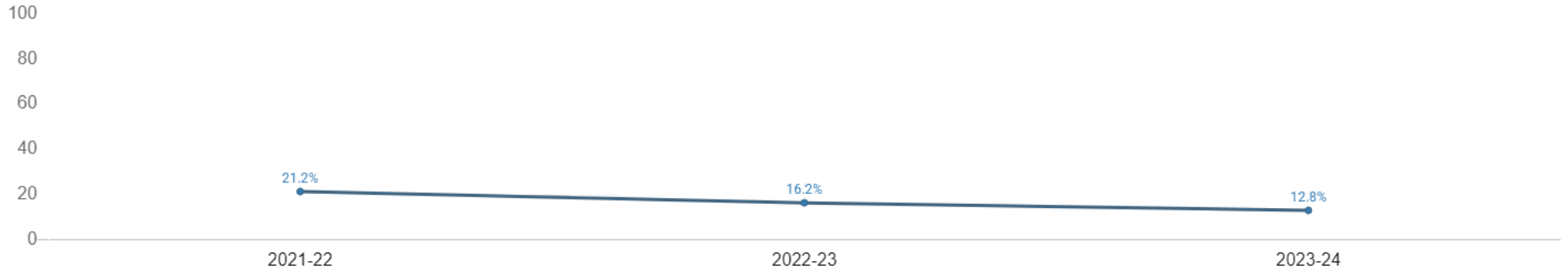

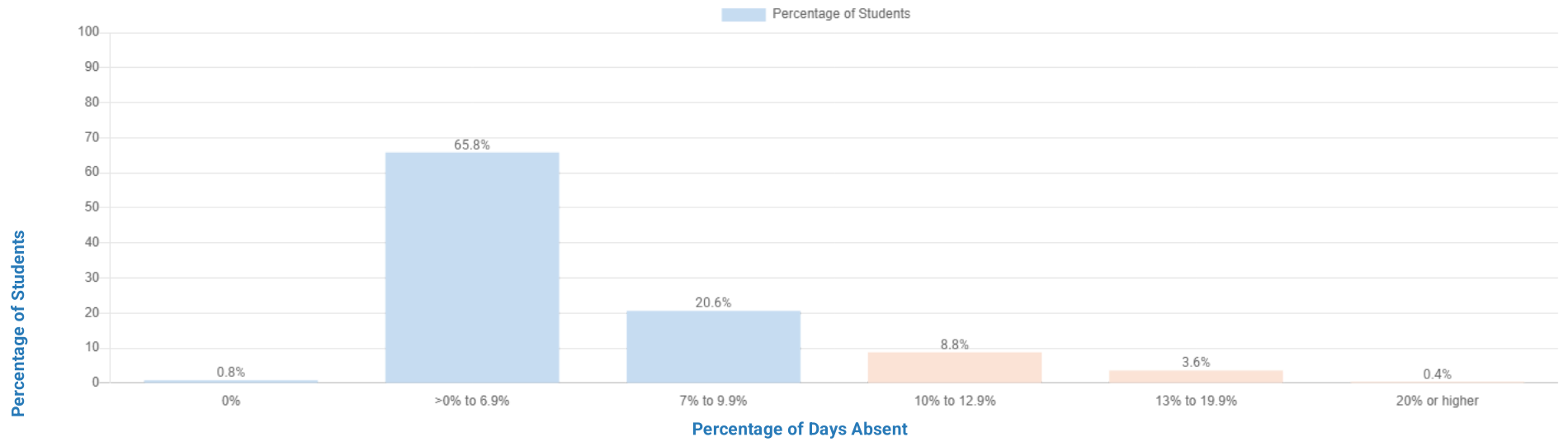

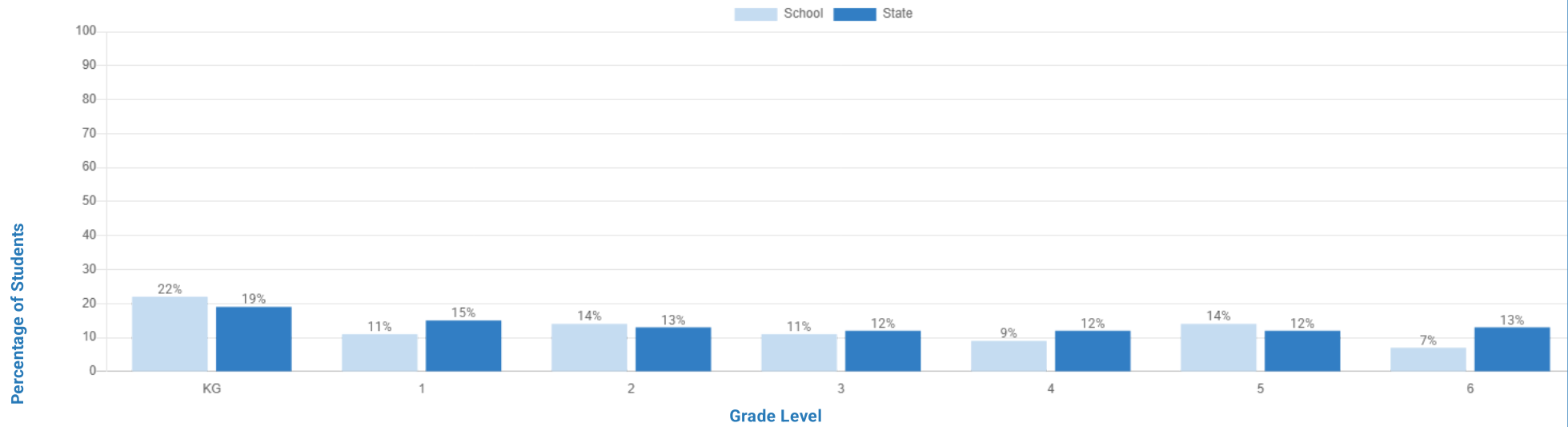

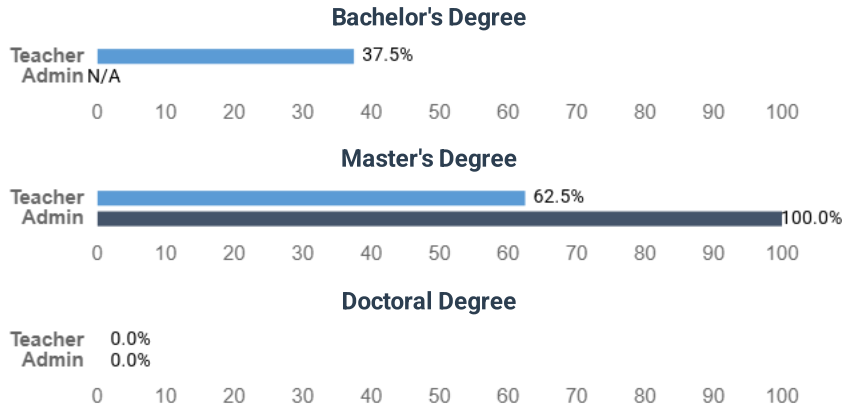

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. The mission of the Nutley Public Schools is to challenge, inspire, and empower students to become creative, confident, passionate, self-directed citizens who actively and purposefully contribute in our global society. The Nutley Public School system is a sustainable, integrated, efficient, and innovative school district that serves as the unifying and driving force in the community; By June 2025, the district and Yantacaw School will define and describe a consistent approach to behavior and attendance, based on situational and developmentally appropriate best practices that include preventative, supportive and corrective accountability. The Yantacaw School faculty infuses current instructional strategies, methods, and materials into all subject areas which include the following: Language Arts, Math (Math in Focus), Mystery Science, Social Studies, Art, Physical Education, Music, Media Center/Library, Instrumental Music, Choir, Health (including SEL), Spanish, Resource replacement Language Arts and Math (special education), In-class support Language Arts and Math (special education), ESL, Leveled Literacy Intervention, Math strategies (Math Bridges program), and Gifted and Talented. The Computer Technology curriculum provides our students with a wide range of application programs and websites that correlate with, and enhance student learning.



Sports and Athletics:

Students in Grades 5 and 6 participate in the local Third Half Club Basketball Tournament in March. Students in Grades 5 and 6 also compete against their peers from the other district elementary schools at the Junior Olympics in the Spring, hosted at Nutley High School. Students have opportunities to participate in various sports through the Parks and Recreation department.



Clubs and Activities:

Yantacaw School offers a variety of clubs to all grade levels which include: Student Council, Creative Writing club, Gaming club, Safety Patrol, Military Fan Mail club, Math club, STEAM club, and the Creativity club. Facilities:

Yantacaw School was built in 1902. The school has a dedicated auditorium, gymnasium, art room, music room and library media center. The building is equipped with heat, air conditioners and air purifiers. The lower field is used for recess as well as outdoor physical education instruction.



School Safety:

Students and staff wear identification badges throughout the day. Fire and security drills are held monthly. Security cameras are installed inside and outside of the building. Yantacaw School has a secure front entrance with a Raptor identification system to check in and identify visitors. Outside doors are activated with a swipe system. Yantacaw has a School Safety team, staff safety training, HIB building coordinator, School Threat Assessment team, and a Resource Officer.



Technology and STEM:

When a student's absence reaches a warning number, a formal letter is sent to parents/guardians regarding the number of absences for the student. Following the letter, there is clear communication shared with the family about attendance and school work expectations. There is personalized positive communication to families when students are absent. We also have recognition for satisfactory and improved attendance. Through family communication, impact of attendance on the whole child is widely understood. Every child and their family is encouraged to develop a success plan that includes attention to attendance. Common community and school barriers are identified and addressed. An attendance committee, is available to support students and meet with parents as needed. Attendance strategies may include peer group connections or intensive tutoring may be offered. Attendance strategies may also be added to a Section 504 plan or Intervention and Referral Services plan.

Other Information:

The school day at Yantacaw School runs from 8:30-3:20 with a one hour lunch. Communication with parents is ongoing through email, SchoolMessenger, the school website, PTO Announce, the PTO Toolkit, and the PTO Facebook page. Many teachers utilize the Remind app, and Schoology to inform parents of upcoming events and activities. Critical thinking, problem-solving strategies, problem design and the fundamental skills to support integrated instruction are included across content areas. Our guidance counselor provides lessons on conflict resolution to small groups, as well as to the whole class.
