




### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 















New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.









### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. ### Before and After School Programs:

Columbia High School has partnered with Family Connections to create the Loft, a school-based youth services program. The Loft is a safe space for all CHS students that offers afterschool recreational trips, community-building, employment counseling - resume building, interview skills and job search assistance, post-high school planning, and individual, group and family counseling provided by a licensed mental health professional.



### Staff and Professional Learning:

A group of students attend MSAN's (National Minority Student Achievement Network), annual student leadership conference to network with other diverse schools across the country and to bring back action plans, leadership, and best practices for increasing opportunity and closing the achievement gap in our school. Faculty advisors and staff mentors then work with the students to lead study groups, school programming, and an AP Student-for-a-Day and informational one-day, student-led conference.



### Postsecondary Information:

Our Advanced Placement (AP) program fully prepares our students for higher education and career goals. Columbia High School offers a full complement of 22 AP courses, which allow students to enter most colleges and universities with advanced standing. The high school also administers AP examinations in courses not offered at the high school, including microeconomics, macroeconomics, and German. 75% of our students attended 4-year colleges and 8 percent attended 2-year colleges

We provide snacks for food insecure students in guidance. We have evening and daytime drug and alcohol prevention programs. One program of note was where we invited police officers to participate in workshops with students discussing town/student relations and had discussions about how to lead a healthy lifestyle.

Parents play a vital role in the school community. They are involved in the Cougar Booster Club, the Achieve Foundation, the Columbia High School Music Parents' Association (CHSMPA), the Home and School Association (HSA), and other organizations to raise funds and organize events that enhance the curricular and extracurricular opportunities for all students.

### Other Information:

In addition to our AP program, the district provides an opportunity in school each October for all sophomores and juniors to take a free PSAT. This allows all students access an early understanding of the college planning process as it relates to the PSAT and SAT, and to begin to have conversations with their families, teachers, and counselors about pathways to higher-level courses that will prepare them to be college- and career-ready upon graduation. We also offer our Cougar Prep Program to incoming ninth graders, which is a transitional, summer program that supports ninth graders as they prepare for their high school careers. Students are recommended from our two middle schools for participation in this program. This initiative invites students to a five-week program that includes instructional, social, cultural, and recreational components. The program partners with Family Connections, an Essex County non-profit organization that supports diverse families in this area. Upon completion of the Cougar Prep program, students are awarded 1.25 credits towards their high school transcripts.
