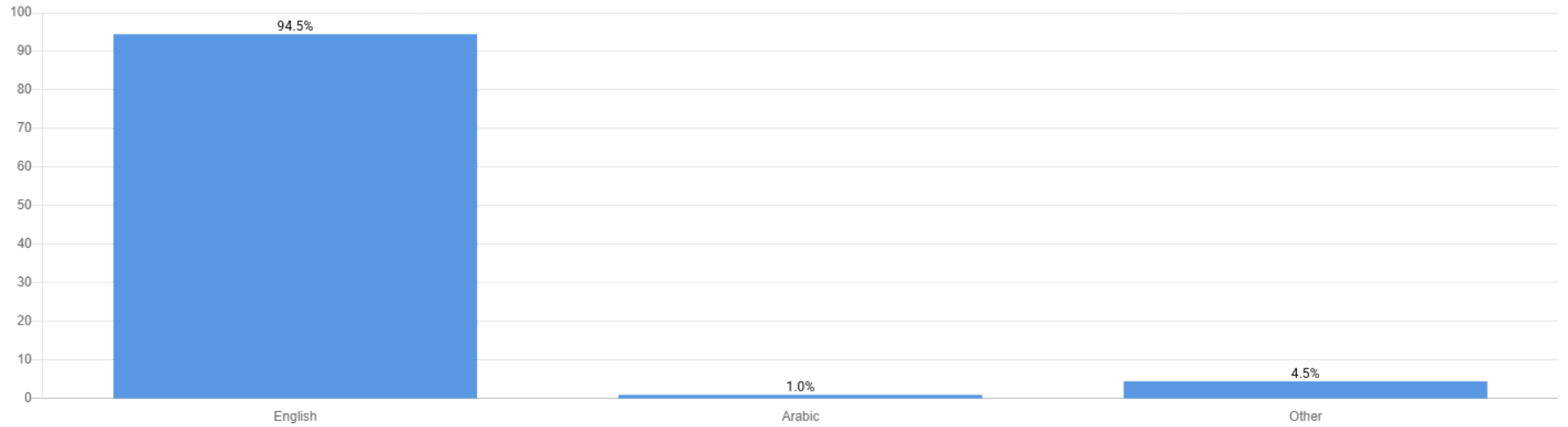

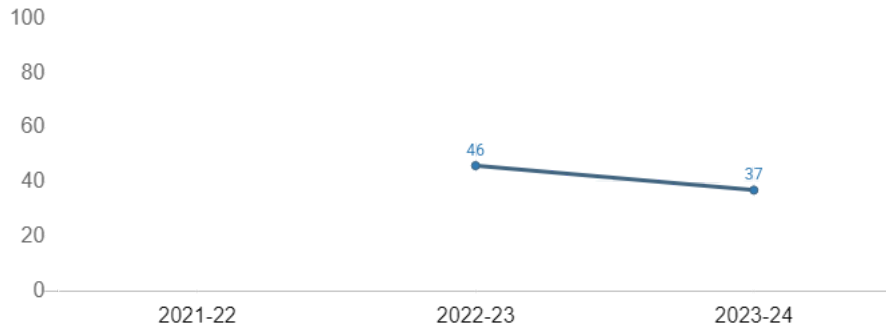

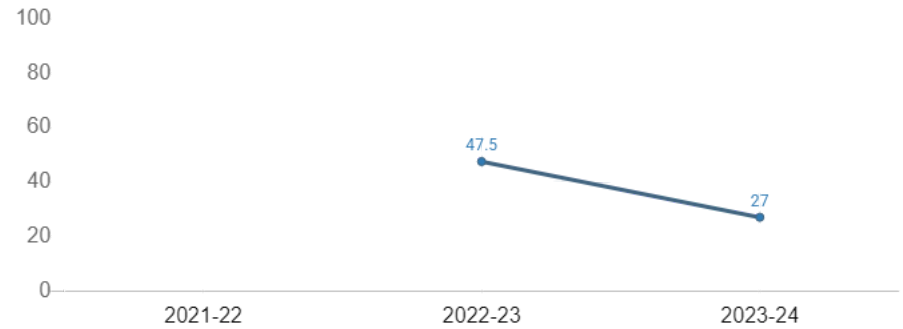

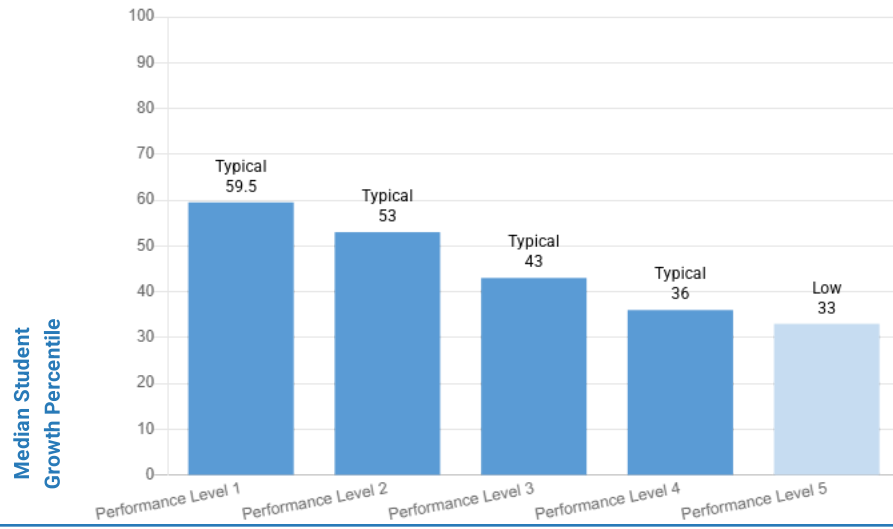

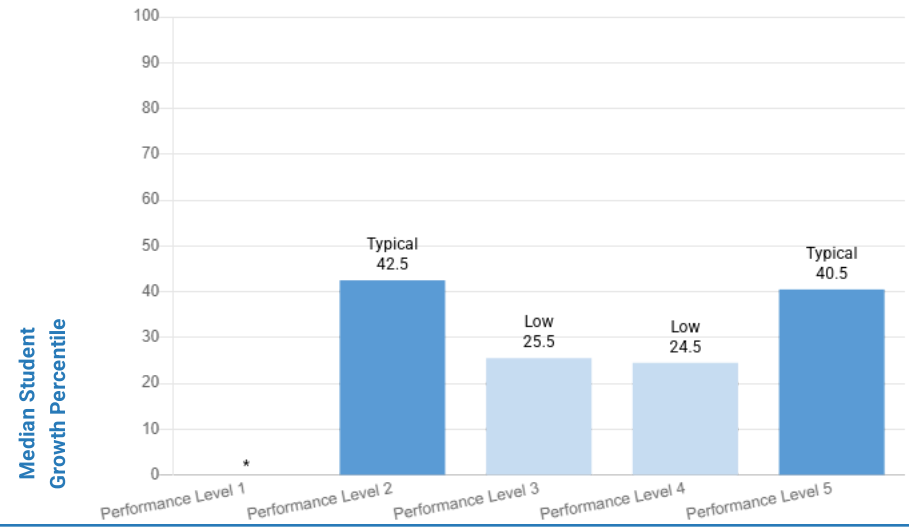

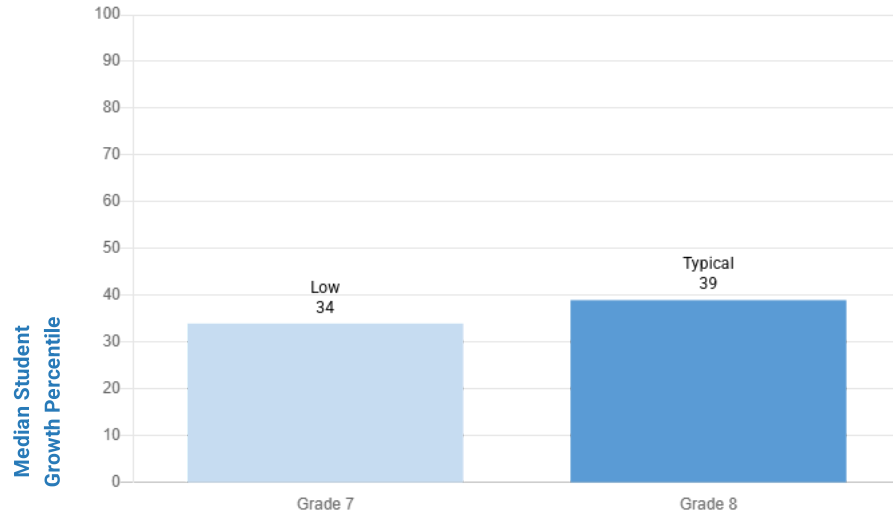

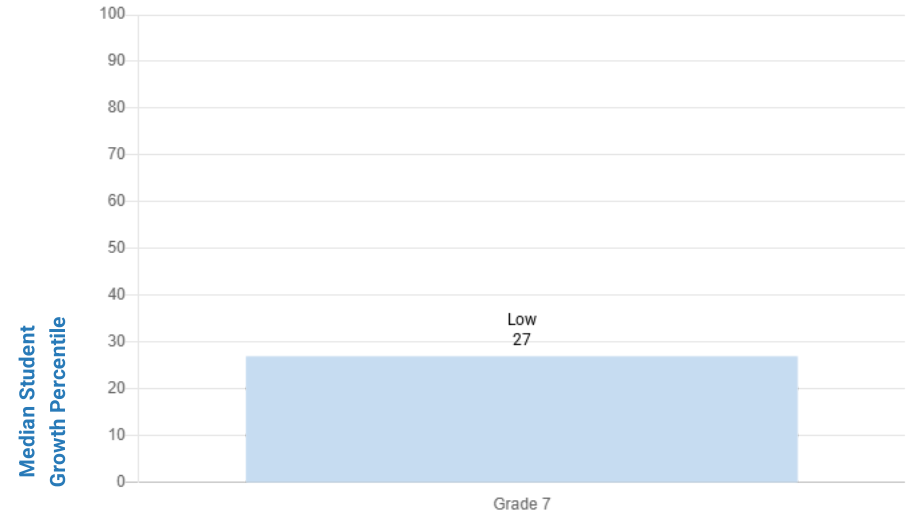

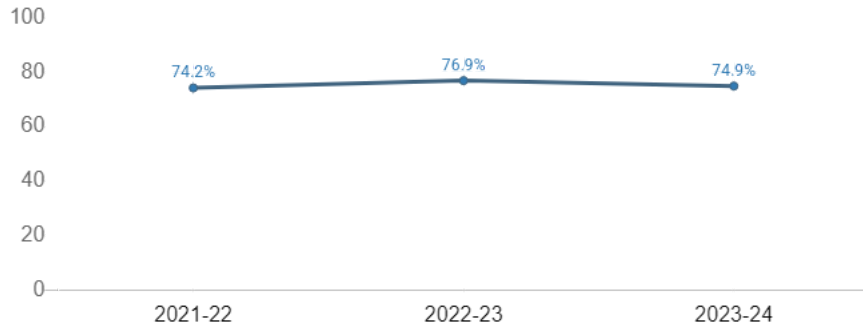

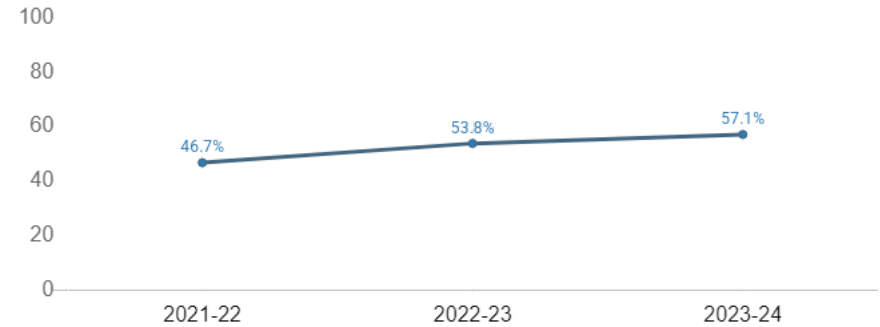
English Language Arts and Mathematics Performance Trends

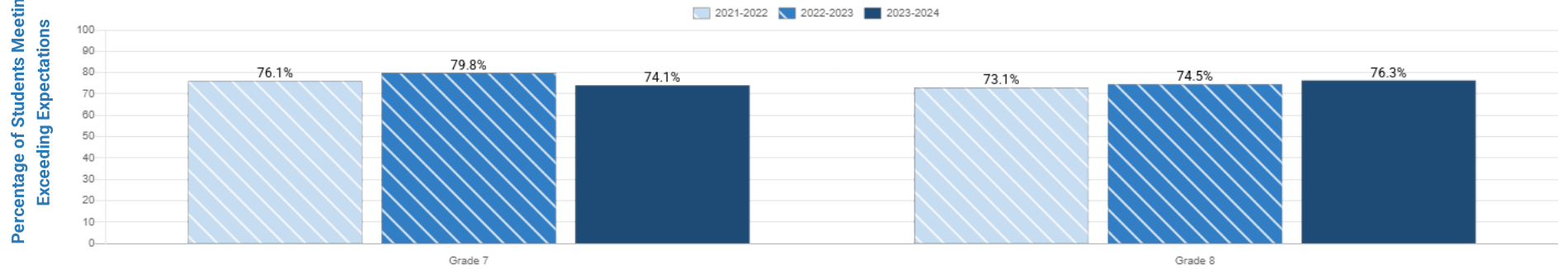

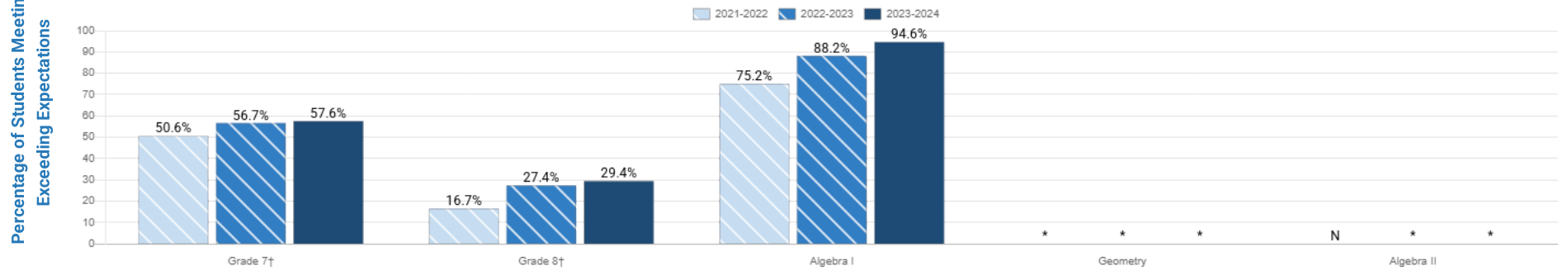

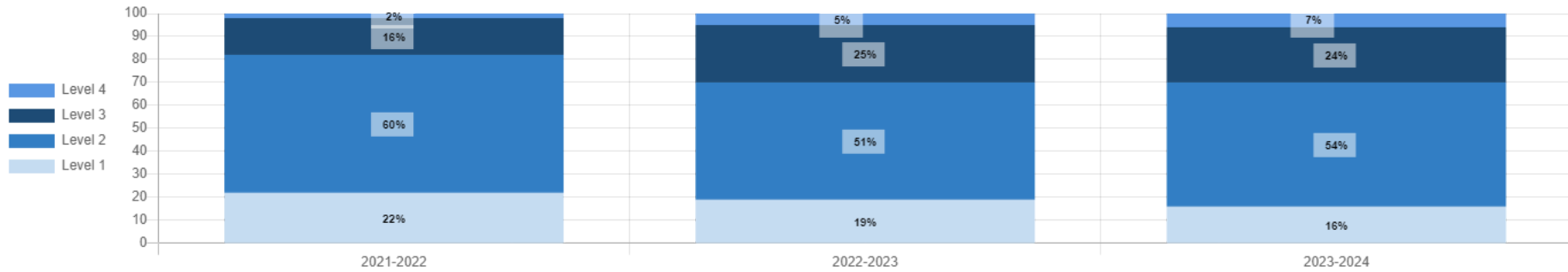

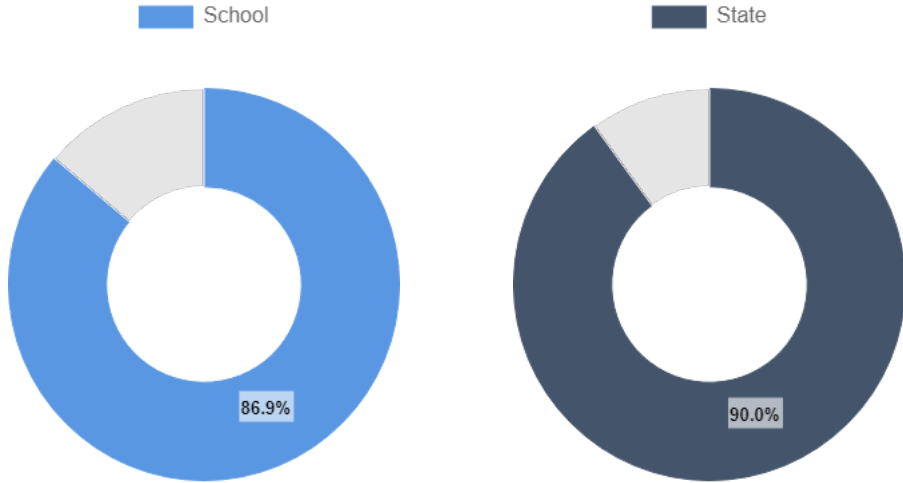

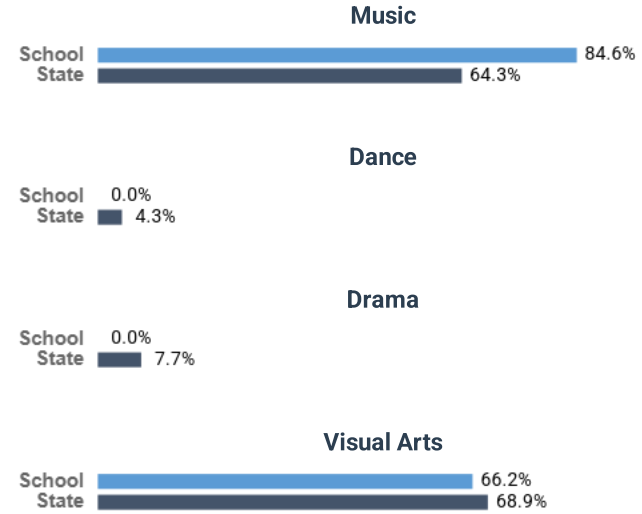

Students enrolled in one or more classes by discipline:



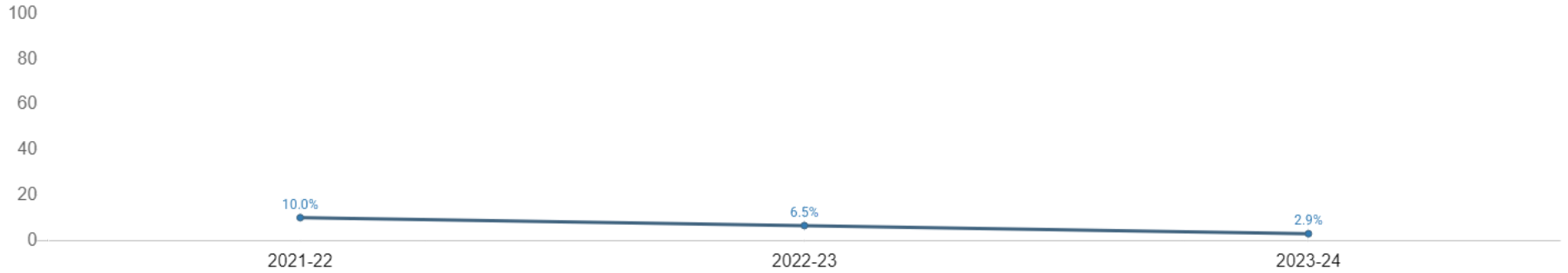

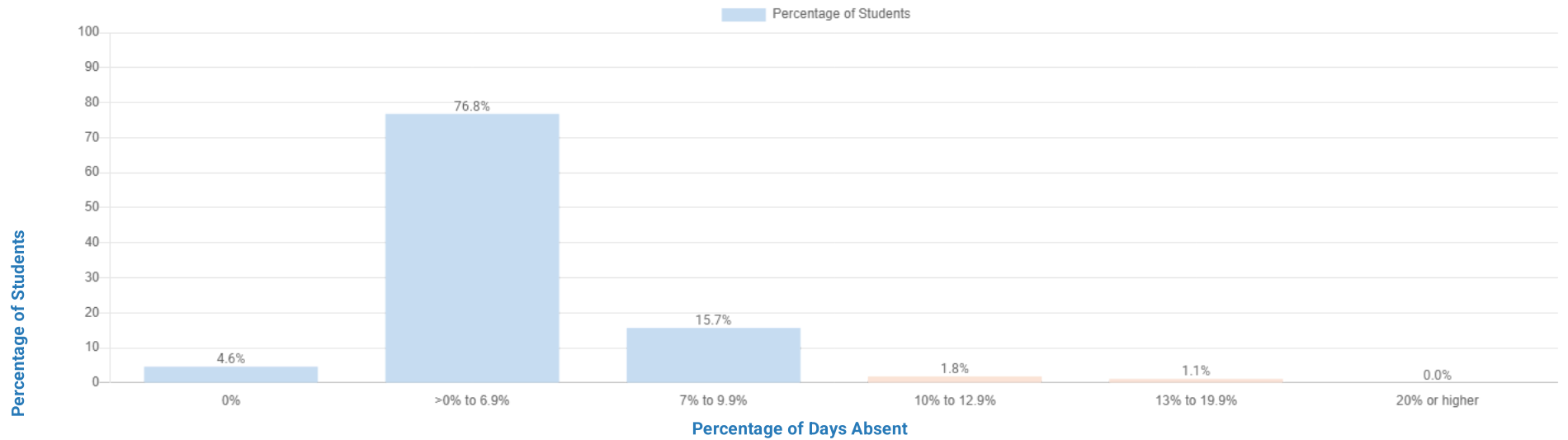

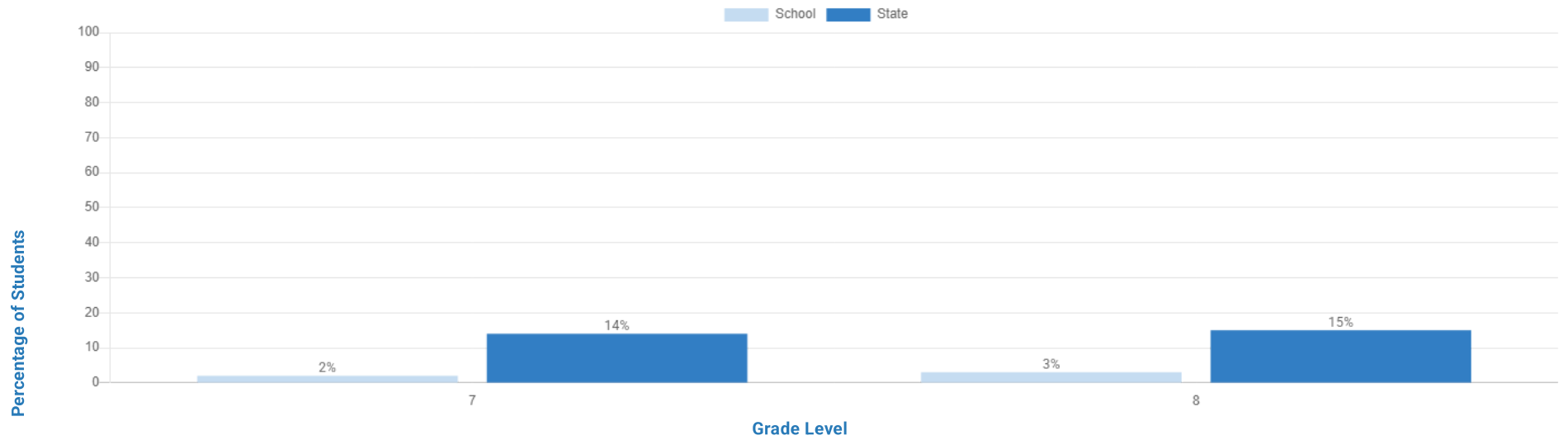

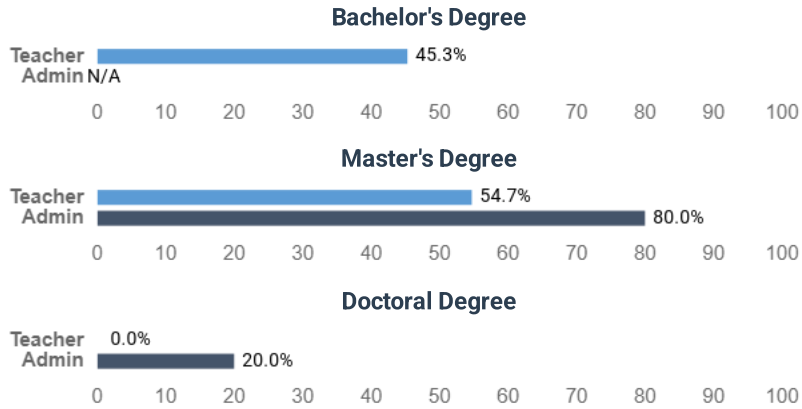

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Before and After School Programs:

We offer four levels of after-school academic support for our students. All teachers are available for extra help after school. West Essex High School National Honor Society Students are available for tutoring in the 5 core academic subjects. Homework Club provides a quiet, structured environment for students to complete their work. Finally, Knight Squad offers focused assistance to students who are performing below grade level.



Staff and Professional Learning:

Professional development time is included in every annual calendar. Faculty and staff are trained in schoolwide and departmental academic, pedagogical initiatives. Faculty members also take advantage of personal, professional learning goals and attend conferences, workshops, training sessions, etc. WEMS values the Team Model which allows teachers to utilize data to collaborate regarding student academic, social, and emotional growth, as well as best instructional practices, and assessment strategies.

School Safety:

West Essex Regional School District is ranked #2 Safest School District in NJ and #7 Safest School District in the country by Niche.com. School safety is a top priority for West Essex Middle School. Along with constant facility upgrades and thorough examination of our procedures, WEMS began a partnership with the non-profit organization "Sandy Hook Promise (SHP)." Through SHP, we have brought in a number of programs to increase student awareness and promote a community of upstanders. School safety measures include multiple State certified School Safety Specialists, state-of-the-art surveillance and communication systems, frequent facility upgrades, building procedure adjustments, extensive staff training, at-risk student identification, and intervention systems, and redundancies for all safety measures. Approximately half of all staff members are certified in First Aid, CPR, and Stop-the-Bleed.



Technology and STEM:

Students enrolled in the Cycle Elective program receive one marking period of STEM instruction and one marking period of Computer Science instruction. The STEM Cycle class presents students with engineering design challenges that foster flexible thinking and problem-solving skills. Students learn to use the equipment in the STEM room to construct projects that require higher-order thinking skills to complete. The Computer Science Cycle class introduces students to the world of Coding. Students also learn about the numerous careers that use technology as a means for solving large-scale problems such as pollution, drought, and poverty.
