











New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.



Intervention and Referral Services provide services to assist students who are experiencing learning, behavioral, or health difficulties. The district is committed to providing small-sized ELA and Math classes with two content-certified teachers providing daily instruction. In 2016, a Robotics Lab and Technology room were added to the High School to support STEM classes. Our 1,000 seat Performing Arts Center, with a full array of supporting rooms, is also a point of pride. Construction on a new turf stadium will be completed in the spring of 2024.



The district's main priority is the safety of the students and staff! We've developed and implemented plans/procedures for the protection of health, safety, security, and welfare of all stakeholders. The ongoing, high level of communication between the local law enforcement agencies enhances our ability to attain our security goals. The Memorandum of Agreement with the local police departments serves as our guiding document for all security matters. Our district complies with all state requirements for school security drills. More importantly, we've implemented several other security enhancements including the following: Dedicated School Resource Officers (SRO) in both schools, Hall Monitors, modified our entrances to limit building access and increase containment to a secured area, installed new digital cameras (interior and exterior) with an increased coverage area, installed Raptor software for background checks, and local police have a live view of all cameras.

Clearview Regional is a comprehensive 9-12 college preparatory high school that serves the residents of Harrison & Mantua Townships. The student enrollment at Clearview is approximately 1,400 students, and our facilities provide an excellent setting for academic, athletic, and extra-curricular programs. Our academic program offers a variety of courses and services to meet the needs of all of our students, while providing them with the chance to pursue their own areas of interest. We offer over 180 courses, including 23 designated as Advanced Placement, along with Honors and Advanced offerings in all fields of study. In addition to the traditional course offerings in English, Social Studies, Math, Science, World Languages, and Health and Physical Education, Clearview offers a comprehensive program that provides students the opportunity to explore and/or excel in areas of talent and interest. These areas include programs in Art, Vocal and Instrumental Music, Business Information Technology, Family and Consumer Sciences, and Technology Education. The Visual and Performing Arts Department offers students creative outlets with their award winning art, music and theater programs and advanced courses such as Advanced Placement Music Theory, Vocal Ensemble, Wind Ensemble, Wind Symphony, Honors Art III, and Honors Art IV, AP Studio Art and Theater. The Business Information program includes multiple levels of Accounting and Marketing.
