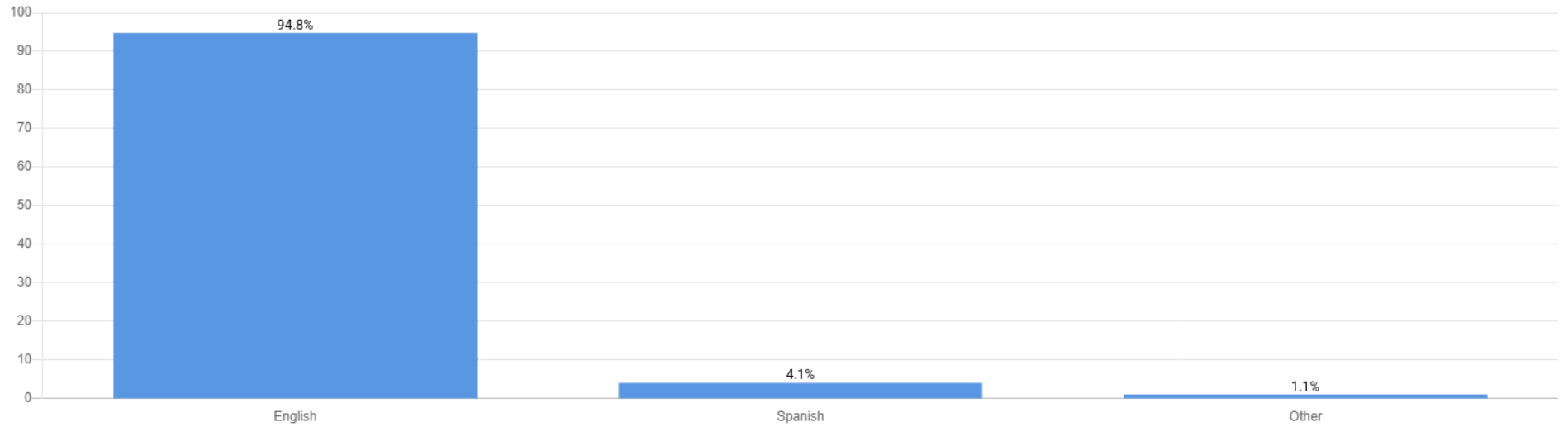

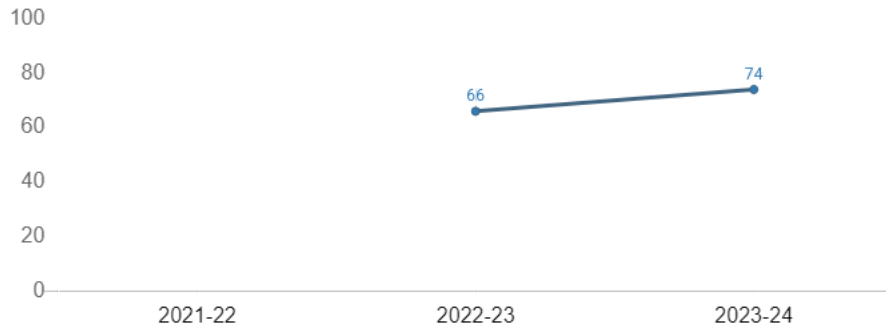

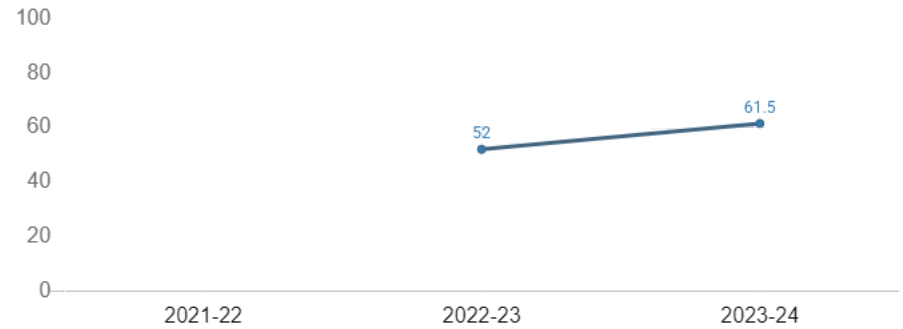

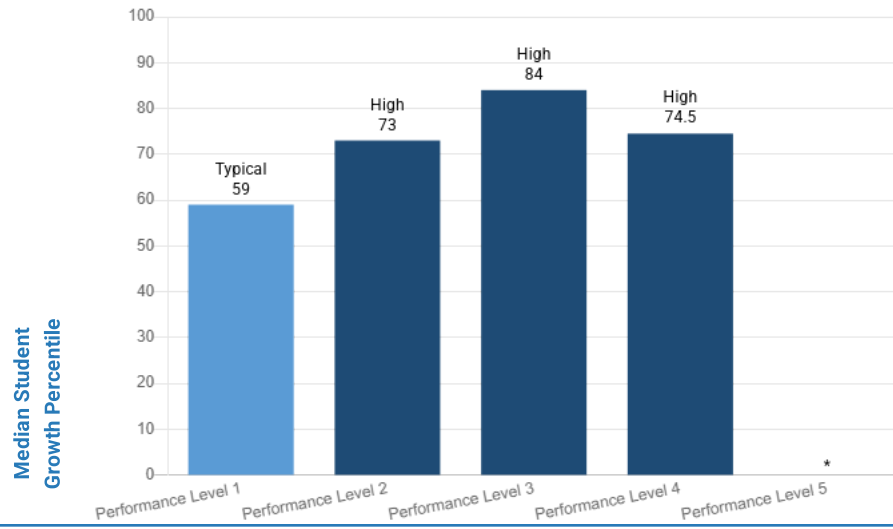

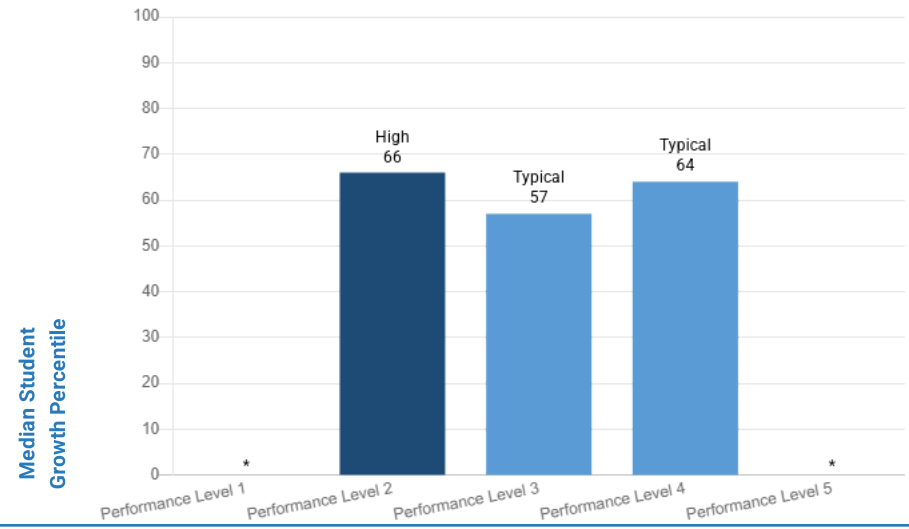

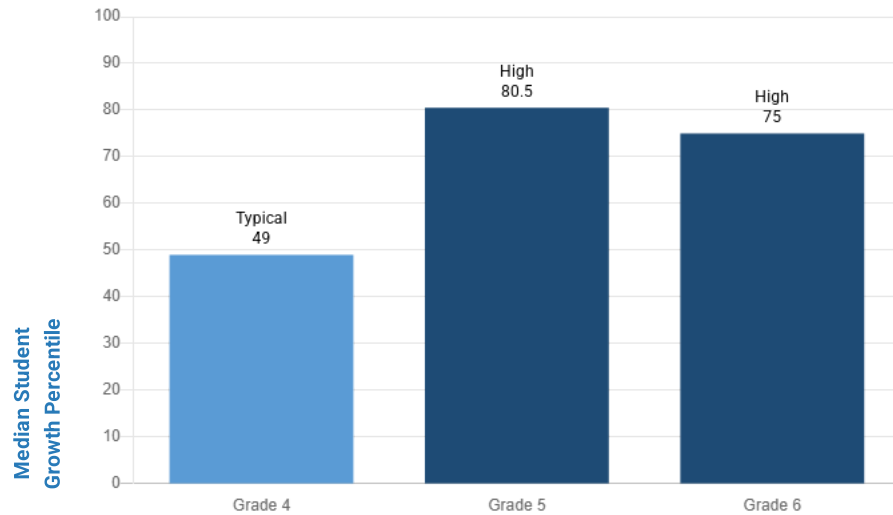

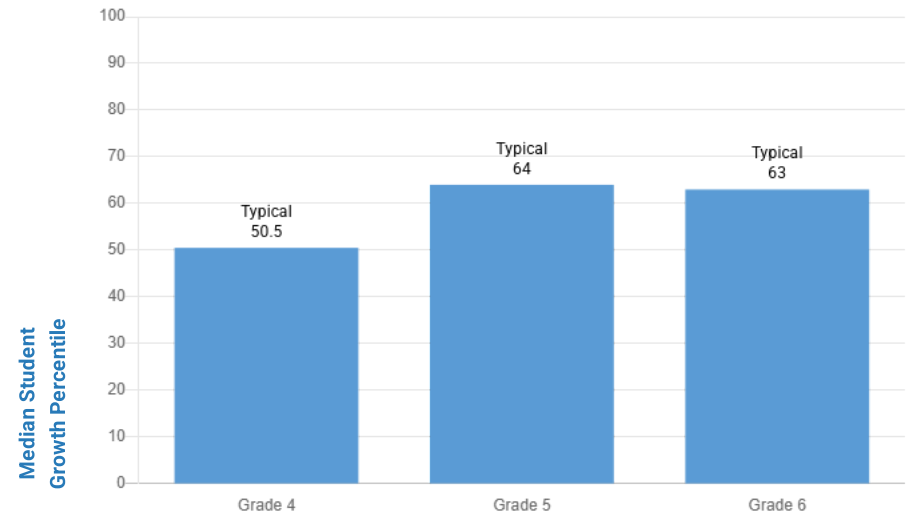

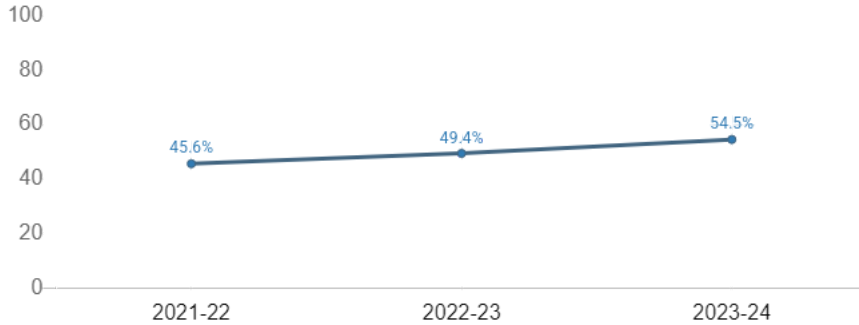

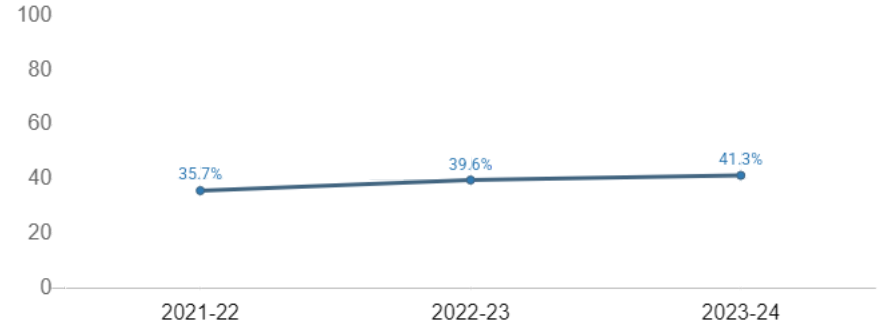
### English Language Arts and Mathematics Performance Trends

### English Language Arts Assessment - Participation and Performance

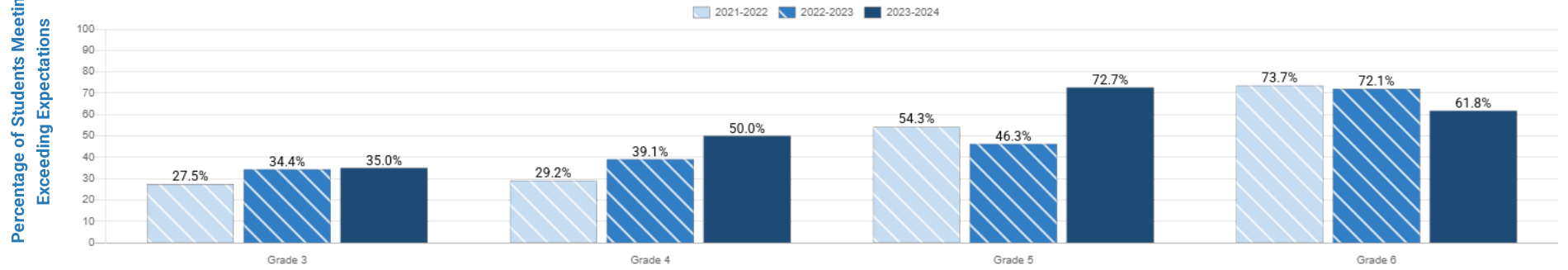

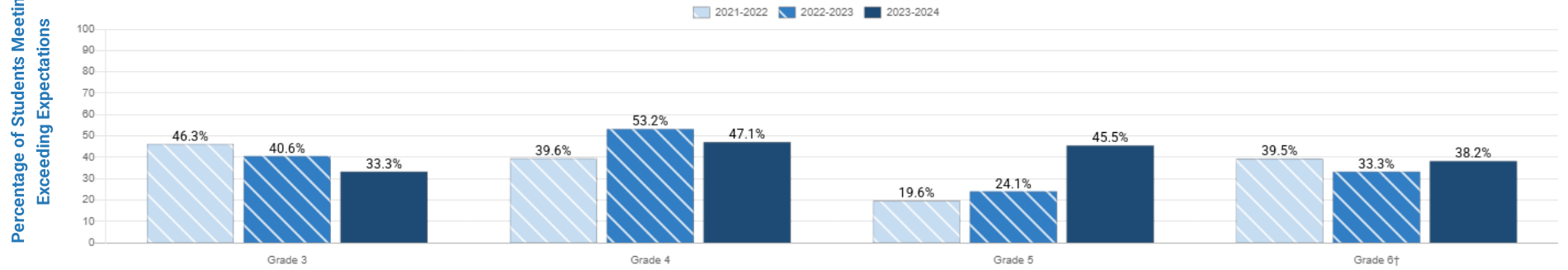

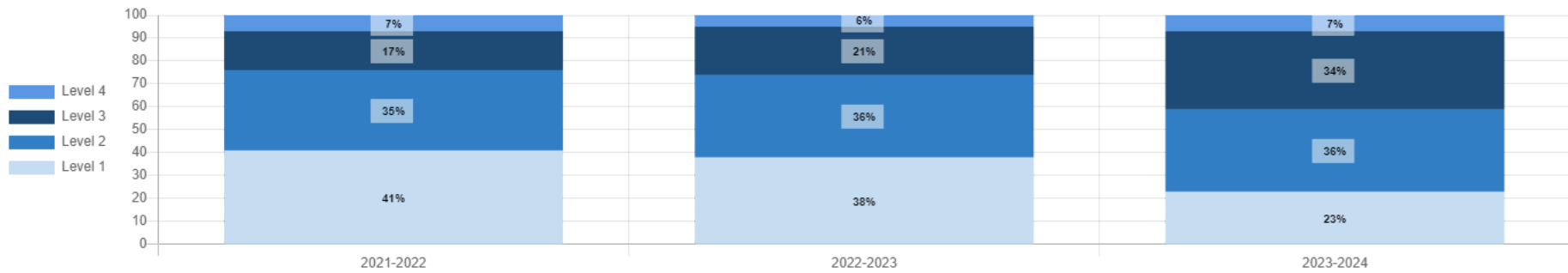

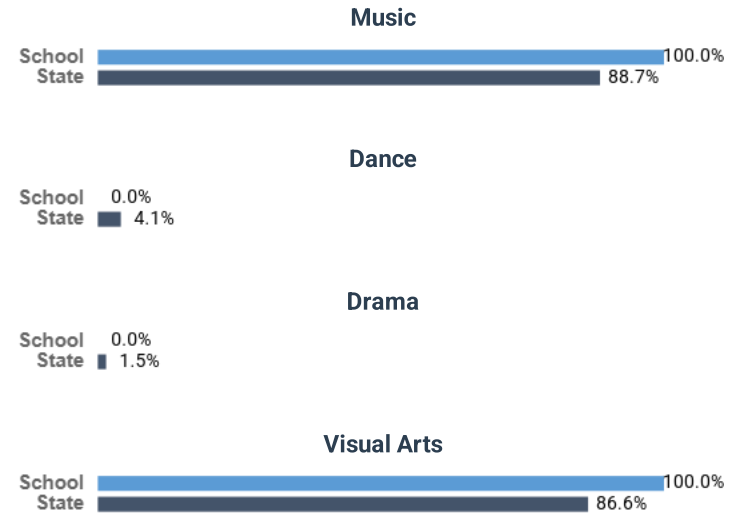

**Students enrolled in one or more classes by discipline:**



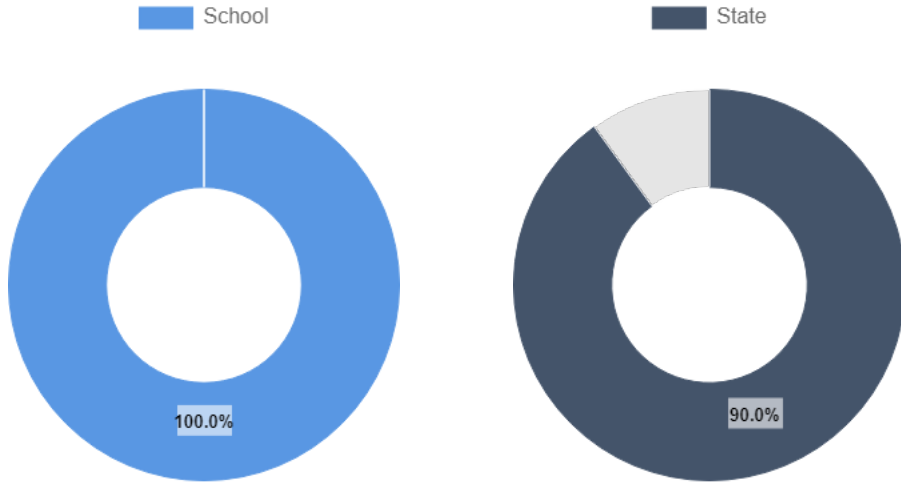

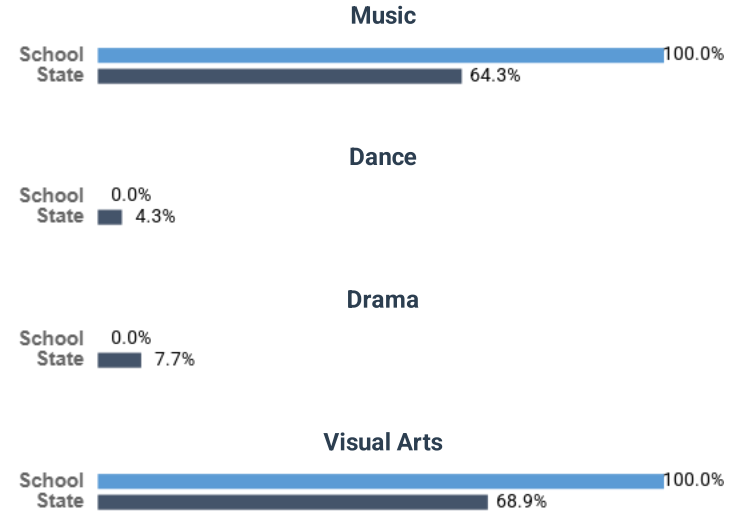

**Students enrolled in one or more classes by discipline:**



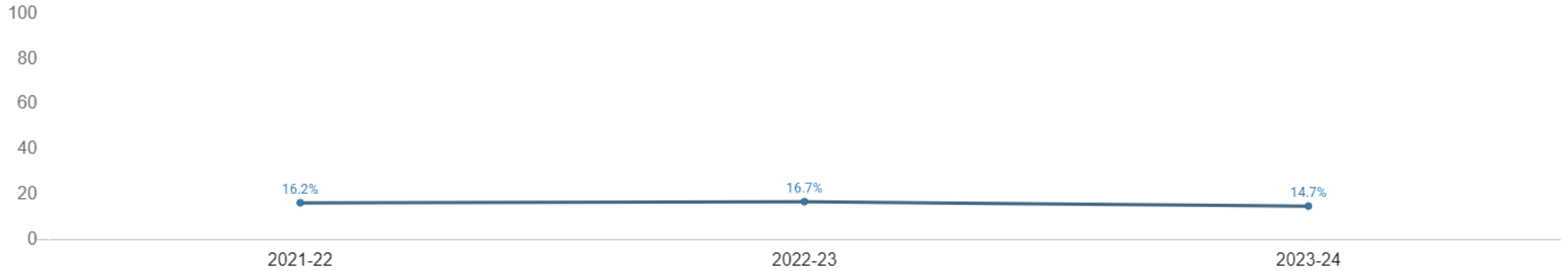

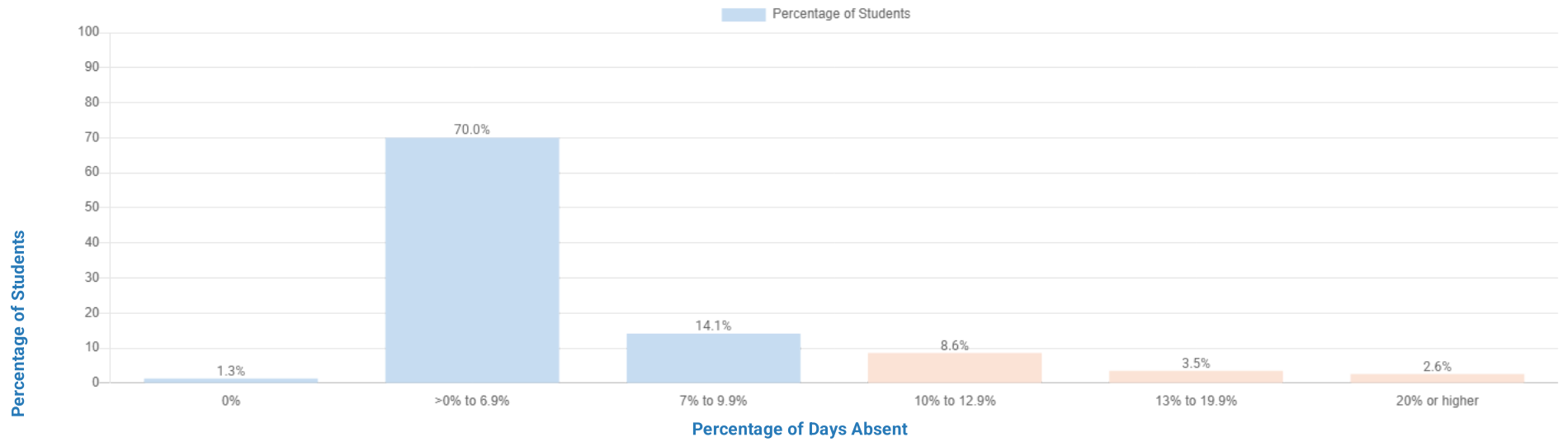

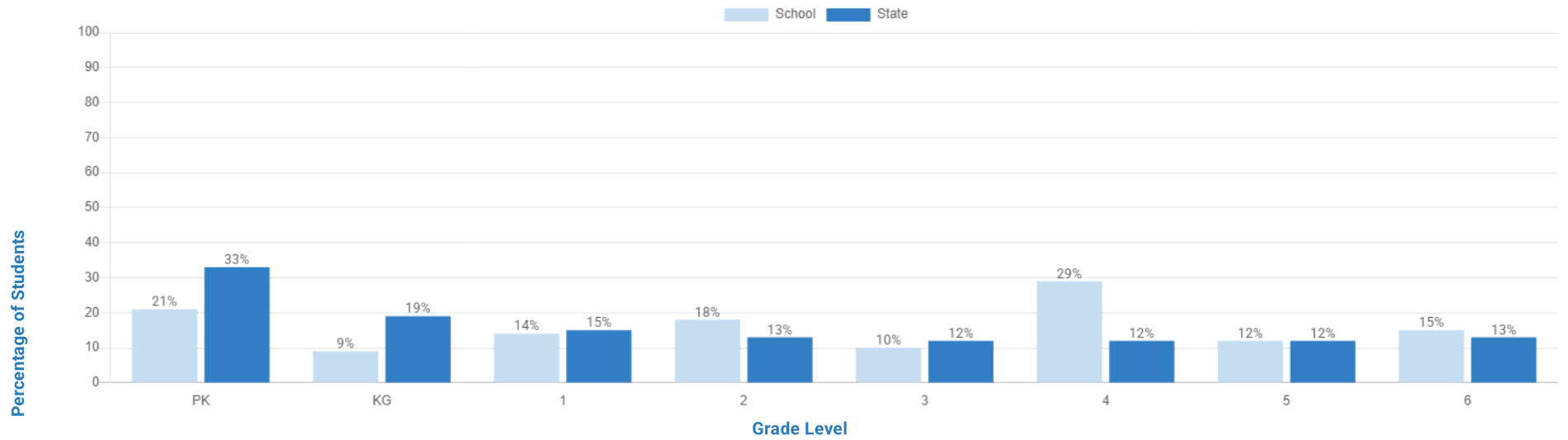

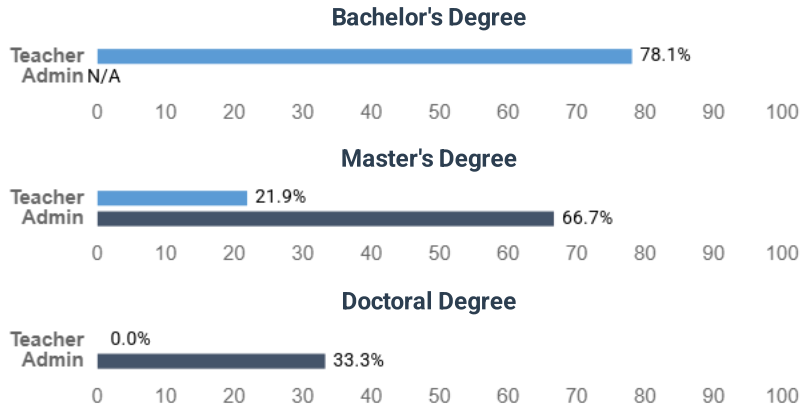

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. ### Mission, Vision, Theme:

We strive to educate students and assist them in realizing their full potential as responsible, productive, contributing members of society by providing an educational environment in which students are challenged, differences are valued, and excellence is expected.



### Courses, Curriculum, Instruction:

The ELA curriculum incorporates the ARC Core reading program; features wide reading libraries, structured phonics, and an adaptive online phonemic awareness platform. Reading progress is measured through the IRLA and Lexile levels. Students requiring more targeted intervention receive support through multi-sensory phonics support and reading comprehension support. Students are universally screened through use of the DIBELS assessment. The math curriculum incorporates the iReady Classroom program which privileges mathematical discourse and problem solving. In grades K-3, social studies and science are weaved into our knowledge-building ELA curriculum. In grades 4-6, students receive discrete instruction in social studies and science. Students also have dedicated instruction in art, music, technology, physical education and health. The gifted and talented program features problem-based learning and STEM activities.

Coverage is also offered on scheduled early dismissal and 2-hour delay days. The program does not operate when school is closed.

Aura School staff actively participates in professional development. The topics of trainings are determined by our District Offices. Teachers also engage in Professional Learning Communities centered around Math and Literacy.

### Student Supports and Services:

There are many support services for our children. These services include speech, physical therapy, and occupational therapy. Aura School has an on-site Child Study Team that evaluates students with learning difficulties. They work closely with the teaching staff to develop Individualized Education Programs. Our IR&S Team meets regularly to determine the allocation of support and services based on the information gathered on our students. We were awarded a grant in which we have added two Behavior Specialists to further support our students, staff, and community. We have now added a mental health resource agency called the Child Connection Center.



### Student Health and Wellness:

The School Psychologist, Social Worker, and School Nurse address any emotional and health concerns that our children might encounter. Aura School also has Intervention and Referral Services. The team is comprised of teachers, administration, and support personnel. The committee provides teachers with strategies to help students that have been identified as being at risk for academic, behavioral, or social issues.



### Parent and Community Involvement:

The parents of Aura School are supportive in the education of their children. They are encouraged to participate in Aura Home & School, an organized parent group that takes an active part in the school. They arrange for a majority of our cultural arts activities and fundraising efforts. Our Home & School (HSA) work in partnership with the school to provide our students fun and engaging events.

**Facilities:**

All rooms are protected by swipe doors for entry. Rooms are climate controlled with AC and heat.



**School Safety:**

The district has been proactive in providing a safe learning environment. We have numerous cameras inside and outside of the building. We have a vestibule area as another layer of protection. We have installed Raptor, a visitor management system that increases building security by screening all visitors and stopping potential threats at the door. All staff members are required to wear identification badges and carry walkie talkies. Our building has three automated external defibrillators (AED) and staff members are trained in its use. Students and staff participate in a variety of security drills, which are constantly updated, streamlined, and improved on a monthly basis. We have also established a working relationship with our local police department. All doors are equipped with swipes to enhance classroom security. Panic buttons are also present with a direct contact with the Elk Township Police Department.



**Technology and STEM:**

Aura School has a robust STEAM Program where students are encouraged to explore, build, and grow. This is a project based program which is informative and fun.

Aura School provides Pre-K through 6th grade students with a comprehensive academic curriculum, enrichment programs and support services to address the needs and interests of our diverse population. We acknowledge the differences among our children and strive to deliver the best possible education for them. We are committed to differentiated instruction to help meet the varying needs of our children. Our Preschool implements a readiness academic curriculum called "Creative Curriculum". This program focuses on play plans and early intervention writing skills. The Preschool program offers a full-year program. Aura School continues to build upon its whole school literacy initiative through Accelerated Reader, guided reading and the use of the American Reading Company Literacy Program for students in Kindergarten through 6th grade. For those learners who struggle with reading, the district has built in supports in grades K-6. We are committed to technology, equipping all classrooms with access to WiFi, Promethean Boards, and Chromebooks. Grades 4-6, students receive a Chromebook through a 1:1 initiative that continues to the secondary district's 1:1 initiative. Teachers participate in ongoing PD to infuse technology into the classroom. Teachers also participate in Educational Rounds to help enhance overall strategies and best practices for instruction. Standards based grades has been fully implemented for grades K-5.
