





Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

Note for 2023-2024: Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.

Kingsway's Academic Assistance Program (AAP) is a Title I funded program that is dedicated to bolstering identified students? academic confidence and performance by providing additional instruction from highly qualified teachers in the core subject areas of English/language arts and math. Students can use this time to receive additional academic reinforcement, effectively prepare for assessments, complete homework with assistance, or work on projects with support.



Staff and Professional Learning:

Kingsway's staff engages in professional learning experiences that develop their capacity to deliver instruction that is guided by the curriculum, rigorous and relevant, engaging, and includes assessment for learning tailored to the individual student. 

Every student at KRHS is required to have Health and Physical Education courses throughout their four years of high school. This includes physical fitness activities, team building and mindfulness activities as well as Human Sexuality, Driver?s Education, Health and Nutrition, and Safety and First Aid/CPR. KRHS offers breakfast each day and the ability for additional physical activities at SMART (open gym and fitness center).

KRHS uses the I Love You Guys protocols. The building and campus are monitored by cameras, a security system, two resource officers, and one security aide. Two security drills are practiced each month which include fire drills, evacuations, and lockdown drills to ensure the staff and students are prepared. The School Safety team meets at least two times per year.



Technology has been a priority at KRHS. During the 23-24 school year, the district continued in its 1:1 initiative with Chromebooks. Science classrooms have been outfitted with new laptops ensuring Science applications can run effectively to ensure that lessons are engaging and relevant in preparing students for their post-secondary plans. KRHS also offers a plethora of technology-based electives that engage students in S.T.E.M. related activities. The wireless infrastructure has been expanded to allow greater access to wireless technology, which has opened the door for greater possibilities using technology. For example, students have an opportunity to engage in discussions with NASA engineers and speak to doctors after viewing live surgeries.

Kingsway employs a unique S.M.A.R.T. Schedule. The school day consists of two wheels: a three-period 50-minute AM wheel and a three-period 50-minute PM wheel which rotates on a four-day cycle and one lunch for all students in between the two wheels. The one lunch (S.M.A.R.T. period) is an acronym that stands for Students Maximizing Achievement, Resources, Relationships, and Time and is the title given to our high school schedule. S.M.A.R.T. reflects a departure from a very traditional schedule to one that maximizes resources, relationships, and time so that our students make the most of their high school experience, improve academic achievement, and graduate college and career ready. Through the S.M.A.R.T. schedule, more students have the opportunity to engage in academic enrichment activities and participate in co-curricular programs, and faculty members have gained opportunities to meet and discuss pedagogy and best practice in an effort to improve student performance.
