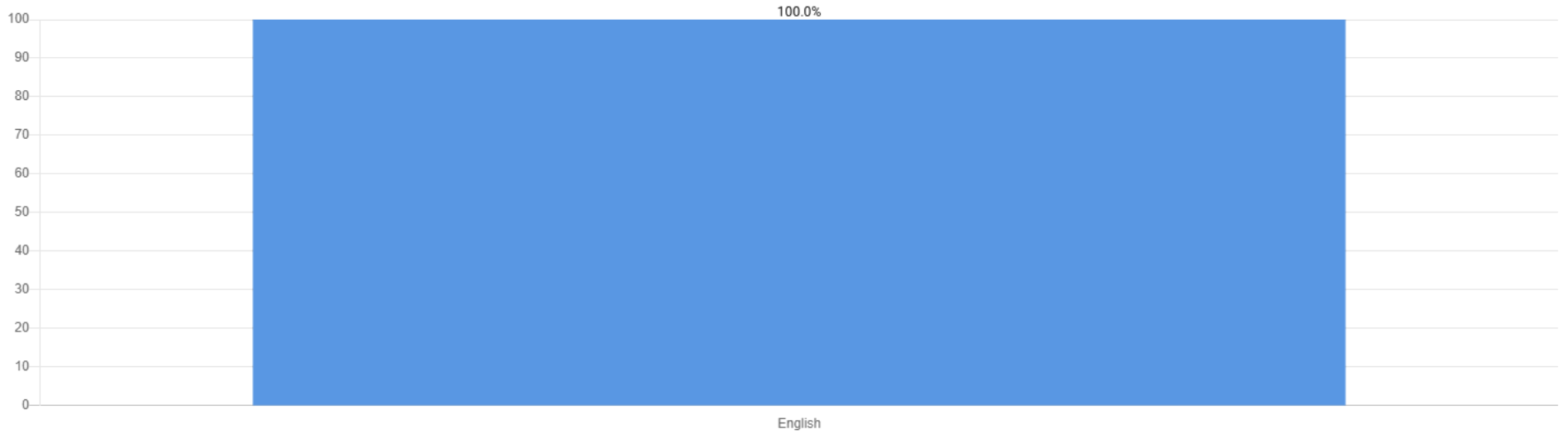

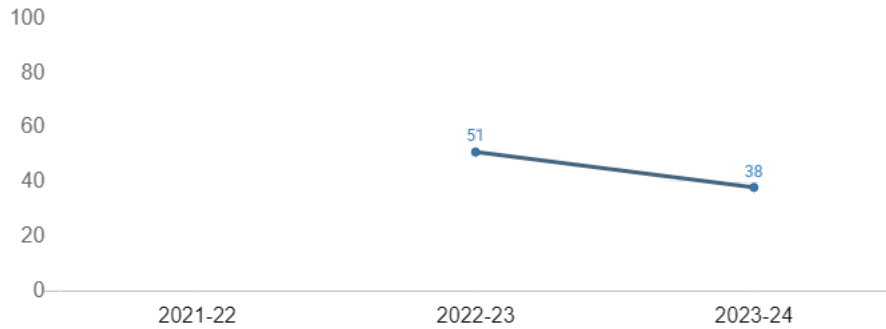

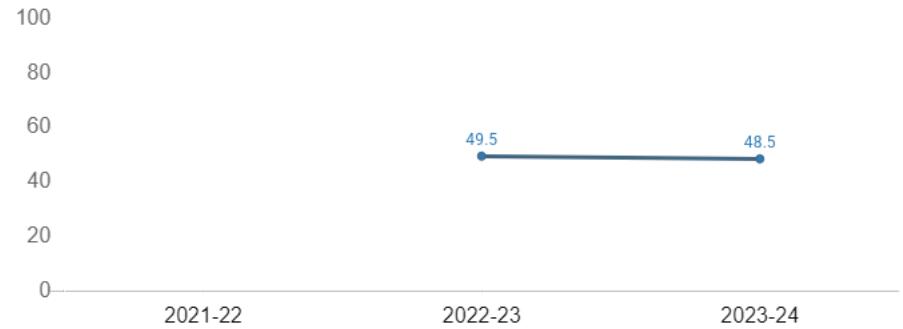

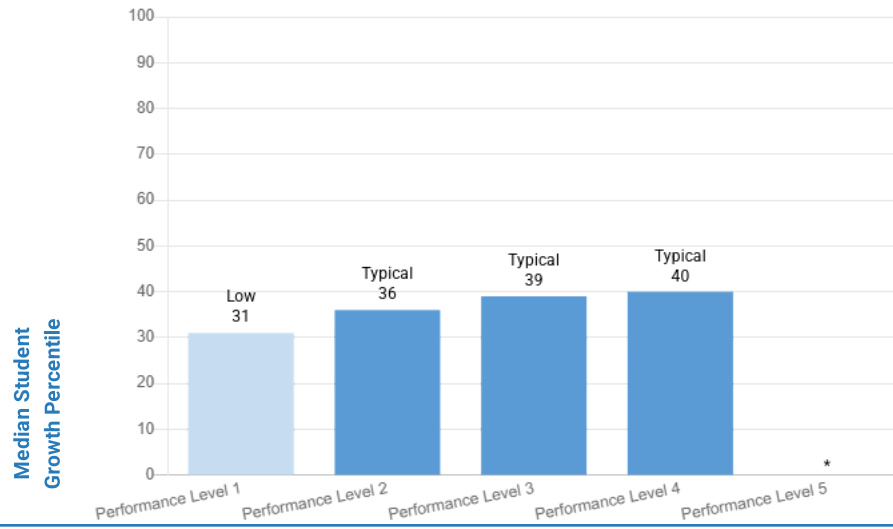

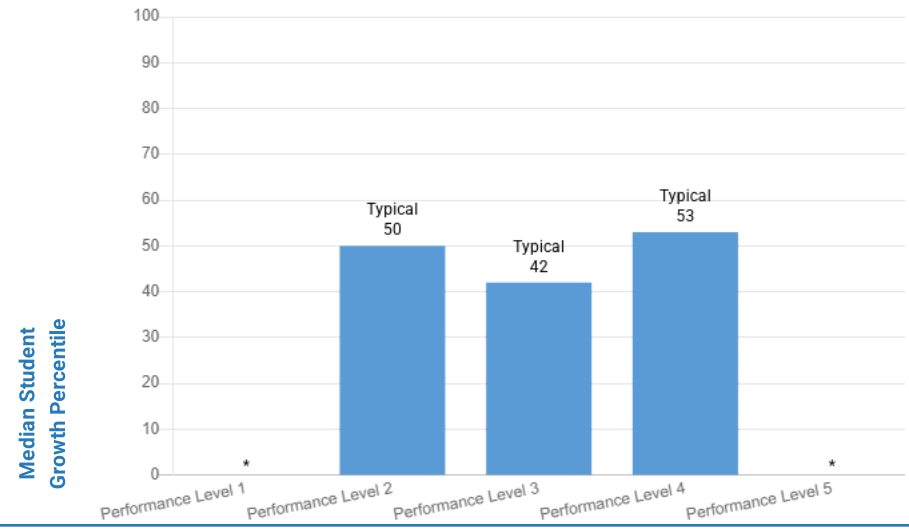

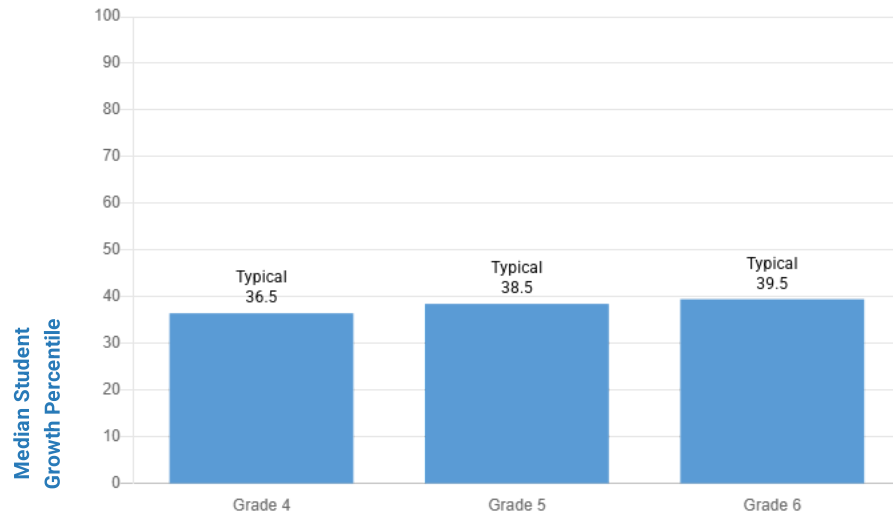

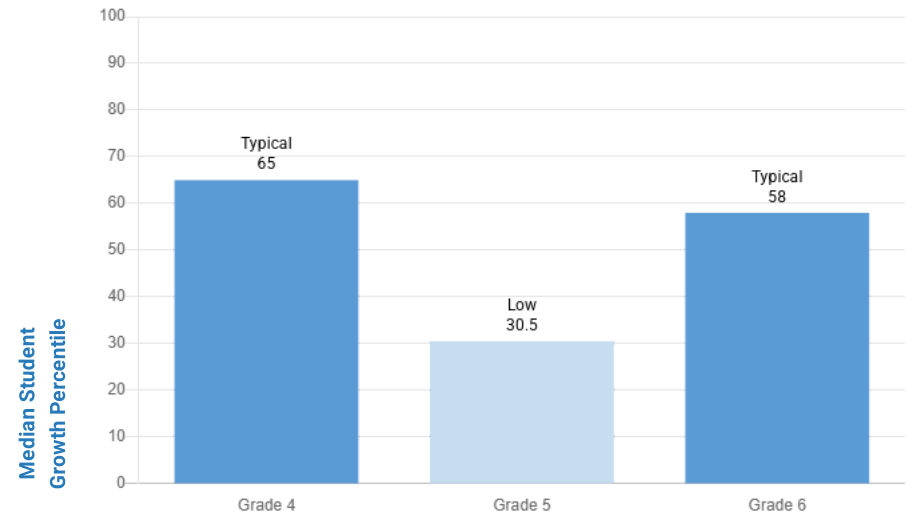

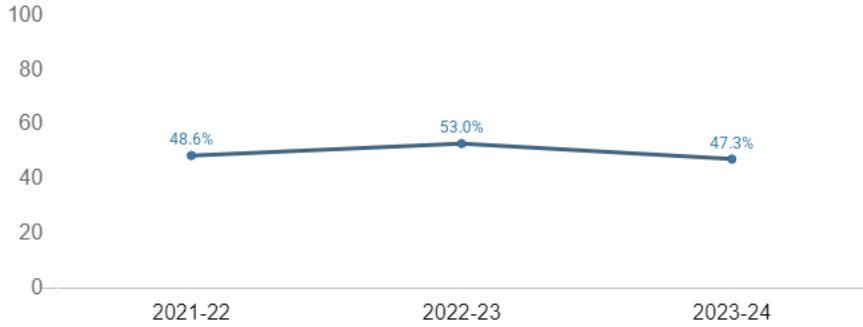

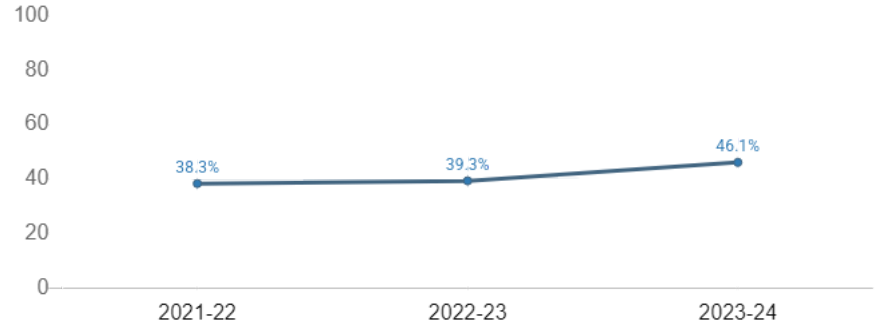
### English Language Arts and Mathematics Performance Trends

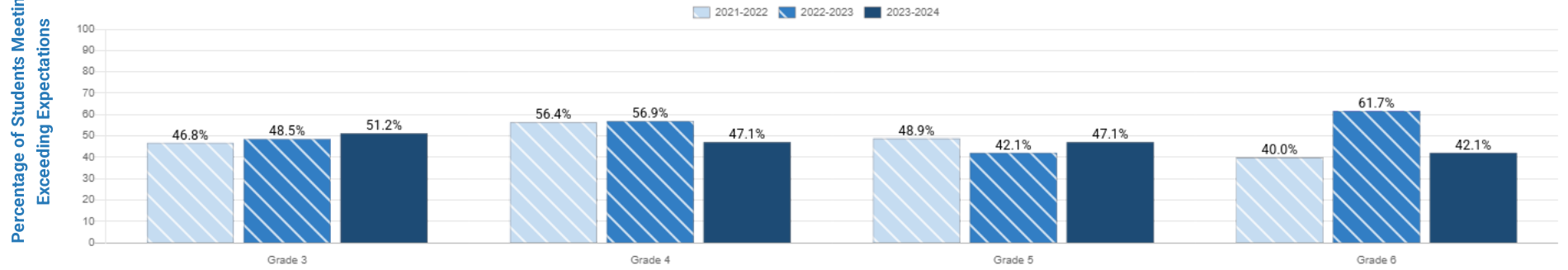

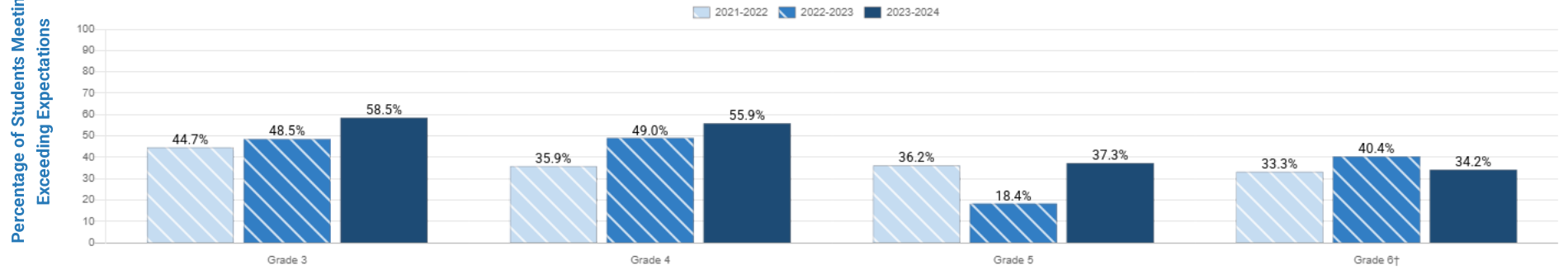

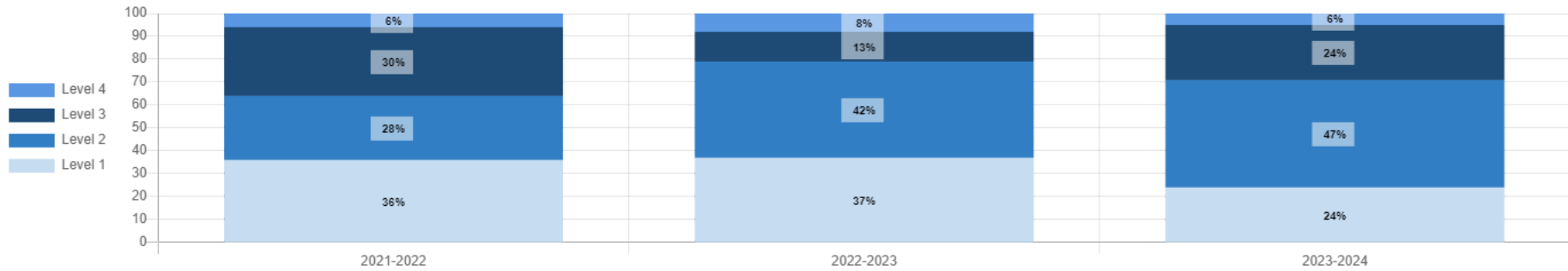

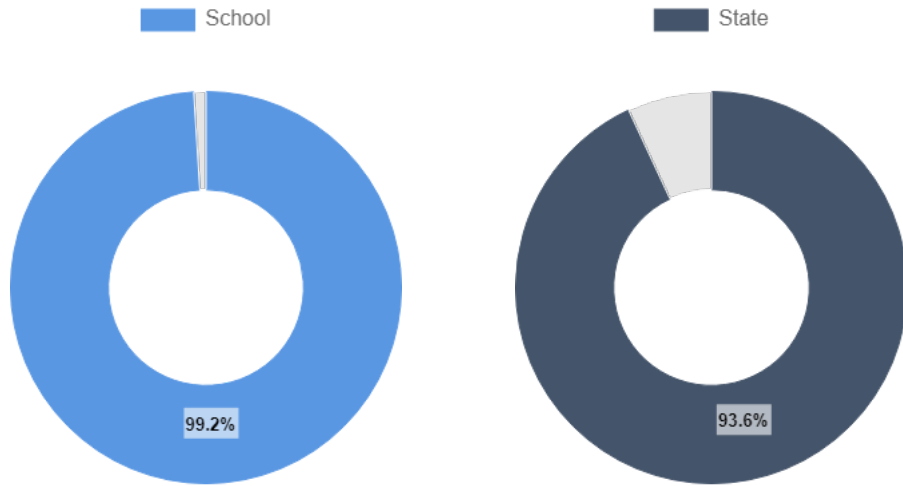

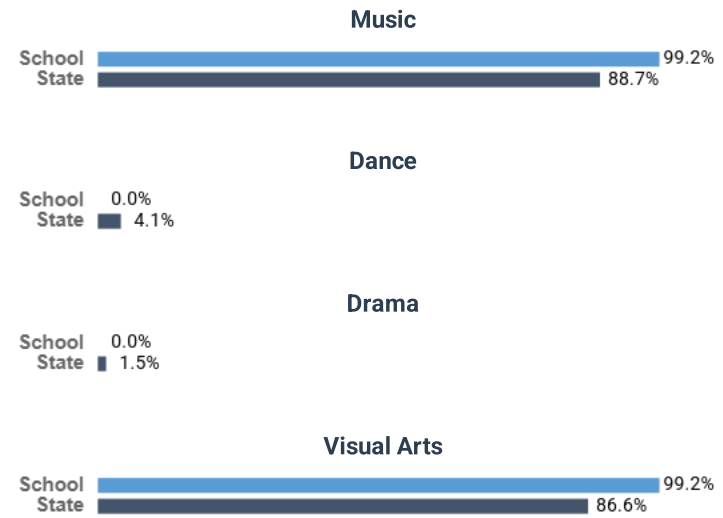

**Students enrolled in one or more classes by discipline:**



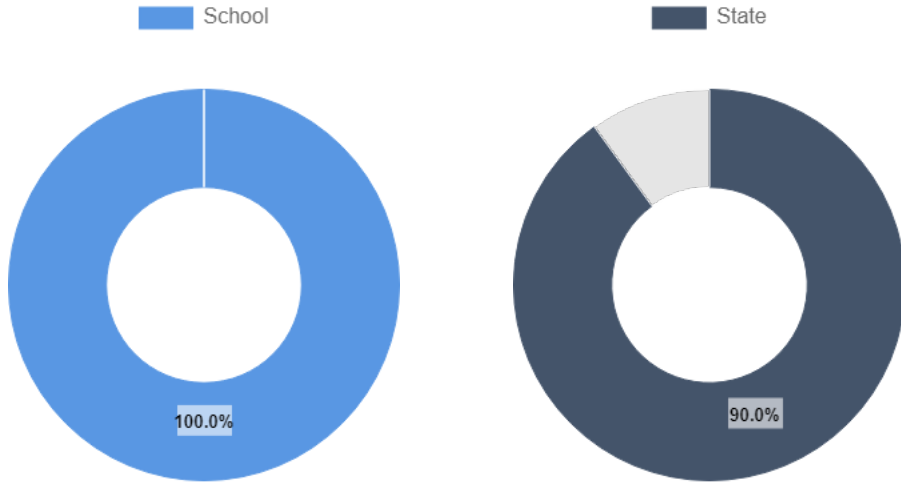

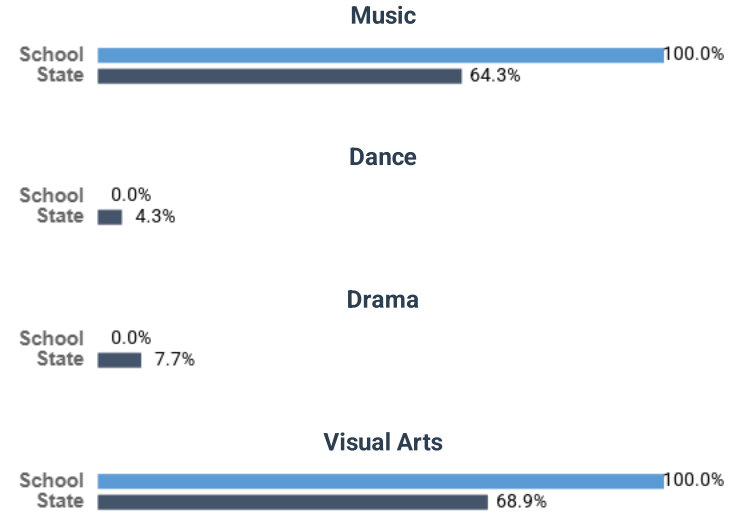

**Students enrolled in one or more classes by discipline:**



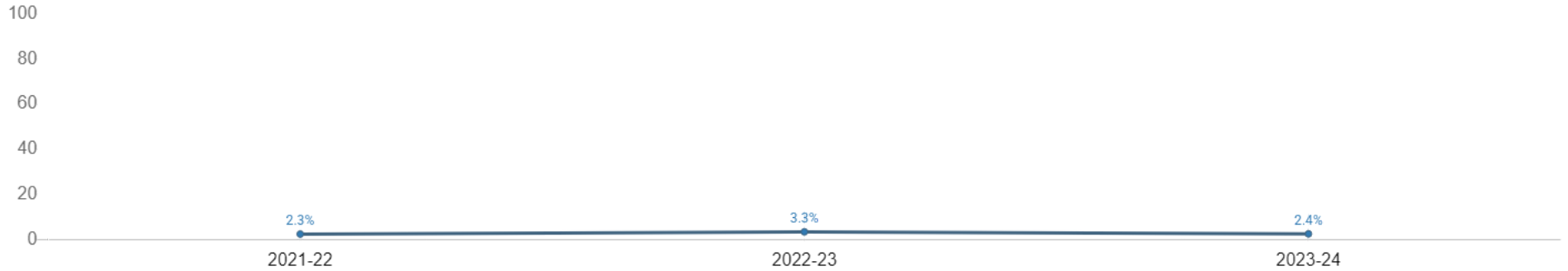

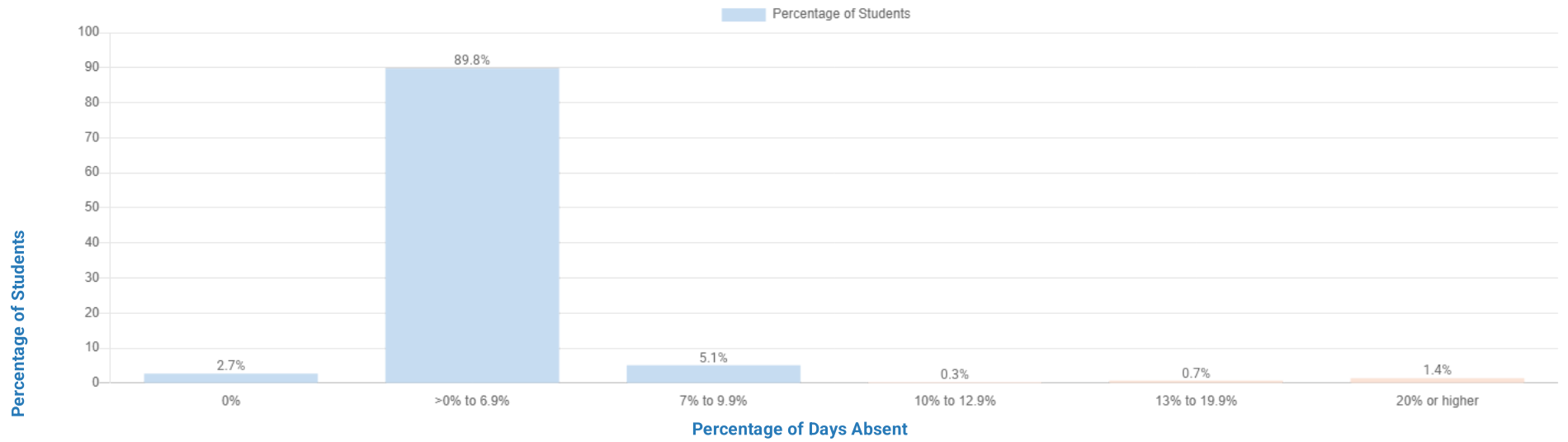

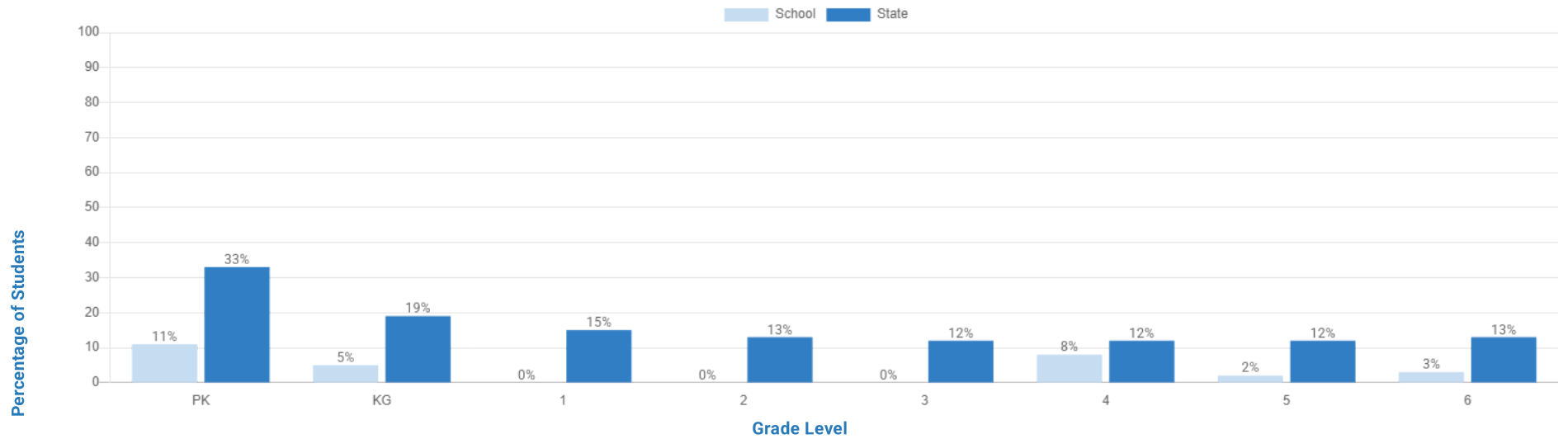

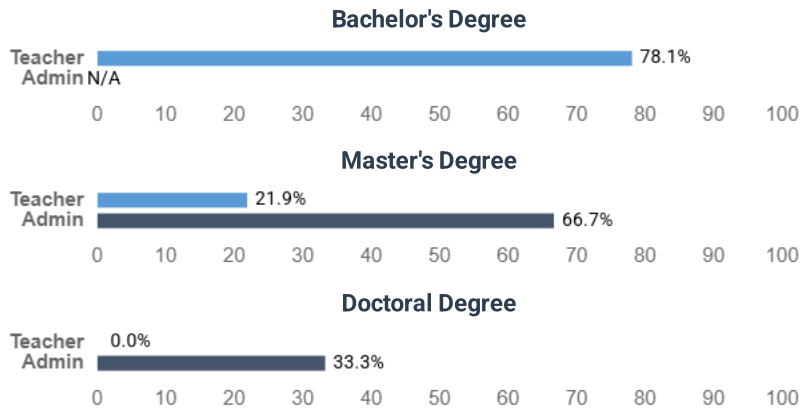

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. South Harrison Township School District's schedule has been strategically arranged to allow grade level common planning time for staff to collaborate on important topics. Our Instructional coaches are available during those times to provide additional support. Monthly, staff meet after school to engage in various professional learning opportunities differentiated based on their needs. Throughout the year, staff engage in meetings to create student action plans to support struggling students, determine interventions, and monitor student progress. ### School Safety:

At SHES, student/staff safety is our top priority! The administration regularly collaborates with the police/other emergency management organizations on planning, training, and daily security matters. We work with the Gloucester Co. Emergency/Trauma Readiness group to prepare to deal with any incident in the county schools. Administration continually trains staff and students, monitors implementation of security procedures, evaluates and enhances the security of our facilities, and investigates potential threats to student safety. Safety drills are held at least twice monthly with scenarios to prepare our students and staff to make quick/appropriate decisions during emergencies. Our school counselor, child study team, administration, and staff in our school support social/emotional well-being through character education programs and anti-bullying training. We want to empower our children to take action regarding school safety and develop problem-solving and conflict-resolution skills.



### Early Childhood Education:

South Harrison offers a full-day inclusive preschool for community members, as well as to serve the needs of students who qualify as pre-school disabled. This program is funded by the state for general education students and local funds for PSD students.
