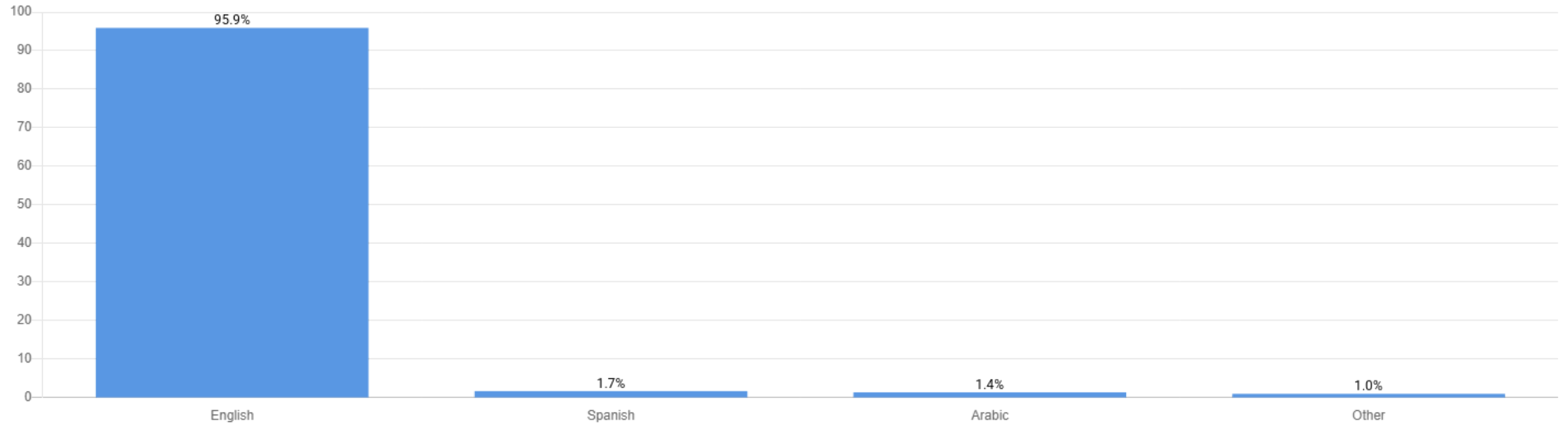

Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

Key terms for staff data:

Teachers: All classroom teachers

Administrators: Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

Experience: Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

Out-of-Field: A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

Provisional Teacher: A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

Teachers – Experience

This table shows information about the experience and professional qualifications of teachers. Out-of-field teachers are teachers who are potentially teaching outside of their area of certification. Teachers with provisional certifications are fully certified novice teachers of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification. The New Jersey Department of Education does not issue emergency instructional certificates for teachers. 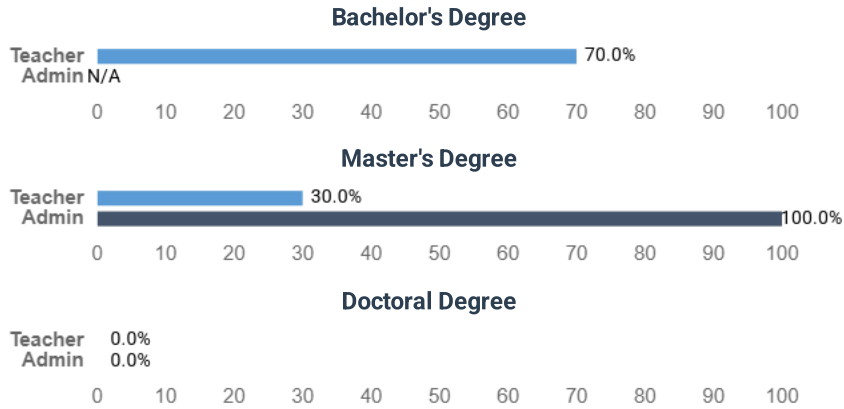

- GTECC uses the ECERS (Early Childhood Environmental Rating Scale) to measure the quality of teacher-child interactions, room environment, and more.

Grenloch Terrace Early Childhood Center is dedicated to the mission of excellence through equity, engagement, and environment. Our students are exposed to play-based curricula, social emotional learning experiences, and creative gross motor activities. Our school has partnered with many community resources to offer a myriad of learning experiences. GTECC also recognizes students with the Grenloch Gardener Award. Recognition is determined by the learning indicators for social emotional health in TS Gold. Students who demonstrate significant growth are recognized and honored monthly.

Courses, Curriculum, Instruction:

Students in our three- and four-year-old classes engage in studies using Creative Curriculum. This curriculum fosters the development of the whole child through teacher-led, small and large group activities centered around 11 interest areas (blocks, dramatic play, toys and games, art, library, discovery, sand and water, music and movement, cooking, computers, and outdoors). The curriculum provides teachers with details on child development, classroom organization, teaching strategies, and engaging families in the learning process.



Clubs and Activities:

Although GTECC doesn't offer clubs for preschoolers, we do provide a multitude of developmentally appropriate activities aligned to the studies in Creative Curriculum. Some of these activities include our Fall Walk, a visit to the farm, and maintaining and observing a butterfly and bird sanctuary.



Before and After School Programs:

GTECC houses wrap-around care for interested families. The school also hosts after school family workshops for parents and students.

Staff and Professional Learning:

The staff at Grenloch Terrace engages in district-level and site-based, job-embedded professional development opportunities. These high-quality workshops develop theoretical understanding, provide demonstrations and/or modeling, and include opportunities for collaboration. Analysis of student data guides the content of these programs. In addition, the support of the preschool instructional coach adds to the innovation of these professional development experiences.



Student Supports and Services:

Student supports range from academic, behavioral, to social/emotional. All teachers analyze data and determine supports for their students. In addition, the school has an instructional coach, CPIS, PIRS, and various teams who work on developing supports for students. GTECC has counseling services, nursing services, board certified behavior analysts and clinical associates, and character programs to support the social and emotional needs of our students. Collectively, teams work with teachers to make decisions regarding the supports and services necessary for each child.



Student Health and Wellness:

Grenloch Terrace Early Childhood Center has a Wellness Committee that recognizes the link between student health and learning. The school is committed to providing a learning environment that promotes student wellness, proper nutrition, health education, and regular physical activity for all students. Breakfast is offered and served daily in each classroom to promote proper nutrition, improve concentration, and increase student performance in the classroom. All students are screened for vision, dental, and hearing shortly after registration.

GTECC offers parent engagement opportunities in a variety of formats. Our HSC and ECAC are active organizations with the same goal in mind: increase community and parent involvement. Our school offers various parent involvement activities such as Trunk or Treat, Buddy Breakfast, Friends-Giving, Fall Walk, Farm Visit, Gingerbread Day, Snowball Dance, Egg-cellent Spring event, Growth Ceremony, speech language parent workshops, OT/PT parent workshops, AAC device parent workshops, and health and wellness parent workshops. All of these activities are based off of the results from the Community Needs Assessment. Parents are partners in their child's learning and invited into Grenloch for various parts of the day and throughout the implementation of our studies. In addition, our school utilizes the parent portal, Ready Rosie. This online resource provides daily activities for parents and guardians to do with their child at home.



Facilities:

Our campus has two buildings, one built in 1936 and the other in 1991. Both are fully air-conditioned and each provides large classrooms for our children. An all-purpose room and library are also included, as is a well-equipped playground.



School Safety:

Each school has a School Safety Team. This team works diligently to support our school safety plans including the rehearsal of drills, ensuring policies and procedures are followed, and annually updating our school emergency handbook. Aside from school safety plans, the School Safety Team works collaboratively to support arrival and dismissal procedures, plan special assemblies, and continuously evaluate measures to ensure safety. In addition to our district security personnel, each of our schools have a school resource officer.

Other Information:

At Grenloch Terrace Early Childhood Center, social-emotional learning and creating supportive learning environments are crucial to early childhood development. All of our classrooms have been trained using the Pyramid Model which provides the framework for the implementation of practices needed to promote young children's social and emotional competence and effectively address challenging behavior. The TPOT is an instrument designed to measure practitioner's implementation of teaching and behavior support practices associated with the Pyramid Model. Grenloch Terrace Early Childhood Center also utilizes Teaching Strategies GOLD which is an authentic, ongoing observational system for assessing children from birth through kindergarten. It helps teachers to observe children in the context of everyday experiences.
