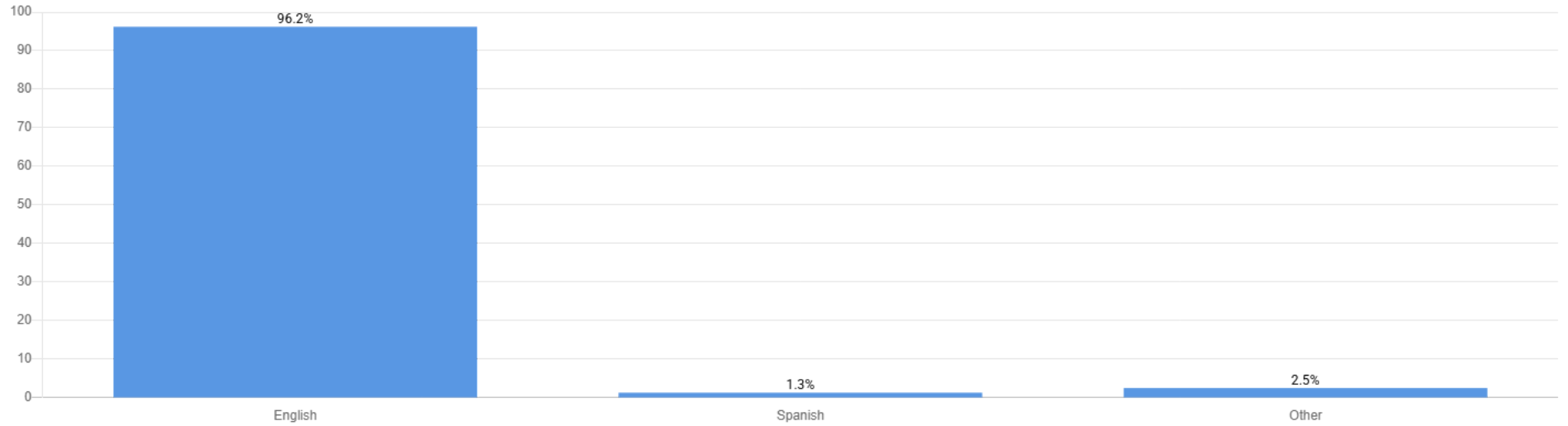

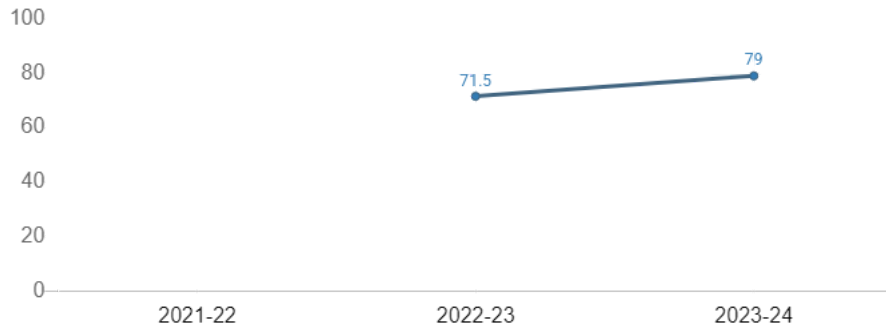

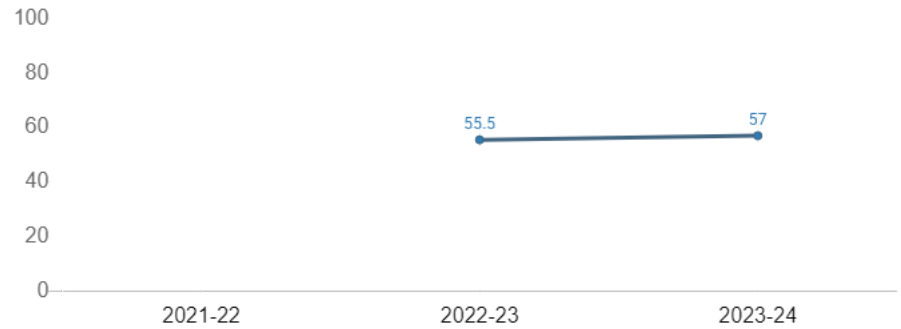

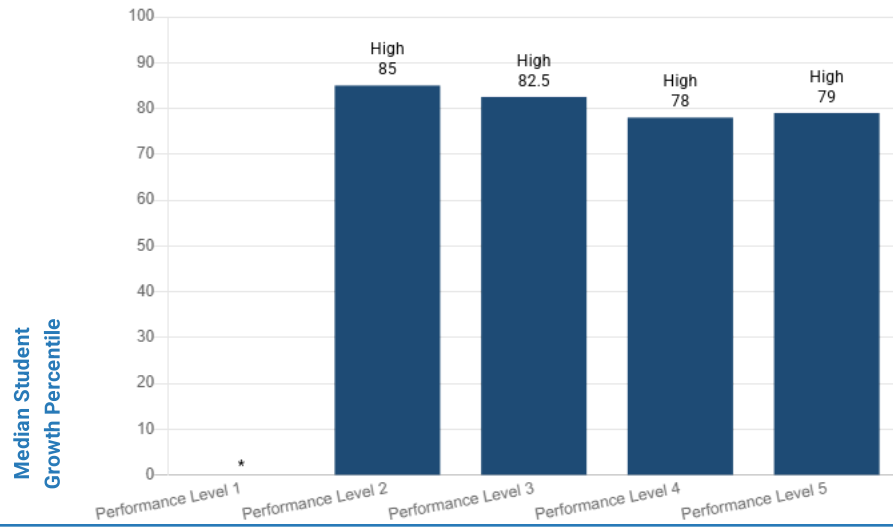

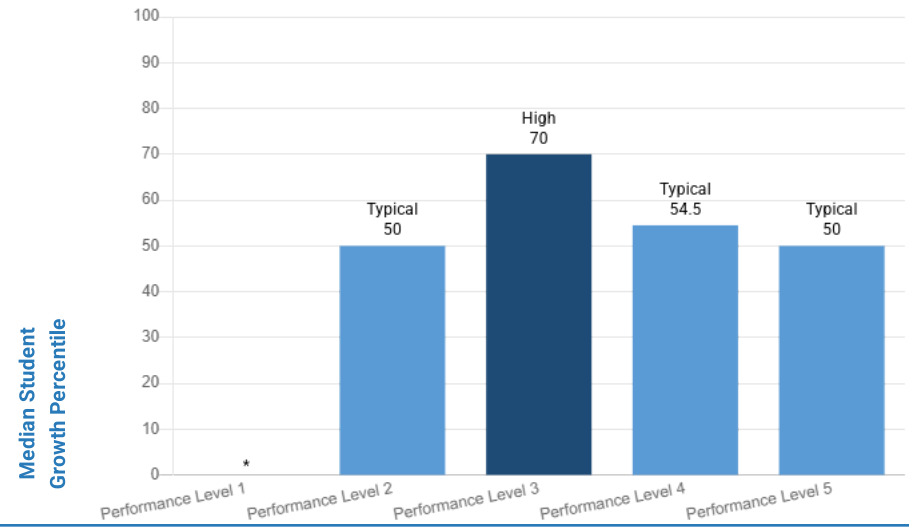

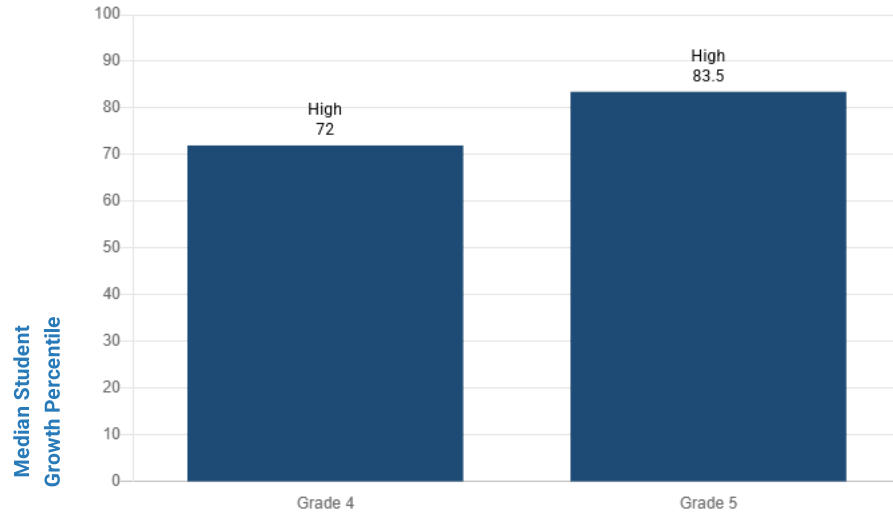

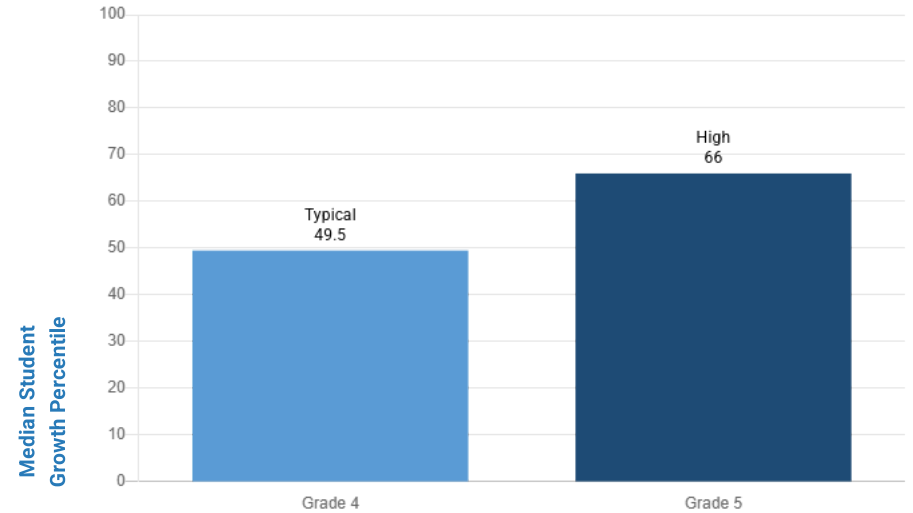

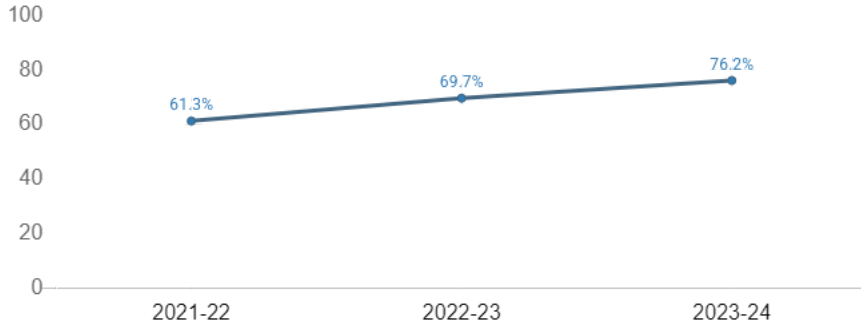

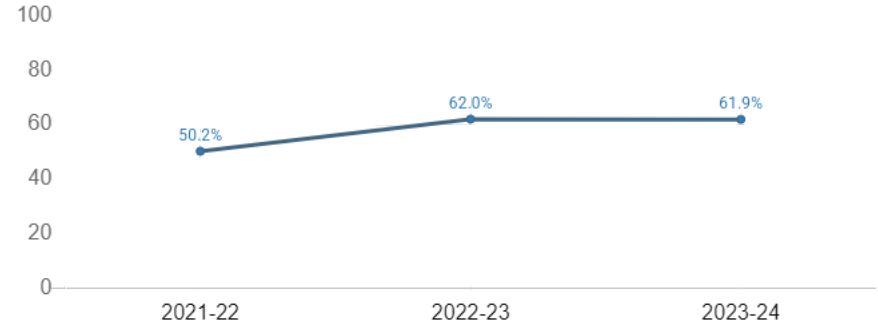
### English Language Arts and Mathematics Performance Trends

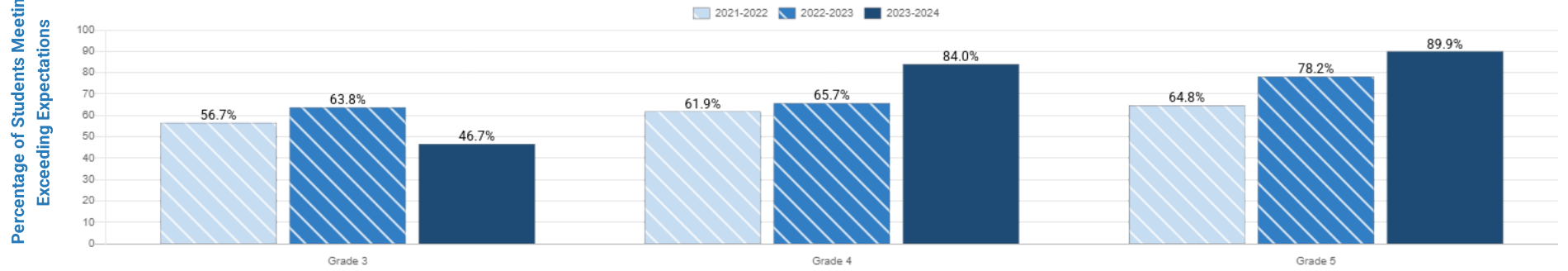

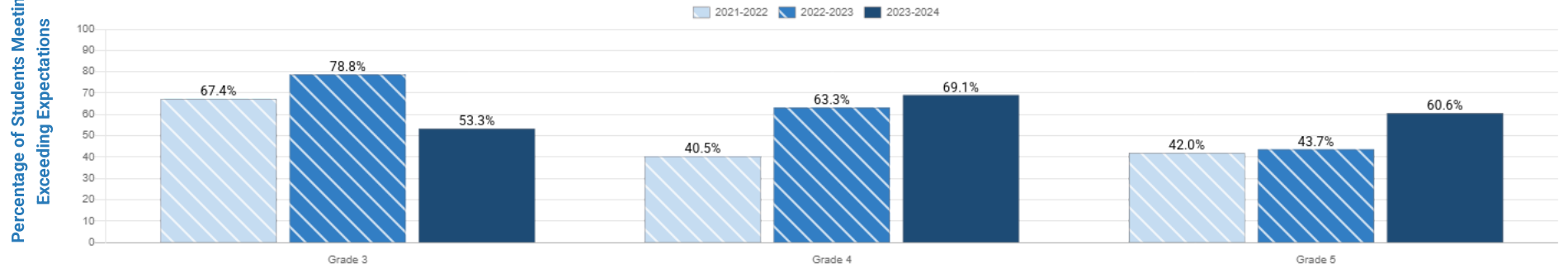

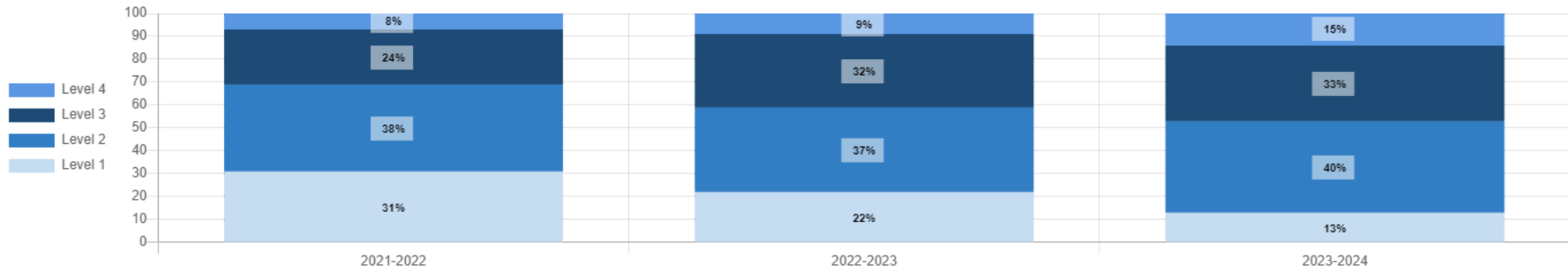

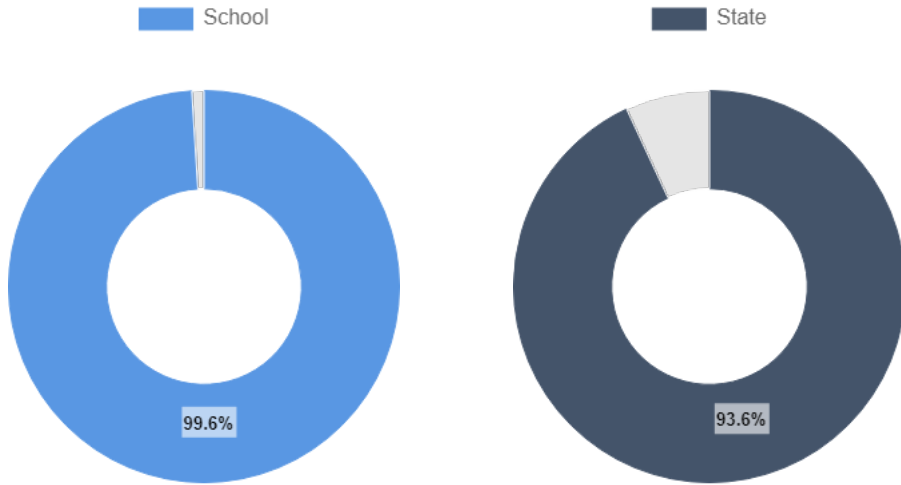

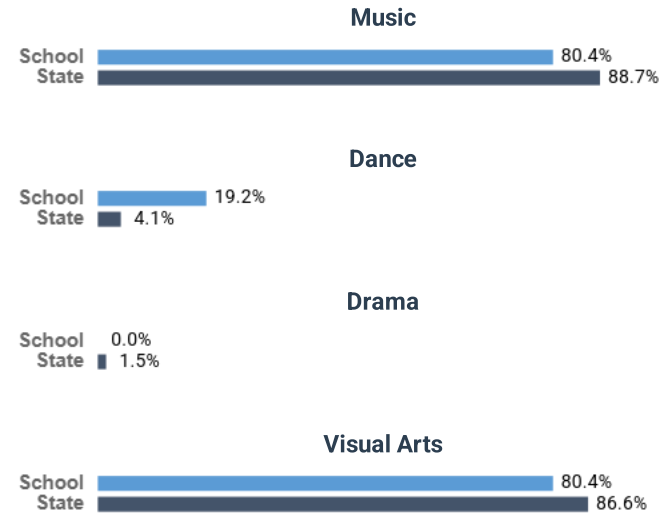

**Students enrolled in one or more classes by discipline:**



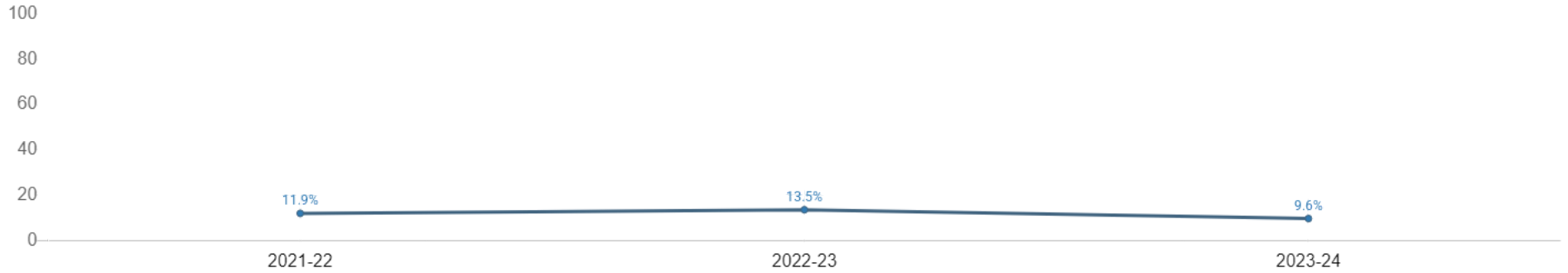

The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. Each student group has the same target based on all students, so the same ESSA Target will appear for all student groups. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

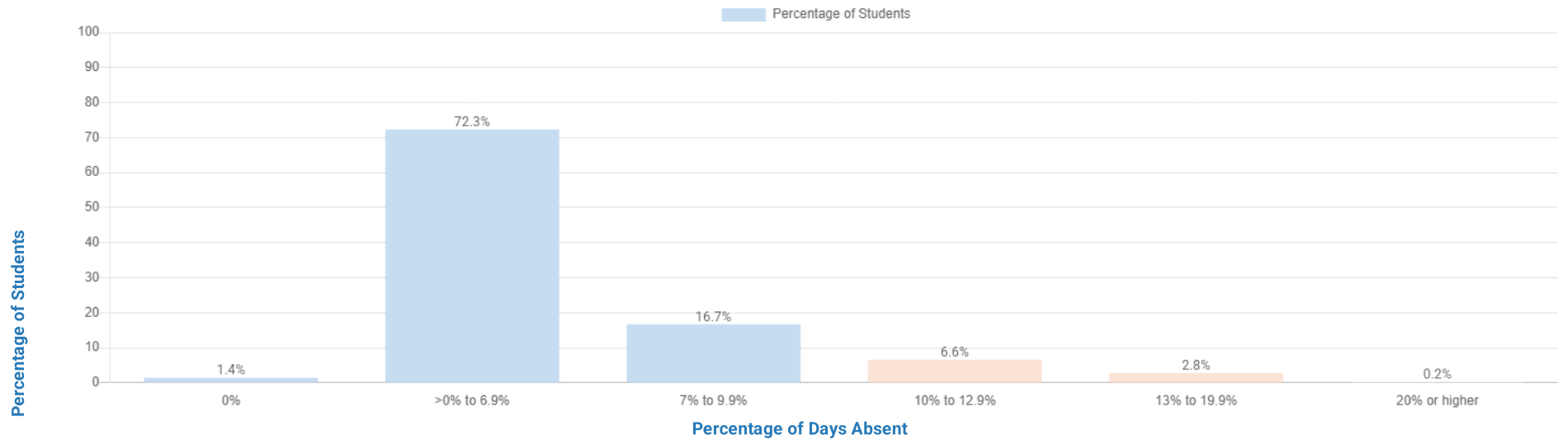

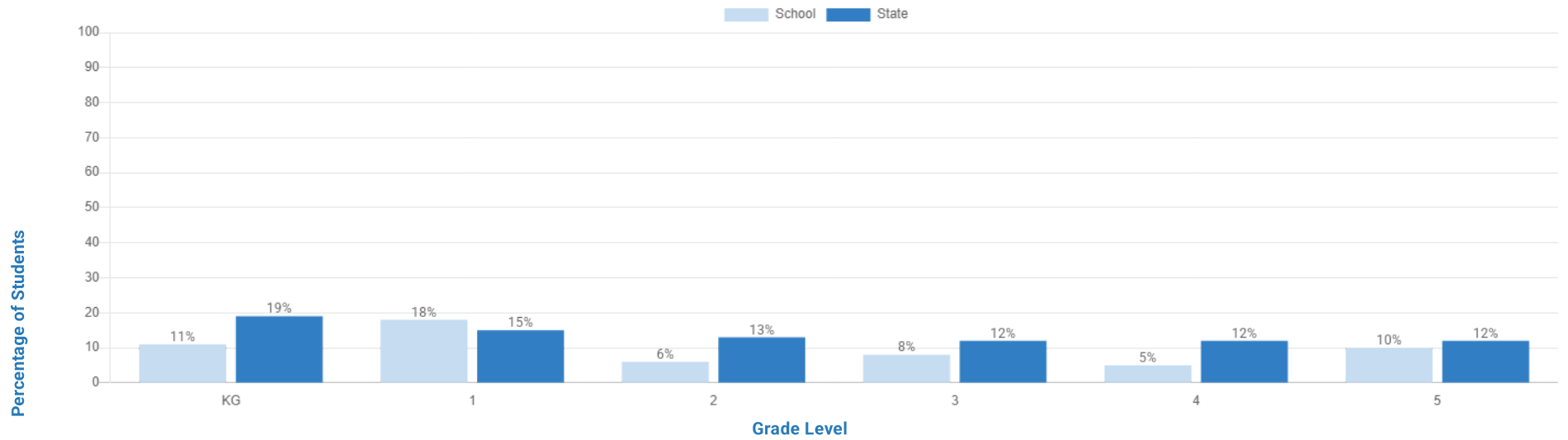

## Staff

Staff data reflects teachers and administrators reported by districts at the beginning of the school year.

**Key terms for staff data:**

**Teachers:** All classroom teachers

**Administrators:** Principals, assistant principals, supervisors, coordinators, directors, and other central-office administrators, as well as superintendents and other district-level administrators

**Experience:** Experience is based on information submitted by districts on all their staff members. For purposes of this report, the ESSA Educator Equity and federal reporting requirements, NJDOE has defined teachers as "inexperienced" if they have fewer than four years of prior experience in a given district. The tables below report on "experienced" teachers and administrators for federal reporting purposes.

**Out-of-Field:** A teacher is labeled "out-of-field" if they are potentially teaching outside their area of certification. This could occur if the teacher cannot be found in the NJDOE's certification system, if their job code does not match their certification, or if the teacher has an expired certificate.

**Provisional Teacher:** A teacher with provisional certifications is a fully certified novice teacher of record who must meet further requirements of evaluation and mentoring during their induction into the profession before being granted "standard" or permanent certification.

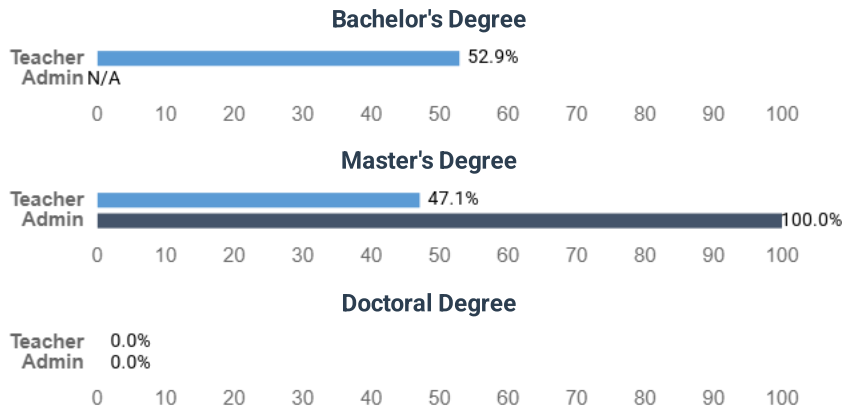

Students are immersed in courses in music, art, physical education, health, media studies, and world language.



### Clubs and Activities:

Students may elect to engage in the following clubs: Drama Club, STEM Club, Strategic Games Club, Future Acts, Newspaper Club, and the Environmental "Green" Club. The majority of these clubs are available to students in grades two through five. Band, orchestra, and chorus are offered as a supplemental program to our fourth and fifth grade students. In addition, students in fifth grade may be selected to serve as a School Safety. School safeties support arrival and dismissal procedures, as well as, the orderly operations of special events.



### Before and After School Programs:

Intensive before and after school tutoring programs provide diagnostic-prescriptive instruction for identified students. Tutoring programs provide academic and/or behavior supports.

### Staff and Professional Learning:

The staff engages in district-level and site-based, job-embedded professional development opportunities. These high-quality workshops develop theoretical understanding, provide demonstrations and/or modeling, and include opportunities for collaboration. Analysis of student data guides the content of these programs. In addition, the sharing of instructional strategies through professional learning communities (PLCs) adds to the innovation of these professional development experiences.



### Student Supports and Services:

Student supports range from academic to social/emotional. A variety of academic supports are provided through our intervention/enrichment programs. We have intervention specialists, reading and math specialists, basic skills staff, and an enrichment/TAG teacher. All teachers analyze data during scheduled data meetings and determine academic supports and tiered interventions. In addition, school counselors, nursing services, board certified behavior analysts and clinical associates, and character programs support the social and emotional needs of our students. Collectively, MTSS teams and I&RS teams work with teachers to make decisions regarding the supports and services for individual students.



### Student Health and Wellness:

The school is committed to providing a learning environment that promotes student wellness, proper nutrition, health education, and regular physical activity for all students. Breakfast is offered and served daily in each classroom to promote proper nutrition, improve concentration, and increase student performance in the classroom.

Our school offers parent involvement in a variety of formats. Our Home and School Council is an active organization along with our district Special Education Parent Advisory Group (SEPAG). Parent involvement nights such as Parents as Partners and Stepping Up to the Next Grade offer informative sessions about curriculum, instruction, and social and emotional supports. Parents are active on school-based committees, and they are also involved in school events and special programs.

### School Safety:

Each school has a School Safety Team. This team works diligently to support our school safety plans including the rehearsal of drills, ensuring policies and procedures are followed, and annually updating our school emergency handbook. Aside from school safety plans, the School Safety Team works collaboratively to support arrival and dismissal procedures, plan special assemblies, and continuously evaluate measures to ensure safety. In addition to our district security personnel, each of our schools have a school resource officer.



### Technology and STEM:

At the elementary level, digital platforms continue to be infused appropriately into the curriculum. This allows technology to open doors for students to access a world of knowledge that exists beyond the doors of our school. All of our classrooms are equipped with ipads and/or laptops, document cameras, Red Cat amplification systems, LCD projectors, and/ or short throw projectors. Our school enables parent access to student performance and attendance using our student and data management system. Students engage in STEM activities during science, digital literacy, and through maker spaces. The school has a Lego Wall, and students are encouraged to join the STEM club.



### Attendance:

At the elementary level, programs such as ROAR (Raising Our Achievement Rates), the High Impact Tutoring grant, and additional time programs were put into place to address academic needs. Digital tools, such as Beable, were utilized during station rotations or Lit Lab periods to further focus on bolstering academics. Social and emotional programs were expanded through our counseling department and students and teacher benefited from coaching on Building Executive Function Skills.
