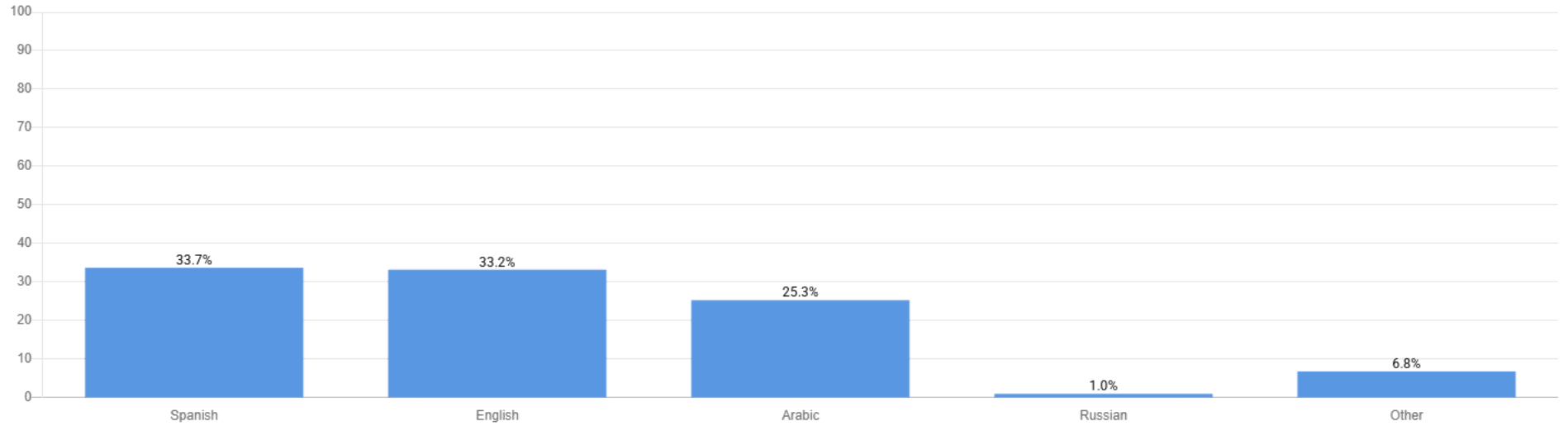

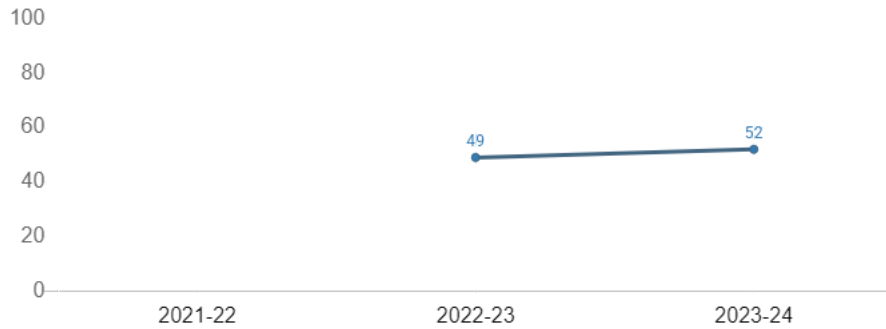

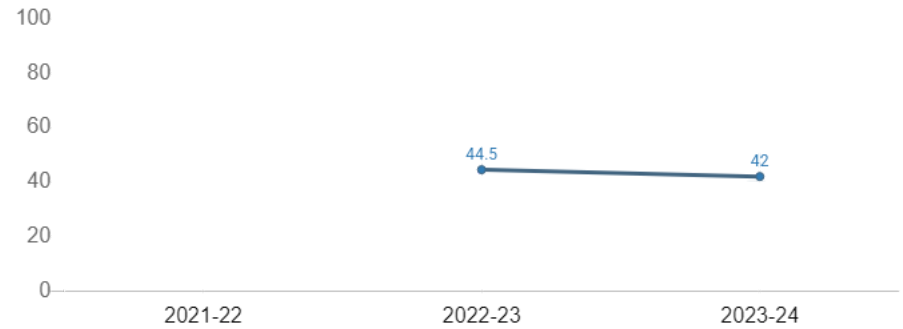

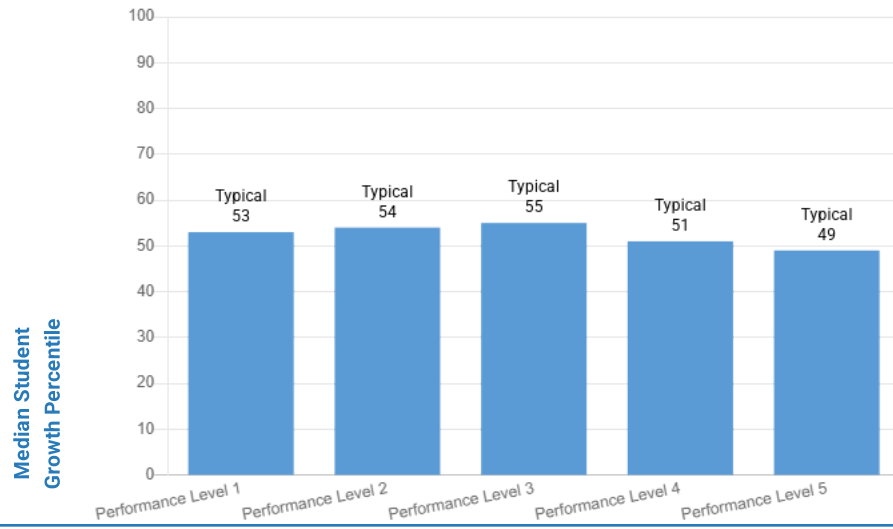

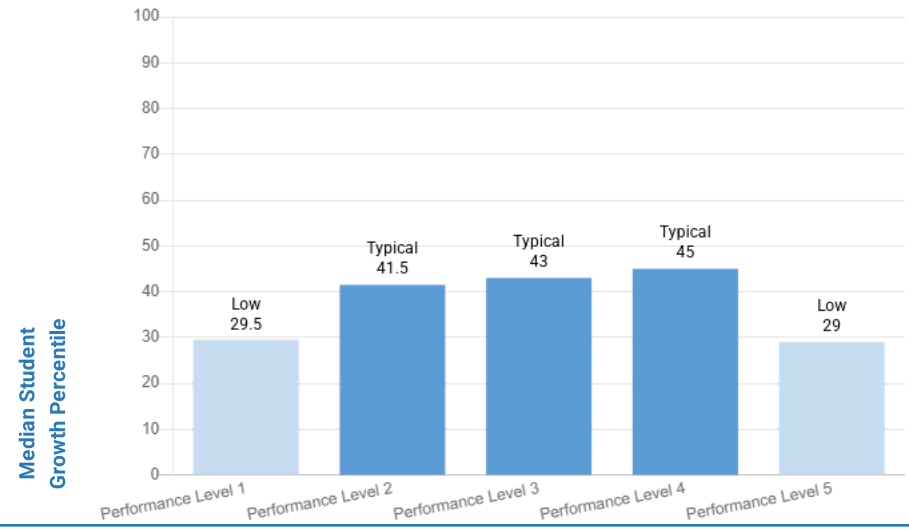

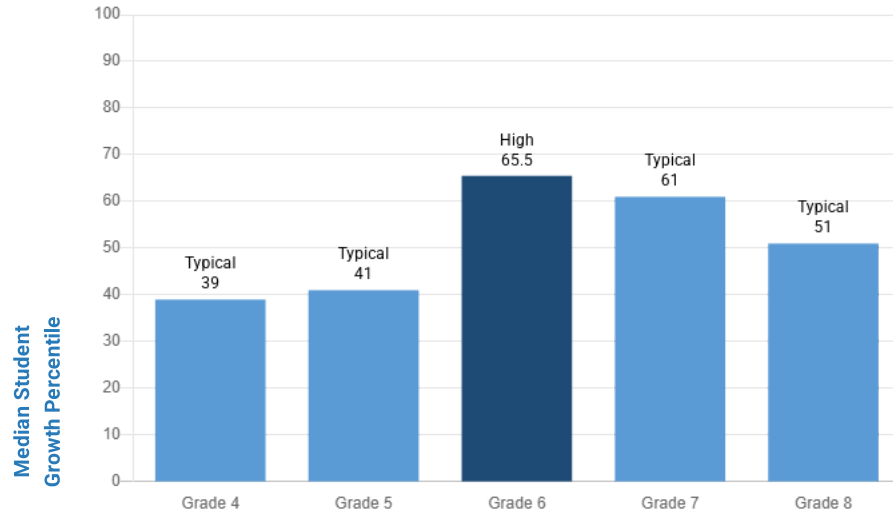

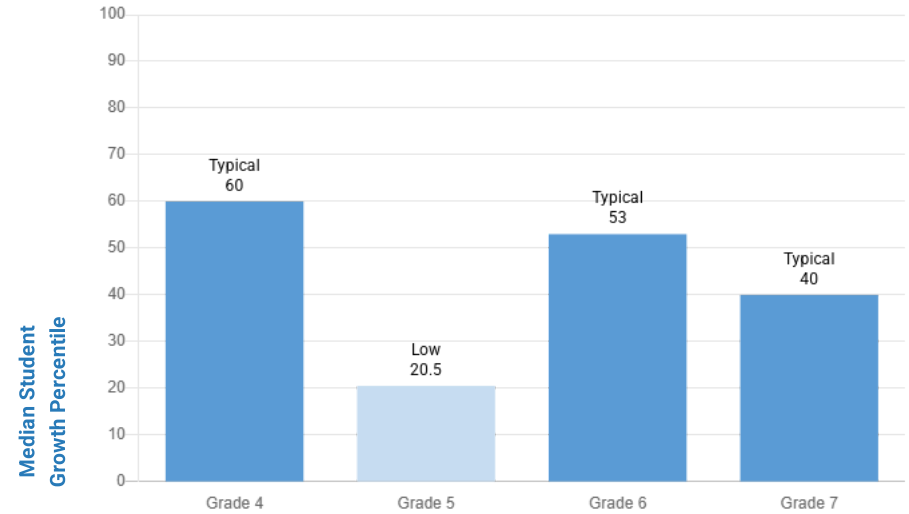

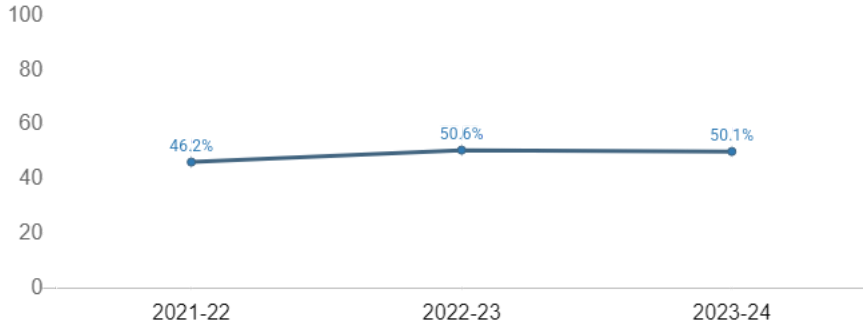

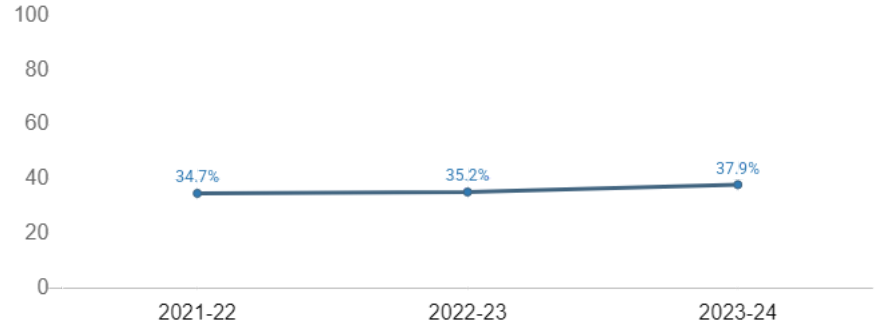
English Language Arts and Mathematics Performance Trends

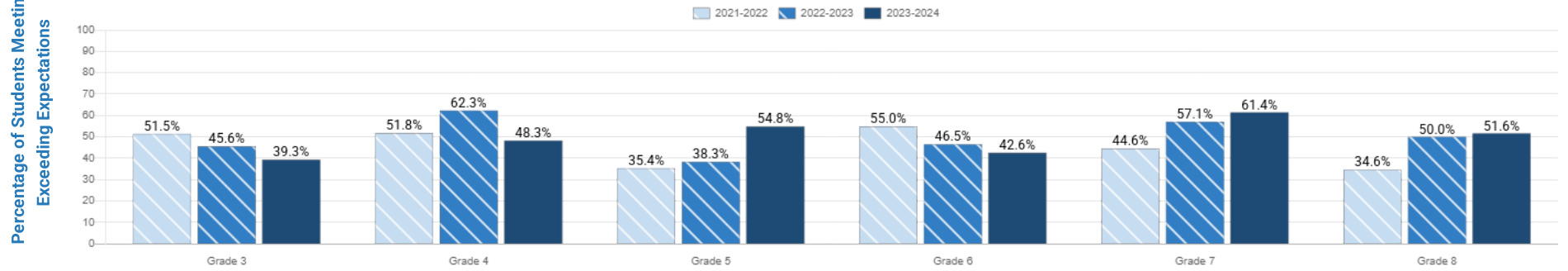

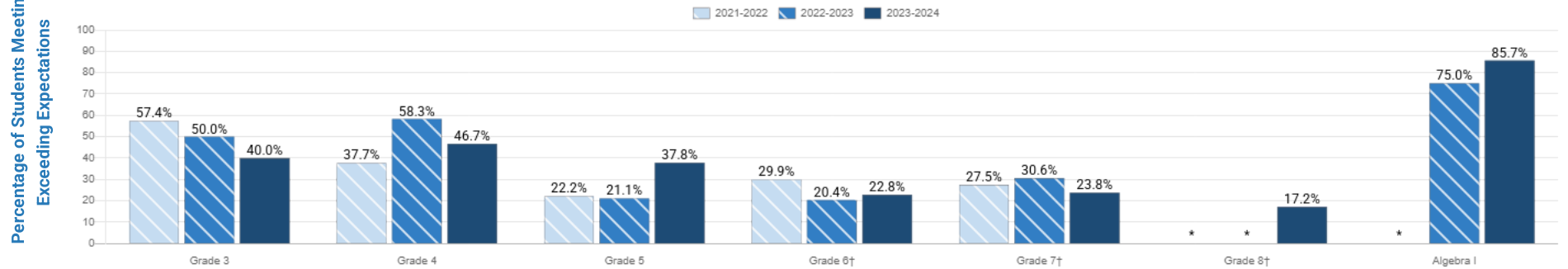

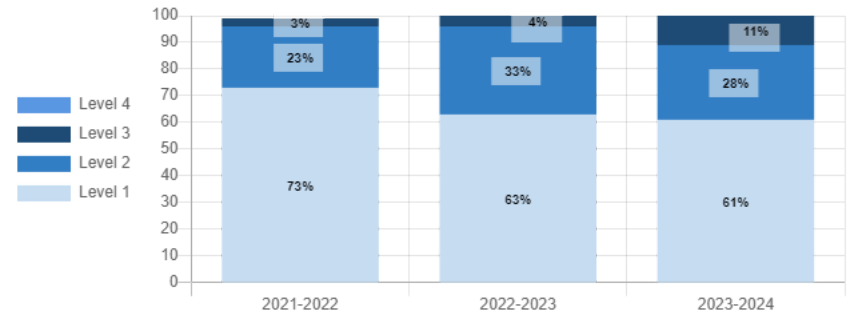

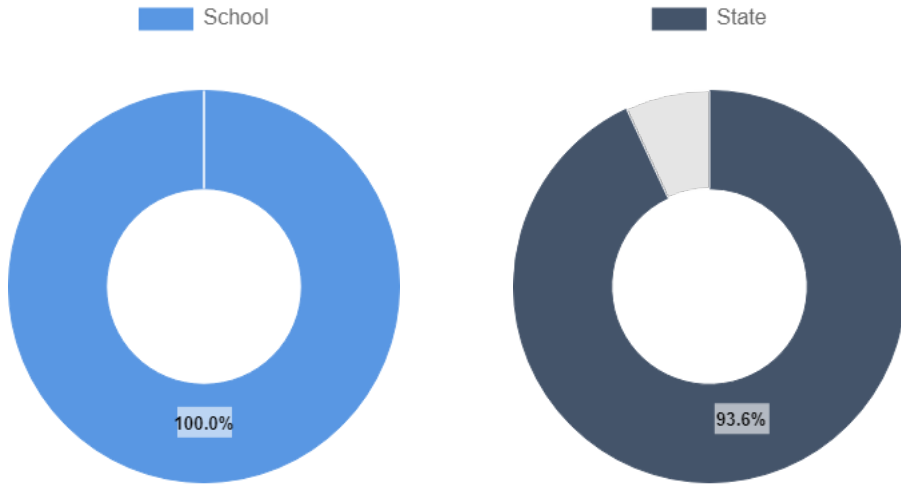

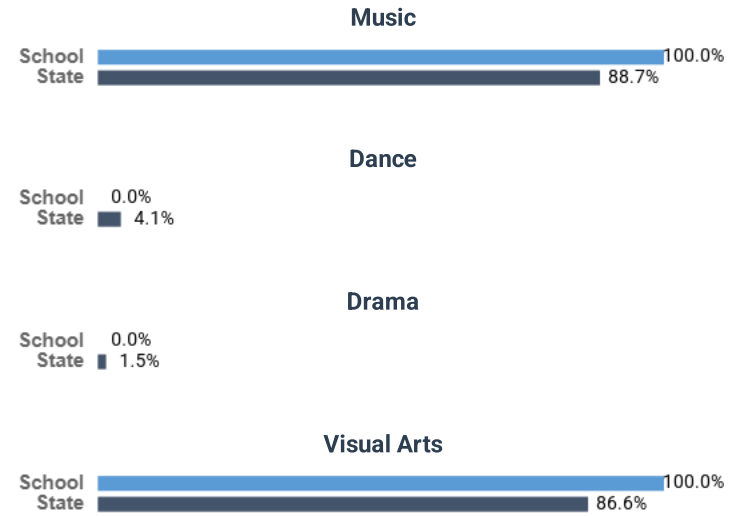

Students enrolled in one or more classes by discipline:



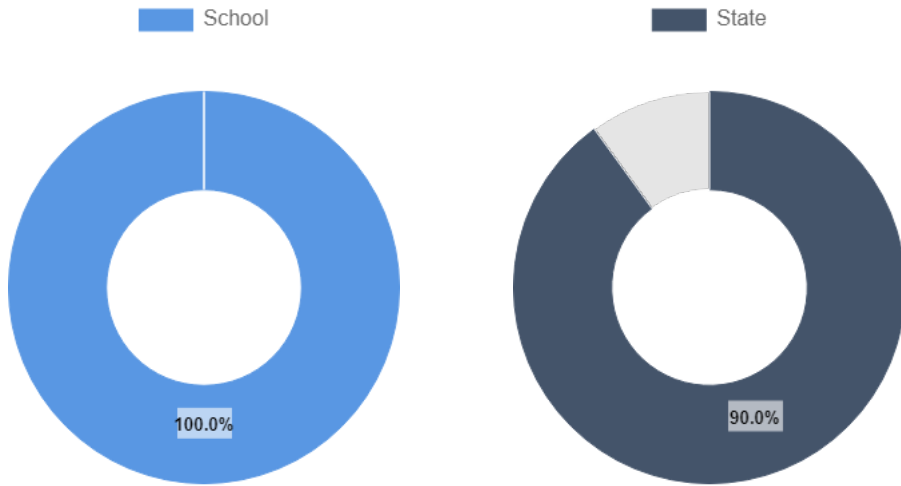

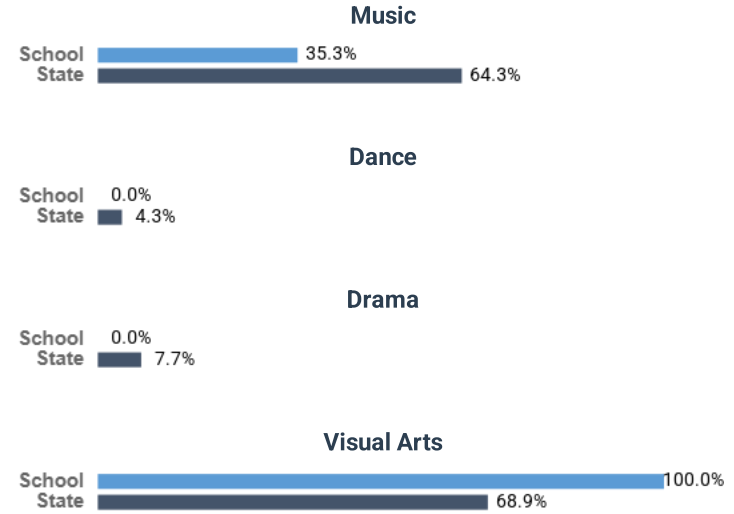

Students enrolled in one or more classes by discipline:



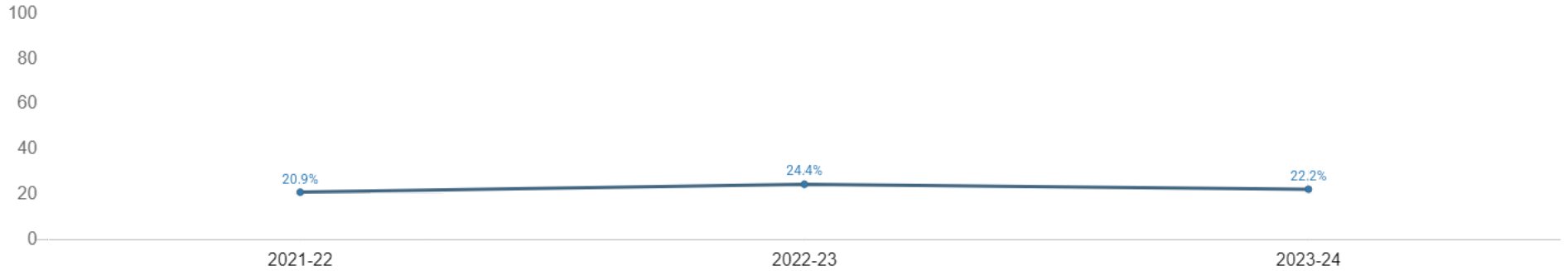

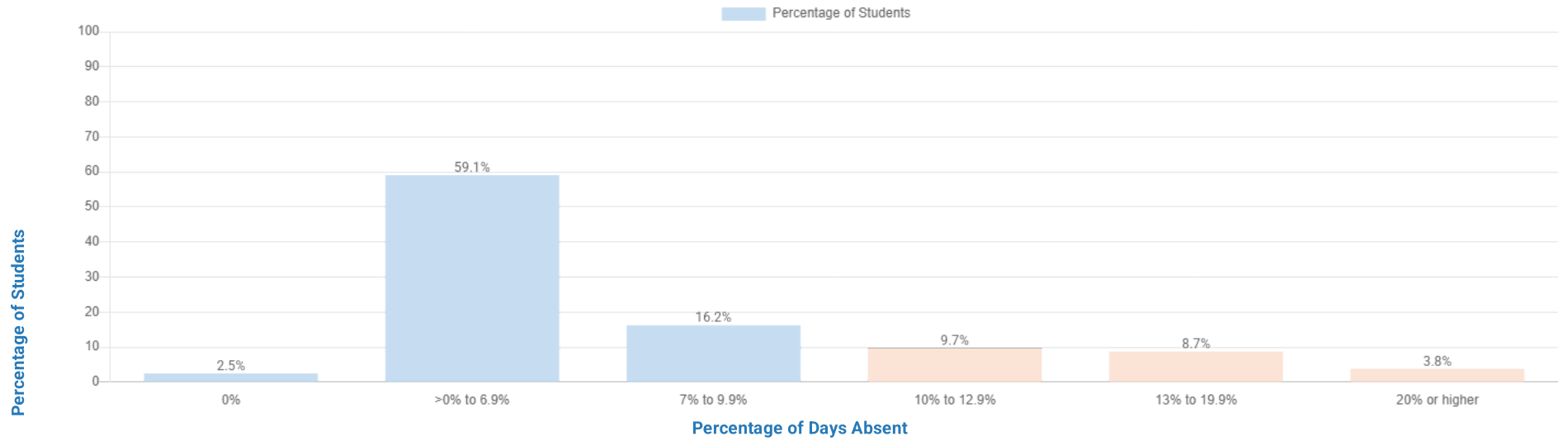

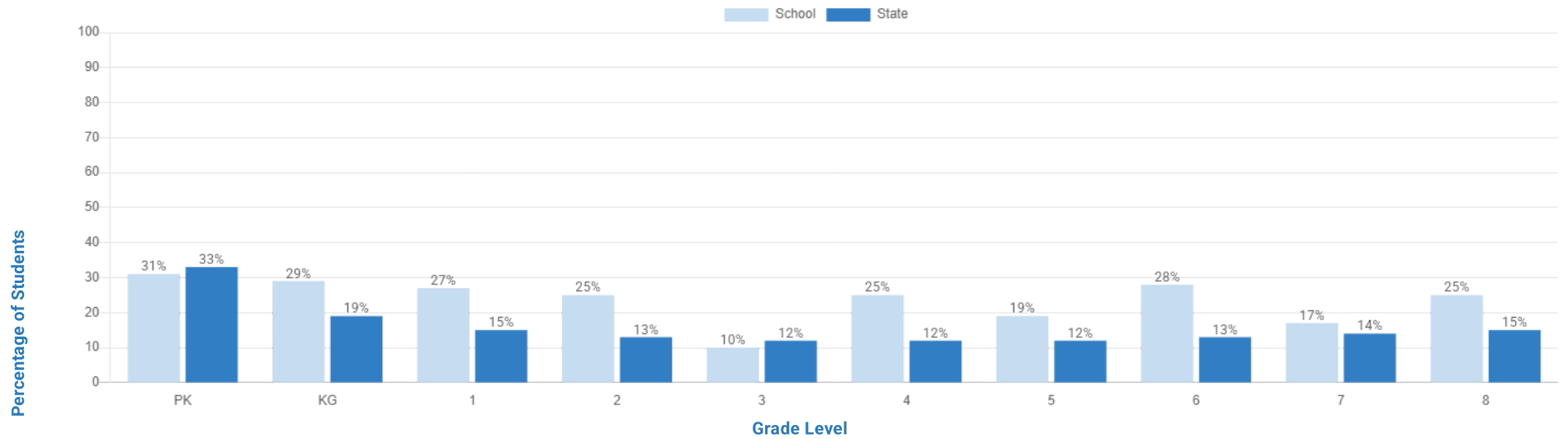

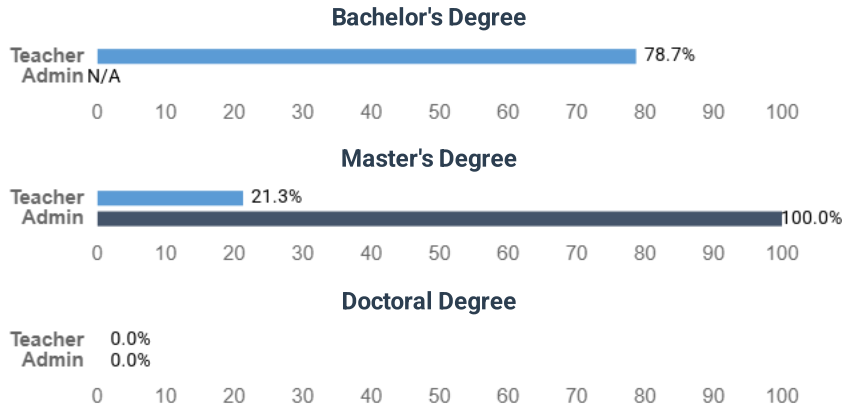

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. - Technology is used to drive instruction as each student in grades 2- 8 have a school issued Chromebook, while grade PreK-1 students have school issued tablets.
- The district continues to utilize Seesaw and Schoology Learning Management Systems (LMS). All students and parents had access to Seesaw and Schoology.
- Extracurricular activities took place throughout the school year.

Instruction is driven based on the NJSL and NGSS standards and assessment. Dr. Walter F. Robinson Community School has a variety of diverse learners. Our programs include general education, special education (both resource room and inclusion), English as a Second Language (ESL) and Bilingual Arabic and Spanish classes.

Before and After School Programs:

A number of before and after school activities are offered to our students. In addition to before and after school childcare, we offer ARMS tutorial classes in both ELA and math to targeted students in grades 3-8. An AM Mathematics Tutorial class is offered each day for students in danger of failing and/or possible retentions in grades 4-8. Programs such as the Latino Family Project and the Arabic Family Project and Homework Helper are offered for our ML population. High Impact Tutoring (HIT) was added for Gr. 3 students providing additional supports three days a week to students.



Staff and Professional Learning:

Professional development is key in our building and district. Staff members are provided opportunities throughout the year for in-house Staff Training and Development on district directed days. In addition, our faculty members are provided PLC opportunities weekly via common preparation periods and monthly during faculty meetings. Science teachers are also provided PD in STEM via our NJ RAISE program. In addition, since our school is the home to our ESL/Bilingual Program, our teachers are actively involved in TESOL.



Student Supports and Services:

ML- The ML population is housed in our building. The assistant supervisor of the program is on-site full time to track the success of the program. Students with Disabilities-The needs of our students are met as addressed via IEPs. A social worker was available twice a week for additional student counseling. I & RS-Our I & RS team meets weekly to track struggling students and provide support for the best learning opportunities. Our school has a full-time school counselor on-site. Additionally, a mental health counselor was added to service students.

We partake in the Breakfast in the Classroom (BIC) program daily where all students are provided a healthy breakfast to start the day. In addition, programs such as Healthy Generation, along with daily recess time and eighty minutes of physical education per week promote the importance of health and wellness among our student body. Two nurses are on staff to meet the needs of our students, as well.

We currently have the original auditorium, which continues to serve our students and staff. An extension was added 16 years ago making our campus quite large. The building is partially air-conditioned.



School Safety:

Safety is a key component to our school climate. Robinson Community School has a Security Team, under the guidance of our School Resource Officer, that follows protocol in checking any person entering our building. Our school is armed with three walk-thru metal detectors, as well as hand-held wands for extra security checks. In addition, our school Safety and Security Team, which is made up of administrators, teachers, our nurse, our secretary, and our guidance counselor, meets regularly to review and adjust procedures, discuss concerns, and ensure the safety of our students and staff.
