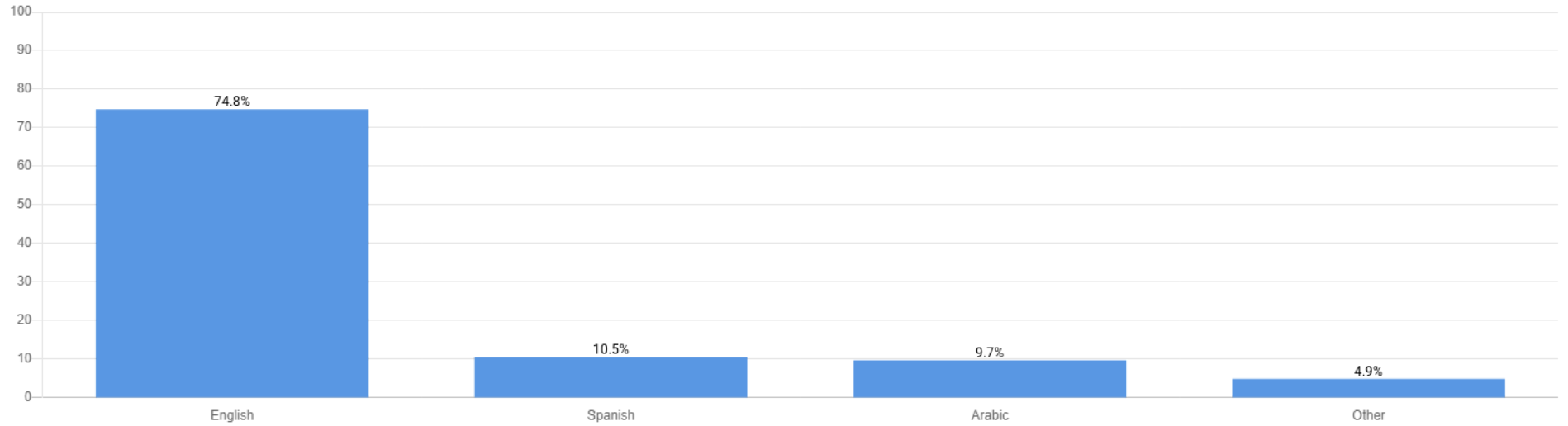

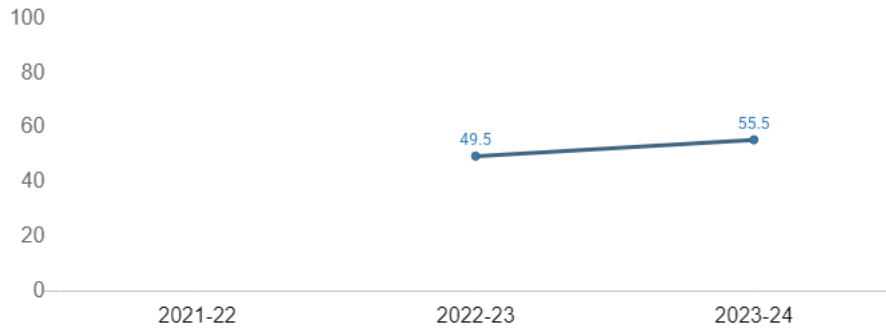

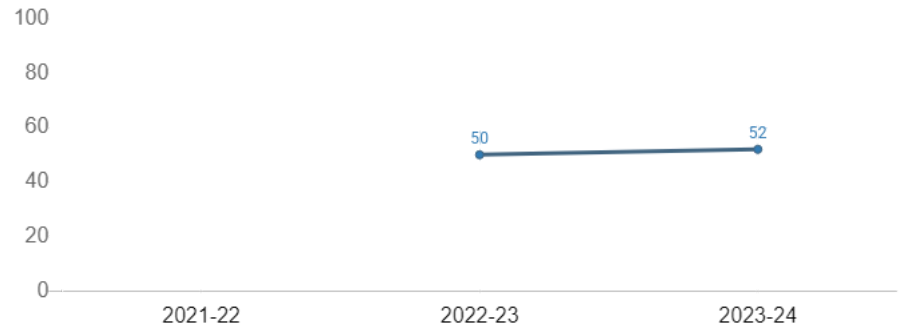

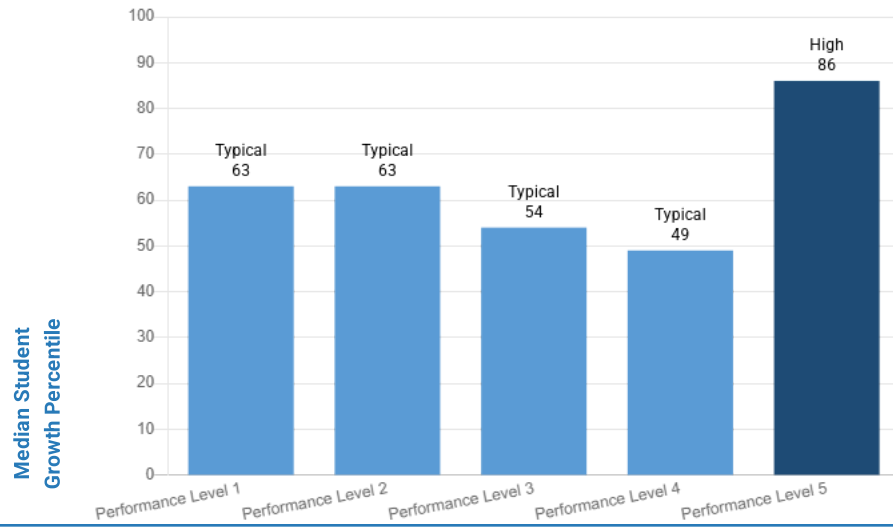

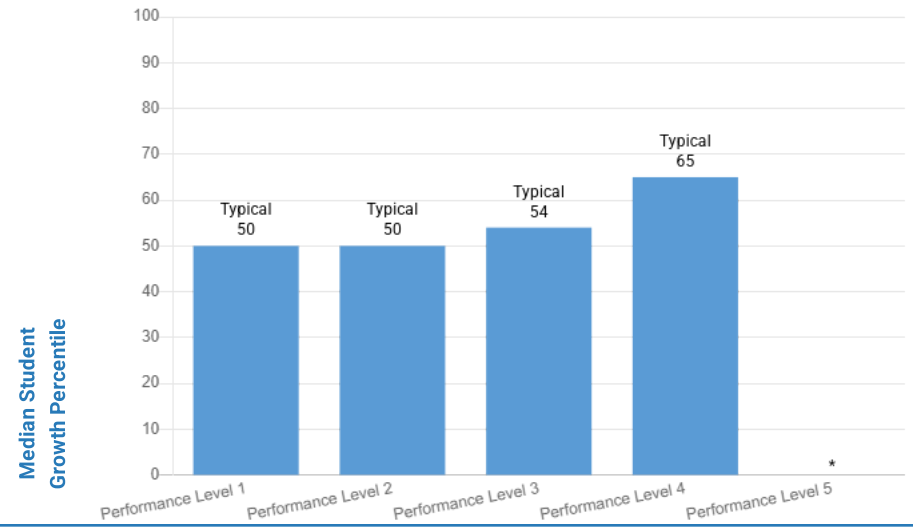

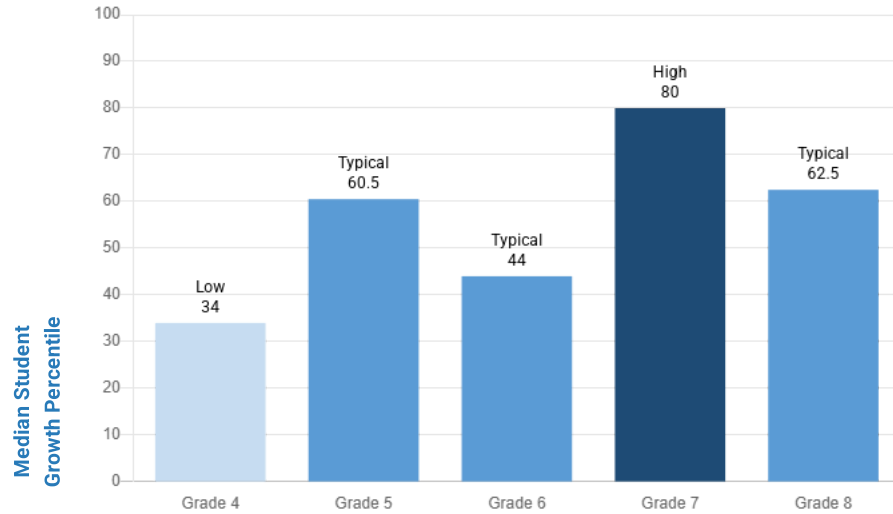

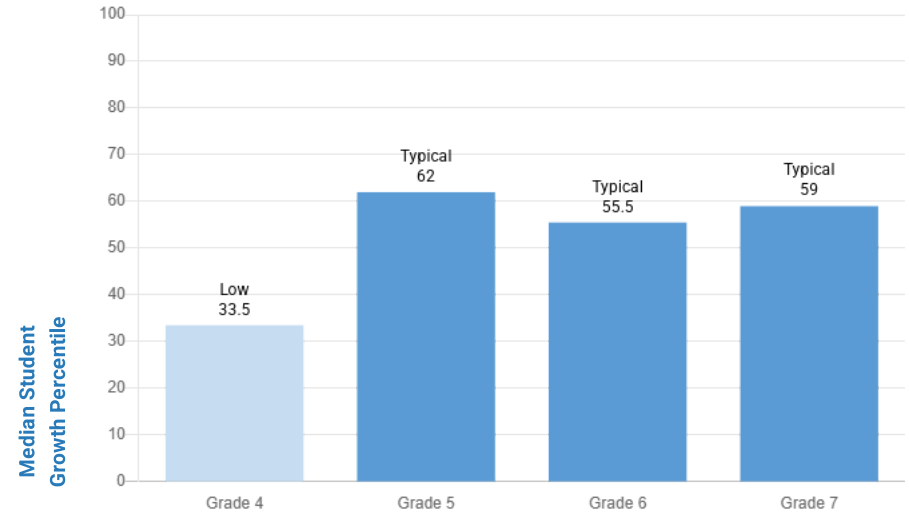

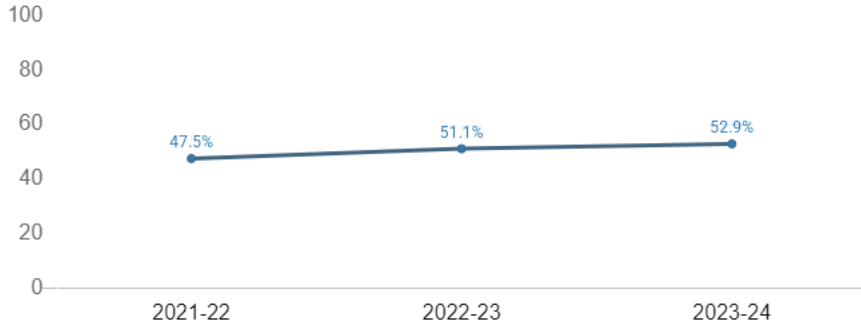

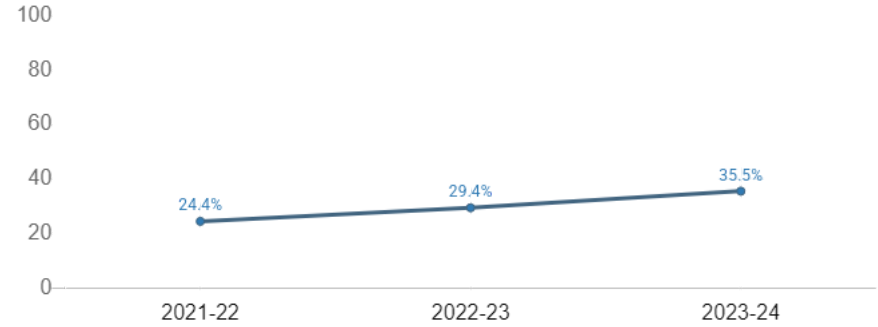
### English Language Arts and Mathematics Performance Trends

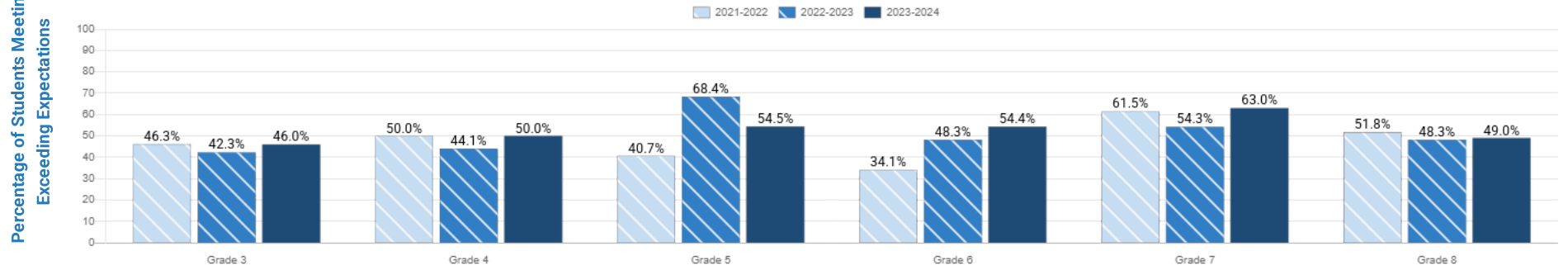

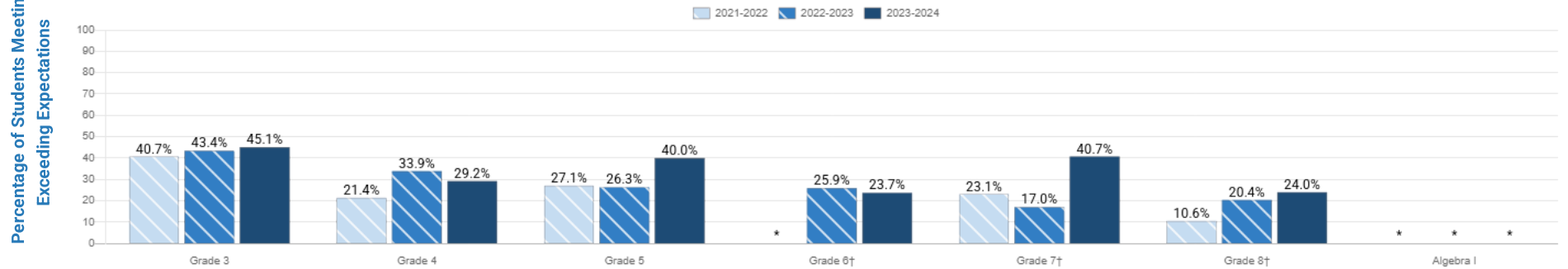

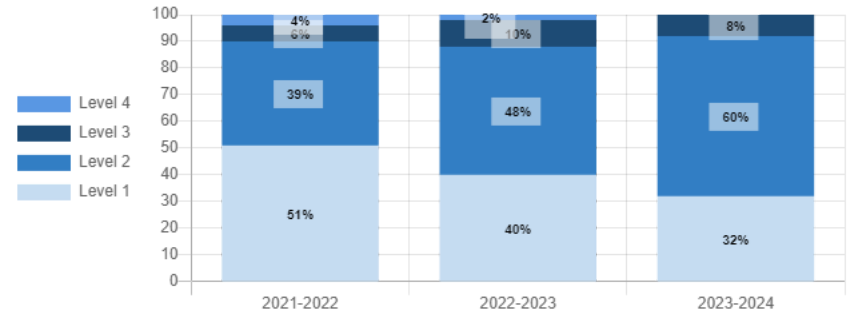
**NJSLA Science Assessment: Grade 5 Summary**

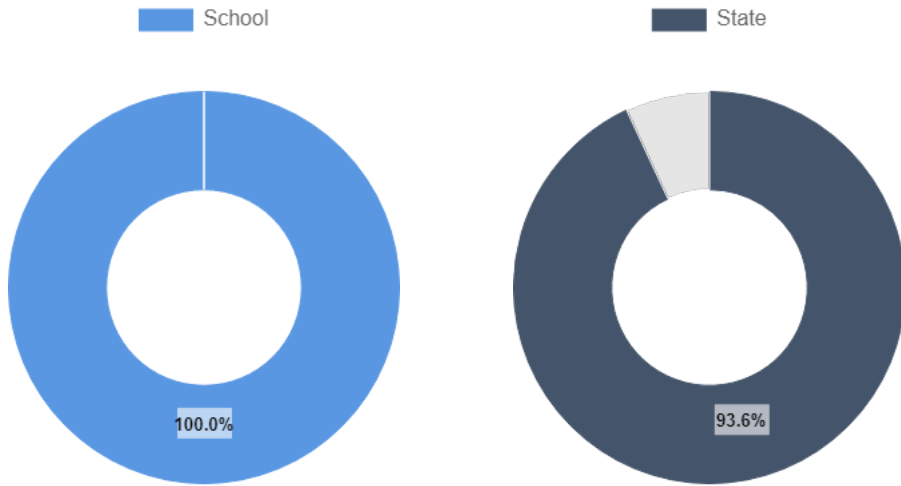

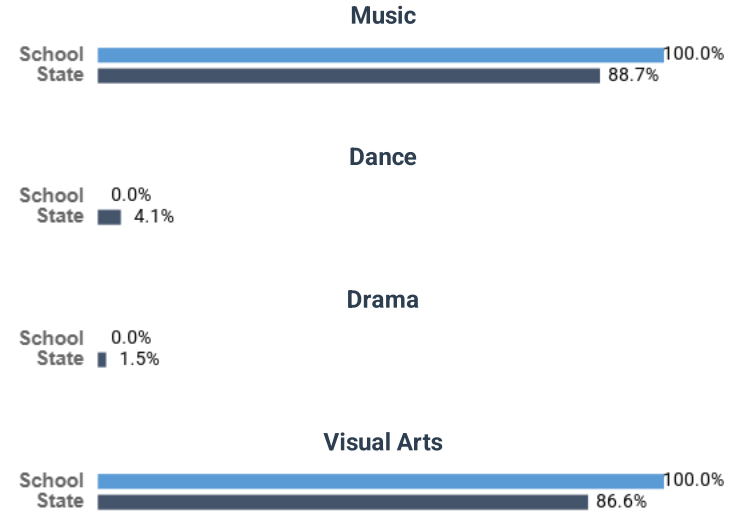

**Students enrolled in one or more classes by discipline:**



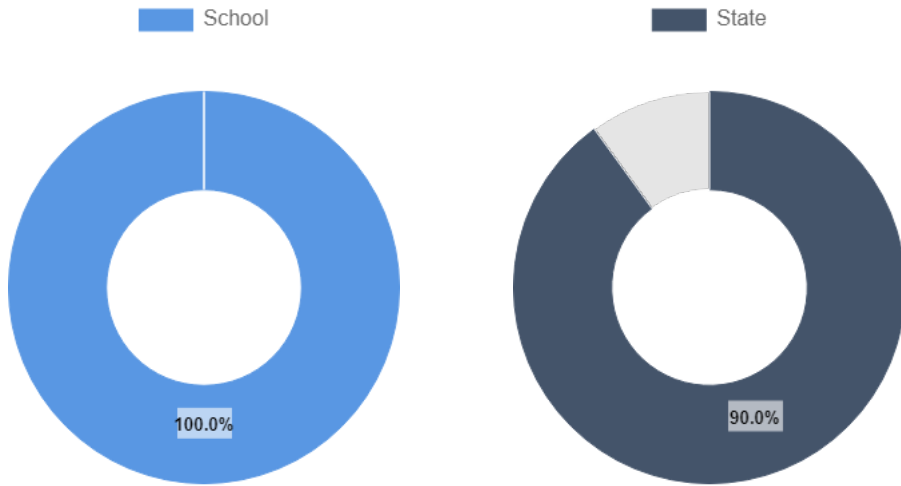

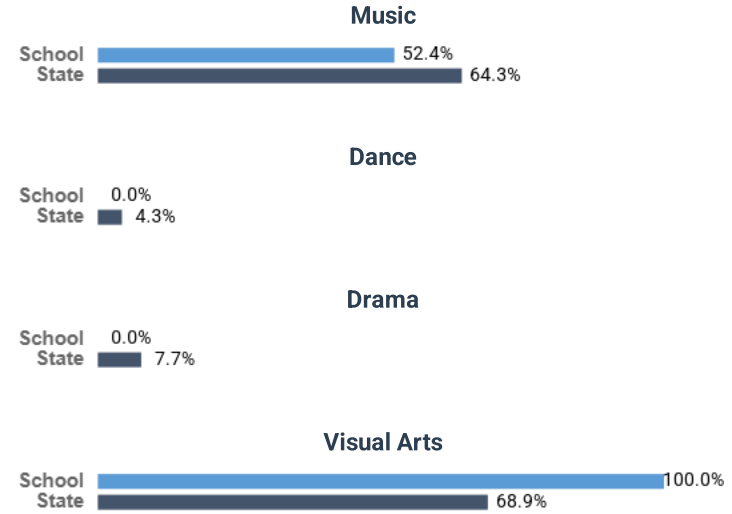

**Students enrolled in one or more classes by discipline:**



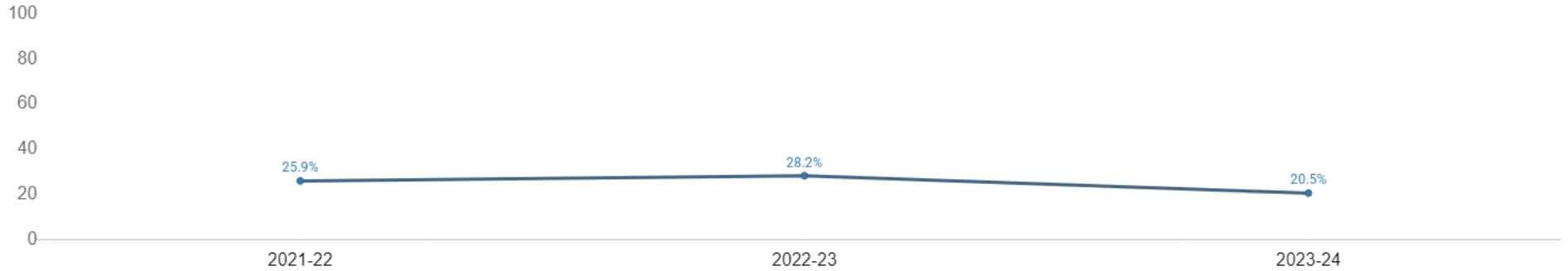
## Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

### Chronic Absenteeism Trends

This table shows the number and percentage of students in grades K-12 both overall and by student group who were chronically absent during the school year. Pursuant to N.J.S.A. 18A:38-25.1, any school where 10 percent or more of the students enrolled are chronically absent must develop a corrective action plan to improve chronic absenteeism rates. The Requires Corrective Action Plan column in the table indicates whether the school's chronic absenteeism rate is 10% or higher, meaning that the school must complete a corrective action plan. The NJDOE Data-based Decision Making for Addressing Chronic Absenteeism guidance document (found on the [NJDOE attendance page](#) under Chronic Absenteeism) provides districts with guidance on responding to chronic absenteeism and includes sample corrective action plan templates.

The ESSA Target: State Average for Grades Served column is the target used for ESSA accountability purposes. It reflects the statewide average for students in the grades offered by the school. The last column shows whether the rate for each student group was above the state average ("Not Met") or less than or equal to the state average ("Met").

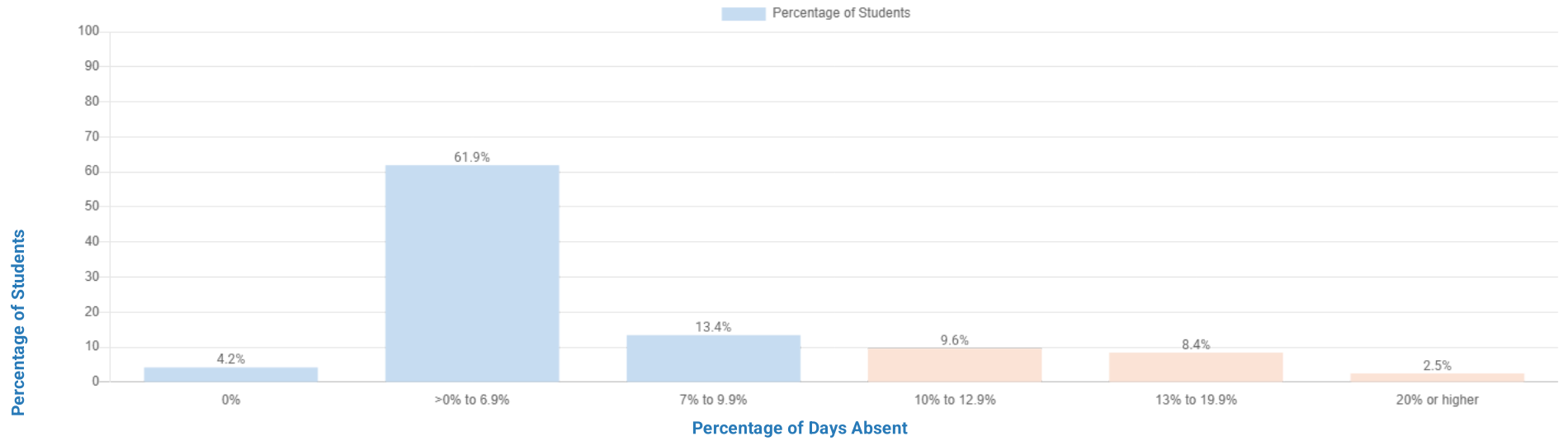

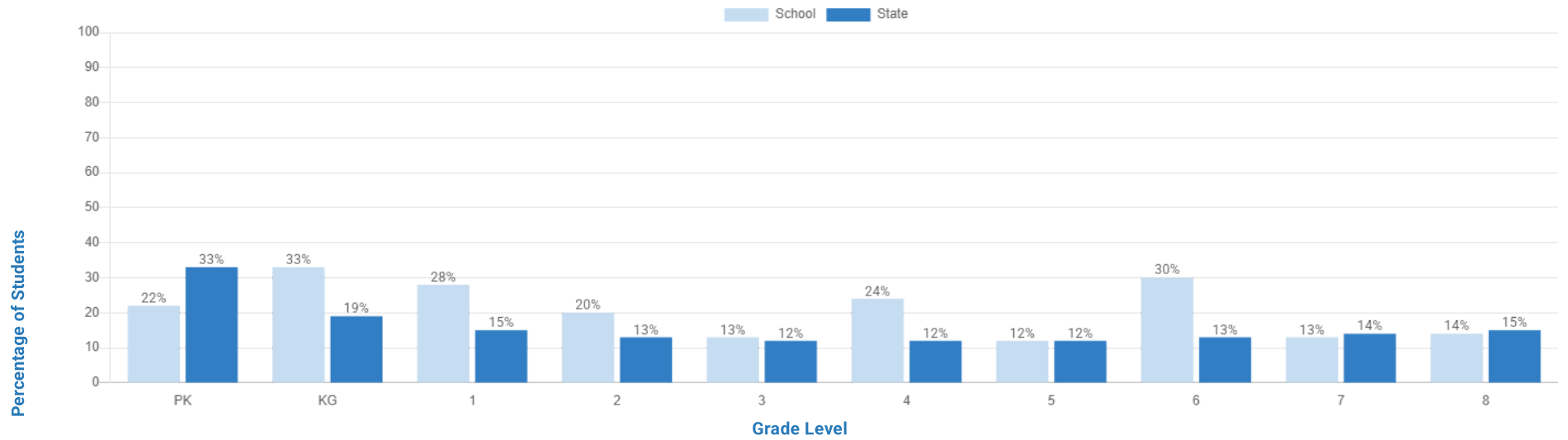

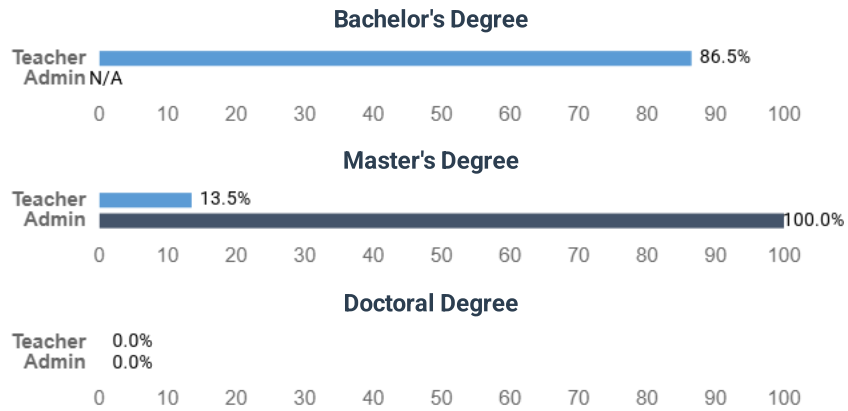

## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Schools are identified for TSI if they have at least one student group that missed annual targets or standards for all indicators for two years in a row. Along with 21 individual classrooms, our school has a gymnasium, health office, technology room, art room, library/media center, two teacher lounges, girls and boys restrooms and a multipurpose room where different types of events take place. There are two school yards, one located in the front of the building and the other on the side.



### School Safety:

At Mary J. Donohoe Community School safety is our first priority! There are two metal detectors where students, teachers and visitors pass through every day and there bags are screened by our receptionist. Our school doors remain locked from the outside at all times. Any person that wishes to enter the building must call the school first to confirm an appointment. Upon arrival each visitor will check in at our reception desk where they are logged into our system and issued a visitor's pass. We have a school safety/climate team that meets monthly to discuss the safety of our students and teachers in the building. MJD also has interior and exterior cameras with direct feed to the main office and the principal's office. Each and every day there is an armed security guard in our building for added security.



### Technology and STEM:

Each student in grades Pre K-8 has access to an electronic device that is used daily to complete assignments. Students in the Pre K & Kindergarten use Acer tablets while students in grades 1-8 use chromebooks. Most every classroom in the building has a smartboard where teachers use to project and work interactively with their students. Students participate in Project Innovate, STEM Showcase, Robotics Club, Science Fair, VR goggles and the Tello Drone Program.
