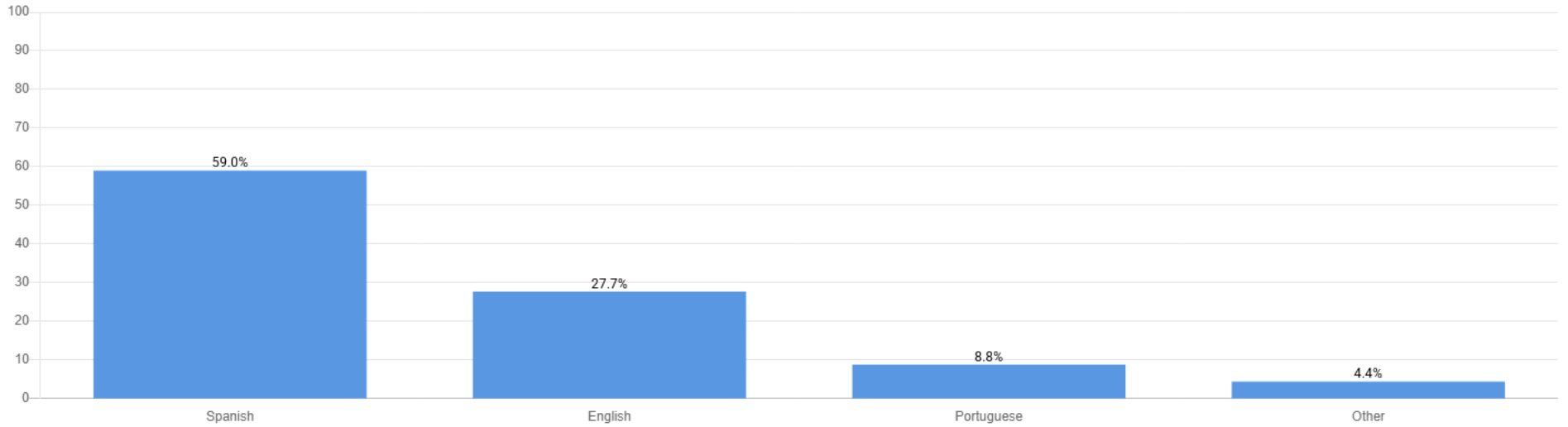

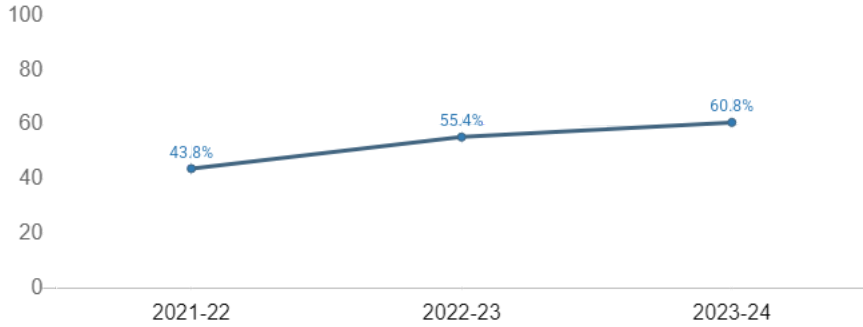

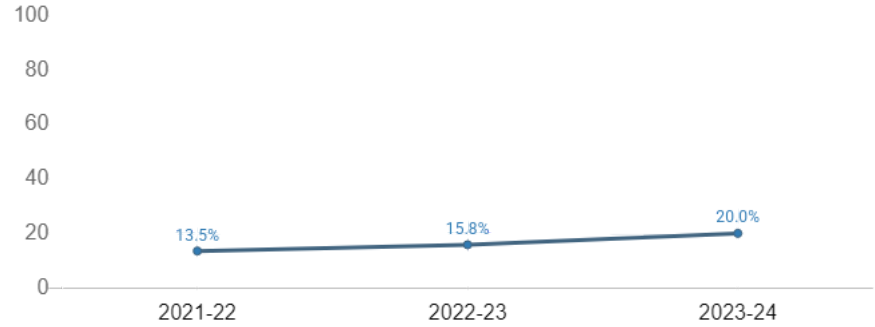
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 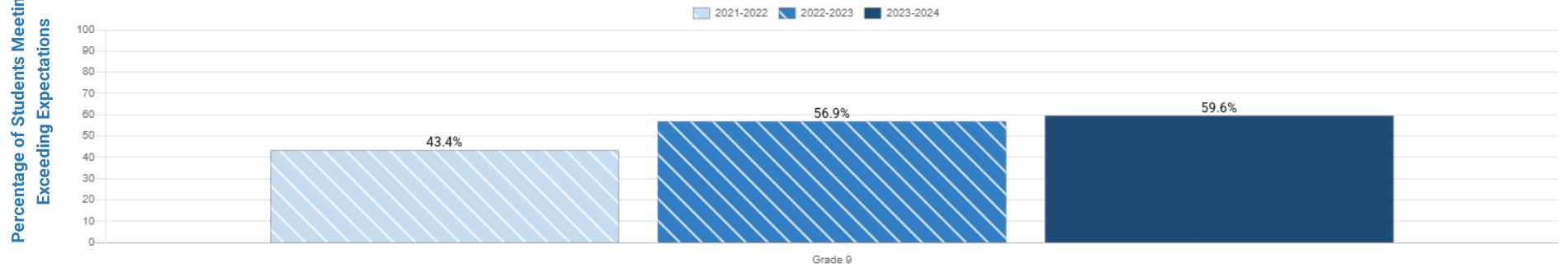

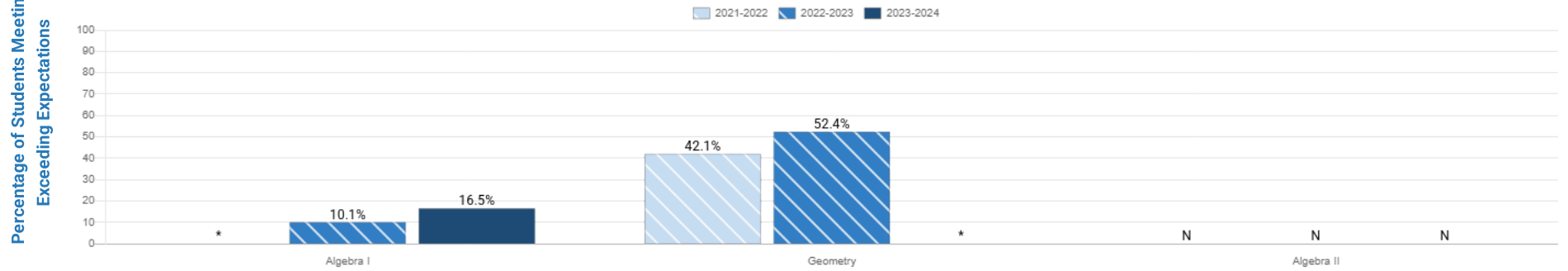

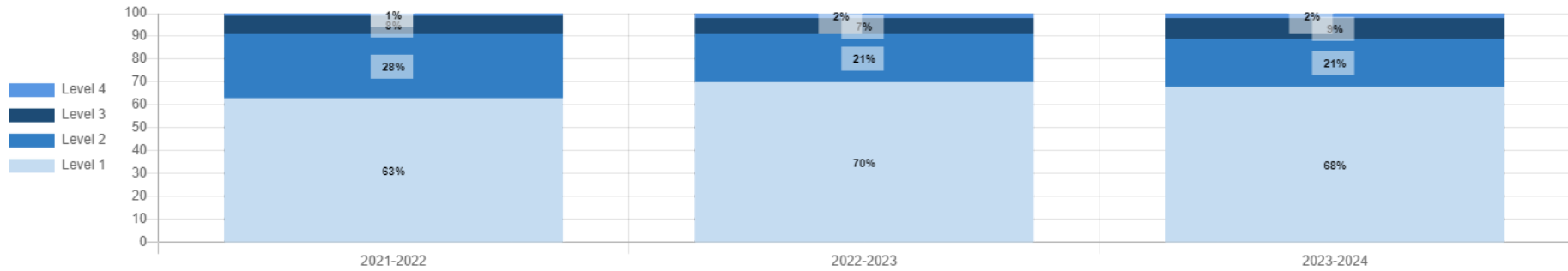

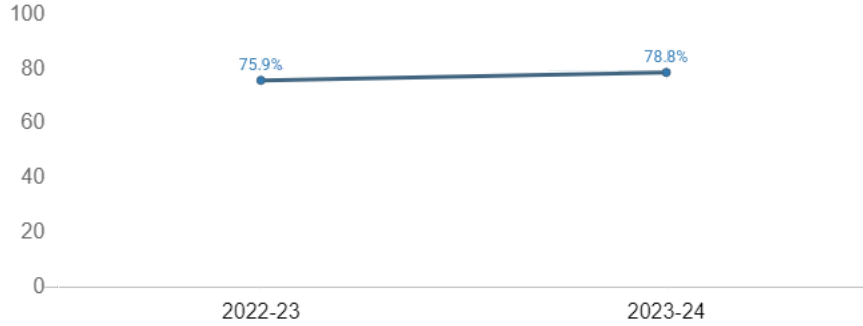

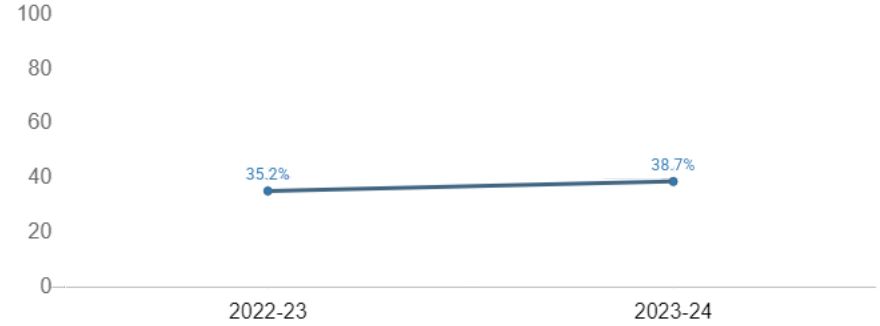

Students taking one or more AP or IB exam

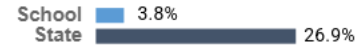

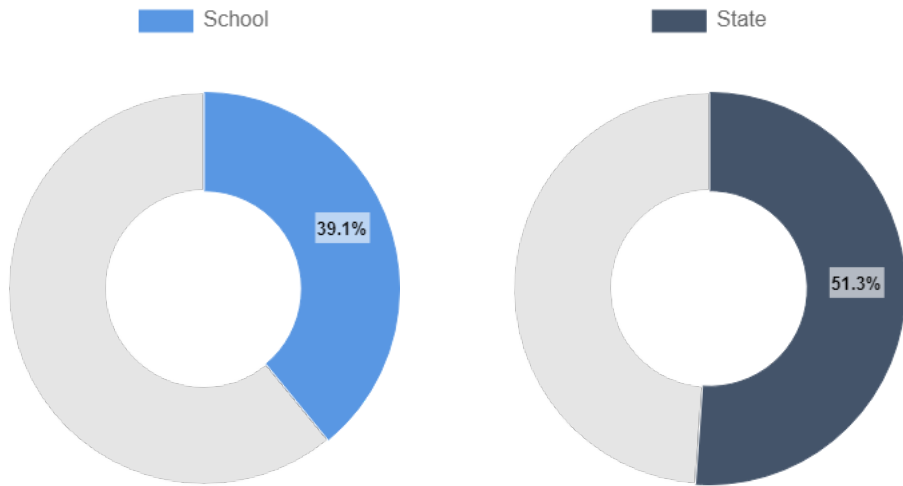

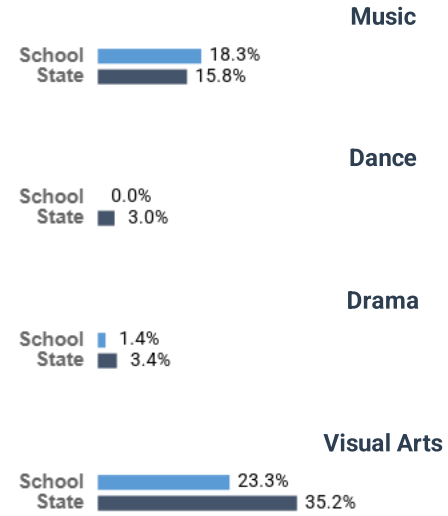

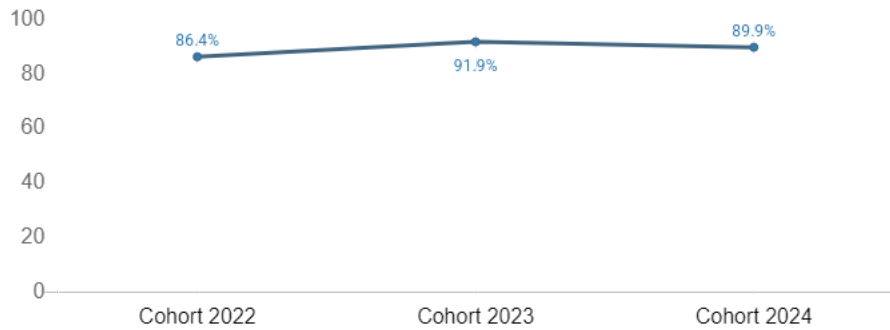

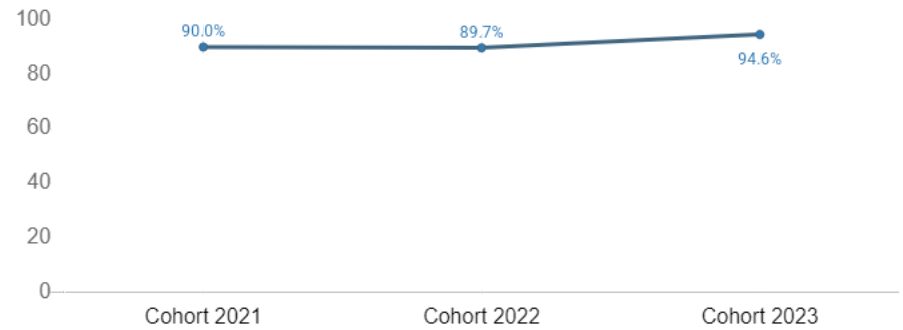

Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

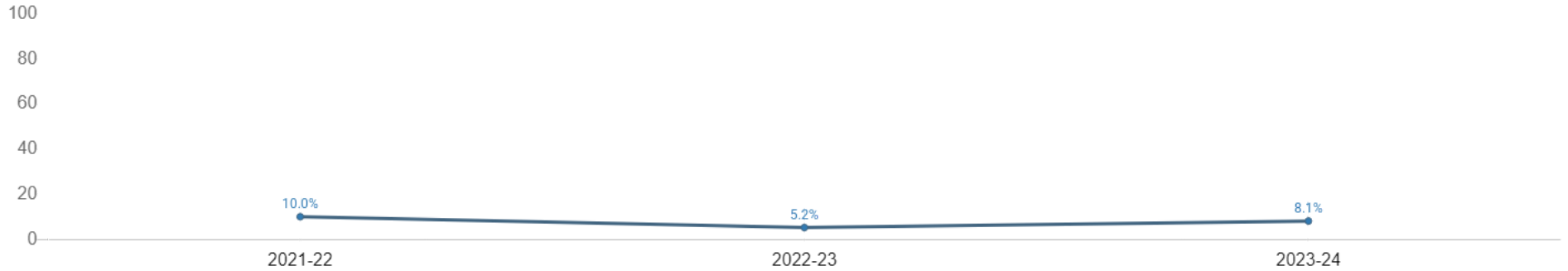

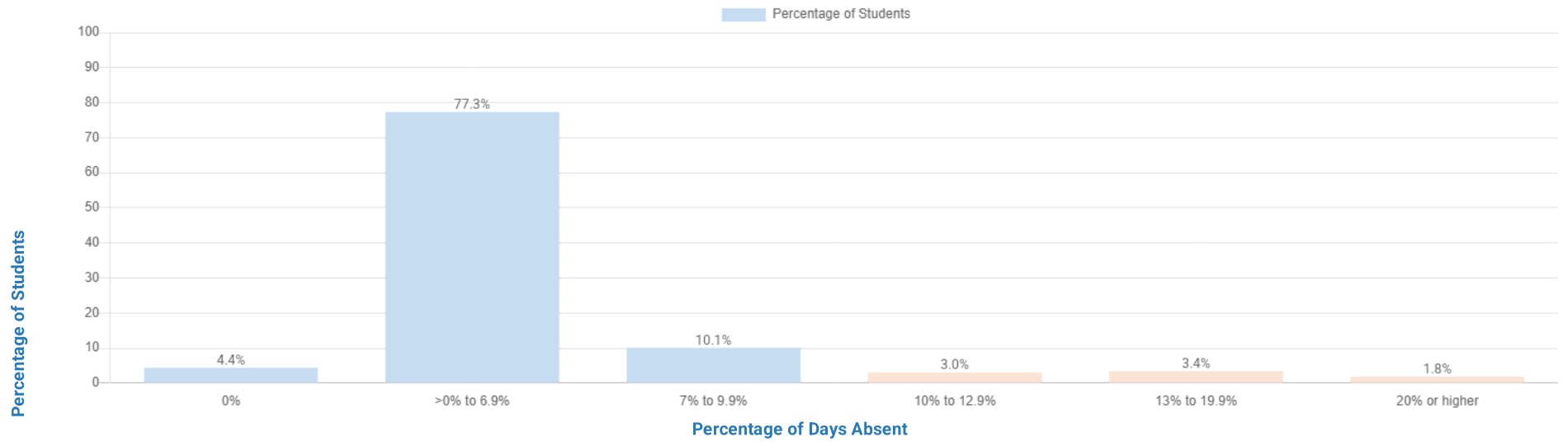

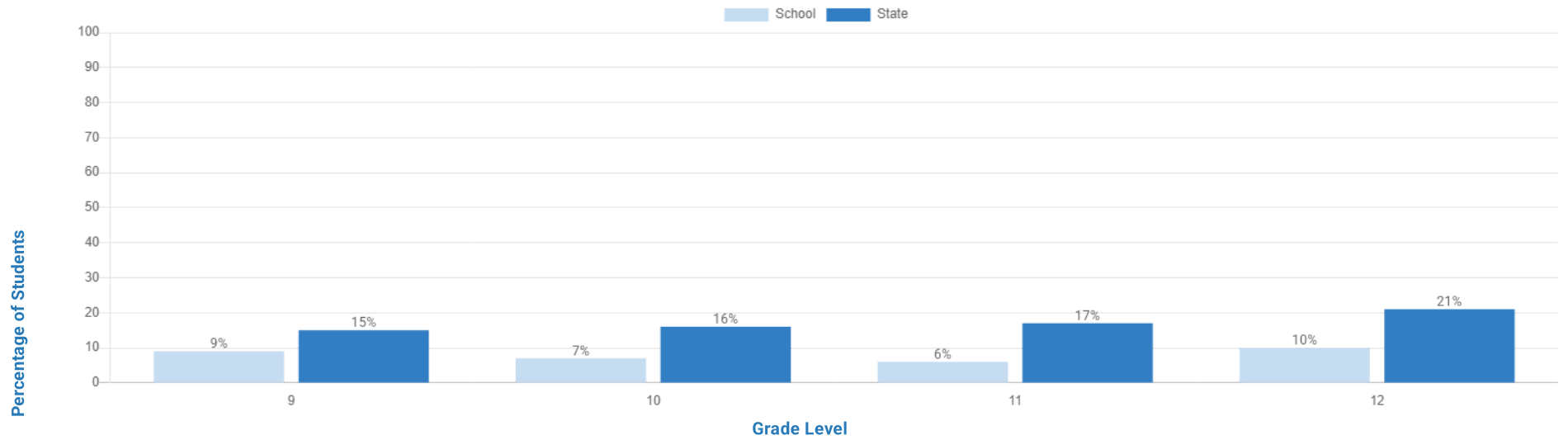

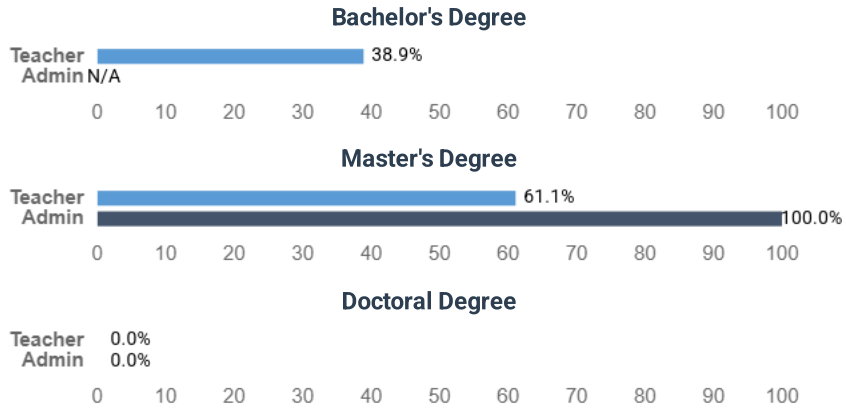

Accountability

New Jersey's Every Student Succeeds Act (ESSA) Accountability System New Jersey's school accountability system identifies schools in need of comprehensive and targeted support as required by the Every Student Succeeds Act (ESSA). Based on New Jersey's [approved ESSA state plan](#), NJDOE will identify schools in the following four federal categories every three years:

Harrison High School collaborates extensively with NJ's public colleges, especially Hudson County Community College. Within our Business and Career Ed Department, we offer a Honors Sports Marketing program and a certification program in Hospitality through Prostart (US Restaurant Association). HHS offers 14 advanced placement courses, 6 dual-credit college courses, an STEM academy, and a vocational training program in hospitality management. World Language instruction is a cornerstone of the curriculum; we are one of the few NJ high schools to offer Chinese as a foreign language. We offer a full catalog of courses in the fine and performing arts. Our award-winning music and art programs participate in the NJ Teen Arts festivals. Our Drama Club competes annually in the Papermill Playhouse Rising Stars program, for which we won distinguished achievement awards in multiple categories in 2024.

Postsecondary Information:

Within the Class of 2024, 87% percent of graduates pursue post-secondary training, and 53% of the class enrolled in four-year colleges. In support of post-secondary endeavors, Harrison High School annually hosts FAFSA workshops, financial aid seminars, on-site college admissions sessions, college representative visits, college instant decision events, and college admissions panels. We also emphasize the importance of skilled trades, and often host trade unions and technical schools at HHS to provide students with opportunities to move into the trades immediately upon graduation from high school.

In addition to following academic progress through our interactive Parent/Student Portal and SCOIR (a future planning and data management tool), Harrison High School's parents take full advantage of our monthly parent seminars, back-to-school night, and parent conferences. One of the most active school organizations is our Parent Teacher Student Organization, which hosts large-scale events for the school/community, donates funding to all types of school programs, and distributes five sizeable academic scholarships each year.

Facilities:

The Home of the Blue Tide is only sixteen years old and boasts such state-of-the-art facilities as a multi-sport athletic complex, fitness center, dance studio, robotics lab, 5 science labs, two gymnasiums, a 600 seat auditorium, indoor pool, expansive media center, STEM Lab, Photography studio, Ceramics workshop, Fine Arts studio, and an impressive culinary arts training center. Over the last year, we also conducted an impressive stadium refresh program, including new field lights and turfing of our field.



School Safety:

HHS Safety and Climate Team (SSCT) meet monthly, and constitute an integral part of the visioning process at HHS. SSCT reviews Harassment, Intimidation, and Bullying incidents on a monthly basis and advises the HIB coordinator on perceived trends and potential solutions. School security and safety are of the utmost importance at HHS. Our security force consists of a full-time uniformed policy officer, who also serves as the liaison to the municipal police force, and a full staff of security guards, who are present at all times the school building is open. We hold quarterly meetings with a Student Safety Team from which we derive important insight into many matters of school governance and safety. Our Mayor and Town Council along with our Chief of Police also take part in our student safety meetings.



Technology and STEM:

Our STEM program, now in its twelfth year, was one of the first in the area. We boast a fully equipped STEM lab where students build machines and robots. Our faculty, comprised mostly of engineers and architects from the field, train our STEM students on design principles, coding, and research techniques. Graduates of the HHS STEM Academy regularly go on to study engineering and computer science in some of the top universities in the country.
