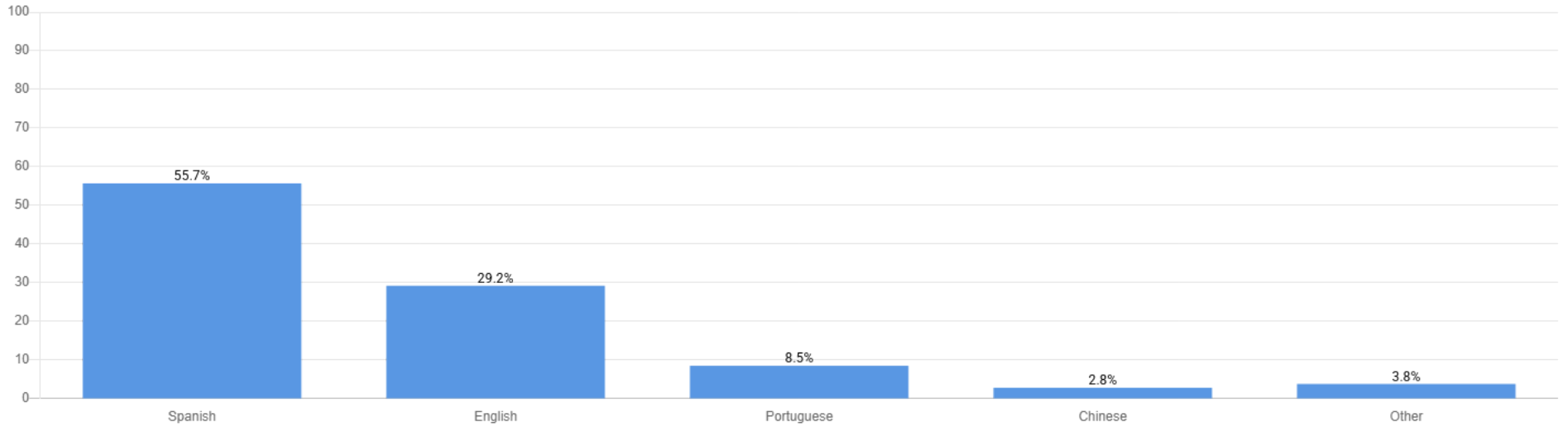

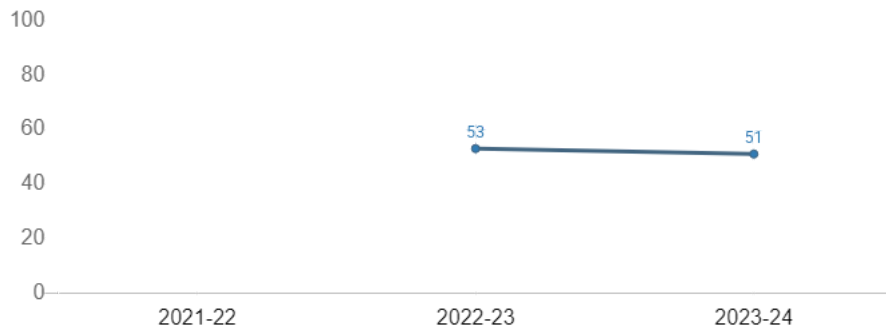

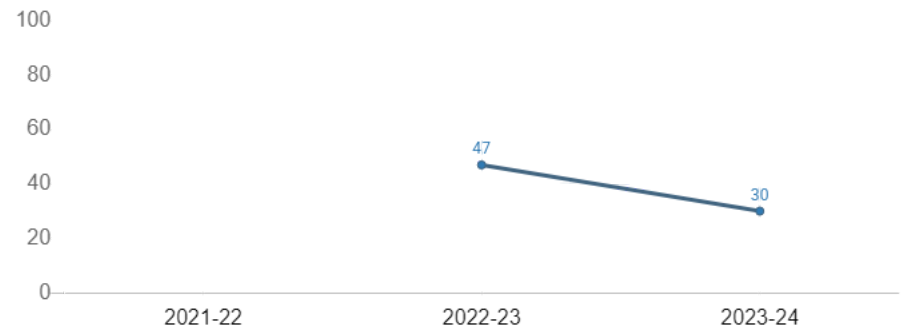

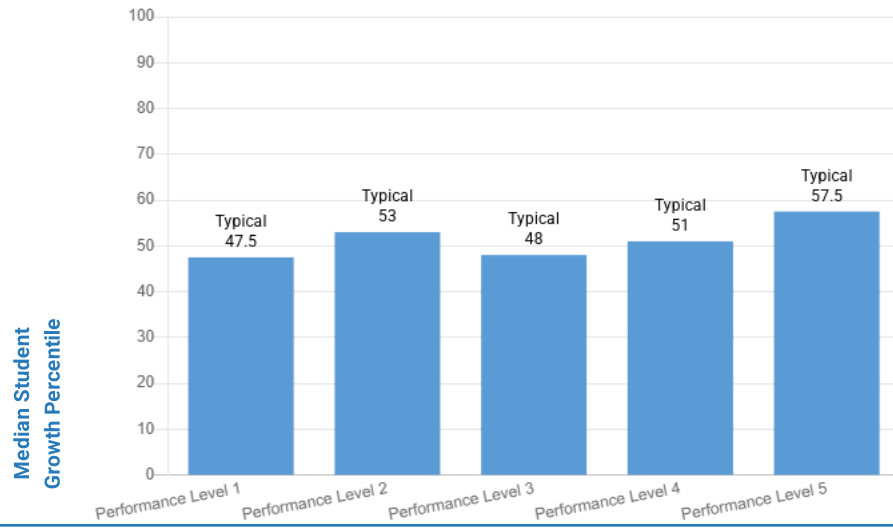

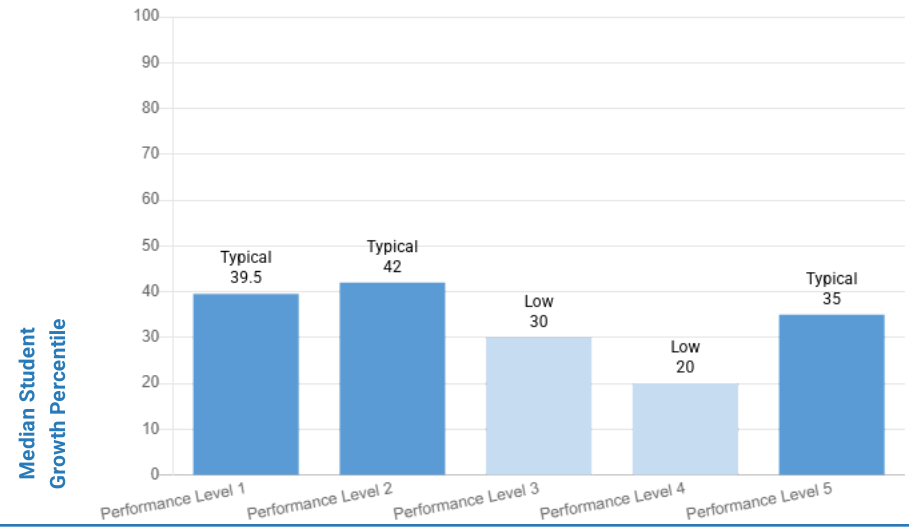

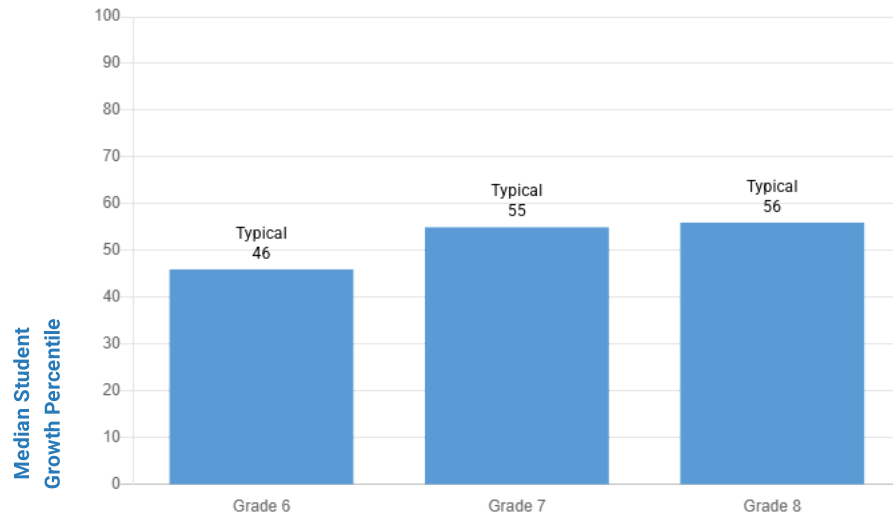

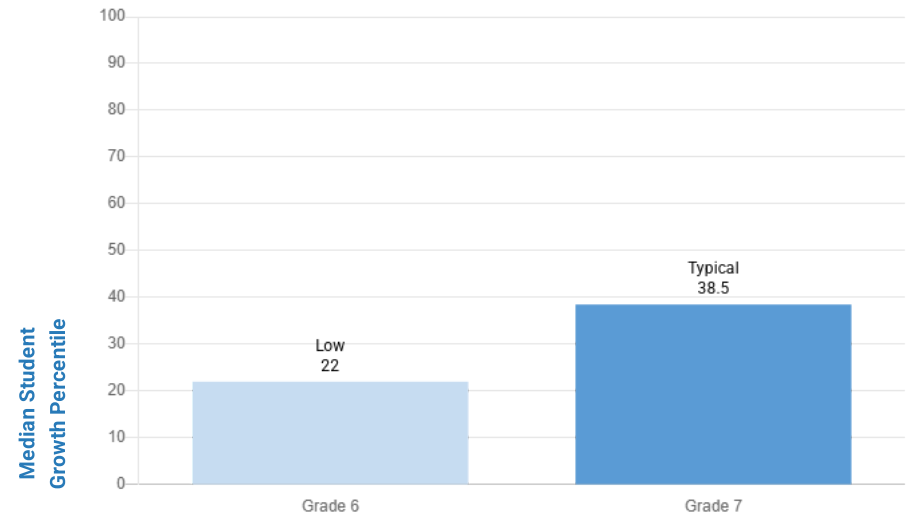

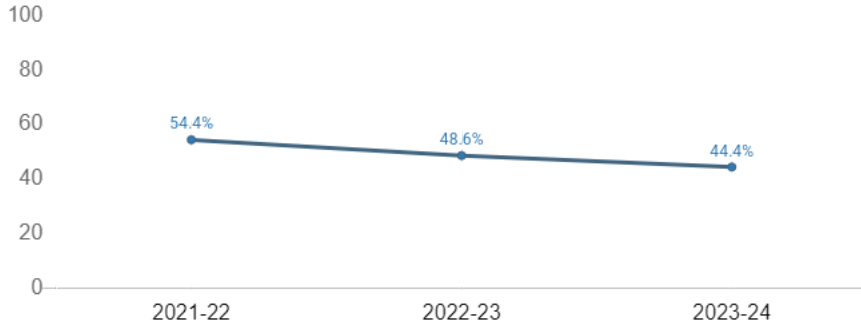

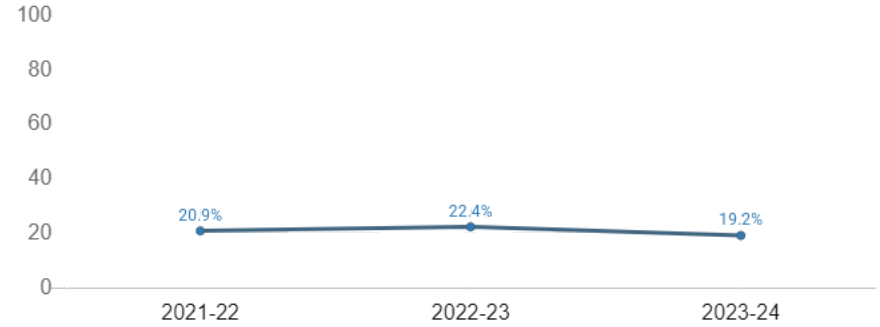
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 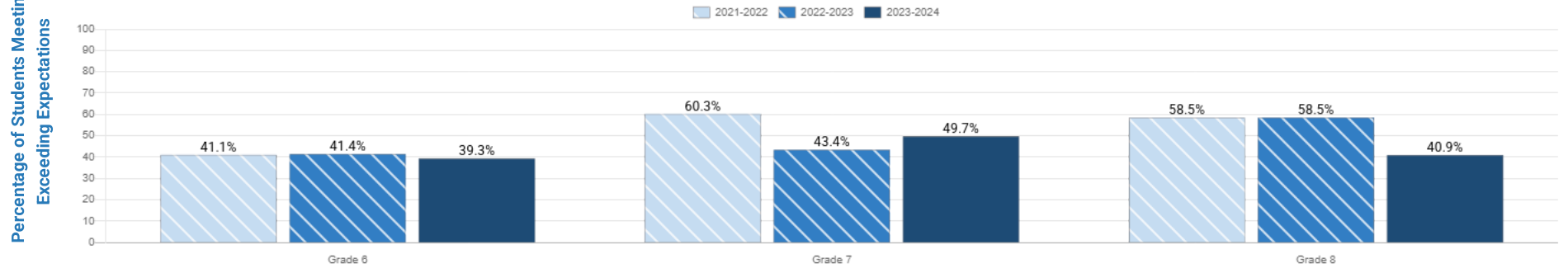

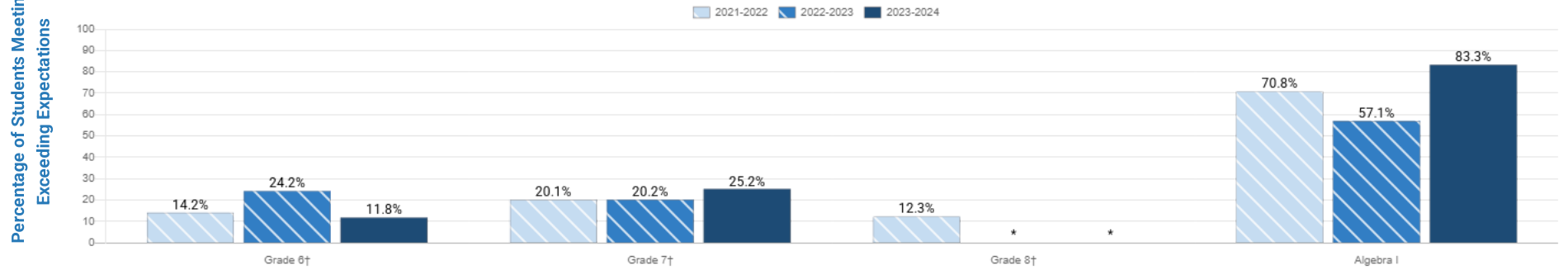

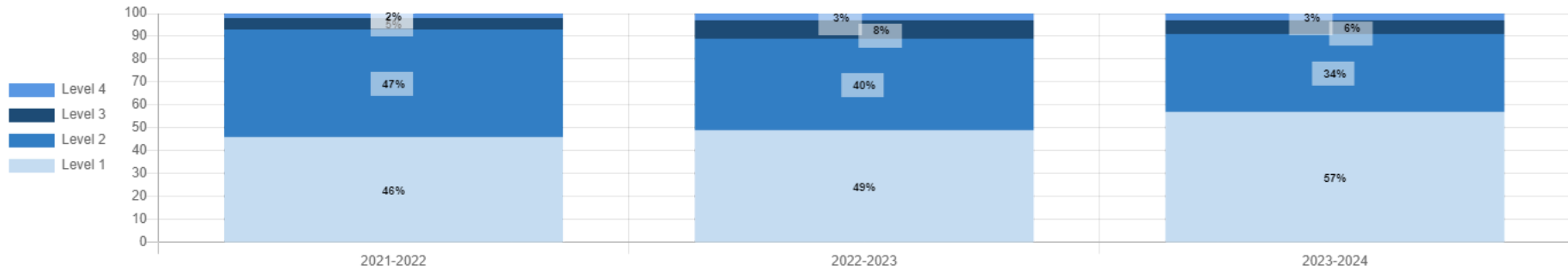

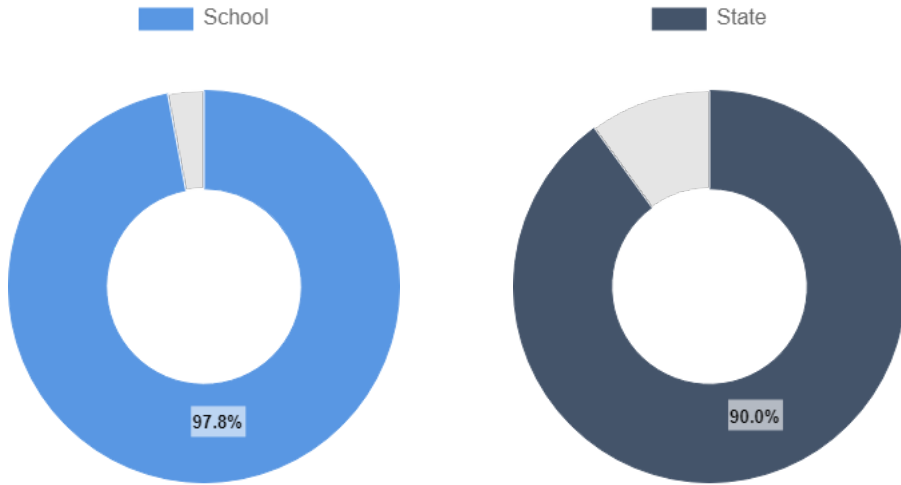

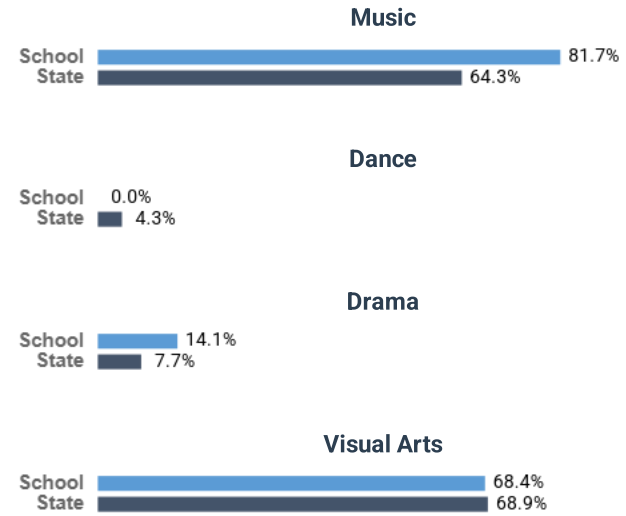

Students enrolled in one or more classes by discipline:



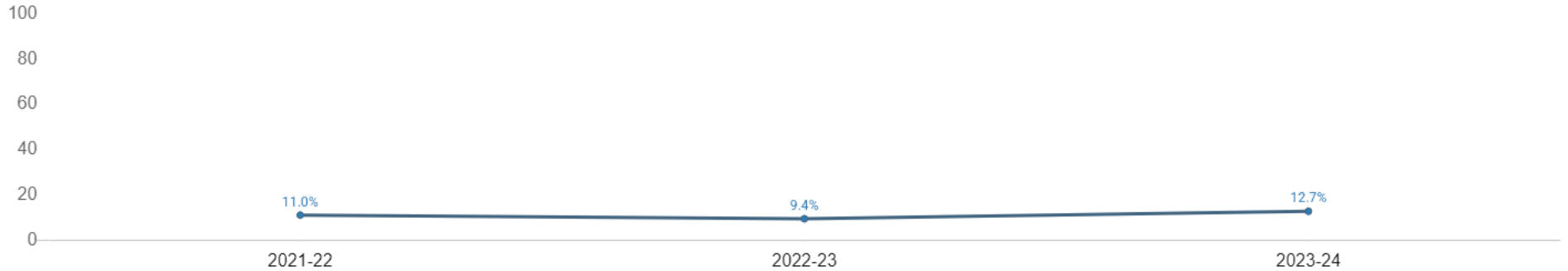

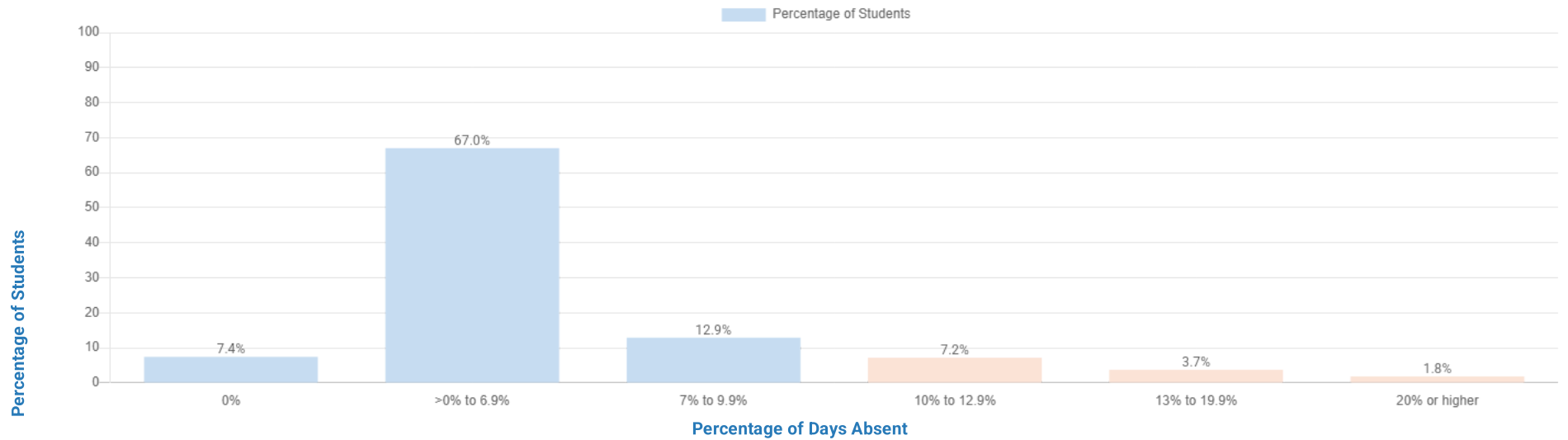

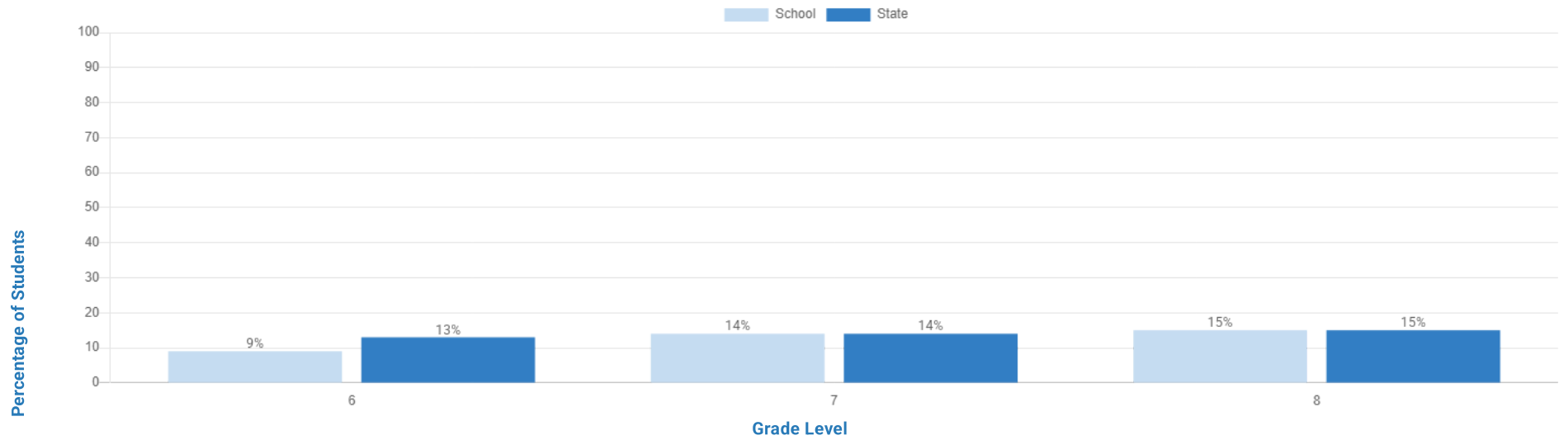

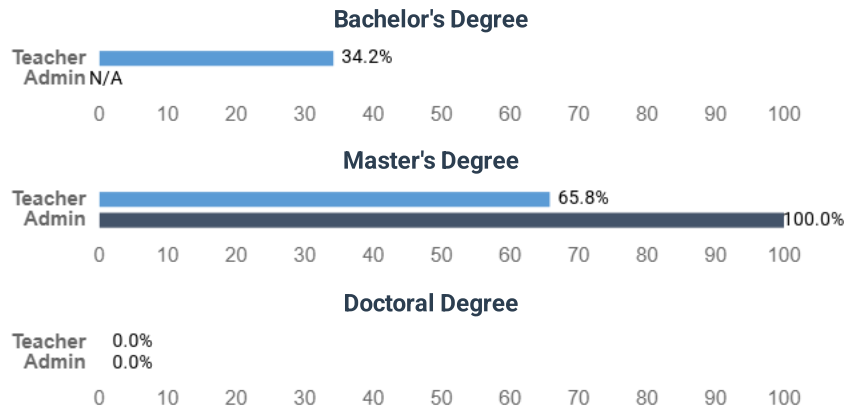

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. Our classrooms contain 60 in. flat screen television screens, whiteboards, document cameras, and specific areas designated to compliment small group instruction, flexible seating, and differentiation.

The safety of our students and staff at WMS is our number one priority. Our school employs two security guards, one of which is a police officer and the other is the district head of security. We have adopted appointment only visitation and have installed a new building safety and intercom system complete with phones in all rooms and strobe lights. We complete monthly fire drills and safety drills to prepare for any contingency.



Technology and STEM:

Washington Middle School has a STEAM program for grades 6, 7, & 8. The students are working on a variety of makerspace activities, lego robotics, and SeaPerch Kits that were awarded from a grant from the U.S. Navy. New 3D printers allow students to expand their technical skills. An end of year STEAM fair combines creativity and construction - Grade 8 students hold a virtual carnival for our elementary school students with all materials made from cardboard!



Attendance:

Students identified as high risk will be offered interventions through our ELA and Math Intervention classes, additional school resources, and other related services programs. Our Gifted and Talented program during the school day offers students the chance to promote critical thinking and reasoning abilities. Our clubs and afterschool program allow for students to explore special interests beyond the bell. ALL WMS clubs, activities, and sports, allow students a chance to socialize, collaborate, and engage in a developmentally appropriate manner.
