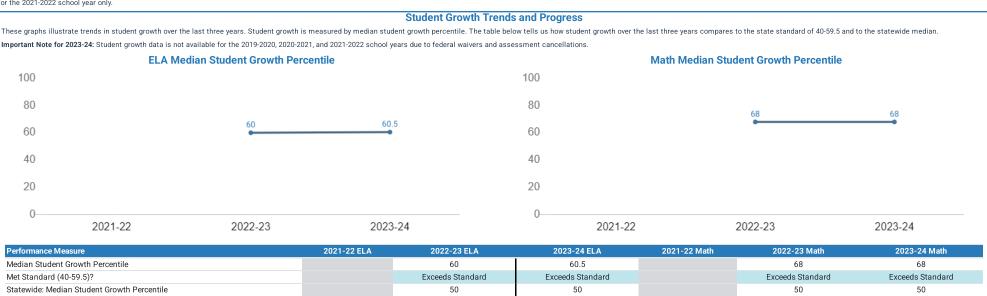

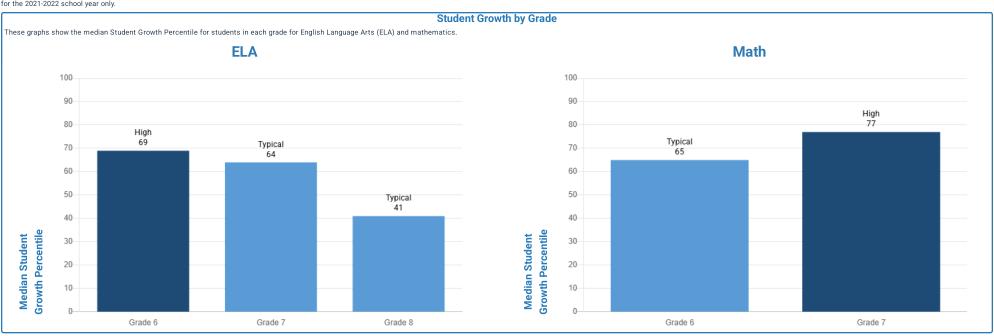

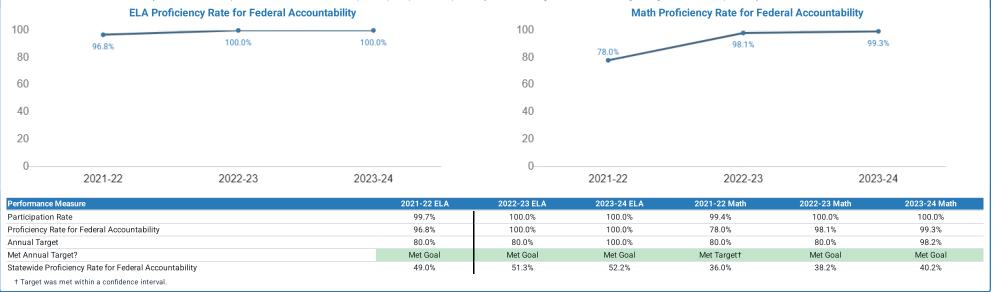

#### **English Language Arts and Mathematics Performance Trends**

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 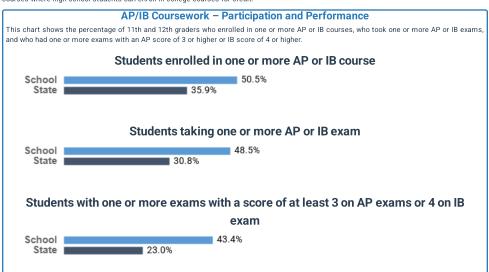

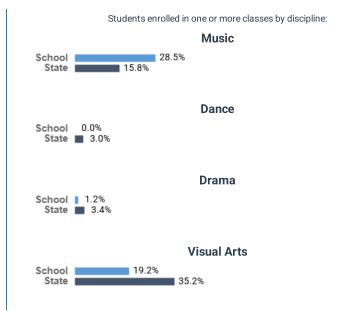

### Graduation/Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

The school's instructional program concentrates on academics and college preparatory coursework in a personalized, challenging environment. At the middle school levels, through its membership with the Cambridge Assessment International Education of the University of Cambridge, the school implements blended curricula in Language Arts, Mathematics and Science. At the high school level, the school only offers honors and Advanced Placement courses. A minimum of 160 credits is required for graduation. For the past two years, Infinity Institute has partnered with the National Education Equity Lab. Through this partnership, high school students are able to enroll in college courses offered by Brown University, Stanford University, and Arizona University. Lastly, high school students have enrolled in a course to earn a Cisco Certified Networking Associate (CCNA) certificate.

**Before and After School Programs:** 

Infinity Institute provides afterschool academic intervention classes for middle and high school students. The academic prep classes include: English Language Arts for Grades 6-9 Math for grades 6-8 Algebra I for grades 9 Geometry for grade 10 Algebra II and College Algebra for grade 11. The afterschool program also provides AP support classes for all high school students enrolled in an AP course. In addition to academic support Infinity and the YMCA provide extracurricular activities for all students including: Model UN, Student Council, Phoenix Fellows, Math Club, Infinity Innovators, Band, Math Club, TechUcate, Newspaper Club, Spirit Club and Band.



Twice a week, teachers participate in cross content and department Professional Learning Communities to analyze student data identify student learning goals discuss instructional strategies and district curricula/resources. At the district and school levels, teachers participate in teacher-led professional learning sessions involving Google applications for the classroom and online formative assessment resources. At the district level AP teachers participate in district-wide AP PLC groups to discuss the content of their AP course instructional strategies and resources and assessment tasks. Teachers are provided in school support from Instructional Specialists Content Supervisors and Instructional Consultants regarding curriculum resources assessments data analysis and lesson planning.



Infinity Institute's school counselor leads a collaboratively comprehensive plan to support Infinity's seniors' college and career goals. The following are a series of activities and programs: Chat and Chew Events with College Representatives, School Links, College Fairs, and Financial Aid workshops.

**Student Supports and Services:** 

In the middle grades, students who are in need of academic support are provided assistance through individualized academic plans. The academic plan includes SMART goals and intervention strategies and programs to improve student achievement in the identified areas. Also school teams collaborate and create IR&S and 504 Plans to support students who are in need of accommodations and/or modifications due to physical emotional psychological or intellectual limitations. The school currently has one Special Education classroom for students classified as having behavioral disorders. The class is supported by a SE Teacher, a Teacher's Assistant, Social Worker, and a LDTC teacher. The school implements a Peer Mentoring program to identify student mentors for newly enrolled students. Lastly, the school's Project Resilience program offers inschool counseling services.



The school participates in the district-wide "Grab and Go" breakfast program. The program provides free breakfast to all students prior to and after the start of the school's instructional day at the students' requests. All students participate in physical education classes based on the district's physical education curricula and mandatory minutes per semester. The middle school students participate in the districtwide intramural sports program Project A-Team. The middle school tudents participate in sport competitions in the areas of Field Hockey Soccer Basketball Track and Volleyball. The school offers middle and high schoolers with the opportunity to participate in open gym during lunch times and afterschool 2-3 times a week.



**Parent and Community Involvement:** 

The school has a PTA organization and a partnership with the YMCA of Newark and Vicinity. The PTA meets once a month. Each year the school facilitates many community service projects involving the Alzheimer's NJ organization, St. Paul's Church St. Ann's Nursing Home, Mercy House, and Clara Mass Medical Center. All school stakeholders are encouraged to participate. Annually the school organized multiple parent activities involving college and career planning curricula resources, mock elections, middle school science fair, and winter and spring concerts.

Infinity Institute is located in a building owned by the Newark Archdiocese. It is leased by the Jersey City Public Schools. It was built in 1926. The building has classic architectural features such as a pair of Doric columns accenting the fenestration on the second floor and a central pediment with a decorative cartouche. The building has 4 floors with 8 classroom spaces per floor. Each classroom is equipped with an interactive board, laptop cart, and a class set of chromebooks. The school houses a library, computer lab, art room, science lab, auditorium and fitness room. The building does not have central air conditioning. Offices and a limited number of classrooms have air conditioners. The school has a parking lot with an adjacent outdoor eating area for students.



To support school safety, the administration formed a School Safety Team that is composed of school stakeholders: school administrators parents teachers senior custodian school security guard school nurse school counselor and students. The Safety Team meets a minimum of twice a year to discuss any safety or school climate concerns strategies to remediate and student activities to promote a positive school relationships and climate. In addition, the school administration meets with the school's security team (minimum of once a marking period) to discuss safety protocols including: visitor protocols, the checking of student bags, school patrols, lunchtime monitoring and reporting of student issues. Each month the school participates in mandatory fire and security drills. Lastly, the school administration enforces the school's Dress Code and ID protocols for all students.

The teachers and students utilize various technology tools during the instructional day. The school has purchased chromebooks for all students and has achieved a 1:1 ratio. All classrooms have interactive boards. Teachers utilize Google applications including Google Classroom Forms and Docs. During the class period, students use laptops/desktops Ipads and Chromebooks to access school's Wifi to complete online instructional tasks and communicate with their teachers and peers. At the middle school level, students are enrolled in a STEM class to provide them with hands-on activities to apply their understanding of robotics and coding. At the high school level, students can enroll in an Intoduction to Technology course, an UAV (Drone) class in which they learn how to design create test and fly an UAV, and a Cisco Certified Networking Associate (CCNA) certificate.

Infinity Institute is a secondary citywide school of choice within the Jersey City Public Schools. The school's program concentrates on academics and college preparatory coursework in a personalized challenging environment. In order to be considered for admission students must be residents of Jersey City and complete the application process. Students can enroll in the middle school grades (6 and 7) and at the high school level (9 and 10). The admissions criteria include grades teacher and administrator recommendations extracurricular activities student attendance PSAT 8/9 or PSAT performance scores (high school admissions test) and OLSAT (middle school admissions test). Students are expected to wear the school's black or white uniform shirt (with logo and motto) and khaki-colored pants and/or shirts.
