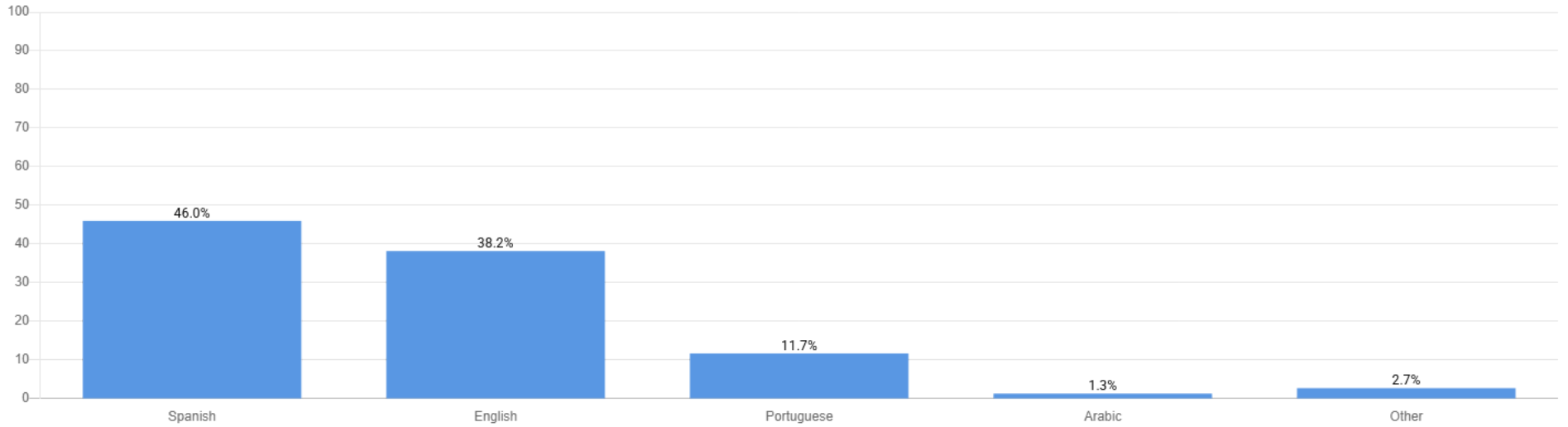

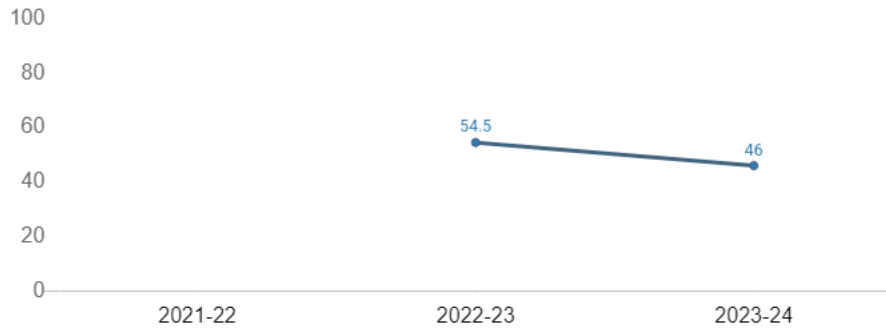

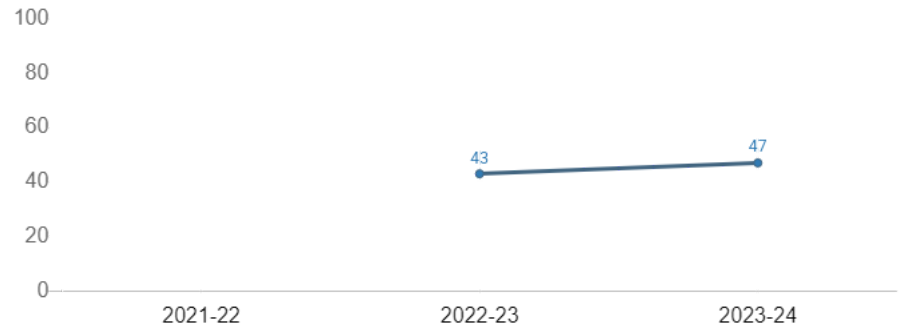

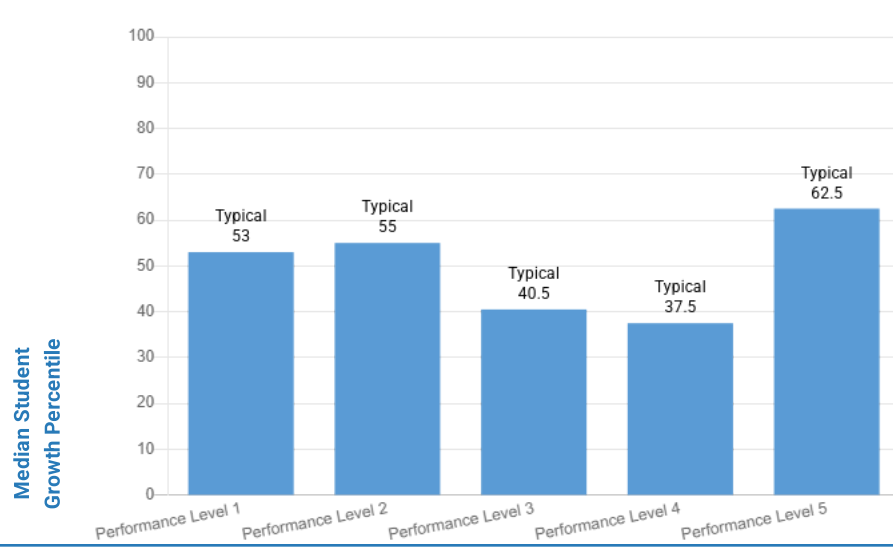

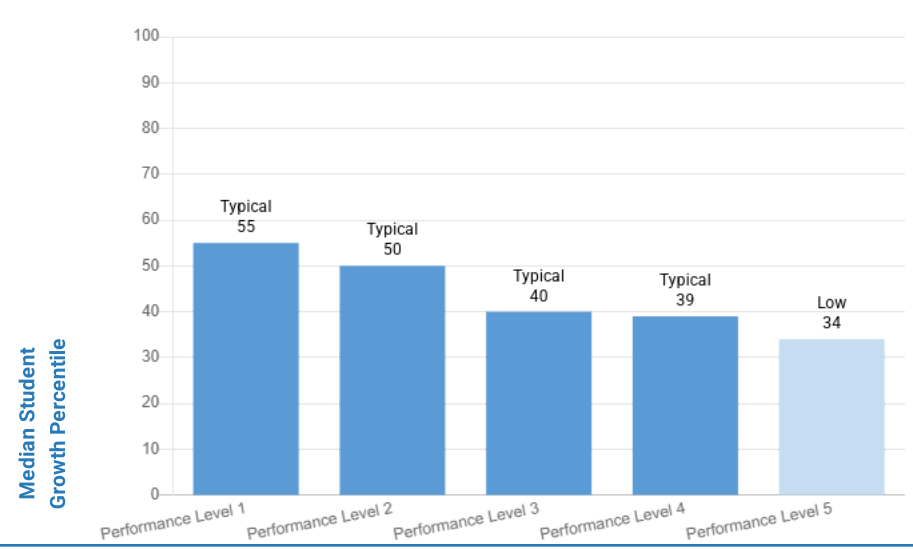

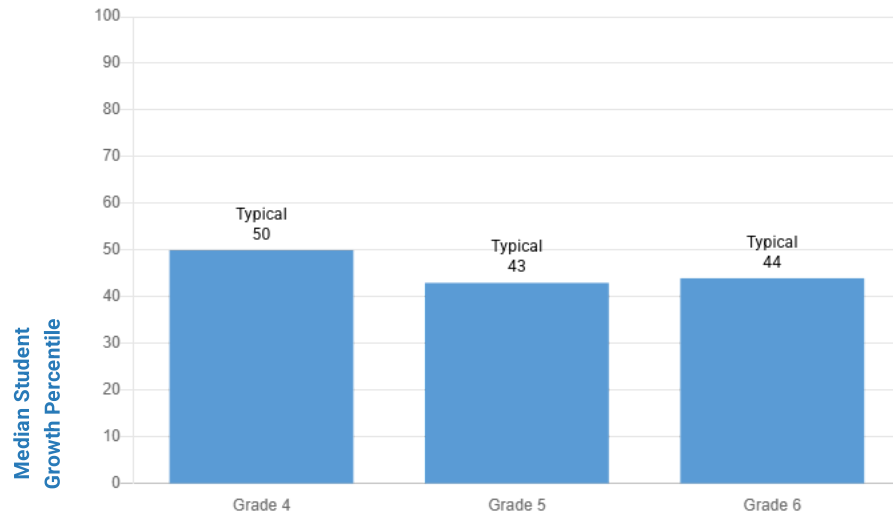

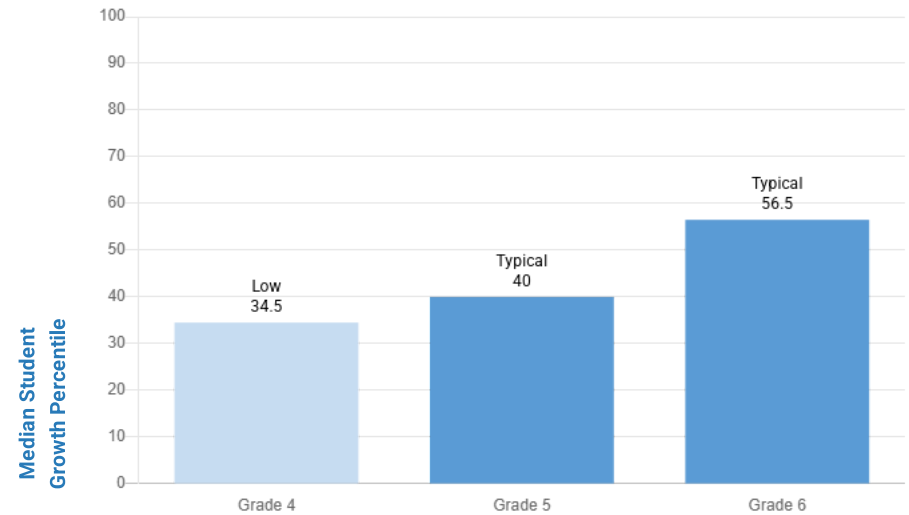

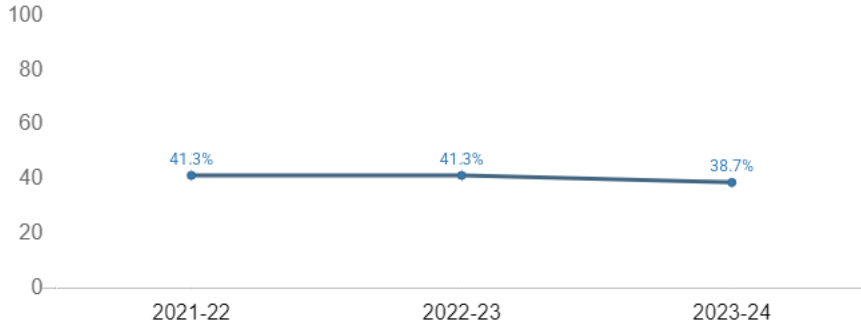

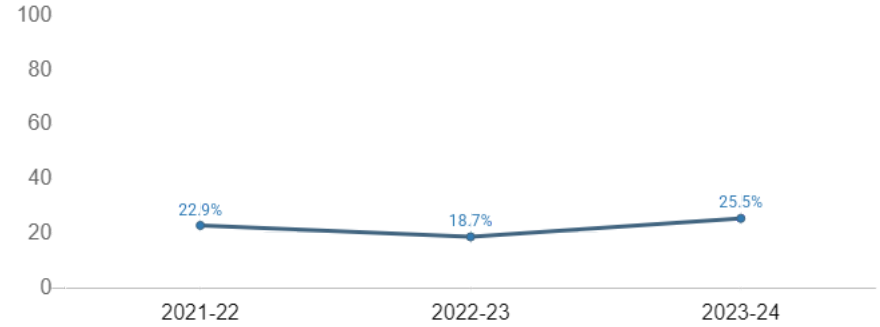
English Language Arts and Mathematics Performance Trends

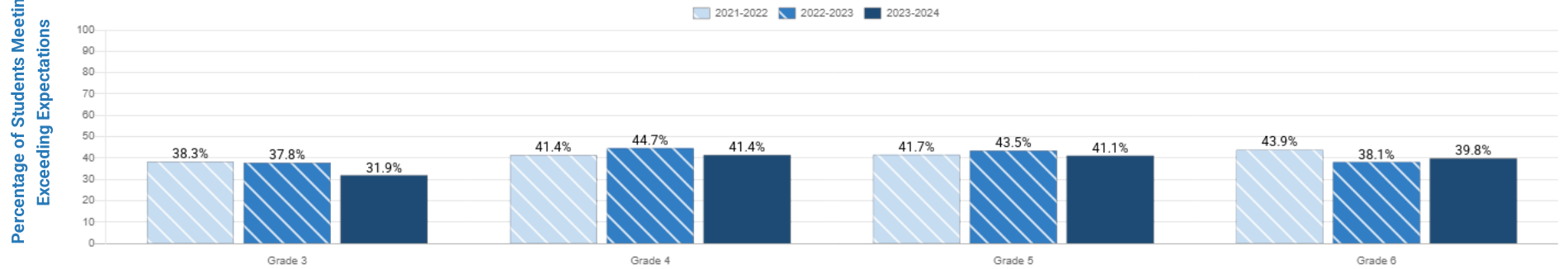

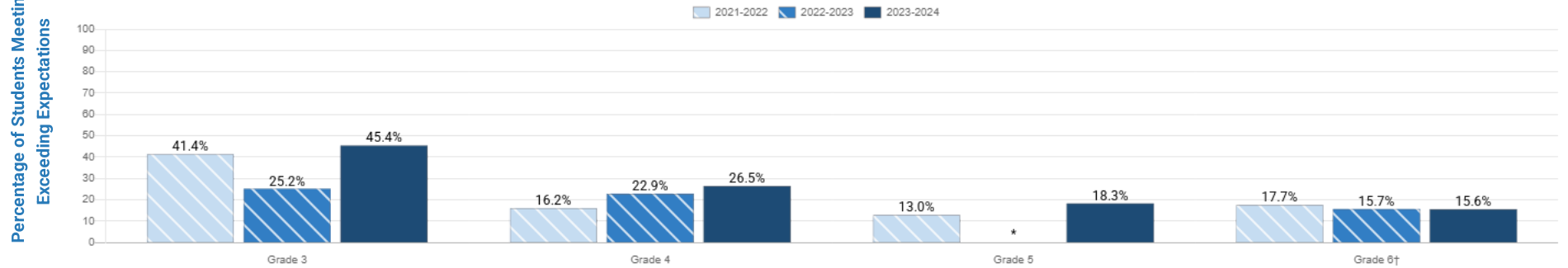

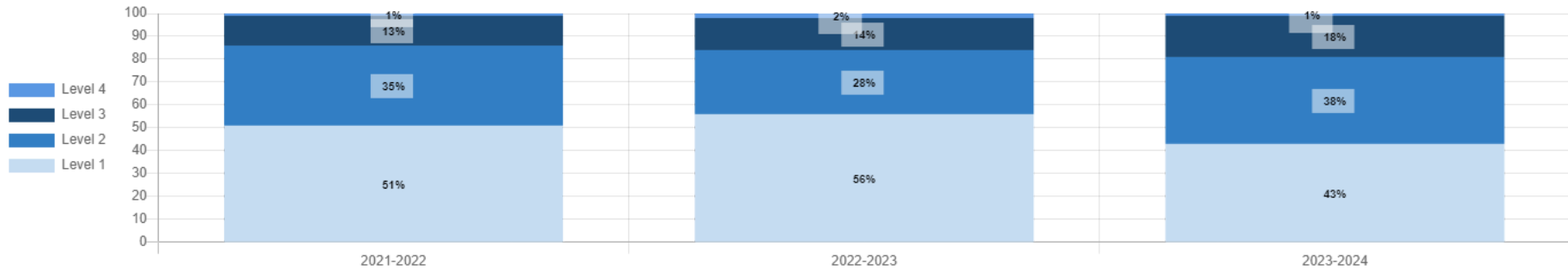

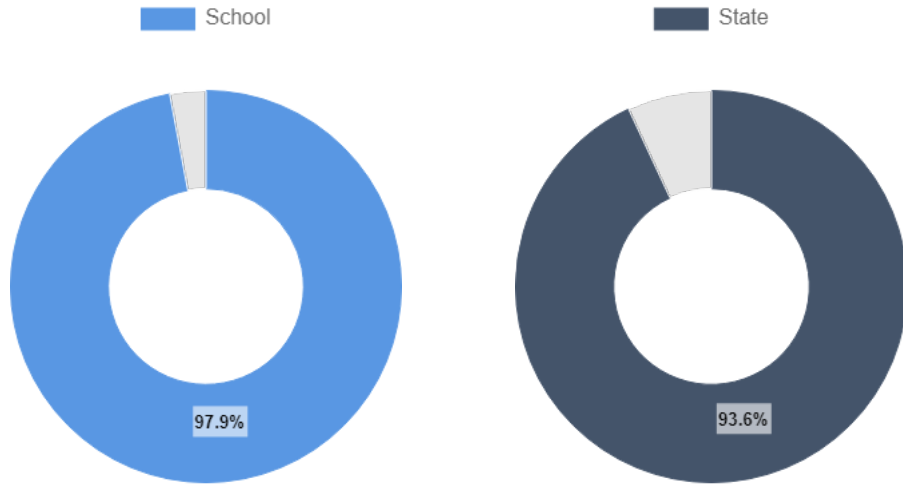

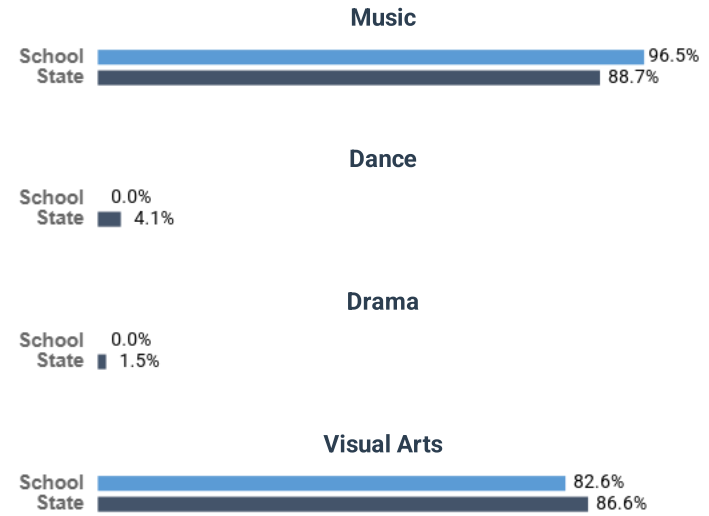

Students enrolled in one or more classes by discipline:



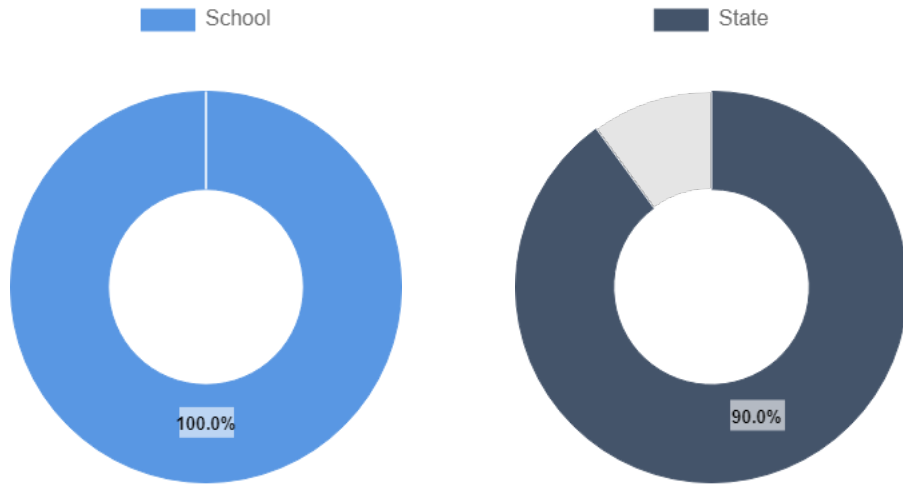

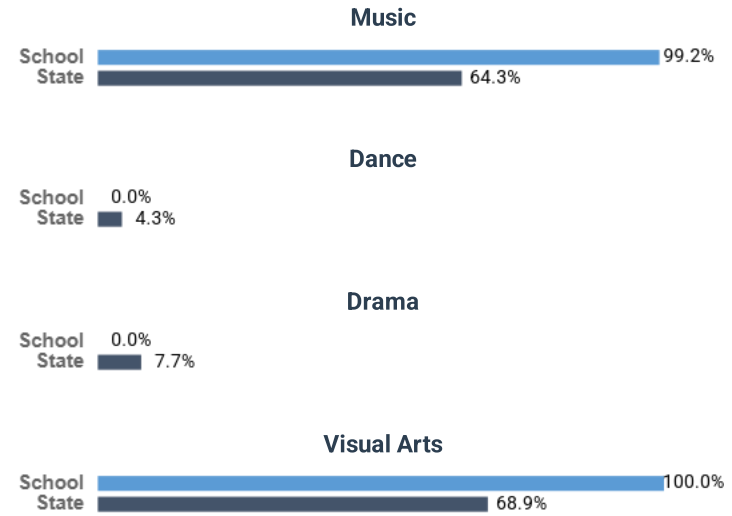

Students enrolled in one or more classes by discipline:



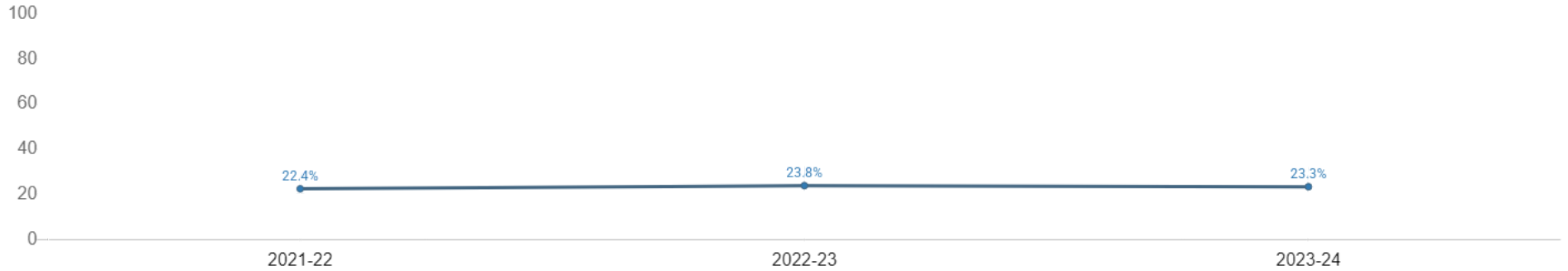

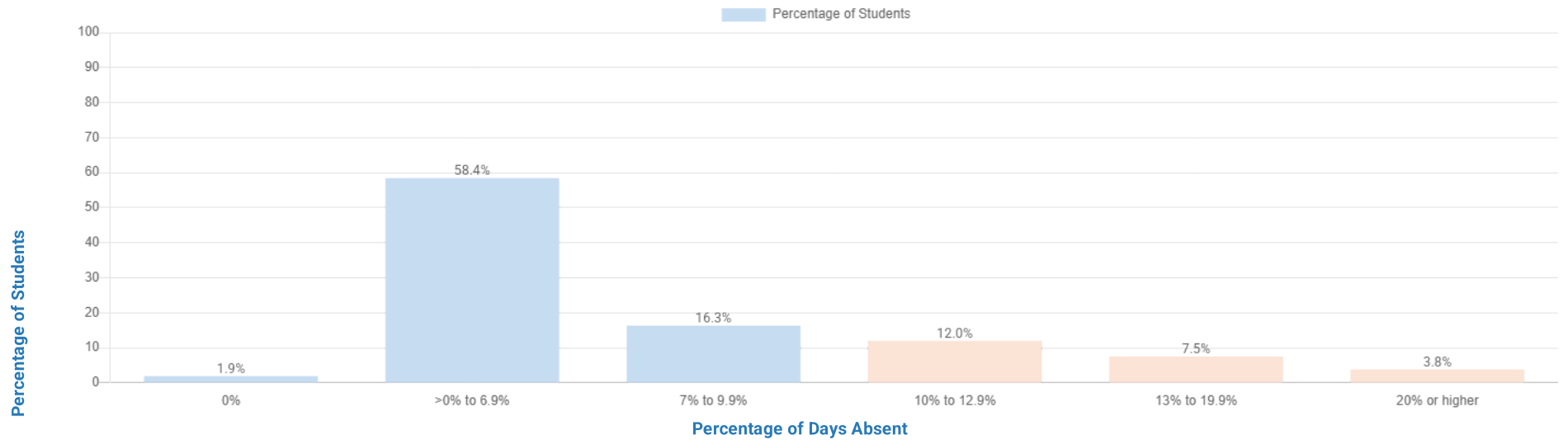

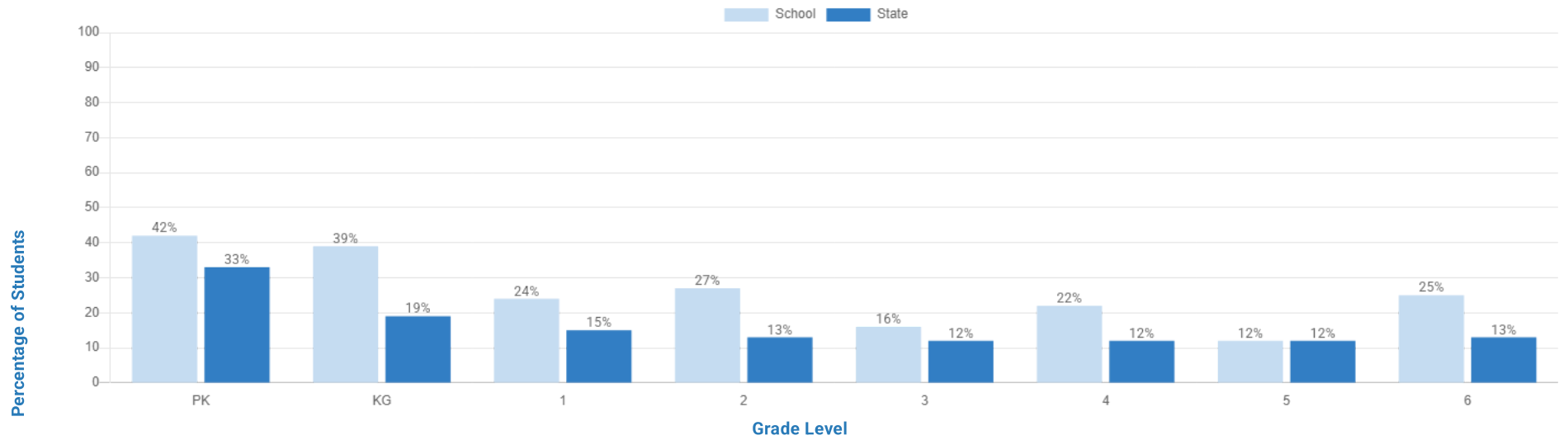

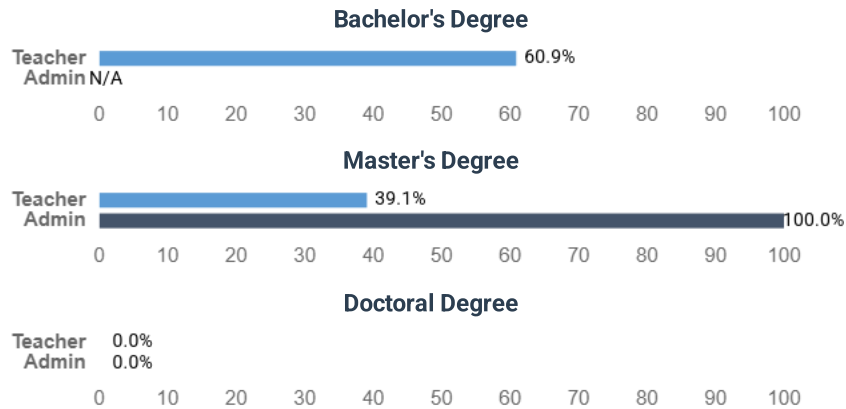

Accountability Summary by Student Group - 2023-24 School Year

We afford our students an exceptional education, empowering tomorrow's leaders, instilling each student with a sense of pride, maximizing everyone's individuality and potential to be a life-long learner and a contributing member of society.



Awards, Recognition, Accomplishments:

Positive Behavior Supports in Schools (PBSIS). Research suggests that schools with a positive climate are associated with fewer occurrences of conduct problems and better student performance in categories such as achievement and attendance. Students receive "talon dollars" for positive behavior throughout the day, not only in the classroom but also in the hallways, cafeteria, lavatories, etc. Office referrals have been reduced by 80% since implementing this program. It has contributed to the very positive climate at Franklin School. This year we began a principal's honors breakfast for those students who attained Principal's Honors more than once. We started with thirty-nine students in the first marking period. By the last marking period, there were eighty-six students receiving principal's honors. Growth Mindset is implemented offering a monthly mantra with teacher resources. Student of the month chosen by each teacher to depict the monthly mantra. Peer tutors for classmate support.

Courses, Curriculum, Instruction:

Our K-6 curricula are aligned to the NJSLs. PreK 3-4 provides developmentally appropriate practices through The Creative Curriculum. Our K-5 Structured Literacy instruction reflects the Science of Reading including Heggerty and Orton-Gillingham. Making Meaning and Being a Writer focus on ELA strategies and vocabulary. Grade 6 myPerspective provides students with various texts, novel studies, and develops writing. K-6 Mathematics develops computational and problem solving skills and mathematical discourse using enVision. Science curricula addresses the three dimensions through hands-on investigations using Mystery Science, Generation Genius, Knowing Science and Science and Technology in the Middle School. Personalized learning includes i-Ready, XtraMath, Achieve 3000, and Membean. K- 6 Social Studies is instructed through Scholastic News, Young Citizens, and Newsela. Data driven instruction is supported by our Data teams. Enrichment classes are provided through our KEEP program.



Sports and Athletics:

Sports Offered: Basketball (Boys & Girls), Volleyball (Boys & Girls)
In the spring the fifth and sixth grade girls played soccer against the four other district elementary schools and won.. The physical education team sponsored a 6th grade Volleyball tournament at Franklin School. A school wide "Fun Run" and PTA sponsored Field Day are activities offered to all students. 6th graders participate in a district wide Track and Field Day each year. Our students learn & practice the basic foundation of sports in our physical education classes.



Clubs and Activities:

Safety Patrols, Junior Peers, Chorus, Yearbook, Gardening Club, Sixth Grade Peer Tutoring, Faculty Liaison Committee, and Principal-Student Liaison Committee. Intramural volleyball, basketball soccer tournaments .Franklin School fundraises for needy families and health charities for the Lymphoma Society, Lupus Awareness, and Breast Cancer Awareness. Junior Peers host a Thanksgiving food drive and donations to ASPCA for shelter animals. Boosterthon's "Fun Run" raised enough money for a two day carnival for our students.

Before and After School Programs:

Before and after school help period for all grades run by staff members. After School Programs to support academic achievement in English Language Arts and Mathematics are provided to students for a majority of the school year. Additionally, the district offers after school enrichment programs addressing a variety of interest areas including music, arts, and sports. Summer programs are also provided that encompass academics, the arts, and sports. Newcomer multilingual learners are given the opportunity to participate in after school tutorial programs to assist them with their English language development. Additionally, the district offers a summer program for newcomer multilingual learners.



Staff and Professional Learning:

The school allocates professional development days to staff addressing topics relevant to school and district needs. Teachers receive training throughout the year for current programs and best practices. Additionally, teachers request professional development days to meet their own professional goals. We provide New Teacher Collaborative staff training throughout the year. In addition, cohorts of teachers are working toward Special Education and bilingual and ESL certifications to improve instructional strategies and enhance student achievement. The School Data Leadership team coordinates training and PLCs to share data analysis and promote data driven instruction. Staff is provided mandated training, including Paul's Law, and Danielson Evaluation Model Training. Several staff members continue to pursue higher degrees (Masters, etc.). Teachers also engage in faculty and curriculum meetings to examine instruction and discuss practices to foster continuous professional growth.



Student Supports and Services:

Special Education: Resource and Inclusion classes. Specialized Programs such as Preschool Disabled Program, Pre-K through 6th grade Language/Learning Disabilities and Applied Behavior Analysis Program, Emotional Regulation Impairment program and Extended School Year for students with disabilities. Behavior Support Team and Special Education Coach for teacher and student support. The District Child Study Team plays a crucial role in identifying students, developing educational plans, and monitoring programs for those referred to the team. ESL/Bilingual: Multilingual learners are provided with English language development support through the part-time Bilingual Program for Spanish speakers and Sheltered Instruction for speakers of languages other than Spanish. Students are supported with after school tutoring opportunities and a summer program. Help period is provided daily.

PTA functions, school-wide presentations, and parent involvement nights are well-attended. The preschool program hosts monthly family involvement evenings to engage families in hands-on activities to focus on developing young children's literacy and mathematical skills. Preschool families are also invited to attend "Lunch and Learn" monthly discussions that center around early childhood. Topics include social-emotional development, establishing routines and structures at home, and helping young children develop self-help and problem solving skills. Title I and Title III students and their families have the opportunity to participate in monthly events that integrate literacy, math, the arts, and the seasons. School-based family engagement teams plan events to involve students and their families.

This school year Franklin School added a Behavior Threat Assessment Team.



Technology and STEM:

Technology is integrated throughout the curricula to enhance instruction. Students in grades K-6 are provided with a Google Chromebook. Pre K students are provided with an i-Pad. Students use Google suite and tools to create presentations, demonstrate understanding and extend learning. Students have the ability to collaborate digitally with peers. Promethean and SMART boards in every classroom add to an engaging, interactive experience for students. Students are enrolled in a Computer Science and Design Thinking course to instruct students on online safety, 21st century computer skills and knowledge. Students are provided with STEM activities including coding, engaging in break out room activities, and programming Kibo robots. Smart TVs highlight school happenings, celebrate student achievements, and promote an inclusive school environment. Students participate in the Saturday Morning STEM initiative at NJIT.

Early Childhood Education:

State-funded preschool three and four year old programs are offered. We offer a developmentally appropriate curriculum tailored to the social, emotional, cognitive, and physical development of young children. Staff utilize observations and performance based assessments to monitor students' progress and to guide individualized learning. The Pyramid Model is implemented to promote social-emotional development and help students build skills in self-regulation and independence in a structured and supportive manner. Instructional coaches and Intervention and Referral Specialists provide ongoing support for staff. Early Childhood Parent Involvement sessions and educational workshops for families are held throughout the year. The Early Childhood Advisory Council meets quarterly to review survey data, discuss the needs of families, and identify community resources to address the needs. Partnerships with local organizations ensure preschool families have access to additional support resources.
