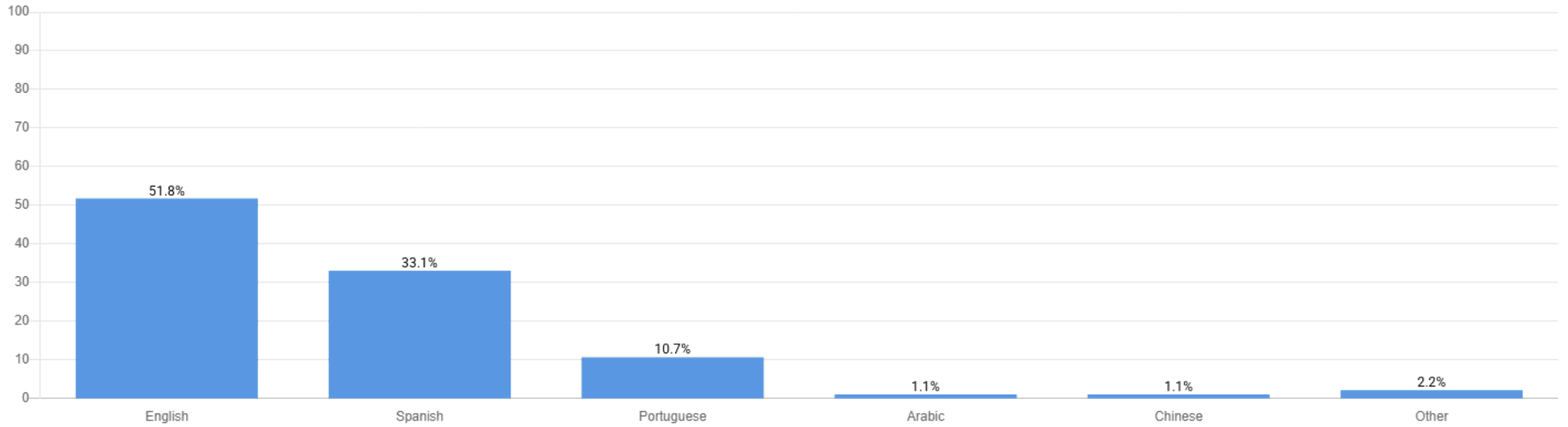

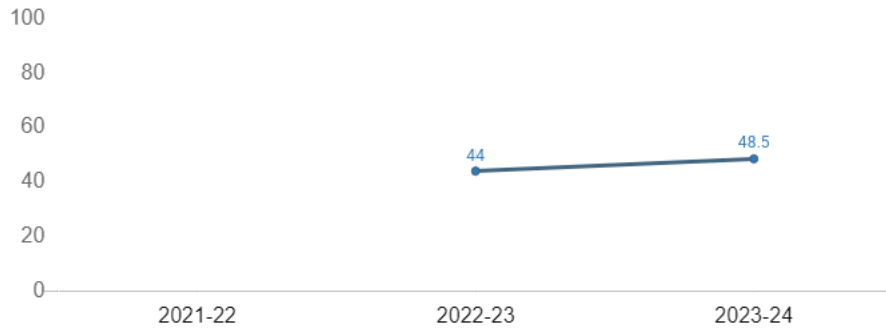

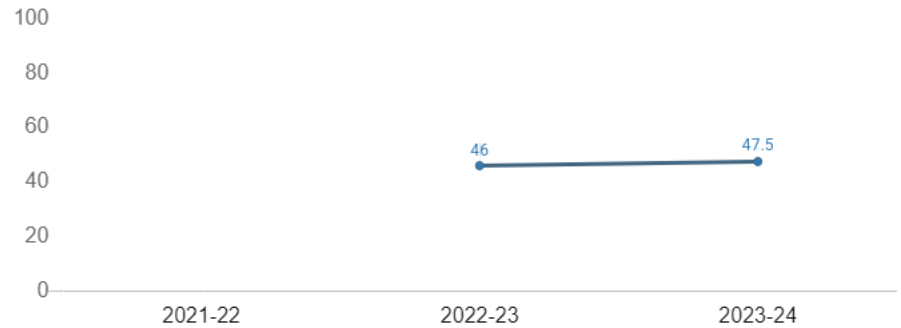

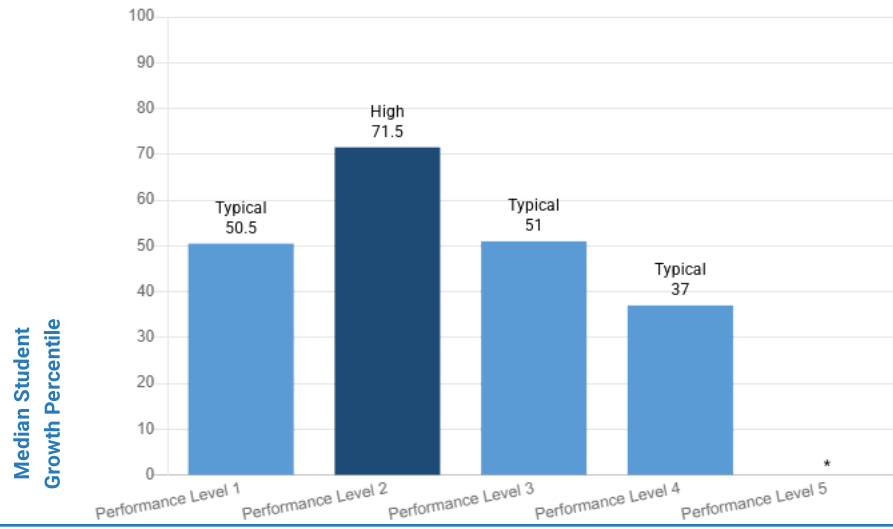

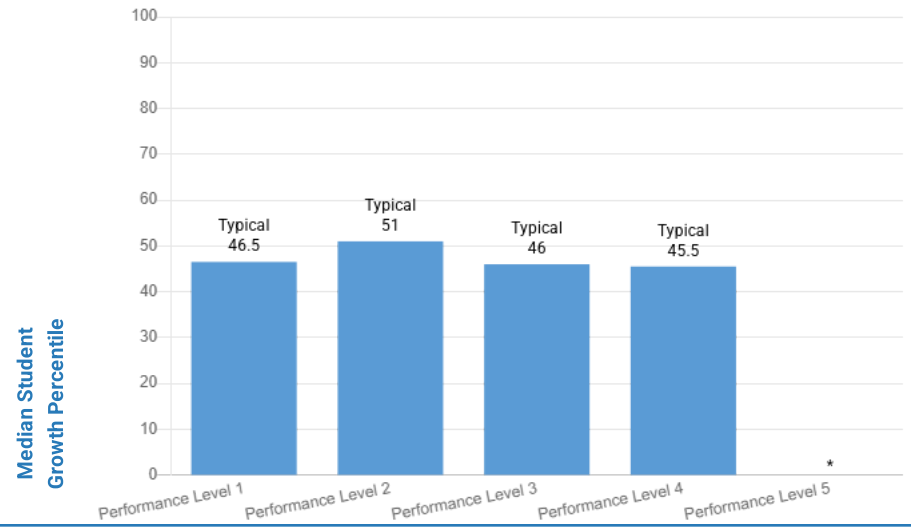

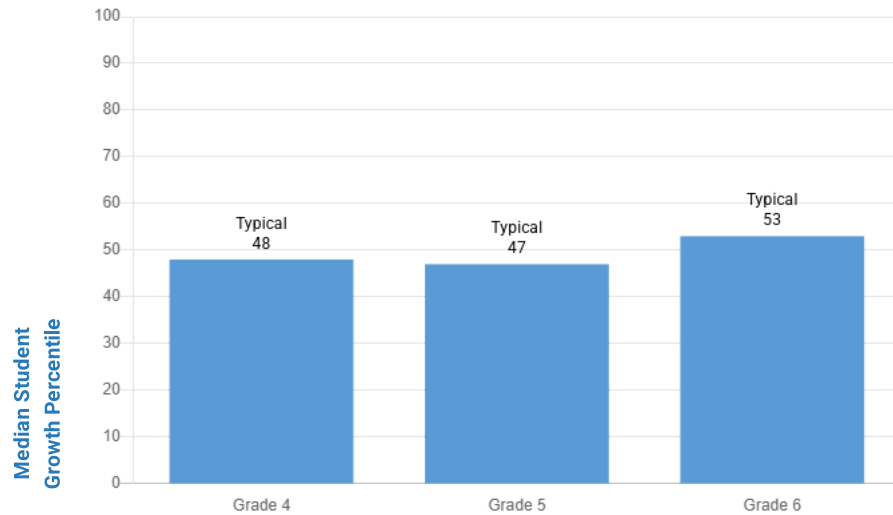

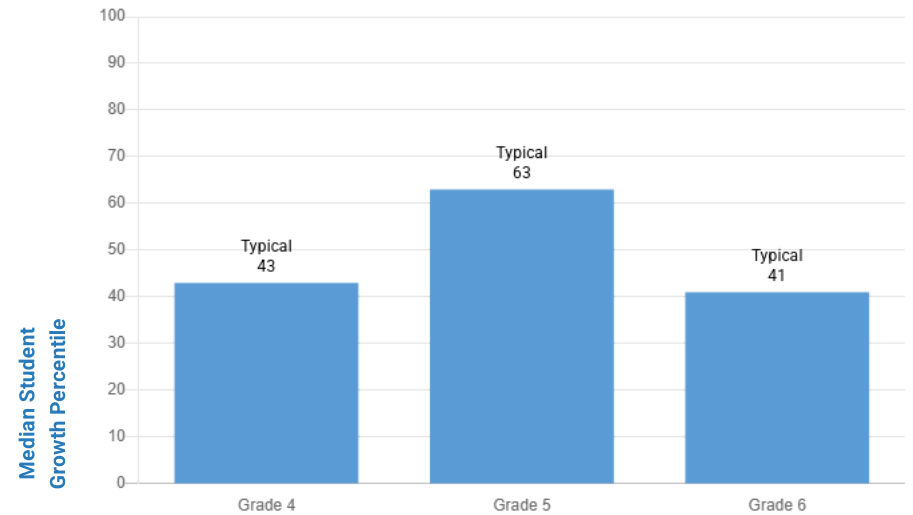

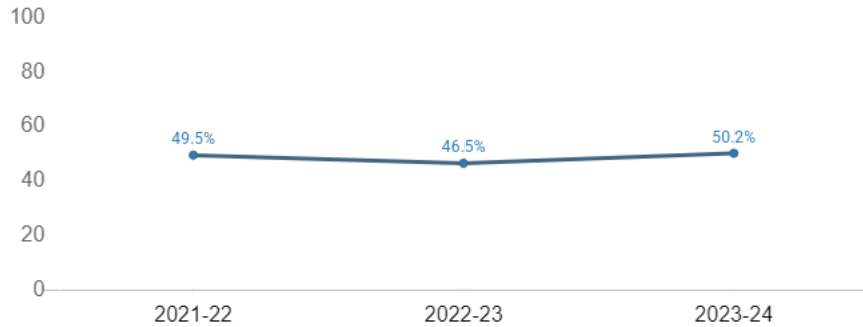

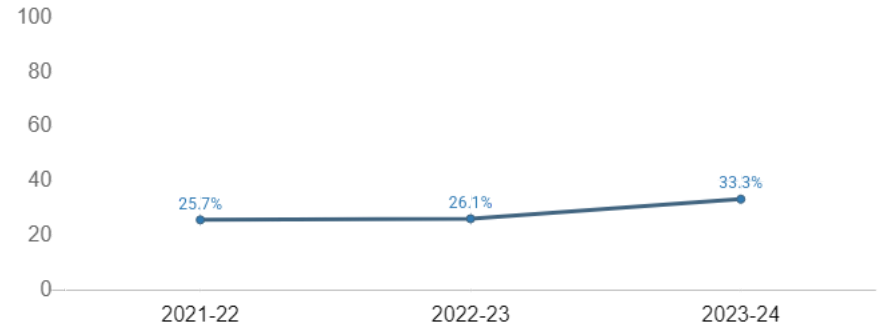
English Language Arts and Mathematics Performance Trends

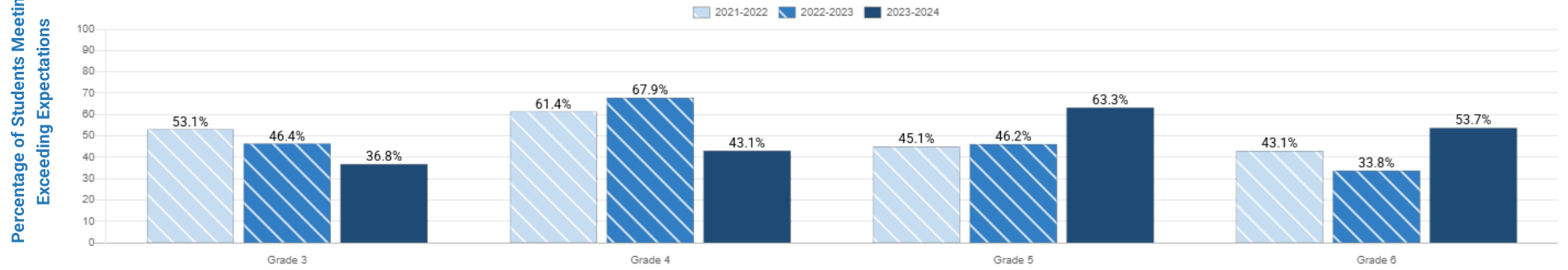

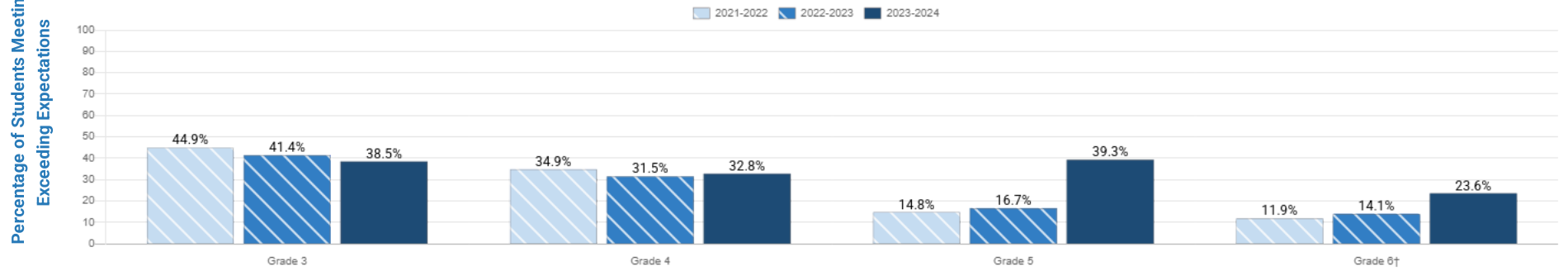

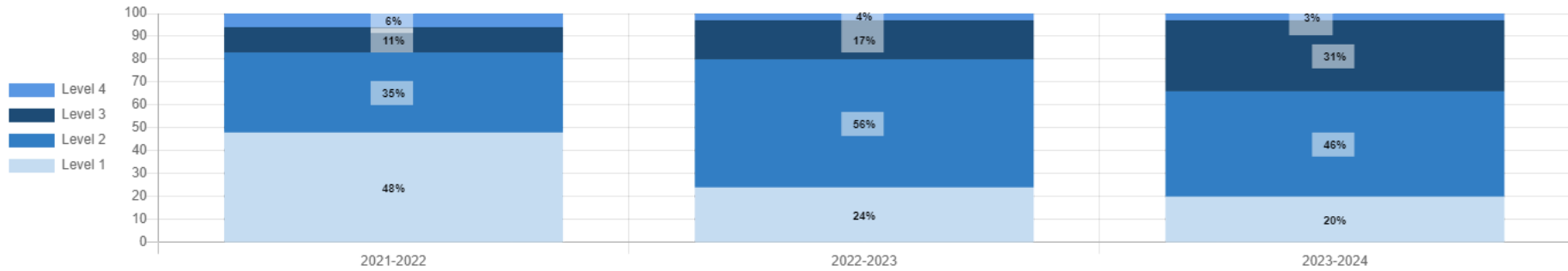

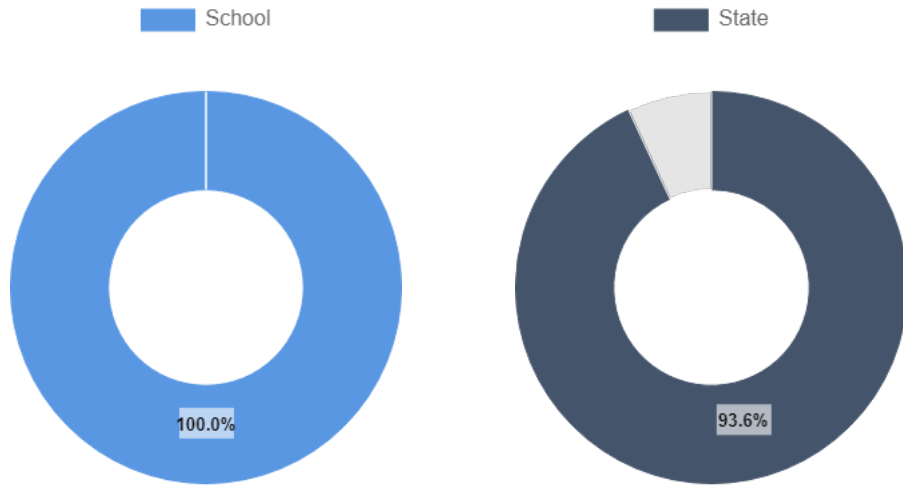

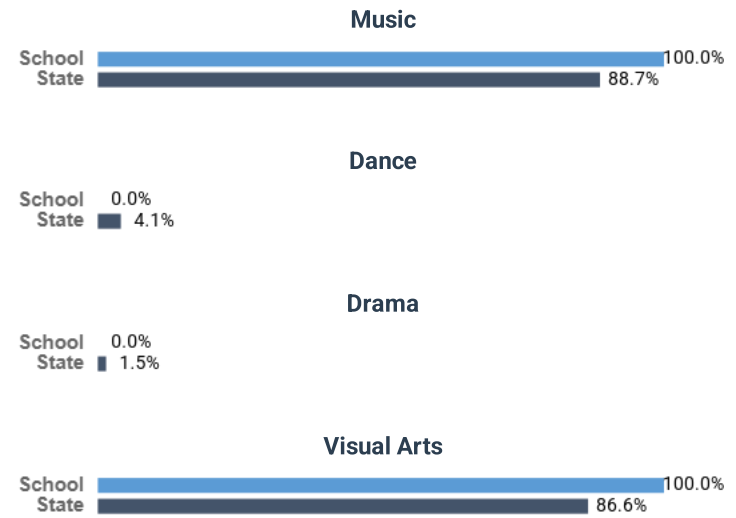

Students enrolled in one or more classes by discipline:



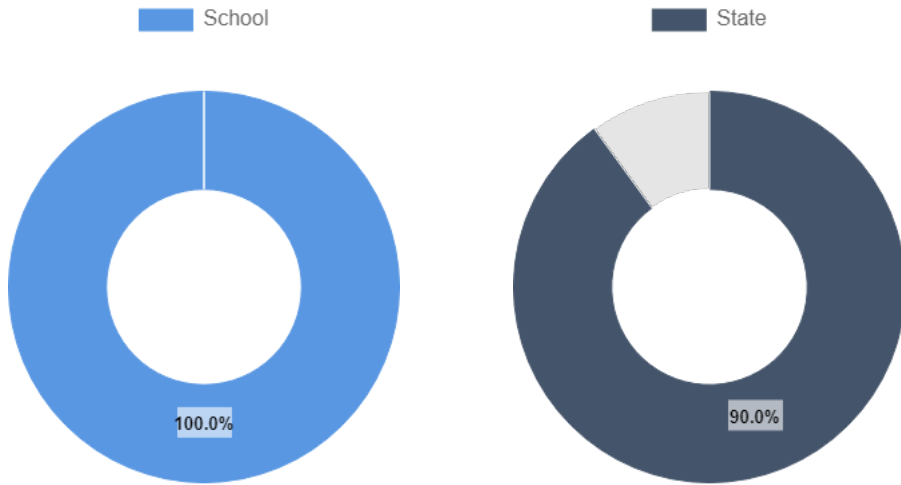

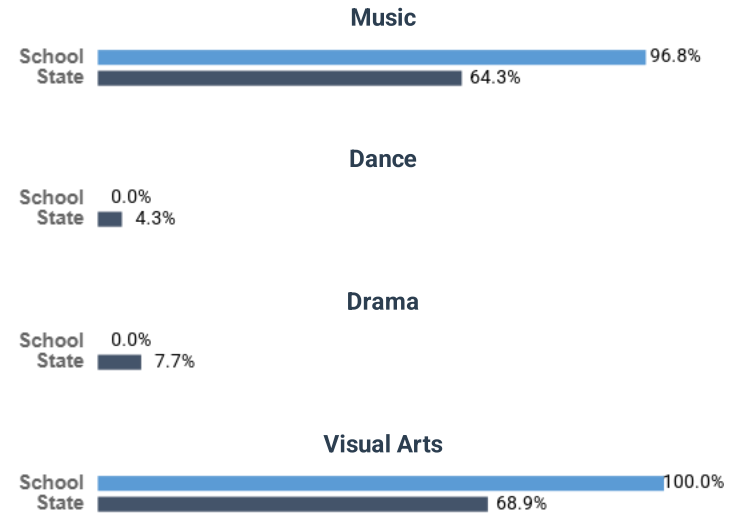

Students enrolled in one or more classes by discipline:



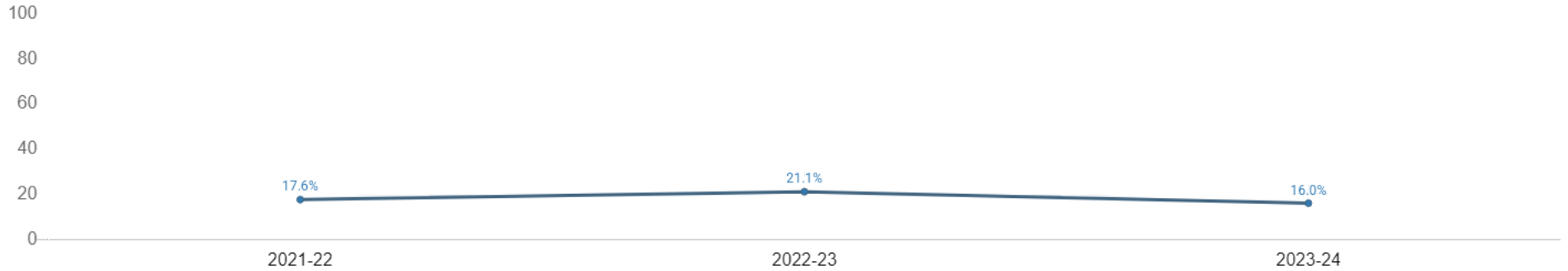

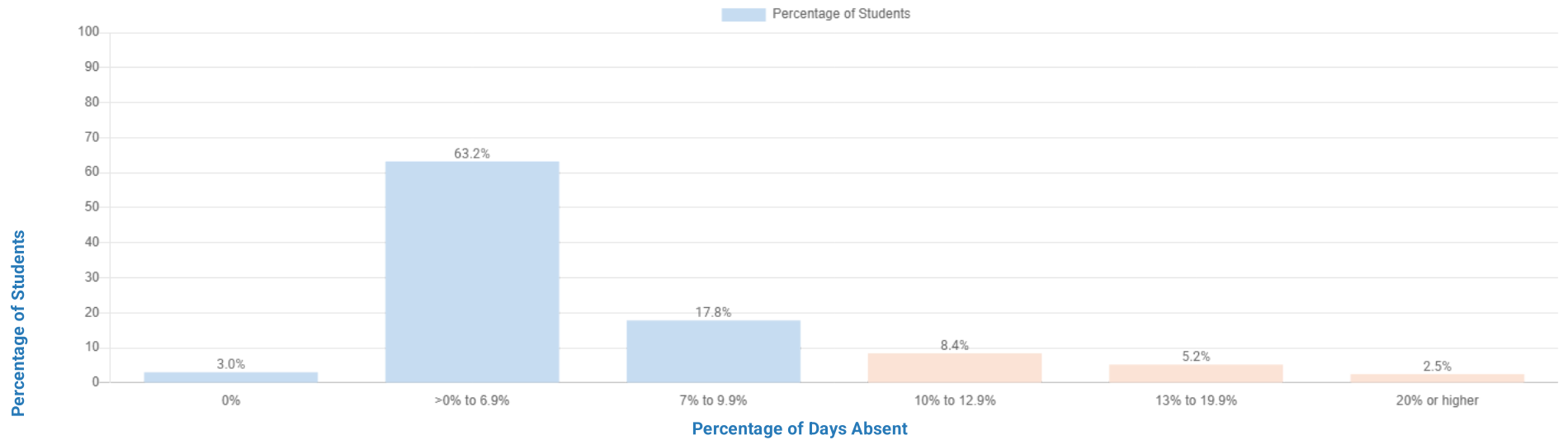

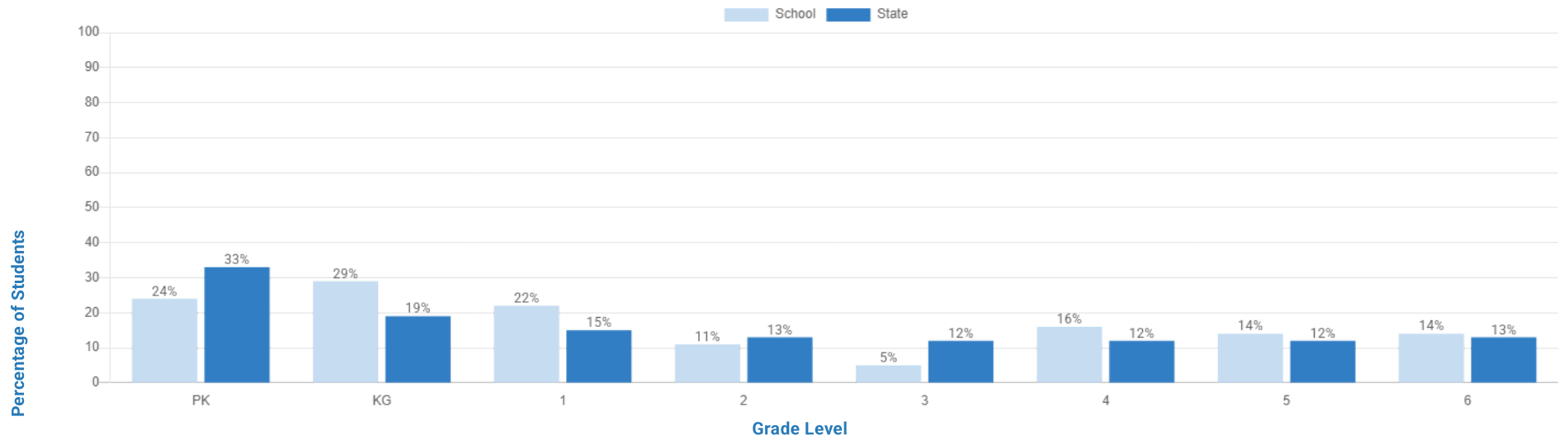

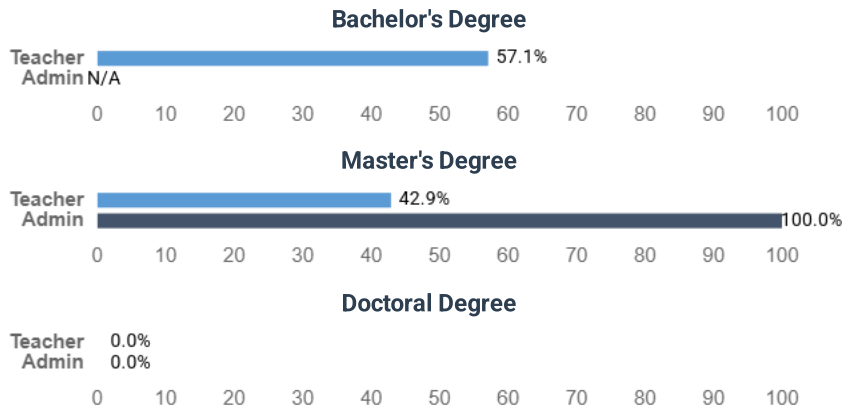

Accountability Summary by Student Group - 2023-24 School Year

Courses, Curriculum, Instruction:

Our K-6 curricula are aligned to the NJSLs. PreK 3-4 provides developmentally appropriate practices through The Creative Curriculum. Our K-5 Structured Literacy instruction reflects the Science of Reading including Heggerty and Orton-Gillingham. Making Meaning and Being a Writer focus on ELA strategies and vocabulary. Grade 6 myPerspective provides students with various texts, novel studies, and develops writing. K-6 Mathematics develops computational and problem solving skills and mathematical discourse using enVision. Science curricula addresses the three dimensions through hands-on investigations using Mystery Science, Generation Genius, Knowing Science and Science and Technology in the Middle School. Personalized learning includes i-Ready, XtraMath, Achieve 3000, and Membean. K- 6 Social Studies is instructed through Scholastic News, Young Citizens, and Newsela. Data driven instruction is supported by our Data teams. Enrichment classes are provided through our KEEP program.



Sports and Athletics:

Sports Offered: Basketball (Boys & Girls), Soccer (Boys & Girls), Volleyball (Boys & Girls)

At the elementary level our students learn and practice the basic foundation of sports and fitness in our gym class and some choose to pursue them through our town recreation program. At Schuyler School we host an annual volleyball tournament for our 5th/6th grade students and we put together a team of fifth and sixth grade students for the district basketball and soccer tournaments. This year we also introduced the game of cricket and pickleball through our phys ed classes.



Clubs and Activities:

Our clubs consist of: Art Club, Guitar Club, Chorus, Band, Safety Patrols, Book Club, Peers, and Student Council. Our Guitar Club, Band and Chorus members perform in our Winter and Spring Concerts and our Art Club helps put together our End of Year Art Show. Our Peers participate in several charity activities throughout the year including a food drive, book drive, and a coat drive.

Before and After School Programs:

Before and after school programs-breakfast, ESL tutoring, help period. After School Programs support academic achievement in ELA and Math are provided to students for a majority of the school year. Additionally, the district offers after school enrichment programs addressing a variety of interest areas including music, arts, and sports. Summer programs are also provided that encompass academics, the arts, and sports. Newcomer multilingual learners are given the opportunity to participate in after school tutorial programs to assist them with their English language development. Additionally, the district offers a summer program for newcomer multilingual learners. We also offer an after school enrichment program with clubs such as book club, board games, legos, mindfulness, and fuse beads. We also work with Right At School who sets up a program in each elementary school to provide before and after school care services for our families.



Staff and Professional Learning:

The school allocates professional development days to staff addressing topics relevant to school and district needs. Teachers receive training throughout the year for current programs and best practices. Additionally, teachers request professional development days to meet their own professional goals. We provide New Teacher Collaborative staff training throughout the year. In addition, cohorts of teachers are working toward Special Education and bilingual and ESL certifications to improve instructional strategies and enhance student achievement. The School Data Leadership team coordinates training and PLCs to share data analysis and promote data driven instruction. Staff is provided mandated training, including Paul's Law, and Danielson Evaluation Model Training. Several staff members continue to pursue higher degrees (Masters, etc.). Teachers also engage in faculty and curriculum meetings to examine instruction and discuss practices to foster continuous professional growth.



Student Supports and Services:

Special Education: Resource and Inclusion classes. Specialized Programs such as Preschool Disabled Program, Pre-K through 6th grade Language/Learning Disabilities and Applied Behavior Analysis Program, Emotional Regulation Impairment program and Extended School Year for students with disabilities. Behavior Support Team and Special Education Coach for teacher and student support. The District Child Study Team plays a crucial role in identifying students, developing educational plans, and monitoring programs for those referred to the team. ESL/Bilingual: Multilingual learners are provided with English language development support through the part-time Bilingual Program for Spanish speakers and Sheltered Instruction for speakers of languages other than Spanish. Students are supported with after school tutoring opportunities and a summer program. Help period is provided daily.

Student Health and Wellness:

We provide services to help enhance our students' physical and mental health and wellness. We offer grab and go breakfast, recess, physical ed classes, scoliosis screenings, Great Body Shop health lessons, and dental, hearing, vision, height and weight screenings. We have a full time nurse in our building to address all health concerns immediately. We have an established MERT team, Janet's Law team, and provide AED/CPR staff training. We also have a full time counselor and crisis team to help address any student social or emotional concerns. We have lunch bunch groups and are establishing a restorative room. We also participate in our district wide Wellness Week with great presentations and activities that address various physical and social and emotional components of life.



Parent and Community Involvement:

We maintain open communication with parents through our Genesis Parent Portal, Parent conferences, Thrillshare calls/emails/texts, Facebook page, school website, progress reports, and report cards. We hold a Back-To-School Night and many PTA events for all families - Back to School Bash, Family Movie Night, Bingo, Trick or Trunk, Book Fair, Fall Festival, Fall Dance, Cookies and Milk Night, Someone Special Dance, and many others. We also hold Early Childhood Parent Involvement Days, Title 1 and ESL Parent Involvement Nights, and school wide family engagement nights including Reading Under the Stars and Dive Into Literacy. We participate in the L.E.A.D program and Jr. Police Academy in collaboration with the Kearny Police Department. We hold food drives, collect toiletries for veterans, and participate in many local and county contests. Our students enjoy assemblies from the Passaic Valley Sewerage Commission and the Hudson County Improvement Authority.

Facilities:

Each year we try to keep updating our building. We have a science lab, art/music room, gymnasium, auditorium/multi-purpose room, play court, library, and a playground. Each room is equipped with a smartboard and the building is fully air conditioned. Our outside grounds are well maintained with a beautiful garden and bench and a digital sign.



School Safety:

School Safety includes ongoing training for staff in conjunction with the Kearny Police Department. We have security walkthroughs conducted weekly, a full time security guard is present in the building, and security cameras are located throughout the interior and exterior of the building. Our security guard keeps a log of all visitors who are also expected to wear visitor ID badges. The building is equipped with a panic button and high noise volume areas (gym, play court, auditorium) have a strobe light. Security drills and fire drills are practiced monthly and we have a school safety team to help continually analyze our safety procedures. This year we also established a Care and Concern Team to help identify and address any behavior threats.



Technology and STEM:

Technology is integrated throughout the curricula to enhance instruction. Students in grades K-6 are provided with a Google Chromebook. Pre K students are provided with an i-Pad. Students use Google suite and tools to create presentations, demonstrate understanding and extend learning. Students have the ability to collaborate digitally with peers. Promethean and SMART boards in every classroom add to an engaging, interactive experience for students. Students are enrolled in a Computer Science and Design Thinking course to instruct students on online safety, 21st century computer skills and knowledge. Students are provided with STEM activities including coding, engaging in break out room activities, and programming Kibo robots. Smart TVs highlight school happenings, celebrate student achievements, and promote an inclusive school environment. Students participate in the Saturday Morning STEM initiative at NJIT.

Early Childhood Education:

State-funded preschool three and four year old programs are offered. We offer a developmentally appropriate curriculum tailored to the social, emotional, cognitive, and physical development of young children. Staff utilize observations and performance based assessments to monitor students' progress and to guide individualized learning. The Pyramid Model is implemented to promote social-emotional development and help students build skills in self-regulation and independence in a structured and supportive manner. Instructional coaches and Intervention and Referral Specialists provide ongoing support for staff. Early Childhood Parent Involvement sessions and educational workshops for families are held throughout the year. The Early Childhood Advisory Council meets quarterly to review survey data, discuss the needs of families, and identify community resources to address the needs. Partnerships with local organizations ensure preschool families have access to additional support resources.
