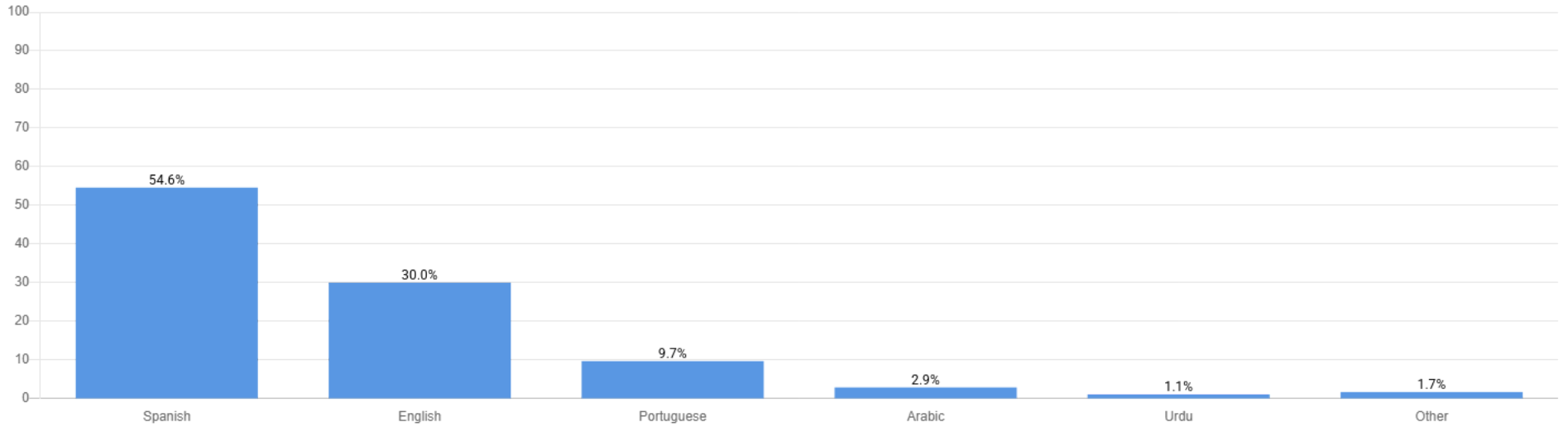

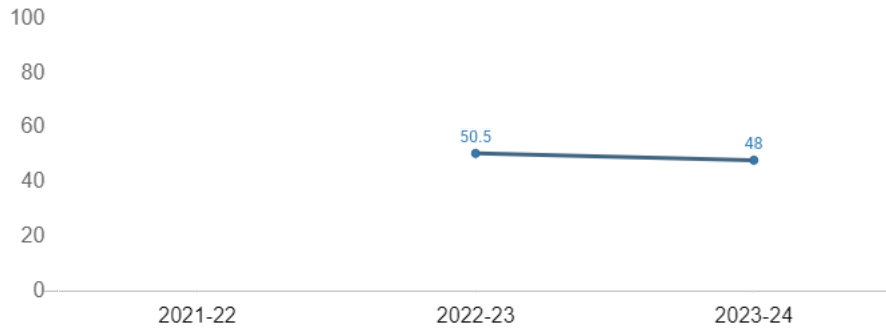

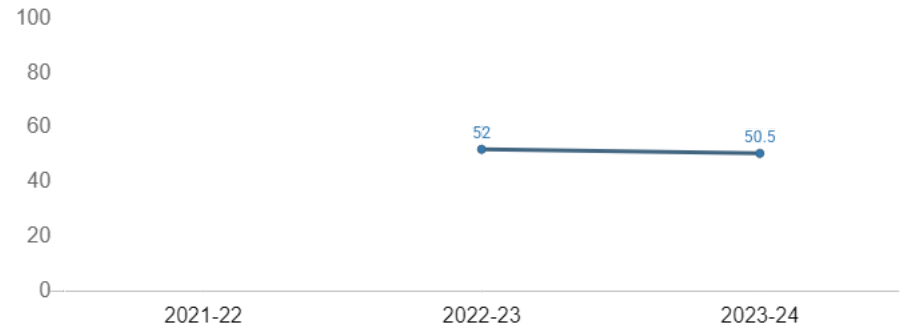

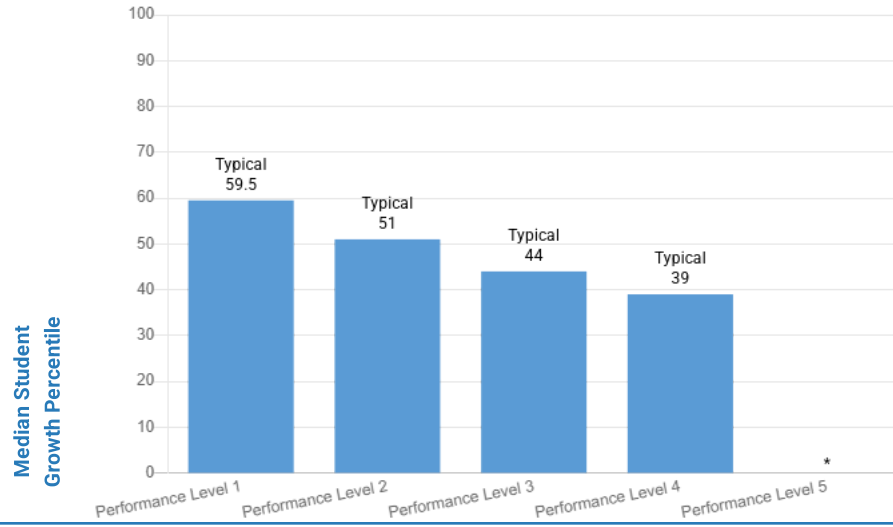

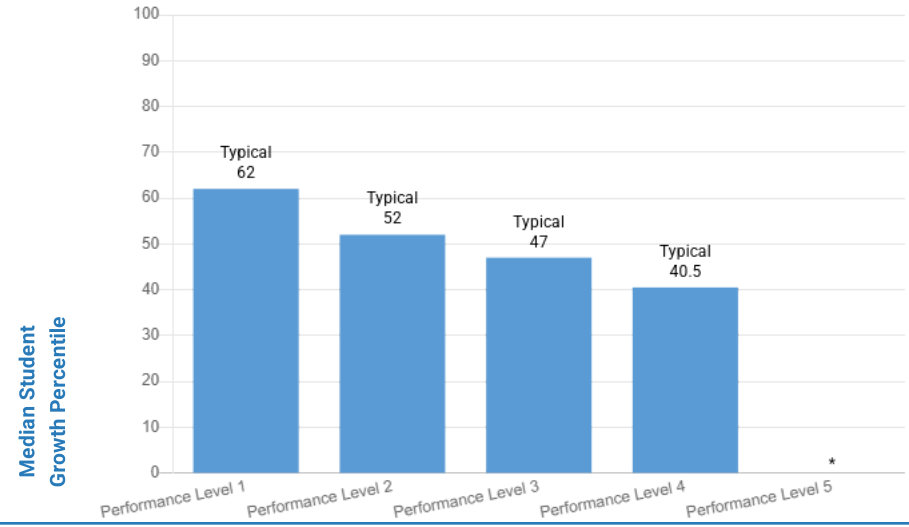

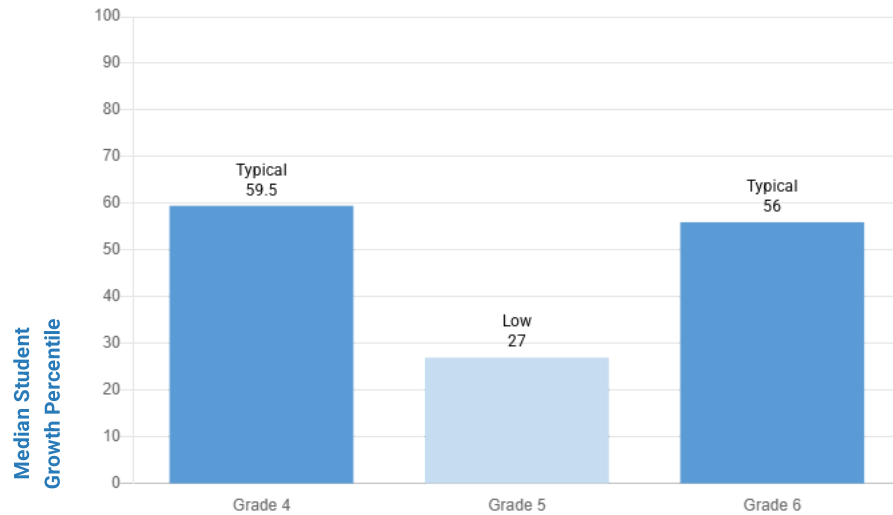

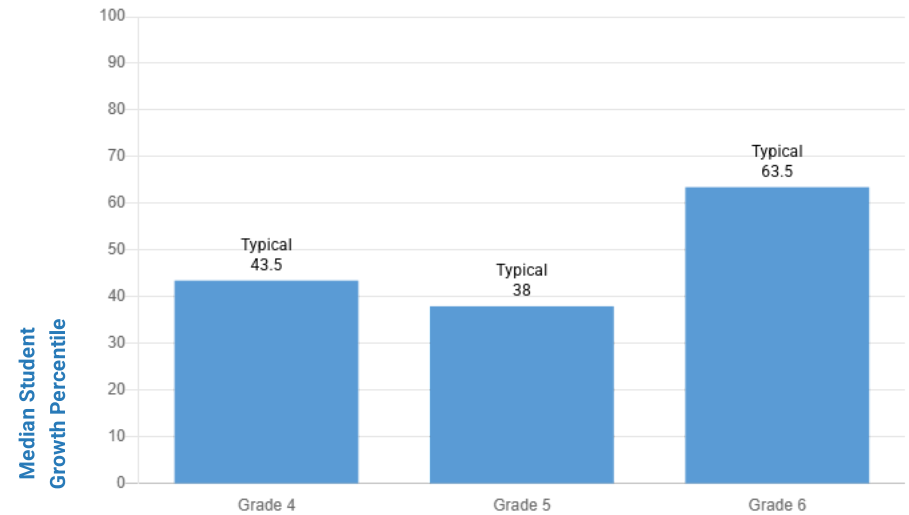

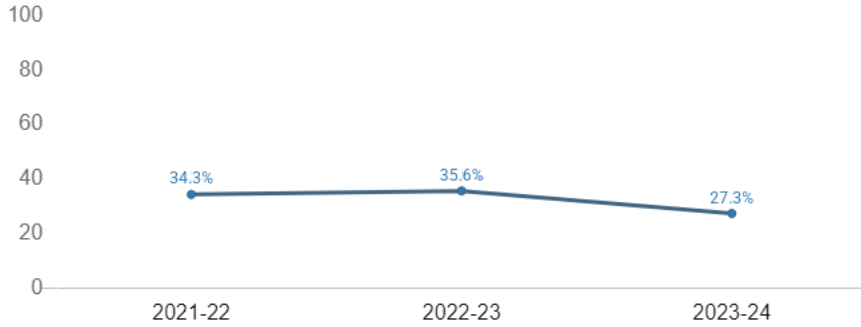

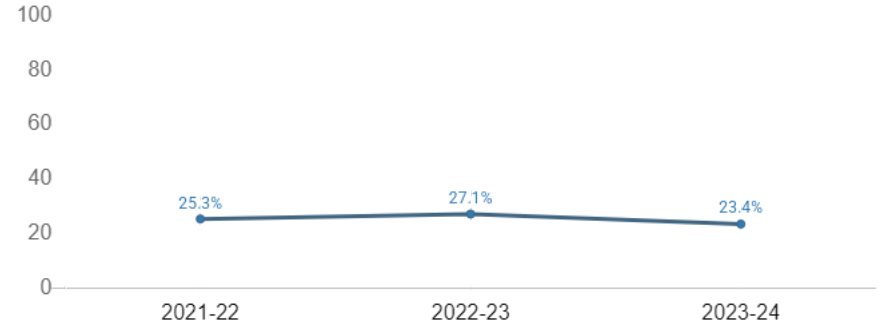
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. The Proficiency Rate for Federal Accountability measures the percentage of students who met or exceeded expectations on the assessments (NJSLA or DLM) with an adjustment made if the participation rate is below 95% to ensure reporting on at least 95% of students. 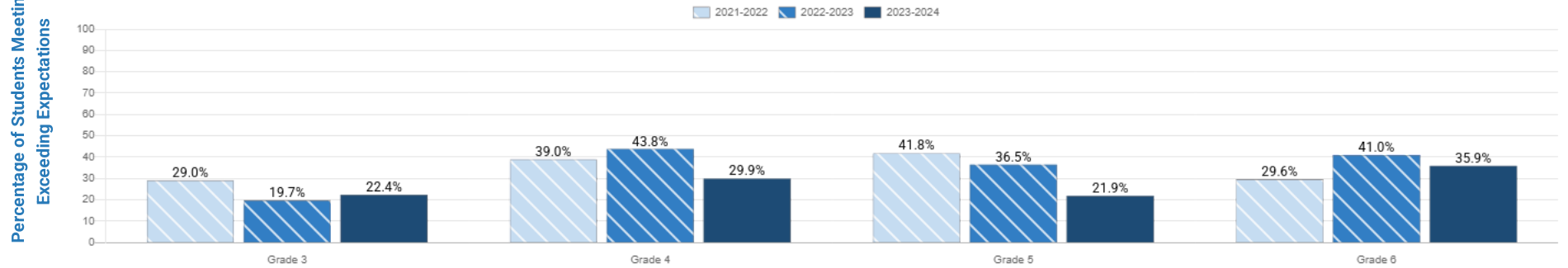

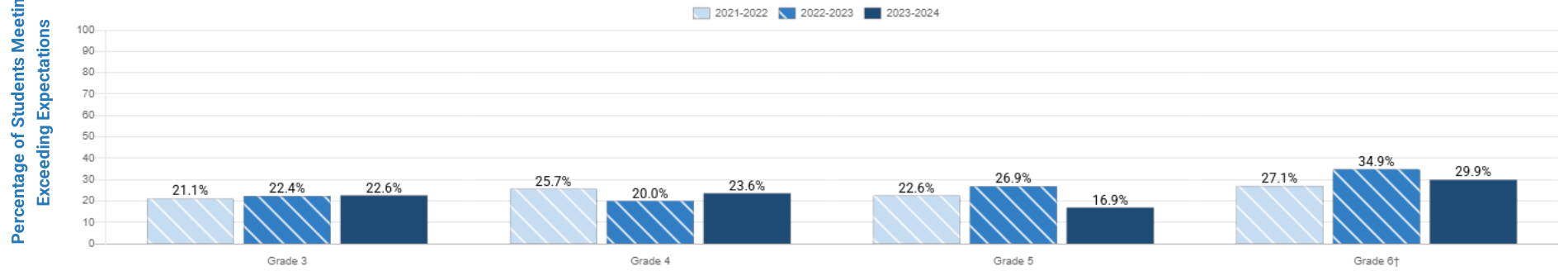

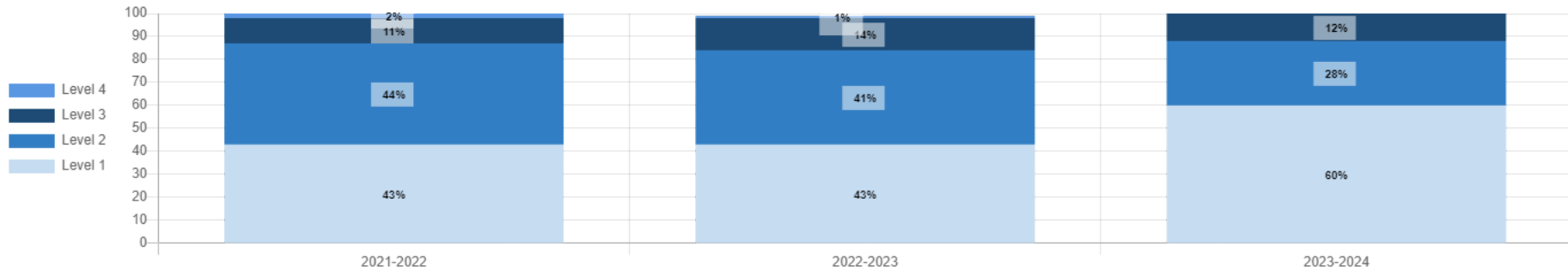

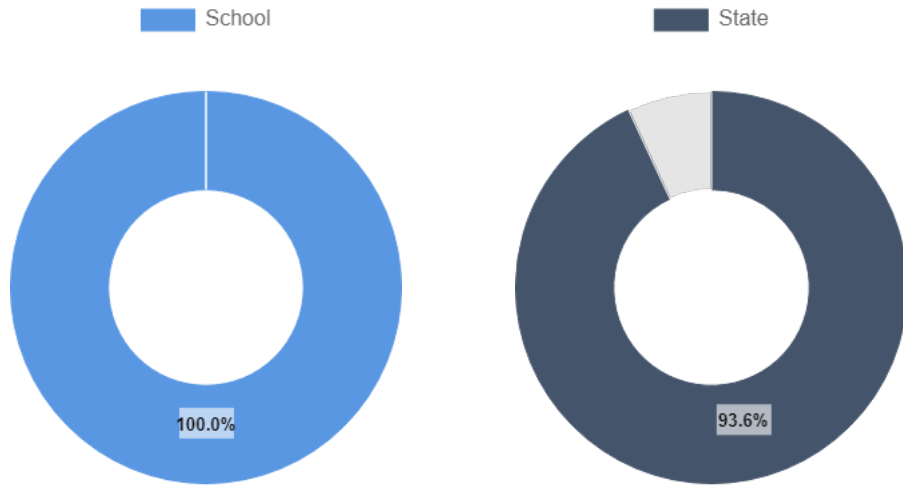

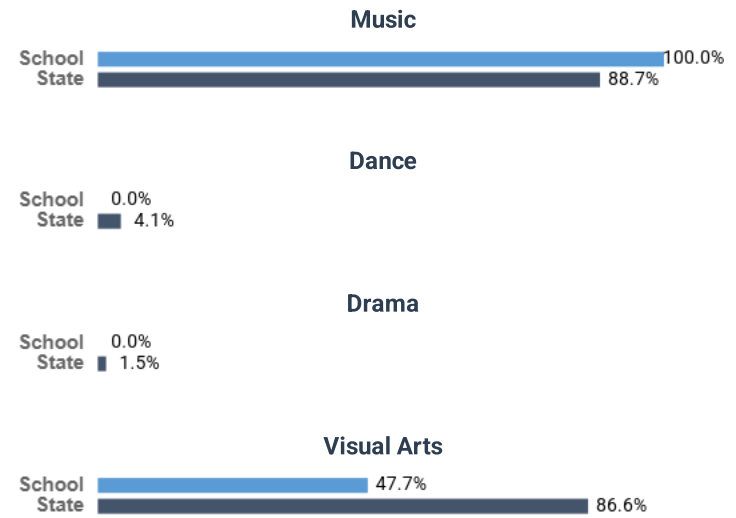

Students enrolled in one or more classes by discipline:



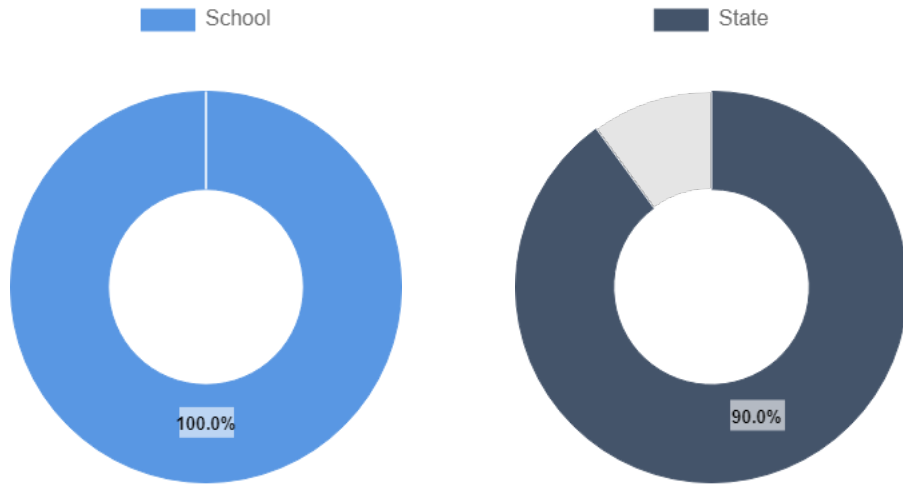

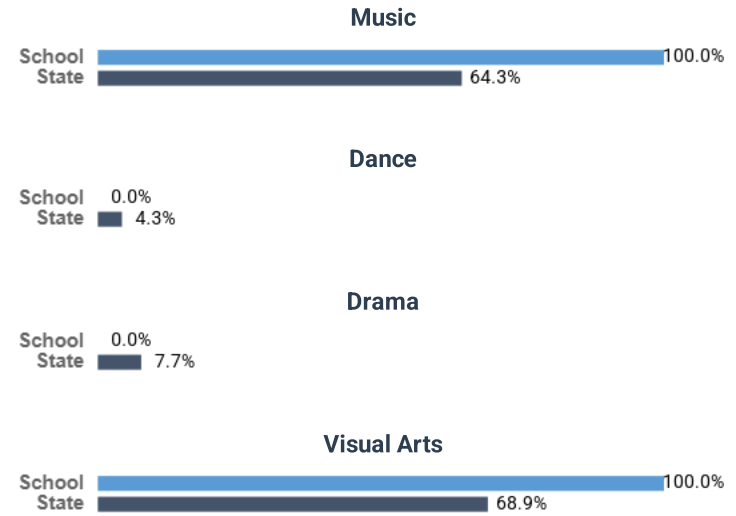

Students enrolled in one or more classes by discipline:



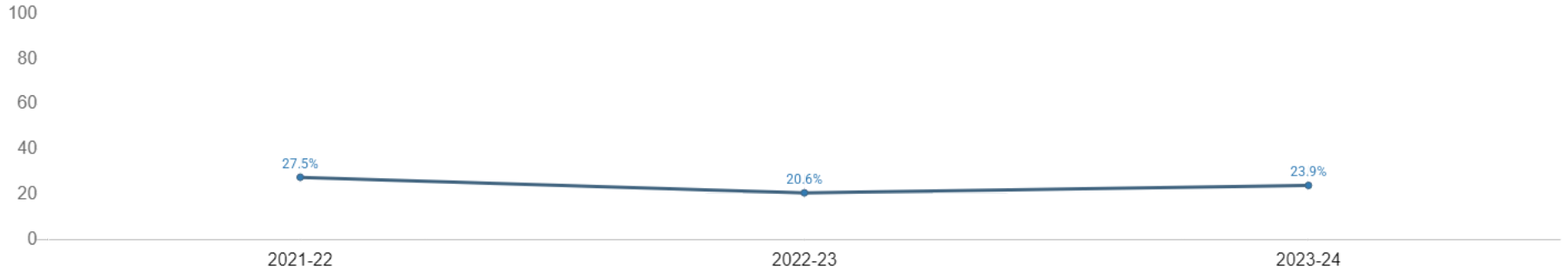

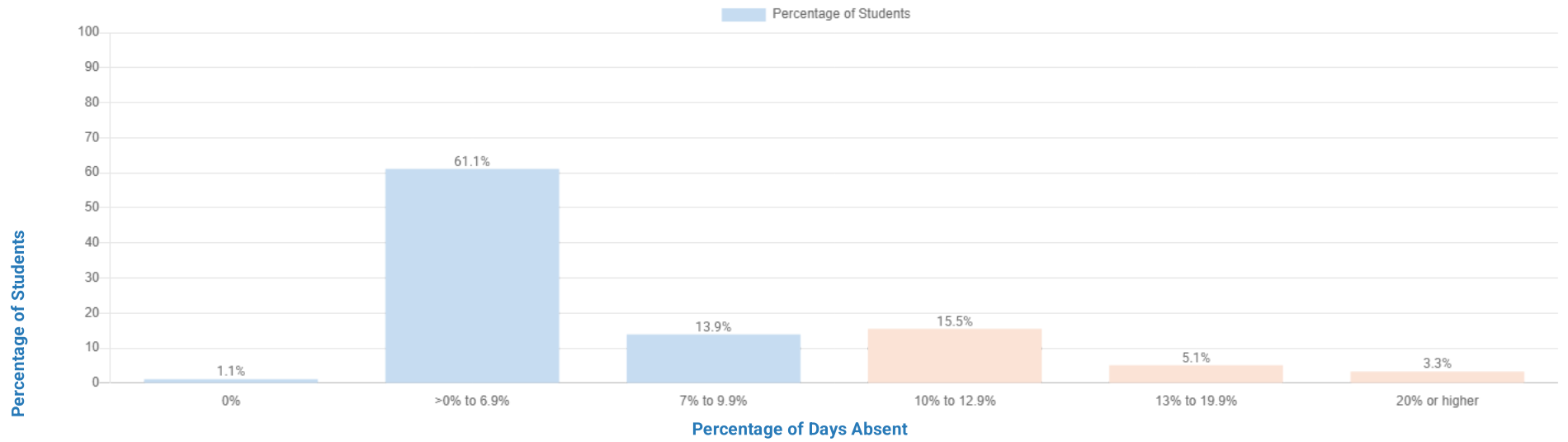

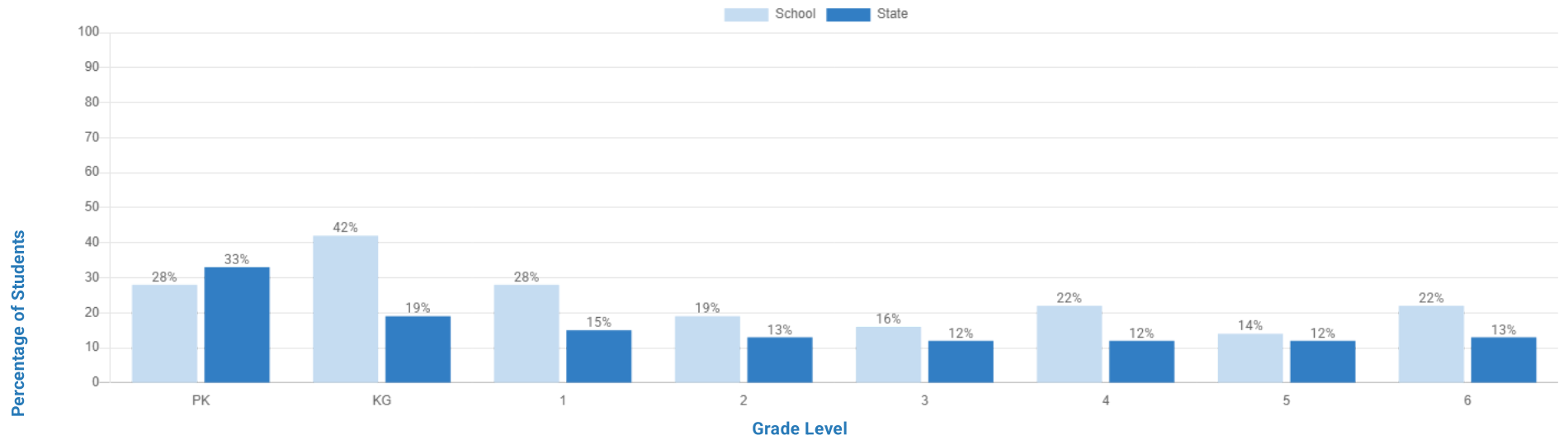

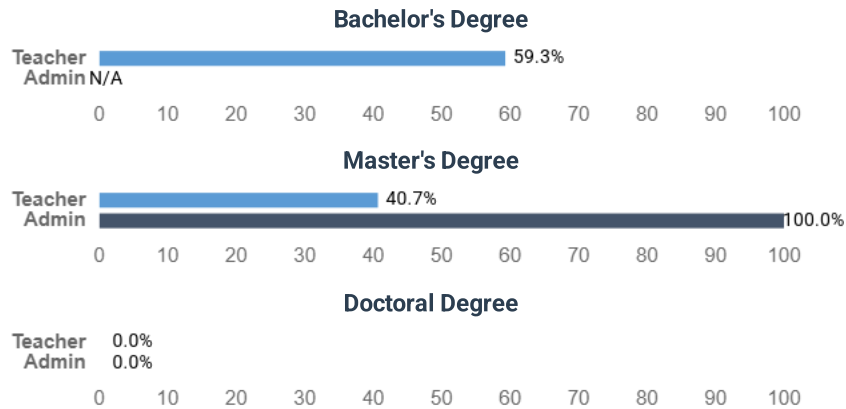

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Early Childhood Education:

State-funded preschool three year old and four year old program is offered. We offer a developmentally appropriate curriculum tailored to the social, emotional, cognitive, and physical development of young children. Staff utilize observations and performance based assessments to monitor students' progress and to guide individualized learning plans. The Pyramid Model is implemented to promote social-emotional development and help students build skills in self-regulation and independence in a structured and supportive manner. Instructional coaches and Intervention and Referral Specialists provide ongoing staff support.
