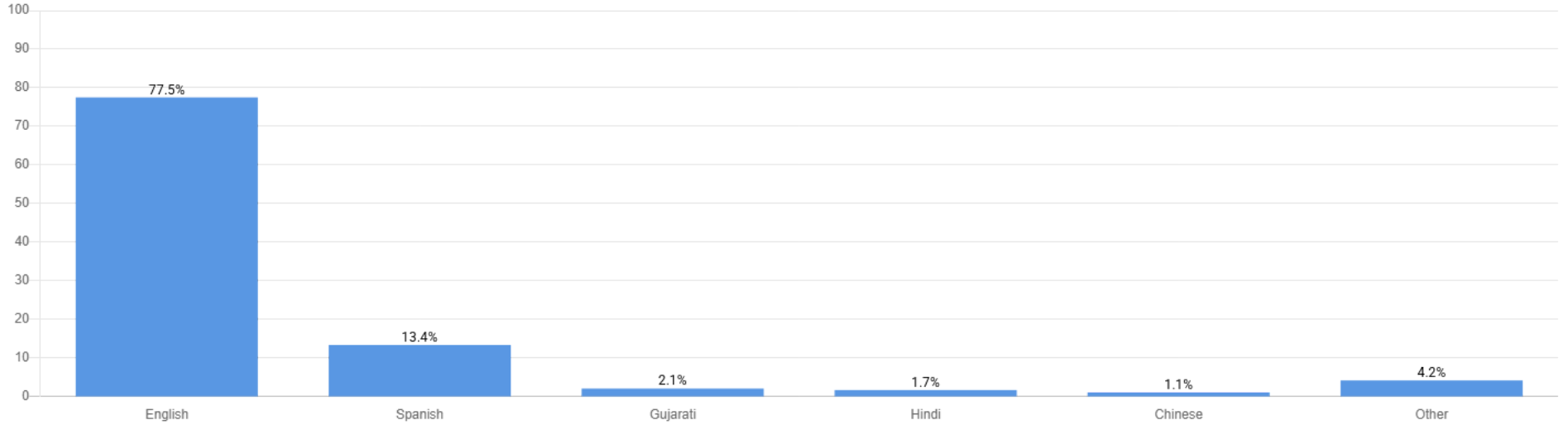

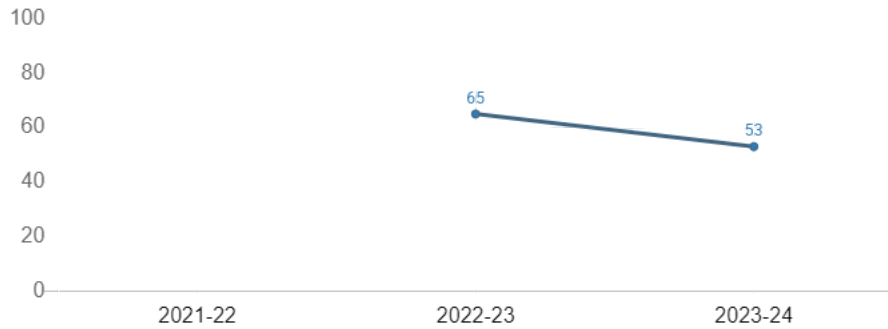

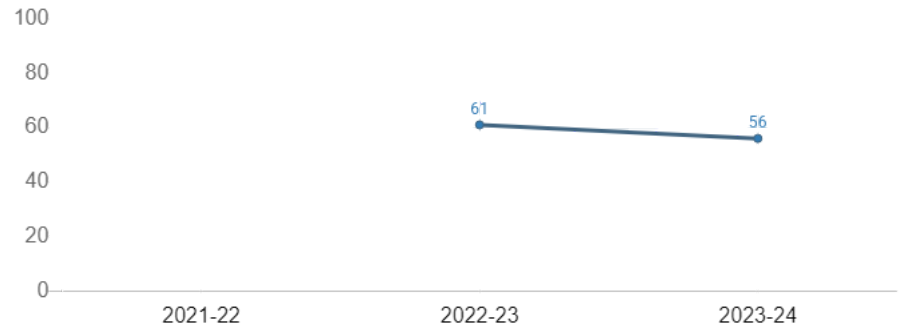

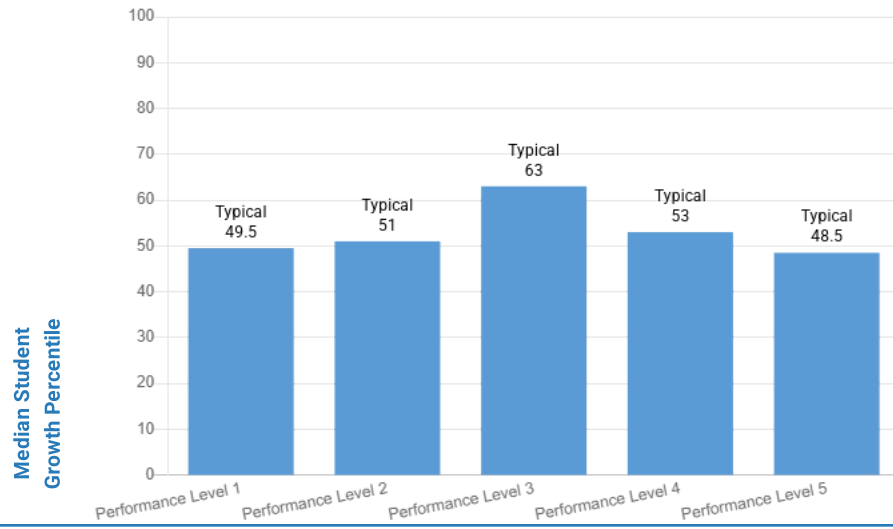

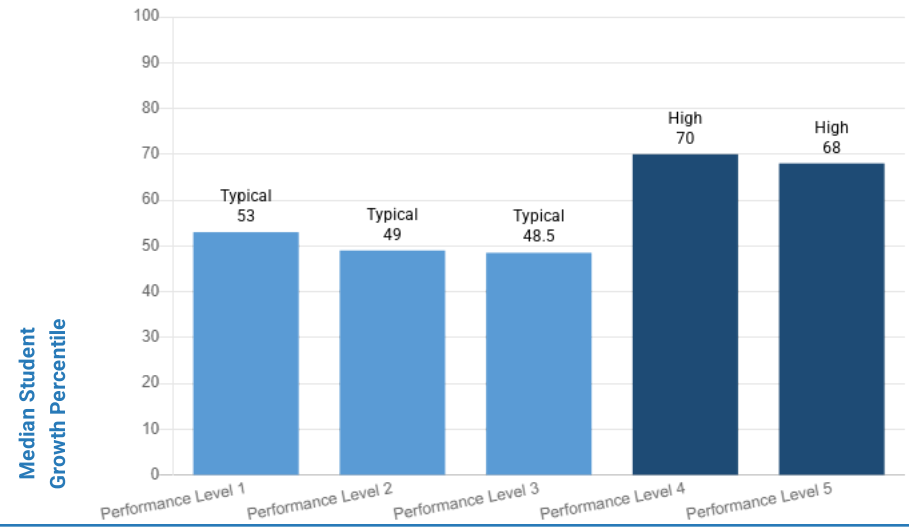

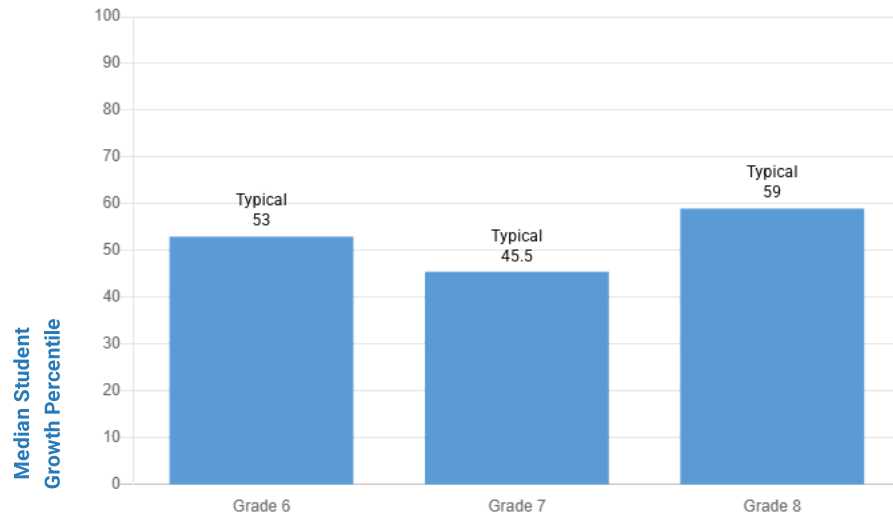

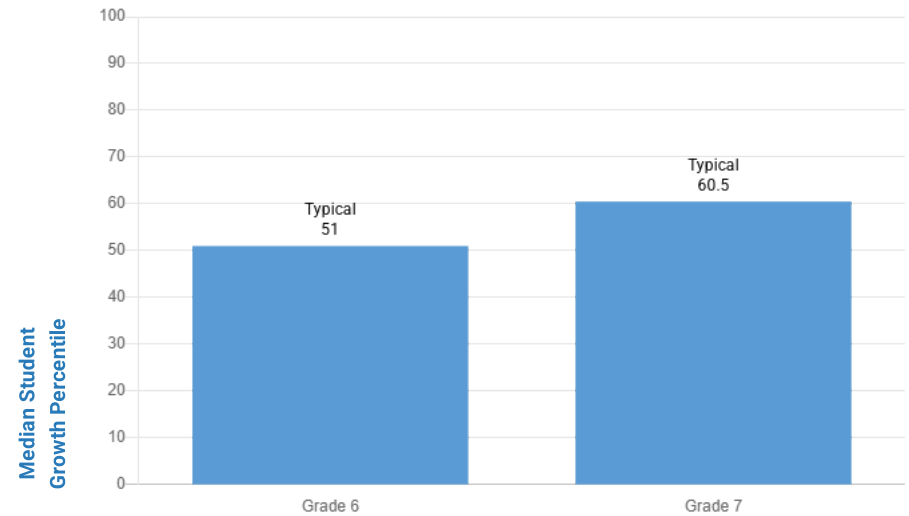

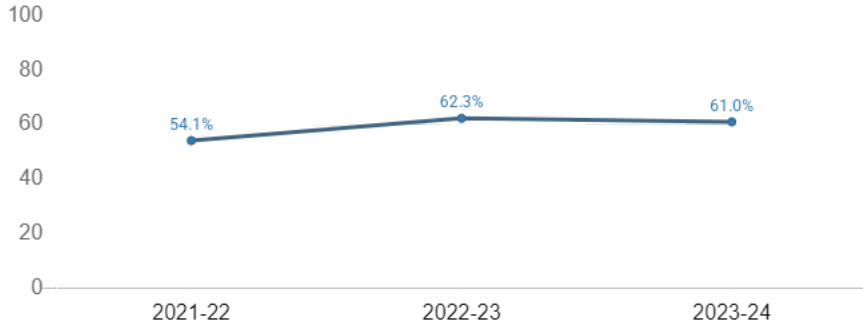

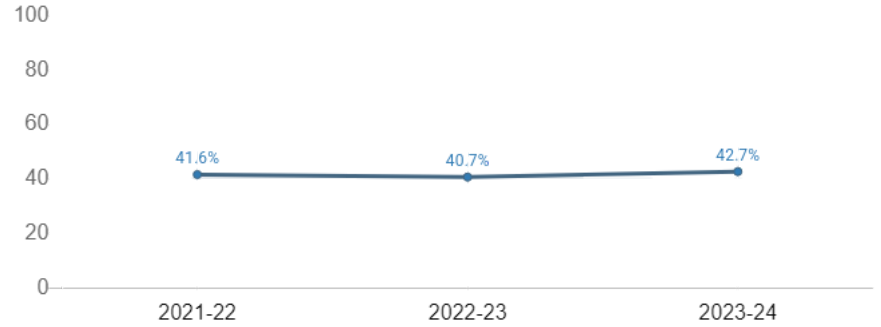
English Language Arts and Mathematics Performance Trends

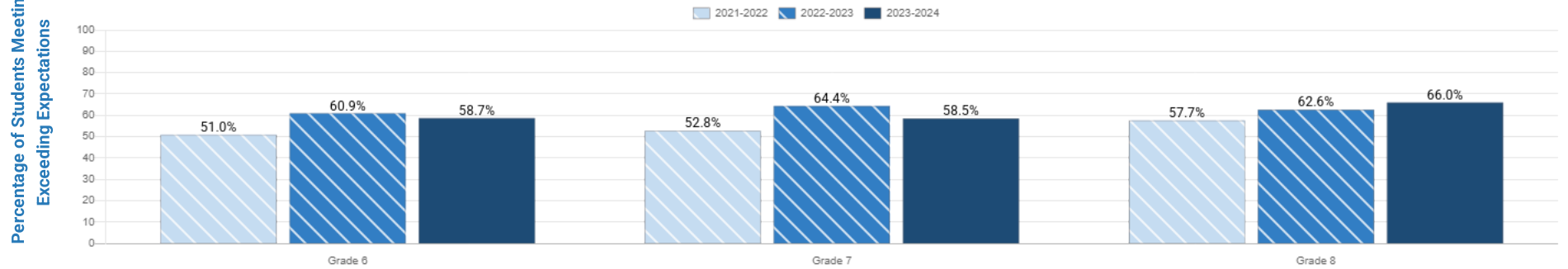

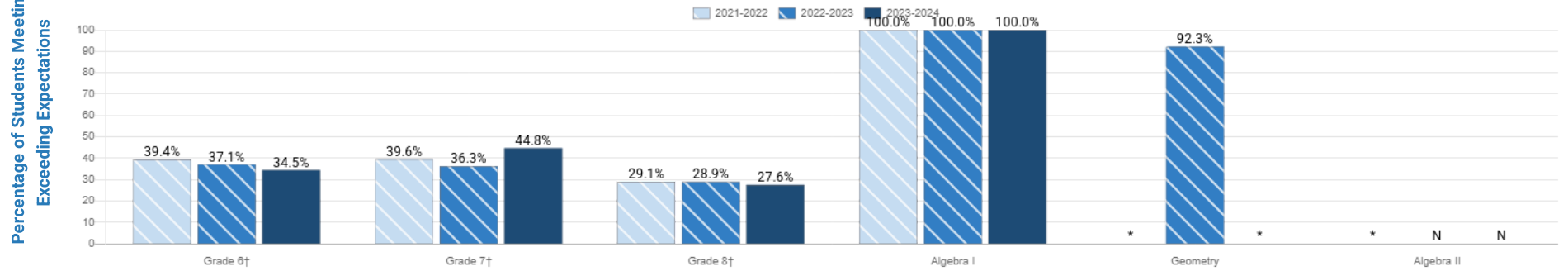

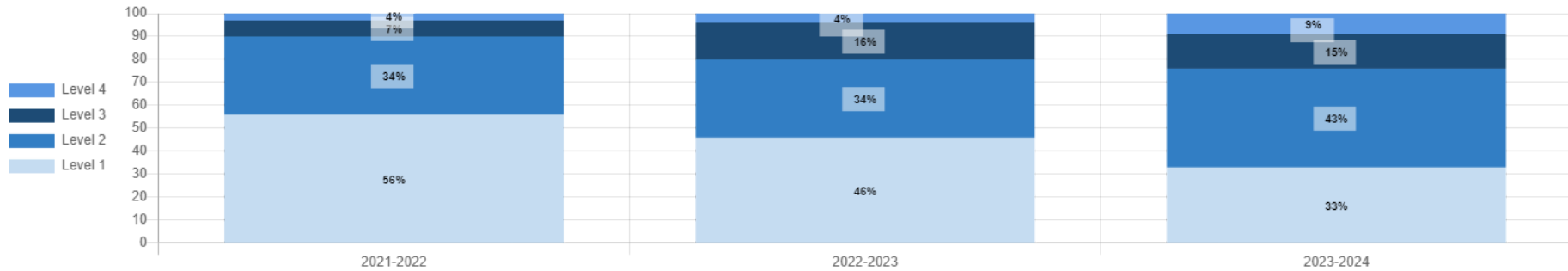

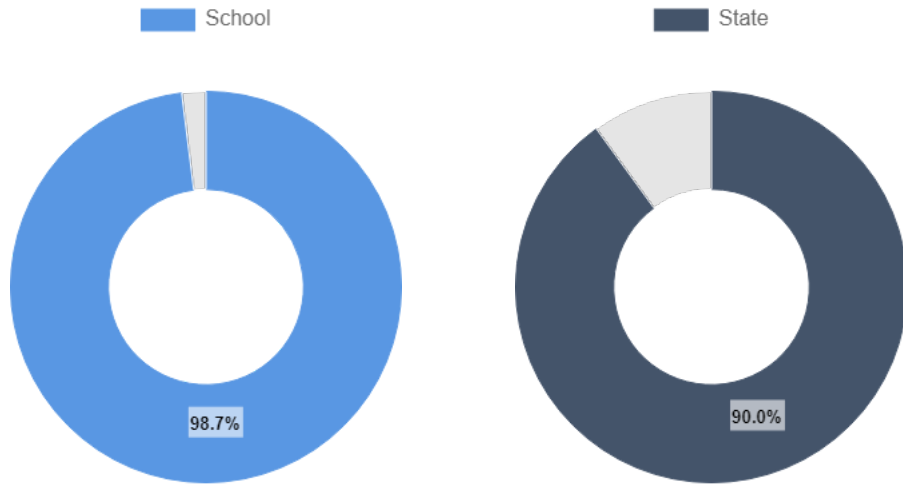

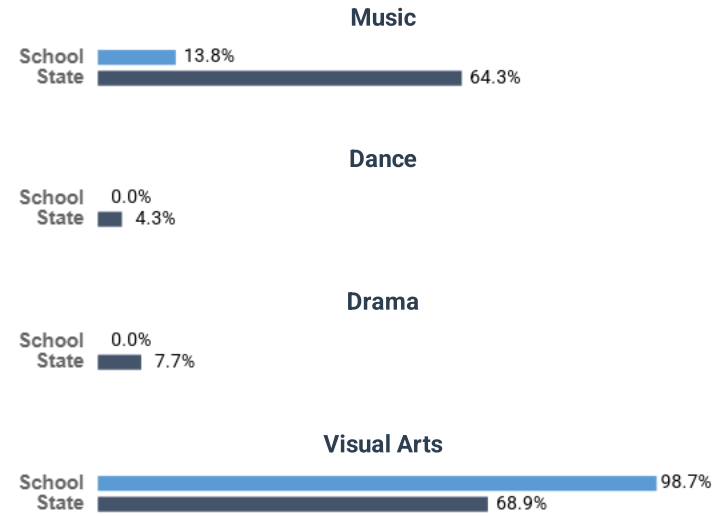

Students enrolled in one or more classes by discipline:



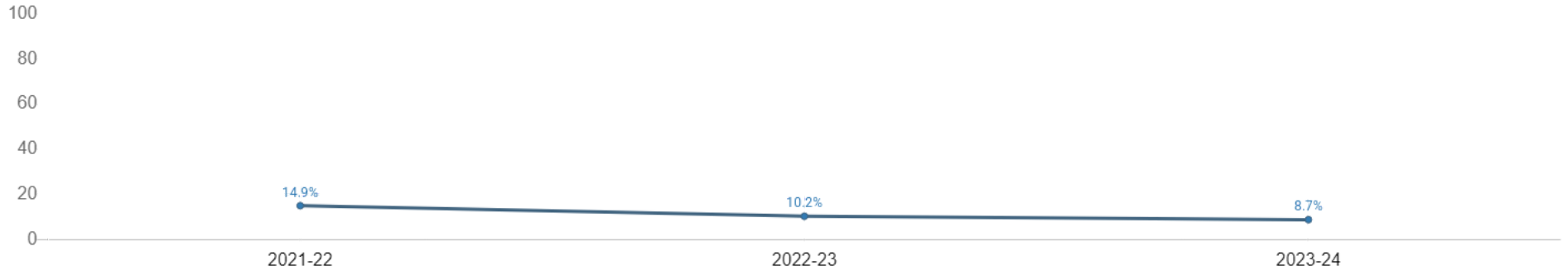

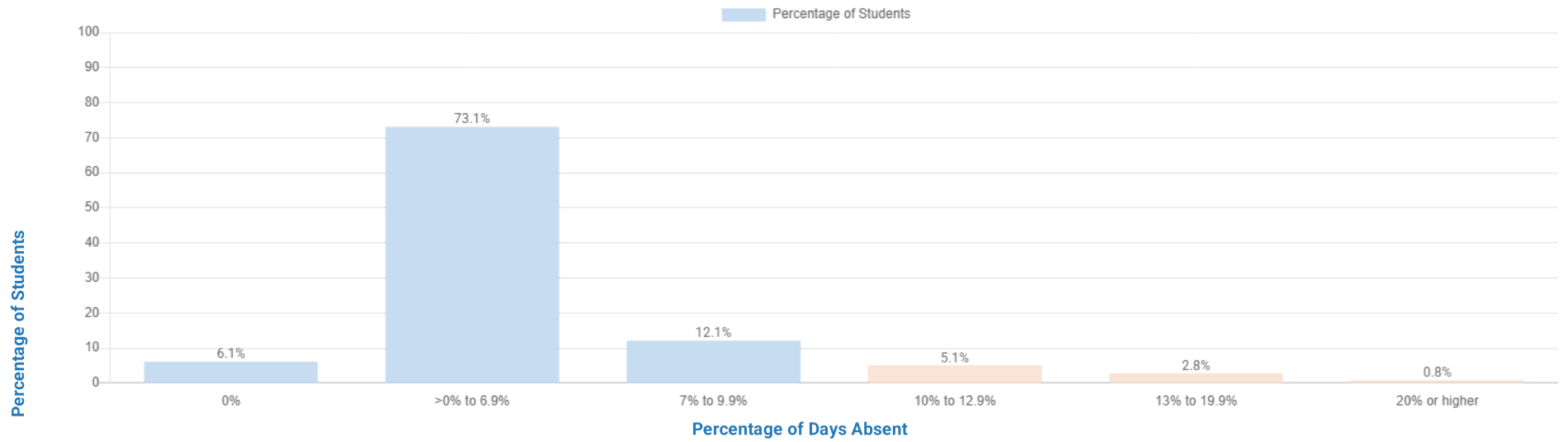

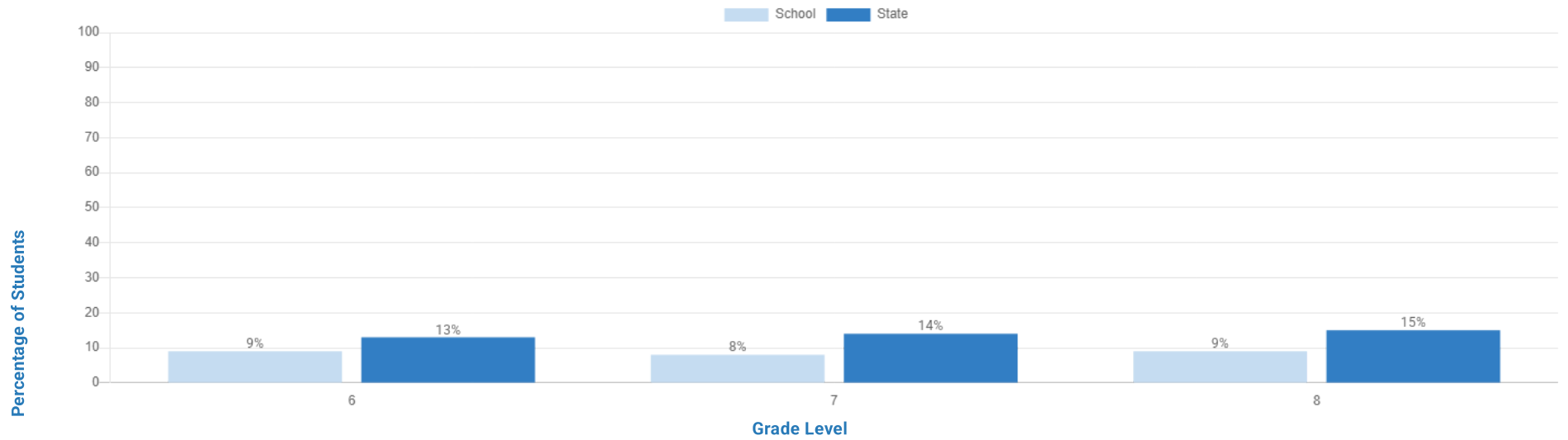

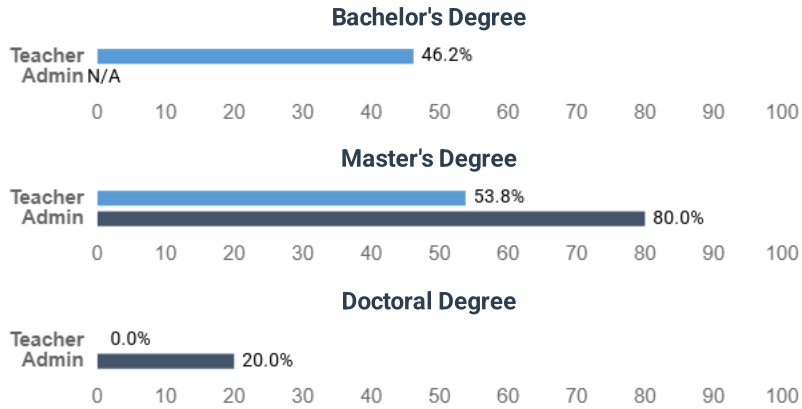

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Secaucus Middle School takes pride in the appearance of the building. All instructional spaces are equipped with interactive whiteboards, smart boards, or Promethean boards. Our school is 1:1 and our entire school building is equipped with wireless internet access. Our custodial staff is conscientious in maintaining excellence in the general upkeep of the school each day. All classrooms are air-conditioned. The school is thoroughly cleaned and maintained each summer.



School Safety:

Security is of primary importance in the Secaucus School District. We have a strong partnership with the Secaucus Police Department, SMS has a full time School Resource Officer in the building during the school day. All outside doors are kept locked at all times. Visitors must present themselves to the Security Guard at the Main Entrance to be admitted. Parents/Guardians and other visitors are required to report to the office upon entering the building. All volunteers and visitors are required to sign in and wear the identification badge issued in the school office. A comprehensive school action plan is reviewed and updated annually. School personnel receive training from experts on how to respond to emergency situations and safety/security drills are conducted twice monthly. The Secaucus Board of Education has adopted an emergency/evacuation in all schools. Evacuation drills are conducted throughout the year.



Technology and STEM:

STEM offers a rigorous three year interdisciplinary STEM Program designed to provide a strong educational foundation for those academically-gifted students. The program establishes small learning communities housed within the larger high school environment, designed to encompass a particular course of study (Engineering, Computer Science, Mathematics, Physical Science, Life Science) through hands-on experiences with experts in the fields.
