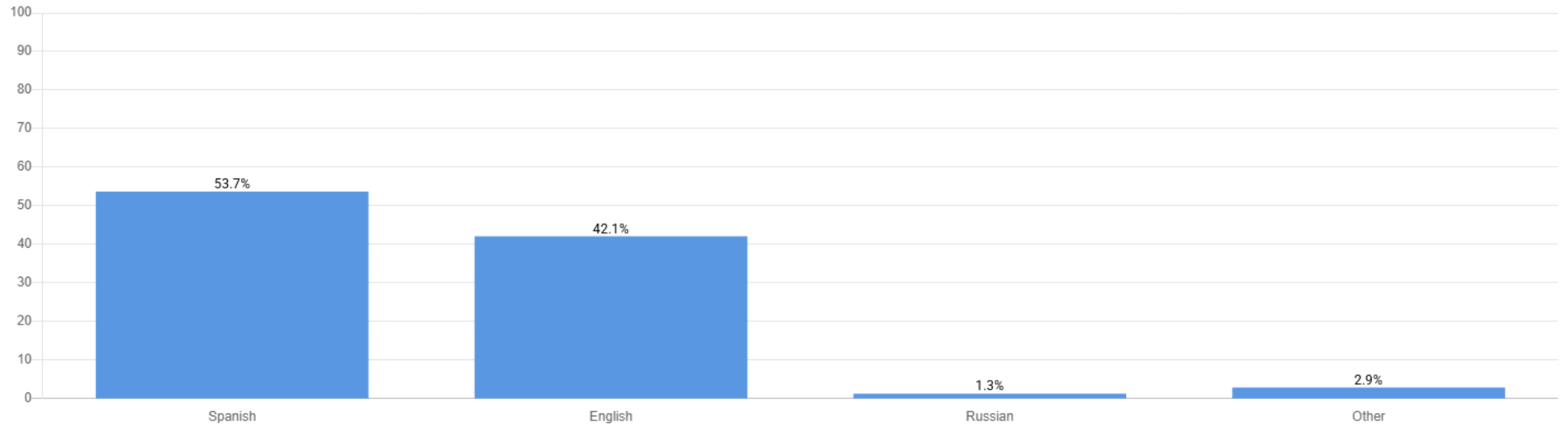

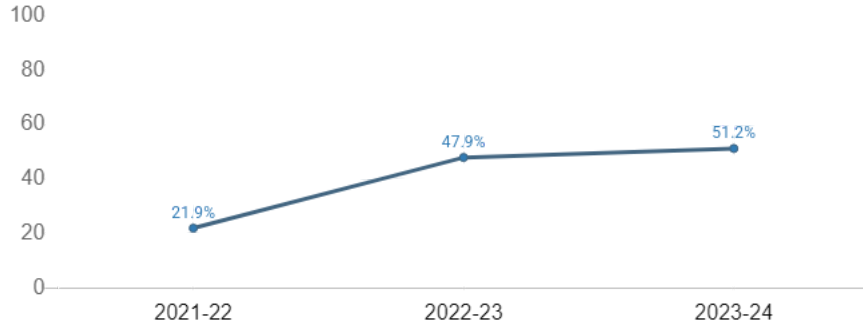

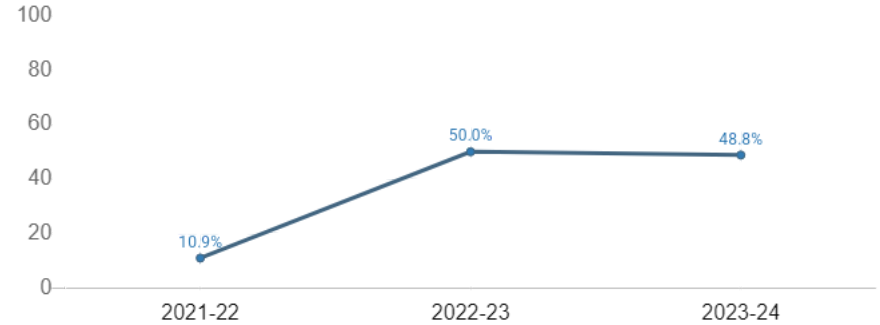
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 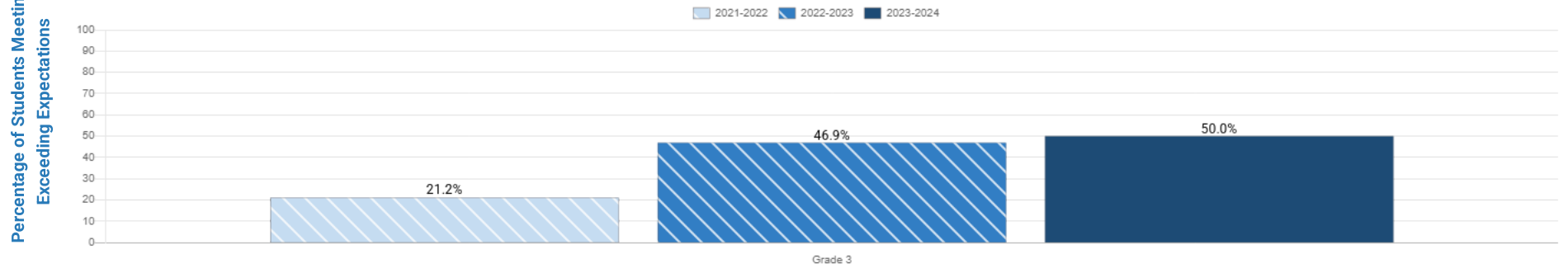

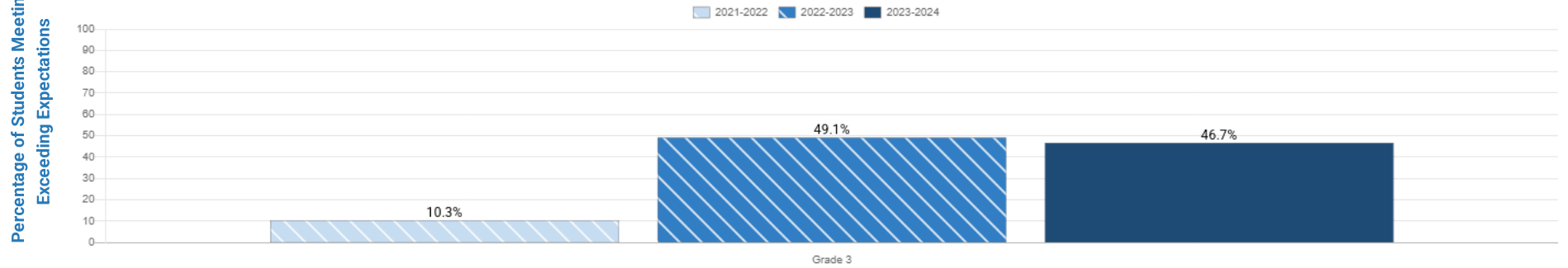

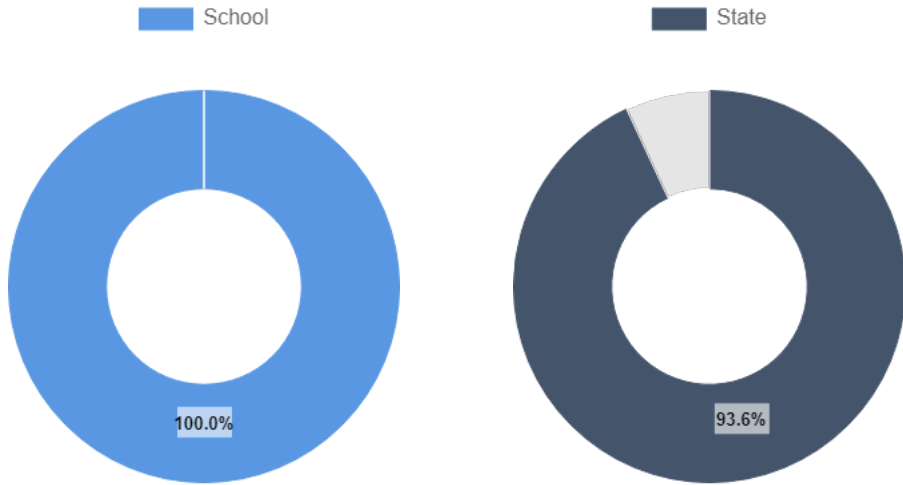

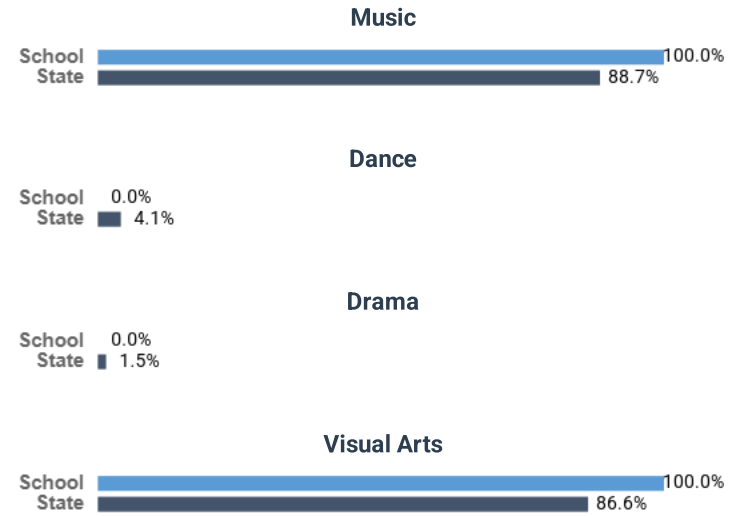

Students enrolled in one or more classes by discipline:



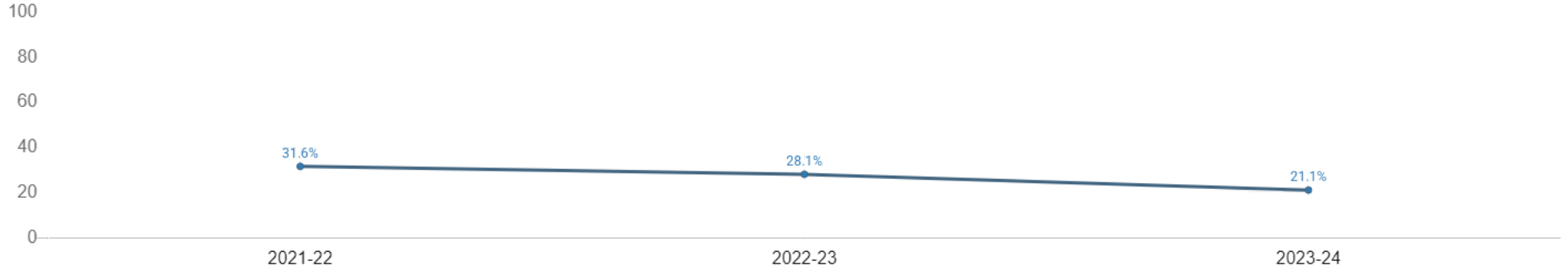
Climate and Environment

Student absences provide important information about a school's culture and climate. Research shows that absences impact a student's ability to succeed in school. The NJDOE used input from stakeholders to select chronic absenteeism as its measure of school quality and student success for the ESSA accountability plan. **Chronic absenteeism** is defined as being absent for 10% or more of the days enrolled during the school year. A student who is not present for any reason, whether excused, unexcused, or for disciplinary action, is considered absent unless permitted by state statute or regulations. Students with fewer than 45 days in membership are excluded from attendance calculations.

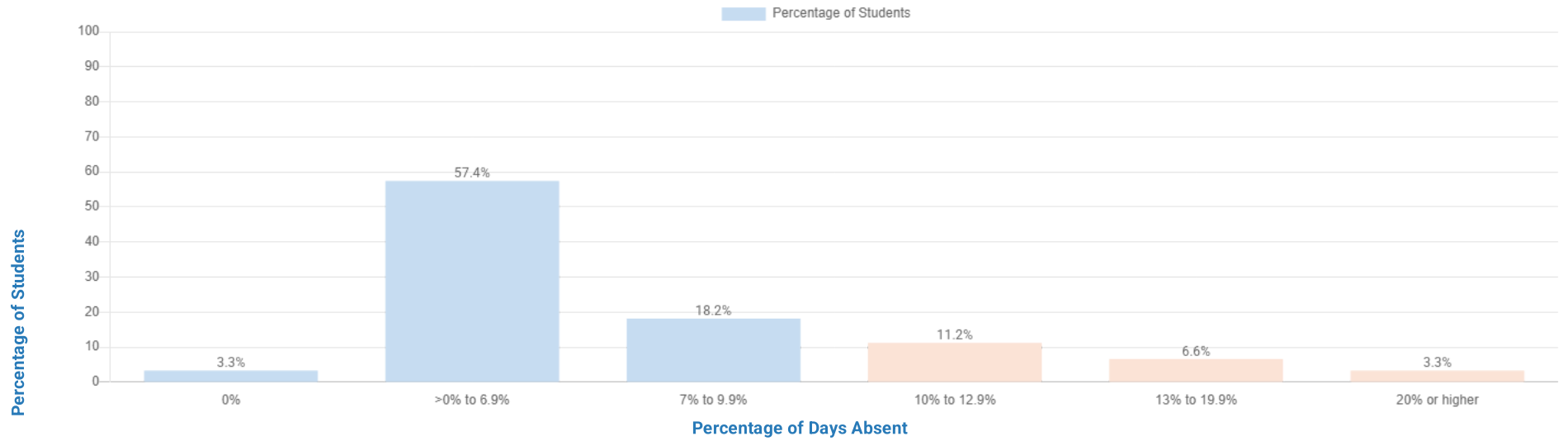

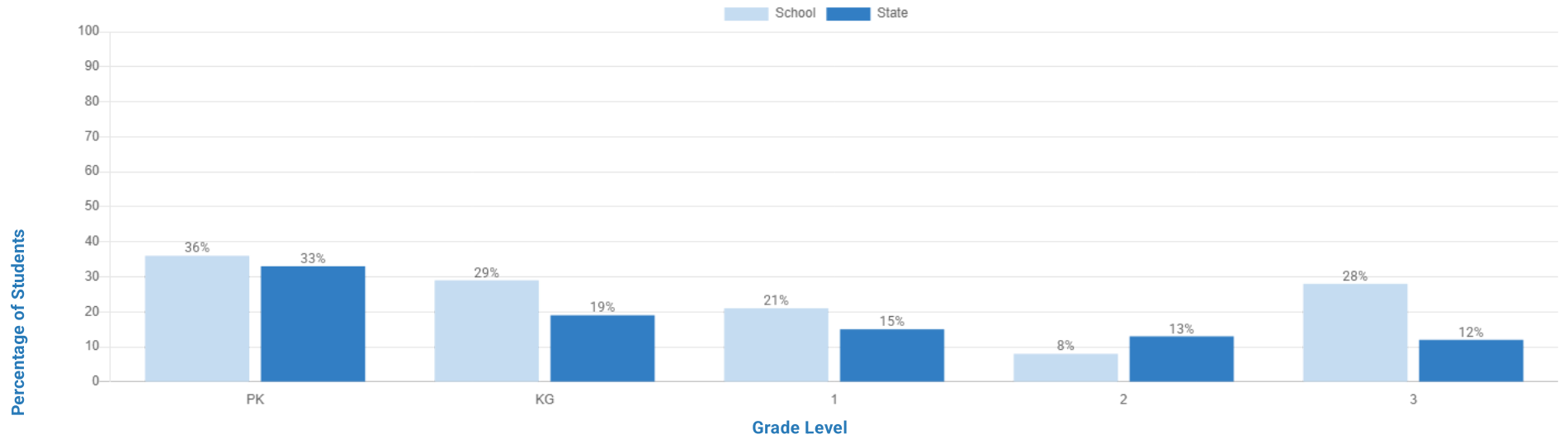

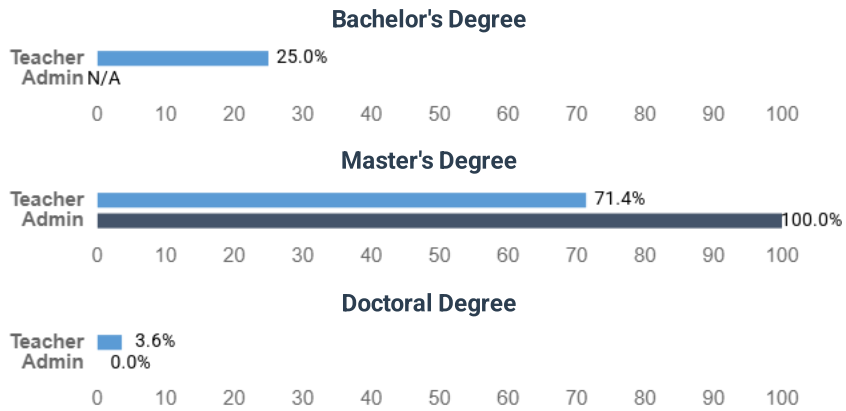

Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Highlights:

Awards, Recognition, Accomplishments:

Our 3rd-grade students ranked 2nd in the district on their performance levels in ELA on the NJSLA state assessment. We incorporated common ELA and Math cohorts in the 3rd grade, which allowed us to identify and group our students according to performance levels 3x a week. This proved highly successful as students were highly successful in benchmark assessments, as well as other district and state assessments such as EdConnect, DORA/ADAM, and EdConnect in the 2nd and 3rd grades. Monthly STEM challenges across all grade levels, 3rd Grade Parent Breakfast, NJSLA Readiness/Preparing Your Child to Success Parent Breakfast. Kindergarten to incoming 3rd grade course work for summer camp including robotics, coding, target tutoring, and blended learning. Before and After School Programs:

Our before-school program is open at 7 am which allows for early drop-off, and serves as a safe haven for students with working parents. They are also provided breakfast with all nutritional state-recommended values. An after-school program was created to target requisite skills and performance levels that are data-driven and provide readiness skills for grades K-2 as well as a High Impact Program that was successfully implemented by Hudson School as a result of a grant for the overall district to Zoom in on ELA and Math for NJSLA testing grades.



Staff and Professional Learning:

Professional development is provided through high-quality professional learning communities (PLCs) that are aligned with teaching and learning standards and are aligned with school and district school goals. The PLCs are rich in content and broaden the knowledge and skills of the instructional staff as they analyze test data and identify students so that performance levels increase and goals are met. We have an English Language Learning Instructional Coach/academic supervisor who is supporting MLL classrooms as well as supporting 3rd-grade classrooms with NJSLA readiness items, Study Island, and Ed Connect Math Benchmarks. The PD opportunities are sustained and supported by the district through job-embedded coaching, in-school curriculum-based grade level turn-key during PLCs, Conquer Math conferences, Wilson ELA conferences for 1st and 2nd grade chosen teachers, and Writing and Vocabulary in 3rd grade.

Student Supports and Services:

Student Support Services at Hudson School provides information and referral services for students who are experiencing difficulties in the areas of academics, medical, and/or social and emotional. Our goal has been to continue to meet the needs of the "whole child," and meet the new and challenging needs of our children, especially in the areas of behavior and emotional development as well as sensory challenges. Our bilingual program enables students to transition in many instances from a port of entry status to General Education. Certified staff meets all student needs to achieve the district goal of successfully transitioning students to the regular education program.



Student Health and Wellness:

Here at Hudson School and in the district at large, all students are eligible for free breakfast and lunch provided by Chartwells under the Community Eligibility Act. A full student lunch included a choice of entree supplying protein and grain, 2 vegetable side dishes, 1 fruit dish, and a choice of milk 1% skim, and chocolate. Provisions are made by the district if students necessitate such. Parents are asked to notify the school nurse if their child has a food allergy or medical condition which is then reported to the Food Service Co. as well as the classroom teacher for safety and awareness. Food modifications are then put into place to secure an individualized dietary plan. Also, we have been proudly participating in the Vegetable and Fruit Grant and have been able to host food workshops with our 3rd grades including cooking activities and simulated fresh fruit markets for all our students from PK- 3rd.



Parent and Community Involvement:

Hudson School continues to support our mission and core value that student success happens when families, students, educators, and community members work together and focus on the academic, social emotional needs of the students. Through rich collaboration that is open and flexible, the school's parent liaison, social worker, and community relations director facilitate collaborative activities with parents such as parent breakfasts where different topics of interest are presented. Also, we proudly held our first Literacy Nights for grades k-3 as well as Math Nights for grades k-3. Parents were invited to be engaged and educated in appropriate activities to take home that would support grade-level academic goals and objectives. The parents were also given dinner along with our students if they needed to bring them to the event. Pizza was served and it proved to be a huge success with very positive feedback and parent involvement increased at home as a result.

Facilities:

Our Hudson School facility is inspected in accordance with state and district protocols and guidelines. Hudson School meets state-mandated codes with well-equipped rooms for all grade levels and subject areas ranging from pre-k to 3rd grades. The building houses 20 regular education classrooms plus 2 special needs self-contained classrooms. It also has a media center, and an art room as well as a STEM room. Our technology teacher now supports and facilitates instruction by moving around to classrooms as our technology standards and usage have changed. We supply chrome books to our 1st to 3rd graders and iPads to our pre-k and k population. Hudson School is decorated and enhances our climate and culture with separate rooms for our adult staff to engage in quiet meditation or engage in 10m min chair yoga. We also have SEL corners in every homeroom in our building. Our school is kept clean and safe by our school custodians and cleaning personnel who work with our facilities Dept.



School Safety:

Hudson School is a safe school. It is supported by the district's initiative to maintain all facilities. It is fully equipped with a security system that includes cameras and radios to constantly monitor all school activities and grounds. Hudson School has fully trained security staff as well as a full-time SRO during school hours. We work in collaboration with district security personnel, ground supervisors, and the UC Police Department to ensure the safety and security of our school. District/state monthly security drills are conducted at the school level and monitored by our district facilities dept.

Technology and STEM:

Hudson Elementary School has been designated as a STEM school. Technology plays an integral role in daily instruction. Classrooms are equipped with SMART interactive boards. In addition, grades pre-k and K have iPads per student, and grades 1-3 have Chrome books for every student, thus providing every child with a computer to use within the classroom environment. The technology teacher sustains and supports technology by assisting with educational apps that are aligned with cross-curricular activities. Our STEM program includes coding, robotics, sustainability activities, and monthly STEM challenges. and successful summer STEM camps.



Early Childhood Education:

Hudson School has 4 pre-k inclusion classrooms that follow the UC Early Childhood Curriculum with NJ state standards/expectations, and developmentally appropriate practices. Our curriculum follows the High Scope Framework. We conduct early childhood assessments that include ESI and our district-derived EWS (Early Warning Summary) to drive effective teacher instruction and maximize the use of the teaching personnel in improving all environmental factors that affect learning. This tool assists teachers in improving the use of resources, materials, and staff within their classrooms. The T-POT is another reflective self-assessment tool. The 17 indicators on this tool allow for reflection on how challenging behaviors can be prevented by overall improved techniques, relationships, and procedures. Planning, clear expectations for learning, and positive staff relationships are looked at.
