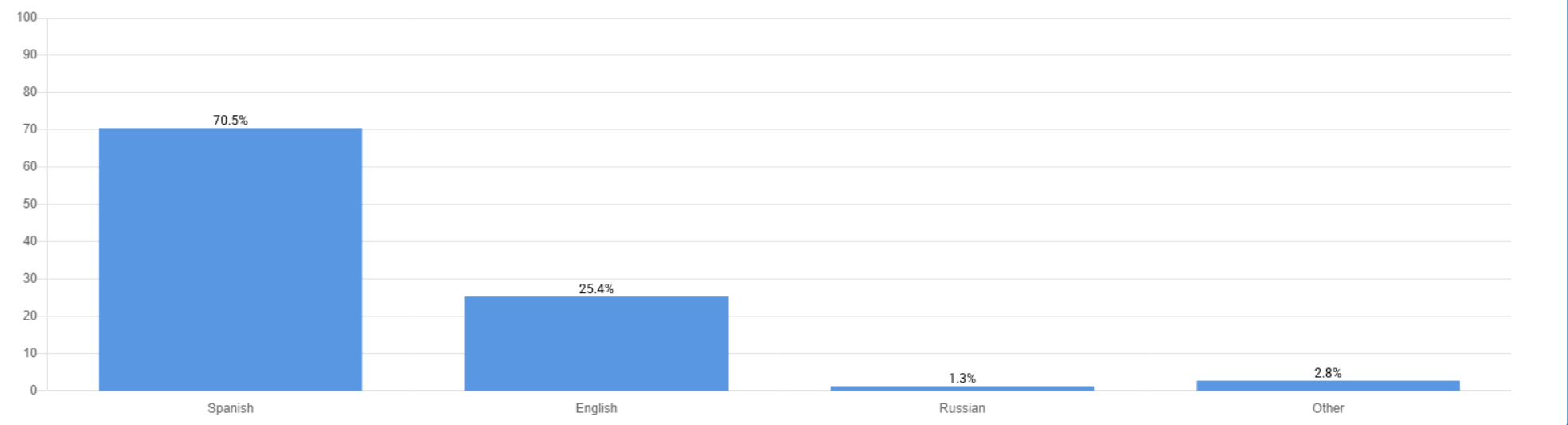

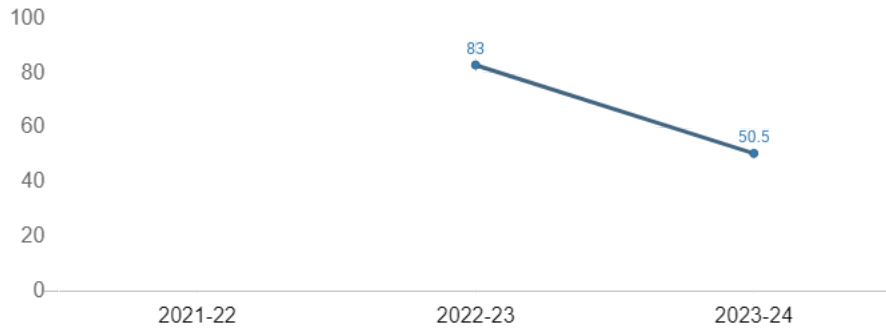

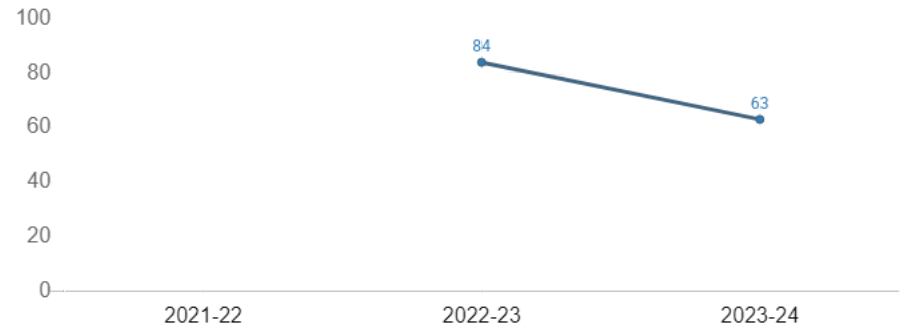

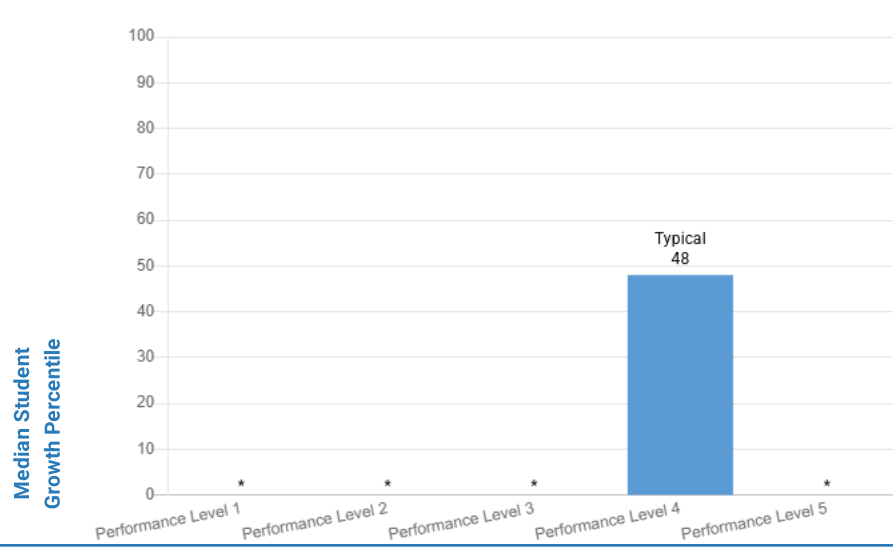

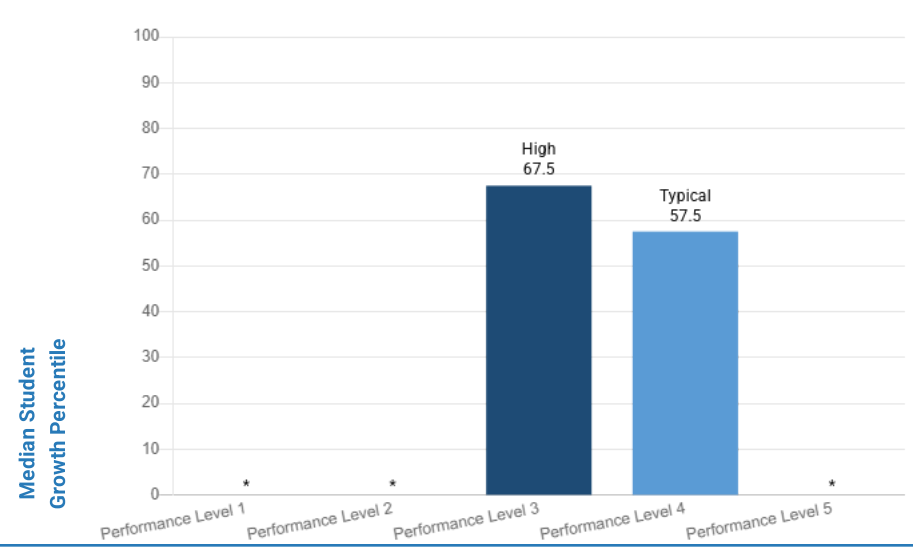

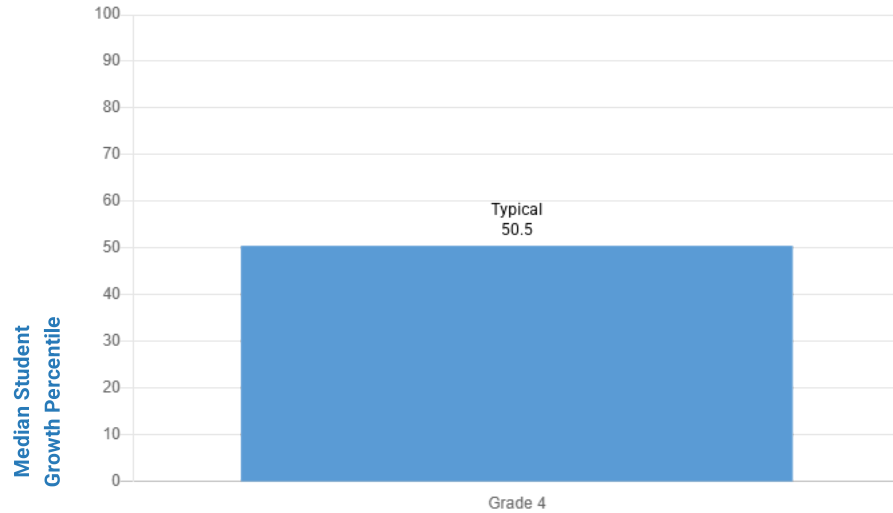

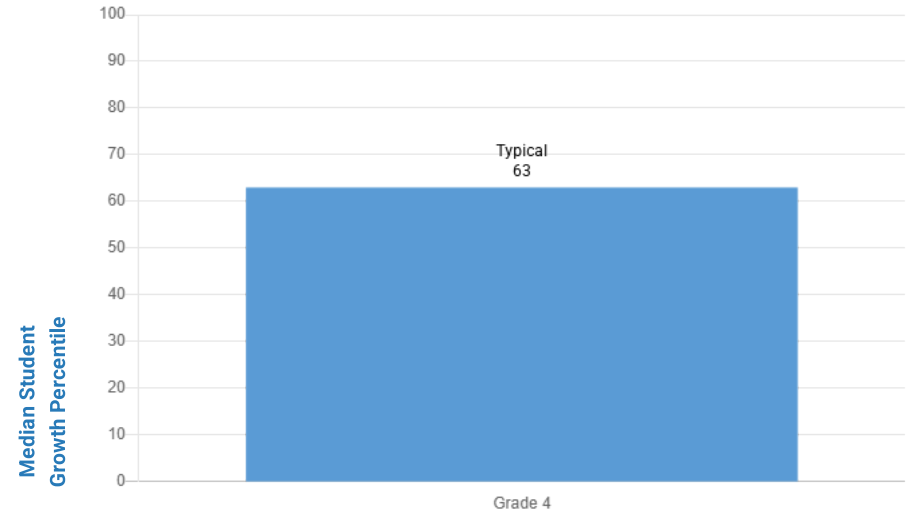

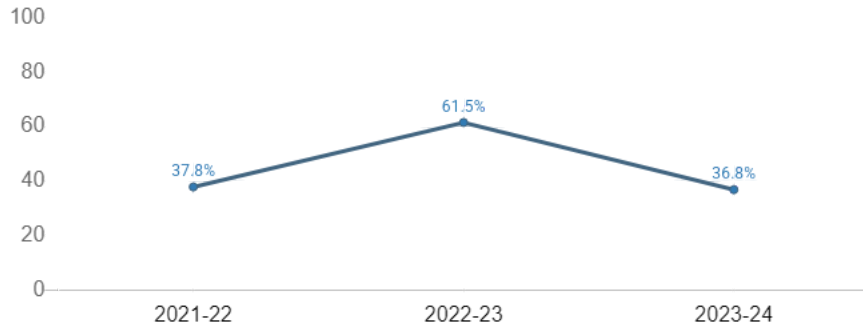

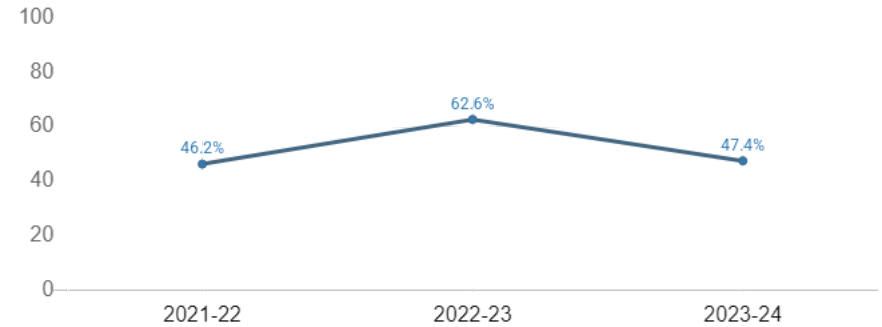
English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. 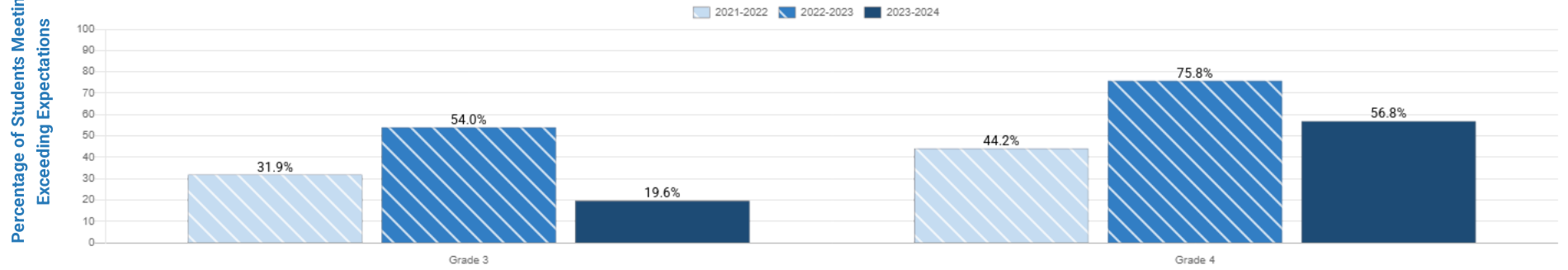

Mathematics Assessment - Participation and Performance

This table shows performance on statewide assessments for mathematics both overall and by student group. It includes the results of students taking both the NJSLA and DLM. NJSLA results include students taking end-of-grade assessments in grades 3 through 8, as well as end-of-course assessments (Algebra I, Geometry, Algebra II) in middle school and high school. High school mathematics assessment results include all results for Algebra I and Geometry and/or Algebra II results only for students who took Algebra I in middle school and who are enrolled in their first high school mathematics course that corresponds to an end-of-course assessment. Students who were enrolled for less than half a school year are excluded from performance results. Student are considered to have met or exceeded expectations if they score at Level 4 or 5 on the NJSLA or at Level 3 or 4 on the DLM assessment.

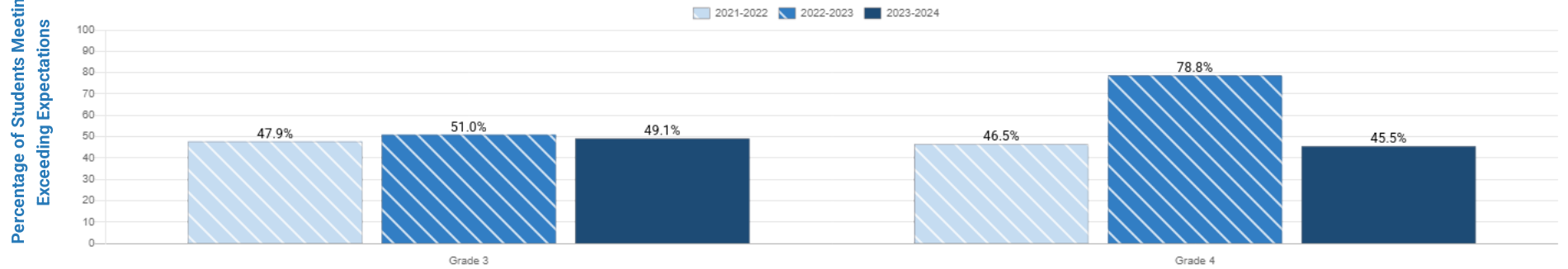

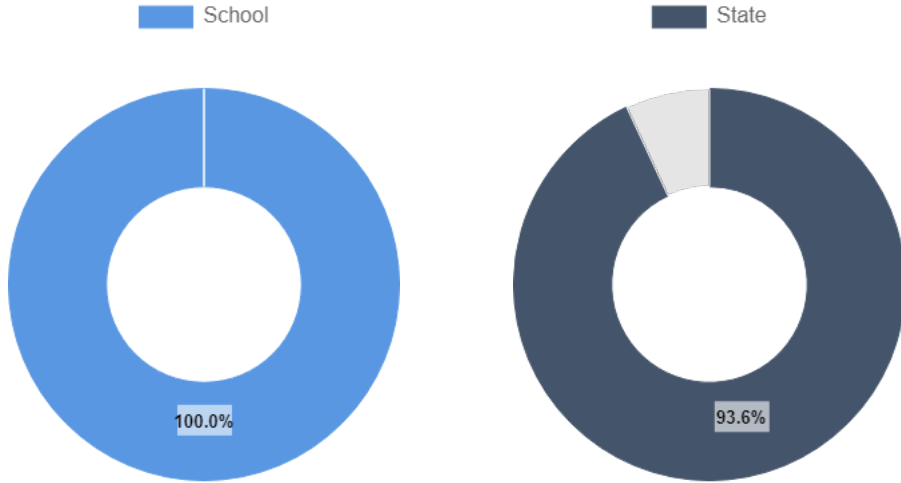

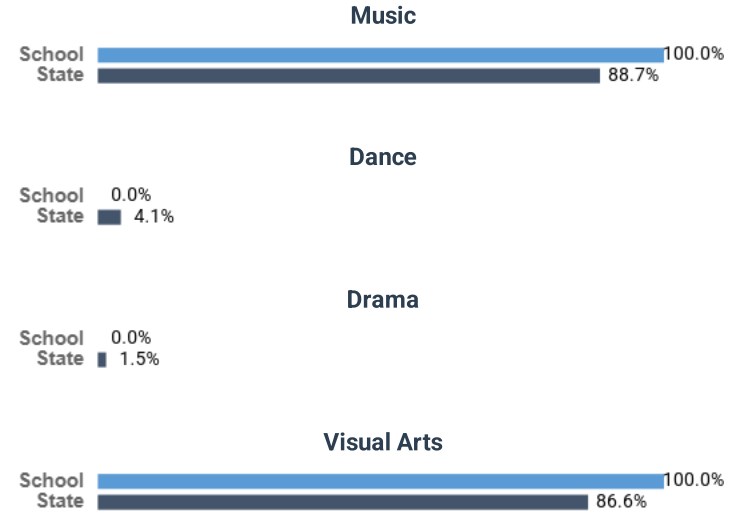

Students enrolled in one or more classes by discipline:



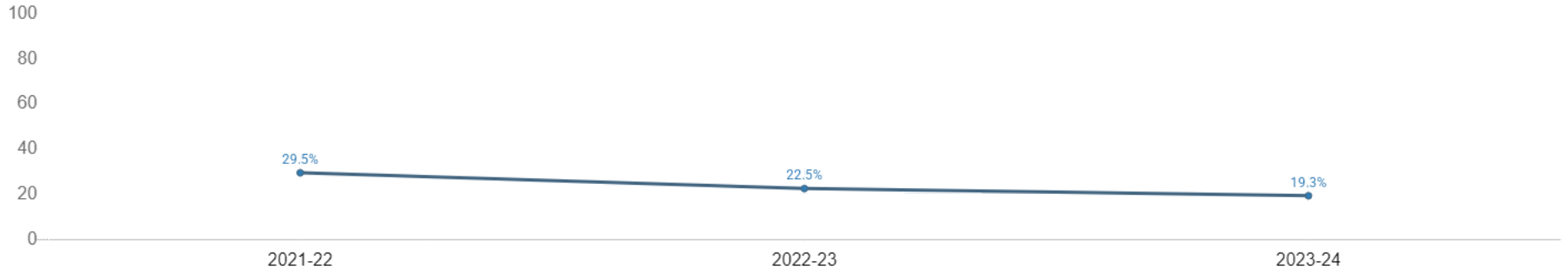

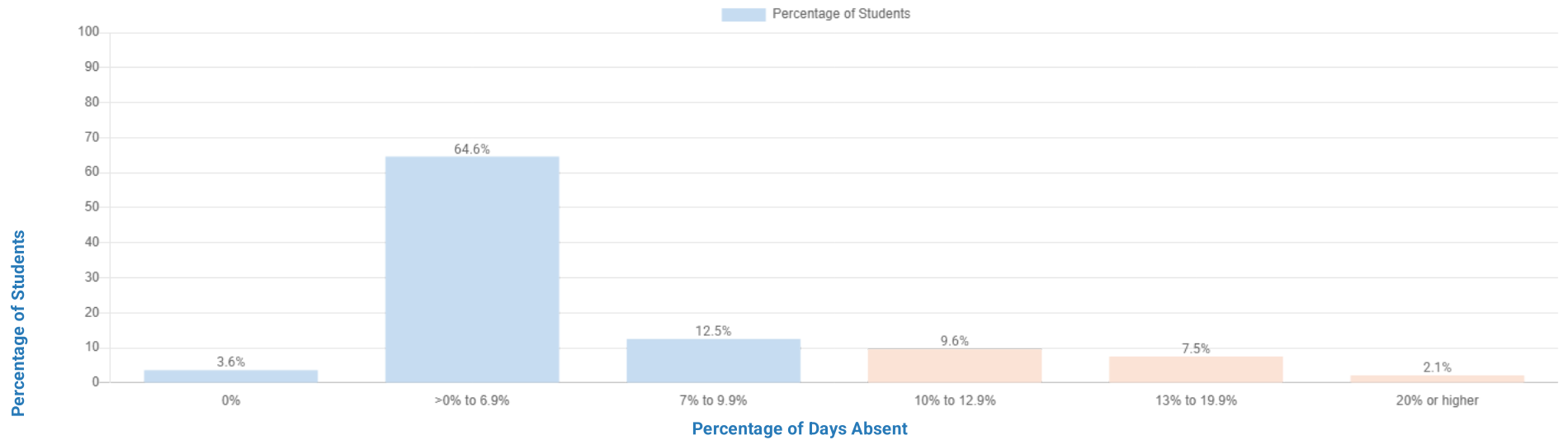

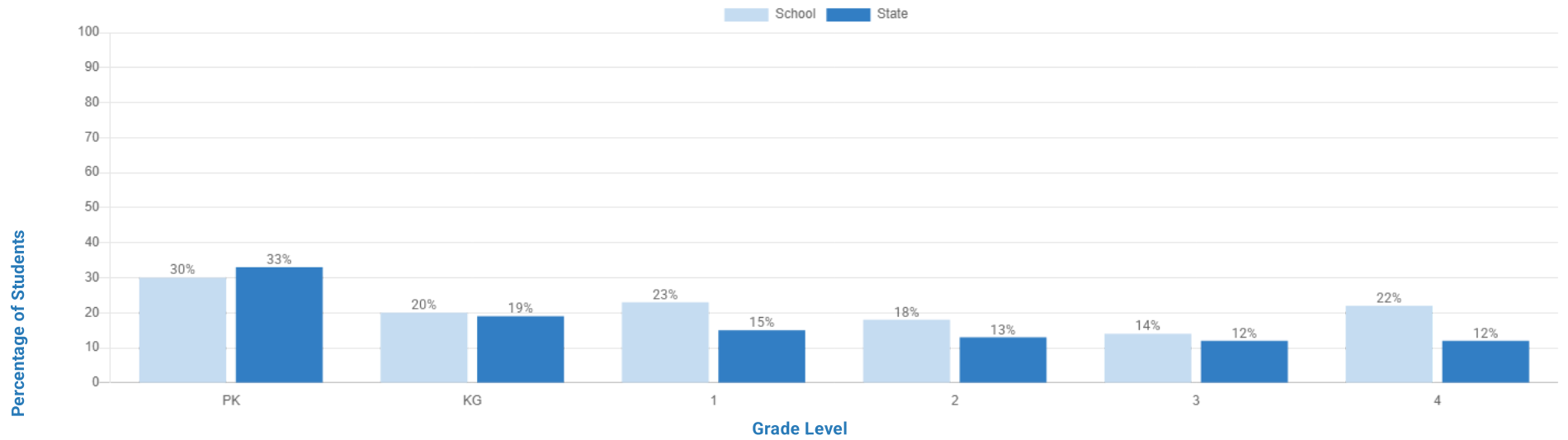

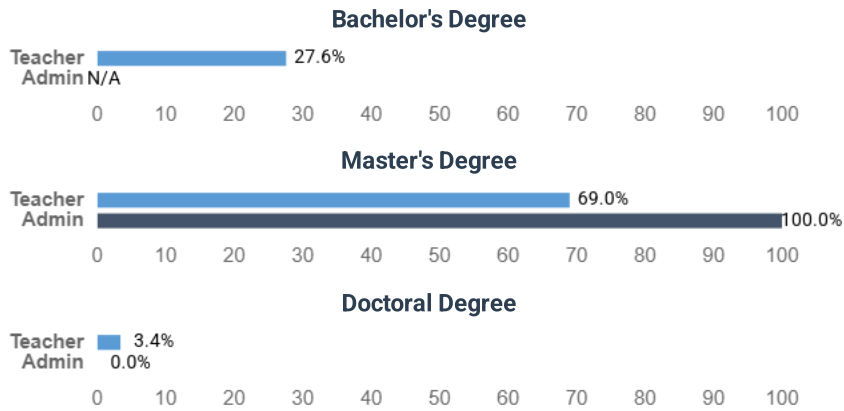

Student Supports and Services:

TJS administrative team and key staff members which include the school's parent liaison, social worker, child psychologist, verification officers, and security team members all took a holistic approach to student support, family outreach, and well-being. The Dean of Students is responsible for shaping and sustaining the district/school guidelines for discipline procedures as well as classroom expectations. Being fair, and positive, and supporting students to ensure they internalize the school's values and aspirations for academic excellence. Special Needs and Special Programs also provide intervention and referral services for students who are experiencing academic, medical, and emotional difficulties. The Bilingual Education program enables MLL students to become competent in English Language skills through the development of literacy and academic skills in their primary language and English. Extended Day Social Emotional Learning Program provided one-on-one and family counseling.
