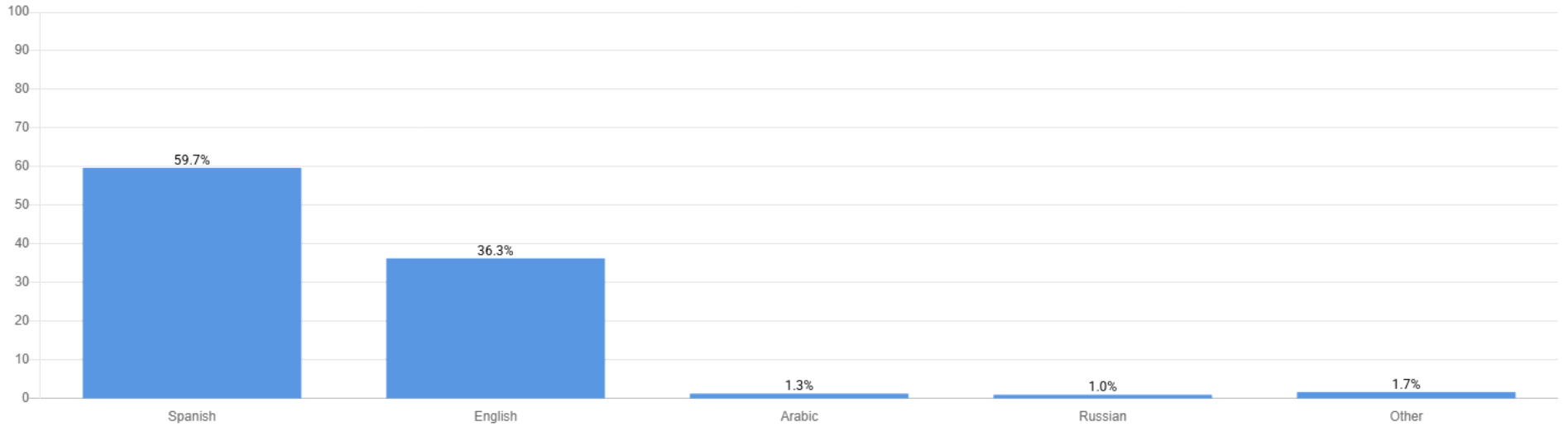

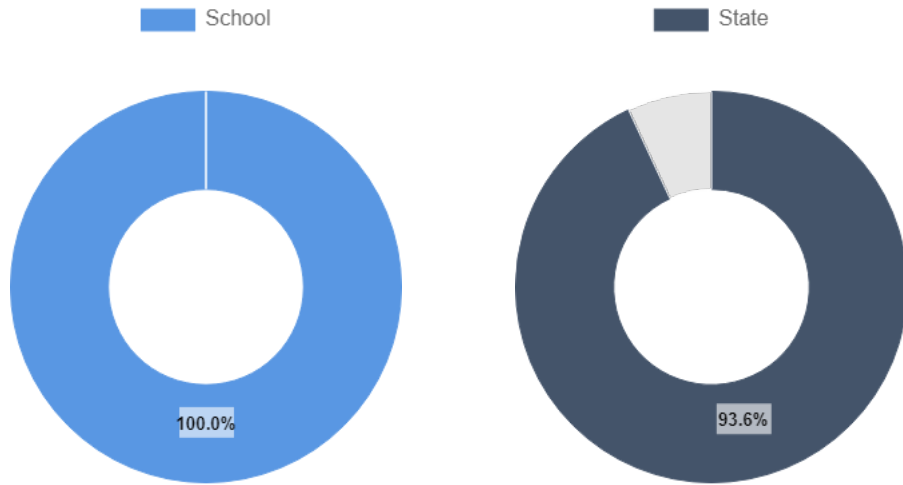

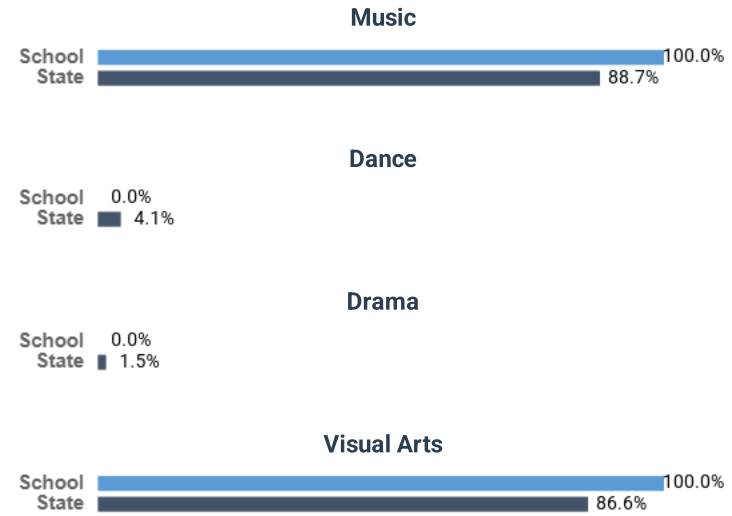

Students enrolled in one or more classes by discipline:



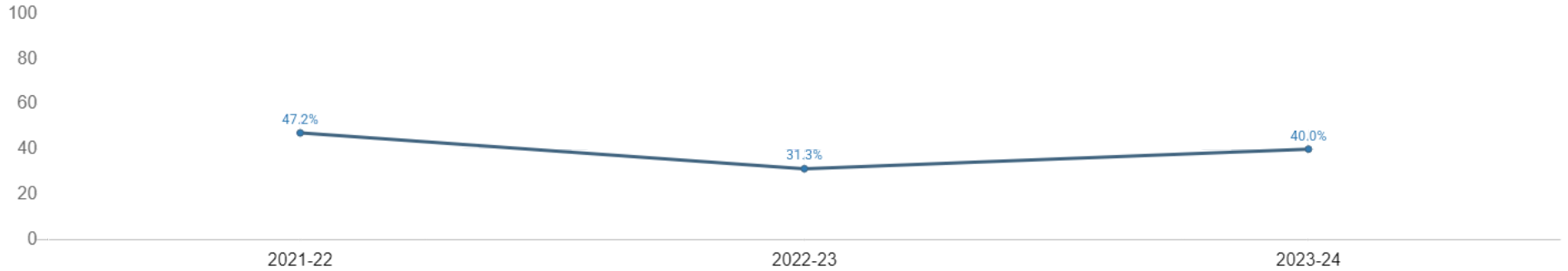

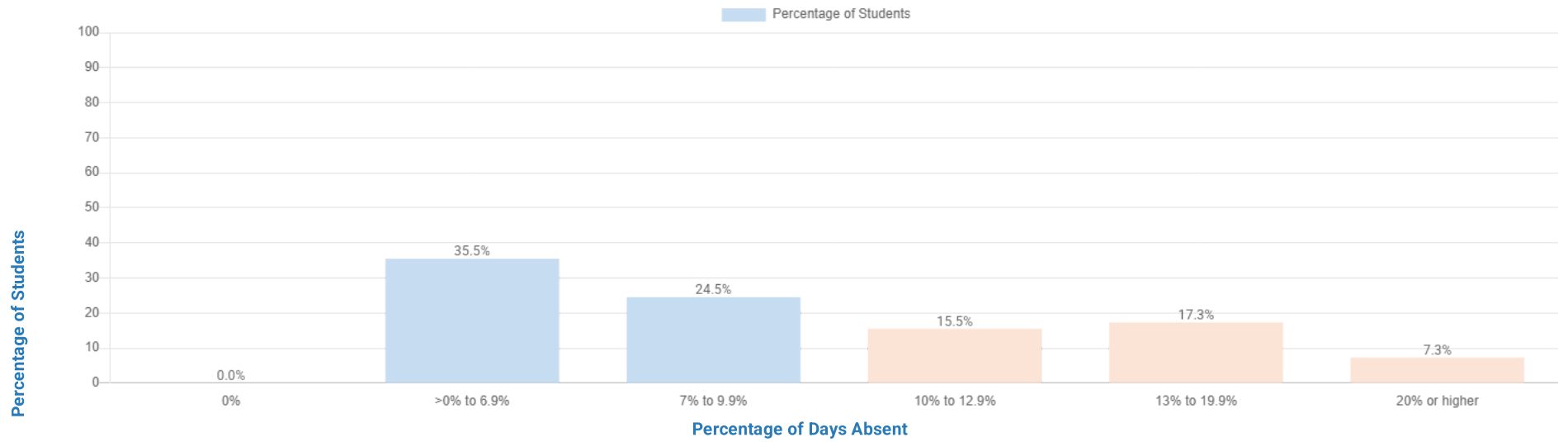

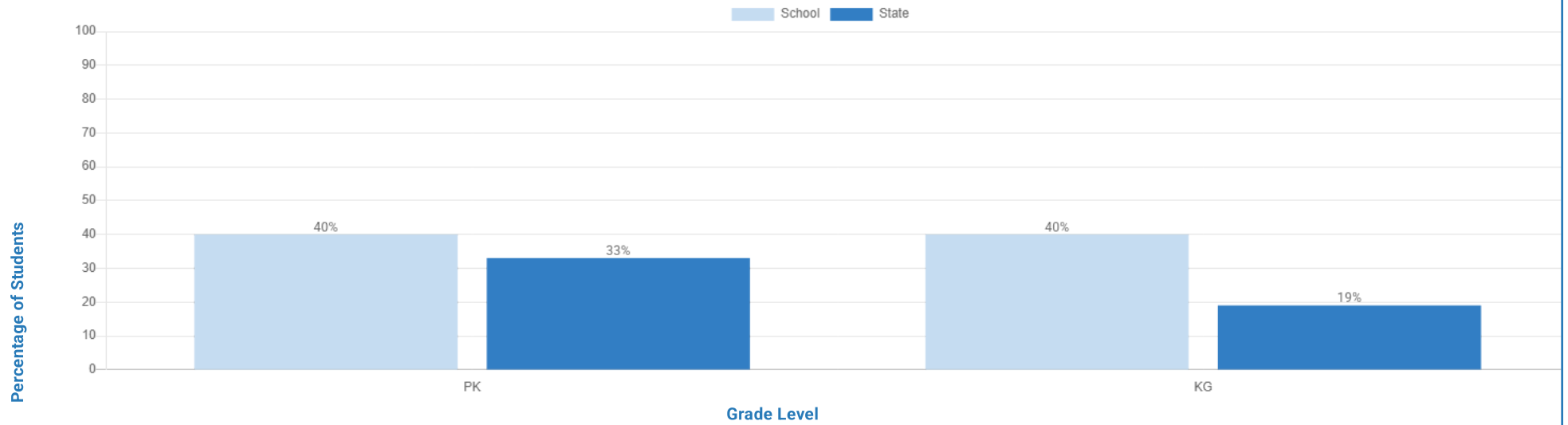

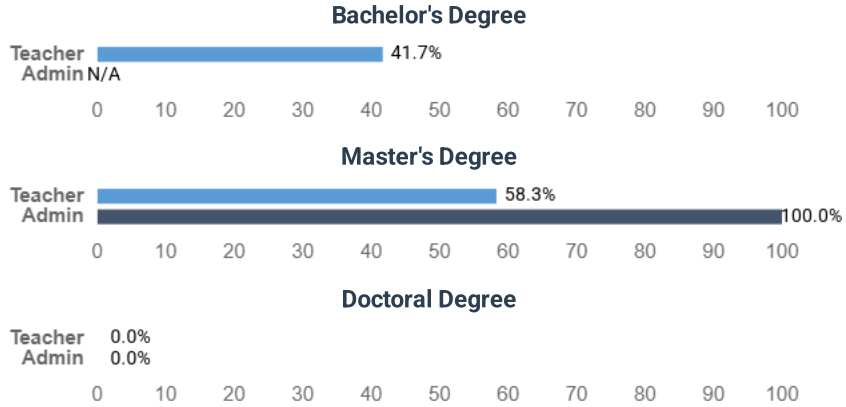

Accountability

Homework assistance and enrichment activities are offered to all participating students. High School students also assist the preschool students during the aftercare. Activities such as literacy learning activities, mathematics, science, arts and crafts, and story time are some of the activities offered during the after-school hours. Dismissal is at 5:00 pm (Monday through Friday).

All preschool students participate in an inclusive learning environment. The individualized needs of identified students with IEP are provided and specific instructional opportunities are offered. Support services and professional development opportunities are ongoing and provided to both the staff and families. Overall, our preschool program offers a variety of challenging learning activities to all students and continues to support early language, literacy, and pre-readiness development and ensures the particularized needs of the children and their community. Age-appropriate learning opportunities and a dedicated highly qualified staff ensure that our youngest population gets the positive learning experiences necessary for future academic success. The staff strives to provide a high-quality learning environment for "all" children. Highly qualified staff members create a safe learning and nurturing environment.



Student Health and Wellness:

All staff members are trained in CPR and have participated in numerous health and wellness programs/workshops. The school participates in all district-sponsored activities and events, such as health and wellness fairs, and other comprehensive community resources. All students are served nutritious meals during the day and follow State guidelines. Breakfast, Lunch, Snack, and Dinner (after-school program only) are offered to all students that participate in the program. A certified nurse is on the premises and adheres to NJDOE medical guidelines and Dept. of Health. Ongoing communication is provided to parents regarding immunization guidance and any concerning health issues. The North Hudson Community Action Corporation provides a free comprehensive health screening of health services to all three and four-year-old children enrolled in the program. A Flu vaccination drive commitment ensures that all children are given the opportunity to be vaccinated.



Parent and Community Involvement:

Parents are the child's first and most important teacher. Parents are strongly encouraged to become active participants in the education of their children. Instructional staff communicates with the parents via Class Dojo in order to keep the parents abreast of daily instructional practices and events. Teachers post activities and pictures of all events that take place in class. Ongoing monthly parent workshops are also offered on various health and social issues/services. Our home-school connection and communication is an essential component for our school. Monthly calendars and home-school activities were provided to all parents so that parents participated in their child's learning. The district strongly believes that parents play an important role in their children's education and we welcome their participation in our program.

The school continues to maintain strict health practices in order to ensure controlled health measures. The classroom environment ensures that the tables and bathrooms are constantly wiped and sanitized as per preschool guidance. The students are encouraged to wash their hands when they enter their classrooms, before and after meals, and comply with health practices whenever sneezing or coughing. The school has a playground for the children to use during school hours. A parking lot is also available for the staff.



School Safety:

School Safety is a priority for the school. Eugenio Maria de Hostos has 5 security guards who assist in ensuring that the students and staff are safe at all times. A Union City Police (SRO) is also stationed at the school in order to reinforce the security of the school. Monthly drills are performed as per NJDOE requirements. All of the staff members participate in ongoing mandated school safety training every year. Safety measures are followed by all staff members. Five security guards are present at all times during school hours. The District has developed a school safety manual as guidance for all staff members. School safety signs are posted throughout the school. Code Blue Training Team has been trained to address emergencies. Staff members at ECC were trained and held a CPR certificate. District/state monthly mandated security drills are conducted at the school level and monitored by our district facilities department.
