




### English Language Arts and Mathematics Performance Trends

These graphs show trends in the Proficiency Rate for Federal Accountability over the last three years. The data includes the results of students taking both the New Jersey Student Learning Assessment (NJSLA) and the DLM alternate assessment for English language arts (ELA) and mathematics. 

















## Graduation/ Postsecondary

Information about students enrolling in colleges and universities after graduation is collected from the [National Student Clearinghouse \(NSC\)](#), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. Students who attend a college or university outside of the United States are not included in NSC data; 3. Certain colleges or universities may not participate in sharing data with NSC or may fail to report data for a certain semester or a certain group of students; and 4. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

**Note for 2023-2024:** Postsecondary enrollment data for the 2023-2024 school year is not yet available. The NJDOE expects to release the data in the coming months. Please refer to the 2022-2023 reports for the most recently available postsecondary enrollment rates.











### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Schools are identified for ATSI if they have at least one student group that has a summative score that would be in the bottom 5% of Title I schools if it was its own school. MHS is a "High Performing School District" as recognized by the NJDOE. Memorial High School offers multiple academies: Freshman Academy, STEAM Academy, Performing Arts Academy, Tomorrow's Teachers, Business Academy, and Public Affairs Academy. Memorial High School offers 32 dual enrollment courses that students are able to get college credit for: 10 SUPA(Syracuse) Courses, 13 AP Courses, 9 other courses that have partnerships with Hudson Community College, NJCU, Bergen Community College, Kean College, or Fairleigh Dickinson University. All teaching staff have Common Planning Time everyday to collaborate and look for ways to enhance the curriculum and instruction. Four days a week tutoring is offered after-school for Math, Science, History and Language Arts.

### Before and After School Programs:

Memorial High School offers tutoring for students after school for Math, Science, Language Arts and History. Certified teachers are available 4 days per week for an hour for students to drop in. We also offer an extended day library that offers the students the opportunity to use the library before and after school along with an open computer lab.



### Staff and Professional Learning:

There are two full days dedicated to professional development for the staff. Once a month the district has Professional Learning Seminars. They are 2 hours in length and vary from school based, district based and department based. The technology committee offers a help desk every week and a PD class during the day once a month. Teachers also have a common planning time everyday where they share best practices.



### Postsecondary Information:

All 10th and 11th graders take the PSAT. There is an annual college fair is held every October. Staff and students use Naviance. SAT Prep courses are offered to 11th graders. MHS is partnered with Stevens Institute of Technology through the ACES program. Through the program, students have access to seminars on college and career access. MHS hosts an annual FAFSA night in both English and Spanish. MHS is also a Pilot school for the High Schools of the Future program in partnership with Liberty Science Center and Bank of America. Students will learning Cybersecurity and receive guaranteed job placement in the field at the end of the two year program.

Six guidance counselors assist all students academically and emotionally. There are three school social workers for emotional support, a four person child study team and two school nurses. Memorial High School also has two school disciplinarians and a SAC to help students when in need. We have brought in outside speakers such as Coming Up for AIR to address mental health issues.



### Student Health and Wellness:

Memorial High School follows the Alliance for Healthier School guidelines. All snacks must be approved by the Alliance guidelines. All students have Physical Education class everyday and all seniors are CPR certified. "Food and you" elective classes promotes healthy living as does the annual health fair that brings in outside resources.



### Parent and Community Involvement:

Organization of Parents and Faculty have meetings once a month. They have workshops and fundraisers to assist the school. Memorial High School has events such as plays, concerts, OPF meetings, sporting events, workshops, guest speakers. Parents have access to the parent portal to see their students grades. Students are able to see upcoming events on the school website and Google Classroom. There is a newsletter sent out electronically. All teachers submit a parental contact form each time they speak to or meet with a parent.

The district offers multiple workshops on school safety. All doors are locked and secured at all times and there are over 150 cameras installed. There are 2 disciplinarians that help monitor school safety. All students are required to wear uniforms and ID. Additionally, one security drill and one fire drill are executed each month.

### Attendance:

The WNY District used ESSER II/CRRSA/ESSER III/ARP funding to employ the research-based model of improving student achievement through extended year programs in both ELA and STEAM, & to address learning loss by hiring Reading Development Teachers. Funding was used to support the health and safety of students and to address mental health and social emotional needs. Programs took a comprehensive approach to help children build resilience to overcome loss and adversity in their lives. Training for social workers to address students' needs were also brought in. Updates to the district's HVAC systems were made. This funding has made a huge impact on the lives of our students and their families. Since a needs assessment process was completed prior to the allocation and use of funding to identify critical areas for support, all practices were successfully begun to address the negative impact of the pandemic. All programs were received well by students, families and all staff members.

Supervisors, administrators, central office and teachers have revised the curriculum to insure it aligns with all State and Federal guidelines. Memorial is not only thriving academically, but also meets the students' social and physical needs. There are numerous groups, organizations, clubs and athletics that are in place to ensure that all students have an activity to participate in.
