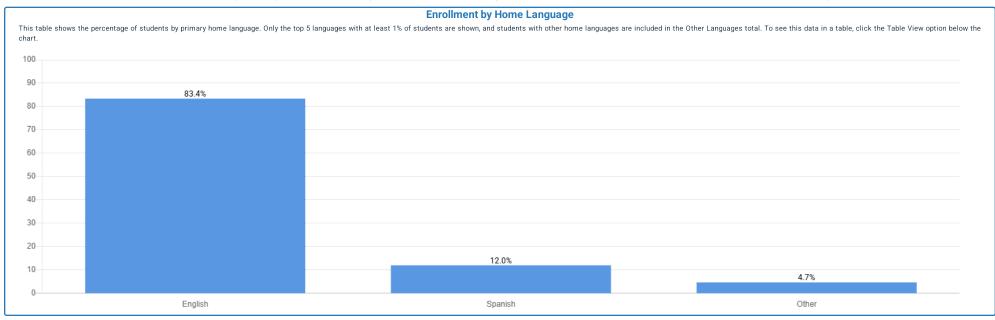

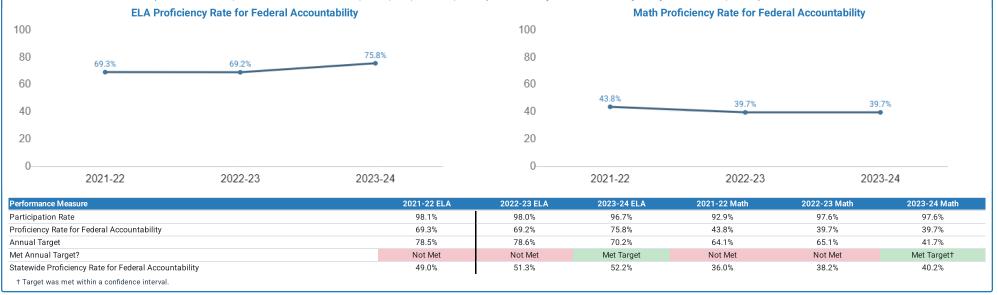

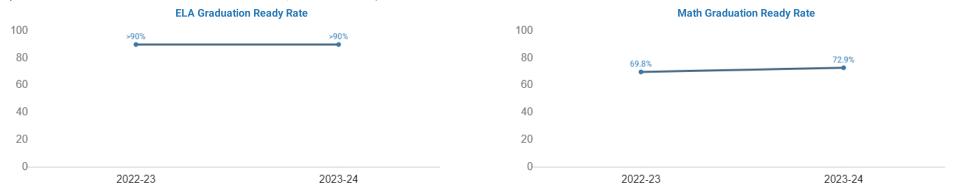

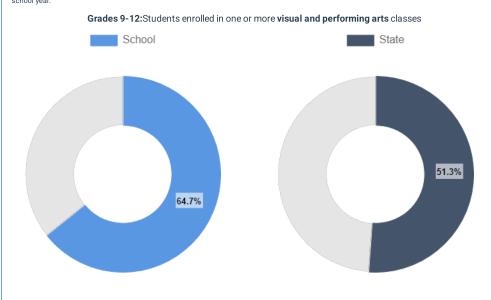

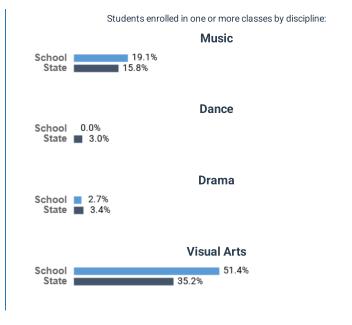

Information about students enrolling in colleges and universities after graduation is collected from the National Student Clearinghouse (NSC), which collects data from at least 97% of higher education institutions nationwide. New Jersey graduates are matched to postsecondary enrollment data by NSC each year. While most students who enroll in a postsecondary institution each year are able to be matched by NSC, there are some students each year who cannot be matched. Some reasons that students may not be matched are: 1. Postsecondary enrollment cannot be shared with the NJDOE if students request a FERPA block on their postsecondary enrollment records; 2. NSC may not be able to match a student's name or date of birth in NJ SMART to the information provided by the postsecondary institution(s) with a high level of confidence.

In 2023, NSC implemented an additional manual review process to reduce the number of students who do not match due to #4 above, which may result in NSC matching additional students to postsecondary records moving forward. As a result, the NJDOE is not including trend data from prior to 2022-2023 in the reports.

HCRHS offers a drop-in after school program for students in the ML Programs. The after-school program meets 1 day per week for approximately 2 hours. Students are MLs of levels 1 through 4, ages 14 to 19. The program is supervised by supervisor of World Languages and ML programs, and designed by two ESL teachers. ESL teachers staff the program every week. Students may drop in for help with homework or social/emotional support. Regular program activities such as enrichment crafts, games and intramural sport activities are also provided.



HCRHS offers a staff training program that has achieved state & national recognition from The National Center for Public Productivity at Rutgers, The N.J. Association for Supervision and Curriculum Development and the U.S. Department of Education Professional Development National Awards. HCRHS offers an innovative professional learning program with summer workshops and opportunities for personalized professional learning. Staff and administrators are frequent presenters at state and regional conferences. Staff are offered a variety of different in-house training opportunities through professional development offered during the school day and after school, content-focused department workshops, and a robust Professional Learning Communities model. In addition, selected HCRHS teachers and staff serve in the capacity of "Instructional Design Assistant," a teacher leadership and instructional coaching structure.

Climate Surveys:



HCRHS opened its doors in September 1956 and is one of the largest, campus-style high schools in N.J. The District has a 72 acre campus with two large general classroom buildings, a music and communications building housing classrooms, FM radio station and TV studio, Instructional Media Center, 280 seat Little Theater, 900 seat Auditorium, 2,000 seat Fieldhouse, 4 gymnasiums, Fitness Center, a Project Adventure course, football stadium, 8 additional playing fields, tennis courts, 3 cafeterias, and a large Commons area.



HCRHS has a robust security program that includes a School Safety Specialist, 1 SRO, 3 Class III officers, 5 full time security staff, and 12 duty release aides that assist in overall management and security presence. All exterior doors remain locked at all times, with access afforded to students and staff via ID swipes. Three staffed reception entrances are equipped with an ID scanning and visitor badge process. A full scope of security cameras throughout the inside and outside of the buildings assist in ongoing monitoring with remote access for specific administrators. The district has a Safety Team that meets monthly as well as a School Threat Assessment team which meets as needed. This District Safety team consists of representatives from all factions of the program. A communicative and collaborative relationship with our local police department and county law enforcement serves as a complement to our internal security program.

HCRHS is a 1:1 district with each student having their own district-issued Chromebook. Classrooms are wireless with full audio and video capabilities. The Instructional Media Center catalyzes innovative practices in technology and STEAM, housing a recently renovated Makerspace with a CNC machine, 3D printers and green screen, and offering multiple flexible learning spaces. HCRHS has multiple STEM programs as part of its Program of Studies, with magnet programs in Architecture, Biomedical Sciences, Computer Science, and Robotics. HCRHS offers a coding club and competitive programming club for students, and python code activities have been embedded into all Geometry classes. HCRHS also has a radio and TV recording studio supporting classroom needs and co-curricular activities. HCRHS has hosted a county-wide Hack-a-thon for community members and students, as well as STEAM showcases. Media specialists and Instructional Design Assistants provide training for teachers and staff.
